# LIFE GETS EXPENSIVE FROM TODAY

The financial year 2022-23 is starting from 1st April i.e. today. With this, many rules will also change. These will have an impact on our earnings, expenses, and investments. From midnight on Thursday, the National Highways Authority of India (NHAI) has increased the toll tax from 10 to 65 rupees. It has been increased by Rs 10 to 15 for small vehicles while Rs 65 for commercial vehicles. State employees will be able to claim a higher deduction on the NPS contribution of their employer. An individual will be able to file updated income tax returns after two years. Tax will not be levied on the amount up to Rs 10 lakh received for the treatment of corona. Investment in mutual funds can be done only through UPI or Netbanking. Exemption for senior citizens above 75 years of age from filing returns.



**CRYPTOCURRENCY** Clear tax rules will be applicable on virtual currency as well from April 1. Virtual digital assets or crypto will be taxed at 30%. If a person gains from selling cryptocurrency, then he will have to pay tax. 1% TDS will also be deducted from July 1 on sales.

**PAN** Linking PAN with Aadhaar will now attract a penalty. It will be Rs 500 till 30 June 2022. After this, a penalty of 1000 rupees will have to be paid. PAN number will become inactive if it is not linked even after March 31, 2023.

**AFFORDABLE HOUSE** If you have bought an affordable house for the first time, then the interest paid will not get the benefit of an additional deduction of 1.5 lakh under section 80EEA. If the value of the house is less than 45 lakhs, then till now interest payment could have claimed a deduction of up to 1.5 lakhs. This deduction or exemption was in addition to the exemption of Rs 2 lakh available under section 24B. This benefit was only for those taxpayers who had taken a loan between April 1, 2019, and March 31, 2022, to buy a house.

**MEDICINES** Healthcare will also become costlier in the new financial year. The price of about 800 life-saving drugs will increase by 10%, which will increase the cost of treatment.

**GST** Businesses with more than 20 crore turnover will come under the purview of mandatory e-invoicing. E-invoices will be issued for every business-to-business transaction. Failure to do so may result in confiscated goods during transport. The input tax credit that the buyer will get will also be in jeopardy.

**TRAVELING HAS BECOME EXPENSIVE** Travelling on national highways could become a little more expensive as the Central government has decided to increase the toll tax from April 1, Friday. As per a report, the National Highway Authority of India (NHAI) has hiked the toll tax between Rs10 to Rs65. While the cost of commercial vehicles has been increased by Rs65, light vehicles have to pay Rs10 more per vehicle for one way. NN Giri, NHAI Project Director confirmed that a notification regarding a hike in toll tax has been issued for the FY 2022-23.

**PROVIDENT FUND (PF)** Employees who have deposited more than Rs 2.5 lakh in the PF account will have to pay income tax on interest. The amount will be divided into two parts for tax calculation. Exempt contribution in one, and contribution of more than Rs 2.5 lakh in the other, which will be taxable. For government employees, this limit will be Rs 5 lakh.

### TVS, ACS SET TO GET COSTLIER BY UP TO 10%

New Delhi: Consumer electronics manufacturers on Thursday said that the prolonged Russia-Ukraine war and China lockdowns will result in significant price hike in the prices of electronic goods by up to 7-10 per cent next month. Smartphones, laptops, TVs, ACs as well as imported watches are set to get costlier in the next few weeks. Industry experts said prices of these consumer goods could go up to 10 per cent. The electronics sector has already been raising prices by 2-3 per cent every quarter owing to the Covid-19 pandemic. With supply chain disruptions, fast-moving consumer goods (FMCG) companies have also been forced to increase the prices of daily-use products.



### FUEL PRICES: 9TH HIKE IN 10 DAYS

New Delhi: Fuel prices continue to rise with petrol and diesel rates rising by another 80 paise per litre each on Thursday, netting an increase of about Rs 6.40 a litre in nine revisions in 10 days so far. In the national capital, petrol now costs Rs 101.81 per litre, while diesel is selling at Rs 93.07 per litre. In Mumbai, the petrol and diesel prices have gone up by 84 paise, thus costing Rs 116.72 and Rs 100.94 per litre.

## Russian Foreign Minister lands in Delhi, to hold talks on Friday

Russian Foreign Minister Sergey Lavrov landed in New Delhi on Thursday evening to hold talks with Indian counterpart S. Jaishankar over crude oil offer, rupee-ruble payment and arms deals. It is the first high-level visit from Russia after the country went to war with

Ukraine. Russian Foreign Minister Sergey Lavrov arrived in Delhi at 6 pm. Lavrov would be meeting Jaishankar on Friday afternoon and by 5.50 p.m. he would be flying for Moscow. As the US-led sanctions and a few Russian banks being removed from the SWIFT messaging system, Lavrov will deliberate upon the rupee-ruble denomi-

ed payment method for crude oil which Russia has offered to India. New Delhi is not averse to buying Russian oil at a discounted rate. It is also stated that the Reserve Bank of India senior officers are meeting their Russian counterparts to discuss the rupee-ruble payment. Since the start of war, India has been facing pressure from the West and its allies to take a stronger stand against Russia. As the war between Russia and Ukraine cost India's military capabilities dearly with delivery of many platforms like nuclear powered submarines, Grigovich class frigates, Fighter jets, Triumf S-400, AK 203 assault rifle and others were expected to delay. Indian leaders will hold discussion with Lavrov over the issue.


## Serial blast bid foiled; 3 held, 12 kg explosives seized

Jaipur: Rajasthan Police have arrested three persons in Chittorgarh district's Nimbahera town and seized 12 kg explosives and other materials used for making bombs from them, officials said on Thursday. A preliminary investigation revealed that the arrested individuals -- Zubair, Altmas and Saiful, are associated with the Al Sufa organisation that operates near Ratlam and Dewas in Madhya Pradesh. They were arrested while they were moving in a Bolero car that had a Madhya Pradesh registration number plate. It is being said that they were going to Jaipur along with explosive materials from Ratlam (Madhya Pradesh). An FIR has been registered in this regard at the Sadar police station of Nimbahera. After interrogation of the accused, three more persons from Tonk and Chittorgarh have also been detained in this case. It was revealed during the questioning that there was a conspiracy of a serial blast in Jaipur, and the arrested individuals were supposed to hand over the explosives to other members of their group. On the basis of this investigation, five other persons have also been taken into custody from Rajasthan and Madhya Pradesh. Officials suspect there were probably plans to carry out serial blasts at three places.

## Armed Forces (Special Power) to reduce in Nagaland, Assam, Manipur

Union Home Minister Amit Shah on Thursday announced that the Central government has decided to reduce the disturbed areas under Armed Forces (Special Power) Act, 1958 (AFSPA) in three northeastern states -- Nagaland, Assam and Manipur. Shah announced the long awaited decision in three separate tweets when most of the political parties and NGOs have been demanding to repeal the AFSPA. The demand intensified after the security forces killed 14 people and injured 30 others in Mon district of Nagaland in December last year. Almost all Chief Ministers of the northeastern states welcomed the Central government's announcement to



reduce the disturbed areas under the AFSPA. According to the officials in the three northeastern states, in Nagaland, the AFSPA would be removed from the jurisdiction of 15 police stations in seven districts. After the Central government's latest decision, in

Manipur, 15 police station areas of six districts would be excluded from the Disturbed Area Act while in Assam, the AFSPA would be removed completely from 23 districts and it would remain enforced partially in one district. The fresh decision on the AFSPA will be effective from April 1.

## UKRAINE CONFIRMS PARTIAL WITHDRAWAL OF RUSSIAN TROOPS FROM KIEV, CHERNIHIV DIRECTIONS

Kiev: Ukrainian Defense Ministry's spokesman Olexandr Motuzanyk on Wednesday confirmed that Russia has been withdrawing some troops from Kiev and Chernihiv directions, in central and northern Ukraine respectively, the Interfax-Ukraine news agency reported.



"The General Staff of the Armed Forces of Ukraine notes a certain partial relocation of individual units from the Kiev direction, as well as from the Chernihiv direction," Motuzanyk told a media briefing. However, there was no mass withdrawal of Russian troops from those areas, he was quoted as saying Xinhua news agency. Motuzanyk suggested that Russian forces may renew their offensive against Kiev and Chernihiv after replenishing the units that suffered the biggest losses in the battles. On Tuesday, Russia's Defense Ministry announced that Russia has decided to significantly reduce military activity in the Kiev and Chernihiv directions.

## ABOVE NORMAL TEMP TO CONTINUE IN APRIL: IMD

### HEAT WAVE LIKELY TO CONTINUE IN CENTRAL, WEST INDIA FOR NEXT 4-5 DAYS

New Delhi: Even as Delhi-NCR continued to witness maximum temperatures hovering between 39-41.2 degrees Celsius while Chandrapur in Maharashtra topped with maximum temperature of 44.2 degrees Celsius, the India Meteorological Department (IMD) on Wednesday said the heat wave spell is likely to continue over Central and West India during next 4-5 days. Heat wave to severe heat wave conditions were observed in most parts of West Rajasthan, in many parts of Himachal Pradesh and in some parts of Haryana while heat wave conditions were observed in some parts of East Rajasthan, Madhya Pradesh and isolated pockets of Jammu Division and Uttar Pradesh. Heat wave to severe heat wave conditions in most parts are very likely to continue over in many parts on March 31 and in some parts over West Uttar Pradesh, East Rajasthan & West Madhya Pradesh on March 31. Heat wave to severe heat wave conditions in isolated pockets over south Haryana & Delhi on March 31.

Riding on the second heat wave continuing over large parts of northwest and central India, the India Meteorological Department (IMD) on Thursday said for April, similar above normal maximum temperatures are likely to be recorded in most parts of northwest and central India and some parts of northeast India. Normal to below normal maximum temperatures are likely over remaining parts of the country, the IMD said, adding that above normal minimum temperatures are likely over most parts of northwest, central and northeast

India while normal to below normal temperature are likely over most parts of northwest, central and northeast India. Normal to below normal minimum temperatures are likely over the south peninsular India, eastern parts of central India and extreme southern part of northeast India, IMD Director General Mrutyunjay Mohapatra said while announcing the Outlook for Temperature and Rainfall for April. March witnessed two spells of heat waves, first between March 11-21 while second started on March 26 and is still continuing. Meanwhile, except coastal peninsular areas, almost all of India received deficit rainfall in March. IMD said, the rainfall in April averaged over the country is most likely to be normal (89-111 per cent of Long Period Average). Below normal rainfall is most likely to occur over most areas of northwest and central India and some parts of northeast India. Normal to above normal rainfall is likely over many parts of south Peninsula, adjoining areas of west central India and some parts of northeast India, he said.

## SC ORDERS FRESH MOP-UP ROUND COUNSELLING FOR NEET-PG 2021-22

New Delhi: The Supreme Court on Thursday cancelled the mop-up round counselling held for All India Quota (AIQ) of the NEET-PG courses for year 2021-22, and ordered a fresh mop-up round. A bench, headed by Justice D.Y. Chandrachud and comprising Justices Surya Kant and Bela Trivedi, said: "The All India Quota mop-up round of counselling shall stand cancelled. For the 146 additional seats which became available after AIQ round 2 on March 16, 2022, a fresh round of counselling shall be conducted as a special case. Students who have joined in round 2 either of the state quota or of the AIQ, will be at liberty to participate in the fresh round of counselling without any financial penalties."



The bench noted that pursuant to its order on March 30, the Union Government - the Ministry of Health and Family Welfare's Directorate General of Health Services - has proposed to set right the anomalies which were noticed in the order. It said in order to facilitate the expeditious completion of the process, the DGHS should invite options from students for the 146 new seats within 24 hours of the uploading of the notification and the process shall be completed within a period of 72 hours after the cut off for receipt of options.



# OVER 1.33 LAKH INDIANS WENT ABROAD THIS YEAR FOR HIGHER STUDIES: GOVT

A total of 1,33,135 Indian students went abroad for higher studies this year, as on March 20, the Parliament was informed on Thursday.

As per information received from Bureau of Immigration (BoI), the number of Indian students, who departed India for higher education in the current year, is 1,33,135 so far while there were 4,44,553 students in 2021 and 2,59,655 in 2020, Minister of State for External Affairs V. Muraleedharan told Rajya Sabha in a written reply.

He also said that according to information received from the BoI, the top preferred countries for education in 2021 were the US, Canada, and the UK.

He also said that granting visas is the sovereign right of a country and various countries have been granting visas to Indian students for studying in universities of their countries. However, if there is temporary restriction or delay in the grant of visa then the Ministry and the respective Indian Mission take it up proactively



with the country concerned.

Responding to a query from CPI-M member K. Soma Prasad, Muraleedharan said that the Student Module of the MADAD portal, launched on July 15, 2016 enables Indian students studying abroad or aspiring to study abroad to register voluntarily and provide information on their course, institutions, contact details, emergency contact etc.

His Ministry, through its missions/posts abroad have been regu-

larly interacting with Indian students studying abroad to register their details on the student module and also encouraging Indian student organisations and Indian community associations for the same including through social media platforms.

In response to another question, Minister of State for External Affairs Meenakshi Lekhi informed the House that overall, 22,500 nationals have returned to India since February 2022 after the Russia-Ukraine war broke

out in February.

"Around 40-50 Indian nationals are still in Ukraine, of which only a few are willing to return to India and their return is being facilitated by the Embassy."

She also informed that during the global Covid-19 pandemic, the government had launched the Vande Bharat Mission to repatriate Indian nationals and to facilitate the travel of passengers between India and other parts of the world.

"Around 2.97 crore passengers (inbound and out-bound) have been facilitated in the flights operated under the Vande Bharat Mission and Air Bubble Arrangements till date," Lekhi said Under Operation Devi Shakti, a total of 669 people were evacuated from Afghanistan. This included 448 Indian nationals, 206 Afghans (including Hindu and Sikh community members) and 15 people of other nationalities (Nepal, Lebanon and Uganda) in seven flights (six flights operated between August 16 to 25, 2021 and the last flight on December 10, 2021). All Indian nationals who had sought repatriation to India were evacuated, she added in her reply.

# Avian flu scare in Bihar's Supaul after bird carcasses found

The fear of avian influenza has spread in Bihar's Supaul district after a large number of crows and ducks were found dead on Thursday.

District Forest Officer Sunil Kumar Sharan said the dead birds were found in large numbers in Chapkahi village under Sadar police station of the district.

"The villagers informed us about a large number of birds found dead in the Chapkahi village. Accordingly, we sent a team of Forest and Animal Husbandry Departments to ascertain the situation.

During preliminary investigation, we have detected the symptoms of a disease in the crows and ducks," he said.

The villagers, after seeing birds were restless, had initially given medicines and injections of veterinary doctors but the birds did not recover.

"We have collected the samples of birds and sent them to the lab for testing. The process of burying the



birds is currently underway," Sharan said. "So far, there is no symptom of bird flu in the dead birds. Still, we have taken precautionary measures and alerted poultry forms to take precautions," he said. "In case any person

cooked it for food, the bird which died due to a disease may not affect human health but if birds died 2 to 3 days ago, it may affect human health as the virus may enter into the blood of a person who consumed it," he added.

# NHAI planning cashless treatment for road accident victims

In what may be a big relief to road accident victims, the National Highways Authority of India (NHAI) is planning cashless treatment for the victims, including drivers, passengers, pedestrians and cyclists, on identified national highway stretches between Delhi-Mumbai, Mumbai-Chennai, Chennai-Kolkata, Kolkata-Agra and Agra-Delhi corridors of the Golden Quadrilateral for treatment of bodily injuries caused due to road accidents.

The scheme will cover the immediate needs of hospitalisation of the victims for the first 48 hours from the time of hospitalisation or providing necessary treat-



ment, whichever occurs earlier, up to a cost of Rs 30,000 starting from the time of the ambulance reaching the accident site as recorded in the control room. The tender for the cashless treatment facility has been invited from the insurance companies registered with IRDAI or enabled by a Central legislation to undertake insurance-related activities for at least the last five years having a claim settlement ratio of not

less than 85 per cent in the last three years. Union Road Transport Minister Nitin Gadkari said in the Lok Sabha that the lessons from the implementation of this scheme may be extended to other national highways as well, and the success of the scheme may be assessed only after it is implemented on the ground following conclusion of the bidding process and on-boarding of the selected insurance company.

# 7 OF MARRIAGE PARTY KILLED IN ROAD ACCIDENT IN J&K'S POONCH

Jammu: Seven persons were killed and several others injured on Thursday in a road accident in J&K's Poonch district, officials said. Official sources said a Tata Sumo carrying guests of a marriage ceremony was going to Buzliyaz from Surankote when it went out of the driver's control and fell into a deep gorge at Tarran Wali.

"Initial reports said seven persons have died in this accident and many others injured. Rescue teams have rushed to the spot. Further details are awaited," a source said.

# Gold bars weighing 700 grams seized at Hyderabad Airport

Customs officials at Rajiv Gandhi International Airport here seized nearly 700 grams of gold from a passenger who arrived from Dubai on Thursday.

Six gold bars weighing 699.5 grams and valued at Rs 37.30 lakh were detected and seized from a male passenger who arrived by Air India flight AI-952 from Dubai, Customs officials said.

He had concealed the gold in his check-in baggage. Further investigation was on. This is the third gold seizure by Customs at Hyderabad Airport this week. On Tuesday, Customs officials had detected and seized 231.5 grams of gold, valued at Rs 12.33 lakh, from a male passenger who arrived by AI-952 from Dubai. The gold was coated with rhodium and concealed as small rings



between beads of two neck chains hidden in garments in check-in baggage.

Earlier, on March 26, 255.6 grams of gold, valued at Rs 13.63 lakh, was seized from a male passenger who

arrived by 6E-25 from Dubai. According to Customs officials, the gold was coated with silver and concealed inside the supporting metal frame of the trolley bag.

# ABOUT 1/3RD OF INDIA'S COASTLINE FACES EROSION

About 33.6 per cent of the coastline is under varying degree of erosion, an analysis of the total 6,632 kms long Indian coastline of the mainland from 1990 to 2018 has found, the Rajya Sabha was informed on Thursday.

The National Center for Coastal Research (NCCR), an attached office of the Ministry of Earth Sciences (MoES) has been monitoring the shoreline erosion since 1990 using remote sensing data and GIS mapping techniques.

On the western coast, Kerala with 275.33 kms shoreline has lost 46.4 per cent to erosion while on the eastern coast, West Bengal



with 323.07 coastline, has lost 60.5 per cent to it. The reasons for coastal erosions include increase in

frequency of cyclones and sea level rise and anthropogenic activities such as construction of harbours,

beach mining and building of dams, Union Minister of State (Independent Charge) Earth Sciences Jitendra

Singh said in a written reply to a question in the House.

There are 526 maps prepared for the entire Indian coast for identifying areas vulnerable to coastal erosion in 1:25000 scale along with 66 district maps, 10 state/UTs maps. A Report on 'National Assessment of Shoreline Changes along Indian Coast' was released in July 2018 and shared with various Central and state government agencies and stakeholders for implementing shore line protection measures. The MoES had successfully demonstrated innovative coastal erosion mitigation measures at two pilot locations: Puducherry Beach Restoration Project, Puducherry and Kadalur Periyar Kuppam, Tamil Nadu.

# Delhi HC dismisses plea seeking Bharat Ratna for Ratan Tata

The Delhi High Court on Thursday turned down a plea seeking conferment of Bharat Ratna, the highest civilian award, on former Tata Sons chairperson and philanthropist Ratan Tata for his service to the nation.

The Public Interest Litigation (PIL) came before a division bench headed by Acting Chief Justice Vipin Sanghi and also comprising Justice Navin Chawla.

However, the bench asked the petitioner's

counsel to withdraw it or else will impose cost, stating it is not for the court to interfere in the matter. The bench told the petitioner to approach the government if he wants. "Is it for us to decide who the Bharat Ratna should be awarded to? You either withdraw or we will impose cost," the bench said.

Highlighting the philanthropic work of Tata and his company, the petitioner Rakesh, who claimed to be a social activist said in the plea: "Ratan Tata is a great businessman and under his leadership, the business focused on global expansion. After retiring as Chairman of Tata Sons in 2012, Ratan Tata has been active in investing, in a personal capacity, in startups and encouraging young entrepreneurs." It also stated that in March 2020, Ratan Tata had pledged Rs 500 crore from Tata Trusts to fight the Covid-19 pandemic.

The revenue of Tata Group's 30 companies in FY20 was \$106 billion. "The 30 companies spread across 10 clusters operates in over 100 companies and collectively employ more than 7.5 lakh people," the petition read.

# Nitish Kumar's comments on Rajya Sabha wish triggers speculation

Bihar Chief Minister Nitish Kumar has expressed his desire that he would like to serve as a Rajya Sabha member one day, triggering massive speculation about his political future.

While interacting with media persons in Patna, Kumar said he has served as a Lok Sabha member and became a cabinet Minister at the Centre. He also became an MLA and was elected as a Member of Legislative Council in Bihar and held the responsibility of Chief Minister of the state.

"I served in Lok Sabha, Vidhan Sabha and Vidhan Parishad in Bihar but never served as a Rajya Sabha member. It is my wish that I would serve as Rajya Sabha member one day. At present, I would not think of it," the



Janata Dal-United supremo added.

Kumar wants to match his political rival Lalu Prasad and friend Sushil Kumar Modi,

who have served in both the Houses of Parliament and state Assembly.

The political analysts believe that Nitish Kumar never says anything without reason. He knew that the post of Vice-President will be vacant in the next few weeks. Therefore, he wants a respectful exit from the politics of Bihar.

During the 2020 Assembly election, Nitish Kumar's party JD-U managed to win only 45 seats, at the third number in the ranking of number of seats. Still, he managed to bargain with the BJP and retained the position of Chief Minister of Bihar.

The alliance with the BJP is not that smooth in Bihar. The BJP has been targeting him on the issues of deteriorating law and order situation, poor implementation of the liquor ban, among many other issues for quite some time.

# World's biggest banks 'continue' to pour billions into fossil fuel

The 13th annual Banking on Climate Chaos report, the most comprehensive global analysis on fossil fuel banking to date, underscores the stark disparity between public climate commitments being made by the world's largest banks, versus the reality of their largely business-as-usual financing to the fossil fuel industry.

The report, released on Thursday, documents that in the six years since the Paris Agreement was adopted, the world's 60 largest private banks financed fossil fuels with \$4.6 trillion, with \$742 billion in 2021 alone. 2021 fossil fuel financing numbers remained above 2016 levels, when the Paris Agreement was signed.

Of particular significance is the revelation that the 60 banks profiled in the report funneled \$185.5 billion



just last year into the 100 companies doing the most to expand the fossil fuel sector. 'Banking on Climate Chaos' was authored by Rainforest Action Network, BankTrack, Indigenous Environmental Network, Oil Change International, Reclaim Finance, Sierra Club, and Urgewald,

and is endorsed by over 500 organisations from around the world.

The report shows that overall fossil fuel financing remains dominated by four US banks, with JPMorgan Chase, Citibank, Wells Fargo, and Bank of America together accounting for one quarter of all fossil fuel financing

identified over the last six years. JPMorgan Chase remains the world's worst funder of climate chaos, while JPMorgan Chase, Wells Fargo, Mizuho, MUFG, and all five Canadian banks were among those that increased their fossil financing from 2020 to 2021. As global oil and gas markets are rocked by Russia's invasion of Ukraine, the data reveal JPMorgan Chase to be the biggest banker covered in this report for Russian state energy giant Gazprom, both in terms of 2016-2021 totals and when looking only at last year. Chuck Blagden, 350.org Regional Finance Campaigner said: "While China may have begun to lead the way on low-carbon development, their banks are lagging far behind. If banks like ICBC truly want to be global leaders, they need a robust fossil fuel financing exclusion policy that is on par with China's goals for carbon neutrality."

Women carry body on cot in MP's Rewa, hospital says no vehicle available

Four women carrying the body of their relative walked from a community health centre to their village to perform the last rites in Madhya Pradesh's Rewa district. While the women carrying the body were heading towards their village on a national highway, a passerby made a video and uploaded it on a social media site.

and Health Officer, Dr B L Mishra said the health centre staff were trying to arrange for a hearse or an auto, but the family decided to carry the body on the cot and left in a hurry.

"It's not a big deal, we don't have a hearse van in the area," Dr Mishra said. According to district administration officials, the lack of vehicles to ferry patients to the Community Health Centre has caused problems in the past as well.

This kind of an incident, where people carry patients, pregnant women or bodies on a cot, cycle or two-wheelers is common in Madhya Pradesh's rural areas.

For instance, two days back a woman delivered a baby boy on the side of a road after a 108 Ambulance, the state government-run Janani Express, failed to take the woman to the hospital in Khargone district.

TWO NEW CENTERS OF THE WORLD

The Russian invasion of Ukraine and a series of Covid-related shutdowns in China do not, on the surface, appear to have much in common. Yet both are accelerating a shift that is taking the world in a dangerous direction, splitting it into two spheres, one centred on Washington, D.C., and the other on Beijing, author Michael Schuman wrote in *The Atlantic*. China's leaders have already been unwinding their ties to the world. In recent years, Chinese President Xi Jinping has set in motion policies aimed at creating a new Pax Sinica—an altered world order built by Beijing. With a newly aggressive foreign policy, Xi has apparently come to see the US as China's chief strategic and economic adversary, and the US-led global system as a constraint on Chinese power. He has taken steps to decrease his country's reliance on (and thus vulnerabilities to) the US and its allies, stressing a "self-sufficiency" campaign to ensure that China controls the production of items key to the economy by securing supply chains and replacing imports with homegrown alternatives, including microchips and jumbo jets. As NATO solidifies in Europe, in Asia the Quad, a partnership that includes Australia, India, Japan, and the US, is coalescing into a China-containment club. Simultaneously, Beijing's continued support for Moscow is forming the axis of an anti-West coalition, which already includes other destabilisers such as Belarus and North Korea. As the global divergence continues, however, countries will gravitate toward one side or the other, and (as during the Cold War) not necessarily on clear ideological grounds. Vietnam, fearful of rising Chinese power, is open to American overtures, while Pakistan, a Cold War ally of Washington's that is now heavily linked to China through Belt and Road investments, has effectively become a client state of Beijing.

# HOW NEW DELHI CAN DRIVE KATHMANDU'S POLICY OF STRATEGIC DIVERSIFICATION

Nepal Prime Minister Sher Bahadur Deuba is set to arrive in India on a three-day visit on April 1, aimed at inking cross-border connectivity and healthcare projects. Additionally, it has also been reported that Deuba and his Indian counterpart Narendra Modi are likely to inaugurate the Kurtha-Jayanagar Railway Project, a 35-km stretch that will link Kurtha in Nepal to Jayanagar in Bihar.

India and Nepal share a deep historical bilateral relationship which has continued to strengthen over time, given the high number of geopolitical and socioeconomic convergences between the two.


The outstanding border issues between the neighbours are also likely to be discussed during Deuba's visit, thus opening doors for a productive dialogue on the same and contributing towards a rejuvenated relationship between New Delhi and Kathmandu.

As Nepal tries to vie for a policy of strategic diversification aimed at reducing external dependence, the visit has the potential to further strengthen the relations between the two neighbours, provide room for India to be the driver for Nepal's domestic growth and confront the existing issues of divergence.

It will also boost Indian government's commitment to its Neighborhood First policy and secure a stable relationship with Nepal in an otherwise volatile environment in the region marred by the Russia-Ukraine crisis and Chinese aggression. Boosting Connectivity: Building on the Janakpur Bond

As per reports, the key project that the two sides shall be inaugurating during Deuba's India visit is the Kurtha-Jayanagar railway project, part of the 68.72 km Jayanagar-Bijalpur-Bardibas rail link built under the aegis of the Indian government at a grant assistance cost of NPR 8.77 billion.

With its inauguration, the railway project will establish the first modern railway network in Nepal and provide a much needed boost in bilateral trade, investment, people-to-people exchange, tourism and cultural diplomacy, and strengthening the overall connectivity between the two countries. Addressing the handing over ceremony of the railway link in 2021, the Nepalese Physical Infrastructure and Transport Minister had remarked that the project will bring modernisation in Nepal's



railway system.

India and Nepal share a deep historical relationship that has widened over the years and the Kurtha-Jayanagar railway project builds on a major cultural and religious bond - the Janaki Mandir in Janakpur, Nepal.

This temple, widely revered by Hindus for pilgrimage in countries like India, Nepal, Sri Lanka etc., will receive a huge tourism and financial impetus due to the inauguration of the railway link. The reason for its importance for Hindus across the world stems from the fact that Lord Ram's wife Sita was identified to be born in Janakpur, thus linking Ayodhya in India (Lord Ram's birthplace) and Janakpur in Nepal. Thus, the Kurtha-Jayanagar railway link will serve as the new foundation for a renewed India-Nepal relationship that will extend to other areas as well. Testimony to this can be attached due to the fact that during Deuba's planned visit, other projects including, but not limited to launching of 137 health posts in the aftermath of 2015 Nepal Earthquake through Indian assistance, are also set to be launched that will further enhance the bilateral relationship.

In this regard, India and Nepal have done well to rejuvenate and reboot their relationship in the last one year through various measures, thus sowing the seeds for a productive visit by Deuba. In 2021, India had gifted Nepal one million domestically manufactured Covishield vaccines to contain the spread of coronavirus. New Delhi also provided grant assistance of Rs 30 crore (approx.) to Nepal for the reconstruction of educational institutions rocked by the 2015 earthquake.

In a goodwill gesture, the Indian government conferred General Prabhu Ram Sharma of Nepal with the rank of 'General of Indian Army' during his visit to India in 2021. Also, at the end of 2021, Indian Foreign Minister had announced the completion of construction of 50,000 houses that had been earlier destroyed in the wake of the 2015 earthquake in Nepal.

Lastly, three power substations built by India at a Line of Credit of \$250 million were also executed recently in March. Such measures have made sure that Nepal receives adequate amounts of grant assistance in areas critical to its economic recovery in a post-pandemic world. The visit by Deuba will provide further momentum to bilateral trade and investment between the two countries through connectivity and infrastructure projects. Driving Nepal's Policy of Strategic Diversification and Securing the Neighborhood Nepal has been facing a dilemma in its bid to balance its dependence on foreign powers since its inception. In recent years, its tenacity and commitment to achieving strategic diversification, wherein it reduces its dependence and at the same time, receives grant assistance in critical areas without getting caught in-between a geopolitical powerplay, has increased. India, being Nepal's longest and most trusted friend, now has the opportunity to drive this policy shift while strengthening its own bilateral relationship with Kathmandu.

Firstly, on the economic front, India and Nepal's infrastructure projects and grant assistance in various sectors

will serve as a major source of income and investment for Kathmandu, which will in turn help it achieve economic growth. This will reduce its dependence on foreign aid and loans that may increase the risk of future debt-traps and strategic leverages that undermine its geopolitical independence.

Plus, India's 'grant assistance model' will make sure that Nepal receives investment in a legitimate way without compromising its economic independence.

At the same time, this visit should also be utilized for identifying further areas of cooperation in the realms of energy, connectivity and maritime domains. In this context, the meeting of Indian External Affairs Minister S. Jaishankar with his Nepali counterpart Narayan Khadka on the sidelines of the 18th BIMSTEC Ministerial Meeting in Colombo was fruitful and the regional forum can be further leveraged to drive deeper convergences between India and Nepal and its regional partners like Bhutan, Bangladesh, Myanmar, Sri Lanka and Thailand. This will also ensure India's commitment to the Neighborhood First policy and strengthen its Act East and Indo-Pacific policies. Finally, New Delhi needs to make sure that it hits the right notes during Deuba's visit and addresses the elephant in the room that currently exists in the form of border disputes with Kathmandu. To achieve this, both sides should aim to establish a joint mechanism to resolve the border issue at the earliest possible - the revival of the 2014 idea floated by Narendra Modi for foreign secretary-level talks for this purpose can definitely be explored again. While ensuring Nepal's economic growth, such an overture will also help India secure its national interests at a time when it is facing Chinese aggression across the Line of Actual Control (LAC).

India's former Ambassador to Nepal, Shyam Saran's words are telling in this regard, "Stability in Nepal is in the best interests of India." ### PAKISTAN NATIONAL ASSEMBLY SESSION ADJOURNED TILL SUNDAY

The crucial session for the no-confidence motion against Prime Minister Imran Khan which started after much delay was adjourned till Sunday, Geo News reported.

The Pakistan National Assembly Secretariat had issued the order of the day for Thursday on Wednesday night, with a discussion on the no-trust move against the premier on the session's agenda. The session was held under the chairmanship of NA Deputy Speaker Qasim Suri, with more than 172 members from the Opposition benches in attendance.

As the session kicked off, during the question and answer session, all the Opposition members demanded the deputy speaker allow voting on the no-confidence motion.

At this, Suri said due to the "non-serious" attitude of the Opposition lawmakers, the session is being adjourned till Sunday - almost 10 minutes after it had started, Geo News reported. PM Imran Khan has seemingly lost the majority in the lower house after PTT's allies MQM-P, BAP, JWP, independent MNA from Balochistan Aslam Bhootani decided to side with the Opposition.

The prime minister, after the allies started leaving the government's camp, has time and




again repeated that he will not resign and "fight till the last ball". PM Imran Khan, who waved a "threat letter" at a March 27 rally in Islamabad, has said that the memo warned the country of the consequences if the no-confidence motion does not pass.

### PAK OPPOSITION CLAIMS IMRAN KHAN SEEKING SAFE EXIT IN EARLY ELECTIONS

As Pakistan faces a highly fluid political situation, Prime Minister Imran Khan has sought safe exit for himself by offering to hold early elections, the Pakistan Muslim League-Nawaz has claimed. PML-N's Shehbaz Sharif and Rana Sanaullah have revealed at the opposition parliamentary party meeting that Imran Khan has made the offer through an "important person" of the country, Samaa TV reported. Sharif said that the prime minister is now proposing something what the opposition had demanded earlier, but it was too late. "The issue will be decided through the vote in the Parliament" on the no-confidence motion against Imran Khan, he said. Imran Khan has reportedly offered that if the opposition withdrew its no-confidence motion, he would dissolve the National Assembly and hold early elections, but if the opposition pressed ahead with the no-trust vote, he would fight them until the end. Meanwhile, PPP Chairman Bilawal Bhutto Zardari has said that he wants to send a clear message to Imran Khan that no NRO would be offered to him and the only honourable exit for him was to step down immediately, paving for Shehbaz Sharif to be elected as the new Prime Minister. The Pakistan Opposition on Thursday submitted a petition to include the election of a new Prime Minister in the agenda of the National Assembly, Dunya TV reported.

### SANCTIONS AGAINST RUSSIA COULD UNDERMINE GLOBAL DOMINANCE OF US DOLLAR: IMF

Moscow: Sanctions against Russia could undermine the global dominance of the US dollar, according to Gita Gopinath, the First Deputy Managing Director of the International Monetary Fund (IMF).

"The dollar would remain the major global currency even in that landscape, but fragmentation at a smaller level is certainly quite possible," Gopinath said in an interview with the Financial Times, RT reported. She added that some countries are already renegotiating the currency in which they are paid for trade. Russia and India are currently preparing a rupee-ruble mechanism which would allow them to trade in national currencies while evading the dollar. According to Gopinath, the radical restrictive measures introduced by Western countries amid Russia's military operation in Ukraine could lead to the emergence of small currency blocs based on trade between individual groups of countries. Furthermore, the use of currencies other than the dollar or the euro in global trade would lead to further diversification of the reserve assets held by the central banks.

The "hellish" sanctions imposed on Russia by the US, EU, and their allies over the conflict in Ukraine have failed to cripple the country, but are instead "returning to the West like a boomerang", Medvedev, who is now the Deputy Chairman of the Russian Security Council, said, RT reported.

### TUNISIAN PRESIDENT DISSOLVES PARLIAMENT

Tunisian President Kais Saied announced the dissolution of the Assembly of People's Representatives, or Parliament.

The announcement was made by Saied in a speech broadcast on state television Wataniya 1 late Wednesday night, reports Xinhua news agency.

"The state is targeted by a desperate coup attempt... My responsibility is to protect the state, its institutions, and its people," the President said.

Saied referred to Article 72 of the country's Constitution, which states that "the President of the republic is the head of the State and the symbol of its unity, guarantees its independence and continuity and ensures respect for the Constitution."

Describing an earlier meeting of Parliament as "illegal", he said it "has already been suspended since last July" and its session has "no legitimacy".

The Tunisian head of state warned against any attempt to sow chaos and internal division.



"Solid institutions and a conscious people will be there to counter any plot against national security, and all the authors of this plot will be prosecuted in justice according to the regulations in force," said the President.

"We will pursue the construction of a new Tunisia... The legitimacy will be that of the people," he added.

On July 25, 2021, Saied sacked former Prime Minister Hichem Mechich and suspended all activities of Parliament.

More than half of the 217-seat Parliament voted on Wednesday in a symbolic online session to revoke presidential decrees halting the functions.

Moscow: A new financial order will be negotiated in the world, and the West won't have the main say in it anymore, ex-Russian President Dmitry Medvedev has claimed.

The "hellish" sanctions imposed on Russia by the US, EU, and their allies over the conflict in Ukraine have failed to cripple the country, but are instead "returning to the West like a boomerang," Medvedev, the former Russian president who is now the deputy chairman of the Russian Security Council, said, RT reported. According to Medvedev, the US and EU have "tarnished their reputation" by blocking the reserves of the Russian central bank. "It is impossible to trust those who freeze the accounts of other states; steal other people's business, assets and personal possessions, compromising the principles of sanctity of private property."

After the outbreak of the conflict in Ukraine in late February, the US and EU froze nearly half of Russia's foreign currency reserves, worth \$300 billion. Confidence in reserve currencies is "fading like the morning mist," and the prospect of abandoning the dollar and euro in this role does not seem like such an unrealistic prospect anymore, he said. "The era of regional currencies is coming."

"No matter if they want it or not, they'll have to negotiate a new financial order," Medvedev said. "And the decisive voice will then be with those countries that have a strong and advanced economy, healthy public finances and a reliable monetary system. And not with those who endlessly inflate their public debt, issuing more and more pieces of paper into circulation which aren't backed by national wealth."

A team of ED along with a posse of the CRPF and local police, landed at the Uke residence around 5 a.m., and launched the search operations.

Uke is famed for running a campaign against Bharatiya Janata Party's Leader of Opposition Devendra Fadnavis, and filing at least two election petitions against him.

Earlier, he represented a RTI activist Mohnish Jabalpure who had lodged two complaints with the ED in August-September 2019, demanding a probe against Fadnavis for various



alleged actions favouring his wife Amruta, working for the private sector entity, Axis Bank.

Among other things, Jabalpure had accused Fadnavis of allegedly misusing his position as the (then) chief minister to transfer the salary accounts of various government departments from public sector

banks to the Axis Bank ostensibly to favour his wife and the Axis Bank.

"Its nearly 3 years now since my complaints, but the ED has not taken any action in the matter, although I have provided all evidence to them," Jabalpure said. Prior to that, in 2018, Uke had filed a plea in the Bombay High Court seeking compensation

for the family of the CBI Judge B. H. Loya who died in Nagpur on December 1, 2014.

Subsequently, Uke was arrested for certain alleged offences committed over 17 years ago. Only last week, Uke was engaged as the lawyer of Congress state President Nana Patole in a Rs 500-crore defamation case filed against IPS officer Rashmi Shukla in the sensational phone-tapping case. However, it is not immediately clear for which particular case Uke is being probed by the central agency, though there's speculation over a property transaction that is reportedly under the ED scanner. Shiv Sena Chief Spokesperson and MP Sanjay Raut slammed the ED raids at Uke's home and said since he is the lawyer of the state Congress chief, "it wouldn't be surprising if Patole is also raided." Raut - who met Uke last week here reiterated how the Centre and BJP are blatantly misusing official machineries especially in Maharashtra, in their attempts to topple the Maha Vikas Aghadi government with the help of the central probe agencies. "A strange situation is witnessed in which those who provide information and evidence are being punished while the guilty are getting away scot-free. In my complaint, nobody from the PMO has taken any action despite furnishing evidence against the ED," Raut told media-persons in New Delhi.

From April 2 -- the Maharashtra New Year day -- the provisions of the stringent Disaster Management Act and Epidemic Diseases Act, enforced in March 2020, shall no longer be implemented in the state.

Accordingly, there will be no curbs on public movement, social, religious or political gatherings, weddings, funerals, visits to malls, cinemas, shopping plazas, hotels, restaurants, swimming pools, gyms, sports activities, travelling by trains, buses or other public modes of transport, to and from workplaces, parties, picnics, vacations, etc. The decision was taken unanimously at a Cabinet meeting presided over by Thackeray this afternoon in view of the huge decline in Covid-19 cases as the third wave is on its last legs after four months.

However, the Maha Vikas Aghadi (MVA) government has recommended physical distancing and voluntary wearing of face-masks as a precaution, though there will be no penalties for defaulters. Ministers and top Leaders of the MVA allies, Shiv Sena-Nationalist Congress Party-Congress like Deputy Chief Minister Ajit Pawar, Eknath



Shinde, Anil Parab, Dilip Walse-Patil, Jayant Patil, Prof. Varsha Gaikwad, Aslam Shaikh and others warmly welcomed the move.

It may be recalled that the state had gone into a lockdown on March 24, 2020, followed by the nationwide lockdown, and after the first few months of stringent restrictions, the curbs were lifted in stages during the first, second and third waves.

Health Minister Rajesh Tope said that while visiting crowded venues, it is advisable to wear face-masks and Minister of State for School Education Omprakash alias Bacchu Kadu said school students must continue with face masks as a precaution.

Commoners across the state greeted the government step heartily and expressed relief that now they would not be subjected to arbitrary fines, penalties or cases for flouting the Covid-19 norms, and can freely move around anywhere at any time without any fear as they did prior to March 2020. It may be recalled that Maharashtra remains the worst-hit in the country notching 78,74,024 cases in the past two years and a staggering 147,783 deaths -- higher than countries like France and Iran.

State Congress President Nana Patole flayed the manner in which the central probe agencies are being

deployed "to silence voices raised against the BJP and the Centre" and now the courts must intervene on their own to protect the country's democratic system.

The comments came while referring to the raids on prominent Nagpur-based lawyer Satish Uke by the Enforcement Directorate (ED), who is fighting Patole's Rs 500 crore defamation suit against IPS officer Rashmi Shukla in the infamous phone-tapping case. "He is our lawyer in this (defamation) case. He filed the petition. Now suddenly the ED has raided his house and confiscated the case file, laptops, mobiles, etc, and detained him. Adv Uke was also working on other cases including the suspicious death of Judge B.H. Loya and this action is to suppress all who speak out against the BJP," Patole said. He said the

central probe agencies are straying from their functions like probing international money-laundering scams, drug trafficking, FEMA, FERA violations, terror funds, human trafficking or flesh trade. Patole accused the Centre of using the central agencies to intimidate the Opposition parties by such actions and attempting to topple duly elected state governments. "Democracy has been overthrown and replaced by a dictatorship, an undeclared state of Emergency exists in the country. We humbly appeal to the courts to step forward and help save democracy," Patole implored. To a query whether he would be targeted next by the ED, the Congress chief said he "would welcome" the probe agency, but it is time for all to unitedly oppose and fight the pressure mechanism of the BJP.

Special NDPS Judge V.V. Patil accepted the plea by the Special Public Prosecutor Advait Sethna that there were certain compelling reasons for seeking extra time to file the chargesheet. These include non-cooperation by

the accused in revealing their passwords, the need to record afresh the statement of a 'witness' K.P. Gosavi who is himself accused of corruption and cheating, and currently in custody of Pune Police, and time to record the statements of 15 suspects. Sethna further argued that since the NCB application has been filed within the 180-day period after the raids, the accused (two, who remain in custody) would not be entitled to default bail even if the order came later.

It may be recalled that on October 2, 2021, the NCB sleuths led by the then Mumbai Zonal Director Sameer Wankhede had swooped on the

Cordelia Cruise ship off Mumbai harbour and detained over half a dozen persons, including Aryan Khan and other celebs.

Later, on October 3, the NCB arrested Aryan Khan though nothing was recovered from him, his friends Arbaaz Merchant, Munmun Dhamecha, and another 17 persons including guests and drug peddlers were also nabbed (total 20).

Four weeks later, on October 28, the Bombay High Court granted bail to Aryan Khan observing that there was no prima facie evidence to show that he and Merchant had conspired to commit offences under the NDPS Act.

Subsequently, Minister Nawab Malik -- arrested by the ED in February -- had made a serial expose questioning the alleged 'farzi' (fake raids) which were intended to seek publicity and extort money, plus ran a huge campaign against Wankhede.

The NCB was further embarrassed when a witness Prabhakar Sail made stunning allegations of extortion and pay-offs involving another 'witness' Kiran Gosavi, alleged Bharatiya Janata Party activists present during the raids, etc.

Following these developments, the case was taken over by a NCB Delhi's Special Investigation Team which is currently probing.



RS 4 CRORE SEIZED FROM CAR NEAR LONAVALA

The Pune rural police have said they seized cash worth Rs 4 crore from a car intercepted on the Pune-Mumbai Expressway near Lonavala in the early

hours of Tuesday. The police said that the seizure had been referred to the Income Tax department and an initial probe suggested that cash belonged to a bullion trader from Sangli district.

Superintendent of police for Pune rural jurisdiction, Dr Abhinav Deshmukh said: "We had received information that some weapons and cash were being transported in a car. Based on the specific input, a checkpoint was set on the expressway in Lonavala and a car was intercepted in the early hours of Tuesday. In the thorough search of the car, we seized cash worth Rs 4 crore. Two people were in the car."

Deshmukh added: "As per the procedure, a record of the seizure was made at the local police station and the case has been referred to the Income Tax department for further inquiry. The probe suggests that cash belongs to a bullion trader from the Sangli district. In such cases, the owner has to present proof of the legitimacy of cash transport to the IT department. If the IT officials are satisfied with the reasoning, then the cash is released. Otherwise, action is initiated as per the legal provisions. In case it comes to light if the cash is from the proceeds of a crime, the case is referred back to us."

IN VIRAL AUDIO, BJP MLA 'THREATENS' MSEDCL OFFICIAL WITH I-T RAIDS

An audio clip has surfaced on social media, in which Maharashtra BJP MLA Babanrao Lonikar is purportedly heard threatening an MSEDCL official with Income Tax raids for allegedly disconnecting the power supply of his residence located in Aurangabad. The alleged foul language used by

the BJP leader prompted state Energy Minister Nitin Raut to ask authorities to lodge a complaint against him.

However, Lonikar, a former Maharashtra minister, issued a denial claiming that the audio clip was fake and there was an attempt to tarnish his image through it. In the audio clip of the purported phone conversation, Lonikar, who currently represents the Partur Assembly constituency in Jalna district of the state, is heard asking the Maharashtra State Electricity Distribution Company Ltd (MSEDCL) engineer that the power supply of his bungalow in Aurangabad was snapped and the meter box was taken away although he has paid Rs 10 lakh outstanding bill amount this year.

During the conversation, Lonikar also asked why the MSEDCL officials

do not cut the electricity supply in slum areas, where people steal power by putting hooks on the overhead transmission lines. "The audio clip is fake and it has been created with the aim of tarnishing my image. I have one residence in Aurangabad, but the MSEDCL did not disconnect its power supply and its meter was not seized, hence there is no question of me threatening any official. This is a bogus recording and it is a conspiracy to defame me," he claimed. He, however, said that he was opposed to the MSEDCL's drive of the recovery of outstanding power bills from the poor and farmers. "The MSEDCL officials are doing it under the pressure of the government. They should stop of the recovery bills from the poor and farmers," he

said. "The kind of language he used while talking to the official is shocking. He has been in public life for 30 years and has been state cabinet minister. His behaviour has exposed the party (BJP) that claims to be civilised," Raut, a Congress leader, said. "Lonikar's claim of paying Rs 10 lakh arrears is misleading. The dues of his both the houses are still as high as Rs four lakh. He has not even paid the bill for more than a year," he said. On being contacted, MSEDCL's joint managing director in Aurangabad, Mangesh Gondavale, told PTI, "All the consumers are expected to pay their bills. I have sought the details of this matter (Lonikar's conversation). I will examine it and accordingly we shall act on it."

One notable new bit of information is the Academy stating they asked Will Smith to leave the Dolby Theatre but Smith refused to do so.

One of the biggest bits of scrutiny regarding the handling of the moment was Smith not being removed from the auditorium. The Academy has offered clarification saying Smith was asked to leave but refused. "We also recognise we could have handled the situation differently," the Academy statement read. The organisation also offered a formal apology to Rock, the other nominees who attended the ceremony and the viewers at home and in person who witnessed the event.


"As a result of this and with much consideration, Bruce is stepping away from the career that has meant so much to him."

In the end the platform set up by Uthappa and Dube helped CSK cross the 200-run mark with skipper Ravindra Jadeja and his predecessor M.S Dhoni landing a few lusty blows towards the end.

## WOMEN'S WORLD CUP England reach final after a superb 137-run victory over South Africa

On the back of a magnificent 129 from opener Danni Wyatt and a career-best 6/36 by left-arm spinner Sophie Ecclestone, defending champions England on Thursday reached the final of ICC Women's Cricket World Cup with a superb 137-run over South Africa at Hagley Oval.

It continues the remarkable upward swing of England, who began their title defence with three losses but fought back to win next five matches in a row, including Thursday's semi-final, to storm into their second straight World Cup final. They will now meet Australia in the final at the venue of their semifinal win on Sunday. Chasing a mammoth 294 in a high-pressure knockout match, South Africa were never in the chase from the word go. Pacer Anya Shrubsole removed both openers, Laura Wolvaardt and Lizelle Lee, cheaply in her first two overs. Wolvaardt, the leading run-scorer in the tournament, departed without



troubling the scorers. Lara Goodall and captain Sune Luus tried to resurrect the South Africa innings. But England struck back as Kate Cross cleaned up Luus while Goodall tried to scoop against Charlie Dean, but the ball shattered her stumps. From 67 for 4, Ecclestone ran through the rest of the batting line-up with all six wickets as South Africa crumbled to 156 all out in 38 overs. Earlier, England posted an imposing 293/8, thanks to Wyatt's knock laced with 12 boundaries. She had plenty of luck on her side as she was roped five times in the

innings (22, 36, 77, 116 and 117), including twice in an Ayabonga Khaka over. The reprieve meant Wyatt took the attack to South Africa's bowlers and put their usually tight fielders under pressure in a rematch of a thrilling 2017 World Cup semi-final.

## MIAMI OPEN SWIATEK BEATS KVITOVA, ENTERS INTO SEMIFINALS

World No.2 seed Poland's Iga Swiatek advanced to the Miami Open semifinals after defeating Petra Kvitova 6-3, 6-3 in the quarterfinals on Wednesday (IST).

The 20-year-old is into her tour-leading fifth semifinal of the season and third straight at the WTA 1000 level. Swiatek joins Caroline Wozniacki, Victoria Azarenka, and Jelena Ostapenko as the only players to have made four or more WTA 1000 semifinals before their 21st birthdays. The Polish star, who is set to rise to World No.1 after Miami, will face 16th seed Jessica Pegula on Friday night for a spot in her third consecutive WTA 1000 final.

Swiatek's run to her first Miami semifinal has been nothing short of dominant. Coming off her back-to-back titles in Doha and Indian Wells,



Swiatek has lost a total of 15 games over four matches and has not dropped more than three games in a set in Miami. Her victory over No.28 seed Czech Kvitova was her tour-leading 24th of the season (24-3). Swiatek continued to pressure

Kvitova's serve through the second set. The Czech buckled down to save four break points to hold 2-1. Swiatek went on to grab a third and final break after 1 hour and 17 minutes to seal her eighth consecutive win over a left-handed opponent.

### CASPER RUUD DEFEATS ALEXANDER ZVEREV, ENTERS INTO SEMIS

Miami: The Norwegian Casper Ruud earned his first win against second seed Germany's Alexander Zverev 6-3, 1-6, 6-3 in the Miami Open on Wednesday (IST) to advance to a semifinal showdown against Argentine Francisco Cerundolo. Now the 23-year-old will have a big opportunity against World No. 103 Cerundolo, who had never previously competed in a Masters 1000 main draw or won a tour-level match on hard court. This will be the pair's first ATP clash. When the Norwegian received treatment on his right foot, which he later said was because of taping on his toe, the momentum was firmly in Zverev's corner. Ruud never panicked, though.

## Powerlifters Sudhir, Jaideep shine as Haryana top with six gold medals in Nationals

Asian Para Games medallist Sudhir and Jaideep, who represented India at the Tokyo 2020 Paralympics, clinched gold medals as Haryana topped the medals table with six gold medals at the 19th Senior and 14th Junior National Para Powerlifting Championship 2022 held at Netaji Subhas Eastern Centre, Kolkata.

Overall Haryana won 11 medals that also included three bronze and two silver. Haryana was followed by Tamil Nadu, Punjab, Delhi and UP with three gold medals each.

In the men's under 88kg category, Sudhir lifted an impressive 232kg enough to take the gold way ahead of Delhi's Joginder Singh (150kg) and Bihar's Mahan Aditya (145kg).

Jaideep, competing in men's under 72kg, lifted 151kg for the gold finish-



ing ahead of Gujarat's Ramubhai Bambhava (150kg) and Delhi's Kuldeep Kumar (146kg).

The other gold medallists for Haryana were Ashok (men's -65kg), Deepak (men's -80kg), Pradeep Joon

(men's -107kg) and Geeta (women's -73kg).

In men's under 49kg finals, World Championships medallist Paramjeet Kumar from Punjab came out with one of his best shows lifting 165kg for the gold. His lift was way ahead of his Worlds bronze medal effort as he finished ahead of Gujarat's Dilip Shukla (118kg) and Delhi's Gulfam Ahmed (118kg).

Seasoned powerlifter Farman Basha, an Asian Para Games medallist, was also in action representing Karnataka claiming the gold in men's under 54kg event.

In the women's event, Asian Para Games silver medallist Shakina Khatun of Karnataka took the under 50kg event gold with her third successful lift of 95kg. Tamil Nadu's Gomathi (58kg) and Sapna Shah of Gujarat (52kg) finished second and third, respectively.
