CBI RAIDS DELHI DY CM MANISH SISODIA'S RESIDENCE, 21 OTHER LOCATIONS TRIGGERS

COUNTER CHARGES

The Central Bureau of Investigation (CBI) has named Delhi's Deputy Chief Minister Manish Sisodia as accused No. 1 in its FIR lodged in connection with the irregularities in Delhi government's excise policy. The FIR has been lodged under Sections 120-B (criminal conspiracy) and 477-A (falsification of accounts) of the Indian Penal Code. The allegations against Sisodia is that liquor businessmen were allegedly given exemption of Rs 30 crore, and the licence holders were allegedly given extension as per their own will. The policy rules were made by violating the excise rules, the FIR said.

The Central Bureau of Investigation (CBI) on Friday was raiding 21 locations in Delhi and six other states, including the residence of Delhi Deputy Chief Minister Manish Sisodia.

The raids were being conducted in connection with the alleged irregularities in the Delhi Excise Policy.

Sources said that a CBI team was at the Sisodia residence in the morning and was "grilling him and scanning different documents at his house".

The probe teams were also raiding the house of former Excise Commissioner E. Gopikrishnan, four public servants and others.

The raid was going on in seven states and could go till evening, said the sources. Sisodia claimed that he was innocent and the CBI was working at the behest of the Centre.

Sisodia went on to say that they will give them full cooperation in the investigation so that the truth can come out soon. He said that till now many cases were filed against him but nothing had come out.

Delhi Chief Minister Arvind Kejriwal shared The New York Times front page article featuring Delhi's Education model and Manish Sisodia. Kejriwal said that he is the best education minister in Independent India.


15 NAMED AS ACCUSED IN CBI'S FIR

Ola ordered to pay Rs 95,000 to Hyderabad man for overcharging

A consumer court in Hyderabad has directed Ola Cabs to pay Rs 95,000 to a customer for overcharging him and also for deficiency in service.

The petitioner alleged that he was billed and forced to pay Rs 861 for a 4-5 km journey which should not have cost more than Rs 200.

Jabez Samuel complained that he, his wife, and an assistant had booked a cab on October 19, 2021 for four hours. They found the cab untidy and the driver not only refused to turn on the AC but also behaved rudely with them. After travelling for a distance of about 4-5 km, they deboarded the cab.

A bill of Rs 861 was generated. The complainant did not have to pay the driver as he had availed of the Ola money cash credit service.

The petitioner brought to the notice of the District Consumer Disputes Redressal Commission that they had to make alternate arrangements and skip some of the

scheduled programmes that day.

Samuel said he lodged a complaint with Ola Cabs over excess bill, but the higher authorities of the company failed to intervene. He said Ola executives made repeated calls asking him to pay the bill.

He paid the bill in January 2022 but approached the consumer court to get justice. Ola Cabs did not appear before the commission to contest the case even after being served notice.

Taking note of Samuel's complaint and the mental agony caused to him, the commission asked the ridesharing company to pay Rs 88,000 compensation to the customer and Rs 7,000 as costs of the hearing.

The commission fixed 45 days as the time for compliance and if the firm fails to comply with the order, it would be liable to pay interest.

The company has also been directed to refund the amount of Rs 861, along with interest at 12 per cent per annum from the date of the journey till realisation.

WHO EXPERTS RECOMMEND 2ND COVID BOOSTER FOR VULNERABLE GROUPS

Countries should consider giving a second Covid-19 vaccine booster to the elderly, pregnant women, health workers, people with weaker immune systems and those at higher risk of severe disease, according to a team of experts from the World Health Organization (WHO).

Most Covid-19 vaccines consist of a primary series of two doses, with a first booster administered some four to six months after completion to improve immune response.

While several countries had rolled out the second booster dose against Covid, the WHO had so far not recommended it.

But after a meeting, last



week, the Strategic Advisory Group of Experts (SAGE) on Immunization recommended the fourth dose or the second booster against Covid, but only for the vulnerable people. Protection offered by current vaccines declines substantially within a few months, particularly in the

context of each variant of concern.

The guidance focuses on the need for a second booster as Omicron remains the dominant variant. It does not take into account future variants, or variant-containing vaccines, which are in late-stage development.

'Relationship purely consensual': SC quashes rape charges against man

New Delhi: The Supreme Court has quashed rape charges against a man, saying that the woman and him had a consensual relationship, which existed before her marriage with another man, went on also during her marriage, and continued after her divorce.

A bench said: "The relationship between the parties was purely of a consensual nature. The relationship was in existence prior to the marriage of the second respondent and continued to subsist during the term of the marriage and after the second respondent was granted a divorce by mutual consent."

It said taking the allegations in the complaint, it is impossible to find in the FIR or in the charge sheet, the essential ingredients of an offence under Section 376 IPC.

The top court judgment came on the plea by the man challenging the Allahabad High Court order refusing to quash the rape charges and the charge sheet filed against him in the case. The top court observed that the woman in her statement recorded before the magistrate had accepted, they had known each other since 2013 and subsequently got into a relationship.

Hawala operator for terror outfits LeT, Al-Badr held in Delhi

In a joint operation, Delhi Police and Jammu and Kashmir police in assistance with central agencies arrested a Hawala operator for funding terror outfits LeT (Lashkar-e-Taiba) and Al-Badr.

The accused was identified as Mohammed Yaseen.

"Inspectors Sunil Kumar Rajain and Ravinder Joshi under ACPs Lalit Mohan Negi and Hridaya Bhushan were working on an information. They held Yaseen, a resident of Turkman Gate in Delhi. He was working as an agent in Hawala transactions related to funding of terror outfits LeT and Al-Badr. On Aug 17, Yasin gave around Rs 10 lakh to a terror operative Abdul Hamid Mir of J&K for further use in terrorist activities in J&K. In this regard, J&K Police registered a case and had arrested Abdul Hamid Mir from Jammu Bus Stand along with the terror funding amount of Rs 10 lakh," said HGS Dhaliwal, the DCP of Special Cell.

The official said that on August 18, an information



was received from central agencies and J&K police regarding a person engaged in funding of terrorist activities and operating from Meena Bazar, Delhi itself.

After receiving the information, a raiding team was constituted and deployed in and around area of Meena Bazar. Yaseen was finally held. The police said that they have recovered cash Rs 7 lakh and a cell phone from him.

During interrogation, Yaseen disclosed the police that the Hawala money was being sent to Surat and Mumbai through South Africa.

Yaseen was the Delhi link in this Hawala chain and from Delhi this amount was further transferred to J&K through different couriers.

This amount is further given to operatives of banned terror outfit LeTs and Al-Badr in J&K. Further investigation in the matter is on.

ONGC, IRCTC among 21 PSEs running without full-time heads

As many as 21 central public sector enterprises (CPSEs) including Maharatna entity ONGC, Navratnas Oil India Ltd (OIL), and Bharat Electronics Ltd (BEL) and Indian Railway Catering and Tourism Corporation Ltd (IRCTC), among others, are functioning without a full-time head. In some cases, the top posts have been lying vacant for as long as 18 months.

According to sources in the Department of Public Enterprises, the country's biggest oil refining company ONGC is without a

Chairman and Managing Director (CMD) since April 1, 2021 i.e. 16 months, while its subsidiary OIL is working without a head since July 1, 2022. Similarly Railway Ministry's catering arm IRCTC is also without a full-time Chairman since February 1, 2021, a gap of more than 18 months. BEL too has no chief since July 1, 2021

while Shipping Corporation of India (SCI) Chairman's post is lying vacant since June 1 this year.

While in the case of SCI and OIL, the Public Enterprise Selection Board (PESB) has recommended candidates for the posts of CMD and MD, for entities like ONGC, IRCTC and BEL, the selection process for CMDs and

chairpersons is undertaken by Civil Services Board or Search Cum Selection Committee.

Sources added that though efforts are made to ensure that posts at board level don't lie vacant for long durations, CPSEs have been functioning without regular heads due to various reasons.



BSF head constable killed in Tripura militant attack

In the first incident of terrorist violence in Tripura this year, a Border Security Force (BSF) head constable was gunned down by militants of the outlawed National Liberation Front of Tripura (NLFT) on Friday, police said.

The BSF has sought the help of Border Guards Bangladesh (BGB) to nab the NLFT militants, belonging to Biswa Mohan faction.

A police spokesman said that the NLFT cadres fired on a BSF patrolling party at Simna Two along the India-Bangladesh border in north Tripura district, injuring Head Constable Girjesh Kumar Uddey, 53, who was shifted to an Agartala hospital but succumbed to his injuries.



A huge contingent of Tripura State Rifles (TSR) led by Inspector General of Police, Law and Order, Arindam Nath and senior BSF officials have rushed to the mountainous areas for taking further course of action.

A BSF official said that massive operations are underway in close coordination with the BGB to track down the insurgents responsible for the attack.

The slain Head Constable, a resident of Madhya Pradesh, belonged to the BSF's 145th Battalion.

TRS LEADER KAVITHA WRITES TO CJI ON BILKIS BANO CASE

Hyderabad: Telangana Legislative Council member Kalvakuntla Kavitha has written to Chief Justice of India N.V. Ramana, requesting him to intervene so that the release of 11 convicts in Bilkis Bano rape case is withdrawn immediately. Bilkis Bano was 21 and was pregnant when this gangrape took place during the 2002 Gujarat riots. On August 15, the Gujarat government released the 11 convicts. Kavitha highlighted technical and legal points, noting that "this case was investigated by the Central Bureau of Investigation (CBI). It was the Special CBI Court that sentenced these convicts. Section 435 (1) (a) of the Criminal Procedure Code states that the power of the state government to remit or commute a sentence in any case which was investigated by the CBI shall not be exercised by the state government, except after consultation with the central government".



PM MODI ATTACKS OPPN, SAYS THOSE WHO TALK BIG LACK VISION

Launching a veiled attack on the Opposition parties while addressing the 'Har Ghar Jal Utsav' event held in Goa virtually, Prime Minister Narendra Modi on Friday called for a long-term approach for nation-building, saying that those who are not bothered about the country only talk big but can't work with a big vision for water security.

Modi said that seven crore households in the country have been given piped water in just three years under the 'Har Ghar Jal' mission, "whereas in seven decades since Independence, only three crore households had this facility".

Under the mission, all rural households are to be provided with clean piped water.

"It is true that to form a government, one does not have to work that hard as one has to work to build a



country. We have all chosen to work for nation-building. That is why we are working on the challenges of the present and the future. Those who do not care about the country, are not bothered about spoiling the present

or future of the country. Such people can definitely talk big, but can never work with a big vision for water," the Prime Minister said.

He further said, "There were about 16 crore rural households in the

country, who had to depend on outside sources for water. We could not have left such a large population of the village fighting for this basic need. That's why three years ago I had announced from the Red Fort that every house would get piped water. Rs 3.60 lakh crore are being spent on this campaign and despite the interruptions caused by the biggest epidemic of 100 years, the pace of this campaign did not slow down. The result of this continuous effort is that in just three years, the country has done more than double the work done in seven decades. This is an example of the same human-centred development, which I talked about this time from the Red Fort."

Modi congratulated Goa for becoming the first 'Har Ghar Jal' certified state where every household is connected to piped water. He also acknowledged Dadra Nagar Haveli and Daman and Diu as first Union territories to achieve the feat.

'Unprovoked': Thoothukudi firing probe panel report indicts police, Collector

The Justice Aruna Jagadeesan (ret'd) Commission, which probed the police firing on May 22-23, 2018 on protesters in Tamil Nadu's Thoothukudi, leading to the death of 13 persons, has come out heavily against police officers involved as well as the then district Collector N. Venkitesan.

The report, submitted to the state government on May 18, is still to be tabled in the Assembly. However, according to the report, as accessed by the IANS, the Commission has held the police firing to be "totally unprovoked and indiscriminate" and coming down heavily against Venkitesan, said that he "had made ill-conceived decisions".

The report also said that police had fired at fleeing protesters and that there was no material evidence with



the police that indicated that the protesters were militant.

Noting that police had taken safe shelter and used sharpshooters from long range to fire at the protesters, the Commission, in its report, has recommended action against 17 officials including then IGP, South Zone, Shailesh Kumar Yadav, then DIG, Tirunelveli, Kapilkumar Sarathkar, then Thoothukudi SP P. Mahendran, and Venkitesan.

The commission, in its report, also came down heavily against the officers for not properly promulgating pro-

hibitory orders under Section 144 of the CrPC. It said that even after promulgating prohibitory orders in respect of two police station limits, the officials did not prevent the demonstration against Sterlite on SAV school grounds in Thoothukudi. This has led to confusion and police not being able to prevent the public from turning violent.

The report, however, said that there were no intelligence failures but the district administration did not attach much significance to the intelligence report.

Damage to Mahatma Gandhi photo: One staff of Rahul's Wayanad office, 3 Cong workers held

Congress in Kerala cried foul after the police probing the vandalism of Lok Sabha member Rahul Gandhi's office in Wayanad arrested one staff of his office - Ratheesh and three other Congress workers on Friday. The incident took place on June 24.

Alleging that Gandhi, who is the Wayanad MP, failed to act on the issue of 'buffer zone' of eco-sensitive areas, the SFI protesters had allegedly shouted slogans against him and damaged his office in Wayanad.

A picture of Mahatma Gandhi was found broken and confusion arose when the SFI protesters claimed they did not destroy it and allegations were there that it was the work of Congress workers.

The police launched a probe and four Congress workers were arrested on Friday.

Local Congress legislator T. Siddique said this is nothing but a ploy to divert the attention as the assembly begins its sitting on Monday. "The AKG Centre-state headquarters of the CPI-M was attacked in the last week of June and all know this was the work of the CPI-M itself to divert attention and to target the Congress party, the Congress workers in Wayanad have been arrested for destroying the picture of Mahatma Gandhi which was in



the office. This is the way the police of Vijayan are acting," said Siddique.

"This act is also done to please Narendra Modi and it's hilarious that the police are yet to examine the CCTV footage from the office where the vandalism took place. Without that how can the police conclude like this. It's just a ploy to keep their folly of attacking the CPI-M headquarters," added Siddique.

The police have taken into custody the four Congress workers including the staff of Gandhi and sources reveal all four will be given bail from the station itself.

School, trust in Partha Chatterjee's late wife's name under ED lens

An international residential school and its managing trust, both in the name of the deceased wife of former state Partha Chatterjee, have come under the scanner of the Enforcement Directorate (ED) probing the multi-crore teacher recruitment scam in West Bengal, in which Chatterjee is the prime accused.

The name of the school is BCM International School, while the name of its managing trust is Babli Chatterjee Memorial Foundation, named after Partha Chatterjee's deceased wife, Babli Chatterjee.

The two members of the trustee board are Partha Chatterjee's son-in-law Kalyanmoy Bhattacharya and the latter's maternal uncle Krishan Adhikari. The residence of Adhikari is located within a kilometre of the international school at Pingla in West Midnapore district.



ED sleuths have already submitted details about this school and the memorial trust to a special ED court in Kolkata where the trials of Partha Chatterjee and his close aide Arpita Mukherjee are being held.

The ED's counsel had also given an explanation as to why the investiga-

tors feel that the proceeds of the recruitment irregularities in West Bengal School Service Commission (WBSSC) were routed through this school. ED sources said that the school is built over an area of 1,50,000 lakh sq ft and its building is fitted with high-quality imported marble slabs

and granites. The school also has several high-end Volvo buses.

"In simple terms, the school is a perfect example of any high-standard international school. We even talked to some of the landowners who sold their land for setting up the school, and many of them said that they received a major part of the money in cash. They also said that most of these purchases were made in the first half of 2017, which is immediately after the end of the demonetisation period," an ED official said.

The ED officials have raided the residence of Krishna Adhikari once and also questioned him on this count. The agency sleuths have also sent communiques to Partha Chatterjee's daughter, Sohini (Chatterjee) Bhattacharya and son-in-law Kalyanmoy Bhattacharya, both settled in the US, to come to Kolkata at the earliest for questioning. However, no positive response has been received from their end so far.

KEJRIWAL LAUNCHES 'MAKE INDIA NO. 1' MISSION

Delhi Chief Minister Arvind Kejriwal on Friday announced a mobile number for common people to give a 'missed call' to connect with AAP's 'Make India No. 1' mission.

In a digital press briefing, he said, "I am issuing a number today, missed call number 9510001000. Those who want to see India as the number 1 nation in the world, give the missed call on this number. We all 130 crore people have to join this movement." "We had announced day before yesterday that we have to make India number one country in the world. The dream of making India number one is now taking the shape," he said in the briefing.



6 DEAD IN 3 SEPARATE GUJARAT ACCIDENTS

At least six people were killed in three separate accidents in Gujarat, police said on Friday.

All three accidents took place on Thursday night. In the first accident, an Ahmedabad family were travelling in their personal vehicle from Vatva to Vadodara. The car rammied into a truck, killing all the four persons travelling in the vehicle on the spot.

Ahmedabad police said the exact cause of the accident is being investigated. The victims were identified as



Jayshree (60), her daughter-in-law Hitika (40), grand-

daughter Jaini (four) and driver Akbar Chatra.

The second accident was a hit and run reported in Ahmedabad. The victim, Vishal Gaikwad (25), was returning home from work when an Audi coming from the opposite direction on the Chimanbhai bridge hit his bike and dragged him for almost 100 meters.

In the third accident, a dumper hit a motorcycle near Limkheda circuit house road, in which bike rider Kanubhai died on the spot and his brother Dilipbhai was hospitalised in critical condition.

The driver of the dumper is absconding.

BENGALURU COLLEGE FACES CASE FOR CREATING JAM WHILE CELEBRATING INDEPENDENCE DAY

A case has been filed against Bengaluru's Mount Carmel College (MMC) for violating rules while celebrating Independence Day and creating chaotic traffic, police said on Friday. According to police, the mega celebrations organised by the MMC saw a footfall of 6,000 to 8,000, resulting in disturbance of traffic in the arterial roads of the central business district on Monday.

The case has been filed under various provisions of IPC including wrongful restraint, obstruction in public way, public nuisance, and

unlawful assembly.

The police said that the management had sold tickets to outsiders, through students, for Rs 100. The visitors had parked their vehicles on the road, creating a chaotic traffic situation outside campus. Police also that the students were asked to sell 20 tickets each and the management had given 10,000 tickets. The trouble started when the management turned down a large crowd from entering the premises. According to police, the college had sought permission for the celebration of Independence Day, but, sold tickets for its silver jubilee event.

EX-GUV COMPARES MODI WITH LORD KRISHNA



Rajkot: Former Governor of Karnataka and senior BJP leader Vajubhai Patil on Friday compared Prime Minister Narendra Modi with Lord Krishna in the fight against 'Parivaarwad' (dynastic politics).

Earlier, 'saala' influential in Bihar, now 'jeeja', claims BJP leader

After Bihar minister Tej Pratap Yadav invited his brother-in-law Shailesh Kumar to a meeting of the state pollution control board, former BJP minister Janak Ram on Friday targeted Chief Minister Nitish Kumar and the RJD for promoting family politics.

"Earlier, saala (wife's brother) was influential, now jeeja (sister's husband)," he said in a reference to RJD chief Lalu Prasad Yadav's brothers-in-law Sadhu Yadav and Subhash Yadav being very influential and dictating terms when he was Chief Minister and now Shailesh Kumar in the government of his son, Tej Pratap Yadav. "Old situation repeated in the new government. Jungle Raj part 3 arrived in Bihar," he claimed.

Hitting out at Nitish Kumar, Ram said: "When I was the minister, I used to go to him for approval of sanctioning jobs in



the department, but he did not even listen. He does not want a Dalit leader seated along with him. He often got angry with me."

Building Construction Minister Ashok Chaudhary, of the JD-U, came to the defence of Tej Pratap Yadav.

"When a leader is newly appointed as a minister, his/her family members used to go into

the offices to see work. It happened sometimes with me as well though I became the minister for the fifth time. Tej Pratap Yadav went to the office for the first time, and his brother-in-law went with him. It is not a big issue. Though, it was an official meeting and he (Shailesh Kumar) should have gone away then," Chaudhary said.

INTER-FAITH COUPLE FOUND DEAD IN UP IN APPARENT SUICIDE PACT

The body of a 15-year-old girl has been recovered from her boyfriend's relative house in Uttar Pradesh's Shamli district after she went missing a day earlier, police said, adding the boy also died later.

According to police, the boy was lying unconscious close to the girl's body and was still alive when found.

He was taken to a nearby hospital, where doctors declared him brought dead, officials said. The incident took place in a village in Shamli where the girl used to live with her maternal grandfather's family. Station house officer (SHO), Karmveer Singh said: "The couple were in relationship with each other and both had left their houses on Wednesday night. The autopsy report has revealed that both the victims died due to consumption of poison. So far, police have not received complaints from both sides." Meanwhile, SP Shamli, Abhishek said "Both the victims belong to different communities. Our investigation is on and necessary action will be taken."

Five held for stripping girl, thrashing couple in UP

Five of the six persons accused of stripping and beating a girl in Hamirpur have been arrested after a video clip of the incident went viral on social media.

Three persons were arrested on Thursday night and two on Friday morning.

According to reports, the girl was sitting and talking at a secluded spot with her male friend when a group of men arrived and began abusing the couple.

They then beat up the youth and stripped the girl.

They beat her with a belt. It is not yet known whether they sexually assaulted the girl or not.

Police officials said that the matter was under investigation and the girl was being sent for medical examination. Meanwhile, Vimla Batham, head of state women commission, has strongly condemned the incident. "We are taking cognisance of the incident and will ask the government to ensure strict punishment for the accused. The incident is proof of the fact that we are heading towards jungle raj," she said on Friday.

SEX RACKET BUSTED AFTER COPS RAID GURUGRAM SPA CENTRE, 4 ARRESTED

Gurugram: Gurugram police have arrested four people, including two women, for allegedly operating a sex racket from a spa centre here.

The arrested, which also includes the spa centre's owner Bhagat Singh and manager Yogesh, have been booked under different sections of the Immoral Trafficking Act and an FIR has been registered at the Sector 50 police station.

According to the police, the spa is located in the Ocus Quantum Mall in Sector 51. The women were arrested for prostitution. While one is a resident of Chhattisgarh, the other is from Mathura. In the preliminary inquiry, it was revealed that the owner and manager had pushed both women into prostitution and used to charge Rs 2,000 per customer. All the accused were produced in the court which sent them to judicial custody in Bhondsi jail."



'DAHI-HANDI' CELEBRATED WITH GUSTO IN MAHA, 24 'GOVINDAS' INJURED IN MUMBAI

After two years of Coronavirus restrictions, Krishna Janmashthami and 'dahi-handi' were celebrated with religious fervour and gusto all over Maharashtra on Friday, though at least 24 'Govindas' were injured in Mumbai.

The celebrations started at midnight with thousands of devotees joining the prayers, aartis, and bells heralding the birth of infant Balgopal at scores of Krishna temples in and around Mumbai.

These included famed ones like ISKCON temples at Juhu and Chowpaty, the Shri Krishna Pranami Temple at Kalbadevi, the Guruvayoor Shree Krishna Temple in Navi Mumbai, and many other smaller little known places of worship dedicated to Lord Krishna.

In the morning, it was the turn of hundreds of 'Govinda' groups - both all-boys or all-girls troupes - moving around the city at scores of 'dahi-handi' events to celebrate Lord Krishna's fascination for curds and butter. The youths formed tall pyramids, ranging from modest four to dizzying nine or 10 tiers to reach the 'handi' (pot) hanging at the top, smash it with a coconut, and savour the treat of fresh curds and butter trickling all the way down - akin to Lord Krishna



who used to raid homes in Gokul in his childhood for the milk and curd in them. Thousands of people gathered at various grounds, chowks, roads or societies watching the Govinda gangs zealously eyeing the 'dahi-handis' - and also the accompanying cash prizes, ranging from Rs 100,000 to Rs 25,00,000 for the winning group - and even a promise of a foreign trip for setting a world record. VIPs including Chief Minister Eknath Shinde, Deputy

CM Devendra Fadnavis, political leaders of various parties, attended some of the celebrations in their respective areas. Some organisers had invited prominent Bollywood and Marathi film stars to attend and perform at their events, along with other artistes, affording a dance and musical extravaganza at several venues.

The state government has announced an insurance cover of Rs 10 lakh for each 'Govinda' besides free

treatment for those who fall and suffer injuries, plus compensation.

Till 5 p.m., around two dozen 'Govindas' fell from various levels while forming the pyramids and around 5 are still in hospital.

Similar enthusiastic Janmashthami and 'dahi-handi' celebrations were held in Thane, Palghar, Raigad, Pune, Nagpur, Kolhapur and other towns or villages across Maharashtra amid tight security by police.

'Need to use state-of-the-art technology to get people to use public transport'

To make the maximum number of citizens use the public transport, it is time to use technology in a sophisticated way, said Union Road Transport and Highway Minister Nitin Gadkari.

Gadkari appealed to the BES&T administration in Mumbai to digitize the public transport system as 70 per cent subsidy is received from the Centre for digitalisation. The Union Minister proposed to Maharashtra Chief Minister Eknath Shinde to build a multi-storey bridge to solve the problem of traffic congestion in Mumbai. For the Mumbai-Delhi 12 hour highway journey, cooperation from the state is needed, added Gadkari.

If water taxis are introduced to connect with Navi Mumbai airport, it will be reachable in just 17 minutes and it is also pollution free. If BES&T takes up this project, it will be beneficial and it is easy to go for a 100-seater fast speed boat.

The Minister's advice to BES&T is to electrify all buses soon, so the losses



will be covered soon. "Government should think about using hydrogen. Flex engine vehicle production has already started. Most of these vehicles are manufactured in Maharashtra. If taxis and Auto rickshaws in Mumbai start using electric or flex engines, it will help reduce pollution. This will also bring financial benefits by reducing the cost of petrol." Gadkari appealed to the

Maharashtra government to send proposals for ropeway, cable car and funicular railway. 165 such schemes have been approved across the country. A double-decker bus that runs on water and in the air can be started in Mumbai by putting a ropeway peeler from Nariman Point, like in the Philippines. For this, he said BES&T may start working on Detailed project Report (DPR).

Speed-boat 'scare': Maha ATS files FIR against unknown persons

After probing the drifted speed-boat scare' on Raigad shores, the Maharashtra Anti Terrorism Squad (ATS) has filed a complaint against unknown persons, officials said here on Friday.

ATS chief Vineet Agarwal, who rushed to Raigad along with his team, and the Raigad Police have investigated the matter, and a possible terror angle has been discounted for the present.

On Thursday, the state security apparatus went into a tizzy after the severely damaged yacht washed up on Harihareshwar beach, around 200 km south of Mumbai, as the fisherfolk alerted the local authorities.

The UK-flagged 53-foot-long yacht 'MY Lady Han', owned by an Australian cou-

ple, was found with some documents, three AK-47 rifles and boxes containing live ammunition, sparking a major security scare in the state. The Navi Mumbai ATS Unit is handing the probe and has filed a first information report invoking various sections of the Arms Act against unknown persons.

Later, a Dubai-based Neptune P2P Group announced that it had provided security to the yacht in June 2022.

The Maharashtra government informed the legislature that the speedboat suffered an engine failure in the high seas on June 26 and the crew on board were rescued by a Korean warship.

Later, after drifting in the Arabian Sea for 52 days, it finally washed up on Harihareshwar Beach on Thursday afternoon.

The Neptune P2P Group said that after the yacht was damaged during monsoon, an emergency was declared, the crew members were rescued though they could not salvage the vessel owing to extreme weather conditions.

The yacht was slated to sail from Oman to Europe with its owner Hannah Laundergun and her husband James Robert sailing it, along with at least one unidentified crew member, when the mishap took place.

The security provider said it had presumed the vessel to have sunk but after it was found on Raigad shores, the Neptune P2P Group is coordinating with the vessel owners, and the authorities in India and United Kingdom for the official recovery procedures of the vessel and the 'controlled items' (weapons) on board.

NIA TEAM LIKELY TO VISIT RAIGAD

New Delhi: A

team of National Investigation Agency (NIA) is likely to visit Maharashtra Raigad where cache of explosives and three AK-47 assault rifles were found on Thursday on an abandoned boat at Harihareshwar beach. According to the information, the Maharashtra government has shared details of the entire incident with intelligence agencies as well as with the NIA.

The NIA is also keeping an eye on the entire incident, a source said, adding a team of NIA Mumbai is all set to reach Raigad. The Maharashtra government has said it is taking the matter seriously, and is in touch with the probe agency.

The NIA has not made any official statement as of now.



Fugitive diamantaire Nirav Modi's HCL House to be auctioned on Sep 23

The Debt Recovery Tribunal-I (DRT-I) has ordered the auction of prime property belonging to absconder diamantaire Nirav D. Modi in one of the cases filed by Punjab National Bank (PNB) to recover a part of their whopping dues of more than Rs 2,133-crore.

As per the Mumbai DRT-I's order, HCL House in Marol shall be put up for e-auction on September 23, with a reserve price of Rs 52 crore, against the massive amounts outstanding since nearly five years to the PNB and 15 more banks.

"Proclamation of sale under Rules 38, 52(2) of the second schedule to the Income Tax Act, 1961 read with the Recovery of Debts Due to Banks and Financial Institutions Act, 1993," said the August 11 order by Recovery Officer Ajeet Tripathi.

The case pertains to PNB plus 15 public and private sector banks versus Nirav Modi's group company Firestar International Ltd. and other



known or new entities from whom the dues are recoverable.

The latest auction comes in the recovery process initiated by various banks after the infamous PNB scam

of over Rs 14,000 crore erupted in the Indian banking sector in February 2018 -- almost a month after Modi, his wife Ami and others fled the country (January 2018).

THE IMPORTANCE OF RIGHTS OF THE NATION

As we celebrate 75 years of Independence, it is a high time to introspect and contemplate about the gains and losses we made in past this much of years.

We got Independence after a long struggle on August 15, 1947. On this day, a new Independent state came into existence. On January 26, 1950, the Constitution of India was implemented, which begins with the Preamble.

The Preamble indicates the mission and vision of the Constitution. The Preamble begins with "We the People of India" followed by "Sovereignty, Justice, Liberty, Equality and Fraternity". All of these goals are the collective responsibility of every citizen of this nation.

Here sovereignty and fraternity is related to the rights of the nation and rest with the rights of the citizens. Unfortunately, the concept of nation has not received appropriate attention within the existing constitutional scheme.

In fact, in the entire Constitution, the term 'nation' has hardly been mentioned at one or two places, only under the chapter of Fundamental Duties.

Article 1 of the Constitution begins with - India i.e. Bharat shall be a union of States. For majority of the people, there is no difference between India and Bharat, but in reality there is a big difference. India is a political entity comprising territories and citizens but Bharat is one of the most ancient cultural civilizations.

India is defined according to the modern theories of political science, but the meaning of Bharat remained undiscussed in post-Independent India.

Bharat is one of those rarest nations whose geography naturally defines its territory. According to Puranas, from the Himalayan range in north to the Indian Ocean in south, the entire region was the land of Bharat. Before 1857, the area of Bharat was somewhere around 1 crore sq km which is now hardly 33 lakh sq km. Bharat Mata means a living entity having all the rights of a natural person. Like any other person, Bharat Mata has the right to dignity, sovereignty and integrity and it is the responsibility of every Bhartiya to protect her rights even at the cost of their own life. Bharat Mata has some distinguished rights - like right to territorial sovereignty, ecological sovereignty, cultural sovereignty and spiritual sovereignty.

Here the meaning of territorial sovereignty is any attempt to alter the territorial boundaries should be discouraged and defended by the people of this country with best of their ability. This right of motherland is non-compromisable. Our land has been divided 24 times in the last 2500 years, which proves that we could not



successfully defend the territorial sovereignty of this country.

The idea of ecological sovereignty is deeply ingrained in Indian society in connivance with spiritual sovereignty.

The Bhartiya culture is fundamentally eco-centric. Bhartiya darshan always believed in the deep alliance of human being with nature and considered itself as the trustee, and not the owner of the same. The philosophy of non-duality removes the difference among the different creation of supreme divine whether inanimate or animate.

Through the spiritual richness of this nation, we kept our ecology balanced for thousands of years and also provided a safe ecosystem to all components of nature, including the five elements of universe or 'Panch Mahabhoots', i.e., Ether, Air, Fire, Water and Earth. Bhartiya culture does not believe in exploitation of nature but under the influence of globalisation we are compromising with the cultural and ecological sovereignty of this nation and leaving behind our richest cultural and spiritual heritage, which is the constant source of our existence in all odds. As we mark the 76th Independence Day, we need to analyse how much we are concerned about our nation's rights. There are several good reasons for celebrations.

We are now the fifth largest economy of the world, there is a considerable hike in per capita income and we are among the most powerful nations in the world.

But there is more to inspect, to think and to analyse. It is a reality that our total forest cover is now only 21.71 per cent though it should at least be 33 per cent of the total area.

In coming years, we are going to be the most populated country leaving behind China, which is going to cause immense pressure on our natural resources.

We are the third most polluted country in the world. We are under serious ecological threat. Around 10,000 species of plants and a

few hundred animal species are under severe threat due to the violation of ecological sovereignty of the nation. Air pollution was responsible for 16.7 lakh deaths in India in 2019, or 17.8 per cent of all deaths in the country that year.

According to a report by World Meteorological Organization (WMO), natural disasters, such as cyclones, floods and droughts, cost India around \$87 billion in 2020. Air pollution cost Indian businesses about \$95 billion or Rs 7 lakh crore every fiscal. There are around 76 active terrorist organisations operating in India. Our border areas are constantly receiving direct or indirect threats; divisive voices are rising from within the nation. These data reveals that we have heavily compromised with the cultural, ecological, spiritual and territorial sovereignty of our nation.

All these data indicate that the threats faced by the nation is actually damaging each of us. All these threats are challenging not only our right to life but also to our cultural, ecological and territorial existence.

Our Constitution and our courts are very much concerned about the protection of the rights of the citizens. Under Articles 32 and 226 on the violation of the fundamental rights, immediate relief can be claimed before the Supreme Court or any high court. But what about the rights of the nation? They have not been properly recognised by us.

In fact, in many cases of conflicts between the rights of the nation and the rights of the citizens, the latter's rights prevail.

In a very recent observation, the Supreme Court suspended the sedition law. The right to freedom of speech and expression of the citizens is many times protected in violation of the restriction of Article 19(2) which is also a constitutional mandate. Even after 75 years of Independence 'Rajdroha' is not recognised in the form of a separate offence,

though it directly violates the right of the nation. Many a times courts are mixing rights of refugees and rights of intruders and illegal migrants and passing such orders which are adversely affecting the rights of the nation.

Perhaps we don't have the realisation that without protecting the rights of the nation, rights of the citizens cannot be protected.

In few recent judgments of high courts some ray of hope could be seen, as the courts gave recognition to the ecological right of the nation when they recognised the rights of rivers, birds and animals.

In 2017, the Uttarakhand High Court (UHC) had ruled that rivers Ganga and Yamuna, the Gangotri and Yamunotri glaciers, as well as other related natural elements are 'legal persons' with all corresponding rights, duties and liabilities of a living person.

And more recently, the Punjab and Haryana High Court declared the entire animal kingdom, including avian and aquatic, as legal entities having a distinct persona with corresponding rights, duties and liabilities of a living person. In both the judgments, the ecological and environmental sovereignty of the nation were indirectly recognised.

All these discussions conclude that we are very indifferent with the importance of the rights of the nation. The importance can be understood from those who are stateless and known as illegal migrants or intruders. We still don't realise that we cannot exist without the existence of our nation.

This is not the responsibility of the armed forces and the government only to protect the rights of the motherland. This should be our collective responsibility.

It is high time for the government/s and judiciary to recognise the rights of the nation and to give them supreme priority.

Governments should be responsible to citizens, but every citizen must also be responsible to the nation. We cannot survive as a powerful citizen unless the rights of the nation are protected. So let's take a pledge to save our nation, to save its values, its sovereignty and its culture. Let's take a pledge that we will not destroy what we have not created on our motherland... we will save this divine motherland at all cost raising above our petty interests. Let's rise together to protect the territorial, cultural, ecological and spiritual sovereignty of the nation to save our existence and to save the future of the coming generations.

Attacks in Ukraine's Kharkiv likely aimed at diverting troops: UK

Russia's consistent shelling of Kharkiv, the second largest city in Ukraine, is probably aimed at keeping significant troop numbers there, "to prevent them from being employed as a counter-attack force elsewhere", according to the UK's Ministry of Defence. At least 12 civilians were killed in Russian strikes on residential areas of the city on Wednesday, the ministry wrote in its latest intelligence

update on Twitter. It noted that Kharkiv is within range of most Russian artillery types, reports news agency. "Multiple rocket launchers and generally inaccurate area weapons have caused devastation across large parts of the city," the defence intelligence update said. Since the Russian invasion of Ukraine began at the end of February, the British government has regularly published details of its latest intelligence on the conflict. Moscow accuses London of a targeted disinformation campaign.

GANDHI STATUE IN NY SMASHED AMID WAVE OF CONTINUED ATTACKS

A statue of Mahatma Gandhi in front of a temple in New York has been toppled and smashed in the second attack on the memorial this month and a local volunteer watch group has sprung into action to protect it. The incident in the early hours of Tuesday was the latest in a series of attacks on Gandhi statues in the US. Six men destroyed the statue at the Sri Tulsi Mandir with a sledgehammer and painted hate-filled words, around it and on the road, according to media reports quoting police. The statue had been vandalised earlier on August 3 and knocked over, according to the Queens Daily Eagle. Police released a surveillance video of the men between 25-30 years who are suspected of involvement in the attack. They fled the scene in a white Mercedes Benz and in a dark-coloured car that may be a Toyota Camry used as a for-hire vehicle, according to police. Assembly Member Jennifer Rajkumar, the first Hindu elected to the New York State legislature, told CBS New York TV on Thursday. "When the Gandhi statue was vandalised, that really flew in the face of all of our beliefs and it's very disturbing for the community" To know that



Gandhi represents peace and somebody would come and just target the statue and vandalize it, it's very sad," temple founder Pandit Maharaj told the New York Post. Meanwhile, volunteer watch group, the Cityline Ozone Park Civilian Patrol, tweeted on Thursday that its members increased their presence around the temple. "We increased our presence at Tulsi Mandir and were happy to see (police from) the 106 Precinct there as well. A big thank you to our four volunteers who were out for 7 hours overnight," it said in a tweet. After the first attack, Rajkumar had brought together several elected officials, including House of Representatives Foreign

Affairs Committee Gregory Meeks, to condemn the attack and demand police action. "Acts of hate have no place in our community and nation and the perpetrators need to be held accountable," Meeks was quoted by the Daily Eagle. The temple is located in South Richmond Park, an area with many people of Indian descent. A combination of leftists and Khalistanis have targeted Gandhi statues across the US, sometimes by circulating petitions for removing them, as in the case of another statue in New York City that was also vandalised by placing a shroud over it, and at other times by damaging them. During the protests against police excesses in February 2020, a statue in Washington had vile personal attacks on Gandhi and anti-India slogans painted on it. It was vandalised again in December that year by pro-Khalistani elements during a protest in support of the farmers' agitation in India. In another incident, a statue of Gandhi was cut at its leg and toppled over and its head was cut in half in Davis, California, in January last year. The same statue had also been vandalised with slogans in June 2020. Speaking to New York Post, Rajkumar noted that "Hindu hate is on the rise".

Salman Rushdie attack was unjustifiable: Imran Khan

Former Pakistan Prime Minister Imran Khan has condemned the attack on Salman Rushdie, describing it as "terrible" and "sad", and saying that while the anger of the Islamic world at the author's book "The Satanic Verses" was understandable, it could not justify the assault. In an interview to the Guardian, Khan also said he expected Afghan women to "assert their rights" in the face of Taliban restrictions in which he sought to moderate his reputation as a firebrand. He is fighting for his political survival after being ousted from office in April. Khan says his staff and followers are being persecuted and intimidated and he is battling eight-year-old charges of illicit campaign financing that could lead to him being banned from politics. Ten years ago, Khan pulled out of an event in



India because Rushdie would also be appearing and the two men exchanged insults, but he does not appear to have expressed support for violent action against the Indian-born author. His denunciation of the attack is striking, however, in a region where most politicians have ducked comment. The Guardian reported. Asked for his response to the knife attack in New York state that left Rushdie badly wounded, Khan said: "I think it's terrible, sad." Rushdie understood, because he came from a Muslim family. He knows the love, respect, reverence of a Prophet that lives in our hearts.

PUTIN, XI PLAN TO ATTEND NOV G20 SUMMIT: INDONESIA'S PRES

Jakarta: Russia's Vladimir Putin and China's Xi Jinping are both expected to attend the G20 summit in Bali in November, Indonesian President Joko Widodo announced. "Xi Jinping will come. President Putin has also told me he will come," news agency quoted Widodo as saying to Bloomberg in an interview published on Friday. Indonesia currently holds the G20 presidency. Widodo had invited Putin but the Kremlin has so far not confirmed the Russian President's plans either way. Bloomberg could not initially obtain confirmation of Putin and Xi's attendance plans from Russian and Chinese sources. Putin's participation in the summit is considered problematic in the West amid Russia's invasion of Ukraine and several countries have put in doubt whether they would participate if he attended in person.

Britain facing public health emergency: Health officials

London | Agencies

Senior officials in UK's National Health Service (NHS) on Friday made an "unprecedented" appeal to the government to take action on rising energy prices as the country faces a "public health emergency". The NHS Confederation sent a letter to ministers, warning that surging costs mean people will have to choose between skipping meals to heat their homes or living in cold and damp conditions this winter, reports news agency. Health leaders said they are concerned that widespread fuel poverty will increase the high number of annual deaths associated with cold homes, estimated at 10,000, and add pressure to an already overwhelmed health service. NHS Confederation chief executive Matthew Taylor said: "The country is facing a humanitarian crisis. Many people could face the awful choice between skipping meals to heat their homes and having to live in cold, damp and very unpleasant conditions. This in turn could lead to outbreaks of illness and sickness around the country and widen health inequalities, worsen children's life chances, and



leave an indelible scar on local communities." Taylors said these outbreaks of illness will strike "just as the NHS is likely to experience the most difficult winter on record". "NHS leaders have made this unprecedented intervention as they know that fuel poverty will inevitably

lead to significant extra demand on what are already very fragile services," he added. "Health leaders are clear that, unless urgent action is taken by the government, this will cause a public health emergency." It comes as energy regulator Ofgem is set to raise the cap on

energy prices from October, leading household bills to soar. The government has faced calls to freeze bills or provide more support to households, but Ministers have said no action will be taken until a new Prime Minister is in place on September 5.

622,000 TONNES OF GRAIN SHIPPED FROM UKRAINE SINCE DEAL: TURKEY

Ankara: A total of 622,000 tonnes of grain have been shipped from Ukraine's Black Sea ports since an agreement was reached in late July, according to the Turkish Defence Ministry. Twenty-five vessels left Ukrainian ports to export grain while 18 ships have entered the ports since August 1, the Ministry said on Twitter. Turkey and the UN helped bring Russia and Ukraine to an agreement on the export of Ukrainian grain at the end of July, breaking a blockade on Ukrainian ports since Moscow's invasion in February, reports news agency. The vessels have to undergo inspection by an international team at a joint coordination centre in Istanbul set up to monitor the grain exports across the Black Sea. The shipments are seen as crucial for the many countries dependent on grain from Ukraine, known as the breadbasket of Europe. Shortages and soaring prices have led to fears of severe shortages, especially in poorer nations in Asia, Africa and the Middle East, with famine looming in many areas. Millions of tonnes of grain have been stuck in Ukrainian ports since Russia attacked its neighbor and blockaded the country's ports. Ukraine, for its part, had mined the port approaches for fear of the Russian invasion. UN Secretary General Antonio Guterres and Turkish President Recep Tayyip Erdogan met Ukrainian President Volodymyr Zelensky in Ukraine on Thursday.



DALIT GIRL BEATEN UP FOR SITTING IN FRONT ROW, TEACHER BOOKED

Madhya Pradesh police lodged an FIR against a woman government teacher for passing casteist slurs and thrashing a 16-year-old dalit girl for allegedly sitting in the front row of the class.

According to police, the incident occurred on August 2 at the Government Higher Secondary Girls School, Baidhan, in the Singrauli district.

In the police complaint, Anjana Saket (name changed), a student of class 12th, alleged that when the teacher Jagriti Singh entered the classroom that day, she was enraged after seeing Saket on the front bench of the class. She subsequently passed casteist slurs and hit Saket with the book on her head multiple times.

"I fell unconscious for hours after she hit me with a book on my head," the complainant

claimed in the FIR.

Acting on the complaint, police lodged the FIR against the accused teacher Jagriti Singh on August 17 at Bairan police station of Singrauli.

"On the complaint of a dalit girl, police booked a teacher Jagriti Singh under section 294, 323 and 506 of the IPC and also invoked two sections of SC/ST Atrocities Act - 1989," said Arun Kumar Pandey, town inspector of Bairan police station. The probe is underway, he added.

According to an official communication issued by the district collector a day after the FIR, the decision to slap a case against the teacher was taken based on the findings of the District Education Officer (DEO) Rohini Prasad Pandey, who was instructed by the district collector Rajeev Ranjan Meena to probe the matter. A day after the incident, the victim, along with her parents, approached the district collector

demanding strict action against the teacher.

During the probe, the DEO found evidence of assault and discrimination and submitted the report on Wednesday to the collector. Acting on the report, an FIR was lodged against her, the collector told reporters on August 18. Many students and teachers have also endorsed the allegations made by the students against the teacher, said officials.

The district collector has also sent a letter to the Rewa commissioner to initiate a departmental inquiry against her as she violated the sections of Madhya Pradesh Civil Service (conduct) 1995.

"We have also written to the concerned department to initiate the suspension process," said Meena in the official communication.

Despite repeated attempts, DEO Pandey was not available for comment.

Upset Over Low Garlic Prices, Farmers Dump Sacks Of Crop In River

In a rare video going viral on social media, some farmers can be seen throwing sacks full of garlic into a river in Madhya Pradesh reportedly due to low prices. According to reports, farmers dumping garlic stacks into the Parvati river from a bridge dividing Sehore and Rajgarh districts. One quintal (100 kg) of

garlic is produced at a cost of Rs 2,500-3,000, however, it was fetching just Rs 300 to Rs 600 per quintal in the market.

Responding to the incident, a group of farmers in the state said that cultivators were getting abysmally low prices for their garlic crop and even sought that the Centre allow export of the produce to give the market a boost.

In the viral video which was posted by Kisan Swaraj Sangathan (KSS), a farmer can be heard saying they were throwing the bumper garlic crop as prices offered to them were very less. A functionary of the KSS said that the viral footage is from Ashta town in Sehore district and had been sent by one of its workers there.

Angry farmers even said that they would agitate in front of local MLAs and MPs as well as the state Assembly if the issue was not resolved at the earliest possible.

"Traders are purchasing garlic in the Rs 1-4 per kilogram range. However, cost of production per kilogram was Rs 30-40. We are facing huge losses and so are dumping the produce," farmer Jamshed Khan of Phulmogra village claimed.

Farmers group led by Suryopal Singh Thakur submitted a memorandum to the Jawar tehsildar after holding a protest.

Letter was marked to Prime Minister Narendra Modi and state Chief Minister Shivraj Singh Chouhan and sought immediate export of onion and garlic in the interest of farmers of the state. It takes Rs 2,000 to produce one quintal of onion, while it is being sold in the range of Rs 500-800.

The BJP found itself on the backfoot with the Brahmin community in Madhya Pradesh following a leader's controversial remarks. It has also got two leaders of the ruling party working against each other. Pritam Singh Lodhi is considered a loyalist of the party's former Chief Minister Uma Bharti. A police case has been filed against him on a complaint by a youth leader of the BJP.

Addressing a function to felicitate meritorious students on the birth anniversary of warrior queen Avantibai Lodhi on Wednesday, Pritam Singh Lodhi slammed the Brahmins. "The Brahmins were fooling and harassing people in the name of offering religious rituals and prayers," he said. "They were grabbing money and other things from commoners. They (Brahmins) are prospering on our money and

resources," he said after the felicitation.

"Seeing beautiful women from good families, they (the Brahmins) want to have food in the homes of those women. They (Brahmins) want young women seated in the front row and make elderly women sit in the back row," Lodhi said while addressing the event at Shivpuri's Kharai village.

The video of the BJP leader's controversial remarks is being widely circulated. Shortly after that, a Brahmin leader of the ruling party's youth wing, Praveen Mishra, got a police case lodged against Lodhi. He has been accused of promoting enmity between two groups.

The Congress was quick to target the ruling party and the Shivraj Singh government. "The BJP leader's public statement is part of his party's well-planned conspiracy against the Brahmins and other general category people," said Congress spokesperson KK Mishra.

"In November 2021, the ruling party's national general secretary in-charge for Madhya Pradesh, P Murlidhar Rao, had said in Bhopal that Brahmins and Baniyas were in his pocket. What Lodhi has said is the extension of Rao's earlier statements," he added.

Mishra questioned why the Brahmin leaders of BJP, such as VD Sharma, Gopal Bhargava and Narottam Mishra, were silent over Lodhi's statements. "The entire Brahmin caste should unite against BJP, else days aren't far when we will be assaulted by these people," Mishra said while demanding an apology from the party.

Lodhi had contested the last two assembly polls against Congress veteran KP Singh 'Kakkaju', from Pichhore. In the 2018 polls, he lost by a narrow margin of about 2,500 votes. He is already accused in at least 37 criminal cases, including four attempt-to-murder and two murder cases.

Jabalpur RTO has assets worth Rs 300 crore; 6 Houses, Home Theatre,

A swimming pool, jacuzzi and mini bar - this is not a description of a 5-star resort but are among the many luxurious features of the palatial house of a government officer in Madhya Pradesh.

The 10,000 square feet bungalow also features a home theatre and a separate office for the assistant Regional Transport Officer or RTO, Santosh Paul.

The visuals of the luxury amenities surfaced during an ongoing search at his house in Jabalpur in connection with a case related to

disproportionate assets. The raids, conducted by the Economic Offences Wing (EOW), also led to the recoveries of Rs 15 lakh cash, expensive jewellery, luxury cars, four more houses and one farmhouse.

Paul's wife Rekha is a clerk at his office. As per initial probe, the couple had assets 650 per cent higher compared to their known sources of income.

Pal owns assets worth Rs 300 crore which comprise six houses, a farmhouse and several luxury vehicles, officials said. Raids conducted at three locations including the official's residence by the

Economic Offences Wing of the Madhya Pradesh Police led to the recovery of cash and jewellery worth Rs 16 lakh.

The recoveries, however, may only be the tip of the iceberg. As per official estimates, the assets owned by Pal amount. A video of the raids at the official's residence shared by news agency ANI showed a lavish house, luxury vehicles, a jacuzzi and a private theatre too.

As per officials, the authorities have also unearthed several undisclosed properties linked to Pal, including a 1247 square foot house in PP colony, 1150 square

foot house in Shankar Shah ward, and two 10,000 square feet residential buildings in Shatabdipuram, etc.

The raids also revealed the lavish lifestyle that the RTO official maintained. The official's opulent residence had a personal movie theatre replete with recliner seats and a screen.

Singh has been posted in Jabalpur since 2018 and has many of his relatives also involved in work related to the RTO department. The officer came under the spotlight following complaints against him, including threatening an auto driver with a fake case.

RAPE ACCUSED 'MIRCHI BABA' SPENDS HIS TIME WITH DREADED CRIMINALS IN JAIL

Bhopal: Mirchi Baba alias Vairagyanand Giri, who once claimed to have political leaders, bureaucrats and thousands as his followers is currently spending his days as the cellmate of dreaded criminals in Bhopal Central Jail.

Mirchi Baba was shifted here on August 8 after he was accused of raping a woman by her giving 'bhabhuti.'

Ever since he landed in this jail, not one political leader or bureaucrat, or follower has visited him here, Dainik Bhaskar reported.

The baba was accused of rape by a 28-year-old woman from Raisen who filed a case at the Women's Police Station in Bhopal. Baba was arrested from a hotel in Gwalior on August 8. The woman had in her complain said that she had been married for four years and had been issueless. Then she met Mirchi Baba who claimed that he could help her have a child if she worshipped him.

The woman further claimed that the Baba on the pretext of treating her fed her intoxicating tablets and then raped her in July this year. Police are also on the lookout for Mirchi Baba's disciple Gopal, who has also been named as an accused in the case. Police said it was Gopal who brought the Raisen woman to meet Mirchi Baba has been complicit in this and several other crimes of the baba.

'Perverse:' SC Sets Aside MPHC Order Discharging Rape Accused

The Supreme Court has termed as "utterly incomprehensible" an order of the Madhya Pradesh high court discharging an accused of the offence of rape essentially on the ground of delay in the registration of the first information report (FIR).

A bench of Justices DY Chandrachud and JB Pardiwala said the facts of this litigation were quite "heart-breaking" and set aside the order of the high court holding that the impugned order could be termed as "perverse and not sustainable in law."

The verdict was pronounced on August 12 but was yet to be uploaded on the apex court website.

"At the cost of repetition, we state that the impugned order of the High Court is utterly incomprehensible. We have yet to come across a case where the high court has thought fit to discharge an accused charged

with the offence of rape on the ground of delay in the registration of the FIR," Justice Pardiwala said while writing the judgement on behalf of the bench.

The top court, however, did not interfere with the decision of the trial court of discharging the accused Amit Kumar Tiwari from the offence punishable under Section 306 (abetment to the commission of suicide) of the Indian Penal Code (IPC).

Notably, the case dealt with the death of a minor girl, who died by suicide after she delivered an illegitimate child conceived with the accused. On April 27, 2020, the survivor had complained of stomach pain and was taken to a private nursing home, thinking it was a case of stomach tumour. While waiting for the doctor at the nursing home, the girl delivered a child on the bench and was rushed to the minor operation theatre. The girl told her father that Tiwari was the father of her child and they both would start a new

life with their baby in a nearby town.

The father of the victim went to bring some money from the village and by the time he returned, the girl had died by suicide and the infant was lying on the dressing table. After that, an FIR was lodged against the accused.

An FIR was registered under Sections 376 (rape) and 306 of the IPC and Sections 5 and 6 of the POCSO Act and a chargesheet was filed. The special court framed charges against the accused.

Allowing a revision petition filed by the accused, the Madhya Pradesh HC noted, "Even in the life time of the deceased she did not approach the police. The story as narrated by the mother of the deceased seems to be doubtful on the ground of delay." The court discharged the accused.

The Supreme Court also rapped the state government for not appealing the order and said that it is a "disturbing feature of this litigation" that the father of the deceased had to

come before this court seeking justice.

The top court said that the state is expected to challenge the illegal order passed by the high court. Barring a few exceptions, in criminal matters, the party who is treated as the aggrieved party is the state - which is the custodian of the social interests of the community at large. So it is for the state to take all the steps necessary to bring the person who acted against the social interests of the community to book, the SC said.

It said, "...the impugned order of the high court could be termed as perverse and not sustainable in law. We refrain from observing anything further in regard to the exact and correct age of the deceased at the time of [the] commission of the offence as alleged as it may cause prejudice to the parties in some manner or the other. It is for the trial court to determine the correct age on the basis of the evidence that may be led by the prosecution as well as by the defence."



The video had a moment of laughter when Axar said to Chahar, "You keep making strong comebacks." In reply, Chahar said, "You keep taking the interview." Jokingly, Axar, who had referred to Chahar as India's own AB de Villiers, responded by saying: "No, no." Thanks to the three wickets taken by Chahar, Patel and Prasidh Krishna, India were able to bowl out Zimbabwe for 189. Chasing 190, Shikhar Dhawan and Shubman Gill remained unbeaten on 81 and 82 respectively to help India take 1-0 lead in the three-match series.

Stuart Broad joins elite club of bowlers with 100th wicket at Lord's

England's quick Stuart Broad has become only the second player to take 100 Test wickets at Lord's, joining long-time pace-bowling partner James Anderson, who was on the field to welcome him in celebration.

On the second day of the opening Test against South Africa, the 36-year-old Broad dismissed Kyle Verreynne with an edge behind to Ben Foakes to become the second player to take 100 Test wickets at the venue. The Proteas though took a commanding lead in the match, first dismissing the hosts for a paltry 165 in 45 overs before lunch on Day 2 and then notching up 289/7 for a 124-run advantage.

Broad with the record becomes the fourth person to take 100 Test wickets at a single venue, entering an exclusive group with his teammate as well as Sri Lankan pair Muttiah Muralitharan and Rangana Herath. Muralitharan has achieved the feat at three venues: Galle, Kandy and the Sinhalese Sports Club Ground in Colombo, according to ICC.

The feat is just another achievement in the sport for Broad, who is



approaching Glenn McGrath's fifth spot on the all-time Test wicket-taking list. Broad, with 553 scalps, is 10 away from equalling his Australian rival, and could well pass him by the end of the

current series. In terms of quick bowlers, Anderson (658 scalps so far) would be the only man separating Broad at the top once overtaking the Australian.,

Neymar and Mbappe PSG penalty row over, Brazil star could leave before September 1

Kylian Mbappe and Neymar have patched up their differences at Paris Saint-Germain, but coach Christophe Galtier has not ruled out the prospect of a sensational departure before the transfer window closes.

Asked whether Neymar might move on before the September 1 deadline, Galtier indicated it was highly unlikely but not entirely out of the question, reports.

A spat between Mbappe and Neymar became apparent during PSG's 5-2 Ligue 1 win over Montpellier last Saturday, with the pair seeming to disagree over penalty duties.

Mbappe missed an early spot-kick but thought he would have a chance to make amends when PSG were awarded a second penalty, only for Neymar to take over responsibility and make no



mistake. It was clear Neymar considered he was next in line, but Mbappe may have thought the duty remained his.

It has led to suggestions of a rift between the star pair that could prove disruptive in the dressing room, with Mbappe looking best placed to win any such tug-of-war after signing a bumper three-year contract in May. He scored later in the

Montpellier game but refused to celebrate, to the frustration of a number of team-mates. Galtier said the matter was put to bed during training this week, saying: "There's no malaise. We have been making plans, saying what we need to say to one another. I can confirm that in all honesty it's been a good week with everyone working hard to prepare well for the game against Lille.



Vijay Deverakonda: Currently, the country is enjoying South Indian cinema


