NIA says outfit trained youth to carry out terror acts

CRACKDOWN ON PFI

Team Absolute New Delhi

n a major crackdown on the Popular Front of India (PFI), the National Investigation Agency (NIA) and the Enforcement Directorate (ED) on Thursday raided premises linked to PFI in 15 states across the country and arrested several top PFI leaders and functionaries.

Sharing a list of 45 arrested persons, an NIA official said that the agency carried out searches at 93 locations across 15 states, including Kerala, Tamil Nadu, Karnataka, Andhra Pradesh, Telengana, Uttar Pradesh, Rajasthan, Delhi, Assam, Madhya Pradesh, Maharashtra, Goa, West Bengal, Bihar and Manipur.

Sources said that as many as 300 NIA officers were pressed into service to carry out the raids across India. The entire operation was supervised by NIA DG Dinkar Gupta.

The NIA has learnt that many of the PFI functionaries arrested on Thursday were convicted in earlier cases. Around 355 PFI members have already been chargesheeted by the agency."The searches were conducted at the houses and offices of top PFI leaders and members in connection

The NIA has made 45 arrests -- 19 from Kerala, 11 from Tamil Nadu, seven from Karnataka, four from Andhra Pradesh, two from Rajasthan, and one each from Uttar Pradesh and Telangana," the official said. The NIA is investigating a total of 19 cases cases realted to the PFI.

JAMAAT-E-ISLAMI EXPRESSES CONCERN OVER NIA, ED RAIDS ON PFI

New Delhi: The Jamaat-e-Islami Hind (JIH) deplored the Wednesday raids on PFI offices and crackdown on its leadership and offices by the NIA and ED.

In a statement to the media, JIH President Sadaatullah Hussaini said: "Jamaat-e-Islami Hind is highly concerned over the raids conducted by the NIA and ED on the Popular Front of India (PFI) offices and their leaders. Agencies like NIA can investigate people against whom they have clear evidence, but such actions should appear unbiased and free from political motivation."Asking if the NIA and ED had followed standard operating procedure in the raids, he said that the way the NIA and the ED have made simultaneous raids across the country, targeting PFI, raises many questions for our society to answer.

MINOR GANG-RAPE VICTIM WALKS HOME NAKED IN UP

Moradabad | Agencies

n a shocking incident, a video has gone viral on social media wherein a 15-year-old girl, who was allegedly kidnapped and gang-raped by five men here, is seen walking naked for about two kilometres on the Moradabad-Thakurdwara Road to reach

Instead of helping the girl, some passers-by are seen standing as mute spectators, while others filmed her and shared the disturbing videos on social media platforms.

According to reports, the incident took place a fortnight ago but the viral video has emerged now.

The girl's uncle said, "She was bleeding profusely when she returned home and narrated the ordeal to us." He then approached the police to file a

complaint but no action was initiated until he raised the matter before the district police head SSP Hemant Kutival. Thereafter, the police swung into action

and nabbed an accused after lodging an FIR on September 7.

The complainant also stated in the FIR that family members of the accused have threatened to kill him.

As per Moradabad police, the girl had gone to attend a fair in a neighbouring village when she was kidnapped by five men who took turns to rape her. Hearing her screams, a villager rushed to the spot but by then the five accused had fled the scene, taking away her clothes and other belongings.

Rahul Gandhi bats for opposition Iran witnesses worst unrest in years strategy to tackle 'divisive forces'

ongress leader Rahul Gandhi, who is leading ↓the 'Bharat Jodo Yatra', on Thursday called on opposition parties to chalk out a strategy to tackle the present divisive forces in the country.

I do think that the opposition has to come out with a strategy. They have to come together to fight the ideological, financial, and institutional power that has now come up in the country," Gandhi said while interacting with the media here on the 12th day of his yatra in Kerala.

He also pointed out that that he differs with the Left on how they view politics.

"I am getting handshakes from a good number of people who support the Left here



as they know inside their hearts what I have raised about hatred is right," he said. Gandhi, however, sidestepped numerous questions on if he will contest for the Congress President's post.

"I have answered this question in detail in my last press conference and it can be checked up... hence I will not say again," he said.

SC RESERVES VERDICT ON KARNATAKA HIJAB ROW

New Delhi: After 10 days of marathon hearing, the Supreme Court on Thursday reserved the judgment on a clutch of pleas challenging the Karnataka High Court verdict which refused to lift the ban on hijab in educational institutions of the state

A bench comprising Justices Hemant Gupta and Sudhanshu Dhulia reserved the judgment after hearing the arguments from the counsel representing the state government, teachers, and the petitioners, who moved the apex court challenging the high court

GUJARAT SCHOOLS GIRLS COMPLAINT AGAINST COOK FILMING THEM DURING BATH.

Valsad: In Eklavya Kanya Saksharta Nivasi Shala, a government-run residential school in Valsad district of South Gujarat, girls have alleged that the cook filmed them while they were taking bath.

The allegations are serious so a Deputy Superintendent of Police, local Crime Branch Police Inspector, local Sub Inspector and even Deputy Collector are looking into it. "If any one is found indulging in such act, they will be booked under the law," assured Rajdeepsinh Zala, Valsad District Superintendent of Police.

At the same time, the officer addressed local media: "Girl students in their written application to the school Principal or to the police, do not mention about video recording or taking photos. There are four male cooks and only one cook has an android phone, which is now in police possession and investigated." School Principal Nita Chaudhary told local media that the initial complaint was about poor quality of food and they had demanded for a women cook

Narmada project: SC refuses to entertain plea seeking compensation modification

▶ The top court said the final settlement package has been determined as Rs 60 lakh for each family, adding that it is difficult to modify the order, as it will be a substantive review of the order of this court.

The top court said the directions issued by it under Article 142 of the Constitution are not susceptible to clarification or modification in this application. It added: "We find no merit in this application... the application is dismissed."

he Supreme Court on Thursday declined to entertain a plea seeking a direction to modify its 2017 order, for payment of final compensation of Rs 60 lakh to each of the families affected by the Sardar Sarovar project on the river Narmada.

Senior advocate Sanjay Parikh, repre-

senting one of the ousted, contended before a bench headed by Justice D.Y. Chandrachud in terms of the Narmada Water Disputes Tribunal, the applicant's entitlement should have been for 4.293 hectares of land. Additional Solicitor General Aishwarva Bhati, representing the Centre, submitted that the 2017 order was passed under Article 142.Parikh contended that a careful reading of the apex court order would establish that the actual compensation would come to be Rs 1.28 crore, as the compensation would have to be Rs



30 lakh per hectare. Bhati said a modification or clarification of the apex court order cannot be passed as it would lead to a substantive review of its decision.In February 2017, the top court passed directions for compensation to the oustees of the Sardar Sarovar Project (SSP) on river Narmada in Madhya Pradesh. Then, it had ordered compensation of Rs 60 lakh for each of the families, which would be dis-

10 Killed, 11 injured in UP rain furry

t least 10 people were killed, seven of them in Etawah, and 11 injured in incidents of lightning, and wall and house collapses as heavy rains in parts of Uttar Pradesh affected normal life in Firozabad and forced the closure of schools in Aligarh.

Apart from Etawah where the seven dead included four children of a family -deaths have also been reported from Firozabad (2) and Balrampur (1) districts since Wednesday, officials said.

According to the India Meteorological Department, rainfall or thundershowers have been observed at most places over West Uttar Pradesh since Wednesday morning. It said Etawah observatory recorded 140

mm rainfall in 24 hours till 8.30 am Thursday. Rainfall

was reported from Agra also. Etawah district witnessed three fatal incidents of wall or house collapses late on Wednesday night, killing seven people in total.

Four children -- Sinku (10), Abhi (8), Sonu (7) and Aarti (5) -- died in their sleep after a wall of their house collapsed in Chandra Pura village. More than six hours of rainfall on Thursday led to heavy water logging and a flood-like situation on multiple stretches and areas in Gurugram. According to the district administration, Gurugram district recorded 395 mm of rainfall till 5 p.m.The residents were seen helpless while multiple stretches across Gurugram resembled river.

SC directs NOIDA to provide flats to 844 members of group housing society

he Supreme Court on Thursday, giving rest to an over three-decade old legal dispute over land allotment, directed NOIDA to provide flats to 844 members of a group housing society of Central government

The flats, which measure 1800 sq. ft, are located in Sector 43 of the city. A three-judge bench, headed by

Chief Justice U.U. Lalit, said: "We exercise our jurisdiction and power to do complete justice in the matter and direct NOIDA to extend to said 844 persons the benefit, as indicated in the affidavit filed on behalf of

The bench, also comprising Justices Indira Banerjee and K M Joseph, added: "Needless to say that the price of said apartments shall be fixed by NOIDA purely in accordance with its extant policy and the applicable norms. The list of said 844 persons shall be furnished by Respondent-Society within two weeks



from today under an authenticated certificate by Respondent-Society.

The bench said New Okhla Industrial Authority (NOIDA) is agreeable to re-lay part of Sector 43 and to make allotments of multistoreyed flats in favour of 844 persons, with each of those flats measuring about 1.800 square feet.

s an apparent punishment for highlighting the issue of substandard food being served to the men in khaki, the police constable who had posted a video in this connection has been transferred to Ghazipur district, which is 600 kilometres away from Firozabad.

Earlier, the 26-year-old constable, Manoj Kumar was sent on a 'long leave' after videos of him highlighting his plight outside the Police Lines with tears in his eyes and a plate of food in his hand had gone viral. He was captured on video saying that policemen were being served substandard food after 12 hours of duty. "Even a dog won't eat this. How can we work if we do not have anything in our stomachs?" he

Manoj Kumar, a resident of



Aligarh district, said, "There are a total of six members in my family, including two younger brothers and an unmarried sister. My parents are old and undergoing treatment. It will be very difficult for me to take care of them by staying on duty over 600 kilometres away from them. I am the only earning member in my family."A friend of Kumar, who is also in the police force, said, "It is disheartening to see that an honest man like him is made to suffer for raising a genuine issue. He comes from a humble background and his two brothers still work as daily wagers. In fact, Manoj worked as a child labourer as well to pursue his education."After the video went viral, Firozabad Senior Superintendent of Police issued a roster for circle officers to check the quality of food served in the mess. Similar orders were issued in other districts as well.

7 UNDERTRIALS ATTEMPT MASS SUICIDE IN VADODARA CENTRAL JAIL

Vadodara: Seven undertrials attempted mass suicide by drinking phenyl and detergent liquid in Vadodara Central Jail, police said on Thursday. They were rushed to the SSG hospital, where their condition is stated to be stable.

According to Deputy Commissioner of Police Abhay Soni, on Wednesday evening, seven undertrials attempted to end their lives by consuming phenyl or detergent liquid as they had some grievances against the jail authorities. The real motive behind this is yet

to be ascertained, he added. One of the jail inmates Harsh Limbachiya alleged that the jail authorities have stopped their tiffin services and are demanding bribes to restore it. They are not allowed to go out of the barracks and food is not served to jail inmates on time.

11-YEAR-OLD RAPE SURVIVOR DELIVERS BABY IN UP'S UNNAO

n 11-year-old rape survivor has given birth to a baby boy at the district hospital in Uttar Pradesh's Unnao district. The health of the new born is being monitored in the NICU of the hospital, said doc-

Initially, the police and medical staff at the CHC (Maurawan) did not believe that the girl could be pregnant and thought that her belly was swollen.

District child protection officer Sanjay Mishra said that the rape survivor was brought to the district hospital after acute labour pain. "She had a normal delivery and the baby weighs 2.60 kg. Both the mother and child are healthy," he said.

CWC chairperson Preeti Singh, who has been in regular touch with the family, said initially the child had



breathing issues. "He has been shifted to the NICU of the hospital, where his condition is being monitored closely," she said.

The victim was kidnapped in January when she was at a local shop to buy sugar. Three men allegedly covered her face and took her away

to a graveyard where she was were arrested after the complaint lodged by the police.

SP (Unnao) Dinesh Tripathi said the family had approached the police in February with a complaint against unidentified persons. During the statement recorded before the magistrate, the girl's father had stated that he would reveal the names later.On the basis of the names he revealed, three persons were arrested for rape and under the provisions of POCSO. The police also invoked Gangster Act against the accused.

"The family has given names of two other persons, saying they were also involved in the crime," he said. "We will put these names before

the court and seek permission to investigate them. The case is already on trial in POCSO court," added

False documents to avail EWS reservation will lead to termination: Government

f a person avails the benefit of 10 per cent reservation under EWS category for a job on the basis of wrong information or documents, his services will be terminated, the government has warned.

Issuing clarifications on the issue of the EWS reservation, the Centre said that the term family will include the parents even if the beneficiary is separated from parents.

Earlier, the Department of Personnel and Training had issued guidelines providing for 10 per cent reservation to **Economically Weaker** Sections (EWSs), who are not covered under the reservation scheme for SCs/STs/OBCs in respect of direct recruitment in civil posts and services in the Central government.

However, it received a number of references from various Ministries, Departments and individuals for clarification of certain issues. The Central

Information Commission in a hearing held on April 27, also directed it to take necessary action to place in the public domain FAQs on EWS reservation to assist the information seekers in future.

Subsequently, the DoPT issued detailed FaQs. It said that the appointment is provisional and is subject to the income and asset certificates being verified through the proper channels and if the verification reveals that the claim to belong to EWS is fake, the services will be terminated forthwith without assigning any further reasons.

It also said that the appointing authority should



verify the veracity of the income and asset certificate submitted by the candidate through the certificate issuing authority. "If the income & asset certificate is found to be fake, the services of the temporarily appointed per-

son shall be done away with."Clarifying on whether in case of applicants(s) not living with parents or separated by parents, property or income of parents shall be taken into account for computation of family income,

the DoPT said that term "family" for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18

"To make it clear, it is stated that whether the children are not living with parents or separated from parents, property/income of parents shall be taken into account for computation of family income.

It said that the threshold income of Rs 8 lakh for the purpose shall include income from all sources including salary, agriculture, business, profession, etc. for the financial year prior to the year of application. The income for this purpose will be gross income taken into account for the purpose of Income Tax.

The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status, it

ODISHA EXCISE OFFICIALS SEIZE 47 SILVER BRICKS, RS 14 LAKH CASH

xcise officials on Thursday seized 47 silver bricks, weighing over 139 kg, silver ornaments packed in 19 packets, and Rs 14 lakh cash from a car near Tangi toll gate in Odisha's Cuttack district. Excise officials said that, acting on a tipoff on illegal transportation of ganja from Ganjam district, they searched West Bengalregistered four-wheelers. he members of a Muslim family have been brutally beaten up by a mob in Madhya Pradesh's Chhindwara district allegedly in what is being considered as "an act of revenge"

Wajid Ali and his family members were attacked as he had eloped with a 23-year-old Hindu woman almost a month ago. The incident which happened on September 15 came to light after a video surfaced on the social media late on

Tuesday. In the video, several people including women could be seen beating a Muslim man and his parents mercilessly. Those attacked have been identified as Wajid Ali, 35; his father Sayed Ali, 52, and mother Sameena Ali, 48 -- all residents of Lalgaon village named located around 35



km from Chhindwara. On September 15, when Wajid and his parents were on their way to meet a relative in Auriya village, they were noticed by the villagers and were attacked. The Chhindwara police claimed to have registered a case against the Hindu family, and also arrested four persons."The act came as revenge after Wajid Ali had eloped with a Hindu woman of the same village. The girl, however, was brought to her family later. When the Muslim family was noticed, some people cornered them and later attacked. An FIR has been registered and at least four persons have been arrested so far. Further investigation is underway," a police officer said.

India wins UN award for initiative against hypertension

In a significant achievement and recognition to country's efforts against hypertension, India on Wednesday won a UN award for its 'India Hypertension Control Initiative (IHCI)'.

A collaborative initiative of Ministry of Health and Family Welfare, Indian Council of Medical Research (ICMR), State Governments and World Health Organization-India, IHCI has won the '2022 UN Interagency Task Force and WHO Special Programme on Primary Health Care Award' at the UN General Assembly side event held on September 21 in New York.

The IHCI is a large-scale hypertension intervention under National Health Mission which has been recognized for its exceptional work within India's existing primary healthcare system, Health Ministry said in a statement.

The award recognizes outstanding commitment and action of India to: (i) prevent and control Non-Communicable Diseases (NCDs) and (ii) deliver integrated people-centric primary care. The UN Task Force has identified organisation which has multisectoral approach in prevention and control of NCDs and multisectoral action with demonstrated results at primary care for prevention and control of NCDs and related Sustainable Development Goals (SDGs). IHCI has been able to leverage and strengthen the existing healthcare delivery system, hypertension control interventions under National Health Mission and improve the linkages between populations-based screening initiative with health care. The initiative was launched in 2017 and expanded in a phased manner to cover more than 130 districts across 23 states. The strategies include a simple drug-dose-specific standard treatment protocol, ensuring adequate quantity of protocol medications, decentralization of care with follow-up and refills of medicines at Health Wellness Centres, task sharing involving all health staff and a powerful realtime information system which can track every patient for follow-up and blood pressure control.

The frog, the scorpion and Pakistan

Pakistan Prime Minister Shehbaz Sharif is in New York to attend the United Nations General Assembly's (UNGA) 77th session. On September 23 he will address the UNGA. Talking to Pakistan media in New York, Sharif said that his aim would be to make the world community aware of the devastation that monsoon rain has caused in his country, one-third of which remains submerged under floodwater.

The devastation caused by the recent floods in Pakistan is no doubt catastrophic. Nearly 40 million have become homeless, thousands of kilometres of roads and scores of bridges have swept away, millions of rupees' worth of livestock is dead, crops have gone and thousands are suffering from diseases such as dengue, dysentery, cholera, malaria and typhoid.

But the Pakistani Prime Minister mentioned to the press something that was totally out of context. He said that the 'Kashmir issue' will also be mentioned during his address to the UNGA.

This reminded me of a story in which a scorpion approaches a frog and asks it to carry him on its back across the river. The frog hesitates and tells the scorpion that he does not trust it since he might sting the frog.

The scorpion begs the frog to take him across and promises that he will cause no harm to the frog. As the frog carries the scorpion on its back, gets to the middle of the river, the scorpion stings the frog releasing his poison in under the skin of the frog.

The frog asks the scorpion why did it sting him despite promising that the scorpion would not sting him. To this the scorpion said apologetically, "I just couldn't help it, you see to sting is my nature."

Pakistan shares the same nature. No matter how many times one trusts Pakistan it always stings it benefactor. At the time of partition of Indian sub-continent in August 1947, Pakistan



had signed a stand-still agreement with the Maharaja of the state of Jammu and Kashmir promising to accept the sovereignty of the state. Yet on October 22, 1947, Pakistan

attacked the state of Jammu and Kashmir! In 1999 when Nawaz Sharif was Pakistan's Prime Minister and was expressing his profound desire to trade with India, his Army

Chief attacked our territory in Kargil.

Pakistan was created in the name of religion and communal division. Something that

it nurtures even to this day. In order to remain relevant, the Pakistan military establishment has to keep the threat of an Indian attack and an imaginary suppression of Muslims in Kashmir and wider India alive.

Shehbaz Sharif's coalition government that has been allegedly propped up by the anti-Imran Khan section of the Pakistan military establishment led by its chief General Qamar Javed Bajwa, is official foreign policy line designed for nearly seven decades by the Pakistan military estab-

On September 29, the Pakistan Tehreek-e-Insaf (PTI) Chairman, Imran Khan is due to address a public rally in Muzaffarabad, the capital city of Pakistan-Occupied-Jammu Kashmir. US FED DELIVERS ANOTHER BIG INTEREST RATE HIKE

The US Federal Reserve announced another interest rate hike to fight inflation amidst growing concerns that the central bank could end up slowing down the economy.

The 0.75 hike was the fourth in 2022. "We have got to get inflation behind us. I wish there were a painless way to do that," Fed Reserve Chairman Jerome Powell said. "There isn't".

He added: "We want to act aggressively now, and get this job done, and keep at it until its done." A further increases are expected later in the year, of three-fourth, which would take the benchmark rate to 4.4 per cent, including a three-fourth hike in November and by a half point in December. More rate hikes will follow next year.

Trump, three of his children sued for business fraud by New York AG

Former US President Donald
Trump and three of his grownup children and executives at
his company have been sued by the
New York Attorney General Letitia
James on Wednesday for "flagrantly
manipulating property valuations to
deceive lenders, insurance brokers
and tax authorities into giving them
better rates on bank loans and
insurance policies and to reduce
their tax liability."

In a 222-page civil law suit, James sought the New York Supreme Court to bar Trump, as well as Donald Trump Jr., Ivanka Trump and Eric Trump, from serving as executives at any company in New York, and to bar the Trump Organization from acquiring any commercial real estate or receiving loans from any New York-registered financial institution for five years, the Washington Post reported.

It seeks to recover more than \$250 million in what James's office says are ill-gotten gains received through the alleged deceptive practices.
While the lawsuit itself is not a criminal prosecution, James (D) said she



has referred possible violations of federal law to the Justice Department and the IRS, the report said. Trump lawyer Alina Habba dismissed the allegations as politically motivated, saying in a statement that the attorney general's claims are "meritless".

The lawsuit, filed in New York Supreme Court, is the result of a more than two-year investigation by James and names 23 properties in the Trump Organization portfolio, including his Mar-a-Lago Club in Florida, his Seven Springs estate in Westchester County, New York, and the D.C. hotel he leased from the federal government until he sold it in May.

"The inflated asset valuations in the Statements cannot be brushed aside or excused as merely the result of exaggeration or good faith estimation about which reasonable real estate professionals may differ,"

Yemen's Houthi militia displays 'home-made long-range' missiles

According to the Houthirun al-Masirah TV, the militia held the parade on Wednesday to celebrate the eighth anniversary of its capture of Sanaa on September 21, 2014, reports Xinhua news agency.

Air and sea missiles, which the TV claimed to be Houthi-made, were displayed.

Top leader Mehdi al-Mashat delivered a speech, calling for the Yemeni government and the Saudi-led military coalition to engage in peace, and lift the blockade on the Sanaa airport and Hodeidah seaport.

In January, the group claimed it launched several rounds of missile and drone attacks against targets in the United Arab Emirates (UAE), which is more than



2,000 km away from Yemen.
The attacks prompted
fears that the militia owns
more powerful missiles that
can reach further targets.

Yemen has been mired in a civil war since late 2014 when the Iran-backed Houthi militia stormed several northern provinces and forced the Saudi-backed government out of the capital Sanaa.The Saudi-led Arab coalition intervened in

the conflict in the following year to support the Yemeni government.

The UN successfully mediated a two-month truce for the first time since the civil war erupted eight years ago.

The truce initially took effect on April 2, then renewed on June 2, and then extended for an additional two months on August 2.

Leicester unrest culmination of growing tension between Hindu, Muslim communities

The unrest in Leicester, which erupted last weekend, was the culmination of several weeks of growing tension between parts of the Hindu and Muslim communities in the English city, the media reported.

It reportedly began after a cricket match between India and Pakistan, at the end of August, reports the BBC.

Whether the match inflamed existing tensions or served as an opportunity for outside instigators is now the subject of intense speculation.

A total of 47 people have been arrested, 20 over the weekend and some have been sentenced for possession of weapons. The fight has spilled online as well, says the BBC. Claims of attacks on people because of their religion have gone viral, though many are unverified and, in one case, confirmed by police not to have happened. On Wednesday, officers urged people not to share unverified claims on social media. Leicester



Magistrates' Court heard one man sentenced for carrying a knife had been influenced by social media, the BBC reported. Footage shared by both Hindus and Muslims on social media, allegedly taken during the unrest in the past few weeks, shows groups from both sides, masked men banging on people's windows in Hindu-majority areas and pulling down religious decorations, and others marching down predominantly Muslim-populated streets, chanting 'Jai

Shri Ram', the BBC reported.

One video posted online shows a man climbing on to the roof of a Hindu temple, on Belgrave Road, and pulling down a religious flag.

In another video, shared by the temple itself, on its Facebook page, a group of men set one of the temple's flags alight. According to Leicestershire Police, a significant number of those arrested in the disorder were not from the city.

On Monday, Temporary Chief
Constable Rob Nixon said they had seen
"a group of people from other cities come
to our city to disrupt and cause harm".
Some activists speculate Hindu nationalist groups from India are also involved,
BBC reported. Violence between Hindus
and Muslims is extremely rare in the UK,
especially in Leicester, which is known
for its particularly strong sense of cohesion. There's long been solidarity
between Hindus and Muslims in the UK,
as two diasporic minority communities
that, in Britain, face similar problems of
racism and discrimination.

BEER SPILL BLOCKS FLORIDA HIGHWAY

Guterres warns against continued global warming, 1.5-degrees limit 'on life support'

United Nations Agencies

N Secretary-General Antonio Guterres warned that global warming continues and the most ambitious goal of the 2015 Paris accord -- to limit Earth's warming to 1.5 degrees Celsius above pre-industrial levels -- is "on life support".

"The 1.5-degrees limit is on life support, and it is fading fast," the top UN official told reporters late Wednesday after he concluded two meetings with many heads of state and government to talk about the climate emergency and the triple global crisis of food, energy and finance.

"You have all seen the appalling images from Pakistan. This is happening at just 1.2 degrees of global warming... We are headed for over 3 degrees," Xinhua news agency quoted the UN chief as saying...

Guterres said that he told the assembled leaders that "we need their action, their leadership, now".

"First, more ambition on mitigation to keep 1.5 alive. Emissions must decline by 45 per cent before 2030. Current commitments will see them rise by 14 per cent."

The Secretary-General said that he particularly called on G20 leadership "to end our fossil fuel addiction".

On financing, the top UN official called for efforts to "deliver in full" commitments to the developing countries.

"The world needs clarity on how developed countries will deliver the \$100 billion dollars a year. I emphasized the need to double adaptation support to 40 billion

dollars a year by 2025," he added.
Turning to food security, Guterres said
"without enough fertilizers, next year's
harvest may not be enough to feed the

"We need international cooperation and solidarity to bring down prices, increase support to developing countries, including through social protection floors, and to prevent a larger crisis next year," he said. Guterres called on international financial institutions to step up support for developing countries.

"No" to both Sena camps for Dussehra rally at Shivaji Park

Both feuding factions of the Shiv Sena have been denied venue permission for the party's annual Dussehra Rally on October 5 at Mumbai's Shivaji Park, but Uddhav Thackeray's camp says it'll go ahead "no matter what". "We will use guerrilla warfare tactics," Ajay Choudhary, leader of the Thackeray faction in the Maharashtra assembly.

"The rally has been taking place at the Shivaji Park for 56 years. It could not happen for the last two years due to the COVID-19 pandemic... It is a matter of loyalty and tradition," said former Mumbai mayor Kishori Pednekar, a spokesperson of the Thackeray-led Sena, terming the denial "a bad script by the BJP".

The Brihanmumbai Municipal Corporation (BMC), currently run by an administrator, cited fears of "a law and order situation" at the venue if permission was given to any one camp.

While the rebel group led by



Chief Minister Eknath Shinde hasn't yet reacted, the camp led by Uddhav Thackeray, who technically remains Shiv Sena chief, was already in the High Court for permission to hold the October 5 rally at Shivaji Park. The hearing is set for

tomorrow.

Unseated as Chief Minister in a coup four months ago, Uddhav Thackeray has been asserting that the rally will "certainly" be held at the venue that's synonymous with fiery speeches of his late father,

party founder Bal Thackeray. But Mr Shinde's faction wanted the same venue as it also claims Bal Thackeray's "original" legacy of "Hindutva and Marathi pride".

The BMC, which appears to have skirted a row, was controlled by the Shiv Sena from 1997 to March this year, when the tenure of corporators ended and polls could not take place. And then the Sena split in June. The civic body is currently governed by an officer as administrator. Eknath Shinde's camp does have a backup plan - it has permission for a ground in Bandra Kurla Complex - but Team Thackeray is all-in on Shivaji Park.

This is the first Dussehra since the split, when the Shinde faction partnered with the BJP to form a new government, replacing Uddhav Thackeray's Sena-Congress-NCP setup. Shinde said this was only a resumption of the partnership with "natural ally" BJP. Thackeray had junked ideological differences while dumping the BJP despite winning the last elections together, the Shinde faction has underlined.

MAHA ATS ARRESTS 20 PFI ACTIVISTS FROM DIFFERENT LOCATIONS

The Maharashtra Anti-Terrorism Squad on Thursday arrested 20 activists of the Popular Front of India (PFI) from the state during a multi-nodal agency operation for allegedly indulging in unlawful activities promoting enmity among communities and waging a war against the country, an official said.

In near simultaneous raids across the length and breadth of the country, a multi-agency operation spearheaded by the National Investigation Agency (NIA) on Thursday led to the arrest of 106 PFI activists in 11 states for allegedly supporting terror activities in the country, officials said.

According to the officials, the arrests were made during the raids which have been termed as the "largest-ever investigation process till date"

In Maharashtra, raids were con-



ducted by various ATS teams in Mumbai, Navi Mumbai, Thane, Aurangabad, Pune, Kolhapur, Beed, Parbhani, Nanded, Malegaon (in Nashik district) and Jalgaon, an official said.

The ATS teams arrested at least 20 people from various places and

seized important documents, he

The ATS has registered four offences in Mumbai, Nashik, Aurangabad and Nanded under various Indian Penal Code Sections including 153-A (wantonly giving provocation with intent to cause riot), 121A (conspiring to commit certain offences against the State) and 120B (criminal conspiracy), and provisions of the stringent Unlawful Activities (Prevention) Act (UAPA), he said.

The ATS officials were also making enquiries with some people in connection with these cases, he said

The PFI was formed in 2006 in Kerala and is headquartered in Delhi.It claims to strive for a neosocial movement ostensibly for the empowerment of marginalised sections of India. It is, however, often accused by law enforcement agencies of promoting radical Islam.

6 killed in 24 hours on highway where Cyrus Mistry died

ED attaches property worth Rs 2,747 cr of ABG Shipyard in bank fraud case

The Enforcement Directorate (ED) on Thursday attached assets worth Rs 2,747.69 crore of the ABG Shipyard Limited in bank fraud case.

The ED said that the attached assets include Shipyards in Gujarat's Surat and Dahej; agricultural lands and plots, various commercial and residential premises in Gujarat and Maharashtra; and bank accounts owned by ABG Shipyard Ltd, its group companies and other related entities.

The ED initiated a money laundering investigation on the basis of an FIR registered by the Central Bureau of Investigation (CBI).

Investigation by ED revealed that ABG
Shipyard Ltd and its Chairman and Managing
Director Rishi Kamlesh Agarwal availed various credit facilities from consortium of Banks
led by ICICI Bank, Mumbai on the pretext of
meeting its capital requirements and other
business expenses, but ABG Shipyard Ltd
misappropriated the credit facilities availed
from the consortium and diverted the funds
for the purposes other than its actual cause in



the garb of various loans, advances, investments to various related entities incorporated in India and abroad. It caused monetary loss to the tune of Rs 22,842 crore to the consortium. The ED has traced movable and immovable assets totaling Rs 2747.69 crore belonging to ABG Shipyard Ltd, its group companies, Bermaco Energy Systems Ltd., Dhananjay Datar, Savita Dhananjay Datar, Krishna Gopal Toshniwal, Viren Ahuja and attached them under the provisions of Prevention of Money Laundering Act (PMLA).

The Fed's new projections showed its policy rate rising to 4.4 per cent by the end of the year, before peaking at 4.6 per cent in 2023 to curb uncomfortably high inflation. Rate cuts are not expected until 2024. He added that the Fed's actions are likely to result in slower growth and higher unemployment.

Fed Chair Jerome Powell said the bank needed to take much more aggressive measures to combat redhot inflation, and was prepared to put some pressure on the economy and the job market as a result.

After the rate hike, the benchmark 10-year US Treasury yield jumped to 3.64 per cent, its highest level since 2011, while the two-year yield hit a fresh 15-year high of 4.13 per cent on Thursday.

Amid all, the broader indices outperformed and gained nearly 0.5 per cent each.

RBI cancels licence of Laxmi Co-operative Bank, Solapur

The Reserve Bank of India (RBI) on Thursday cancelled the licence of The Laxmi Co-operative Bank Ltd in Maharashtra's Solapur.

Consequently, the bank ceases to carry on banking business, with effect from the close of business on September 22.

The Commissioner for Cooperation and Registrar of Cooperative Societies, Maharashtra has also been requested to issue an order for winding up the bank and appoint a liquidator for the bank.

On liquidation, every depositor would be entitled to receive deposit insurance claim amount of his/her deposits up to a monetary ceiling of Rs 5 lakh only from the Deposit Insurance and Credit Guarantee Corporation (DICGC) subject to the provisions of DICGC Act, 1961.As per the data submitted by the bank, about 99 per cent of the depositors are



entitled to receive full amount of their deposits from the DICGC. As on September 13, the DICGC has already paid Rs 193.68 crore of the total insured deposits under the provisions of Section 18A of the DICGC Act, 1961 based on the willingness received from the concerned depositors of the bank.

FOLLOWING ARE THE REASON THE CENTRAL BANK STATED FOR CANCELLING THE LICENCE:

- The bank does not have adequate capital and earning prospects. As such, it does not comply with the provisions of Section 11(1) and Section 22(3)(d) read with Section 56 of the Banking Regulation Act, 1949.
- The bank has failed to comply with the requirements of Sections 22(3) (a), 22 (3) (b), 22(3)(c), 22(3) (d) and 22(3)(e) read with Section 56 of the Banking Regulation Act, 1949;
- The continuance of the bank is prejudicial to the interests of its depositors;
- The bank with its present financial position would be unable to pay its present depositors in full; and
- Public interest would be adversely affected if the bank is allowed to carry on its banking business any further.



The Indian bowlers were totally ineffective in death

T20I cricket after a substantial gap and should be given another chance. Jhulan had made her ODI debut against England in January 2002 at Chennai. In a career spanning two decades, she would be leaving the international arena as the highest wicket-taker in women's cricket, with her tally currently sitting at 352 wickets across all formats.

Synopsis: A psychopath is murdering film critics one by one in the most heinous way possible. Can the cops catch him before the next film review is published?

Review: The film's plot begins with the first murder, which introduces the world to a serial killer. A serial killer who murders film critics solely for their unfair ratings and sarcastic reviews. The film lacks suspense as the audience learns who the real killer is very quickly. It is typical R. Balki cinema which examines the world around us in a variety of ways. His stories are about the absurdity in the ordinary, as well as the eyes that creates the absurdity in the first place.

The filmmaker, along with his cowriters Raja Sen (a renowned film critic) and Rishi Virmani creates a story that delves into virgin lands and is as delicate as a castle of cards, one wrong step and the entire castle crumbles in an instant.

Technically, this film meets the criteria for a good film. It appeals to the eyes by creating tension with the camera. Perfect close-ups and top shots remind us that the cameraman attempted to



emulate Dutt's style somewhere. To be sure, there are many nostalgic moments in the film and the intentional homage to Guru Dutt by including chartbusters such as 'Jaane kya tune kahi' and 'Yeh Duniya agar mil bhi jaaye' from his classic 'Pyaasa' was an incredible attempt. In addition, the film pays homage to Guru Dutt's incredible work, Kaagaz Ke Phool. Balki wins the show when he decides to include a final chapter in the last 10 minutes of the show, bringing two lives full circle.

When it comes to character performances, Sunny Deol has literally acted well in the film, though you can see him pulling an OG Sunny Deol when he jumps out of a window and lands in a studio, crossing an entire corridor of the building.

Dulquer Salmaan's Danny was a visual treat; the boy Danny has several personalities and talks to his own other personality in general. Dulquer's role has a few layers, but he portrays the character of Danny Urf Sebastion Pinto

Amitabh Bachchan's cameo in the film came as a surprise, and it's lovely



to see him as Bachchan Sahab, saying things that only Amitabh Bachchan can say. Shreya Dhanwanthary, who plays Nila Menon, an entertainment reporter and Danny's love interest, has clearly left an impression on the audience. Pooja Bhatt has a limited but notable role as a criminal psychologist.

Speaking of the rest of the cast who contributed to the film's success. Each character in the film has its own significance, and each character has contributed to the film's excellence.

The film has elements of the old school Pehli Najar ka Pyar that can be seen when Danny and Nila fall in love. When it comes to movie soundtracks, the songs are relaxing and scary at the same place. The background music contributes to the suspense. This film makes excellent use of some classics in the most appropriate context.

Conclusion : The film focuses on the extraordinary and never-touchedbefore issue of how biasedness can turn an artist into a criminal. The movie has a few loopholes but as a whole, it is a decent film. It is definitely time well spent.
