A high rate of inflation hurts the poor, hits demand for consumer goods and adversely impacts investment demand. High inflation hits the poor people harder as their income is low and they are not able to afford regular consumer items. For savers, optically the interest income rise, but inflation being high, their purchasing power is adversely impacted.

ndian households' savings fell to a five-year low in 2021-22 as rising inflation gnawed into the purchasing power of the middle class.

Also, due to the Coronavirusinduced lockdowns, people were forced to dig into their savings, as the pandemic also led to severe job losses and in the absence of steady incomes, savings were the last resort for people to run their households.Compared to 15.9 per cent in 2020-21, the gross financial savings of households stood at 10.8 per cen in 2021-22. NO SIGNS OF INFLATION COOLING, **RATE HIKES PREDICTED**

New Delhi: The Reserve Bank of India (RBI), during the last meeting of its monetary policy committee (MPC) on September 30, had hiked repo rates by 50 basis points for the fourth consecutive time

As retail inflation in India continues to remain above the RBI's comfort zone for the past 10 months, analysts feel that more hikes are expected in future.

After four hikes, the RBI has now raised rates by a total 190 basis points since its first unscheduled mid-meeting increase in May. In this scenario, economists expect further hikes by the central bank.

GOVT HIKED DEPOSIT RATES TO TAME INFLATION; BABY STEPS

New Delhi: Concerned over rising inflation, the government, aiming to tame price rise, had hiked interest rate for senior citizen savings scheme by 20 basis points from 7.4 per cent to 7.6 per cent on September 30 through a notification.

The interest rate for Kisan Vikas Patra is now 7 per cent for the maturity period of 123 months, compared to the earlier rate of 6.9 per cent for a maturity period

A three-year time deposit with post offices will now give 5.8 per cent interest compared to 5.5 per cent earlier. For a two-year time deposit, however, the rate hike was only 20 basis points from 5.5 per cent to 5.7 per cent. Interest rates though were not

changed for more popular

schemes like Public Provident Fund (where the interest rate is 7.1 per cent), Sukanya Samriddhi Yojana (7.6 per cent), savings deposits (4 per cent) and National Savings Certificate (6.8 per cent).

The rates of one-year and fiveyear term deposits were also kept unchanged at 5.5 per cent and 6.7 per cent, respectively. All these hikes came into effect from October 1, 2022 and are valid till December 31, 2022.

Experts point out that inflation cannot be controlled unless term deposit rates and rates of small savings schemes are not hiked. They add, however, that these are baby steps and these rates need to be hiked on a regular basis to bring about a semblance of sanity on rising inflation.

Mother-son arrested in Delhi for chopping & dumping husband's body

n another bone chilling incident similar to the gruesome killing of Shraddha Walkar, the Crime Branch of Delhi Police has arrested a woman and her son for the killing of her husband, chopping his body into 10 pieces and dumping the remains in a New Ashok Nagar drain and near the Ramlila ground in Pandav Nagar.

According to the police, the murder occurred on May 30and so far, six body parts have been recovered while a search is underway for the missing remains. The accused have been identified as Poonam and her son Deepak.

Sources said that after chopping Anjan Das's body, the duo had stored the body parts in their fridge and started gradually disposing them.

The police said that on June 5, after noticing a foul smell in the Ramlila ground, the police inspected the premises and recovered the human remains.

Yadav went on to say that after the police teams conducted door-to-door verification, the body was finally identified. Poonam was narrowed down as a suspect after it was

revealed that her husband was missing for the last 7 to 8

months and no complaint was also filed. The CCTV cameras in the neighbourhood showed Deepak walking with a bag in his hand late at night. His mother Poonam was seen following him. They were captured in CCTV cameras several times while disposing off the body remains in plastic bags, said the police. Both were

interrogated and they confessed to the crime. "On interrogation, it was revealed that the mother and son had hatched a conspiracy to kill the victim in March and then on May 30, after giving him sleeping pills mixed in alcohol, the duo stabbed him to death with a knife and dagger, at several vital parts of the body, including the neck,"

According to the police, Poonam alleged that her husband had illicit relations and was also eyeing Deepak's wife, adding that he even sold her jewellery.

"Poonam, a native of Bihar was first married to Sukdev Tiwari. However, Sukhdev had come to Delhi. Poonam came looking for him but was not able to locate him. After some time, she married Kalu in Delhi and both had a son, Deepak. After Kalu died due to liver failure, she married Anjan Das in 2017," said Yadav. The victim, a resident of Kalvannuri used to work as a lift mechanic and had eigh children back in Bihar.

'Kasab' jibe on Muslim student lands teacher in trouble

ollowing a public outcry and internet fury, an engineering college professor in Karnataka has been 'debarred from classes' and a probe ordered into the matter by college authorities, two days after he allegedly addressed one of his students, a Muslim, as 'Kasab' in the classroom. The controversy broke out after a 45-second video showing the student calling out the professor over being called a terrorist, went viral on social media.

The issue reportedly occurred in the Manipal Institute of Technology in Manipal on November 26, the anniversary of the 26/11 Mumbai terror attacks.

"Being a Muslim and facing this everyday is not funny," the student can be heard saying angrily

in the video which was seemingly recorded by another student in the class.

Even as the contrite professor tried to apologise and mollify him by saying he is like his son, the student refused to relent saying it wasn't funny.

Meanwhile, without divulging details but confirming that the said incident had taken place, the college authorities have said that action has been initiated in the

"The concerned staff has been deharred from classes till the inquiry is over. We would like everybody to know that the institute does not condone this kind of behaviour and this isolated incident will be dealt with in accordance with the laid down policy," the Manipal Institute of Technology stated on Monday.

MEHRAULI MURDER: MEN WITH SWORDS ATTACK POLICE **VAN CARRYING AAFTAB**

New Delhi: A police van carrying Aaftab Amin Poonawalla, who is accused of the ghastly murder of his live-in partner Shraddha Walkar in Delhi's Mehrauli area, was attacked by a group of men armed with swords outside the Forensic Science Laboratory (FSL) in Rohini when he was being taken back to Tihar jail after a polygraph test. A group of people even tried to enter the van carrying swords. However, the police sprung into action to take control of the situation. A policeman also waved a gun at the attackers to disperse them.

In a video doing rounds on social media, the men could be seen chasing the van carrying Aaftab and managing to open the van's rear door to find a policeman standing inside, in an apparent attempt to attack Aaftab.

According to G.S. Sidhu, the Deputy Commissioner of Police (Rohini), two persons, Kuldeep Thakur and Nigam Gujjar, both residents of Gurugram, have been

Thakur runs a car sale and purchase business, while Gujjar works as a truck driver.

Meanwhile, Vishnu Gupta, the national president of Hindu Sena, denied the organisation's role in the matter.

'IT'S A MENACE': CENTRE TO SC ON FORCED RELIGIOUS CONVERSION

he Centre on Monday told the Supreme Court that the issue of forced religious conversion "is a menace", and it is cognizant of the gravity and the seriousness of the issue.

NOTICE TO CENTRE, STATES ON PLEA SEEKING FREE SANITARY PADS FOR SCHOOL GIRLS

New Delhi: The Supreme Court on Monday sought response from the Centre, states and Union Territories (UTs) on a plea seeking direction to provide free sanitary pads to girls studying in Classes 6 to 12 in government schools across the country. The bench said the plea has raised an important issue of sanitation and hygiene of girl students. The plea said that adolescent females between the age group of 11 and 18 years, who come from poor backgrounds, face the insurmountable difficulties in receiving education on account of lack of access to education, which is a right under Article 21A of the Constitution and it is free and compulsory under the Right to Education Act, 2009. The plea has been filed by Jaya Thakur, a Madhya Pradesh-based doctor.

GOVT LAUNCHES SCHEME TO PROCURE 4,500 MW ELECTRICITY

he Power Ministry has launched a scheme for procurement of 4,500 MW of aggregate electricity for a period of five vears.

The provision of procurement of electricity would be conducted under the ministry's Scheme for Harnessing and Allocating Koyala (Coal) Transparently in India (SHAKTI) policy.

"Ministry of Power kicks off a scheme for procurement of aggregate power of 4,500 MW on competitive basis for five years on finance, own and operate (FOO) basis under SHAKTI Policy," a statement issued by the Power Ministry said.PFC Consulting Ltd, a wholly-owned subsidiary of **Power Finance Corporation** (PFC Ltd), has been made the nodal agency by the power ministry for the



scheme. Under the scheme. PFC Consulting Ltd has invited bids for the supply of 4,500 MW of electricity. The supply will commence from April 2023 and the coal ministry has been requested to allot around 27 million tonnes per annum of dry fuel

Some of the entities which have shown interest in the scheme are Gujarat Urja Vikas Nigam Ltd, Maharashtra State Electricity

Distribution Company Ltd, Madhya Pradesh Power Management Company Ltd, New Delhi Municipal Corporation and Tamil Nadu Generation and Distribution Corporation Ltd. The last date for bid submission is December 21, 2022.

The scheme is expected to help those states which are facing power shortage and will also help increase capacity of generation plants, official sources said

Dailyhunt & Josh parent firm VerSe Innovation lays off 150 employees

erSe Innovation, the parent company of Dailyhunt and short-form video platform Josh, has laid off nearly 150 employees in a bid to "streamline" its costs and teams.

The layoffs impacted about 5 per cent of a 3,000-strong workforce at VerSe Innovation, which in April raised \$805 million from global investors, taking its valuation to \$5

Sources told reporter that given the current economic climate, the company evaluated its strategic priorities, and conveyed the decision during a town hall meeting addressed by the company's cofounders, Virendra Gupta and Umang Bedi.

"Considering the long-term viability of the business and our people, we have taken steps to implement our regular bi-annual performance management cycle and made performance and business



considerations to streamline our costs and our teams. This has impacted 5 per cent of our 3,000strong workforce," according to a company statement issued on Monday.

VerSe Innovation has also reduced salaries by up to 11 per Rs 10 lakh per annum, the sources added.VerSe Innovation registered a loss of Rs 2,563 crore in FY22, which increased from Rs 808 crore in

In June this year, the homegrown local language technology provider announced the launch of its vernacular content platform Dailyhunt in the Middle East region.

Dailyhunt rolled out its offering in the UAE, Saudi Arabia, Bahrain, Oman, Qatar and Kuwait with its headquarters in Dubai, with over 5,000 content partners.

Bedi had told reporter that there is a growing opportunity in local language content globally that they aim to tap.

Dailyhunt then offered more than 1 million new content every day in 15 languages, licensed and sourced from a creator ecosystem of over 50,000 content partners and a deep pool of over 50,000 creators.

SOUTH DELHI SCHOOL RECEIVES BOMB THREAT IN EMAIL

New Delhi: An email regarding a bomb being placed on a school campus in south Delhi was received on Monday. However, no bomb was found during the search operation by the police, said an official

According to Chandan Chowdhary, the Deputy Commissioner of Police (South), on Monday at around 1:19 p.m. an email was received on the official email ID of Indian Public School, Sadiq Nagar that there is a bomb in the premises of the school.

"The school administration immediately informed Defence Colony police station following which bomb disposal squad, dog squad along with police teams reached the spot," said

"The school was evacuated and a thorough search has been made. But no bomb has been found," said the Chowdhary, adding that the email is also being verified by the cyber team.

3 MLAs including 2 of NPP quit Meghalaya assembly; likely to join BJP

n a major political development, three sitting MLAs of Meghalaya, including two from the ruling National People's Party (NPP) resigned from their respective parties and the state assembly on Monday. They are likely to join the BJP soon.

NPP MLAs Benedic R. Marak and Ferlin C.A. Sangma and Trinamool Congress MLA H.M. Shangpliang submitted their resignation to Assembly Speaker, Metbah Lyngdoh.

The state would go to assembly polls along with two other northeastern states --Tripura and Nagaland -- in February next year. Shangpliang, while talking to the media,

said: "We want development in the state and the BJP is for development. In neighbouring Assam, Chief Minister Himanta Biswa Sarma while undertaking massive all-round development of the state, gave job letters to 25,000 youths in one day... why cannot the Meghalaya government do this?"With two MLAs, BJP has recently announced that it would contest the next year's assembly polls on its own, and field candidates in all the 60

Former Meghalaya Chief Minister Mukul Sangma (2010-2018), along with 11 Congress MLAs joined the Trinamool Congress in November last year. The party is now the main opposition party in Meghalaya.

Assam's Dibrugarh University rusticates 18 students for ragging

he authorities at Assam's Dibrugarh University on Monday rusticated at least 18 students for their alleged role in ragging a student who eventually jumped off a two-storey building of the varsity hostel "to save himself from mental and physical harassment". The incident happened on Saturday evening. The harassment meted to the student -- identified as Anand Sharma, an M.Com first semester student, continued till Sunday morning. Sharma was later admitted to a hospital on Sunday afternoon.

The accused students have also been expelled from the university hostel. An FIR lodged by the Registrar of the university in the incident mentioned that Sharma was mentally and physically assaulted from 4.30 p.m. on Saturday at Padmanath Gohain Baruah hostel at the campus. The assault continued until 5 a.m. in the



An official of the Dibrugarh University said that at around 10.30 a.m. on Sunday, Anand Sharma, in the pretext of going to the bathroom, jumped off the B block of the hostel to save himself from the "extreme mental and physical torture". He sustained serious injuries.

"A few students of the hostel took him to a nearby hospital in critical condition. Later, the varsity authority shifted Sharma to another hospital for advanced treatment." the official added. The university authorities have named accused five in the FIR including a former student of the university in the alleged ragging incident.
Police have detained four accused in this case. But the alumnus Rahul Chetri is still absconding.

Sharma is a student in M.Com's first semester. He is undergoing treatment in ICU at a private hospital in Dibrugarh. The victim's mother Sarita Sharma said: "My son was mentally and physically tortured, forced to drink liquor. He was not allowed to take food. The seniors used to send him for bringing liquor for them. He told me earlier to leave the hostel... I insisted him to stay at the hostel as we cannot afford a rented house. But, I never imagined the such level of torture he was facing at the hostel. The seniors also threatened him not to

complain anything to the authority. However, she claimed that the family earlier lodged a complaint with the university administration but no steps were taken to stop these activities.

Meanwhile, the university students have staged a protest on Monday and demanded stern punishment to the

SHARMILA'S ARREST, ATTACK ON CONVOY TRIGGER TENSION

ttack on VSR Telangana Party (YSRTP) leader Y. S. Sharmila's convoy allegedly by the supporters of ruling Telangana Rashtra Samithi (TRS) and her subsequent arrest by the police triggered tension during her padyatra in Warangal district on Monday

Chief Minister Y. S. Jagan Mohan Reddy, was arrested after she allegedly made certain objectionable comments about TRS MLA P. Sudershan Reddy.

Sharmila wanted to know from police why were they taking her into custody instead of arresting those



who attacked her bus.

YSRTP alleged that the bus which Sharmila is using to rest during her ongoing Praja Prasthanam padayatra was attacked and burnt down by the members of the ruling TRS party.

The mob also damaged cars belonging to YSR Telangana Party leaders. The incident happened near Lingagiri village, under Chennaraopeta mandal in Warangal

padyatra on 223rd day when a group and hailing KCR, reached the place where the caravan was halted and

"For the past 223 days, me and my Party leaders and representatives are holding a peaceful Padayatra to highlight the plight of various sections of people in Telangana. Our rising popularity has jolted Chief Minister KCR and his party men, who want to stop me at any cost," she said.

Daughter of former chief minister Y. S. Rajasekhara Reddy said that it is highly unfortunate that some police officers are siding with the ruling party and disrupting 'our efforts to reach the people and raise their issues.'The Praja Prasthanam padayatra has so far crossed 3,500 kms mark, covering 75 Assembly segments in the State. She has covered 1863 villages under 208 mandals and 61 Municipalities along with 4 Municipal Corporations, so far.

J&K POLICE BUSTS TERROR MODULE; ARMS, AMMUNITION RECOVERED

he Jammu & Kashmir Police along with 22 RR of the Army busted Ansar Gazwatul Hind (AGuH) module by arresting North Kashmir's AGuH handler and four terrorist associates at Sopore in North Kashmir's Baramulla district, officials said on Monday. According to the police, incriminating materials, huge cache of arms and ammunition have been recovered from their possession."Upon an information by sister agency regarding movement of main terrorist handler, Sopore Police alongwith 22RR established an MVCP grid in Sopore," the police said."During MVCP two individuals identified as Mushtaq Ahmed Bhat (main handler) of Chanapora, Srinagar and Ishfaq Ahmed Shah resident of Budgam were arrested.'

Police said incriminating material, arms and ammunition including one Pistol, one magazine, 10 rounds and three grenades were recovered from their possession.

"On further interrogation and development of the information, two more terror associates identified as Abdul Majeed Kumar resident of Bernate, Boniyar and Abdul Rashid Kumar



resident of Pattan were also arrested," the police said. The police said that preliminary investigation revealed that the busted terrorist module of AGuH was being handled by Ahsaan Dar and one individual named Chaudhary from across the border (PoK).

"The module was instructed to ensure continuous supply of arms and ammunition in Kashmir Valley for conducting attacks on outsiders, civilians and security forces to instil fear in the minds of general public. The timely and effective action by Sopore police and 22RR by busting the terrorist module have resulted in averting a possible major tragedy," the police said.

Couple burnt alive in Begusarai; wife dies, man critically injured

woman died while her husband is fighting for his life after they were set afire by miscreants over a property dispute in Bihar's Begusarai district, an official said on Monday.

According to the official, the victim Sanjay Yadav has a property dispute with one Ramesh Yadav in the village Barihari under Chakia police station in the district.

We were sitting inside our grocery shop on Sunday, when Ramesh Yadav, along with around half a dozen accomplices, came and doused us in petrol. As there was no power and a candle was burning inside, it caught fire immediately. Soon, the fire engulfed the entire shop. 

However, water is being wasted in many parts of Mumbai. The situation is similar in other cities. Therefore, all civic authorities should take this kind of action.

Money laundering case: Special court grants bail to ex-Maha minister Anil Deshmukh's son

ormer Maharashtra Home Minister Anil Deshmukh's son Hrishikesh Deshmukh on Monday appeared before a special court here in connection with a money laundering case and was granted bail.

A special court designated to hear cases related to the Prevention of Money Laundering Act (PMLA) recorded his appearance and then granted him bail. The court had in February this year issued summons to Hrishikesh after the Enforcement Directorate (ED) submitted its complaint (chargesheet) in the case.

Hrishikesh was arraigned as an accused in the chargesheet. After appearing before the court, Hrishikesh filed an application



through his advocate Aniket Nikam requesting the court to accept his appearance and grant him bail.

In his application, Hrishikesh pointed out that the accusations in the ED's case were confined to the

alleged acts of omission and commission by his father in his capacity as the then home minister from January 2020 to April 2021.

The plea cited that Anil Deshmukh had already been granted bail in the

case by the Bombay High Court. The ED began its probe against Anil Deshmukh after the Central Bureau of Investigation (CBI) registered a case against him over allegations of extortion made by former Mumbai police commissioner Param Bir Singh.The probe agency claimed that the former minister had misused his official position and collected Rs 4.70 crore from various bars and restaurants in Mumbai.

The money was channelled to Nagpur-based Shri Sai Shikshan Sansthan, an educational trust controlled by the Deshmukh family, it alleged.

Although Anil Deshmukh has been granted bail in this case, he continues to remain in jail in the case lodged against him by the CBI on corruption charges.

PRESIDENT RAISES ISSUE OF OVERCROWDING IN PRISONS

resident Droupadi Murmu on Saturday raised the issue of overcrowding in prisons and emphasised that there is a need to do something for the poor people in jails. "It is said that jails are getting overcrowded and there is a need to set up more jails," the President said. "Are we moving towards development? What is the need to set up more jails? We need to reduce their numbers. Poor people incarcerated for many years for petty crimes need help," Murmu ssaid. She pointed out that people are even jailed for slapping somebody or for some other minor offence, while there are people who do many things, even kill others, but are roaming free. The event was attended by the Chief Justice of India, D.Y. Chandrachud, Law Minister Kiren Rijiju,

Attorney General of India R. Venkataramani, Solicitor General Tushar Mehta, judges of the Supreme Court and members of the Bar. The President emphasised that there are poor people in the prisons and there is a need to do something for them. "You need to do something for these people. Who are these people in jail? They do not know the fundamental rights or the fundamental duties," Murmu said, as she recommended decongesting the jails. The President said that people do not act to release their family members, who are languishing in jails, as they feel that they would have to sell their utensils and property. The President said the legislature, the executive and the judiciary need to have "one thinking" for the country and its people, adding that checks and balances need to be there, but somewhere "we need to work together". "Our job is to think about people (poor undertrials languishing in jails). We all have to think and come out with some way... I am leaving it all on you," she said.

BIS MOVES IN ON FRAUD PRODUCT **REVIEWS: MUST INCLUDE FILMS**

ou want to buy some product and when you visit its website, there are a number of reviews related to it, mostly adorned with four or five stars. Do you trust the four or five stars? How do you know if these reviews and stars are genuine? You don't, you have no way of knowing if they represent genuine feedback about the product.

Also, you have no way of finding out if the people who posted the reviews really exist or have been created for the job, or have a vested interest in the product.

In the good old days, when there was no Internet, you went to your trusted vendor in the bazaar to buy what you wanted. Local traders and vendors built a reputation and repeat customers were his five-star ratings. Now you love to buy online, sitting in the comfort of your home. Also, in the good old fashion days, if a newspaper or a magazine published an article promoting a product, a professional person, a service provider, just about anything the publication did not endorse, the page carried a disclaimer with the four letters ADVT in one corner of the material published.

The Bureau of Indian Standards (BIS) wants a similar system to be in place in e-commerce businesses. Rarely do you find the letters ADVT in most publications plugging a product or service, except a few that still have a conscience as well as the interest of readers in mind. Most of them let it pass off as part of the editorial content.

The reason is that there are no regular checks on what thousands of print publications and online portals carry, and with the volume of social media platforms, tracking has become well nigh impossible. Actually, the burden of bringing frauds or misinformation to light is on the public, especially the aggrieved ones who grumble about

fraud but never report it.

Certain influential and affluent publishing houses have devised special sections to accommodate, promote and cash in on those products that need unabashed paid plugs or promotions. The sections are so named that if you are smart enough, you are not expected to take the matter printed in them seriously. They are called advertorials or promotional sections

Looks like the Bureau of Indian Standards (BIS) has caught up with these fraudulent practices carried out blatantly without any fear of action. And the Bureau is not wasting time implementing its decision to bring order to this exploitation of the consumer. Starting November 25, all those promoting or sponsoring a product or a service against payment will have to describe it as

Portals that offer food delivery, travel or ticketing services will no longer be able to publish paid reviews about their product or service and, in case it is done, such reviews will have to carry a disclosure of being a paid review. Not complying with the BIS directives will invite action against the Consumer Protection Act.

How does this move by the BIS matter to the film industry? The BIS' move to stop such fraudulent acts include fake reviews by independent third-party entities. This is what happens on a regular basis, unabashedly, in the case of film

reviews posted on social media.

The one who posts false reports, reviews and box-office collection numbers does not need to apply his mind. He simply posts what is drafted by the PR person concerned. Some film critics have become touts of filmmakers and the deal is that their posts in favour of a film earns them a few thousand. This is a grand fraud played on the moviegoer who falls prey to the publicity, not knowing that they are paid



Though the frauds regarding paid movie reviews are not mentioned specifically, I am sure the definition of fraudulent reviews and posts on e-commerce platforms and social media also covers this aspect. After all, a movie is a consumer product and a fraud is a fraud anywhere.

No Joyride For Joyland

Many years ago, a prominent daily newspaper carried a column where For and Against views were sought from two sides. The theme was whether India and Pakistan should get into a joint venture to produce films. Not strangely, as things work in our profession, the side I chose was already committed to the Pakistani representative, a lady filmmaker. I was left to debate against her point of view which was that India should enter into joint ventures to produce films with Pakistan.

Why? My stand was that the Indian film industry was thriving and had no need for a Pakistani coproduction. Also, it was not our job to promote or prop up the Pakistani film industry with joint productions. For most of its life, the Pakistani cinema chains have survived on Indian films when they are not banned in Pakistan off and on. So, by promoting the Pakistani film industry, should we compromise our own interests?

My final summation was that if Pakistani filmmakers really wanted to join hands, they had better start with their counterparts in our Punjab. After all, Punjabi is a language spoken on both sides. Also, our Punjabi industry was comatose in those days, and both made loud and crude films.

Pakistan still makes such crude films full of gore and violence and they are lapped up by the audience. Imagine, 'The Legend Of Maula Jatt', a remake of the 1979 film, 'Maula Jatt', was the biggest Pakistani hit in Pakistan as well as in the overseas market, where it is matching the box-office figures of Indian films such as 'RRR'! If the original was a huge hit, the 2022version is even a bigger hit. No wonder, in that country, a contemporary new film, 'Joyland', has to struggle

even to get a decent release. The film is about a married man

falling in love with a transgenPakistan is not ready for such a theme. To think that the film has won awards at various international festivals and is Pakistan's nomination for the Oscars does not help. The film has fallen prey first to the fear of mullahs and now to politics.

A mutilated version (thanks to the Censors in Pakistan) has been released in all provinces except Punjab, which is controlled by the PTI (Pakistan Tehreek-e-Insaf) headed by the country's deposed Prime Minister, Imran Khan.

Whereas India has one censor certification authority with regional offices serving the other language film industries, Pakistan has five, each independent of the other.

Pakistan is no country for creative ity and it had better stick to making 'Maula Jatt' kind of films. Because the audience there still loves what it loved in 1979. Malala Yousafzai has lent her name to 'Joyland' and while Pakistan is proud to have a Nobel Prize winner of Pakistani origin, her endorsement of the film carries no

He further as of Sunday evening, most regions in Ukraine were having only rolling power cuts, adding that "the situation is under the control of the energy authorities". The President noted that the situation at the front remains "very difficult", especially in the Donetsk region. The latest warning comes days after Russia launched another large-scale missile attack on Ukraine's critical infrastructure on November 23, which also led to the deaths of 10 people.



AUS FACING DISASTROUS SUMMER OF EXTREME WEATHER EVENTS



Canberra: Australia's climate council on Monday warned that the nation is facing a disastrous summer of extreme weather events. In a report, the council and **Emergency Leaders for Climate Action** (ELCA) identified floods, cyclones and outbreaks of the mosquito-borne Japanese encephalitis virus as major risks faced by Australians through the summer, reports Xinhua news agency

The report said climate change has rendered Australia's disaster planning not fit for purpose, calling for a boost in resilience funding and a national disaster strategy.

"There is nothing natural about these disasters, they are being unleashed on Australians by decades of reliance on fossil fuels," Lesley Hughes, a leading climate scientist and author of the report, told local

"These same companies are enjoying billions in public subsidies. It's high time we end fossil fuel subsidies and use the savings to create a climate disaster fund so we can help communities deal with the fallout of compounding and worsening disasters," said Lesley.

Most of Australia has received higher than average rainfall in 2022 due to a La Nina event while the country is not expecting a severe bushfire season.

However, wet weather has created ideal breeding conditions for mosquitoes and not allowed the east coast to recover from catastrophic flooding through winter and spring.

The report found that weather-related disasters cost Australia A\$35 billion in the 2010s, more than the previous two decades combined.

Disasters have cost the state of Queensland more than A\$30 billion since 1970, significantly more than any other state or territory.

Syria retrieves 35,000 stolen artifacts during 11-yr war: Official

Firas Dadoukh, Director of Cultural Relations and Head of the Professional Development Department at the Directorate of Antiquities and Museums, on Sunday

said that the retrieved artifacts have been restored with the help of local communities and relevant authorities

Speaking at the sideline of an exhibition of recovered archaeological treasures at the Syrian national museum, Dadoukh added that a large portion of the retrieved pieces have already gone through a process of identification -- calculating the age of each piece and validating its authenticity -- before going through a rehabilitation work to prepare it for display at the museum, Xinhua news agency reported.Laila Al-Sammak, the curator of the Museum of Ancient Syrian



Antiquities, told Xinhua that most of the plundered pieces belong to the northern region, particularly in areas controlled by the rebels.

She said that the Syrian army has managed to confiscate many pieces and prevented their smuggling outside the country.

"In fact, the war on Syria was a war on the Syrian heritage in order to destroy the Syrian identity, which is known for its originality and greatness," she added.

Anshul Taran from Siddhanta Hospital said that Anmol had received injuries on his head and there was hardly 15 per cent chance of his survival. In the last seven days, the doctors tried their best but his condition continued to deteriorate. He could survive for one week despite multiple injuries because he was young and healthy.


Anmol's father, Abhishek Jain, who said if the organs are functional, they should be donated," said Taran, who happens to be a cousin of the deceased.

MP FOREST MINISTER'S AFRICA TOUR BEFORE CHEETAH TRANSLOCATION UNDER SCANNER

early three months after eight cheetahs were successfully transported from Namibia and released by Prime Minister Narendra Modi on his birthday (September 17) at Kuno National Park (KNP) in Sheopur district, a controversy has arisen over a tour by state forest minister Kunwar Vijay Shah and two senior officials to Tanzania and South Africa in August. The project translocation of cheetahs, which was processed and completed under the supervision of the Centre, but, state forest minister Kunwar Vijay Shah and two senior officials' Tanzania (East Africa) and South Africa tour in August (around one month before eight the cheetahs were transported from Namibia) still remains a puzzle here in Madhya Pradesh. Vijay Shah was accompanied by senior forest department officials, including chief of forest -- R.K. Gupta, Principal Chief Conservator of Forest, and Shubhranjan Sen, Additional Principal Chief Conservator of Forests of Madhya Pradesh.

A Right to Information (RTI) reply available revealed that the 10-day long study tour has cost Rs 35 lakh to the state government, which was more than double from an estimated amount for the same tour. Documents revealed that the proposal for study tour was made in April and had estimated



that it would cost around Rs 15 lakh. Out of total expenses (around Rs 35 lakh) on so-called study tour, Rs 31,71,500 were spent on air tickets, accommodation and local visiting.

Madhya Pradesh based wildlife activist Ajay Dube claimed he sought the details of the 'study report'. "If it was a study

tour, then why that study report was not made public domain, the first question arises? Dube said.

Dube further said, "Besides all these, this tour is also questionable because translocation of cheetahs was the Centre sponsored project with Indian Oil funds under CSR (corpo-

rate social responsibility). And, more importantly, the Supreme Court (SC) is monitoring this project. They (MP government) claimed it was a tourism project tour, then questions arise, why even after over 90 days of the visit, no development took place on translocation of African cheetahs. It was against the SC's guidelines for the cheetah translocation project and I am going to file a petition in the issue," Ajay Dube added.

He further claimed that the MPgovernment has no role in this cheetahs translocation project, except that cheetahs were released at Kuno National Park, then why MP's forest minister and officials were on study tour in Africa? "If they really did some study, then that study report should be in the public domain," Dube asked.

Contrary to that, Principal Chief Conservator of Forest, R.K. Gupta, who was one of the officials on the study tour with MP forest minister Shah, while talking he claimed that the study report has already been submitted to Madhya Pradesh Wildlife Society. "It was a study tour and the study report was submitted within one or two weeks after coming from Africa. It is a mandatory procedure to follow and it was done," Gupta added. Reporter also tried to seek a reply from MP Forest Minister Kunwar Vijay Shah on this matter; however, calls were not answered.

GHANA BEAT SOUTH KOREA 3-2 IN A THRILLER

CAMEROON RALLY TO HOLD SERBIA IN SIX-GOAL THRILLER

Doha (Qatar) Cameroon came back from a two-goal deficit to force a 3-3 draw with Serbia in a FIFA World Cup Group G thriller at the Al Janoub Stadium here on Monday. With the draw, arguably the most exciting game of the World Cup in Qatar so far, Cameroon kept their hopes alive of reaching the World Cup last 16 Stage.

Jean-Charles Castelletto opened the scoring in the 29th minute for Cameroon. Thereafter, two

quick goals from Strahinja Pavlovic and Sergej Milinkovic-Savic just before the break, in injury stoppage time, saw Serbia head into half-time with a 2-1 lead. Mitrovic then added a third in the 53rd minute as Serbia appeared to be cruising to victory with a 3-1 lead against their name.

But Cameroon had other ideas and staged a remarkable second-half comeback. The Indomitable Lions bounced back, scoring twice to level. Substitute Vincent Aboubakar scored an outrageous lob that was initially ruled offside until VAR intervened to award the goal for Cameroon in the 63rd minute. Two minutes later, Aboubakar drove down the right and passed it to Eric Maxim Choupo-Moting who equalized to make it 3-3. But all eyes will be on the Switzerland-Brazil tie which takes place today with the winner qualifying for the next stage, having won their respective first round matches against Cameroon and Serbia respectively.



FULLKRUG'S STRIKE HELPS GERMANY TO 1-1 DRAW WITH SPAIN

Al Khor (Qatar)| Substitute Niclas Fullkrug's goal seven minutes from end helped Germany to a 1-1 draw against Spain in a FIFA World Cup Group E match at Al Bayt Stadium in Al Khor, Qatar, on Sunday evening. The close range strike gave the Germans the first point of the competition having lost their first match to Japan 2-1. Fullkrug, who is playing his first-ever World Cup, came from the bench to the rescue with a fine turn and finish to level in the 83rd minute, smashing home a loose ball inside the box. 
Ruturaj Gaikwad smashes record 7 sixes in an over

Right-handed opener Ruturaj Gaikwad on Monday hit a mind-boggling seven sixes in an over, the first time it's happened in List A cricket, while on the way to smashing 220 not out for Maharashtra in a Vijay Hazare Trophy quarterfinal match against Uttar Pradesh at the Narendra Modi Stadium B Ground in Ahmedabad.

Gaikwad, who is captaining Maharashtra in the match, achieved this feat in the 49th over of the innings. The over was bowled by Uttar Pradesh's leftarm spinner Shiva Singh, operating from around the wicket. Gaikwad smashed sixes over deep mid-wicket, straight down the ground, and deep square leg.

Shiva then went in with a change in the trajectory, but the result was the same as Gaikwad smashed consecutive sixes over the long-off fence. A no-ball was signalled and Gaikwad smacked the ball from Shiva over long-on



right-handed batter his maiden double century in List A cricket in 153 balls. For the last ball, Shiva went for over the wicket angle, but it made no difference as Gaikwad sent it soaring over deep midwicket to take 43 runs. Gaikwad eventually finished on 220 not out off 159 balls, with ten fours and 16 sixes, as Maharashtra made 330/5 in their 50 overs, as 58 runs came off the last two overs.

Gaikwad taking 43 runs from that over off Shiva made it to the record books as the most expensive over in List A cricket, equalling the combined effort of Brett Hampton and Joe Carter, off Willem Ludick, for Northern Districts against Central Districts in a Ford Trophy game in New Zealand in 2018.

He also became the first Indian batter to make 43 runs off an over in List-A cricket.

KARNATAKA BEAT PUNJAB, SAURASHTRA DEFEAT TAMIL NADU; SET UP SEMIFINAL MEETING

Ahmedabad | Karnataka opener R Samarth slammed a match-winning half century to help his side beat Punjab by four wickets in the first quarterfinal of Narendra Modi Stadium Ground 'A'. 
