lphabet and Google CEO Sundar Pichai on Friday said that he is "deeply sorry" for reducing the workforce by approximately 12,000 roles, and takes "full responsibility for the decisions that led us here".

In an email to employees, Pichai said the company has already sent a separate email to employees in the US who are affected by the layoffs.

"In other countries, this process will take longer due to local laws and practices," he added. In the US, Google will pay employ-

ees during the full notification period (minimum 60 days) and also offer a severance package starting at 16 weeks salary, plus two weeks for every additional year at Google, and accelerate at least 16 weeks of GSU (Google stock) vesting. "We'll be offering 6 months of

healthcare, job placement services, and immigration support for those affected. Outside the US, we'll support employees in line with local practices," said Pichai.

The Google CEO said that these are important moments to "sharpen our focus, reengineer our cost base, and direct our talent and capital to our highest priorities"

The layoffs at Google's parent company were expected amid the deepening funding winter that has hit companies of all sizes in the global slowdown and recession fears.

Microsoft Chairman and CEO Satya Nadella said earlier this week that the company will be "making changes that will result in the reduction of our overall workforce by 10,000 jobs through the end of FY23 Q3 (third quarter)".



New Delhi: Online food delivery platform Swiggy on Friday confirmed that the company is laying off 380 employees as food delivery growth slows.

The impacted employees will receive a minimum assured payout of 3 months, which will include variable pay/incentives at 100 per cent.

The joining bonus and retention bonus paid out will be waived off. Moreover, the affected employees will get medical insurance coverage for themselves and nominated family members till 31st May, 2023, the com-

pany mentioned. The company also said that it will be shutting down its meat marketplace very soon as the company was not able to achieve product-market fit despite their iterations.

1.8 KG 'URANIUM' **SEIZED IN PATNA, 9 ARRESTED**

Patna: Nine persons, including two Nepalese nationals, were arrested in Patna on Friday for smuggling highly radioactive "uranium metal", police said.

A team of Anti-Terrorist Squad (ATS) learnt about a uranium consignment that reached the city's Patrakar Nagar police station area, a team was set up, and carried out a raid, seizing the metal and arresting nine. Apart from two Nepalese nationals, the 7 others belong to Patna and Purnea districts. According to an ATS Patna official, who requested anonymity, the 1.8 kg of highly radioactive metal was in two black bags with each having 900 gram weight. The manufacturing and expiry dates of June 3, 2017 and October 28, 2024, respectively mentioned on each of the bags, which also had "metal from the US" written on them. The officials have sent the seized items to a forensic lab to ascertain the actual nature of the substance.

Kumar Singh told mediapersons, while releasing the guidelines, that the whole issue is centred around consumers' right.

Consumer Affairs Secretary R

"It is the responsibility of the endorser, celebrities and influencers or other advertisers to truthfully disclose whatever information the consumer must know before making any decision for purchase," the guidelines said.

Singh further said social media influencers should disclose the nature of their endorsements.

Influencers are defined as creators who advertise products with a strong influence on the decisions or opinions of their audience. Virtual influencers, which are defined as fictional computer-generated people with realistic features of humans, are also required to disclose their endorsements, the guidelines said further.

The department noted that, "When there is a material connection between an advertiser and celebrity/influencer that may affect the weight or credibility of the representation made by the celebrity/influencer.'

These material connections include monetary or other forms of compensation, free products, contests and sweepstakes entries, trips or hotel stays, media barters, coverage and awards, or any personal, family or employment relationship,

the rules note.

The influencers should be able to substantiate the claims made by them. The Consumer Protection Act, 2019 provides the framework for the protection of consumers against unfair trade practices and misleading advertisements.

The product and service must have been actually used or experienced by the endorser, the ministry said, adding that consumers can seek legal actions against those defaulting.


The administration has permitted the people of Jaypee colony to demolish the 15 houses declared unsafe in the colony themselves.

DGCA imposes Rs 30 L fine on Air India, suspends Pilot-In-Command for 3 months

Moreover, the regulator has also imposed a penalty of Rs 3 lakh on Director-inflight services of Air India for failing to discharge her duties on November 26, 2022



The DGCA issued show-cause notices to Accountable Manager of Air India, Director in-flight Services of Air India, all the pilots and cabin crew members of that flight as to why enforcement action should not be taken against them for dereliction of their regulatory obligations. CHARGE SHEET CAN'T BE EQUATED WITH **AN FIR FOR FREE PUBLIC ACCESS: SC**

he Supreme Court on Friday junked a PIL seeking free public access to charge sheets filed by police departments and investigative agencies - CBI and ED -- saying that a charge sheet is not a public document.

It also held that copies of the charge sheet and the relevant documents along with the charge-sheet do not fall within Section 4(1)(b) of the Right to Information ActA(RTI) Act. The bench said: "Putting the

FIR on the website cannot be equated with putting the charge sheets along with the relevant documents on the public domain and on the websites of the state governments."



It stressed that if charge sheets are put on the public domain, then it will be contrary to the scheme of the Criminal

Procedure Code and may also violate the rights of the accused as well as the victim and/or even the investigating agency.

LEENA MANIMEKALAI PROTECTED FROM ARREST OVER GODDESS **KALI POSTER**

New Delhi: The Supreme Court on Friday granted interim protection from arrest to filmmaker Leena Manimekalai in multiple FIRs lodged against her for depicting Hindu goddess Kaali smoking a cigarette in a poster of her documentary.

The bench said: "At this stage, prima facie, it appears that the institution of FIRs in multiple states would be a matter of serious prejudice to the petitioner. We are inclined to issue notice so that all the FIRs shall be consolidated in one and the same place in accordance with law.

The bench said pending further orders, no coercive steps shall be taken against the petitioner either on the basis of the FIRs which have been instituted against her, or pursuant to any other FIR which may have been lodged or may be lodged hereafter in respect of the same film.

Husband, in-laws convicted of murdering woman for dowry 15 years ago

Delhi court has convicted four accused, including the husband, in the case relating to a woman, who died on October 3, 2007 in unnatural circumstances, of causing her death for dowry and and subjecting her to cruelty.

Additional Sessions Judge Gautam Manan held the four - husband, mother-in-law, father-in-law and brother-in-law - guilty under Sections 498 A (husband or relative of husband of a woman subjecting her to cruelty), 304 B (dowry death), and 34 (common intention) of the Indian Penal Code.

...It is held that prosecution has been successful to prove its case beyond reasonable doubt against accused persons for the offences under Sections 498 A, 304 B and 34 of the Indian Penal Code. They are convicted for said offences," he said.

The court listed the matter for arguments on sentencing on January 30.

However, the court acquitted the accused of the charges of murder and causing disappearance of evidence. It was stated that even though the Investigating Officer (IO) added the murder charge after receiving the postmortem report, he did not look into the murder trail. The cause of death was suffocation



from smothering, the court noted, citing the post-mortem findings.

It stated that neither was any evidence inspected or seized in this regard, nor did authorities attempt to determine how the woman was suffocated.

"Prosecution has not discharged its initial onus to prove the manner and persons behind homicidal death," the court said.

"Incidents narrated by prosecution witness es cannot be segregated from one another and they all form a part of the continuous transaction. These incidents qualify the criteria of soon before death due to the rule of the proximity of time because it was a continuing ordeal having continuity of action and community of purpose," it added. The court also made note of a particular incidence of dowry demand made the day before the victim's passing.

Kamal Nath, Jyotiraditya Scindia spar over parties' strength in Gwalior-Chambal

ongress' Madhya Pradesh unit President Kamal Nath on Friday attacked his Union Minister - and former party colleague -Jyotiraditya Scindia, whose defection to the BJP led to his government's fall in 2020, saying he has become "politically redundant" even in his pocket borough Gwalior.

Citing results of the municipal elections held few months back, Nath, who was visiting Tikamgarh district in Bundelkhand region, noted that the ruling BJP lost mayoral posts in both Gwalior and Morena, despite having Scindia on their side.

"If he (Scindia) was such a big gun, why did they (BJP) lose mayoral seats in Gwalior and Morena?" he said in response to a question by a reporter on the Congress contesting the upcoming Assembly elections without Scindia.

"We (Congress) don't need Scindia anymore. They were doing a conspiracy to dissolve the Congress government three months before it (March 2020) and I was aware of it. I too, could have purchased MLAs to save my government, but I didn't do that because I didn't want to tar-



nish Madhya Pradesh's image," the former Chief Minister said in an aggressive tone.

The BJP had lost the mayoral posts in Gwalior and Morena, the home turf of two Union Ministers Narendra Singh Tomar and Scindia earlier in July last year. The Congress had won five

out of 16 mayoral posts against the ruling BJP, which had been in power in all 16 municipal corporations in Madhya Pradesh, but was now restricted to nine only.

Notably, in the 2018 Assembly elections, Nath and Scindia had together campaigned in Gwalior-Chambal region, where the Congress defeated the BJP by a slender margin after 15 years.

However, in March 2020, Scindia, along with over 20 Congress MLAs shifted into the BJP, forcing Nath to resign as Chief Minister's post and paving the way for the return of Shivraj Singh Chouhan-led BJP government in the state.

Scindia hit back at Kamal Nath's remarks, levelling a series of charges against the then Congress government, including making the Madhya Pradesh government a 'transfer industry', indulging in corruption, breaking promises made to the people and 'mafia raj'.

Taking to Twitter, Scindia, on Kamal Nath's comment "if he was a big gun", wrote: "Record of 15 months cannon government of Madhya Pradesh Congress. Transferred, Industries, Breaking the promise, Corruption and Mafia-Raj," adding that "It is good that I do not fit your definition of cannon".

he NGO Coordination Committee (NGOCC), a conglomerate of major voluntary organisations, civil societies and student bodies in Mizoram, urged the Central government to take proactive action on the reported "violation of Indian airspace by the Myanmar Air Force".

Officials from the Central Armed Police Force (CAPF) said that the Indian territory remained unaffected after the Myanmar military's bombing on militants' camps of that country on January 10 and 11.

Villagers residing along the India-Myanmar border earlier claimed that a bomb was dropped near Tiau river on the Mizoram side. The river divides the two countries.

According to the villagers, a truck owned by a village council member has been damaged in the explosion when it was carrying river sand.

A spokesman of the NGOCC on Friday said that that they sent a memorandum to Union Home Minister Amit Shah on Thursday to take appropriate action on the issue of violation of Indian airspace by the Myanmar Air Force.

The NGOCC claimed that the Myanmar's Tatmadaw (military) during its airstrikes against pro-democratic forces along the Indo-Myanmar border on January 10 and 11 "not only violated Indian airspace, but also dropped and exploded bombs inside the Indian territory of Mizoram".

The bombardment on Indian soil caused a feeling of insecurity for the people living along the border areas, the memorandum said.



63 moons, others win AT1 bonds case against Yes Bank in Bombay HC

n significant relief to 63 moons and others, the Bombay High Court on Friday set aside the order of Yes Bank Administrator which had written down AT1 bonds of more than Rs 8,300 crore overnight, leaving investors high and dry

This will benefit all bondholders, including 63 moons technologies, which held bonds worth Rs 300 crore, the Mumbai-based fin-tech company said.

The Bombay High Court set aside an order from the administrator of Yes Bank and a letter by the Reserve Bank of India (RBI) to write off additional tier 1 (AT1) bonds sold by Yes Bank to ineligible investors. The order was passed in a batch of petitions filed by bond-holders, including financial institutions as well as individual retail investors.

CUSTODIAL DEATH ONE OF THE WORST CRIMES IN CIVILISED SOCIETY, SAYS HC;

Mumbai: Custodial death is one of the worst crimes in a civilised society and the police cannot torture citizens in an inhuman manner under the guise of power, the Bombay High Court observed while asking the state government to pay Rs 15 lakh as compensation to the mother of a man allegedly killed in police custody. The Aurangabad bench, comprising Justices Vibha Kankanwadi and Abhay Waghwase, passed its judgment on a petition filed by one Sunita Kute who alleged that her 23-year-old son Pradip had died after being tortured and assaulted by two policemen attached to the Solapur police.

Kute sought a compensation of Rs 40 lakh from the police and disciplinary action against the errant policemen. Custodial death is perhaps one of the worst crimes in a civilised society governed by the rule of law, the bench said. Though the police have the power to control the actions of people and the crime, it was not unfettered, it said. Under the guise of exercise of the said power they cannot torture or deal with a citizen in an inhuman manner, the judgment said. The state is the protector of the life of its citizens and if its employee undertakes torturous acts under the guise of power, then it has to compensate such a citizen, the court said. The bench noted that in the present case, the victim was a 23-year-old man who had married just four months before his death. The bench directed the Maharashtra government to pay a compensation of Rs 15,29,600 to the victim's mother.

It will be open to the state to recover the amount from respondent 4 and 5 (the two errant policemen), as they have been revealed to be the persons responsible for the death of Pradip, the court said.

As per the plea, the petitioner's son Pradip, who was a sugarcane harvester, was stopped by the police when he was driving a tractor in November 2018. The policemen started assaulting Pradip and others in the tractor for playing music, the petitioner claimed, adding that while the others managed to flee, Pradip died on the spot. A FIR was then lodged by the petitioner against the policemen who had assaulted Pradip. The errant police officials however, refuted the allegations and claimed that they did not have any motive to kill the victim, who suffered from a brain disease and was feeling dizzy. He was taken to a hospital, where he was declared dead. We would like to say that there was no reason for the police to intercept the tractor driven by Pradip, even if they were having some objection regarding the sound, they could have told the same to Pradip in a dignified manner, the court said in its judgment. There was a violation of the fundamental rights of the deceased, as there was no reason for interception and hence no reason to mete out atrocity on the victim, the bench observed.

63 moons technologies, which has an exposure of Rs 300 crore to the written-off additional tier 1 (AT1) bonds of Yes Bank, had launched a lawsuit against the private sector lender and the RBI. 63 moons had filed a petition in the High Court against the bank's decision to write off the AT1 bonds as part of a rescue plan. The company had invested in 3,000 bond holdings of Yes Bank's writtendown AT1 bonds and has been holding these papers since March 2018.

The company filed the petition on June 1, 2020, against Yes Bank, the RBI, and the administrator appointed by the RBI. The petition claimed that the company's Rs 300-crore investment in AT1 debenture bonds has been completely misused by the promise of good returns. In March 2020, Yes Bank forced a government-led rescue after it collapsed under the weight of alleged financial irregularities. The RBI, which took over the bank, wrote down the so-called AT1 bonds of Yes Bank worth Rs 8,415

crore as part of a revival plan. 63 moons petition argued that a write-off of bond holders' claim - under Basel-III norms as well as international best practices - can only take place when the equity capital has virtually lost all value and must be written off

INTERIM BAIL GRANTED TO VIDEOCON'S VENUGOPAL DHOOT

Mumbai: The Bombay High Court on Friday granted interim bail to Videocon Group Chairman Venugopal Dhoot, who was arrested in connection with the ICICI Bank-Videocon scam case by the Central Bureau of Investigation (CBI).

A division bench of Justices Revati Mohite-Dere and Prithviraj K. Chavan also refused the CBI's plea to stay the order to enable them appeal in the Supreme Court.

The court has granted Dhoot, who was arrested on December 26, 2022, a cash bail of Rs 1,00,000 and furnish the surety amount in a couple of weeks.

In his bail plea, Dhoot's lawyers termed the CBI arrest as "illegal, arbitrary", done without following due procedures and grossly violative of CrPC Sec. 41(A) mandating the issue of a notice to an accused to join the probe and to arrest only if absolutely necessary.

The other co-accused in the same case, former ICICI Bank CEO and MD Chanda Kochhar and her businessman husband Deepak Kochhar were granted bail on January 9.

of Maharashtra over a period of one month after he was given the keys of her house by her mother who used to lock the minor daily at home for safety before stepping out for work, police said on Friday. The victim's mother had started locking her at home before going to work ever since the minor's father sexually assaulted her three months back, they said.

The victim as well as the accused lives in Daighar area in the city, and the offence was committed mid-December onwards, a police official said.

The girl lodged a complaint on Thursday night, based on which the police registered a first information report (FIR) against the accused in the early hours of Friday.

"As per the complaint, the victim's mother works as a cook at a local madrassa. She also works elsewhere in the evenings. The victim's father had raped her three months ago and a complaint in that regard was lodged. However, after the incident, the girl's mother started locking her at home before stepping out for work in the evening. She used to hand over the keys to the tailor who resided oppoalteration of her clothes. He even threatened to kill her if she revealed it to anyone, he said.

After that, whenever the victim's mother went out for work after handing over the keys to the tailor, he used to forcibly take the girl to his house and rape her. Since the girl was terrified, she did not reveal her ordeal to anyone, the complaint said, adding that on January 14, the victim managed to video-record the offence on her mobile phone without the knowledge of the accused.

On January 19, when the tailor was dragging the victim to his house, a female acquaintance of the girl came there and strongly objected to his act. The minor mustered courage and told about her ordeal to the woman and also showed the video.

Thereafter, the victim approached the police and lodged the complaint. Police have registered a case against the accused under Indian Penal Code (IPC) sections 376(2)(n) (repeatedly raping the same woman), 323 (voluntarily causing hurt), 506 (criminal intimidation) and sections of the Protection of Children from Sexual Offences (POCSO) Act, the police said.

Sane, a third year MBBS student, had gone missing from Bandra Bandstand in November 2021. The Mumbai crime branch, which is investigating the case, had recently



arrested Mithu Singh, a lifeguard, in this connection.

"During his interrogation, the accused told the police that he had

killed Sane and dumped her body near the Bandstand," the official said. After this revelation, the Mumbai

divers on Friday conducted a search operation in the Bandstand area for several hours to locate Sadichha Sane's remains, he said. "The search operation started in the morning," the official said, adding the investigators were also using other mechanisms to trace Sane's body.

Sane, a resident of Boisar, had left her house on November 29 morning to appear for her third MBBS prelims at Grant Government Medical College. Police said she boarded the 9.58 am local from Virar station and got off at Andheri station to board a fast train. She had called her brother Sanskar and said she would call again at 5.30 pm and until then her phone would be switched off. However, when she did not return home till late in the night, her family got worried and started looking for her. They, then, filed a missing person report at the Boisar police station. According to the crime branch unit 9 officers, Sane got off a fast train at Bandra station and took a taxi to Bandstand. The police checked the CCTV footage of all roads leading to Bandstand. While there is evidence that she went to Bandstand, nothing has been found related to her return.

Govt to introduce incentive scheme to boost *R&D by pharma industry: DCGI Somani*

he Centre is all set to introduce a research linked incentive program shaped on the lines of the production linked incentive (PLI) scheme to boost research and development of biotech products in the country, said Drugs Controller General of India Dr V G Somani on Friday

PLI scheme aims to give companies incentives on incremental sales from products manufactured in domestic units.

Somani was speaking on the first day of the 72nd Indian Pharmaceutical Congress in Nagpur. The three-day event will cover various issues related to the pharmaceutical industry, academia and community pharmacy and will be attended by delegates from India and abroad.

The accomplishments of the Indian pharmaceutical sector during the COVID years were a huge boon for society, said Somani, who heads India's apex drug regulatory agency Central Drugs Standard Control Organization (CDSCO).

Firstly, the urgency to identify the virus (coronavirus) and secondly to develop vaccine, medi-



cines and diagnostics for COVID-19 was not an ordinary challenge. But, with the encouragement from Prime Minister Narendra Modi, the Indian pharmaceutical industry accepted this challenge

and successfully developed the vaccine that not only saved millions of lives in India but also in several other parts of the globe, said Somani. Underscoring the importance of policy

reforms, innovation, and research and development, he said the government has taken several initiatives to aid innovative research and establish appropriate ecosystems. To enhance the capabilities of the domestic pharma industry and help it establish itself in the global market, Somani said, the Centre is all set to introduce a research linked incentive (RLI) scheme shaped on the lines of the PLI programme to cover R&D costs for biotech products.

Somani said the pharma industry has experienced numerous regulatory developments and several pharmaceutical companies are rethinking their regulatory approval and drug development strategies

Introduction of new Indian Pharmacopoeia 2022 and several amendments in rules for drugs and medical devices have been done to establish a dynamic pathway for ensuring patient safety while encouraging the growth of the sector, he said.

They have been booked under section 382, 34 IPC of IPC. The arrested accuseds were produced before the court and were remanded to police custody. WOMEN'S CRICKET - A ROSE BY ANY OTHER NAME WOULD SMELL AS SWEET

he famous line by Juliet: "A rose by any other name would smell as sweet", from the play Romeo and Juliet written by William Shakespeare, seems quite appropri-

ate for cricket in India. The recent success, as regards the selling of the Rights of Women's IPL cricket tournament, truly reflects the progress that has been made by both the BCCI and cricket as a sport, in India. The game of cricket is the true benefactor, as it smells as sweet when played by either men or women.

The reason why India's marketing gurus find the property enticing is that Indian Women's cricketers bring in a feel of amateurism in the way that they play the game. They instil a breath of fresh air, a different look to the sport. It enables one watching it to enjoy cricket at a pace that is easier to follow.

Men's cricket, on the other hand has become a contest, wherein, it has become professional with a serious outlook. The game of cricket and cricketers are thoroughly scrutinized. Whereas, in women's cricket one accepts errors and blunders and enjoys the naivety that it brings about. There is joy in watching women play the game in the way one enjoyed men playing it many years ago.

Love for cricket was the only factor that kept men's cricketers engrossed in the sport in the past. Although the reason to play is no different now, the game has taken a turn into becoming a serious one to pursue. The fun element and laughter that once prevailed in playing the game of cricket by boys and men at all levels of the sport, seems to have lost its charm. Cricket now seems to be a business in which winning has become the most important factor.

Women's cricket, on the other hand, has still the aura of being in the embryo stage. Although it has



gone through many years of difficulty and hardships in the past, the IPL in April this year should catapult it into a huge leap for the better in the future.

I can still recall my conversation a decade ago, when I met the present Indian captain, Harmanpreet Kaur, at the MCA indoor nets. She was a girl from Haryana who had left the comfort of her home. She was nestled into accommodation in Mumbai, struggling to make two ends meet. She desired to continue playing cricket for India and to bring laurels to the country. The lack of facilities is what brought her to Mumbai, the Mecca of Indian cricket, along with several others from around the country. Harmanpreet along with the likes of Mithali Raj, Jhulan Goswami and Smriti Mandhana are household names now. Their success should catapult women's cricket in India to another level.

The platform is set for women's

cricket to flourish; however, the challenge would be for the BCCI to structure facilities for them to excel. Girls aspiring to play the sport should be taken care of in every manner possible by providing them with the security and needs that are necessary in all respects.

At the other end of the spectrum is India's domestic cricket. With the season in full flow, one is astounded by the runs scored by batters in the Ranji Trophy tournament. There have been one triple and 18 scores of double centuries, over 40 scores of 150 plus runs and close to a century of centuries. These are phenomenal numbers and truly reflect the focus, fitness and mindset of the new breed of Indian batters.

One name that shines out like the North star, having had 3 years full of buckets of runs, is Sarfaraz Khan from Mumbai. He unfortunately has had, as one lightly conjectures, a piece of bad luck. This has been the case for many consistent perform-

ers playing in the domestic circuit. Jaydev Unadkat, the fiery left-arm fast bowler from Saurashtra, was another case in time. Fortunately, after 10 years of being in oblivion. he managed to get selected and has performed well enough to retain his place in the immediate future.

The irony of the domestic Indian cricket circuit is that established and BCCI-contracted players rarely play in any of the tournaments. The annual Indian International cricket calendar makes it difficult for them to do so. This makes the contracted players exclusi've and comfortably secured. The problem that surfaces is that the domestic performers do not get a window in which to stake their claim for an India cap.

Furthermore, without the top 35 Indian cricketers in the fray, there always is an element of doubt about the quality of domestic international perform-

ances. The

Indian A team tour was a good initiative as an incentive for an aspiring player. However, most other countries do not have the quality or quantity of players in their fold. In India in the earlier times, the Duleep and Irani Trophy matches were the selection trials for an Indian side playing in India or touring abroad. Both these tournaments have lost their lustre and therefore the domestic performers are now hoping to get recognized via the IPL route.

Indian cricket needs to find a solution or else the likes of Sarfaraz Khan and many more will remain in the wilderness waiting for the elite lot to get injured or come in as replacements when they are on a rest and recreation break. They end up with a short stint as drink boys for their efforts.

Novo-Ogarevo, evidently to protect him from Ukrainian drones or missiles, Daily Mail reported. Pro-Russian Telegram channel Military Informant acknowledged this was an admission that Moscow, with

a 12 million population, is now vulnerable, with the deployment underscoring that the "the military are afraid of a possible strike". On Wednesday, photographs appeared of the modern S-400 missile

There are reports of such deployments at half a dozen sites in Moscow, as Putin daily increases his defences in the capital city, Daily Mail reported.One deployment is said to be at Zarechye village, close to his country retreat Novo-Ogarevo, said Sirena Telegram channel.

A video purportedly showed the deployment.

There are rumours that Putin and his young family with former Olympic gymnast Alina Kabaeva are now usually based in one of several secret bunker complexes, Daily Mail reported.The children have not been introduced to the Russian people, and secretive Putin has never confirmed his relationship with Kabaeva.

OLD CHURCH IN CANADA TRANSFORMED INTO SIKH TEMPLE

Toronto: An old church has been transformed into a Sikh place of worship -- the first in Canada's Red Deer city after requests from the local Sikh community since 2005.

The Cornerstone Gospel Chapel at 5911 63rd Street is now Guru Nanak Darbar Gurdwara, and will open seven days a week from 6 a.m. to 8 p.m.

It will serve around 150 families, 250 international students and temporary foreign workers from India, CBC News reported.

"The community is growing every day. So many people are moving here from B.C., Calgary and Ontario," Nishan Singh Sandhu, the gurdwara's president, told CBC News.

"It's very important, otherwise we don't have a place to get together. We struggled for the last 20 years to build a gurdwara," said Sandhu.

The community received donations from neighbouring Sikh communities in Calgary, Edmonton and Surrey, British Columbia, along with private donations to the tune of \$450,000, which allowed them to buy the building with no mortgage.

The gurdwara, which opened last month, includes a main floor with a large basement area and kitchen.

The centre's kitchen provides free vegetarian meals ('langar') to visitors and anyone who needs it.

Sweden to send Archer artillery system to Ukraine

weden will provide Ukraine with the Archer artillery system, its tenth and the largest military aid package so far, Prime Minister Ulf Kristersson said.

The package is worth around 4.3 billion Swedish kronor (\$415 million) and also includes around 50 CV-90 armoured vehicles with ammunition, NLAW antitank missiles, disposable anti-tank weapons, and mine clearing equipment, the government said at a press conference here on Thursday.

Ukraine has repeatedly requested that Sweden provides them with Archer, a vehicle-mounted howitzer with a range of up to 50 km, Xinhua news agency reported.

The Swedish government

has tasked the Swedish Armed Forces with preparing for deliveries of the system, including ammunition.

Sweden will also assist Ukraine with their own arms procurement through cooperation and co-purchases with the Swedish Defence Materiel Administration (FMV), the government said, adding that it would speed up arms deliveries to Ukraine.

Before Thursday's announcement, Sweden had already pledged to provide Ukraine with military equipment worth nearly five billion kronor in total, Swedish Television (SVT) reported.

Russia has said that the supply of Western weapons to Ukraine does not help resolve the conflict but prolongs the suffering of the Ukrainian people, and that Western arms convoys to Ukraine would be considered "legitimate targets" for the Russian armed forces. (1 Swedish krona = 0.097 US dollar)

Burglars break into Texas Hindu temple, steal donation box: Report

he Indian community was left in a state of shock after burglars broke into a Hindu temple in the US state of Texas and stole its donation box, the media reported.

The Brazos County Sheriff's Office said they are investigating the burglary at Shri Omkarnath Temple located in Brazos Valley, Texas, which took place on January 11.

"There was a break-in. They (burglars) broke in through the side window and what was immediately...missing was our donation box and a safe in which we kept our valuables," Srinivasa Sunkari, a board member of the Shri Omkarnath Temple, told KBTX news channel.

According to the report, a video captured by security cameras inside the temple showed a person walking straight to the donation box.He then used the temple's cart to wheel the box out the door.



"There was a sense of invasion, that sense of loss of privacy when something like this happened to us," Sunkari, told the news channel.

He said the priest and his family, who live in an apartment right behind the temple, are safe, adding that the community members were notified about the incident at a gathering."We will rebound, we will take extra precautions to make sure our priest is safe and this family is safe and our place of worship is safe. And we hope that something like this doesn't happen to anybody in the future," a shocked Sunkari said.Condemning the incident, the HinduPact, an advocacy collective in the US, has asked the FBI for a thorough probe into the incident.

"Our village houses are very poor families, most of whom are livestock farmers. One of those kidnapped farmers is so poor that his house doesn't even have a proper roof, then how are these families going to pay Rs 15 lakh ransom for the release, so we will try and pool in the money," said for-



mer sarpanch Siyaram Baghel.

The former state minister and senior Congress leader **Bamnivas Bawat visited the** village and met with families of the three kidnapped farmers. Rawat claimed that many other farmers are selling their livestock, including goats, to escape being targeted by dacoits. "First Rs 10,000 bounty was declared by my office for getting information about the captors, it has now been raised to Rs 30,000 by the ADG-Chambal Range, said Sheopur SP Alok Kumar Singh. According to sources the Sheopur police are work-

ing with Rajasthan police, but is yet to track the kidnapped farmers. Gangs, particularly dacoits operating from Rajasthan, have often been active in bordering districts of MP's Gwalior-Chambal region, particularly Sheopur district. Some months back, a farmer from Sheopur ditrict was kidnapped and released after payment of ransom. One of the most active inter-state gang's active in the

Gurjar, who carries a bounty of Rs 1.25 lakh on head and is active in Rajasthan, adjoining MP and also neighbouring UP.





In pursuit of this mission, he falls head over heels in love with a blind girl Nasreen. Well, does Amandeep Singh succeeds in his mission and is able to stop the destruction while saving his own life? The answer lies in the film.

Review : Mission Majnu marks the Bollywood directorial debut of Shantanu Bagchi and it's quite evident that he tries to bring to the table a story we probably are oblivious of. There is no denying in the fact that a patriotic film with a tint of romance has always carried a certain success ratio.

The same formula is used by director Shantanu Bagchi for Mission Majnu. It is because the issue with the film is that it is walking a tightrope between being a romantic film and a patriotic representation of an unsung war hero.

It begins with giving his a gist about World War 1 and 2. It proceeds with introducing us to Sidharth Malhotra's character Amandeep Singh who is in Pakistan where he falls in love with a blind girl Nasreen and is on the cusp of embracing fatherhood while also carrying out the mission despite being billed as the son of a traitor.

Director Santanu invests prominent time in establishing their love story which takes a major part of the film. Few scenes are extremely predictable and at times sitting through them does become a task.

As mentioned above, the direction of the film is formulaic but there are some gripping moments that do get us at the edge of the seats with a few surprising elements and well executed action sequences. Barring climax, even the emotional moments in the film falls short of striking the right chord.

The dialogues are conversational but at the same time also have the required punch and drama. Talking of other technical aspects, the cinematography is fine whereas the editing could have been a bit taut. The BGM and songs with moving

lyrics add gravitas to the plot.

When it comes to performances, after Shershaah the expectations are certainly high with Sidharth Malhotra and he even puts forward his best foot. Rashmika Mandanna's accent

appears and disappears as per convenience, just like her role in the film. The actress barely gets a chance to shine in her limited screen space.

The rest of cast including Kumud Mishra, Sharib Hashmi, Parmeet Sethi deliver from what's offered to them.

Conclusion : Overall, the storyline of Mission Majnu is gripping and riveting, but only in fragments, making for a passable experience.
