RBI imposes monetary penalty of Rs 3.06cr on Amazon Pay (India)

The Reserve Bank of India on Friday said that it has imposed a monetary penalty of Rs 3.06 crore on Amazon Pay (India) Private Limited for non-compliance with certain provisions of the Master Directions on Prepaid Payment Instruments (PPIs) and the Master Direction - Know Your Customer (KYC) Direction, 2016 dated February 25, 2016.

(RBI) has imposed monetary penalty of Rs 3,06,66,000 on Amazon Pay (India) Private Limited for non-compliance with certain provisions of the Master Directions on Prepaid Payment Instruments (PPIs) and the Master Direction - Know Your Customer (KYC) Direction, 2016 dated February 25, 2016. The penalty was imposed in exercise of powers vested in RBI under

Section 30 of the Payment and Settlement Systems Act, 2007. This action is based on deficiencies in regulatory compliance and is not intended to pronounce upon the validity of any transaction or agreement entered into by the entity with its customers. It was observed that the entity was non-compliant with the directions issued by RBI on KYC requirements.

Accordingly, a notice was issued to the entity advising it to show cause as to why penalty should not be imposed for non-compliance with the directions, said the statement. After considering the entity's response, RBI concluded that the aforesaid charge of non-compliance with RBI directions was substantiated and warranted imposition of monetary penalty, it added.

ON RAHUL GANDHI'S "SNOOPING" ALLEGATION, BJP'S "HALLUCINATION" RETORT

The BJP on Friday made light of Rahul Gandhi's allegation that he was being snooped upon, saying that the Congress leader was "hallucinating" and makes such claims as he wants to create headlines wherever he goes.

"What we can say for Rahul Gandhi's hallucinations. If he makes his (Congress) MoU with China public, we will be interested and people of India will also like to know. Who is interested in his telephonic conversations," BJP spokesperson Tom Vadakkan told reporters.

During a lecture at Cambridge University, Gandhi alleged that Indian democracy is under threat and several politicians, including himself, are under surveillance.

"A large number of political leaders have Pegasus on their phones. I myself had Pegasus on my phone. I've been called by intelligence officers who say please be careful of what you say on the phone as we are recording the stuff," the former Congress chief has claimed. Vadakkan noted that the Supreme Court has closed the Pegasus matter. He added that Gandhi had not even given his mobile phone for inspection during the inquiry, directed by the Supreme Court, into the Pegasus issue. What was he so scared to hide, the BJP spokesperson asked.

"Why is he not raising questions about the attack on Indians abroad. It has happened in Canada and Australia. The issue is he wants to create headlines wherever he goes and in that process, he loses votes in India



Privilege Committee to hear BJP's demand for action against Rahul Gandhi on March 14

New Delhi: The Privilege Committee of the Lok Sabha will take up the breach of privilege notice against Congress MP Rahul Gandhi on March 14. The Privilege Committee directed BJP MP Nishikant Dubey, who had filed the notice against Rahul Gandhi, to appear before it on March 14 and present his case.

Dubey had sent a notice of breach of privilege claiming that Rahul Gandhi had levelled derogatory allegations against Prime Minister Narendra Modi without any evidence and facts during a discussion in the Lok Sabha on the motion of thanks on the President's address.

Acting on the notice as per the laid down parliamentary convention and rules, the Lok Sabha Secretariat issued a notice to Rahul Gandhi, asking him to reply by February 15.

According to sources, Rahul Gandhi had sent his reply based on which the Committee has summoned the complainant.

HIMACHAL BRINGS OPS FOR EXISTING, FUTURE EMPLOYEES

The Himachal Pradesh government on Friday decided to implement the old pension scheme (OPS) for the existing 1.36 lakh employees, and for the future employees too.

A decision in this regard was taken at the Cabinet meeting chaired by Chief Minister Sukhvinder Singh Sukhu here. It was decided that the OPS beneficiaries would also be brought under the ambit of GPF and those employees under the new pension scheme (NPS), who retired after May 15, 2003, will be given OPS from the prospective date.

It was decided that after necessary amendments to rules, the contribution by the government and the employees under the NPS will stop from April 1, 2023.

No deductions would be made from the employees from their salary under the NPS

from April 1. If any employee wants to be governed under the NPS, he/she can give his consent to the government in this regard.

The government will spend an additional amount of Rs 1,000 crore in fiscal 2023-24 on the implementation of the OPS.

The Cabinet also passed a resolution to be sent to the Central government to return Rs 8,000 crore under the ambit of the state's NPS.

The Cabinet asked the Finance Department to amend the rules and issue necessary instructions in this regard.

It was also decided to engage 780 ASHA workers under the National Health Mission (NHM) on an incentive basis to provide affordable and reliable healthcare to the people.

It gave nod to guidelines for the engagement of ASHA facilitators under the Community Process Programme.

SC junks Vijay Mallya's plea challenging proceedings to declare him a fugitive

The Supreme Court Friday dismissed a plea by businessman Vijay Mallya, facing extradition, against proceedings in a Mumbai court to declare him a fugitive economic offender and confiscate his properties.

Counsel, representing Mallya, contended before the court that he was not receiving any instructions from him in the matter. A bench of Justices Abhay S. Oka and Rajesh Bindal said counsel for the petitioner states that Mallya is not giving any instructions. "In view of this



statement, the petition is dismissed for non-prosecution," said the bench. In December 2018, the apex court had

issued notice to the Enforcement Directorate (ED) on Mallya's plea but declined to stay the proceedings before a special Prevention of Money Laundering Act (PMLA) court at Mumbai, where the probe agency sought a 'fugitive' tag for him under the Fugitive Economic Offenders' Act, 2018.

The prosecuting agency has the powers to confiscate his property, once a person is declared a fugitive economic offender under the provisions of the Act.

Mallya was declared a fugitive under the Act in January 2019, by a Mumbai special court.

Record 14 women elected to Tripura, Meghalaya and Nagaland Assemblies

In Tripura, BJP candidates Mina Rani Sarkar (from Badharghat assembly constituency), Pratima Bhowmik (Dhanpur), Antara Sarkar Deb (Kamalagar), Santana Chakma (Pecharthal), Swapna Majumder (Rajnagar), Swapna Das Paul (Surma), Kalyani Saha Roy (Teliamura) and Tipra Motha Party nominees Swapna Debbarma (Mandai Bazar) and Nandita Debbarma Reang (Raima Valley) were elected to the state assembly in the February 16 elections.

In Meghalaya, former state minister Mazel Ampareen Lyngdoh and Santa Mary Shylla, both from the ruling National People's Party (NPP) and Miani D. Shira of the Trinamool Congress, were elected to the assembly.

Days ahead of the International Women's Day on March 8, good news from three northeastern states -- Tripura, Meghalaya and Nagaland -- that 14 women were elected to the state assemblies in the recent polls against six women legislators in the outgoing houses. The highest number of nine women were elected to the Tripura assembly followed by three in Meghalaya and two in Nagaland.

Scripting history in 60 years of statehood, two women, Hekhani Jakhlu and Salthoutonuo Kruse of the ruling Nationalist Democratic Progressive Party (NDPP), were for the first time elected to the Nagaland assembly from Western Angami and Dimapur-III assembly constituencies respectively.

In all 183 candidates including four women nominees contested the February 27 assembly elections in Nagaland.

With nine of the 31 women contestants winning, the Tripura assembly now has the highest number of women legislators since it became a full-fledged state in 1972. In 2013, five of the 15 women contestants became lawmakers in Tripura, while three women were elected in the assembly polls in 2018. In Meghalaya three women, the same number as in the previous election (2018), were elected in

the February 27 assembly elections when 36 women fought the poll battle. In the 2018 assembly elections, five women contested in Nagaland and none was elected while in Tripura 24 women fought and three women won. In Meghalaya 32 women tried their electoral fortunes and three were successful. Congress turned NPP leader Lyngdoh retained her East Shillong constituency while Shira made it to the Assembly once again from Ampati. Shylla marked one of the biggest upsets of this election by defeating Lok Sabha member from Shillong parliamentary constituency and Meghalaya state Congress president Vincent H. Pala in the Sutnga-Saipung assembly seat.

In the assembly elections in the three northeastern states, women voters' turnout was higher than men.

For the past many years, women voters have outnumbered their male counterparts in the electoral lists of several northeastern states. Of the total 21,61,729 voters in Meghalaya, the number of male voters is 10,68,801 and that of female voters is 10,92,326. In Nagaland, the number of male voters is 6,52,938 and that of female voters is 6,55,144. In Tripura, in seven of the 60 assembly constituencies, women voters outnumbered their male counterparts. The number of women ministers, MPs and MLAs in several northeastern states is very less compared to their percentage in population.

WITCHCRAFT PRACTICED IN RESIDENTIAL SCHOOL IN SURAT

Surat: In a shocking incident, witchcraft was practiced in a government-funded residential school in Surat to treat a girl student who was unwell.

As soon as the reports about the incident spread, the state government on Thursday evening directed tribal development commissioner to inquire into the matter. According to sources, a student of Vatsalya Kanya Asram Sala at Madhi village, a vocational training residential school for tribal girls, fell ill, however, instead of taking her to a doctor, hostel warden called an occult practitioner who carried out witchcraft on all 140 girls of the institution. The rationalist group demanded an inquiry and Vigyan Jatha group leader Jayant Pandya demanded that the government should file a criminal complaint against the warden and the trustees of the residential school.

Hijab not allowed during exams: Karnataka Education Minister

Karnataka Education Minister B.C. Nagesh on Friday asserted that students wearing hijab will not be allowed inside the examination centres. The II PUC (class 12) examinations are set to begin from March 9 in the state. Speaking to reporters he maintained that it has been clarified that all students should attend exams wearing uniforms. Hijab is not part of it. Those who want to write exams wearing hijab won't be allowed into the examination hall, he added. Minister Nagesh further claimed that there is an increase in the number of Muslim students who appeared for the examinations after the hijab ban. "After hijab ban, more



number of Muslim sisters appeared for examinations and the enrolment of Muslim girl students has increased," he added. The hijab case, which is in the Supreme Court, is likely to be taken up after Holi vacation. Many students abstained from attending the examination as they were not allowed to wear hijab and write exams.



ED seizes Rs 3.5 cr cash in MGNREGA fund scam involving IAS officer Pooja Singhal

In a latest development in the MGNREGA fund scam involving suspended IAS official Pooja Singhal and others, the Enforcement Directorate (ED) on Friday said that they conducted raids in Jharkhand's Hazaribagh at the premises of Mohammad Izhar Ansari and recovered cash around Rs 3.5 crore.

Ansari is said to be an aide of one of the accused in scam.

The ED had on February 23 arrested Virender Ram, the chief engineer working with Rural Development Department of Jharkhand Government in connection with the case. The ED team took him to Ranchi where his arrest was made.

The ED had initiated money laundering investigation on the basis of multiple FIRs registered by Jharkhand Police and Vigilance



Bureau Jharkhand." Investigation revealed that the Proceeds of Crime (POC) generated from the MGNREGA scam in the form of commission was deposited in different bank accounts belonging to Pooja Singhal and her relatives. The said POC was mixed and layered with the other

unaccounted money generated by Singhal, by misusing her official position," the ED claimed.

The probe agency has said that initially the POC was generated from MGNREGA scam only, which was subsequently intermixed with other unaccounted funds generated

from the corrupt practices of Pooja Singhal and these funds were layered as investment and further funds were generated from these funds, both as legitimate profit as well as by further infusion of POC.

"By this modus-operandi, Singhal amassed huge wealth disproportionate to her known source of income, and source of funds invested in these immovable properties were primarily from the unaccounted cash profits generated from these POC and therefore termed as POC," the ED has alleged. The Supreme Court on January 3 had granted interim bail to Pooja Singhal, Jharkhand cadre IAS officer suspended in a money laundering case, to look after her ailing daughter. The former state mines department secretary in Jharkhand, had been in custody since May last year, after raids were conducted at properties connected with her. She has been accused of money laundering.

FORMER MINISTER SATYABRATA MUKHERJEE PASSES AWAY IN KOLKATA

Senior BJP leader and former minister of state Satyabrata Mukherjee passed away due to age-related ailments at his residence on Friday. He was 91.

Mukherjee was Minister of State for Chemicals & Fertilisers and Commerce & Industries in the Atal Bihari Vajpayee-led government from 1999 to 2004.

Mukherjee, who also served as the former state president of BJP in West Bengal, was a high-profile practicing lawyer with the Supreme Court and Calcutta High Court.

He was elected BJP Lok Sabha member from Krishnanagar Lok Sabha constituency in Nadia district of West Bengal from 1999 to 2004. However, in 2004, he was defeated from the same constituency by CPI(M) candidate and ath-



lete-turned-politician Jyotirmoyee Sikdar.

Mukherjee was popular in both the legal and political circles as "Jolubabu". In 2008, he became party's West Bengal chief. However, the very next year, he was replaced by Rahul Sinha.

He was born on May 8, 1932 in Sylhet, which is now

in Bangladesh. He earned his reputation as a corporate lawyer at a very young age and was active in his profession even four years back.

He was popular among the leaders of other political parties for his amicable nature and philanthropic activities.

Madhya Pradesh Assembly adjourned till March 13 amid ruckus

The Madhya Pradesh Assembly on Friday witnessed uproarious scenes over the 'no confidence' against Speaker Girish Gautam, leading to disruption of the House's functioning, and eventually the adjournment of the fifth day of the Budget Session without any business.

The continuous ruckus in the Assembly prompted Speaker Girish Gautam to adjourn the House till March 13.

As the opposition Congress was already prepared to bring a 'no confidence' motion against the Speaker following his decision to suspend former minister and Congress MLA Jitu Patwari from the House for the remaining Budget Session on Thursday, they (Congress MLAs) raised slogans and demanded a debate on the matter.

Gautam tried to control the situation and begin the House's proceedings. However, relentless noisy scenes prompted him to adjourn the Assembly first for 10 minutes, soon after the House met.

When the House resumed its business for the day again, the Congress MLAs continued their demand to have a debate over the 'no confidence' motion brought against the Speaker.



The Congress legislators led by the Leader of the Opposition (LoP) Govind Singh, an MLA from the Lahar seat, reached the Speaker's podium, and shouted slogans against him.

The Speaker tried to calm down the situation and requested the legislators to go back to their seats, saying he had not received any information regarding a 'no confidence' motion.

The Opposition tabled a 'no confidence' motion against Speaker Girish Gautam, accusing him of acting on behalf of the ruling BJP, and "shrinking the duration of the session".

However, the ruling BJP hit back on them for not having the signature of the Madhya Pradesh unit Congress president Kamal Nath.

Meanwhile, Madhya Pradesh Parliamentary Affairs Minister Narottam

Mishra intervened into the matter by showing the 'rule book' of the House.

As the Congress MLAs had already approached the Speaker's podium, the BJP MLAs stood in the Speaker's support, and eventually, the MLAs from both sides came face to face against each other briefly.

Further, LoP Govind Singh alleged that Narottam Mishra had thrown a book at him to hurt him.

This again created an uproar in the house. The LoP demanded suspension of the minister for the entire Budget Session, on the lines of the suspension of Jitu Patwari.

Mishra, however, tried to clarify that he was trying to move the pen when the 'rules book' accidentally slipped from his hand.

"I had no intention of hurting anyone. I have apologised for this in the House," Mishra said.

7 ARRESTED, SEX RACKET BUSTED IN NOIDA; 2 GIRLS RESCUED

The Kotwali Sector 39 police along with the Anti-Human Trafficking Unit of Noida police arrested 7 people including a woman in connection with a flesh trade being run from a rented house in Noida's Salarpur village. Two girls have been rescued from their captivity.

The officials raided the place on Thursday night.

The kingpin, Mala Devi, had been running the racket along with her associate, who has been identified as Manpreet from a rented accommodation in Salarpur.

DCP Noida Zone, Harish Chandra said that upon receiving information, the officials sent their own agent to pose as a customer in front of the



duo. After receiving the agent's signal, they raided the place and Devi and Manpreet along with five customers were detained.

The arrested customers have been identified as Anil, Rajan, Sagir, Abhishek and Harish.

The house belongs to one Neeraj Bhati.

Police recovered six mobile phones, Rs 2,100 in cash and objectionable items from their possession.

The official added that Devi and Manpreet had rented two rooms at Bhati's place some days back and had started the business here.

The police have registered a case against the accused persons under the Immoral Traffic (Prevention) Act, 1956 and is gathering information about the others involved.

5 arrested for duping banks of over Rs 90 L using PAN details of 95 celebrities

Five people have been arrested for duping banks of over Rs 90 lakh by using PAN details of 95 celebrities including Bollywood actor Abhishek Bachchan and former captain of the Indian cricket team M. S. Dhoni, and getting credit cards issued in their names, an official said on Friday.

According to officials, the cards were issued from Pune-based fintech startup 'One Card'.

Some of the other celebrities whose names and details were used by the fraudsters were Shilpa Shetty, Madhuri Dixit, Emraan Hashmi, Saif Ali Khan,

Sachin Tendulkar, Alia Bhatt, Sonam Kapoor, Hritik Roshan, among others.

The accused were identified as Puneet, Mohd Asif, Sunil Kumar, Pankaj Mishra and Vishwa Bhaskar Sharma.

Addressing a press conference, the Joint Commissioner of Police (Eastern Range), Chhayya Sharma said that a complaint was lodged by Prem Shekhawat authorised representative of M/S FPL Technologies Private Limited Pune -based company wherein it was alleged that several accused persons have cheated their company to the tune of Rs 21,32,572 by creating fake PAN Card and Aadhar card of

celebrities.

During investigation, police collected the IP Addresses from one card credit card company, device ID of accused persons, IPDR of 95 mail IDs, CDR of mobile numbers and details of bank accounts which were involved in settling the cheating amount.

"Banks and credit card companies are also under investigation regarding their KYC procedure. Money trail of over Rs 90 lakh has been obtained. Further investigation is underway regarding misuse of aadhar updation process and KYC verification processes of banks by the gang," the official added.

FORMER MP MEENA SINGH QUILTS JD-U

Patna: After Upendra Kushwaha, two-time MP Meena Singh also left the Bihar's ruling Janata Dal-United on Friday.

Meena Singh won the bypoll to the Birkramganj Lok Sabha seat in 2008 after the death of her husband and sitting MP Ajit Kumar Singh, and won from Arrah in the 2009 Lok Sabha elections. She contested the 2014 elections from Arrah but lost and did not fight in 2019.

She sent her resignation letter to party as state President Umesh Kushwaha.

"I have resigned from the primary membership of the party. The resignation letter is sent to the JD-U state President. I have not decided to join any party. My priority is to go among the people of the constituency and then decide further course of action," Singh said. Sources, however, said that she is expected to join the BJP.

Sukesh's another letter levels fresh allegation against Kejriwal

Another letter by incarcerated alleged conman, Sukesh Chandrashekhar has now surfaced, which is addressed to the media and social media pages, making fresh allegations against Delhi Chief Minister Arvind Kejriwal, Manish Sisodia and Satyendra Jain.

Chandrashekhar, who is lodged in the national capital's Mandoli jail, has alleged in his five-page letter that Sisodia's arrest by CBI is just a starting and that he has "looted commissions" in every department that he was heading as being a Deputy Chief Minister.

"All that matters to them (AAP leaders Kejriwal, Sisodia and Jain) is commission," he wrote.

Referring to a tablet scam, Chandrashekhar has alleged that he had bought tablets (for distribution to children) from a Chinese company, which the Kejriwal government decided to hand over the tender to someone else in exchange for 20 per cent extra commission.

He said that every single decision in terms of commission and kickbacks were always discussed in Kejriwal's presence and were finally decided and proved by him (Kejriwal).

Chandrashekhar has claimed that kickbacks more than a "1000 odd crore" were decided and routed to



Kejriwal through various person's nationally and internationally.

Recalling how Kejriwal and Jain in 2017 sang "Ye dosti hum nahi todenge" on his (Sukesh) birthday to "persuade" him to bring in contributions from Middle East and South India, Chandrashekhar wrote that there is only "payback" now and no friendship.

In reference to an international newspaper article backing the government, Sukesh claimed the same was published through him and was used by the AAP leaders to their benefit. On Jain's recent resignation, Chandrashekhar has alleged that Kejriwal made Jain resign only now after the alleged conman challenged him during the ED custody four days ago. He wrote: "As you knew I was

taken to ED custody, and you got to know through reports that Chaturvedi who is yours and Satyendra Jain's hawala operator and shell entry operator has been summoned by ED in my case, you, and Jain got spooked to what all disclosures I must be making in ED against Satyendra Jain, Chaturvedi and you, 4 days ago."

"You know I have disclosed the role of Satyendra Jain in my case, and both of you know very clearly what's going to hit you on this regards, that's why you decided to make Satyendra Jain also resign along with Sisodia, or else why 9 months not this step and now suddenly when I have made disclosures and Chaturvedi summoned by ED, in my case," he added.

SISODIA MOVES DELHI COURT SEEKING BAIL IN LIQUOR POLICY CASE

New Delhi: Aam Aadmi Party (AAP) leader and former Delhi Deputy Chief Minister Manish Sisodia on Friday moved a bail plea at a court here after he was arrested by the CBI in connection with the now-scrapped excise policy.

Special Judge M.K. Nagpal on Monday sent Sisodia to the custody of the Central Bureau of Investigation (CBI) for five days. The custody ends on March 4.

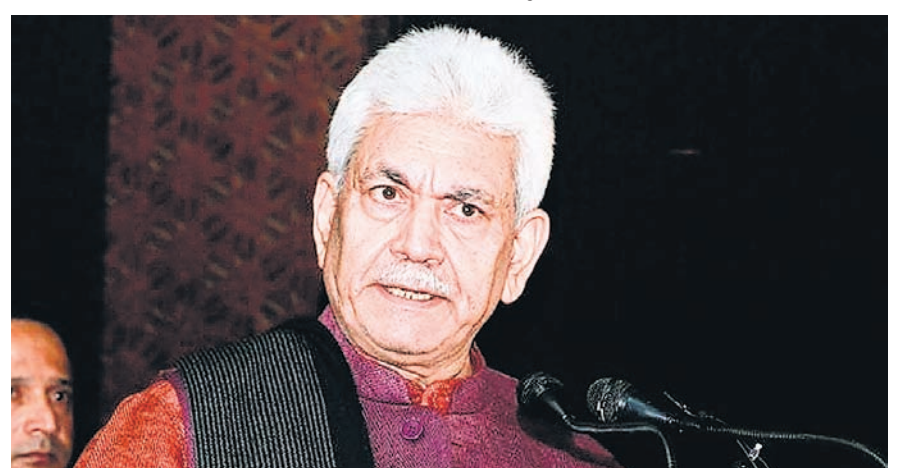
The probe agency arrested Sisodia on February 26 after eight hours of questioning.

Sisodia had moved the Supreme Court challenging his arrest by the CBI on Tuesday.

His plea, however, was declined by a bench comprising Chief Justice D.Y. Chandrachud and justice P.S. Narasimha.

The apex court said that Sisodia has alternative remedies available before the Delhi High Court.

Schools without boundaries

Nearly 75 government primary and upper primary schools in Bijnor either have no boundary walls or have dilapidated boundary wall, and since majority of these schools are located near sugar cane fields, 3500 children are under the constant fear of leopard intrusion in attack-prone region. Three leopard attacks have been reported in the last 10 days, and a 14-year-old girl was killed. The sugar cane fields are safe haven for leopard. According to officials, at least 150 leopards live amidst the cane fields. With cane harvesting having begun, leopard sightings have also increased in the area. "Leopards have been attacking villagers after sugarcane harvesting. Three leopard attacks have occurred in Nagina area in the last 10 days. A 14-year-old was killed by leopard and two days ago, a 60-year-old woman was attacked in Fatehpur village when she was mowing grass in a sugarcane field," said a local resident. Villagers are now scared to send their children to school as there is no boundary wall around it. Many schools are located on the outskirts of villages and the routes to reach them are unsafe. Teachers are also scared to take such routes. Basic Shiksha Adhikari (BSA) Jai Karan Yadav said, "We have prepared proposal to construct boundaries around primary and upper primary schools for the safety of the children. The walls are to be built under MNREGA."

ACTUAL MEANING OF HUMAN RIGHTS

Our 'Father of Nation' Late Mahatma Gandhi stated for human being: "The greatness of humanity is not in being human, but in being humane." "Earth provides enough to satisfy every man's needs, but not every man's greed." "Your must not lose faith in humanity. Humanity is like an ocean; if a few drops of the ocean are dirty, the ocean does not become dirty." As per the thoughts of our 'Father of Nation', our framers of the Constitution prepared the draft for providing fundamental rights and duties to the citizens of India. The said Constitution was implemented on 26th January, 1950. The basic structure of Constitution is based upon the human rights because our country suffered the slavery for years together. For the first time the freedom of speech and right to life is given to the public after implementation of the Constitution. Human Rights are the most basic rights which are bestowed on each and every individual. These human rights take up their action rights from the birth of these individuals till their death do them apart with their own rights. Every other human on this planet, irrespective of their caste, religion, creed, gender, nationality, social status or color are entitled to these rights. While their rights are being protected by respective country laws. To demonstrate the rights and the freedoms of these human beings, a historical document known as the Universal Declaration of Human Rights (UDHR), was set up in the year 1948. This was indeed the first intentional agreement on the basic principles of human rights. At times, our rights are defined as mere privileges, but I would agree with this notion that our rights are described as to be something more than basic privileges. In simpler words, the entitlement of the fundamental rights which are conferred on every individual is called human rights. We are born with these rights that are present until our death. All the humans surviving on this planet are entitled to these rights. These rights prove to be effective for each and all, irrespective of the fact of who they are or where they come from or how they choose to live. The reason why these rights



are formed is to protect anyone who wants to harm or to violate someone. These human rights give people the freedom to live and to express themselves as to how they want to. Everyone deserves to be themselves and this is supported by human rights. The Indian Parliament enacted the Human Right

Protection Act in the year 1993 in which in every State of the country the Human Rights Commissions were constituted so as to protect the human rights of the citizens.

Not only the Central Government, but the State Government is making policies for protection of human rights and a task is given to the State Human Rights Commission to watch the implementation of the policies for protecting human rights. It is very sorry to see that policies were framed by the legislation but implementation of policies are very slow and the administrative officers are not paying heed to the policies for its true implementation and therefore, the National Human Rights Commission as well as the State Human Rights Commission are repeatedly making recommendation for implementation of the policies.

Human Rights include-
i. Right to life and liberty.
ii. Protection from torture.
iii. Fair trials.
iv. Freedom of expression, religion, peaceful assembly.
Human Rights are inclusive of many other rights, as we deepen our thoughts the circle will get bigger. Economic, social and cultural rights cover rights which are namely the right to education, housing and health facilities. All these are available resources are required to be utilized by the government to achieve them. Treaties are formed to protect the rights of women, children, refugees, the LGBTQ+ society, minorities the disabled and domestic workers.

We are appreciating two policies of State- namely- (i) for providing free medical facilities to the poor persons- the policy of CHIRINJEEVI YOJNA, in which the poor persons can get best treatment in any of the Hospital free of cost; (ii) likewise, the State Government has established "INDIRA RASOI" which is meant for providing food for the poor people. In these Kitchens the poor person/s can get food after paying consideration of Rs. 8/- only. And the State Government is bearing rest of the expenditure occurred for their food.

I have visited so many hospitals as well as Indira Rasoi in which I found that these policies are protecting not only the human lives but also protecting health facilities to the poor people. In these circumstances, I congratulate the State Government because State Government is having intention to protect human rights of the people.

HAVING BEEN DUPED, US CITY SCRAPS AGREEMENT WITH NITHYANANDA'S 'KAILASA'

Having been duped, a US city has scrapped a sister-city agreement with the fictional nation of "Kailasa" that the fugitive godman Nithyananda's outfit claimed was recognition by Washington.

"Based on deception, the (sister-city) ceremony was groundless and void," Newark Press Secretary Susan Garofalo said in a message to correspondent on Wednesday.

"As soon as we learned about the circumstances surrounding Kailasa, the City of Newark immediately took action and rescinded the sister-city agreement on January 18," she added.

Despite Newark revoking the agreement, the make-believe "government of Kailasa" continues to post it on its website with the claim, "The United States of America recognises the United States of Kailasa (USK) and signs a bilateral agreement."

The Newark caper illustrates how easy it is for groups to manipulate municipal and state bodies taking advantage of their lack of international sophistication to unwittingly make them appear to confer legitimacy on their causes, even when they are at odds with official US positions. "USK's" Newark effort was a part of the



disinformation campaign claiming legitimacy for the "nation" set up by Nithyananda, who fled India in 2019 while facing charges of rape and abduction.

Last month, two members of "USK made an appearance at a meeting of a United Nations panel in Geneva when the session of the Committee on Economic, Social and Cultural Rights (CESCR) on sustainable development opened up for questions and comments from the audience.

One of them injected their claims that Nithyananda was being "persecuted" into her comments.

They then created the false impression on social media that "USK" was recognised

by the UN. In January when a UN panel in Geneva asked for comments on the sexual exploitation of children for a report, USK sent in comments that the panel collated along with those of others.

USK then claimed that their report was an official UN document.

The agreement with Newark was signed on or around January 11 at a ceremony at which Newark's Mayor Ras Baraka and other city leaders were present.

A picture on the "USK" website showed Baraka signing the since revoked agreement with a woman with a turban and a pendant on her forehead and wearing several necklaces while another similarly dressed woman in their trademark attire looked on.

Council Member Luis Quintana, who made the motion to junk the agreement, said, "We cannot bring Sister-Cities International into an issue where there is controversy." "We cannot put ourselves in a situation where we put a sister-cities (agreement with a city) that has no human rights and (is involved) in terms of the issues that are created elsewhere," he added.

He said, "This oversight cannot happen any longer."

There have been other instances of cities and states stepping into controversies involving India.



32 PEOPLE DIE FROM LEPTOSPIROSIS IN INDONESIA

Jakarta: At least 32 people died from leptospirosis in Indonesia from January to early March, the Health Ministry said.

These death cases were reported in Central Java (18), Yogyakarta (12), and West Java (2), Xinhua news agency reported.

"Leptospirosis bacteria spread more readily during the rainy season, which leads to flooding or inundation in many areas," Health Ministry spokesperson Siti Nadia Tarmizi told Xinhua on Thursday.

Out of 1,408 cases, 139 leptospirosis deaths were reported in the country last year.

Child suicides, abuse cases in Japan hit record high in 2022

Tokyo | Agencies

Suicides committed by school-aged children hit a record high of 512 in 2022 in Japan, data from the education ministry showed on Thursday.

According to the data, the reasons for the children taking their own lives spanned the mental burden of entrance exams to schools and universities, general woes about grades, and worries about their future, Xinhua news agency reported.

The data covered students from elementary school to senior high school age, with suicides by high school boys markedly higher in the reporting period.

As a result of the figures being the highest since comparable data became available, the country's education ministry has pushed local education boards to bet-



ter identify at-risk students. Otherwise, the boards have been pushed to provide better career advice to help ease students' concerns about their job prospects after graduating.

The education ministry has also asked high schools, where the number of suicides has been the highest, to report on their efforts to understand why a disproportionately high number of students are taking their own lives, their response in the event of a suicide, and what the schools are doing in terms of suicide

prevention. Separate data from the National Police Agency (NPA), meanwhile, on Thursday showed that cases of child abuse in 2022 also hit a record high.

The agency said that cases of suspected abuse against children aged below 18 that were reported to child welfare sentences surged by 7,703 from the previous year's record to 115,762 cases. The cases involved murder, physical and emotional abuse, revenge porn and stalking, among others, the NPA said.

DEATH TOLL FROM GREECE TRAIN CRASH RISES TO 57

Athens | Agencies

The death toll from the train crash in central Greece has increased to 57, authorities said.

Forty-eight people remain hospitalised, six of them in intensive care, Greek police spokeswoman Konstantia Dimoglidou told journalists on Thursday.

A search and rescue operation is expected to conclude on Friday, Greek Fire Service spokesman Vasilios Vathrakogiannis added.

An investigation is simultaneously underway to determine the causes of the crash - how and why a passenger train collided head-on with a



freight train travelling in opposite directions, Xinhua news agency reported.

A station master has been arrested and charged with manslaughter by negligence.

The government has declared a three-day national mourning until Friday and promised that problems affecting the operation of railways will be addressed to prevent such tragedies in the future.

Fukushima's nuclear wastewater capable of producing cancers after release

Treated nuclear wastewater from Japan's damaged Fukushima power plant, which, if released into the Pacific Ocean as planned will ultimately reach the High Seas, is "capable of producing cancers", New Zealand scientists said on Friday.

Japan has planned to release treated nuclear wastewater from the damaged Fukushima Daiichi nuclear power plant into the Pacific Ocean, reports Xinhua news agency.

Jamie Quinton, head of School of Natural Sciences, Massey University, said that in this original unprocessed wastewater, radioactive isotopes of concern were iodine-131 and caesium-137, and that they being used in nuclear medicine radiotherapy means that they have sufficient energy to cause cell death and mutation.



"In other words, they are capable of producing cancers," Quinton said.

International law expert Duncan

Currie told Xinhua that Advanced Liquid Processing System (ALPS) treatment at best does not remove tritium, and there is next to no sci-

entific information of the effects of tritium on the marine environment, including on different species.

Currie noted that planned target in treatment of Fukushima nuclear wastewater is only to remove other radioactive isotopes to "regulatory," rather than detectable, levels.

Tests of ALPS treatment systems have not been encouraging, Currie said.

"There were several other radioactive products in the unprocessed water that are hazardous to living species and ecosystems. As organisms consume other organisms, more of these radioactive products accumulate in their bodies, which can in turn, end up in humans. So these radioactive elements must be kept out of natural ecosystems as much as possible, especially the ocean," Quinton said.

David Krofcheck, senior lecturer in Physics at the University of Auckland, agreed by saying the dan-

ger of indiscriminately releasing nuclear fission products into the ocean is that the products can find their way into the food chain.

"Once in the food chain the long-lived nuclear fission heavy nuclei like cesium-137, strontium-90, and iodine-131 tend to concentrate in human muscle, bones, and thyroid, respectively. Cancers can be the result," Krofcheck said.

New Zealand should be concerned over nuclear wastewater effects on the Pacific, Currie said, citing modeling that shows movement of radioactive water to the North Pacific, including for instance through uptake in highly migratory fish and marine mammals.

Currently, an independent panel of global experts on nuclear issues are supporting Pacific Islands Forum nations in their consultations with Japan over its plans to discharge treated nuclear wastewater into the Pacific Ocean.



ATTACK ON MNS LEADER STARTS ANOTHER POLITICAL SLUGFEST IN MAHARASHTRA

Maha breach of privilege move: Sanjay Raut's reply sought

Soon after the Raj Thackeray-led Maharashtra Navnirman Sena (MNS) spokesperson Sandeep Deshpande was attacked by some unidentified persons during his morning walk, a fresh political ruckus started with finger pointing at each other, here on Friday.

A few hours later, Deshpande, 50, was discharged after treatment, with an arm in a sling, was taken in a wheelchair to his car, and interacted briefly with the media.

"I am not scared by this assault... Everybody knows who is behind it," a defiant Deshpande said without taking names. Dhuri claimed that the sudden assault, the motive of which is not clear, was well-planned one as the assailants, believed to be around four, sported face masks and had come prepared with the weapons to isolate and fatally harm Deshpande.

Earlier, MNS President Thackeray, his son Amit and other senior leaders visited the hospital to enquire after the condition of Deshpande - known for his fiery view on various issues.

Playing the attack, MNS leader Amey Khopkar demanded a probe

into the alleged role of Shiv Sena (UBT) leaders Aditya Thackeray and MP Sanjay Raut behind the assault on Deshpande.

"The police must investigate the involvement of Aditya Thackeray and Sanjay Raut and if anything is found against them, they should be arrested," demanded Khopkar.

Nationalist Congress Party's Leader of Opposition Ajit Pawar took a swipe at Chief Minister Eknath Shinde, and said "this is what can be expected in a government of the common masses".

Sena (UBT) Spokesperson Sushma Andhare said the incident proves that Bharatiya Janata Party Deputy Chief Minister is "ineffective" in handling his home portfolio.

NCP MLA Rohit Pawar (grand nephew of NCP President Sharad

Pawar) said it's a matter of concern how many political leaders are being targeted, threatened or attacked in the past few months.

He cited the instances of Union Minister Nitin Gadkari, Aditya Thackeray, Pradnya Rajeev Satav, or today's incident of Deshpande - plus Dr. Jitendra Awhad, and wondered if prominent politicians are not secure then how can the common man feel safe. BJP city President Ashish Shelar said even he has been getting similar threats to "spray bullets into him" and wondered whether there was any link with the assault on Deshpande. MNS leader Avinash Jadhav warned that they would not retaliate in stealth, but "we shall storm into their press conferences and public meetings and hammer them".

The Maharashtra Legislative Assembly has sought Shiv Sena (UBT) MP Sanjay Raut's reply to the breach of privilege notice moved by the ruling ally Bharatiya Janata Party members, by Friday (March 3) evening.

Raut, who is currently touring Sangli, told media-persons that he has "not received any notice" so far, adding that this is a legal matter and he would require time to file his reply.

"I have already been to jail... If I don't submit the reply, shall I be hanged?" countered Raut, who is under fire for his purported 'chor mandal' remarks that enraged the state's legislators.

On Thursday, the Maharashtra Legislative Council Deputy Chairperson Dr. Neelam Gorhe directed him to file his reply to a similar notice from the Upper House within seven days.

The Opposition Sena (UBT) Leader of Opposition in the Council Ambadas Danve has moved a separate



breach of privilege notice against Chief Minister Eknath Shinde for his remarks calling the Opposition as 'anti-nationals' (desh-drohi) after they boycotted his session-eve tea-party last Sunday.

On Thursday, the Chief Minister clarified that his statement was intended at the Nationalist Congress Party (NCP) MLA Nawab Malik, who is currently in jail for alleged deals with the mafia.

Quickly reacting to this,

Raut said that even his statement ('chor mandal') was directed at the CM Shinde's Shiv Sena MLAs and not at the entire legislature.

A day before, Nationalist Congress Party President Sharad Pawar expressed his reservations on the formation of the committee excluding Sena (UBT) members, but including the complainant on the panel, besides the legality and guidelines for such a move since Raut is a Member of Rajya Sabha.

IPS officer Rashmi Shukla appointed DG of SSB, faced phone-tapping allegations

The Central government has appointed Rashmi Shukla, an IPS officer of the Maharashtra cadre as the Director General (DG) of Sashstra Seema Bal (SSB). Shukla has been accused in a phone tapping case.

She was accused of tapping the phones of Shiv Sena leader Sanjay Raut and Nationalist Congress Party (NCP) leader Eknath Khadse among others.

A complaint had been registered in the matter, however the Eknath Shinde government rejected the demands to prosecute her.

Shukla's posting was done on Thursday and she will be replacing Anish Dyal Singh.

The 1988 batch officer has previously headed the Central Reserve Police Force (CRPF) as Additional Director General and has been the former Chief of Maharashtra Intelligence Department.

The order issued on Thursday read that the



Appointments Committee of the Cabinet (ACC) approved Shukla's promotion to the rank of DG in February. Shukla has also been a recipient of several accolades.

WOMAN'S BODY FOUND WITH MULTIPLE STAB WOUNDS

Thane: The body of a 33-year-old woman with multiple stab wounds was found in her hut at Kalwa in Maharashtra's Thane city, police said on Friday. The body was found on Thursday evening in Jai Bhim Nagar locality, they said. The woman was identified as Kamlibai Pawar and her body was sent for post-mortem, the police said.

"A police team was informed about a woman lying in her house in an injured condition. The team rushed to the place and found the woman lying in a pool of blood with multiple stab wounds," a police official said. "Someone had attacked her with sharp weapons.

Ahead of SSC exam, love-torn teen killed by girlfriend's kin

In a shocking tragedy ahead of the SSC exams, a love-torn minor boy was killed by his girlfriend's family after they caught them together at their home, an official said here on Friday.

The Vajapur Police have arrested three persons of a single family for murdering the boy and dumping his body in a nearby field, said Investigating Officer Manoj Patil.

The incident happened in Bhivgaon village on the night of February 25, when the boy from the neighbouring Borsar

village had sneaked in to meet his girlfriend at her home.

When the girl's family members learnt of this and their 'affair', they were furious and brutally hammered the boy, dragged him out of the house and then dumped him in an adjoining field.

It was only after around five days that the locals stumbled upon the victim's highly decomposing body and informed the Vajapur Police which rushed a team to the spot, said Patil. After establish-



ing his identity, the police learnt that he had gone to meet his girlfriend -- both aged 15 and classmates in Class 10 in a local school -- and

confronted her family. Following sustained interrogation, the family finally revealed the truth, and the girl, who was initially unwilling to cooperate also admitted that she was in a serious relationship with her deceased boyfriend.

"We have arrested the prime accused Madhavrao Jangle, 65, and his sons,

Dadasaheb and Sunil on charges of murder. They are the grandfather, father and uncle of the girl," said Patil.

The accused father-sons were produced before the Magistrate Court which remanded them to police custody till March 6, and further investigations would now be conducted by a female officer from the police headquarters.

Incidentally, both the teen lovers were planning to write the SSC public exams which got underway across Maharashtra from March 2, but it is not clear if the girl will appear for the crucial examinations or not after her boyfriend's grisly death.

Democracy under threat, whole world knows about it: Aaditya Thackeray

Shiv Sena Leader (UBT) leader Aaditya Thackeray on Friday said that democracy in India is under threat and the whole world knows about it.

2 from Surat nabbed for sneaking into SRK's home, cops probe motives

A day after nabbing two youths from Gujarat's Surat for allegedly trespassing into the iconic 'Mannat' bungalow of Bollywood mega-star Shah Rukh Khan here, the Bandra Police are probing the 'motives' of the duo's action, official sources said here on Friday.

The Bandra Police swung into action after an alert from the actor's team late on Thursday night that they had caught the duo -- who claimed to be fans of the actor -- jumped over the boundary wall and sneaked into the bungalow on Bandra Bandstand ostensibly to meet and greet SRK.

In what is considered as a major security breach, the



two youngsters, aged in their early 20s, managed to reach the third floor of the bungalow, but were apprehended by the startled security personnel after they spied them sauntering on the premises late last evening.

It is not immediately clear

if the actor or his family was present in the bungalow, or whether anything was damaged or stolen, but the Bandra Police are understood to have 'advised' Khan to carry out a review cum audit of his security detail.

Result of Kasba Peth shows...": Team Uddhav as BJP stunned in Maharashtra

Launching an attack on the BJP after the latter lost the Kasba Peth Assembly to the consensus MVA candidate, the official mouthpiece of Shiv Sena (UBT), Saamana, today claimed the bypoll result goes to show the deep-seated public discontent against the BJP in Maharashtra and across the country.

In an editorial published on Friday, the mouthpiece said, "The result of Kasba Peth (Assembly bypoll) shows the deep-seated public discontent against the Bharatiya Janata Party in Maharashtra and in India as well. The voters are aware of all that is happening around them and hence voted against the BJP. The bypoll result in Kasba is being celebrated across Pune. This celebration will continue till 2024, not just in Maharashtra but across the country



as well."

Further, on the victory in Kasba Peth, the editorial claimed the Maha Vikas Aghadi (MVA) had breached a BJP bastion.

MVA-backed Congress candidate Ravindra Dhangekar won the Kasba Peth bypoll, trouncing BJP's Hemant Rasane by 10,915 votes.

"These bypolls had to be held owing

to the untimely demise of BJP MLAs Mukatai Tilak and Laxman Jagtap, and it is the BJP, which now has to bear the embarrassment of losing the prestigious seat of Kasba," the Saamana editorial read further.

On the MVA's loss in the other bypoll for the Chinchwad Assembly seat of Pune, the editorial stated that the BJP only emerged victorious after a struggle.

"In Kasba, the Maha Vikas Aghadi's candidate Ravindra Dhangekar defeated BJP's Hemant Rasane (by a comfortable margin), while in Chinchwad, the wife of late MLA Laxman Jagtap, emerged victorious only because of a three-way split in the Opposition votes. Had it been a contest between two candidates like Kasba, the BJP, which believes in 'Khokeshahi' (splashing cash to seize power), would not have won," the editorial read.

"The contribution of the 'original'

Shiv Sena, which was in the alliance at that time, was equally important in the BJP's victory in the town till date. If the Shiv Sainiks had not put its efforts at the time, then this so-called citadel of the BJP would have collapsed long time back," it read.

The Kasba seat was considered a BJP stronghold in Maharashtra as the party held the constituency for 28 years.

The bye-election in Kasba was necessitated after the BJP's Mukta Tilak died after a prolonged battle with cancer in December 2022.

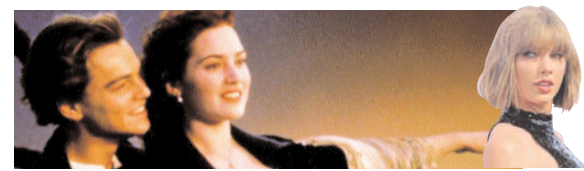
Grish Bapat, who is presently a BJP MP from Pune, represented the seat five times till 2019.

The victory of Congress in Kasba is significant as it was the first direct contest between the ruling BJP-Eknath Shinde-led Shiv Sena and the MVA after the change of guard in the state last year.

GIRL, DIES BY SUICIDE, ACCUSES FATHER OF SEX ABUSE

Palghar: A 14-year-old girl allegedly hanged herself to death at her house in Vasai taluka of Maharashtra's Palghar district, with the police recovering a "suicide note" in which she accused her father of sexually abusing her, an official said. The girl died three days back at her family residence in Valiv and the note was found on Thursday, he said.

After her death, the minor's body was sent to a government hospital for post-mortem and a case of accidental death was registered. "In the suicide note purportedly written by the girl, she alleged that her father sexually abused her. It also said that although she raised the issue with her mother, the latter failed to take any action on it," an official said. In the note, the girl sought strict punishment for her father, he said, adding that a probe into the case is on.

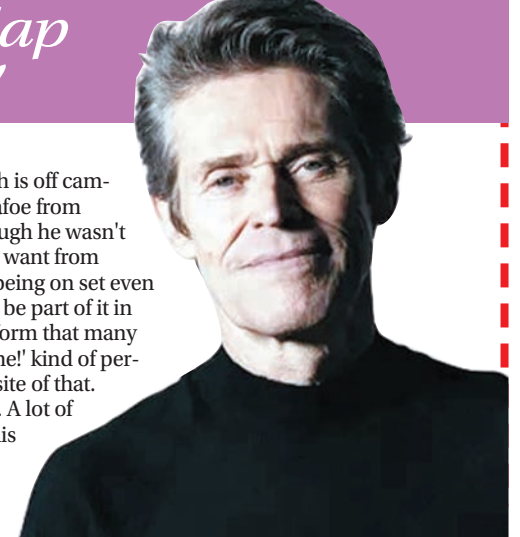
In a new Dafoe profile published by The New York Times, it's revealed that Dafoe asked to be slapped repeatedly for a scene in which he does not

IND vs AUS 3rd Test Day 3

Head, Labuschagne take Australia to comprehensive 9 wicket win

Travis Head and Marnus Labuschagne slammed unbeaten 49 and 28 respectively to take Australia to a comprehensive nine-wicket win over India in the third Test at Holkar Stadium.

Day three's play began with Australia needing 76 runs to win on a minefield of a pitch. Despite losing Usman Khawaja early for a two-ball duck, Head and Labuschagne were able to make short work of the target and got the job done in 18.5 overs to make the four-game scoreline 2-1.

The victory also means that Australia have qualified for the World Test Championship final, to be held from June 7-11 at The Oval in London.

The day began with Ravichandran Ashwin getting an outside edge on Khawaja's forward defence and KS Bharat catching it behind. Khawaja went for a review, but replays showed a healthy spike on the UltraEdge, giving India some relief.

A fiercely determined Ashwin asked tough questions of Head and Labuschagne and even took a DRS against the latter when Virat Kohli, at



leg-slip, took a diving catch, which resulted in India burning a review.

After some quiet overs as Australia were just 13/1 in ten overs, Head broke the shackles by whacking Ashwin over mid-on for four and followed it up with a huge six down the ground in the 11th over where India had first to change the ball. Head welcomed Ravindra Jadeja by hammering

a four over his head and Labuschagne ended the over by sweeping the left-arm spinner through mid-wicket for another boundary in the over.

When Ashwin overpitched, Labuschagne quickly brought out the cover drive for a delightful four. When Jadeja sent in an arm ball, Head played the cut late through backward point for another boundary. Ashwin was taken apart in the 15th over, as Head danced down the pitch to punch through cover while Labuschagne placed a reverse sweep well through backward point to make it two fours in the over.

India introduced Umesh Yadav in the bowling attack as a last throw of dice. But Head and Labuschagne were unstoppable; the former slapped the Vidarbha pacer through cover while the latter pulled past square leg to make it two boundaries.

When Ashwin pitched up, Head smacked down the ground for four. Labuschagne finished off the chase in style by dancing down the pitch and lofting past mid-on for four to take Australia to an emphatic Test victory in India, and their first in the country since the 2017 win in Pune.



IT WAS A COMPLETE PERFORMANCE IN THE END: SMITH

Indore | Australia's stand-in captain Steve Smith said his side produced a complete performance by the end of the third Test at Holkar Stadium.

"I think obviously that first day, losing the toss and having to bowl first. But our bowlers did really well, especially Kuhnemann. With the bat, Usman was really good in the first innings."

"We had some good partnerships. India bowled really well in the back end; we had a bit of a collapse. We had to toil hard yesterday, Pujji (Cheteshwar Pujara) played a good knock, but all our bowlers did really well. It was a complete performance in the end," said Smith.

"It's a place that I really enjoy and I think I did a reasonable job this week. The approach will be much the same. We have to see what the conditions are like. It's good to be in the WTC final but it's just about playing good cricket. Hopefully, we can finish the series well."

"It's been a pretty remarkable series. But to come out here and put out a good team performance was pretty special. I don't have all the skills and all the tricks in the trade but the one thing I have is the belief in my stock ball."

THE PITCH IN INDORE HAS BEEN RATED AS "POOR"



Dubai | The International Cricket Council (ICC) on Friday announced that the pitch for the third Test of the ICC World Test Championship series between India and Australia at the Holkar Cricket Stadium in Indore has been rated as "poor" under its Pitch and Outfield Monitoring Process.

ICC Match Referee Chris Broad submitted his report to the ICC expressing the concerns of the match officials and after consulting with captains of both teams. Following the assessment, the venue has received three demerit points.

Following the assessment, the venue has received three demerit points. The report has been forwarded to the BCCL, who now have 14 days if they wish to appeal against the sanction.

"The pitch, which was very dry, did not provide a balance between bat and ball, favouring spinners from the start. The fifth ball of the match broke through the pitch surface and continued to occasionally break the surface providing little or no seam movement and there was excessive and uneven bounce throughout the match," said Broad in an ICC media release.

When a venue collects five demerit points (or crosses that threshold), it will be suspended from hosting any international cricket for a period of 12 months. A venue is suspended from staging any international cricket for 24 months when it reaches the threshold of 10 demerit points.



WE DIDN'T BAT WELL IN THE FIRST INNINGS, ADMITS ROHIT SHARMA AFTER LOSS

After a comprehensive nine-wicket loss to Australia in the third Test here, India skipper Rohit Sharma admitted that the hosts paid the price of not batting well in the first innings.

"When you lose a Test match, there are a lot of things that didn't go our way. To start with, we didn't bat well in the first innings. We understand how important it is to put runs on the board in the first innings. And obviously, when they got an 80-90 run lead, we needed to put in a big performance with the bat but we couldn't do that, taking just a 75-run lead," he said in the post-match presentation ceremony. In the second innings, barring top-order batter Cheteshwar Pujara's 59, none of the batters

stepped up as Nathan Lyon took an eight-wicket haul. We had to try and be brave, which I think we were not. We can take a lot of credit as well, how we batted in the first two games. "One odd game can happen where things don't come together, but even then you need players to come together and chip in. We wanted a few guys to stand up but it didn't happen. We were slightly behind and we did not apply ourselves the way we would have liked to." "Honestly, we haven't thought about it yet. We just finished this Test now so we need to regroup and try. We need to understand that we need to improve as a team. When you are playing on challenging pitches you have to bowl. We allowed their bowlers to bowl in one spot. Not to take any credit away from their bowlers, Nathan Lyon especially."

"In father's footsteps"

Ronaldinho's son joins Barcelona academy

FC Barcelona made an important connection with their past when they confirmed the signing of forward Joao Mendes -- the son of legendary Brazilian forward Ronaldinho.

The 18-year-old is expected to initially form a part of Barcelona's B team, which plays in Spanish football's third tier, the club informed.

Mendes, who had been without a club since leaving Brazil's Cruzeiro in February last year, impressed Barcelona coaches during a trial earlier this year, reports

The youngster has already made his debut with Barca's under-19 side in a friendly against Manchester United. He is a player who can play as a central striker or in a deeper role.

He is right-footed but good with his left, and Barca hope he will be able to follow in his father's footsteps.

Ronaldinho spent five seasons with Barcelona between 2003-2008 and played a huge part in lifting the club to dominance between 2004-2006 when Barca won back-to-back La Liga titles and the Champions League trophy.

He played 207 times for Barca, scoring 94 goals, with arguably his most memorable performance coming in November 2005 when he scored two goals in a 3-0 win away to Real Madrid, which even saw some Madrid supporters applaud him.

India's nine-wicket defeat to Australia has made Rohit Sharma & Co's path to qualifying for the World Test Championship (WTC) final, to be held from June 7-11 at The Oval in London, a little bit complex.

While India hold on to second place on the standings with 60.29 of their possible WTC points and are in prime position to qualify for the final, they can still be overtaken by Sri Lanka should results go against Rohit Sharma's side over the coming weeks.

A victory in the fourth Test against Australia in Ahmedabad will ensure India's spot in the WTC Final. But another victory for the visitors or a draw will leave the door open for Sri Lanka to overtake India and snatch the last spot for the final.

home against New Zealand this month and know they have to complete a 2-0 series sweep over the Kiwis to have any chance of snatching a spot for the WTC final. But with New Zealand recently holding England to a 1-1 draw at home, it is easier said than done for Sri Lanka to stop India from qualifying for the WTC final unless something dramatic happens.

For Australia, they have now got their first-ever spot in a WTC final. Australia have been the dominant side during this WTC period of 2021-23, with Pat Cummins' side having won 11 of the 18 Tests they have featured in, and winning the Indore Test with Steve Smith at helm.

The victory in Indore has helped Australia amass an impressive 68.52 of their possible WTC points and that means they will finish the current period in first place on the standings regardless of the result in the final Test of their ongoing series against India at Ahmedabad.

Dubai Tennis Championships

Djokovic, Medvedev to face off in blockbuster semifinal

World No. 1 Novak Djokovic moved into the semifinals of the Dubai Tennis Championships with a hard-fought straight-sets 6-3, 7-5 win against Hubert Hurkacz of Poland, setting up a blockbuster semifinal clash with former world no 1 Daniil Medvedev.

Djokovic, competing in his first tournament since lifting his record-extending 10th Australian Open trophy, is now 15-0 in the season, marking his fourth-best winning streak to start a season.

The Pole threw everything in his deep arsenal at Djokovic on the centre court. From winning a point after hitting a tweener in the early moments of the match to putting pressure on the Serbian by moving forward, the Pole tried to take the 35-year-old out of his comfort zone.

But Djokovic dominated on serve - he did not face a break point - and chipped away to earn opportunities until he broke through. The top seed converted two of his eight opportunities to advance after one hour and 21 minutes and take a 5-0 lead in the pair's ATP head-to-head series.

In the first round, the Serb needed a final-set tie-break to claw past Tomas Machac. Now Djokovic is two wins from capturing his sixth title in Dubai and his 94th tour-level crown overall. That would tie him with Ivan Lendl for the third-most titles in the Open Era.

The 22-time Grand Slam champion will be fully focused on the face-off with Medvedev, who ousted eighth seed Borna Coric 6-3, 6-2 in the last match of the day. The third seed won the last 21 points of the match to send a message to his next opponent.

Copa del Rey

Barcas make case for defense with 1-0 win at Real Madrid in semis

FC Barcelona produced a rock-solid and very untypical defensive display to beat Real Madrid 1-0 at the Santiago Bernabeu Stadium in the first leg of their Copa del Rey semifinal.

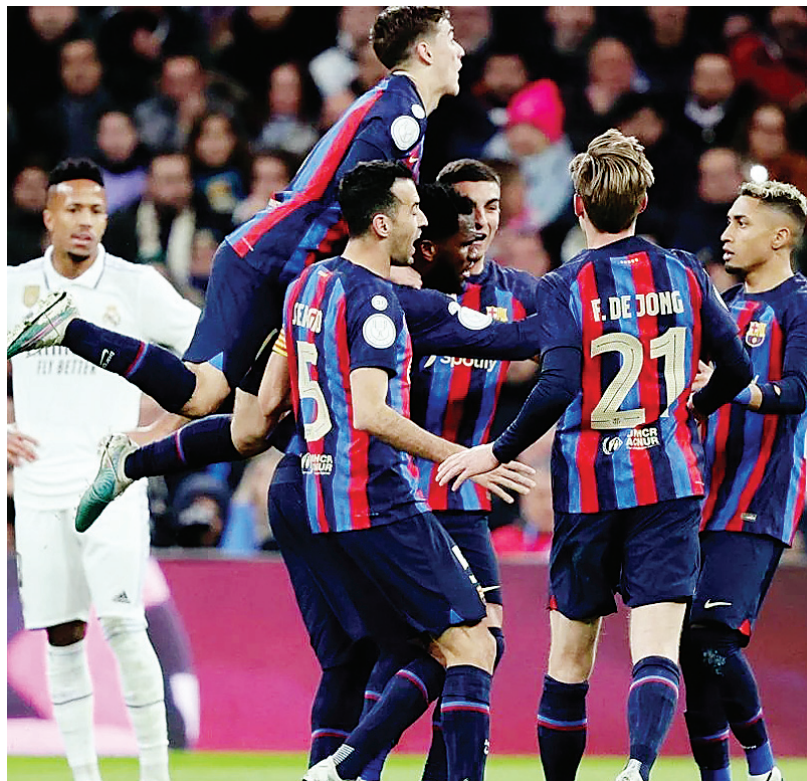
Real Madrid dominated possession in the first half, with Luka Modric running on goal in the first minute, although the offside flag went up. The flag went up again in the 12th minute to rule out an effort from Benzema after a good cross from Vinicius Junior, who was involved in most of Madrid's attacking play, but also looking for niggles with the Barca players, reports news agency Xinhua.

Barca opened the scoring with a touch of fortune in the 27th minute. Eduardo Camavinga lost possession in his own half, the ball was threaded to Kessie and although Thibaut Courtois saved well with his feet, the ball rebounded into the net off Eder Militao.

Vinicius responded with a cross that was cut out by Ter Stegen and after Gavi's cross just evaded Raphinha, Dani Carvajal wasted Real Madrid's best chance of the half, drifting in unmarked behind the Barca defense before volleying high and wide.

Madrid came strongly out of the blocks at the start of the second half, but despite Barca at times being reduced to clearing the ball aimlessly upfield for Raphinha to chase, the only save Marc-Andre ter Stegen had to make was from Vinicius' curling cross.

Barca could have made it 2-0 only for

moments, but Barca will be happy with the result ahead of the return in the Camp Nou on April 5th.

Ability to stay grounded makes Kohli champion: Dinesh Karthik
