H3N2 VIRUS: HEALTH EXPERTS CALL FOR MASKS, BETTER HYGIENE & FLU SHOT



ven as India is seeing a spurt in Influenza cases, caused by H3N2 virus, health experts on Monday have suggested people to take precautionary measures such as use of masks, better hand hygiene, as well as an annual flu shot.

A total of 3,038 lab-confirmed cases of various subtypes of influenza including H3N2 have been reported till March 9 by the states, as per the latest data available on IDSP-IHIP



(Integrated Health Information Platform). This includes 1,245 cases in January, 1,307 in February, and 486 cases till March 9.

"In my opinion, for the time being the government can again make masks mandatory at least in highly vulnerable zones like public transports, hospitals, airports, railway stations and other public conveyances. People should avoid visiting crowded places, or wear a mask whenever in public," Dr. Sunil Sekri, Associate Consultant - Internal Medicine, Max hospital, Gurugram, told reporter.

Meanwhile, the Covid infection has also reported a spike after four months as 524 daily Covid cases were reported on Sunday

"For the last three years we have learned how respiratory infections can be prevented. Because the infec-

tions go out and come in from the nose and mouth, you need to cover this area and that is masking. Proper masks are needed, particularly when you are in crowded places," said Dr. Iswar Gilada, an infectious disease expert.The experts also suggested people to wash their hands before eating or utilising any public transit with soap or sanitiser to minimise the risk of infection.

Another thing is flu shots, that need to be taken annually to help boost immunity. It is because, "a vaccine that you took last year might not necessarily cover the influenza virus that's going to come next year or the year after. It will give you some baseline protection but it may not give you the best protection", Dr. Jayadevan told reporter. Meanwhile the experts also stated that antibiotics should be

The respiratory virus "spreads through droplets, so which means that the secretions can spread from person to person, and most people touch their nose and mouth at some point, or those secretions can remain on the fingers and when they shake hands with other people."

'Very seminal issue'

SC REFERS PLEAS FOR SAME-SEX MARRIAGE TO A CONSTITUTION BENCH

he Supreme Court on petitions seeking recognition of same sex marriage to a constitution bench for final hearing, noting it is a "very seminal issue" against the backdrop of interplay of various rights including of right to live with dignity.

A bench headed by Chief Justice D.Y. Chandrachud and comprising Justices P.S. Narasimha and J.B. Pardiwala said: "It is a very seminal issue", while scheduling the matter for consideration before a five-judge bench on April 18. The proceed-

ings will be live streamed. The bench said it will invoke Article 145 (3) of the Constitution and have this matter decided by a constitution bench, comprising five judges. Solicitor General Tushar Mehta, representing the Centre, contended that the right



to love or right to express one's love, irrespective of gender of other person, is completely different from what the court would find the mechanism to give recognition or to give a sanctity by way of an institution called marriage.

Mehta further contended that if the marriage is recognised between same sex, then the question will be of adoption, then the Parliament, which represents the

will of the people, will have to examine the psychology of child, who has seen either two men or two women as parents, and has not been reared by a father and a mother, and clarified that he is not giving any judgement.

He added that Parliament will have to debate and take a call, in view of societal ethos and several other factors, whether same-sex marriage needs to be recognised.

DELHI-DOHA PLANE DIVERTED TO KARACHI DUE TO MEDICAL EMERGENCY, PERSON DECLARED DEAD

New Delhi: An IndiGo flight was diverted to Karachi airport one of its passengers fell sick. The plane was flying from Delhi to Doha.



The passen-

ger reportedly passed away before the flight could land. Officials said that a passenger on IndiGo Airline flight 9E1736 felt sick in the flight, after which the captain of the plane contacted the Karachi Air Traffic Control and relayed the information regarding a medical emergency.

"IndiGo flight 6E-1736, operating from Delhi to Doha was diverted to Karachi due to a medical emergency on board. Unfortunately, on arrival, the passenger was declared dead by the airport medical team," said the airline on Monday.

"We are deeply saddened by the news and our prayers and wishes are with his family and loved ones. We're currently making arrangements for transferring the other passengers of the flight, in coordination with the relevant authorities," added the airline spokesperson.

WOMAN STRIPPED, ASSAULTED BY 11 MEN IN AGRA



Agra: A 30-year-old woman was allegedly beaten and stripped by a group of men after she resisted eveteasing in Uttar Pradesh's Agra district. According to the FIR, the woman had objected to eve-teasing by two men last week.

Later, the two along with 11 others, armed with sticks, barged into her house and stripped her while her family members were also assaulted. The woman said that the accused also threatened to kill her family if they filed a police complaint. An FIR has been registered at the Tajganj police station against the 13 accused under various IPC sections including rioting. SHO Raj Kumar said, "The accused men are absconding. Efforts are being made to arrest them.

"India's engagement with China is complex. It further stated that "the External Affairs Minister has conveyed to his counterpart that restoration of normalcy will require a restoration of peace and tranquility in the border areas. India consistently raises the issue of Pakistan's continued support to cross-border terrorism and terrorist infiltration in bilateral, regional and multilateral fora. In such outreach, credible inputs regarding the Pakistani-origins of the captured terrorists are also shared," the report said further.

RETAIL INFLATION SEES MARGINAL FALL TO 6.44% IN FEBRUARY 2023

New Delhi: Retail inflation for February 2023 fell marginally to 6.44 per cent compared to 6.52 per cent in January 2023 as commodity prices witnessed a slight slide.

Food inflation also slid to 5.95 per cent in February 2023 compared to 6 per cent in January.

Consumer price index (CPI) based inflation had touched 6.52 per cent in January 2023, which was a three-month high owing to higher

food prices. However retail inflation was 6.07 per cent in February 2022, and therefore CPI-based inflation in February 2023, at 6.44 per cent, was higher compared to the year-ago period. The marginal fall in retail inflation in February 2023 was mainly due to reduction in prices of meat and fish, egg, vegetables, pulses, and sugar. At the same time though, prices of fruits, clothing and footwear, education, transportation, health and household goods went up in February 2023 compared to

January 2023.


GOVT DEMANDS APOLOGY FROM RAHUL AS CONGRESS OBJECTS

As soon as Lok Sabha convened at 2 p.m., Rajendra Agrawal, who was in the Chair, asked for papers to be laid in the House. However,

Congress members came into the well of House, shouting slogans "We want JPC" while treasury benches were also seen shouting slogans "Rahul Gandhi Maafi Maango" (Rahul Gandhi apologise).

Agrawal urged protesting members to return to their seats, saying that they should allow some business to be transacted. "All issues would be discussed," he said. Agrawal also said that the Speaker has disallowed all adjournment motions given by various members.

SC AFFIRMS ORDER TO REMOVE MOSQUE FROM ALLAHABAD HC PREMISES

he Supreme Court on Monday affirmed the Allahabad High Court order passed in 2017, directing removal of a mosque from its premises

A bench of Justices M.R. Shah and C.T. Ravikumar declined to interfere with the high court order and granted three months' time to the petitioner to remove the mosque from the high court premises. It noted that the high court can demolish the construction. if it is not cleared within three months and also allowed the petitioner, Waqf Masjid High Court to make a representation to the state government for an alternative land

The bench said it does not see any reason to interfere with the impugned judgment and order of the high court. It added, however, it will be open to the petitioners to make a detailed representation to the state government seeking alternative land, which may be considered in accordance with law and on its own merits, and refused to entertain a petition challenging the high court order.

The bench noted that the mosque was situated on government lease



2002, and after cancellation of the lease, the land was resumed in favour of the high court in 2004 for its expan-

Senior advocate Kapil Sibal, representing the Waqf Masjid High Court, narrated the history of the mosque and added that Muslims were offering namaz and there was an arrangement for wazu as well. He said that the mosque is situated across the road outside the high court and wrong to say it was on the high court

Sibal added that in 2017, the government changed and a PIL was filed against the mosque after the new government was formed and added that the mosque was functioning as a public mosque for decades.

Senior advocate Indira Jaising, representing the UP Sunni Waqf Board, submitted that though the land belonged to the government but the board was in possession of the mosque meant for public use. She added that her client is willing to be

not insisting that namaz has to be offered there.

The counsel, representing the high court, argued that the petitioner is unnecessarily giving the matter a religious colour.

The top court told the mosque's counsel to try to understand that they have no right since it was a lease property. "Lease was terminated and land was resumed and confirmed by this court... You can't claim it as a matter of right to continue.'

Madras HC quashes govt orders empowering police to exercise powers of executive magistrates

he Madras High Court has quashed two government orders issued in 2013 and 2014 empowering Deputy Commissioners of Police to exercise the powers of executive magistrates under Sections 107 to 110 of the Code of Criminal Procedure (CrPC).

A division bench of the Madras High Court comprising Justices N. Satish Kumar and N. Anand Venkatesh said that the government orders issued on September 12, 2013 and February 20, 2014 suffer from "manifest arbitrariness and violate the principle of separation of powers under the Constitution".

The court ordered status quo ante as it prevailed before the issuance of the two government orders, and held that such a status would be restored forthwith.

The court made it clear that violation of a bond exe-

cuted under Section 110 of CrPC could be dealt with only by judicial magistrates under Section 446 and not by the executive magistrates under Section 122(1) (b) of the Code.

An executive magistrate cannot authorise imprisonment under Section 122(1) (b) of the code for violation of the bond under Section 107. "A person who has violated a

bond executed before an executive magistrate under the said provision would have to be prosecuted before a judicial magistrate for inquiry and punishment under Section 122(1)(b) of CrPC," the verdict said. The judges also stated: "The police, like the proverbial camel in the tent, occasionally got their noses into the canopy but were stopped in the tracks by the courts. Then in 2013, the camel in its entirety struggled and the revenue officials and executive magistrate were ousted from the canopy and left in the cold. Now we have ousted the camel and put the canopy of justice where it

Excise policy scam: Delhi court extends bizman Arun Pillai's ED custody by 3 days

Team Absolute New Delhi Delhi court on Monday extended Hyderabadbased businessman Arun Ramchandra Pillai's Enforcement Directorate (ED) custody by three days in the excise policy case.

He was arrested on March 6 after hours of questioning in the case. Special judge M. K. Nagpal of the Rouse Avenue Courts sent Pillai to ED custody on March 7, which expired on Monday.

The judge, dealing with the matter, extended his custody on Monday. On March 10, Pillai moved an application before the same court seeking to retract his statements given to the probe agency in the case. This led to the court issuing a notice to the ED. His arrest makes up for the 11th

arrest made in the matter by

The ED has alleged that Pillai was involved in forming a cartel (now called South group) manufacturers, wholesalers and retailers which controlled more than 30 per cent of the liquor business in the national capital. The central agency named the said cartel, South group, which includes BRS leader K. In exchange for kickbacks given by the South Group to Vijay Nair and AAP, Indo Spirits was made the wholesaler of Pernod Ricard which made it one of the most profitable L1. Thus the fund of Rs 3.40 crore which used to show investment in Indo Spirits (a special purpose vehicle to recoup the kickbacks paid by the South Group and channel the illegal gains) is proceeds of crime, the ED added. Kavitha Spirits with a 32.5 per cent is a member of Telangana stake and he represented K. Legislative Council.

he National Investigation Agency (NIA) on Monday conducted a search at Uzair Azhar Bhat's house in Karfali Mohalla of Srinagar and seized digital devices.

Bhat is suspected of spreading ISIS ideology, luring people to join the terrorist group and indulging in antinational activities.

The NIA said that in 2021, they started investigating Mohammed Ameen alias Abu Yahya who had been running various ISIS propaganda channels on different social media platforms, such as Telegram, Hoop and Instagram.

"He was propagating the violent jihadi ideologies of the ISIS and was radicalizing and recruiting new members to this ISIS module. He and his associates had even identified certain individuals for targeted killings. They



had also made plans to undertake Hijrah to Jammu and Kashmir for engaging in terrorist acts and had raised funds from various sources for

this trip," the NIA said. The official said that during the probe, it was found that Mohammad

Ameen was in touch with Deepthi Marla of Kerala, a converted Muslim, married to Anas Abdul Rahiman of Mangalore. In 2015, she had gone to Dubai to pursue studies where she met Mizha Siddeegue and both women developed an inclination

towards the ISIS. In 2019, they tried to do Hijrah to Khorasan and reached Tehran, Iran. After reaching Tehran, their contact with ISIS operatives based in Khorasan could not be established.

"They both returned to India, and Deepthi got in touch with Ameen, Obaid Hamid Matta, Madesh Shankar alias Abdullah and others and made plans to undertake Hijrah to ISIS administered territory. In January 2020, she went to Srinagar to meet Obaid to plan the Hijrah and stayed in Srinagar for one week," the NIA said. One of the common contacts between Deepthi and Obaid, Uzair Azhar Bhat, who is suspected to have been part of the conspiracy, was raided on Monday. The NIA conducted a search at Bhat's house in Srinagar. The seized digital devices are being examined and further investigations are in progress.

V.D. Satheesan has sent a letter to Madhya Pradesh Chief Minister Shivraj Singh Chauhan seeking his intervention in the matter.

As per the reports, students who were allegedly attacked were identified as - K. T. Nasheel, R. Abhishek, Adnan, and Adil Rashif.

The Public Relations Officer of the IGNTU, Vijay Dixit has in a tweet said, "An argument broke out between the students and security personnel over clicking photographs at a water tank near the main gate of the university on the night of March 10."

"The matter escalated into a fight, following which security personnel approached the Amarkanatak police station with a complaint against the students, who in turn demanded that the university administration take action against the security staff."



JD(U) READY FOR ALLIANCE WITH SP IN UP FOR 2024 POLLS

ANTI-WOMEN TALIBAN

he slew of anti-women measures adopted by the Taliban government in Afghanistan has essentially gone against them, further isolating them globally and making them a pariah.

Reportedly, a handful of Afghan women courageously held a demonstration in the Afghan capital, Kabul, on 8 March, calling on the international community to protect Afghan women.

This was the second International Women's Day observed under the Taliban-led government in Afghanistan, which swept back to power in August 2021, and more or less marked a year-and-a-half of increasing misery for Afghan

In a statement to mark the International Women's Day, the head of the UN mission in Afghanistan, RozaOtunbayeva said it has been distressing to witness the Taliban's methodical, deliberate, and systematic efforts to push Afghan women and girls out of the public sphere.

The UN mission said the crackdown was a "colossal act of national self-harm" at a time when Afghanistan faces some of the world's largest humanitarian and economic crises.

The anti-women Taliban decisions have faced international condemnation, including by some Muslim countries even. The State of Qatar, earlier this week expressed deep concern over the Afghan caretaker government's decisions which negatively affect Afghan women and girls' rights, especially suspending their studies in secondary schools and universities and banning their work in non-governmental organisations.

The Qatari condemnation was conveyed in a statement delivered by the Permanent Representative of the State of Qatar to the United Nations Office in Geneva, HE Dr. Hind Abdul Rahman Al Muftah dur-



ing an interactive dialogue with the Special Rapporteur on the situation of human rights in Afghanistan, within the framework of the 52nd regular session of the Human Rights

The deputy foreign minister of Turkiye, Mehmet Kemal Bozay, has said that the international community must not allow the situation in Afghanistan to deteriorate "even further." The Secretary General of the Organisation of the Islamic Cooperation (OIC), Hissein Brahim Taha, spoke in Geneva and, reiterated the OIC's condemnation of Kabul's edicts banning women from education and work, saying: "It is against our religion."

Anti-women diktats

The biggest crackdown on teenage girls and university students came just days before Women's Day, when earlier this week the authorities banned them from secondary schools and higher educational institutions. No country has officially recognised the Taliban government as Afghanistan's legitimate ruler, with the right to education for women a sticking point in negotiations over aid and recognition.

According to UNESCO, currently, 80 percent of school-aged Afghan girls and young women - totalling 2.5 million people - are out of school.The Taliban's decision to keep girls' schools shuttered has reversed significant gains in female

education during the past 20 years. In another anti-women diktat, Taliban government has annulled divorce in Afghanistan, forcing divorced women to go back to abusive husbands. Lawyers say that several women have reported being dragged back into abusive marriages after Taliban commanders annulled their divorces.

Latest international efforts

UN deputy spokesman Farhan Haq said last Friday that a delegation headed by UN Deputy Secretary General Amina Mohammed to Afghanistan recently, found that some Taliban officials were more open to restoring women's rights, but others were clearly opposed.

Mohammed, a former Nigerian Cabinet minister is the UN's highest-ranking woman, she was joined on the trip by Sima Bahous, executive director of UN Women, which promotes gender equality and women's rights, and Assistant Secretary General for political affairs Khaled Khiari.

The UN team met with the Taliban administration in the capital Kabul and talks focused on the restrictive measures the Taliban government has imposed on women and girls since they re-took power.

The UN has stressed that Afghan women are crucial to delivering humanitarian help to civilians, the majority of them women and children.

The Taliban government adheres to an austere interpretation of Islam and has imposed severe restrictions on women's lives that the United Nations called "gender-based apartheid".

Notably, the Ministry of Women's Affairs and the Human Rights Commission in Afghanistan have been erased under the Taliban regime.

According to the UN Mission in the country, nine out of 10 women in Afghanistan experience physical, sexual or psychological violence from their partner. Divorce, however, is far greater a taboo than the abuse itself and women who part with their husbands sustain many atrocities at the hands of society.

The United Nations' special representative for women in Afghanistan, Alison Davidian said the implications of the government's policies "impact all Afghans and will resonate throughout generations". Meanwhile, a prominent group of Afghan and Iranian women are backing a campaign calling for gender apartheid to be recognised as a crime under international law.

The campaign, launched on International Women's Day, reflects a belief that the current laws covering discrimination against women do not capture the systematic nature of the policies imposed in Afghanistan and Iran to

the status of women in society.

The authors of the open letter.

The authors of the open letter, including international lawyers, argue that the legal definition of apartheid as a crime against humanity, adopted by the UN in 1973 and supported by the 1998 Rome Statute, does not fit the case of Afghanistan and Iran, even if the descriptive term does.

Taliban Mindset

Initially, when the Taliban 2.0 took over power in Afghanistan in August 2021, there was some euphoria that now they might be a changed Taliban, looking forward to mend their earlier ways and chart a new course of development for their country.

However, starting with their first diktat in September 2021, urging for segregated classrooms for boys and girls at schools, the caretaker Taliban government has followed it up with a slew of anti-women measures.

What perplexes one is that though the Taliban describe most of these decisions as Islamic, in fact they are completely unIslamic. Islam gives equal rights to men and women in all spheres of life, including, education, inheritance, right to work, say in marriage. Yet, in action Taliban goes completely against the spirit and teachings of Islam.

Instead, if they had adopted a new pragmatic and forward looking approach towards reorganising the Afghan society, it would have gone in their favour and would have helped them to consolidate their power in the country. As currently there seems to be no political force in the country, which could counter the Taliban. In addition, it would have provided them legitimacy and support from the so-called Islamic countries, if only they would have chosen to uphold the Islamic teachings, which in reality, they have failed to do.

UK CUTS DIPLOMATIC JOBS IN COUNTRIES LIKE INDIA, PAKISTAN, CHINA: REPORT

Pritish-based diplomatic posts for key Indo-Pacific countries like India, Pakistan and China have been cut by up to 50 per cent in recent years, according to new government figures.

Despite being identified as key places to deepen ties with over the coming decade, staff members of embassies and consulates in Pakistan, China and India have all been diminishing over the last seven years, the Guardian reported.

According to the report, the number of British-based Foreign Office staff was between 110 and 119 in the Pakistan embassy and consulate.

This fell to 50-59, a cut equivalent to about 50 per cent.

Over the same timeframe, the number of British-based Foreign Office staff was cut from 70-79 to 40-49 in the past seven years in India.



The figures shared by the Guardian came from the Foreign Office minister David Rutley, in response to written parliamentary questions by the Labour frontbencher Catherine West.

The figures also showed a reduction in the number of trips by ministers to these countries.

The Foreign Office and international development department conduct-

ed 37 ministerial trips to the Indo-Pacific region in 2018, with some countries being visited more than once a year.

However, by 2022, the number of ministerial trips conducted was less than a third of that, with just 12 recorded, the Guardian reported.

A Foreign Office spokesperson told the Guardian that these numbers do not give an "accurate picture" of Britain's presence in the Indo-Pacific

The reduction in headcount of UKbased staff in China and India is partly due to Covid and how the UK spends its overseas development budget, the Guardian was told.

Citing evidence of the UK's growing influence in the region, the spokesperson told the Guardian that there was a boost of 16.4 per cent in trade with the Indo-Pacific year-on-year from autumn 2021 to 2022.

N.Korea fired 2 'strategic cruise missiles' from submarine

orth Korea fired two "strategic cruise missiles" from a submarine in waters off its east coast over the weekend, the country's state media said on Monday.

The North's first known firing of cruise missiles from a submarine is widely viewed as an apparent show of force against a major South Korea-US combined military exercise, reports Yonhap News Agency.

The missiles were fired from the 8.24 Yongung in waters off Kyongpho Bay in the East Sea in an underwater launching drill held at dawn on Sunday, according to the North's official Korean Central News Agency (KCNA).

"The drill confirmed the reliability of the weapon system and examined the underwater-to-surface offensive operations of submarine units that constitute one of other major forces of the DPRK nuclear deterrent," the KCNA said in a report, using the acronym of the North's official name

the North's official name.

The missiles precisely hit preset targets in the East Sea after "travelling the 1,500 kmlong eight-shaped flight orbits for 7,563 to



7,575 seconds".

The latest launch came on the eve of the start of the allies' 11-day Freedom Shield exercise, which the North calls "preparations for a war of aggression" against it.

North Korea said its latest underwater launching drill "verified the current operation posture of the nuclear war deterrence means in different spaces".

Earlier in the day, South Korea's Joint Chiefs of Staff (JCS) said it detected an unspecified missile launched from a submarine in waters off the North's eastern coastal city of Sinpo on Sunday morning. It did not immediately provide other details.

22 KILLED AFTER MIGRANT BOAT CAPSIZES OFF MADAGASCAR

Antananarivo: At least 22 people have been killed after a boat carrying migrants capsized off the coast of Madagascar, the East Africa nation's port authority said.

The boat carrying a total of 47 people capsized on Saturday due to an accident in the seas off the coast of Madagascar, the Maritime and River Port Agency said in a statement late Sunday.

Twenty-three of them on board were saved, and operations to rescue the missing were still ongoing, Xinhua news agency quoted the authorities as say-

The boat was on its way to the French overseas island of Mayotte, according to the statement.

Flood water inundates Australian state with crocodiles lurking underneath

Brisbane Agencies

Tith major flooding still occurring in Burketown and the Gregory River, the police force in the Australian state of Queensland on Monday reminded residents to limit movement in floodwaters due to unseen hazards and recent crocodile sightings.

"Police rescued a baby kangaroo from floodwaters behind a residential community in Burketown yesterday. A helicopter pilot flew over at the time and spotted two very large crocs nearby, a timely reminder to stay out of floodwaters as you never know what is lurking beneath," Queensland Police Service warned on social media.

In an update on the severe weather event affecting northwestern Queensland, the state police said sewage and water treatment plants in Burketown are now offline, with residents instructed to conserve water usage and continue to monitor advice



from local councils.

As significant flooding is surging downstream of Urandangi to Roxborough Downs, police are closely monitoring the situation in Urandangi, with 16 people so far evacuated from the town in preparation for rising floodwaters.

According to the police, air assets are stationed nearby and on standby for emergency rescues and transport of food, water and medical supplies.

Days of heavy rainfall led to major to record-breaking floodings through parts of northwestern Queensland. "No observations are available for the Burketown Airstrip manual gauge. Based on anecdotal information from Burketown, the river level is expected to have peaked above the 2011 record flood level of 6.78 meters on Sunday," said the Australian Bureau of Meteorology (BOM).

"Major flooding is expected to be easing slowly on Monday. The river level along the Albert River at Burketown Airstrip is expected to continue easing slowly over the next few days, but is likely to remain above the major flood level (6.00 m) during Monday and Tuesday, possibly longer," the BOM added.

Burke Shire Mayor Ernie Camp told Australian Broadcasting Corporation (ABC) on Monday morning that up to 100 people had been evacuated from Burketown, with another 120 across the shire.

Camp noted that the water levels dropped about 400 mm.

"So hopefully, there won't be no any further rises and we'll keep it positive."

22 IS militants killed in operation in Iraq

Baghdad Agencies

A total of 22 Islamic State militants, including some of the group's leaders, were killed in an operation in Iraq's western province of Anbar, the Iraqi military said.

Lieutenant General Abdul Wahab al-Saadi, Head of the Iraqi Counter-Terrorism Service, said on Sunday at a press conference that the operation was carried out in two phases by an airborne force on a rugged area north of the town of Rutba, nearly 400 km west of the Iraqi capital Baghdad.


All the killed militants were wearing explosive belts, and senior leaders were among the dead, said al-Saadi without revealing the exact date for the beginning of the operation, confirming



that the operation is still underway, Xinhua news agency reported.

Over the past months, Iraqi security forces have conducted operations against extremist militants to crack down on their intensified activities.

The security situation in Iraq has been improving since the defeat of the IS in 2017. However, its remnants have since sneaked into urban centers, deserts, and rugged areas, carrying out frequent guerilla attacks against security forces and civilians.

ot impressed by the government's announcement of a Rs 300/quintal subsidy for distressed onion cultivators, thousands of farmers started their footmarch from Nashik to Mumbai on Monday afternoon in support of their various

The All India Kisan Sabha leader and seven-time ex-CPI(M) MLA Jiva Pandu Gavit said that after discussions with the various farmers groups, it was concluded that the Chief Minister Eknath Shinde's proposal is "not acceptable" and the 'long march' will continue as scheduled.

"We have asked for Rs 600/quintal as immediate relief when onions are being sold at one or two rupees, and Rs 2000/quintal MSP from the next season. The government has offered only Rs 300/quintal now and no word on the MSP," Gavit told IANS during the walkathon.

CPI(M) spokesperson P.S. Prasad said that the government's assurance of Rs 300/quintal is "no relief" to the crisis-hit farmers who are now throwing away or burning their produce.

For the third time in five years. thousands of farmers are again on the road to Mumbai for their various demands that remain pending since long, braving the intense summer heat. It has come after similar march-

es in 2018 and 2019 - and will traverse around 175 kms - attracting farmers from all over the state who converged in Nashik on Sunday.

Among the demands are an immediate subsidy of Rs 600/quintal and MSP of Rs 2000/quintal from next season for onion growers, writing off of farmers' loans, suitable remuneration for all agriculture produce, power bills waivers, quick compensation for crop losses due to unseasonal rains-hail, forest land rights, etc.

Led by Gavit, the participants include ASHA workers, and representatives of the unorganised sectors

who wend their way waving the party flags and placards with slogans 'Give MSP to Onion', etc.

"Besides the subsidy and MSP, we demand that there should be bulk export of onion, it should be procured in bulk from NAFED at the MSP," Gavit and other farmers leaders said.

The farmers have sought regularisation of encroachers on forest lands up to four hectares with names in the 7/12 documents, waiver of power bills and making electricity available 12 hours daily for farmlands, clear the 7/12 of farmers by waiving off their entire agriculture loans.

They have also demanded NDRF amount of compensation for all crop damages due to unseasonal rains and other natural calamities that hit the agriculturists round the year, quick compensation and curb the "loot" by crop insurance companies, create an independent system for regular inspection of milk meters and weighing forks for milk and a minimum price of Rs 47 for cow milk and Rs 67 for buffalo milk and stop the conspiracy to slash prices of soybean, cotton, tur and grams, re-start selling grain along with free rations on ration cards every month.

FOURTH TEST DREW; INDIA RETAINS BORDER-GAVASKAR TROPHY BY 2-1

Ahmedabad | Agencies

The fourth Test between India and Australia has ended in a draw at the Narendra Modi Stadium, with the hosts' winning the Border-Gavaskar Trophy series 2-1 and retaining the trophy at home.

With more than an hour left on the clock for the game to end, both teams called for the match to end, as it reached the inevitable result of draw, as India pocketed their 16th consecutive series win at home. Also, it is the fourth straight series between India and Australia that has ended at 2-1 scoreline.



India and Australia will meet again in the World Test Championship final at the Oval in England from June 7-11. India's spot was sealed after New Zealand beat Sri Lanka by two wickets in a thrilling last-ball finish at Hagley Oval. It was a Test match in Ahmedabad where the batters were dominant on a slow, flat pitch, completely opposite of the spin-friendly pitches in the first three Tests, which all ended in three days.

"It was fantastic. Right from the word goes. It was exciting, all the Test matches there was something in it for everyone to watch. We understand the importance of the series and definitely understand the importance of the opposition."

Post lunch, Head reached his fifty when he guided a delivery from Axar past slip for four to take Australia towards safety. Opener Travis Head fell ten runs short of his Test century while left-arm spin all-rounder Axar Patel claimed his 50th Test wicket as Australia reached 158/2 in 64 overs.

Bangladesh clinch historic series victory over England

Bangladesh has registered a landmark series victory over England in any format, beating the reigning Men's T20 World Cup champions by four wickets in the second T20 of the three-match series at Shere Bangla National Stadium.

Mehidy Hasan Miraz's impressive all-round show set up the stirring victory with 4/12 from four overs that helped dismiss England for 117, then added 20 valuable runs in the chase in Sunday's win.

Najmul Hossain Shanto scored an unbeaten 46* and Taskin Ahmed hit the winning runs with two fours in the penultimate over to steer Bangladesh to their target with four wickets and seven balls in hand, ending England's long run of success in this format, having won the T20 World Cup, and bilateral series against Australia and Pakistan last year.

The T20I series in Bangladesh is the first between the teams, with England coming out on top in their only other meeting in the format by eight wickets at the T20 World Cup 2021.

England has triumphed in all five ODI series against Bangladesh, including with two wins from the three 50-



over clashes between the teams earlier this month.

Bangladesh won their fifth-ever ODI against England in 25 attempts in their most recent meeting after half-centuries to Shanto, Mushfiqur Rahim and Shakib Al Hasan.

England has been even more dominant in red-ball matches, with victories in their first eight Tests against Bangladesh to open with a streak of four 2-0 series victories. Bangladesh won the first T20I in the series by six wickets and will be aiming for a clean sweep in the third and final clash in Mirpur on March 14.Miraz and Shanto were two of five players in the Bangladesh team to have played fewer than 20 T20Is, as they look to build a new group to compete at the


