39 INDIAN CITIES AMONG WORLD'S **50 MOST POLLUTED: REPORT**

Chad, Iraq, Pakistan, Bahrain, Bangladesh, Burkina Faso, Kuwait, India, Egypt and Tajikistan were the top 10 most polluted countries while Australia, Estonia, Finland, Grenada, Iceland, and New Zealand met the World Health Organization (WHO) PM2.5 guideline (annual average of 5 Aug/m3 or less). The data from 131 countries was taken from over 30,000 groundbased monitors, either government or non-government operated.

AS PER THE REPORT. AMONG THE SIX METRO CITIES, KOLKATA WAS RANKED THE MOST POLLUTED AFTER DELHI. HOWEVER, CHENNAI WAS STATED TO BE THE CLEANEST WITH POLLUTION 'JUST' 5X THE WHO'S SAFE LEVEL. THE METRO CITIES -- HYDERABAD AND BENGALURUA -- SAW POLLUTION LEVELS UPTICK OVER THE AVER-AGE SINCE 2017.

he Swiss firm IOAir in its 'World Air Quality Report' released on Tuesday ranked India the world's eighth most polluted country in 2022, dropping from fifth place the previous year. In the list of most polluted cities in the world, out of the 50 cities, 39 are in India.

As per the report, In India, the transportation sector causes 20-35 per cent of the PM2.5 pollution while



other sources of pollution are industrial units, coal-fired power plants and biomass burning. After the two top most-polluted cities, Lahore in Pakistan and Hotan in China, Rajasthan's Bhiwadi is in third place and Delhi ranked fourth.

Delhi's PM2.5 level is almost 20 times the safe limit, the report stated.

Delhi has so far been the most polluted capital in the world and the report made a distinction between 'greater' Delhi and New Delhi the capital. Both are in the top 10 and the infamous distinction of being the world's most polluted capital goes to

Chad's N'Djamena. National Capital's peripherals--

Noida, Ghaziabad, Gurugram and Faridabad have seen a decline in pollution levels. The report said that there is a 34 per cent decline in Gurugram to 21 per cent in Faridabad if compared to the average PM2.5 levels reported in previous years.

Delhi has seen a decline of eight per cent.The report said that worldwide, poor air quality accounts for 93 billion days lived with illness and over six million deaths each year.

"The total economic cost equates to over \$8 trillion dollars, surpassing 6.1 per cent of the global annual GDP. Exposure to air pollution causes and aggravates several health conditions which include, but are not limited to. asthma, cancer, lung illnesses, heart disease, and premature mortality," the report said. According to the report, 31 cities including 10 cities in Uttar Pradesh and seven in Harvana, have seen a steep percentage decline in pollution levels."A total of 38 cities and towns have seen a rise in pollution compared to an average of previous years," stated the report.

Shinde govt rattled as 1.8 mn govt employees strike for Old Pension Scheme

round 1.8 million Maharashtra government employees in various departments, schools, colleges, hospitals and other sectors on Tuesday started an indefinite strike to press for a return of the Old Pension Scheme.

Facing its biggest challenge, the 9-month old government of Chief Minister Eknath Shinde and Deputy CM Devendra Fadnavis has warned of action against the striking employees while offering an olive branch to discuss and consider their demand after taking into account the financial implications.

However, the striking unions are adamant and declared that they want an immediate announcement on OPS - which was discontinued in 2005.

"We are collecting the figures, but a majority of the state government employees across departments have joined the strike and will continue till we succeed," Government **Employees Unions Steering Committee** Convenor Vishwas Katkar told media persons. The OPS was replaced by a new pension scheme in which the pension amount was deducted from the employees' salaries, unlike the previous version.

Explaining the effect, Katkar said that in OPS, the employees use to get 50 per cent of the basic salary as pension, but in the new scheme, the amount is barely 25 per cent of the basic pay.

As the Class I and II employees are not part of the strike, there is only a partial impact on the normal working of various



departments. However, the strike has hit various government schools, colleges with teaching and non-teaching staff staying away, paramedics and nurses in hospitals, plus Class III and IV cadres remained off work.

The working was also affected in government offices in urban and rural centres and districts as a majority of the civic employees are also joining the agitation for OPS.

Nevertheless, in certain major cities like Mumbai, where the civic employees are keeping off the strike, the impact would be minimal, though they have expressed solidarity with their striking fraternity.

Chief Secretary M.K. Srivastava on Monday directed all Divisional Commissioners and Collectors to take appropriate measures to avoid any inconvenience to the common people.

Shinde said that the government will constitute an administrative committee of top officers to study the OPS demands and it would submit its report within a given timeframe, but the employees unions insist it should be accepted as a policy.

Denial of RTI to non-citizens would be against Indian Constitution: Delhi HC

he Delhi High Court has held that both Indian citizens and noncitizens have Right to Information (RTI), and to

restrict that to non-citizens would be against both the RTI Act and the Indian Constitution.

AS Rawat, a Public Information Officer (PIO) employed by the Central Tibetan Schools Administration (CTSA), was presenting a case in court contesting the Central Information Commission's (CIC) order slapping fine of Rs 2,500 on him.

Section 3 of the RTI Act, which states that "all citizens have the right to information," must be seen as a positive affirmation of the right in favour of citizens rather than as a restriction on non-citizens, a singlejudge bench of Justice Prathiba M.

She said: "Creating an absolute bar

(against non-citizens) would be contrary to the purpose and object of the RTI Act itself, and such an absolute bar cannot be read into the RTI Act.'

The court, nonetheless, made clear that the disclosure of information to non-citizens would depend on the kind of information sought and the recognition of the rights guaranteed to such class of persons under the Constitution of India.

The fine was imposed on Rawat because he withheld information from Dawa Tashi, a teacher who had asked for details on his confirmation letter and other advantages from the

Because Tashi was a Tibetan national, the information was rejected to him by Rawat.

150 DOG BITE CASES IN BIHAR'S MUZAFFARPUR IN PAST 24 HRS

Patna: Panic gripped Bihar's Muzaffarpur district after 150 cases of dog bites were reported in the past 24 hours, sources said here on

On Monday, while 100 victims rabies vaccines, Sri Krishna Medical College and Hospital

(SKMCH) received 50 patients. A long queue was witnessed in both the hospitals. The victims claimed that stepping out from their houses has become very risky as the dogs attack in packs. Majority of the victims are women and children. Some people carry batons to save themselves. According to an official of the district civil surgeon office, 4,000 doses of anti-rabies vaccines have been used in the last 13 days. He said that even those with no bites are also turning to the hospitals to take anti-rabies vaccine in advance. Meanwhile, the Municipal Corporation of Muzaffarpur has hired a team of experts to capture stray dogs in the district.

META CEO FIRES 10K MORE EMPLOYEES, SHUTS 5K ADDITIONAL OPEN ROLES

eta Founder and CEO Mark Zuckerberg on Tuesday announced to sack an additional 10,000 employees via several job cut rounds in the com months.In a Facebook post, Zuckerberg said overall, "we expect to reduce our team size by around 10,000 people and to close around 5,000 additional open roles that we haven't vet hired" in the company's "year of efficiency".In a separate filing with the US SEC, Meta said the new job cuts will lower the high end of its expense guidance for the year by \$3 billion.Over the next couple of months, organisation leaders will announce restructuring plans focused on flattening the organisations, cancelling lower priority projects, and reducing hiring rates."We will let recruiting team members know tomorrow whether



they're impacted. We expect to announce restructurings and layoffs in our tech groups in late April, and then our business groups in late May,' the Meta CEO said.In a small number of cases, it may take through the end of the year to complete these changes, he added."Our timelines for international teams will also look different, and local leaders will follow up with more details," said Zuckerberg.

The fresh cuts come just four months after he laid off 11,000 employees, or 13 per cent of the company, in November last year.

"Other relevant efficiency timelines include targeting this summer to complete our analysis from our ing so we can further refine our distributed work model. We also aim to have a steady stream of developer productivity enhancements and process improvements throughout the year," he added.

In its 'Year of Efficiency', Meta will make the organisation flatter by removing multiple layers of management."As part of this, we will ask many managers to become individual contributors. We'll also have individual contributors report into almost every level -not just the bottom -- so information flow between people doing the work and management will be faster,"

Zuckerberg noted.

ASIAN MARKETS FALL AMID SVB FALLOUT FEARS

sian stocks fell broadly on Tuesday, dragged down by banking shares, as fears over the fallout of Silicon Valley Bank's collapse gripped the market despite US government efforts to stabilize the financial system, media reports

Japan's Nikkei 225 tumbled 2.19 per cent to post its third straight day of declines. Hong Kong's Hang Seng briefly dropped 2.5 per cent, before trimming losses in the afternoon. Korea's Kospi lost almost 3 per cent. China's Shanghai Composite shed 0.65 per cent, CNN reported.

Banks were the hardest hit sector across the region, CNN reported.

HSBC Holdings plunged more than 5 per cent in Hong Kong after the banking giant pledged to inject 2 billion pounds (\$2.4 billion) of liquidity into SVB's UK unit,



which it had bought for 1 pound, Standard Chartered Bank sank nearly 7 per cent, CNN reported.

The sell-off happened despite extraordinary measures by US regulators over the weekend to avert a potential banking crisis following the collapse of SVB. The California-based lender fell with astounding speed on Friday, marking America's biggest bank shutdown since

Investors are now on edge over whether the demise of SVB could spark a broader banking sector meltdown. On Monday, US stocks were mixed, with banking shares taking a hit, CNN reported.

ONLY CLEAN-SHAVEN GROOMS CAN EXCHANGE **VOWS: RAJ COMMUNITY'S PECULIAR DECISION**

n what could be ascribed as a strange decision, a local committee organising mass marriage ceremonies in Rajasthan has taken a collective decision of allowing only clean-shaven grooms while those with long beard will be returned.

The decision was taken unanimously in the meeting called by Shri Kshatriya Kumawat Samuhik Vivah Samiti, which will be conducting a mass marriage ceremony on March 30. However, what makes news is the unique order issued by the committee members.

The officials of the committee have directed that only clean-shave grooms will be permitted to attend the marriage, and anyone with a beard will be sent

The meeting was held in Govindgarh where committee president Satyanarayan Mawar and secretary Chhoturam Mawal said that grooms are directed to come clean-shaven to promote Indian culture. Under western



influence, many grooms come for their wedding with long beards which look indecent. At times, their identity remains hidden and hence comes the

All committee members gave their consent to the order and accepted that only clean-shaven grooms will be permitted to exchange vows in marriage ceremony while others shall be returned.

PARLIAMENT ADJOURNED TILL WED AMID PROTESTS BY TREASURY BENCHES, OPPN

As soon as the lower House reconvened at 2 p.m., the ruling BJP members and opposition MPs began their noisy protests.

The BJP members sought Congress MP Rahul Gandhi's apology over his remarks on democracy during a speech which he delivered in London last week, while the opposition led by Congress, DMK, Left and TMC started shouting slogans, seeking JPC probe in the Adani issue.

The Congress MPs displayed placards showing some old remarks made by Prime Minister Narendra Modi. They stormed the well of the House with placards.

Amid chaos, the lower House was adjourned for the day to meet on Wednesday (March 15).

This is the second consecutive day when no business could be transacted in Lok Sabha, ever since the Parliament reconvened on Monday (March 13) after a month-long break.

The Secondary Education Board of Assam (SEBA) announced the cancellation of Monday's examination late Sunday night after the paper leak came to light.

After the Class 10 Board examination started in the state, several allegations have surfaced over the paper leak in other subjects.

Himachal Governor aims to make state free from drugs

imachal Pradesh Governor Shiv Pratap Shukla on Tuesday said it would be his priority to make the state free from drugs and appealed to the people to cooperate at every level so that "we can save the youth from falling prey to

Presiding over a meeting of senior officers of the Police Department held at Raj Bhavan here on drug abuse and illegal trafficking, he was categorically clear in saying that the Panchayati Raj and educational institutions, nongovernmental organisations, community-based organisations, research institutes, experts and common man can immensely contribute and play an important role in making the society drug-free.

He said the police force along with other social



organisations has a great responsibility to spread awareness amongst the masses. Besides, the issue could be discussed in length and measures to be adopted to tackle drug menace to be taken up with the civil and police authorities of the bordering states that will help routing this evil thoroughly.

Shukla said the issue was also part of discussion when he called upon Prime Minister Narendra Modi after becoming the Governor of Himachal Pradesh.

A planned strategy has to be chalked out to fight this

social evil. He expressed contentment that the police department is doing its job well to capture illegal drugs in day-to-day checkpoints and is also spreading awareness in society about drug abuse and its consequences.

Shukla said Himachal Pradesh is also known for its tourism potential thereby adding to its economy but under the pretext of tourism 'we won't allow free flow of drugs in the state".

"The illegal drug trade is now spreading like an organised crime and the police needs to be more vigilant to capture the kingpins of this organised crime and to conduct sudden checks at state barriers.'

A bench of Justice Satish Chandra Sharma and Justice Subramonium Prasad was hearing a PIL filed by Jasmine Kaur Chhabra seeking direction to construct separate washrooms for the third gender on the ground that the absence of such public toilets makes them prone to sexual assault and harassment.

The court noted that the city government's status report stated that the process of construction was stated to be underway and no public toilets have been built for the transgender population.

During the visit of PM Narendra Modi to Karnataka to dedicate Bengaluru-Mysuru Expressway, Praveen Sood has allowed distortion of history by allowing an entrance to be named after Nanje Gowda and Uri Gowda, A case should be lodged against him and he has to be arrested," Shivakumar said.

"This DGP is a nalayak (useless). He had heeded the demands of the government. Immediately, a case should be registered against him. The Election Commission should transfer him to a different place. He was there in the post for three years. Why is he still there?" he asked.



Addressing reporters before attending the Convention of Tigala community members, Shivakumar stated he thought the DGP was impartial and a good man. "But he is working as a stooge of the BJP party. How can he allow such an entrance?

he said.

"BJP is always trying to distort history from the beginning. They have not spared Kuvempu, Basavanna, Narayana Guru, Ambedkar, Balagangadhanatha swamiji and Shivakumar swamiji. Now, they have taken up the names of Uri Gowda and Nanje Gowda. Where is their history? Their names have been created and BJP is hatching a conspiracy to betray the Vokkaliga community," he

"Their (Uri Gowda and Nanje Gowda) names have been created and the Vokkaliga community has been insulted. I don't want to discuss now about Srirangapatna and Sringeri, where there is a different history," he said, accusing the BJP of sowing seeds of poison between communities before election".

The ceremony was

presided over by the Special Commissioner of Police, Sanjay Singh and Pragya Misra from Truecaller India at Police Headquarters. The MoU was signed and exchanged among the Deputy Commissioner of Police, Suman Nalwa and Misra. As per the MoU, the Truecaller will display official numbers of Delhi Police representatives on their Delhi Police Directory Services and all verified numbers will have a green badge and a blue tick mark, with a government





services tag highlighting it.

"The partnership with Truecaller will help the public in identifying verified numbers and protect them from cyber fraud and impersonation scams in the name of government officials," said Nalwa.

"Delhi Police shall also be regularly sharing a list of phone numbers against which they have received complaints about harassment, scam or issues registered against them with Truecaller to mark them as spam or fraud on the platform to protect citizens and

alert them in case these numbers continue to remain active. To thwart cyber threats, Truecaller, in association with Delhi Police, will generate cyber safety awareness by training citizens in Delhi," said Nalwa

During the function, the Special CP, Singh recalled how the quick response by Delhi Police helped in curbing increasing cyber crimes.

He further said that it has become imperative to spread cyber awareness as more and more people are adopting digital means these days.

TERRORIST ARRESTED IN J&K'S SOPORE

AAP seeks CBI probe into multi-crore parking scam in Chandigarh

Titting out at Bharatiya Janata Party (BJP) Mayor Anoop Gupta for "rampant corruption" in the Chandigarh Municipal Corporation, the Aam Aadmi Party (AAP) on Tuesday sought a CBI inquiry into the multicrore parking scam "to unearth the involvement of senior BJP leaders and top officials".

AAP's Punjab chief spokesperson Malvinder Singh Kang, along with party leaders Pardeep Chhabra and Damanpreet Singh, lashed out at Chandigarh Administrator Banwarilal Purohit and BJP leaders for ignoring the irregularities and corruption in the BJPruled civic body.

Accusing Purohit of dancing at the tunes of the BJP, Kang asked why he has turned a blind eye towards rampant corruption in the municipal corporation and is patronising BJP leaders in



Chandigarh.

Contrary to this, he interfered in the day-to-day affairs of the Punjab government to hamper the progress of the state, he added.

Raising questions over the municipal corporation and police for not disclosing arrest of Sanjay Sharma, Director, Pashchatya Entertainment Pvt Ltd, for three days in connection with submitting fake bank guarantees of Rs 1.65 crore for running 57 paid parking lots in Chandigarh, Chhabra said something is fishy in this entire case and alleged that

the BJP is trying to save their leaders and officials involved in this scam. He said Chandigarh parking is worth Rs 4-5 crore. He said it was not the first case of corruption but earlier, firm Arya toll and Selvel Company had cheated the corporation of several millions in collusion with the officials but no action was taken against them as well.

Leader of Opposition in Chandigarh corporation, Damanpreet Singh, said all AAP councilors have also submitted a memorandum to the Mayor to seek a special house session for a thorough discussion on the issue of corruption.

He said the municipal corporation is mired in controversy of corruption and fraud is committed by the paid parking contractors, while there is audio of water meter readers claiming giving bribes to SDEs and JEs, fake issue of employment letters, irregularities by Lions Company and complaints against the outsourcing

Man chained to tree and thrashed, found dead later, cops suspect suicide

olice are investigating the death of a man in Madhya Pradesh's Chatarpur days after he was chained to a tree and allegedly thrashed because his son married a woman from the same village.

Udha Ahirwar's wife Savitri has alleged that her daughter-in-law's relatives forcibly entered their home and killed him. Police. however, have said the man was upset over the humiliation of the public assault and died by suicide on March 4.

Six accused have been charged with abetment to suicide and wrongful restraint, and police are looking for them. Police said Udha Ahirwar's son Shankar and a woman from the same village work as labourers in Rajasthan. The two reportedly married there. Both families are from the same caste. But the woman's father was infuriated when he heard of the wedding. It is alleged that he and five others took Udha Ahirwar to another village Panchampur, chained him to a tree there and thrashed him.

A video shows Ahirwar sitting near the



tree, his hands and feet chained. He was eventually freed and returned home. Two days later, he was found hanging in his room.

His wife has alleged that the assailants barged into their home when Ahirwar was alone, killed him and hanged his body. Police, however, have denied this charge and said the man appears to have died by suicide. Further probe into the horrifying incident is

Congress MLAs stage walkout against BBC censure motion in MP Assembly

Congress MLAs on March 14 walked out opposing a censure motion that the Madhya Pradesh Assembly passed against the BBC for allegedly showing Prime Minister Narendra Modi in a bad light in its documentary on the 2002 Gujarat riots.

he House on March 13 passed the censure motion against the British Broadcasting Corporation (BBC) after it was introduced as a private member resolution. It came days after the Gujarat Assembly passed a resolution requesting the Centre to take strict action against BBC for "tarnishing the image and popularity of PM Modi".

As the house convened on March 14, Leader of Opposition Dr. Govind Singh quoted news articles saying it was reported that the censure motion was approved "unanimously" by the House, though the Congress had not supported it.

It is incorrect to say that the motion was approved unanimously as it was brought during "Zero Hour' without prior notice, Singh said. Also, the motion was not brought before the House business committee for discussion, which he said was against democratic norms The Opposition leader

said that the Congress legislature party was opposing this censure motion. Minister for Parliamentary Affairs Narottam Mishra, however, countered the charge saying most of the Congress MLAs, except for the party's State chief Kamal Nath, were present when the motion against BBC was passed in the House. "But

the Leader of Opposition didn't speak then," he said. Dr. Singh claimed that he

had opposed the censure motion at the time but it was not recorded. Some Congress MLAs, including Sajjan Singh Verma, also started speaking about the resolution related to the BBC documentary With several members

speaking together, the Leader of the Opposition announced that the Congress legislature party was staging a walkout against the motion. As the Congress members walked out, Speaker Girish Gautam clarified that the censure motion against BBC was passed with a voice vote and not "unanimously".

"BETRAYAL, AGAIN": BHOPAL GAS TRAGEDY SURVIVORS ON SUPREME COURT ORDER

ours after the Supreme Court turned down the centre's plea for more compensation in the Bhopal Gas Tragedy case, those who lost their own in the disaster termed the verdict a "betrayal".

Over a lakh people were affected by the poisonous gas leak at the Union Carbide plant on December 2, 1984, widely considered the worst industrial disaster ever. Estimates of death range from 5,000 to as high as

Rashida Bi lost seven members of her family in the tragedy. Speaking to NDTV at her Bhopal home, she said they continue to face health effects caused due to the gas leak. "The health problems continue. My brother was hospitalised today. The court's verdict is injustice," she said.

The Bhopal victims, she alleged, were denied their day in court because of the "pro-corporate bias" of the bench. "The counsel for Union Carbide was given ample time to speak, but the lawyer for the survivors' organisations was heard for just 45 minutes," she added.

The centre had sought an additional compensation of Rs 7,844 crore from successor firms of Union



Carbide. A compensation of Rs 715 crore was paid back in 1989. The centre had argued that the scale of damage to human lives and the environment could not be assessed properly

at the time of the settlement. The court, however, said the centre

had not provided any rationale for raking up the issue now. The successor firms of Union Carbide, represented by senior advocate Harish Salve, had told the court that depreciation of the rupee since 1989 cannot be a ground to seek a "top-up" of

compensation now

Shehzadi, another survivor of the tragedy, said, "There was a betrayal in 1989. This is again a betrayal.

Balkrishna Namdeo, president of an organisation voicing the demands of the survivors, questioned how the court can "draw the curtain" when those affected in the gas leak disaster continue to die and suffer.

"How can you impose finality when the corporation's crimes continue to victimise people? When people continue to die untimely deaths from cancers and other chronic diseases induced by their exposure to the poisonous gas?" he asked.

"When the criminal remains absconding and the suffering of the victims, including that of their children, continues, how can a Supreme Court bench draw the curtain over the injustice in Bhopal?" Namdeo asked. The then Union Carbide chairman Warren Anderson was prime accused in the case, but did not appear for the trial. A Bhopal court declared him an absconder in 1992. Two non-bailable warrants were issued before his death in 2014.

FACE OF GENDER INEQUALITY: UN CHIEF

N Secretary-General Antonio Guterres has warned that the gender digital divide is fast becoming the new face of gender inequality.

Women and girls now face a new source of discrimination and bias: digital technology. Today's digital technology often uses algorithms designed by a male-dominated tech industry, based on male-dominated data, he said on Monday.

Rather than presenting facts and addressing bias, technology based on incomplete data and badly designed algorithms is digitising and amplifying sexism -- with deadly consequences, he warned.

Medical decisions based on data essentially from men can damage women's health. Safety features based on men's bodies can put women's lives at risk. And policies



based on men's data will leave women and girls even farther behind, he told a townhall meeting with civil society at the 67th session of the Commission on the Status of Women, Xinhua news agency reported.

Artificial intelligence will be shaping the world of the future. Without

women's equal input, it will continue aging stereotypes prevent women gender digital divide is fast becoming the new face of gender inequality."

Rather than uplifting women and girls by providing access to education, healthcare and financial services, technology is often used to harm and control them through surveillance and trafficking, Guterres said.

Online spaces are not safe for women and girls. Gender-based violence online has increased exponentially. Organised campaigns target women politicians, journalists and activists -- a direct attack on women's representation and on democracy itself. So-called influencers denigrate women and feed misogyny and toxic forms of masculinity to millions of young men and boys. Groups that campaign against women's rights find a warm welcome on digital platforms,

Centuries of patriarchy and dam-

tion they deserve. Those same stereotypes push girls away from studying science, engineering, and math, and strangle the careers of women scientists. Women are credited less for their achievements, win far fewer prizes, and receive less research funding than men, even when they have the same conditions. Just two per cent of venture capital investment

goes to start-ups founded by women,

he said. "This must change." The male chauvinist domination of new technologies is undoing decades of progress on women's rights. Gender equality is a question of power. For more than 100 years, that power was gradually becoming more inclusive. Technology is now reversing that trend. It is concentrating power again more in the hands of men -- to the detriment of all, said

REPORTED HATE **CRIME INCIDENTS INCREASE IN US: FBI**

Washington: The Federal Bureau of Investigation (FBI) said in its updated data that 10,840 hate crime incidents and 12.411 related offences were reported in in the US 2021, up 11.6 per cent.

Nearly two-thirds of the victims were targeted because of the offenders' race, ethnicity, or ancestry bias, Xinhua news agency reported citing the data.

While 15.9 per cent were targeted because of the offenders' sexual-orientation bias, 14.1 per cent were targeted because of the offenders' religious bias.

And there were 310 multiplebias hate crime incidents that involved 411 victims, the data showed.

Of the 8,327 hate crime offences classified as crimes against persons in the updated 2021 dataset, 43.2 per cent were intimidation, 35.5 per cent were simple assault, and 20.1 per cent were aggravated assault.

Japan approves bill to raise age of consent

apan's Cabinet on Tuesday approved a bill to amend the country's Penal Code regarding the age of sexual consent and a range of sexual offence charges

According to the bill aimed to be passed during the current parliamentary session, the age of sexual consent in Japan will be raised from 13 to 16, reports Xinhua news agency.

Sex with children under the age of 16 will be criminalised by raising the legal age of consent, with Japan having long been under pressure from child consultation centres here which deal with abuse, as well as international human rights organisations, for the legal age of consent to be raised.

The age of sexual consent in Japan has not been legally raised from 13 since its enactment in 1907.

The age of consent in this country has been one of the



lowest in the industrialised

world for many decades. The amendment to the current law will make having sex with a child under 16 illegal, regardless of whether the act was consensual.

In 2017, Japan, inexplicably, according to welfare and counseling centres dealing with the issue, as well as a host of

lawyers and legal institutions, renamed the crime of "rape" to

"forcible sexual intercourse". The new amendments, however, will see this redressed. and criminal recognition will be given to an act of sexual violation, even when coercion or physical violence is not used.

The sexual offences charges being renamed in the amendments will better clarify nonconsensual sex as being illegal.

In addition, the statute of limitations for prosecution for non-consensual intercourse will be extended to 15 years from 10 years under the amendment, and extended from 15 years to 20 for cases of indecent assault that result in

Under the amendments, the statute of limitations will not begin for a victim under the age of 18 when assaulted, until they turn 18.

Other sexually deviant acts will also be criminalised, such as taking sexually explicit photographs without consent and producing illicit images without permission, as part of reforms to the country's Penal

Cyclone Freddy kills 99 in Malawi, rescue mission underway

Lilongwe Agencies

t least 99 people have been killed in Malawi after tropical cyclone Freddy lashed the east African nation, authorities said on Tuesday, adding that a rescue mission is currently underway.

Confirming the toll to reporters late Monday, Commissioner for the Department of Disaster and Management Affairs (DoDMA) Charles Kalemba said that 85 fatalities were recorded in the commercial city of Blantyre alone, reports Xinhua news agency.

Kalemba said Blantyre has recorded 134 serious injuries while several other injuries and loss of property have been recorded across the 10 districts that have been heavily

affected by the cyclone. The deaths were caused due to the collapse of residential houses, flash floods, and landslides in the affected districts including Blantyre where one of the mountains, Soche, broke loose releasing a huge flow of water, heavy rocks, and mud that swept a number of homes and buried residents in the process.

The cyclone has also destroyed power generation infrastructure, leaving almost the entire country in blackout since Monday morning.

Chakwera has declared a state of


emergency in the 10 districts that have been heavily affected in the southern region. Freddy is the strongest tropical cyclone on record and could also be the long-lasting one, according to

the World Meteorological Organization. On Sunday, it struck Mozambique as a cyclone -- for the second time in a less than a month after battering the island nation of Madagascar in

the Indian Ocean, causing severe destruction. It has been difficult to determine the extent of the damage caused in Mozambique and the number of deaths as power supply and phone signals were cut off in some parts of

"We shall bring in a law that would provide for three months in jail and a fine of Rs 10,000, or both," Cultural Affairs Minister Sudhir Mungantiwar said in the legislature on Monday.

He said that his ministry would hold discussions with the Law & Judiciary and Home ministries in this context.

Besides, Mungantiwar warned that visitors to these forts who are found spoiling the premises or polluting the local environment would also attract action by way of hefty fines.

We shall implement various activities to maintain the sanctity and cleanliness of all these forts. Punitive action will be taken against those who desecrate the sanctity of these heritage monuments. Rewards will also be offered to the informers who can provide inputs about those who

sully these historical structures in any manner," Mungantiwar said. Maharashtra has around 450

recorded forts around the state comprising imposing hillforts, awesome sea-forts, in urban or rural centres, river-sides or forests, etc. dotting almost every district.

Constructed by various Indian or foreign rulers of different dynasties, some of these forts are said to date back to over six centuries, and although many are in ruins, some are still in an excellent condition.

Lakhs of tourists from the state

and outside throng several of the popular forts that fall in the regular tourism circuits of Mumbai, Pune, Chhatrapati

Sambhajinagar, Nashik, Thane, Raigad, Ratnagiri, Sindhudurg, Satara, Kolhapur, Nagpur, etc.

Though jokes about the moment were very present, Molly McNearney, an executive producer of this year's show and Kimmel's wife, explained why her husband did not go "hard-



IOC: MAJORITY IN FRANCE WELCOME RUSSIAN, BELARUSIAN **OLYMPIANS TO PARIS 2024 AS NEUTRAL ATHLETES**

he International Olympic Committee (IOC) said that an online survey shows the majority of the French people are in support of the Olympians with a Russian or Belarusian passport to compete as neutral athletes at Paris 2024.

Conducted by research company Odoxa, the survey included responses from 1,005 French people aged 18 and over, reports Xinhua.

"The poll found that 72 percent of the French people are in support of the participation of athletes with a Russian or Belarusian passport, with 44 percent suggesting they should be at the Games under a neutral banner, without the use of flags, anthem, colors or any kind of identification of their country," IOC wrote on its website on Monday.

According to IOC, Russian and Belarusian athletes have been competing in a number of international sports over the past weeks and months as neutral athletes, but no discussions or decisions around the participation of athletes with a Russian or Belarusian passport at the Paris 2024 Olympic Games have been taken yet.Meanwhile, as the 500-day countdown to the opening ceremony



of Paris 2024 is around the corner, a total of 3.25 million tickets were sold in just the first three weeks of ticket

sales, with the second phase starting on March 15. The Paris 2024 Olympic Games will take place from July 26 to August 11, and the Paralympic Games will run

India became the capital of women's boxing: IBA president Kremlev

he International Boxing Association (IBA) president Umar Kremlev on Tuesday termed India as the capital of women's boxing as the country is all set for the biggest boxing event with the IBA Women's World Boxing Championships 2023, kickstarting on Wednesday at Indira Gandhi Sports Complex, here.

Hosted by the Boxing Federation of India (BFI), the prestigious tournament is taking place in India for the third time-the most for any country in the history of the championship. The previous two editions took place in 2006 and 2018 in New Delhi.

"India became the capital of women's boxing and now we are witnessing historical moments together. Generally, 250 to 260 boxers compete in such championships but this year it's a huge championship," Kremlev said while addressing the media during the press conference which was also attended by the BFI president Ajay Singh along with the Rio Olympics champion Estelle Mossely of



France and the reigning African champion Sara Haghighat-joo from Sierra Leone.

The upcoming 13th edition of the tournament will witness participation of more than 300 boxers form 65 countries competing for the title as well as the massive prize pool of INR 20 core

across 12 weight categories. "I think the fact that India is hosting the championship for the third time is testimony

accomplished that before turning 22 years old. In a flurry, Andreescu won that 2019 title here, then the Toronto 1000 and the US Open. She was 19 years old. Since then, dogged by a variety of injuries, it has been a slog. She's 6-6 for the year and looking for a spark. This match, despite the result, might have been the thing she was looking




