## IS YOUR COUGH, FEVER DUE TO H3N2 VIRUS OR COVID?

ACCORDING TO DATA FROM THE INDIAN COUNCIL OF MEDICAL RESEARCH (ICMR), THERE HAS BEEN A COMBINATION OF RESPIRATORY VIRUSES RANGING FROM COVID-19 VIRUS, SWINE FLU (H1N1), H3N2, AND THE SEASONAL VICTORIA AND YAMAGATA LINEAGES OF INFLUENZA B VIRUSES IN CIRCULATION.

H3N2 AND H3N1 ARE BOTH TYPES OF INFLUENZA A VIRUSES, COMMONLY KNOWN AS THE FLU. SOME OF THE MOST COMMON SYMPTOMS INCLUDE PROLONGED FEVER, COUGH, RUNNING NOSE, & BODY PAIN. BUT IN SEVERE CASES, PEOPLE MAY ALSO EXPERIENCE BREATHLESSNESS AND/OR WHEEZING.

IN ADDITION, COVID IS ALSO ON THE RISE. MORE THAN 700 COVID-19 CASES WERE RECORDED IN A DAY AFTER A GAP OF OVER FOUR MONTHS, TAKING THE ACTIVE CASELOAD TO 4,623, ACCORDING TO UNION HEALTH MINISTRY DATA UPDATED ON THURSDAY.

India is currently seeing a surge in respiratory illness commonly characterised by cough, body ache, fever, and sore throat. But how to know whether it is influenza, caused by H3N2 virus, or Covid, caused by Omicron sub-variants XBB.1.16 and XBB.1.5? Health experts note that it is very difficult to differentiate between the clinical manifestations of the three, and the differentiation is generally based on a laboratory diagnosis from a nasopharyngeal swab sample.

"The only difference is that in the present clinical scenario, Covid symptoms barely last for 2-3 days and the patient recovers soon without any hassles and any major treatment," Dr. Samrat Shah, Senior Consultant, Internal Medicine, Sir HN Reliance Foundation Hospital told correspondent.

"Whereas with H3N2 and H1N1 has more predilection for productive and wet coughs which lasts longer for a few weeks and has more chances of getting pneumonia or a secondary bacterial infection," Shah added.

Influenza is not fatal. But irrespective of the virus if there is a major comorbid factor there are more chances of morbidity and mortality. The risk is also high for young children, infants, adults with comorbidities, elderly people over the age of 65 years, patients who are pregnant, patients who are immunocompromised, etc.

The total number of deaths due to



H3N2 in the country has now reached nine, according to media reports. The Health Ministry, however, is yet to release the official death toll.

On the other hand, a total of 754 new Covid cases were reported in a span of 24 hours, while the death toll has increased to 5,30,790 with one fatality reported by Karnataka, as per the Health Ministry data updated at 8 a.m. on Thursday.

The doctors stated that coupled with the changing weather, pollution is also playing a pivotal role in multiplying the patient numbers impacted by viral infections.

The health experts advised people to follow Covid appropriate behaviours such as using masks, maintaining hand hygiene and avoiding crowded places. They also stressed on the need for an annual flu shot.

### ICMR APPROVES NEW RT-QPCR KIT TO DETECT INFLUENZA, SARS-COV-2 & RSV

Chennai: The Indian Council of Medical Research (ICMR) on Thursday approved a novel RT-qPCR test kit by Chennai-based KRIYA Medical technologies that can detect influenza (H1N1, H3N2, Yamagata and Victoria sublineages), Covid-19, and respiratory syncytial virus (RSV).

The approval of the kit marketed as KRIVIDA Trivirus comes even as several parts of the country are facing a significant rise in these viruses.

The three pathogens have similar initial symptoms but differ in how the illness progresses, how easily they spread, and how they are treated.

The KRIVIDA Trivirus effectively distinguishes influenza, SARS-CoV-2 and respiratory syncytial virus, within the shortest TAT (turnaround time), -- cycle time of 27 minutes, and the time taken for the result to be read can vary between 50-60 minutes. This can enable an immediate line of treatment, the company said in a statement.

The kit can also be used in all the available RT-PCR equipment.

The ICMR evaluated the kit at National Institute of Virology, Pune, using 225 known positive samples and 85 negative samples. The overall sensitivity of KRIVIDA Trivirus is 99.11 per cent and specificity is 100 per cent.

### CHANDRAYAAN-3 PASSES ISRO'S VIBRATION TESTS



Chennai: Indian space agency on Thursday said it had successfully completed the tests to check Chandrayaan-3 -- moon spacecraft -- to withstand the harsh vibration and acoustic environment that the spacecraft would face during its launch.

According to the Indian Space Research Organisation (ISRO), the tests were conducted during the first week of March 2023 at the test facilities located at the UR Rao Satellite Centre in Bengaluru.

These tests are an essential part of the qualification and acceptance process for any spacecraft.

These tests were particularly challenging, considering the fact that the Chandrayaan-3 spacecraft is a composite of three modules viz. Propulsion Module, Lander Module and the Rover module.

The vibration and acoustic tests carried out on the integrated spacecraft have provided sufficient confidence on the structural integrity and survivability in the launch environment, ISRO said.



### Haven't spoken against India, will speak in House if allowed: Rahul

At the centre of target of the government over his statement in London, Congress leader Rahul Gandhi on Thursday said that he will speak inside the House if allowed to and that he has not spoken anything which is anti-India. Gandhi was smiling when asked by the reporters in Parliament whether he will apologise for his UK speech. He said, "I haven't spoken anything anti-India," he said. Rahul Gandhi arrived in Parliament to attend the second part of the Budget Session for the first time after it started on March 13. Later in press conference, Gandhi said that he had met Lok Sabha Speaker Om Birla on Thursday, and as four ministers have spoken against him, so he has the right to speak in the house. "I am hopeful that I will be allowed to speak at the floor of the house as an MP, I have

responsibility to the parliament," he said, but added that he doubts that he will be allowed and this is the "test of democracy". "I spoke about Adani in parliament but it was expunged... the government and Prime Minister are fearful about Adani. This is distraction as the PM wants to avoid questions on the issue," he claimed. Parliament was adjourned for the day on Thursday amid ruckus by treasury and opposition members in both Houses. As soon as the Lok Sabha convened for the day at 11 a.m., opposition members rushed towards the Speaker's podium, shouting slogans and waving placards seeking a JPC probe in the Adani matter. Treasury benches, on their part, also were seen shouting slogans, demanding Gandhi's apology for his remarks during his speech in London last week, where he had said that democratic values were under threat in India.

### LEMON PRICES SOAR TO RS 200 PER KG



Noida: With the onset of summer, the price of lemon has hiked to Rs 200 per kg. The wholesale rate of lemons has been reported as Rs 150-160 per kg.

Vegetable vendors say that the price increases at the onset of summer due to the increase in demand and decrease in supply.

Mayan Rathore, a vegetable seller in Sector-12 of Noida, said that lemons dry up on trees due to the lack of proper irrigation and gradual increase in heat, which finally leads to reduction in their yield.

A hike in the prices of other vegetables is also expected.

### Army chopper crashes in Arunachal, two pilots dead

Two pilots who were missing after an Army chopper crashed in Arunachal Pradesh on Thursday have died, an official said. "With regret we inform that the pilot and the co-pilot of the helicopter lost their lives in the accident," Army PRO Lt. Col. Mahendra Rawat told reporter.

The deceased were identified as Lt. Col. VVB Reddy and Major Jayanth A.

Five search parties of the Indian Army, SSB and ITBP were immediately launched after the news of the crash emerged.

The wreckage of the helicopter was found



near Banglajapa village, near Bomdila. "A Court of Inquiry is being ordered to ascertain the cause of the accident," Rawat added. Meanwhile, army sources said that local villagers discovered that the crashed chopper caught fire and they informed the police. The visibility in the area was

very poor due to inclement weather, which may be the reason behind the crash. The Cheetah helicopter that was on an operational sortie was reported to have lost contact with the Air Traffic Control at 9.15 a.m. on Thursday morning.

### Sisodia is main accused in CBI's snooping case FIR

The Central Bureau of Investigation (CBI) has made former Delhi Deputy Chief Minister Manish Sisodia as the accused number one in the snooping case.

Apart from Sisodia, the CBI has booked Suresh Kumar Jain (IRS-1992), the then Secretary Vigilance; Rakesh Kumar Sinha (Retired DIG, CISE), working as Special Advisor to the CM; Pradeep Kumar Punj (Retired Jt. Deputy Director, IB); Satish Khetrpal (Retired Assistant Commandant, CISE); Gopal Mohan, Advisor Anti-corruption to the Chief Minister and others.

The FIR was lodged on March 14 under the



Prevention of Corruption Act read with several sections of Indian Penal Code (IPC).

The AAP wanted to create a Feedback Unit (FBU) in 2015. Suresh Jain, the Secretary (Vigilance) was

directed to submit a detailed proposal for setting up FBU.

It has been alleged that Jain deliberately and willfully avoided referring the matter of creation of 20 posts in FBU to the Administrative

Reforms Department. The CBI's preliminary inquiry established that a proposal was made by Jain, which was approved by Sisodia, that 20 posts in FBU be adjusted against 88 posts created in the Anti-Corruption Branch. These 88 posts were created in 2015. The proposal for the creation of these 88 posts had not been sent for approval to the competent authority.

The FBU didn't frame any Recruitment Rules to appoint people on the posts. Yet, 17 posts in FBU were filled up. And Rs 20,59,474 were sought for operationalization of FBU from the Finance Department.

The CBI's FIR said that bogus bills of lakhs of rupees were also raised by the accused persons.



### MALALI MOSQUE ROW RESURFACES AS VHP HOLDS YAGNA FOR 'DIVINE BLESSINGS'

The Malali mosque row in Karnataka's Dakshina Kannada district has surfaced again as Vishwa Hindu Parishad (VHP) activists on Thursday performed a special 'yagna' seeking divine blessing and intervention for a temple to come up.

The activists performed 'Maha Gana Yaga' or 'Ganapathy Homa' to pray for construction of a temple at the site of the mosque, as per the advice of tantris. When

the question was asked whether the temple will be constructed at the site of Malali mosque, tantris (foretellers) had advised that the work needs divine blessings.

As per the advice the VHP activists conducted the 'Maha Gana Yaga' at Ramanjaneya Bhajana Mandir at Malali town. BJP MLA from Mangaluru South Constituency Bharath Shetty was present.

A temple structure was found on April 21, 2022 during the renovation of Malali mosque, stirring a controversy. Following the controversy, the court had ordered the mosque management to stop the work.

### How can court reinstate a CM who didn't even face floor test and resigned: SC

The Supreme Court, after hearing submissions for nine days, on Thursday reserved its judgment on a batch of cross-petitions of Uddhav Thackeray and Eknath Shinde groups in connection with the Maharashtra political crisis. A five-judge constitution bench, headed by Chief Justice D.Y. Chandrachud and comprising Justices M.R. Shah, Krishna Murari, Hima Kohli and P.S. Narasimha, before reserving the verdict, shot a volley of questions at senior advocate Abhishek Manu Singhvi, representing the Thackeray group.

The Chief Justice asked Singhvi: "So, really the question is whether there was a valid exercise of power by the Governor to call for a trust vote? And what happens, if we come to a conclusion that there was no valid exercise of power by the Governor to call for a trust vote?" Singhvi said everything falls.



However, the bench that everything falls on would be simple but Singhvi stressed that is the core question and urged the court to allow him to present his case.

The Chief Justice further queried, "Then, according to you what, we reinstate the Uddhav Thackeray government? But you resigned." As Singhvi said Thackeray's resignation and not facing the trust vote is irrelevant,

the Chief Justice observed: "That is, the court being told to reinstate a government (which has resigned)." The Shinde group was represented by senior advocates Neeraj Kishan Kaul, Harish Salve, Mahesh Jethmalani and advocate Abhikal Pratap Singh. Solicitor General Tushar Mehta represented the office of the Governor in the matter. The hearing in the matter commenced on February 21.

### MVA to contest all future polls unitedly, no seat-sharing formula

Mumbai: Enthused by the winning formula in last month's Kasa Peth (Pune) by-polls, the opposition Maha Vikas Aghadi (MVA) have agreed in principle to contest all future elections -- civic, assembly and parliament -- unitedly, party officials said here on Thursday.

The decision came after a series of meetings held among the top leaders of Congress, Nationalist Congress Party and Shiv Sena (UBT) in the past few days.

The final seal came at a meeting of the MVA top brass and their district and state leaders held here on Wednesday night, with a call to go out and work in tandem before the elections.



# CONNECT PINJORE, KALKA, ZIRAKPUR WITH CHANDIGARH THROUGH METRO: HARYANA CM

Haryana Chief Minister Manohar Lal Khattar on Thursday said metro connectivity should be extended to Panchkula district's Pinjore and Kalka towns from Chandigarh and Zirakpur town in Punjab under the Comprehensive Mobility Plan (CMP).

These routes should be included in the first phase of the metro project, he said at a meeting of the Comprehensive Mobility Plan, chaired by Punjab Governor and UT Administrator, Banwarilal Purohit, here.

Punjab Tourism Minister Anmol Gagan Mann, Chandigarh Mayor Anup Gupta, Haryana Chief Secretary Sanjeev Kaushal, along with senior officers from Chandigarh and Punjab, were present at the meeting.

A detailed presentation on the comprehensive mobility plan for the tricity which includes Chandigarh, Panchkula and Mohali was given by officials of the Rail India Technical and Economic Services (RITES).

Various proposals for mass rapid transport system to tackle tricity's growing traffic congestion was



discussed.

During the meeting, the Chief Minister suggested that important places like PGIMER, the Punjab and Haryana High Court and Punjab and Haryana's

joint secretariats and Vidhan Sabha should also be added in the first phase of the metro.

"Pinjore and Kalka should be connected with Chandigarh under the metro plan as it the gateway of Himachal Pradesh and movement of a large number of people takes place towards Panchkula and Chandigarh on a daily basis. This will further strengthen the Panchkula-Chandigarh connectivity, ensuring smooth flow of traffic," Khattar said.

He also suggested that the airport connectivity to Panchkula should be considered under the plan. "The metro should aim to improve and facilitate airport connectivity. A timeline in this regard should be prepared and it should be included under the mobility plan," he added.

Besides, the Chief Minister also suggested that the area of the Ghaggar river and new Panchkula extension should also be included in the expansion of the metro.

# President Murmu arrives on two-day visit to Kerala

# Bhopal, Indore Police Commissioners to swap posts

The Madhya Pradesh government has shifted Bhopal and Indore Police Commissioners among 12 IPS officers reshuffled on Thursday.

As per an order issued by the state Home Department, Bhopal Police Commissioner Makarand Deouskar and Indore Police Commissioner Harinarayanchari Mishra will swap their positions.

This is the first time the police commissioners of both major cities of Madhya Pradesh were transferred after the police commissionerate system was introduced in Bhopal and Indore from January 1, 2021.

According to the Home Department order, senior IPS officer Irshad Wali, who has been serving as IG, Bhopal Rural, has been made IG, Hoshangabad range, ADG Yogesh Mudgal, posted at Police Headquarters Bhopal, has been made ADG, Technical Services, and G. Akhetto Sema has been made ADG, Jails.

Deepika Suri, IG, Hoshangabad zone, has been posted as IG, Administration at the Police Headquarters, while 2001 batch IPS officer Pramod Verma has been made IG, Sagar Zone, Abhay Singh has been made IG, Bhopal Rural, and Shushant Kumar Saxena the IG, Chambal Zone.

# LAND-FOR-JOB SCAM: CBI SUMMONS TEJASHWI FOR 4TH TIME ON MARCH 25

The Central Bureau of Investigation (CBI) on Thursday issued fourth summons to Bihar's Deputy Chief Minister Tejashwi Yadav in connection with the land-for-job scam.

He has been asked to appear before the probe agency on March 25.

Tejashwi has as of now skipped three summons. Before this, he was summoned to join the investigation on March 4, 11 and 14. Last time Tejashwi didn't join the probe after citing wife's health issues.

The probe agency had recently grilled former Bihar Chief Minister Rabri Devi and former Union Railway Minister Lalu Prasad in the case.

The CBI has alleged that during the investigation, it was found that "the accused in conspiracy with the then GM and CPO of the Central Railways engaged persons as substitutes in lieu of land either in their name or in the name



of close relatives of the Lalu family".

The CBI had registered a case against Lalu Yadav, the then Union Railway Minister, his wife Rabri Devi, two daughters and 15 others, including unknown public servants and private persons.

"During the period 2004-2009, Lalu had obtained pecuniary advantages in the form of transfer of landed property in the name of his family members in

lieu of appointment of substitutes in Group 'D' posts in different Zones of Railways," the official said.

A number of residents of Patna themselves or through their family members sold and gifted their land in favour of the family members of Lalu Prasad and a private company controlled by him and his family.

"No advertisement or any public notice was issued for such appointment of substitutes in Zonal Railways, yet the appointees, who were residents of Patna, were appointed as substitutes in different Zonal Railways located at Mumbai, Jabalpur, Kolkata, Jaipur and Hajipur.

"In continuation of this modus operandi, about 1,05,292 Sq. feet land, immovable properties situated at Patna were acquired by Yadav and his family members through five sales deeds and two gift deeds, showing the payment made to seller in cash in most of the land transfer," the CBI had said.

# CBI WON'T ARREST TEJASHWI YADAV THIS MONTH, SAYS DELHI HC

New Delhi: The Delhi High Court on Thursday noted that Central Bureau of Investigation (CBI) will not arrest Bihar Deputy Chief Minister Tejashwi Yadav this month in the alleged land-for-jobs scam case.

This development came a day after Tejashwi approached the High Court challenging the summons issued by the CBI asking him to appear for questioning in the case.

During Thursday's hearing, he told the court: "My wife is pregnant; I am a resident of Bihar, the (state) Budget Session is going on till April 5." Tejashwi's counsel contended that in 11 days his client had been summoned thrice -- February 28, March 4 and March 11. He further argued that their (CBI) endeavour is that when he comes to Delhi, they will arrest him. "They did this with another accused in the case," he argued. Representing the CBI, Advocate D.P. Singh argued that the Budget Sessions are not on Saturday and Sunday and that their charge sheet is ready to be filed this month. "I am saying on instructions, he will not be arrested, if he joins the investigation," Singh added. To this, Tejashwi's counsel told the court that he will appear after April 5. Justice Dinesh Kumar Sharma noted that the petitioner is a Deputy Chief Minister with four portfolios and that the CBI will not arrest him.

# Activist Sudha Verghese accused of trying to influence minor rape survivor in Bihar

Begusarai police briefly detained Padma Shri and social worker Sudha Verghese along with her six-member team in connection with allegedly influencing minor rape survivor.

The district police also deleted the recorded statement of the victim from their mobile phones and then released them.

Sudha Verghese along with her team members and Patna High Court lawyer Ashok Kumar went to Sadar hospital and met the victim. Awanti Kumari, the SHO of women police station of Begusarai said that Sudha and her team were influencing the rape victim to give wrong statement.

"We have deployed cops for the protection of the victim. When Sudha Verghese and her team reached the Sadar hospital and started taking her statement, they were asking the victim to give a video statement according to what they were instructing her. The cops present there objected to



the act of Sudha Verghese and informed the senior officers of Sahebpur Kamal police station of the district," Kumari said.

"A team of Sahebpur Kamal police station reached there and detained them. They handed it over to us. During the detention, they were involved in creating ruckus with police officials as well as local journalists," Kumari said.

Ashok Kumar, the lawyer of Patna High Court, who was also a part of the team of Sudha Verghese, said: "The local police detained us and took our mobile phones.

# ISRO'S LVM3 ROCKET TO LAUNCH ONEWEB'S 36 SATELLITES ON MARCH 26

Chennai: An Indian rocket LVM3 is scheduled to launch the 36 low earth orbit satellites of the UK-based Network Access Associated Ltd (OneWeb) on March 26 morning, the company said. The OneWeb is backed by India's telecom major Bharti Group and with the successful launch of the satellites on March 26, the company will complete the global footprint of its Gen 1 constellation.

OneWeb has 582 satellites now in orbit. On March 26 the total number is expected to go up to 618. By completing the constellation, OneWeb is taking a pivotal step forward in delivering global coverage including India, the company said.

According to OneWeb the second batch of 36 satellites will be launched by Indian Space Research Organisation's (ISRO) rocket LVM3 at 9 a.m. Indian time on March 26.

The upcoming launch will be the 18 one for OneWeb.

The first batch of 36 satellites was launched on October 23, 2022 from Sriharikota rocket port in Andhra Pradesh with the LVM3 rocket formerly known as Geosynchronous Satellite Launch Vehicle MkIII (GSLV MkIII). ISRO's commercial arm, NewSpace India Ltd (NSIL) has signed a contract with OneWeb to launch 72 satellites in two phases for a launch fee of over Rs 1,000 crore, OneWeb Chairman Sunil Bharti Mittal had said last October.



# Over 20 feared buried in cold storage collapse in UP district

A cold storage collapsed in Sambhal district on Thursday. More than 20 labourers are feared buried under the debris. According to reports, the incident took place in the cold storage of Mawai village in Chandausi.

Chief Minister Yogi Adityanath has directed the officers to reach the spot immediately along with teams of NDRF and SDRF. Officials have been asked to ensure proper treatment to the injured persons.

The local people, meanwhile, have already reached the village and are helping in the rescue operation. Reports claim that after the collapse

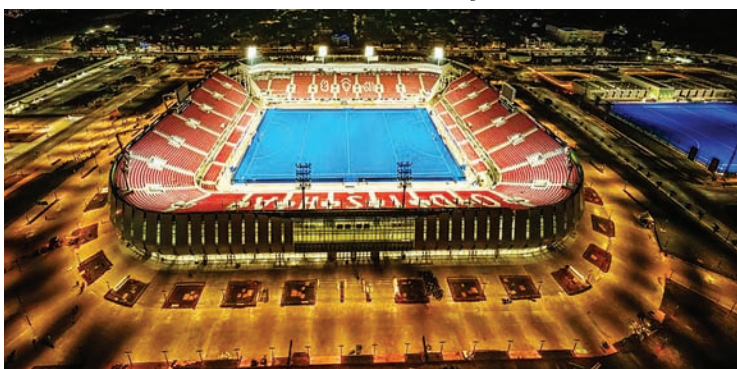


of the building, an ammonia gas leak has also been reported.

# 'Odisha spent Rs 261.76 cr in construction of Birsra Munda Hockey Stadium'

The Odisha government has made an expenditure of Rs 261.76 crore for construction of the Birsra Munda Hockey Stadium in Rourkela, sports minister Tusharkanti Behera told the state Assembly on Thursday.

In a written statement to a question of BJP legislator Subash Panigrahi, the minister said Rs 124.94 crore from state budget and Rs 136.82 crore from District Mineral Foundation (DMF) fund has been utilised for construction of the hockey stadium.

However, the ministry of youth affairs and sports has not allocated any fund for the project, he said. Behera further informed that the

work was done by State PSU Odisha Industrial Infrastructure Development Corporation (IDCO) within the deadline.

Birsra Munda Hockey Stadium has created Guinness Book of World Records as it is the world's largest fully seated hockey stadium.

The stadium, which is now a benchmark in hockey infrastructure, was built in a record 15 months and has a seating capacity of 20,011 with uninterrupted viewing experience for all.

Last Men's FIH Hockey World Cup was organised in the stadium along with Kalinga Stadium in Bhubaneswar in January this year. FIH Hockey Pro League was held in the Birsra Munda Hockey Stadium between March 10 and 15.

# DELHI POLICE BUST GANG OF CYBER CHEATS, ARREST 9

With the arrest of nine persons, Delhi Police on Thursday claimed to have busted a gang of cyber cheats who indulged in allegedly duping youths on the pretext of providing those jobs in private airlines.

The accused were identified as Manvendra Singh Rajawat, Vinit Singh Bhadauriya, Ajeet Singh Rajawat, Deepak Singh Chauhan, Surendra Pratap Singh, Rajat Sengar, Abhay Yadav, Satyam Singh and Shivam Singh Rajawat.

According to the police, a complaint from Burari resident Sumit Singh was received at the Cyber North police station via the National Cyber Crime Reporting Portal (NCRP) wherein.

The complainant alleged that he posted his resume on the Shine.com job portal and after a few days he received a call from a person posing to be a representative of IndiGo airlines, informing that he had been selected for a job. "Thereafter, he was made to speak with another person impersonating as an HR Manager and his tele-interview was conducted. After his interview, he was directed to deposit Rs 1,37,500 as fees for uniform, salary account activation, passport etc. Following this inducement, the complainant deposited the amount in a bank account provided by the accused," said Sagar Singh Kalsi, the Deputy Commissioner of Police (North).

After a while when the complainant persisted with the job offer, he was informed that due to some internal emergency, the company had stopped hiring and when he asked to return his money, the accused switched off his phone.

During investigation, the police team tasked with the probe zeroed in on the accused person's location at



Sector 49 Noida.

"Raids were conducted but the accused had left the premises just a day before the team reached there. However, after sustained technical analysis, their location traced at a flat in Nawada, Uttam Nagar. But on reaching there, it was found that they had already moved towards the Bundelkhand area of Uttar Pradesh," said the DCP. However on March 14, the police team managed to nab all nine accused from Faridabad.

On interrogation, the accused told the police that they came to Delhi in search of jobs. "It was revealed that absconding co-accused, Amir and Shivam, were already cheating people through the same modus operandi and had been earning quick money. This sudden increase in their financial status of lured Manvendra Singh and he started doing this fraud on a large scale," said the offi-

cial.

"Therefore, he along with the other accused hatched a plan to dupe job aspirants in the same manner to earn quick money. To execute his plans, he brought together his relatives, friends and started a call centre. Fear of being caught by police or to not create any suspicion in the eyes of neighbours, the accused persons kept on changing their location. "Amir works for Shine.com and he used to provide data to the accused, who would call job aspirants for jobs in various private airlines based on their qualifications and experience. Fake tele-interviews were conducted on phones after which forged appointment letters were also transmitted to victims. Money in lieu of fee for uniform, opening of salary account, passport, security etc. were asked from victims on different pretexts in different bank accounts," the official added.



VIOLENCE OVER TRIBAL WOMAN'S DEATH: SECTION 144 IMPOSED IN INDORE

In a bid to normalise the situation after the suspicious death of a 23-year-old tribal woman and death of a youth in police firing during a violent protest in Indore's Mhow, the administration on Thursday imposed Section 144 in the areas falling under as many five police stations.

A decision has been taken sensing that the tension may prevail again after the death of tribal youth. Briefing the press, Indore Collector Ilayaraja T. on Thursday said adequate police personnel have been deployed in the area. Besides police, administrative officials were also deployed to monitor the situation in tensed areas.

"Section 144 has been imposed in five police stations, including Mhow. Any kind of protest, gathering of people or rally will not be allowed in prohibited areas. Decision has been taken sensing the situation following the incident. The administration stands with the families of the victims and all possible help will be provided," Ilayaraja T. said.

The boy, who died in police firing, has been identified as Bherulal, and a compensation of Rs 10 lakh has been announced by the district administration. The funeral of the deceased boy has been performed amidst tight security, Collector said.

On Wednesday, a 23-year-old tribal woman, who was preparing for competitive exams, was found dead in a rented room.

Alleging that the woman was gang-raped and murdered, the family members staged a protest while keeping the body on the road. The protesters pelted stones and damaged a local police station, and vehicles were set on fire. At least, six cops were reported injured due stone pelting. Sensing the trouble, the police used teargas and fired shots to disperse the crowd. During the firing, tribal youth - Bherulal died.

However, when asked who ordered firing on protesters, Collector Ilayaraja said the matter was under investigation. "A magisterial inquiry has been ordered to probe the entire incident. Things will be clear only after investigation. Chief Minister Shivraj Singh Chouhan is monitoring the situation. At present, the situation is under control," he added.

Meanwhile, Madhya Pradesh Home Minister Narottam Mishra said - "There are contrary in claims of two groups regarding the incidents." He added, "While the family of deceased woman claimed the death occurred due to electric current, while the others who protested and injured cops, are saying the woman was raped and murdered. Chief Minister has ordered for a magisterial inquiry in the matter and the truth will come out soon."

Bulldozer targets men accused of murder in Damoh

A bulldozer was used to raze standing crops belonging to a group of men accused of murder in Madhya Pradesh. Jahar Singh, Umaid Singh, Makhhan Singh, Arjun Singh were accused of a double murder which took place two weeks ago. The men are on the run.

Two weeks ago, two elderly men, Badri Shukla, 68, and his brother Ramsevak Shukla, 65, were shot dead over a land dispute in Damoh district. The men had bought three acres of land in 2021. Since then, there was a dispute with the family of the accused.

On February 28, the Singhs wanted to take their tractor from the fields of the Shuklas, but the family refused, the police said. Shortly after, Jahar Singh, Umaid Singh, Makhhan Singh and Arjun Singh reached Shuklas' home and shot them dead.

After investigating the case, the local police brought in a bulldozer today and razed the crops on the Singhs' land. Sources said the Singhs had

apparently grabbed government land. The family had also taken possession of part of the government school building and a borewell in the village, the police said.

According to Tehsildar Vikas Aggarwal, property worth over Rs 25 lakh has been seized.

District collector S Krishna Chaitnya said, "In Hinauta's double murder case, the revenue department had identified the encroachment by the accused. Two kutchha houses were demolished, they also encroached on the government for farming, so a joint team of revenue and police took action and the encroachment was removed."

Two days ago, the Brahmins held a big protest march in Damoh. The protesters had accused the administration of trying to shield the accused from the Lodhi community because of political influence.

Three persons were arrested in connection with the gang-rape of a minor. A fourth one, Kaushal Kishore Chaubey, is on the run. The police said he had illegally built a house on occupied land. The police also demolished the house.

The officer who led the bulldozer team said it was a heinous crime and the cops did a "good job". Such actions deserve such a punishment, he had said.

2 women married to same man reach an "Agreement" to split days with him

A man and two women, including his first wife, have decided to live peacefully in two separate houses by dividing three days each of a week between them and also with the liberty to the man to spend the seventh day with the woman of his choice, said a lawyer associated with the family court in Gwalior city.

However, counsellor and advocate Harish Diwan termed the "agreement" between them illegal as per Hindu law.

The story of the two women and a man, who is an engineer, came to light when the man again entered into wedlock with a female colleague in Gurugram after he left his wife in Gwalior during the COVID-19 pandemic, Harish Diwan said.

His first marriage took place in 2018 to a Gwalior-based woman and they lived together for two years. During COVID, he sent his wife to her



parents' home and went back to Gurugram, he said.

When he did not return till 2020 to take her legally wedded wife, she grew suspicious and went to his Gurugram office. She learnt that he had married a colleague and a girl was also born during the period, Harish Diwan said.

The woman fought with the man publicly and protested in the office

over his second marriage. She then approached a family court in Gwalior for justice, he said. Later, her husband was summoned to Gwalior. Despite attempts to counsel him, the man refused to leave the second woman, Harish Diwan said.

His wife as well as the second woman were counselled but they were not ready to understand, he said. Later, the trio entered into an

agreement according to which the man will spend three days of a week with his wife and another three with the woman he allegedly married, with the liberty to live with the woman of his choice on Sunday, Diwan said.

He provided a flat each to his wife as well as the other woman in Gurugram and also agreed to share his salary equally with them as per their agreement, Harish Diwan said.

When asked whether this agreement has any legal sanctity, Harish Diwan said, "This agreement was done between three of them with mutual consent. Neither the family court nor the councillor has any role in it." "In fact, the three were categorically told that they are Hindu and as per Hindu law, this agreement between them is illegal. As per the law, a Hindu man cannot marry another woman until he divorced his first wife in a legal manner, but they decided to go ahead with their pact," Harish Diwan added.

MP Assembly Budget Session Congress keeps mum over suspension of Jitu Patwari

Congress's internal politics that the party leaders are keeping quiet over Patwari's suspension.

Patwari often goes beyond the party rules to take opposition to task. This was the reason that Nath had removed him from the post of the party's media cell president. Patwari got a lot of publicity after his suspension from the House. This is the reason that the party has sidelined him. On the other hand, Verma said Patwari's suspension was not the only issue.

No-trust move against the Speaker, breach of privilege motion against Narottam Mishra and against two Congress legislators are pending, he said.

OPIUM WORTH RS 1.47 CRORE SEIZED IN NEEMUCH

In continuation of anti-drug operations, a team of Central Bureau of Narcotics (CBN) MP unit officials acting on the basis of specific intelligence intercepted a TATA truck at the Sikandara Toll on the Jaipur-Agra Highway on Tuesday and seized 128 packets of opium weighing 97.120 kilograms. As per the international market value of opium that was seized in an operation, the expected value stands around Rs 1.47 crore, sources said.

Officials informed that the truck, which had Nagaland state registration, would be carrying huge quantities of illicit opium from the Northeast to Rajasthan.

On questioning, the occupants of the vehicle revealed that opium



was concealed in specially built cavities inside the cabin and body of the truck.

The truck was carrying bamboo sticks as cover cargo. As it was not possible to search the vehicle on the highway due to safety and security issues, it was decided to bring it to the CBN office. After reaching the CBN office, the vehicle was thoroughly searched, and a total of 128 packets of opium weighing 97.120 kilograms were recovered from specially built cavities inside the cabin and the body of the truck.

The vehicle, along with the contraband drug and cover cargo, has been seized, and two persons have been arrested under the provisions of the NDPS Act, 1985. Further investigation is in progress.

Drinking coffee may help you in weight loss

Drinking coffee, a rich source of caffeine, may help curb the amount of body fat and reduce the risk of developing Type 2 diabetes, suggests a study. Researchers from the Imperial College London found that people who carry genetic variants associated with slower caffeine metabolism drink, on average, less coffee, yet have higher levels of caffeine in their blood than people who metabolise it quickly to reach or retain the levels required for its stimulant effects. The research published in the journal *BMJ Medicine* concluded that the speed at which coffee is metabolised by the body may impact the weight. To find out, the study looked at the role of two common genetic variants of the CYP1A2 and AHR genes in nearly 10,000 people of predominantly European ancestry. The CYP1A2 and AHR genes are associated with the speed of caffeine metabolism in the body. The results of the analysis showed that people with higher plasma caffeine levels enjoyed a lower body mass index (BMI) and body fat, alongside a lower risk of developing type two diabetes. "Ninety-five per cent of your caffeine is metabolised by an enzyme," Dipender Gill, clinical scientist at the Imperial, was quoted as saying *Independent.co.uk*. "Two genes - CYP1A2 and AHR - affect the function and level of that enzyme. Using these genetic variants, the team found that slower metabolisers have higher plasma (blood) caffeine levels, and those with higher plasma levels go on to have a lower BMI and risk of diabetes, Gill said. However, more research is needed, the team said. It is because caffeine has been associated with lower sleep quality and increased palpitations.

BARREN FIELDS, DWINDLING YIELDS: HOW BT COTTON DITCHED FARMERS OF MADHYA PRADESH

At a time when the much-hyped Bt cotton crop is giving heartburn to farmers, the Union Government is slowly setting the stage for the roll-out of genetically-modified (GM) mustard. Last October, the Ministry of Environment, Forest and Climate Change approved the field trials of Dhara Mustard Hybrid-11 developed by former Vice Chancellor of Delhi University Deepak Pantel. While the government argues that the GM variety will increase mustard production and reduce the country's reliance on edible oil imports, anti-GM activists are wary. They have before them the poor show put up by Bt cotton, the first genetically modified crop in the country.

They have seen how the guarantee of better yield and claims of reduced requirement of pesticides and chemical fertilisers have gone with the wind. Apparently, the few things that Bt cotton farmers ended up with were barren fields and increased input costs.

Take the case of Madhya Pradesh, which accounts for 18.69 lakh cotton bales (in 5.47 lakh hectares) of the total 352 lakh bales (in 1.18.81 lakh hectares) produced in the country. Khargone, Barwani, Khandwa and Burhanpur are the main cotton-producing districts here.

Cotton crop covers a total of 2,11,450 hectares in Khargone, according to statistics from the Farmer Welfare and Agriculture Development Department. A resident of Mogargao, Chhagan Chauhan (50) has come to Khargone's cotton market to sell 2.6 quintals of cotton. This year has proved to be better for him. "Today, I got Rs 8,500 per quintal. This price is good for me," he beams.

Last year, incessant rains and pest attacks destroyed half of his crop. "Ideally, 10 packets of Bt cotton seeds that I sprayed on the field should have got me about 40 quintals of cotton. But I harvested just 16 kg. Thankfully, pests have spared me this time," he sighs.

Temla-based Shyam (24) has been assisting his father Anil Dhangar (55) in cultivating Bt cotton on seven acres for the last two years. Ask about the challenges they face, Anil says, "Getting a good price for the yield and worm infestation are our biggest worries."

He unrolls a cotton boll in his hand. "See, the pink-coloured insect (Pectinophora



gossypiella) has made a home here, damaging the seed kernel. Now, this cotton fruit will not grow into a flower to give yield. The only thing left to do is to remove it from the field as quickly as possible," he says, adding that pest attacks began late this year compared with the previous year when around 40 per cent of the crop was affected.

Bogus claims Four types of caterpillars - Pink Bollworm, Spotted Bollworm, American Bollworm and Tobacco Cutworm - are found in cotton. Of them, Pink and American bollworm attacks are common in India. A 2018 survey conducted by the Central Institute of Cotton Research found that the incidence of pink bollworm had increased from 5.17 per cent to 73.82 per cent between 2010 and 2017 in Maharashtra, Gujarat and Madhya Pradesh.

The irony is that the government had permitted the commercial cultivation of the first generation Bt cotton (Bt-1 cotton) in 2002 to prevent insect attacks, while its second generation (Bt-II) was launched in 2006 by combining two Bt (Bacillus thuringiensis) proteins (Cry1Ac+Cry2Ab) with the promise to specifically target the pink bollworm.

Adoption of Bt cotton soared to 81 per cent in 2007 and 93 per cent in 2011 as farmers thought pest-resistant varieties were their best bet. Unlike other crops, new seeds have to be bought from the market each time to cultivate the GM variety. What's more, a packet of

seeds weighing 450 gm costs Rs 750!

Though things are not in their favour, a return to natural cotton varieties is near impossible for farmers as only GM varieties are available in the market. According to experts, Bt cotton has become so prevalent that they make up for 98 per cent of the cotton fields nowadays.

"All the farmers in Khargone and Burhanpur district grow Bt cotton only. Helicoverpa armigera was the first pest to attack our crops. Pink bollworms were not to be seen in the initial years," says Mahesh Patidar (52) of Temla.

Agriculture expert and senior journalist Devinder Sharma tells 101Reporters that Bt cotton's ability to resist pests has come down in just two or three years after its arrival. "This is a scientific fraud... All the claims made about Bt cotton have been proved wrong. As far as the increase in yield is concerned, if you examine the data on irrigation, it will be clear that the production has not increased solely due to the introduction of GM variety. There are other reasons too," he explains, adding that the government should withdraw it now.

Farmer leader Vijay Jawandhiya, also an anti-GM activist, reiterates this point. "Production has not increased just because of the seeds. The use of chemical fertilisers has also increased, and so has irrigation."

According to a study by KR Kranthi and GD Stone, Bt cotton's contribution to increased yield is only 4 per cent. It has also been revealed in the study that after 2018, the yield decreased as compared to the initial years.

Four flowers come out of one boll of cotton. In September, pink caterpillars start appearing. Sometimes, the entire ball is covered with worms. By November, the cotton-picking season also begins. As the farmer cannot pick cotton from plants with caterpillars, he has to remove the remaining plants also by running a rotavator to use as waste.

Sandeep Yadav (35) of Behrampur Tema claims the yield has been dropping over the years. "In 2014, I could get 22 quintals of cotton from one acre of land. Today, I somehow manage to get five to six quintals from the same land." While highlighting the increased use of insecticides, he says, "Suppose I have sprinkled insecticides worth Rs 50,000 this year. Next year, their prices would be around Rs 55,000."

Like in the rest of India,

chemical fertiliser prices in Madhya Pradesh have gradually increased by 62 per cent from 2007-08 to 2014-15. According to Devinder Sharma, the cost of pesticides has increased "by 30 per cent in the last 20 years".

Soil quality Dr GS Kulmi, senior scientist and head of Khargone's Krishi Vigyan Kendra, confirms the increased use of pesticides and chemical fertilisers over the years. "Soil microbes have reduced and so has their ability to multiply. This has affected soil quality, leading the farms to barrenness."

Take the case of Madhav Yadav (38), who has been using more chemical fertilisers and pesticides in his field in Behrampur Tema with each passing year to save his crop. He is into cotton farming for the last 20 years and has been facing pink bollworm attacks for the last three years.

"Pink bollworms damage around 30 per cent of my crop every year. As I have been spraying more pesticides and fertilisers to make up for the losses, the land has become hard. Earlier, we could easily stir the soil using a cultivator, but now it is a pain," says Madhav.

Noting that the soil's carbon content is decreasing, Jawandhiya says only a return to the traditional use of livestock manure or compost can reverse this condition. Sandeep, on the other hand, notes that farmers are opting out of livestock rearing, which naturally reduces the availability and use of natural fertilisers.

The spraying of pesticides on cotton has had a cascading effect on the other crops. "Worms can be seen in my maize and wheat crops now. There was no need to spray chemicals on them until three years ago. But now, it is needed once or twice to protect the crop," says Madhav.

Dr Kulmi thinks the changes in the environment and pesticide use are the possible reasons. "Heat has increased and the rain pattern has changed. Earlier, fall armyworm was seen in maize only in South India and not in the fields here. The more pesticides you use, the more resistant insects become. In this case, the pests have become polyphagous, which means they can attack more than one type of crop."

GARCETTI CONFIRMED AS US AMBASSADOR TO INDIA

Eric Garcetti was confirmed as the next US Ambassador to India on Wednesday, ending a logjam that had left an important American mission abroad without a regular envoy for almost two years and his fate in the balance.

The US Senate confirmed him in a 52-42 vote with cross-voting from both parties, with several Democrats voting against Garcetti, a nominee of the Democratic President Joe Biden, and several Republicans siding voting for him.

Garcetti, a former Mayor of Los Angeles, was once a rising star in the Democratic party, but had had come under severe criticism lately for ignoring complaints of sexual harassment against one of senior aides. His nomination had been stalled over these allegations, which came up



during his confirmation hearing.

President Biden had first nominated him in July 2021, but it did not proceed and it was technically deemed as returned to the White House, to either be re-sent or replaced.

The Biden White House sent back the nomination this January when the new congress went into session, demonstrating the administration's unwavering backing for him, which, it

was noted, will hold him in good stead by those who may tend to consider him damaged because of the protracted fight over his confirmation.

Garcetti's re-nomination had run into fresh trouble in February when Republican Senator Marco Rubio announced a hold on it along with a bunch of others, including Rich Verma, who has been named to be a Deputy Secretary of State, and Geeta Rao Gupta as Ambassador at large for global women's issues.

The Senate Foreign Relations Committee voted 13-8 to approve his nomination last week, setting up a vote by the full 100-member senate.

With Garcetti's nomination stalled and the Biden administration refusing to name a nomination, observers of the bilateral relationship wondered if this was a manifestation of a deeper problem between India and US,

because this was possibly the longest America has not had an ambassador in New Delhi.

This prolonged period of no-ambassador also coincided with extraordinary delays in issuance of US visas in India, with the waiting period for first-time applicants for business and tourism visas reaching two years at its worst (it's been cut down considerably now).

Garcetti was once widely expected to run for White House, given his credentials: Hispanic descent, top Democratic operative, a top operative in a presidential campaign, Rhodes scholar at Oxford and alumnus of London School of Economics. Fifty one-year-old Garcetti is close to the White House and was once considered a potential member of the Biden cabinet but the same allegations that came up during his confirmation hearing had come in his way.

Marriages in S.Korea hit fresh low in 2022

Seoul | Agencies

The number of marriages in South Korea crashed to yet another record low in 2022, adding to concerns over the country's already plunging birth rate, data showed on Thursday.

Around 192,000 couples tied the knot in Asia's No. 4 economy last year, slipping 0.4 per cent from 2021, according to the data from Statistics Korea.

The number is the lowest since 1970, when the statistical agency began compiling related data, and represents the 11th straight year of shrinkage, reports Yonhap News Agency.

The decrease nevertheless slowed from a 9.8 per cent on-year drop tallied in 2021, apparently as couples who had delayed their marriages during the earlier stages of the Covid-19 pandemic held weddings.

South Koreans in their 20s further distanced themselves



from getting married in 2022.

The number of marriages in the age group 25 to 29 decreased 8.4 per cent for men and 7.2 per cent for women on-year.

The average age for grooms getting married for the first time came to an all-time high of 33.7 in 2022, up 0.4 from a year earlier, and brides reached a new record of 31.3, up 0.2 over the period. The number of couples getting divorced, meanwhile, came to 93,000 in 2022, down

8.3 percent from a year earlier. Couples who have been married for four years or less accounted for 18.6 per cent.

The number of divorces marked the lowest level since 1997, when the figure came to 91,160.

The number of South Koreans marrying foreign spouses stood at 17,000 in 2022, up 27.2 per cent from the previous year.

The latest tally came amid South Korea's chronically low childbirths.

26 KILLED, 4,368 INJURED DURING FIRE FESTIVAL CELEBRATIONS IN IRAN

Tehran | Agencies

At least 26 people were killed and 4,368 others injured in Iran between February 20 and March 14 in incidents related to the celebrations of Chaharshanbe Suri, or the Fire Festival held two days back, official news agency IRNA reported.

Among the injured, 229 people were amputated for serious injuries and 1,428 others sustained eye injuries, Jafar Miadfar, head of Iran's National Medical Emergency Organization, was quoted as saying on Wednesday.

The number of casualties this year has registered a year-on-year increase of 22 per cent, according to Miadfar.

The provinces with the most casualties were Tehran, East Azarbaijan, Hamedan, West Azarbaijan, Qazvin, and Fars, said Miadfar.



Men make up 79 per cent of those injured, while 44 per cent of those injured aged between six to 18 years, he added. The Fire Festival is celebrated by Iranians on the eve of the last Wednesday before Nowruz, the Iranian new year that begins on March 21 this year. Celebrations often start days before the festival, Xinhua news agency reported.

Iranians celebrate the Fire Festival by jumping over bonfires and lighting firecrackers in public places to bid farewell to the old year and welcome the new one.

7.0-MAGNITUDE QUAKE JOLTS NZ'S UNINHABITED ISLAND

Wellington: A 7.0-magnitude earthquake jolted the uninhabited Kermadec Islands, located about 1,000 km northeast of New Zealand's North Island, on Thursday, with a depth of 10 km. The Pacific Tsunami Warning Centre in Hawaii issued a tsunami warning for coasts within 300 km of the quake epicentre in the South Pacific, Xinhua news agency reported.

"Tsunami waves reaching 0.3 m to 1 m above the tide level are possible for some coasts of Kermadec Islands," it added. There is however, no tsunami threat for New Zealand following the strong earthquake, according to the National Emergency Management Agency.

Judge ready to halt arrest attempts if Imran surrenders in court

Islamabad | Agencies

Pakistani judge on Thursday said that he would stop the Islamabad police from arresting former Prime Minister Imran Khan in the Toshakhana case if the latter surrendered in court.

Additional District and Sessions (ADSJ) Judge Zafar Iqbal made the remarks while hearing the Election Commission of Pakistan's (ECP) reference seeking criminal proceedings against Khan for concealing details of the state gifts, Dawn reported.

The sessions court was set to indict the PTI chairman in the reference on February 28, but his lawyer had requested the judge that he be exempted from the hearing because he had to appear in several other courts.



His indictment was deferred multiple times before. The judge had subsequently issued non-bailable warrants for

Khan and instructed the police to present him in court by March 7. The former premier managed to dodge the arrest and later

approached the Islamabad High Court (IHC) for the cancellation of the warrants, Dawn reported.

The IHC, while granting some relief to the PTI chief, had told him to appear in sessions court by March 13, but the former prime minister once again skipped the hearing.

Resultantly, ADSJ Iqbal had on Monday re-issued non-bailable warrants for Khan and directed the police to bring him to court by March 18.

However, when the police reached his Zaman Park residence in Lahore to arrest him on Tuesday, they were met with resistance, leading to two-way pitched battles between PTI supporters and law enforcement agencies, Dawn reported.

The clashes ultimately subsided after the courts intervened on Wednesday.



# Mumbai cops detain 2 for trying to 'bribe & blackmail' Fadnavis' wife

Maharashtra Deputy Chief Minister Devendra Fadnavis has claimed a political plot to frame him a day after his banker-singer wife Amruta Fadnavis, lodged a police complaint accusing a father-daughter duo of bribe-blackmail, here on Thursday.

Moving swiftly, the Malabar Hill Police Station detained the two persons -- a bookie, Anil Jaisinghani, and his daughter Aniksha, a professional designer -- from Ulhasnagar in Thane district. They have been booked under IPC Section 120(B), and Prevention of Corruption Act Section 8 and 12, and further investigations are on. Fadnavis said that his wife



Amruta came in touch with Aniksha for nearly one-and-half years. She (Aniksha) had visited the Fadnavis home and had tried to give a bribe of Rs One Crore and when they did not fall for it, resorted to threats and blackmail. Aniksha had given Amruta some designer clothes and

jewellery to be promoted at her social and public shows. Later, Fadnavis said that Aniksha allegedly tried to lure Amruta by revealing that her father was passing on information about bookies to the police, and said Fadnavis could make money by directing the police to either ignore

or act against those bookies, and they would show them more routes to rake in money. She also allegedly offered Rs 1 crore to them to help get her father off the hook in a case, and sensing a trap, Amruta had blocked her off. A couple of days later, Aniksha sent some video clips, voice and text messages to Amruta from an unknown manner. Leader of Opposition Ajit Pawar, raised the issue in the assembly, after which Fadnavis said he has ordered a probe into the incident. Later, outside the legislature, Fadnavis pointed fingers at the erstwhile Maha Vikas Aghadi (MVA) saying a lot of sensational things, including some big names like an ex-Commissioner of Police, are likely to tumble out in this matter and he would speak after the investigations.

## Two residents of same building die by suicide in Mumbai in 24 hours

Mumbai: Two persons, including an 18-year-old boy and a 56-year-old woman, died by suicide as many incidents separated by a few hours in a building located in suburban Kandivali, police said on Wednesday.

The woman hanged herself in her flat on Tuesday as she was upset that her daughter couldn't become a mother, an official said. In another incident, an 18-year-old boy jumped from the building on Wednesday morning after his father shouted at him for not studying. His body was spotted by watchmen of the building and society members.

Police have registered cases of accidental death and further investigation is on, an official added.

# Govt accepts most demands of farmers: Chief Minister Shinde

'LONG MARCH' HALTS IN THANE

In what is perceived as a major victory for the farmers, the Maharashtra government on Thursday evening accepted almost all demands of the peasants, Chief Minister Eknath Shinde said, after which the farmers' Nashik-Mumbai "long march" was halted en route at Vashind in

Thane. "We had very fruitful negotiations on all issues and most have been resolved. I shall make a statement in the legislature tomorrow morning," Shinde said, after emerging from a marathon meeting with over a dozen leaders of All India Kisan Sabha (AIKS). Confirming the developments from the AIKS side, CPI-M MLA Vinod Nikole said that most pertaining to

the jurisdiction of the state have been sorted out while those in the Centre's ambit have yet to be resolved. "Accordingly, we have decided to halt the 'long march' at Vashind. The agitation is not called off till the government issues the relevant orders right up to the district level to implement our demands within the next two days," Nikole told media persons.

# CBI arrests Assistant Labour Commissioner in bribe case

The Central Bureau of Investigation (CBI) on Wednesday said that they have arrested an Assistant Labour Commissioner (Central) in Maharashtra's Nagpur for allegedly demanding and accepting a bribe of Rs 30,000 from two persons.

A senior CBI official said that a case was registered against Vijay Kumar Jaiswal, the Assistant Labour Commissioner (Central), Block-C, CGO Complex, Nagpur on complaint alleging a demand of bribe of Rs 30,000 each from two persons to issue cheques of their gratuity to them.

It was alleged that both the Complainants at the time of their retirement could not vacate the government allotted houses and the PSU referred their gratuity matter to the Office of Labour Commissioner (Central), Nagpur and deposited their gratuity amount with the said office.

"When the complainants contacted the accused to obtain their gratuity cheques, the accused allegedly demanded bribe of Rs 30,000 each from both the complainants. After



negotiation, the accused agreed to accept the reduced bribe of Rs 15,000 each," said the official. The CBI laid a trap and caught the accused while demanding and accepting the bribe money from the complainants. The official said that searches were also conducted at the office and residential premises of the accused which led to the recovery of documents related to property. The arrested accused was produced before the Special Judge, CBI Cases, Nagpur which remanded him to the CBI's custody till March 18.

# Probe agency conducts search against Franklin Templeton in Mumbai, Chennai

The Enforcement Directorate is conducting searches at some places linked to asset manager Franklin Templeton and its former and current executives in Mumbai and Chennai as part of a money laundering investigation, officials said.

The federal agency is looking to gather more evidence as part of its investigation against the company and its promoters under the Prevention of Money Laundering Act (PMLA), they said. In November 2020, capital markets regulator SEBI issued a show-cause notice to the company following its April 2020 decision to wind up six debt schemes having Rs 25,000 crore of assets under management (AUM) from 3 lakh investors, citing liquidity challenges because of the pandemic.



Eventually, the company was asked to pay Rs 5 crore as penalty, return over Rs 450 crore collected as 22-month investment management and advisory fees, and was banned from launching new debt schemes for alleged irregularities in running the six debt schemes. The Chennai police economic offences wing (EOW) subsequently registered an FIR to probe these alleged irregularities. The Enforcement

Directorate case of money laundering stems from this complaint. In 2021, SEBI restricted the heads of the asset manager - Vivek Kudva and Roopa Kudva - from accessing the securities market and from buying, selling or otherwise dealing in securities, directly or indirectly, or being associated with the securities market in any manner, whatsoever, for a period of one year.

# Mumbai woman murder: Police recover cutter, knife from house

Mumbai: The Mumbai police recovered cutters and a small knife from the house of the woman whose decomposed body was found in a plastic bag on Wednesday. The police said they suspect that the woman was murdered in December.

"The woman's arms and legs were chopped off after she was killed. This was done using cutters and a small knife which have been recovered from the house," an officer said.

Rimple Jain, daughter of the deceased, who was identified as Veena Prakash Jain, has been taken into custody. The sleuths said they haven't yet told her that she has been arrested in connection with the case, and she is still being questioned.

The investigators suspect that she might have committed the murder.

Earlier, on Tuesday, the police recovered the rotting body in a plastic bag kept in the cupboard in the Lalbhau area.

The police took custody of the body and sent it for post-mortem.

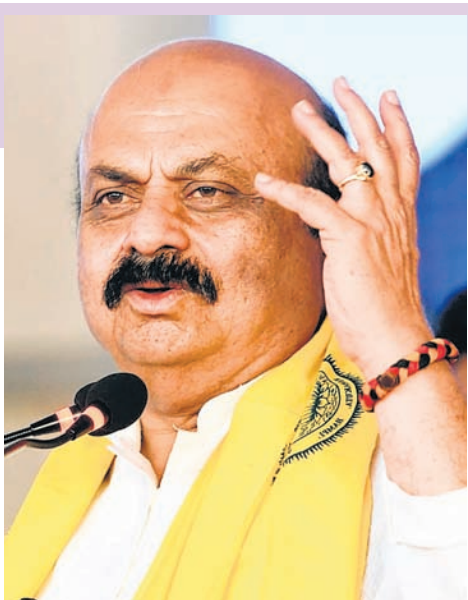
# K'taka CM slams Maha govt over health cover insurance to border villages

Minister," he said. Opposition leader Siddaramaiah had stated that the decision by the Maharashtra government to provide Mahatma Jyotiba Phule Health Scheme to 865 villages that are situated within borders of Karnataka is a challenge to the federal structure and sovereignty of the state. "Maharashtra CM Eknath Shinde government, which is threatening federal structure, should be expelled by the central government. "I also demand that CM Bommai should resign as he completely failed to protect the interests of the state," Siddaramaiah said.

"We are asking him (Agnihotri) to remain present because he is the contemnor. Does he have any difficulty if he has to express remorse in person? The remorse cannot always be expressed by way of an affidavit," the bench had said.

Agnihotri had put out tweets against Justice Muralidhar. Pursuant to the tweets, Agnihotri had put alleging bias against Justice Muralidhar.

As a result, contempt of court proceedings were initiated against the director.



Agnihotri's tweets were regarding the judge granting relief to activist Gautam Navlakha in the Bhima Koregaon case. In September 2022, the court had decided to proceed ex-parte against Agnihotri. Post which, he filed an affidavit expressing apology.

Agnihotri had mentioned in his affidavit that he himself had deleted his tweets against the judge.

However, the Amicus Curiae Senior Advocate Arvind Nigam had pointed out that it could be the social media platform which deleted the tweets and not Agnihotri himself.

# James Gunn all set to direct 'Superman: Legacy'

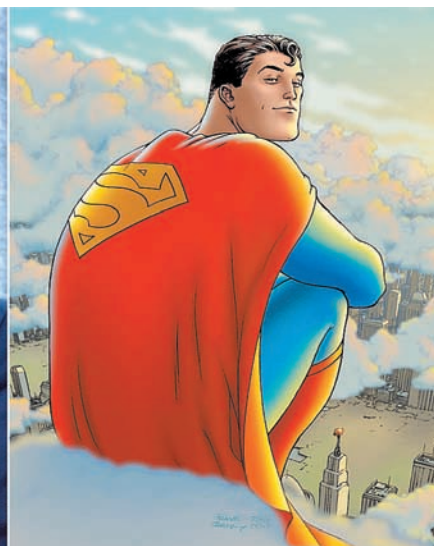

Despite announcing his retirement last month amid his battle with Parkinson's disease, Ozzy is eager to get back on stage - one way or another. Ozzy is said to be "so upset and annoyed" at being unable to play live that he is already considering a comeback. "He is refusing to give up on his hope of getting on stage despite his statement last month," said a source close to the singer.



# TOM HOLLAND, ZENDAYA GO GROCERY SHOPPING ON LONDON DATE

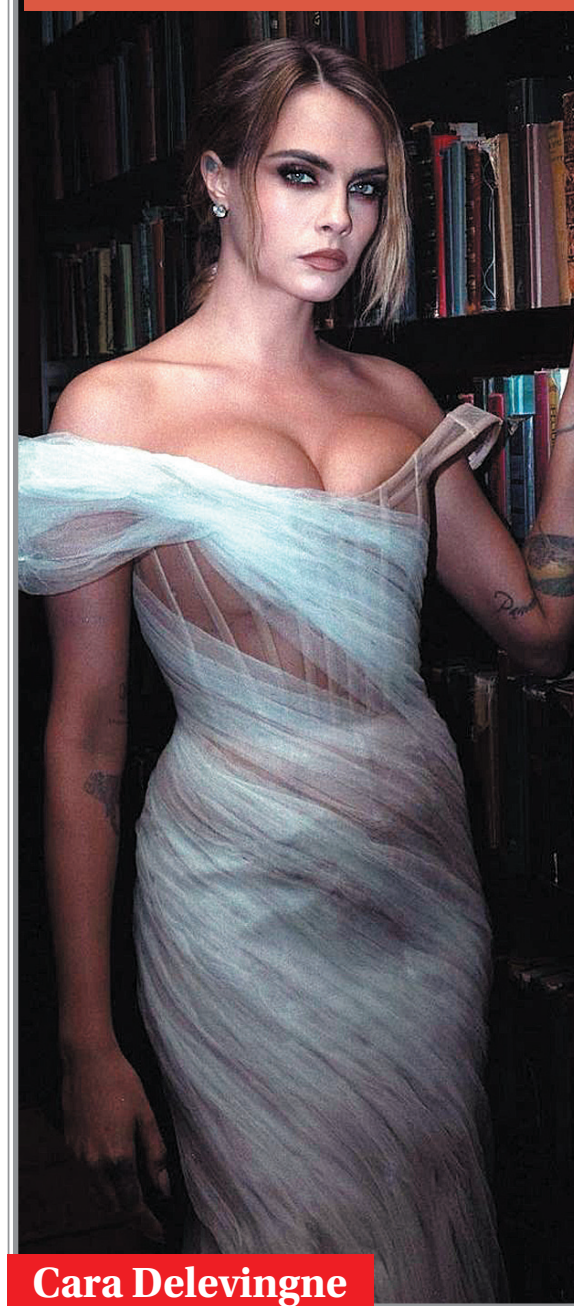

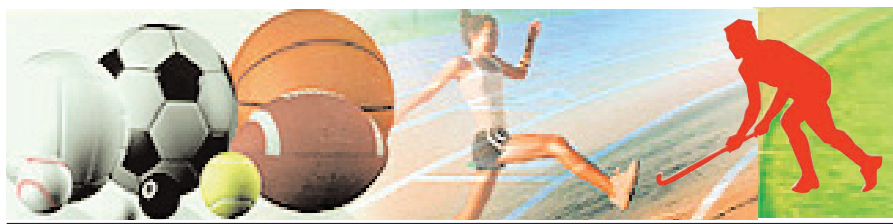

# 'EXPERIMENTATION' ON MENU FOR BOTH IND, AUS AS WC PREPARATIONS GATHERS PACE

In the year in which they will host the 50-overs World Cup, India restart their preparations for the mega event in the hectic year with three One-day Internationals (ODIs) against Australia, the first of which will be played at the Wankhede Stadium.

India is going into the first ODI without regular skipper Rohit Sharma, who will miss the match due to family commitments. In his absence, Vice-captain Hardik Pandya, who has led the T20 squad admirably, will discharge the duties, getting another chance to establish himself as the frontrunner to take over the reins from Rohit Sharma.

The hosts suffered a big blow as middle-order batter Shreyas Iyer was ruled out of the entire series due to a back injury he suffered during the fourth and final Test against Australia in Ahmedabad.



Though the team goes into another series without pace spearhead Jasprit Bumrah, the presence of Mohd Shami and Mohd Siraj, both of whom had a good Test series against Australia, along with youngster Umran Malik, Shardul Thakur, Jaydev Unadkat and skipper Hardik Pandya give the selectors test the pace department once again on the road to World Cup selection.

In the batting department, it will be a chance for K.L. Rahul to cement his claim for a place in the World Cup squad. He has lost his place in the Test

squad but a good series with the bat, and gloves if he gets the chance, will help his cause a lot ahead of the IPL. On the other hand, Shubman Gill has been in great form in the preceding ODI series against the Black Caps, hitting a double century in the first match and a century in the third. He also scored a century against Australia in the Ahmedabad Test as did Virat Kohli, who had regained his form in the shorter versions of the game before hitting a majestic 186 against Australia a few days back.

## NO RUSHING BACK FOR WARNER UNLESS 100 PERCENT FIT, SAYS MARSH

Mumbai | Australia opener David Warner is still not in the clear over his fitness and could miss the first One-day International of the three-match series against India to be played at the Wankhede Stadium.

Warner had returned home after suffering a concussion and a hairline fracture in his left elbow during the Test series and despite three-week rest, has not fully recovered from the injury.

The 36-year-old left-handed opener will face a fitness test of sorts during nets on Thursday and seasoned all-rounder Mitchell Marsh said he will not be rushed unless he is 100 percent fit. Marsh said Warner will be assessed on Thursday and "hopefully he comes through".

"Consultations will be held today and there is no rushing back if he is not 100 percent fit, I know that," said Marsh during the press-match press conference here on Thursday.

The all-rounder said all the Australian players are looking forward to this series as it gives them a chance to cement their claims for the World Cup selection.

# Nikhat starts with a bang; Sakshi and Nupur also advance

Star boxer Nikhat Zareen kickstarted the defence of her title and India's challenge with an impressive win at the IBA Women's World Boxing Championships with a dominating victory while Sakshi Chaudhary and Nupur Sheoran also made winning starts at the Indira Gandhi Sports Complex here on Thursday.

The 26-year-old exuberant boxer from Telangana, who clinched 52kg gold in the last edition in Istanbul, began her title defence in style as she took just over four minutes to outclass Anakhanim Ismayilova with the Referee Stops Contest (RSC) verdict in the 50kg opening round contest. The pugilists from Azerbaijan looked clueless against Zareen's strong jabs and quick movement in a thoroughly lopsided bout. The Indian will take on top-seeded Roumaysa Boualam



of Algeria in the second round.

Zareen's dominating triumph, in the first bout of the day, provided a befitting start to the prestigious event, which is being hosted by the Boxing Federation of India for the record third time in the country.

Extending the hosts' domination further on the opening day, 2021 Asian Championships bronze medallist Chaudhary and Sheoran also registered emphatic wins with an identical 5-0 margin in their

respective matches.

Sakshi dominated Colombian Maria Jose Martinez with supreme technical ability in the 52kg Round-of-32. Sheoran (+81kg), on the other hand, proved too strong for Abiola Jackman of Guyana in the Round-of-16 bout. She will now face Kazakhstan's Urakbayeva Zhazira in the next round whereas debutant Nupur Sheoran will be up against tough Lazzat Kungeibayeva of Kazakhstan, the 2016 World Champion, in the quarterfinals.

My association with the women's team, and the Pretoria Capitals over the last few months has been fantastic, and I'm looking forward to the upcoming season of the IPL," Ganguly said. "Delhi Capitals had done well as a team during my last stint with them. I've already been involved with the players this time around, and I'm keen to see them as a group. Hopefully, we will all have a great time over the next couple of months," he added.

# REAL MADRID MOVE INTO QUARTER-FINALS AFTER LIVERPOOL WIN

Real Madrid booked their place in the quarter-finals of the UEFA Champions League with a 1-0 win at home to Liverpool, giving them a 6-2 triumph on aggregate.

Karim Benzema scored Madrid's goal in the 79th minute after the ball fell kindly for him in Liverpool's penalty area, and his side never looked in danger of surrendering their 5-2 lead from the first leg.

Both sides had chances to score in an entertaining first half but Madrid had the best of them, and were it not for the heroics of Alisson in the Liverpool goal, the tie would have been dead and buried long before Benzema's goal, a Xinhua report said.

The Brazilian made a spectacular block from Vinicius Jr's effort as the forward arrived unmarked at the far post to meet a cross from a narrow angle, only for the keeper to stick out an arm to make a reflex save.

Alisson then tipped over Eduardo Camavinga's shot from



outside the area after it took a wicked deflection off James Milner. Luka Modric then fired just over and Alisson again denied Vinicius, although this time the flag was up for offside as Madrid threatened to overrun their rivals. At the other end, Thibaut Courtois pulled off two saves to deny Darwin Nunez and Cody Gakpo as Liverpool looked to react, although Alisson had to make another routine save from Toni Kroos before the halftime whistle. There were no changes at the break and Alisson was quick-

ly called into action to deny Federico Valverde, who was put clean through on goal after an error from Andrew Robertson.

Valverde then headed wide and Real Madrid continued to threaten, with Benzema firing over from a Vinicius pass when he would have usually at least put his effort on target.

The Frenchman made no mistake from close range shortly afterwards, when the ball fell kindly for Vinicius to play it to him from the floor to fire into an empty net.

## NAPOLI BOOK HISTORIC QUARTER-FINAL BERTH

Rome | Napoli reached their first UEFA Champions League quarter-finals as they dominated Eintracht Frankfurt 3-0 in the last-16 second leg, eliminating the German side 5-0 on aggregate.

The Partenopei had one foot in the quarterfinals after winning the first leg in Germany thanks to strikes from Victor Osimhen and Giovanni Di Lorenzo, a Xinhua report said.

The Azzurri showed no mercy at the Stadio Diego Armando Maradona, as they were firmly in charge and went ahead before the break when Matteo Politano floated a cross from the right and Osimhen jumped high to steer in a header.

Osimhen doubled the lead minutes after the break, when Di Lorenzo rolled across for the Nigerian to slide home.

The home side put the game to bed 10 minutes later when Piotr Zielinski was tripped down in the box for a penalty, which the Pole converted himself. Napoli joined Inter and AC Milan in the Champions League last eight, representing the first time since 2005-06 that three Serie A sides have reached the quarterfinals.



# RAFAEL NADAL SIGNS UP TO PLAY IN MONTE CARLO MASTERS

The 22-time Grand Slam champion Rafael Nadal has prepared to return to action after recovering from a hip flexor injury as he has signed up to compete in the Monte Carlo Masters, starting from April 8, the organisers of the clay court tournament said.

Nadal has been absent from the courts since his Australian Open second round loss to American Mackenzie McDonald, where he aggravated a hip injury.

The Spaniard had also withdrawn from the Indian Wells Masters and Miami Open due to grade 2 injury in the iliopsoas muscle in his left leg.

"Rafa was the first player to sign up. He wants to play in Monaco and is giving himself every chance to be



able to participate in this tournament that he loves so much, and which he has won eleven times in singles,

including a record eight consecutive titles between 2005 and 2012," tournament Director David Massey said

in a statement. The field, which will be led by Australian Open champion Novak Djokovic, includes the young Spaniard Carlos Alcaraz, Stefanos Tsitsipas, the Dane Casper Ruud, the American Taylor Fritz Daniil Medvedev, Andrey Rublev, Holger Rune, Felix Auger-Aliassime.

The 116th edition of the Monte Carlo Masters is the first major European tournament, which opens the clay season, on the legendary courts of the Monte-Carlo Country Club.

The main draw will be organised on April 7 in the presence of Stefanos Tsitsipas, who won his second consecutive singles title last year, while the pair Rajeev Ram/Joe Salisbury (United States/England), won the doubles.

# UAE's Asif Khan slams fourth fastest hundred in Men's ODIs

UAE batter Asif Khan slammed the fourth-fastest century in men's ODI cricket history, scoring 101 not out off 42 against Nepal in an ICC Cricket World Cup League Two match on Thursday.

Asif brought up his century in just 41 deliveries, helping UAE to a massive total of 310/6 in 50 overs.

Walking out to bat in the 38th over, he was in full flow right from the very off. He took over the change from Vriitya Aravind, who was brilliantly anchoring UAE's innings.

Making easy work of the Nepal bowlers, Asif pummelled 11 sixes and 4 fours in his knock. Nepal who were hoping to restrict UAE to a low total had to see their disciplined bowling efforts come undone against a rampaging Asif, with the visitors setting the hosts a target of 311 in the all-important encounter.



Asif's knock was one for the record books and now ranks as the fourth fastest ton in Men's ODI cricket history, only behind AB de Villiers (31 balls), Corey Anderson (36 balls) and Shahid Afridi (37 balls).

Shane Watson joined Gayle who continued to execute his powerful shots. In the sixth over, he smashed Dinda for a boundary, a six and two more consecutive boundaries to take 19 runs off the over. The powerplay yielded 72 runs.

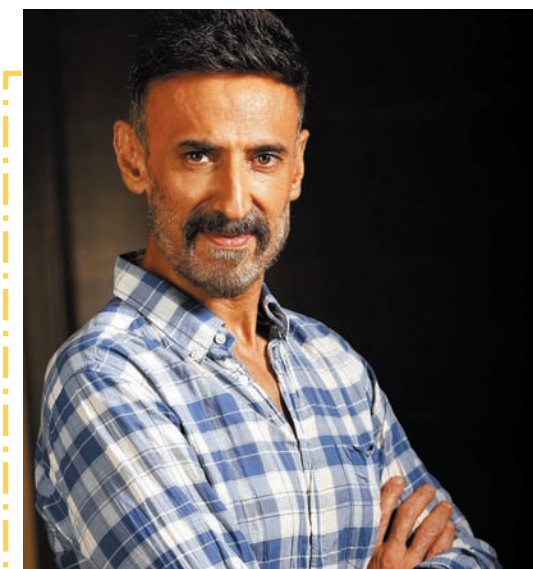
## VIKRANT MASSEY DID NOT ANTICIPATE SARA TO BE A 'RECEPTIVE' ACTOR
