

# **GRAPPLERS WON ROUND 1**

he Delhi Police on Friday informed the Supreme Court that it will register an FIR in connection with women wrestlers' allegation of sexual harassment against Wrestling Federation of India (WFI) president Brij Bhushan Sharan Singh.

Solicitor General Tushar Mehta, representing the Delhi Police, submitted before a bench headed by Chief Justice of India D.Y Chandrachud, "We have decided to register FIR, we will register it today. Nothing else survives...

Senior advocate Kapil Sibal, representing the women wrestlers, submitted that they are worried on two grounds -- number one, security and safety -- and second, there are several cases

against Singh. The Chief Justice told Mehta, "Mr. Solicitor, we'll record your statement that FIR is being registered. Second, we'll say that let security be provided to her (to the minor complainant). Instead of disposing of it, we'll take it after a week?"On the aspect of the court taking up the case next week, Mehta said this is going in a different direction. The bench, also

All of them on Friday put out tweets supporting the protesting wrestlers as #IStandWithWrestlers was trending for most of the day. # 'We are apolitical'

### SC directs states to register cases against all making hate speeches

The Supreme Court on Friday directed all states and Union Territories (UTs) to register cases against those making hate speeches even if no complaint has been made, while stressing that both judges on the bench are apolitical and "they do not care about party A or party B or party C".

THE BENCH WARNED THAT ANY DELAY IN REGIS-TERING CASES WILL BE TREATED AS CONTEMPT OF THE COURT AND EMPHA-SIZED THAT ITS OCTOBER 21, 2022 ORDER SHALL BE MADE APPLICABLE IRRE-SPECTIVE OF RELIGION.

he bench of Justices K.M. Joseph and B.V. Nagarathna termed hate speech a serious offence capable of affecting secular fabric of the country and added that the court had passed the order last year with public good in mind for suo motu action against hate speech.

"This is something which goes to the heart of our republic...about dignity of people....", said Justice Joseph.

During the hearing, the bench made it crystal clear that both judges are apolitical and they do not care about party A or party B, or party C, "we only know the Constitution and the laws of the country... let us be very clear about it... whatever order we pass, it is allegiance to the oath we have

Solicitor General Tushar Mehta said there is no dispute about it and also there is no doubt about it

When counsel cited instances of hate speeches in various parts of the country, the bench orally observed: "Don't bring in politics. If the attempt is to bring in politics, we won't be a party to this...we said in our order, irrespective of religion (action should be taken), what more do you want...".

It said it is entertaining petitions against hate speeches in different parts of the country for "larger public good" and to ensure establishment of "rule of law".

The top court was hearing a batch of pleas in connection with hate speech. One of the petitioners had initially sought direction against Delhi, Uttar Pradesh and Uttarakhand to register cases against those delivering hate


## Fix accountability on those who aid, fund terror activities: Rajnath at SCO meet

efence Minister Rajnath Singh on Friday called upon the Shanghai Cooperation Organisation (SCO) member states to collectively work towards eliminating terrorism in all its forms and fix accountability on those who aid or fund such activities.

Defence Ministers of China, ussia Iran Belarus Kazakhsta Uzbekistan, Kyrgyzstan and Tajikistan were present in the SCO meeting here. Addressing the defence ministers of the SCO countries, Singh asserted that any kind of terrorist act or support to it in any form is a major crime against humanity, and peace and prosperity cannot coexist with this menace.

"If a nation shelters terrorists, it not only poses a threat to others, but for itself too. Radicalisation of youth is a cause of concern not only from the point of view of secu-

New Delhi: Eight Indian Navy officers, who have been in the custody in Qatar since the past eight months on espionage charges, are learnt to be facing a potential death sentence, according to a Pakistan media report.

The Express Tribune report claims that the officers are accused of spying for Israel

The accused have been identified as working for the India's intelligence agency, Research and Analysis Wing (RAW) and were reportedly caught carrying out espionage activities in Qatar, the report further claimed


The arrested officials reportedly provided Israel details of Qatar's secret programme to buy advanced submarines from Italy, says The Express Tribune.

The CEO of a private defence company and the head of international military operations of Qatar have also been arrested in the same case, according to the report.

All eight officers of the Indian Navy were also employed in the same company, it added.

# Female Cheetah again strays out of Kuno National Park

- The KNP's core area is spread over 748 sq km while its buffer zone covers an area of 487 sq km.
- Some wildlife experts believe that an individual cheetah needs a habitat of 100 sq km, and the KNP, which now has 18 translocated cheetahs (two animals have died so far) does not have enough space.
- But another forest official said that it is difficult to determine how much area a cheetah exactly needs. Some literature on the subject states that a female cheetah needs a habitat of 400 sq km.

around."We are monitoring her movements

Namibia and South Africa. Deshdeep Saxena, a senior journalist who writes on wildlife issues, noted that at present only four of the translocated animals are out in the wild at the KNP, yet two of them ventured out."What will happen when three more Namibian and 11 South African cheetahs (who are currently in enclosures) will be set free," he said.

There is a need to develop 4,000 sq km of landscape adjoining the KNP for the cheetahs," said Saxena.

Prime Minister Narendra Modi released the first group of eight cheetahs brought from Namibia into quarantine enclosures at the KNP on September 17 last year. Of them, one female cheetah died due to a kidney ailment. The second lot of twelve cheetahs imported from South Africa was released on February 18. Of them, a male cheetah died due to cardiopulmonary failure.

Malik had claimed that he was offered a bribe for clearing the files during his tenure as the J&K Governor between August 23, 2018 and October 30, 2019. Last year, the CBI had

lodged a case in this respect and conducted raids in six states.

## **'EVIDENCE SPEAKS VOLUMES..': COURT DENIES** SISODIA BAIL IN ED'S EXCISE POLICY CASE

Team Absolute New Delhi

Delhi court on Friday denied bail to AAP leader and former Deputy Chief Minister Manish Sisodia in connection with the Delhi excise policy case being investigated by the Enforcement Directorate (ED), holding that that the evidence, prima facie, "speaks volumes" of his involvement in commission of the offence.

Special Judge M. K. Nagpal denied the relief, noting the "serious nature of allegations made and role played by Sisodia in the criminal conspiracy, his connection with the activities relating to generation or acquisition and use etc of the proceeds of crime and the oral and documentary evidence collected in support of the same".

"Hence, this court is not inclined to grant bail to the applicant in this case of economic offences having serious repercussions upon the general public and society at large as the evidence collected during investigation speaks volumes of his involvement in commission of the said offence.'

The judge also said that the purported medical condition of Sisodia's wife was not a reason to grant him bail in



this case. Additionally, he stated that it was impossible to rule out the potential of Sisodia influencing key witnesses in the case.

The judge noted that the alleged offence against Sisodia was a "serious economic offence of money laundering" and that he has not been accused of committing the offence in his personal capacity, but rather in his official capacity as a public servant overseeing the Excise Ministry and serving as Delhi's Deputy Chief Minister. "The seriousness or gravity of the offence and its nature or category, the capacity of applicant in which it was committed, the manner of its commission and also certain other factors like impact of

the offence as well as the possible impact of release of applicant on society etc. are the factors which go against the applicant and force this court to decide against his release on bail in the present case," the judge said. Judge Nagpal pronounced the order on Friday after having reserved it on April The court had a day before, extend-

ed Sisodia's judicial custody by two weeks in the case. On Thursday, the same court extended Sisodia's judicial custody till May 12, in the case being probed by the Central Bureau of Investigation (CBI). The ED had earlier submitted before the judge that Sisodia had planted fabricated emails to show that there was public approval for the policy. The directions to send these predrafted emails were given to Zakir Khan, Chairman of Delhi Minorities' Commission, who then asked his interns to send the emails, the ED claimed. The probe agency had also said that the 60 days given to complete the investigation against Sisodia are not over yet. It said that it has found fresh evidence indicating Sisodia's involvement in the alleged scam, and the investigation is at a crucial stage.

# IPL betting racket busted in Goa, 14 arrested

he crime branch unit of the Goa Police on Friday busted an IPL betting racket and arrested 14 people, said officials.

Superintendent of Police (Crime Branch) Nidhin Valsan informed that all 14 accused persons were caught redhanded and have been arrested from Porvorim in North Goa.

"All accused persons were caught redhanded while accepting bets on the ongoing 20-20 IPL Cricket match played between Rajasthan Royal and Chennai Super Kings and seized from their possession cash of Rs 38,000, 47 mobile phones, one laptop, three LED TVs, three net routers, three set-top boxes, one router modem and other gaming electrical accessories all worth of Rs 25,38,000,"



The accused persons have been identified as Ranjit Gedam, Pravin Rajput, Ankit Chaudihar, Nanda Kishan, Jyotiprakash, Kesham Kumar, Ayaz Khan, Jagdish Verma, Kawal Singh, Pankaj Chaure, Manjeet Singh, Nitish Pandey, all natives of Chhattisgarh; Mohit Kumar from Bihar and Rajan Dube from Uttar

The offence has been registered under section 3 & 4 of 'The Goa, Daman and Diu Public Gambling Act'.

# Punjab Police bust gang involved in providing passports to gangsters

The Punjab Police's Anti-Gangster Task Force (AGTF) has arrested three people involved in procuring and providing passports on fake particulars to gangsters and criminals to facilitate their escape from the country, Director General of Police Gaurav Yadav said here on Friday.

he arrested have been identified as Onkar Singh, Sukhjinder Singh, and Prabhjot Singh of Bareilly in Uttar Pradesh.

The police have seized at least nine passports, besides recovering several photocopies of passports of absconding gangsters prepared using fake particulars.

DGP Yadav said acting on tip-off about the involvement of an interstate travel agents in preparing passports using fake particulars, AGTF teams, headed by ADGP Promod Ban and assisted by AIG Sandeep Goel, in an overnight operation busted the gang. "Investigations reveal that the gang, having links in states, including Delhi, Uttar Pradesh, West Bengal, Gujarat and Maharashtra,



had facilitated a number of gangsters and criminals and other states to flee from the country on fake passports," he said.

The DGP said five more persons linked with the gang rounded up and investigations are on to unearth the entire network.

During the preliminary interrogation, accused Prabhjot Singh has revealed that one of his conduits, Charanjit Singh, who has been arrested by Delhi Police, had made a passport using fake particulars for gangster Deepak Boxer, who was recently deported from Mexico.

Another accused Sukhjinder Singh disclosed to have procured a passport on fake particulars for Deepinder Singh, alias Deepu, of Ajnala, who has a criminal background and is an associate of absconding gangster Harry Chatha.

#### STONE PELTING ON THE CONVOY OF 'KING' MAHENDRA'S BROTHER, 6 INJURED

Patna: At least 6 persons, part of a convov of leading industrialist Umesh Sharma alias Bhola Babu, the younger brother of late JD-U leader 'King' Mahendra Prasad, sustained injuries during stone pelting in Jehanabad district on Friday afternoon, police said.

Sharma, along with company employees, were on the way to a village in Ghosi area and as they reached Bharthu village under Ghosi police station, around 20 persons chased his convoy and pelted stones on

The window panes of 4 vehicles broke down in the attack but luckily, Sharma escaped unhurt.

In a statement to police, Sharma said: "We were on the way to a village to participate in an event organised by my company under CSR scheme, when around 20 persons pelted stones on my convoy. 6 persons, who were inside the vehicles, were injured."Following the incident, a large number of police force reached the village. They are making efforts to identify the accused. The reason for stone pelting is not ascertained yet.King Mahendra, who hailed from Jehanabad, was a Rajya Sabha MP of the JD-U as well as the founder of Aristo Pharma. After his demise, his younger brother Umesh Sharma is looking after the

# MAHA POLICE BURST TEARGAS, CANE ANTI-REFINERY PROTESTERS; OPPN LIVID

n the fifth day of the ongoing protests against the proposed Ratnagiri Refinery & Petrochemicals Ltd coming up with Arab help, police burst teargas shells and cane-charged protesters who attempted to block the ongoing soil survey work in the affected villages, here on Friday.

The problems started this afternoon when over 400 villagers, including many women, attempted to stop a team conducting soil testing work in one of the villages, according to activists.

The Ratnagiri Police, which had already clamped prohibitory orders in the region till May 31 to enable the soil testing work, accosted the villagers and attempted to disperse them but they

As they started running towards the soil testing team, the police stopped them and tried to push them away from the officials, but the locals continued to defy and tried to enter the testing area.

Amid the huge ruckus, screaming, shouting, at one point the police caned the protesters running and burst teargas shells to drive them away.

According to an activist, Sachin Chavan, the police bundled off more than 500 villagers in six waiting vehicles from the soil testing site and took them into detention, though the number of arrests is not clear yet. "We are not allowed to go to these areas. The mobile phones of the villagers have been seized, several of our activists have been externed for two weeks from the district, and the media are facing restrictions," said Sachin

Another activist of Sustainable Konkan



Movement, Satyajit Chavan, said in Mumbai that "the people in the region are being repressed by the use of police force", and not allowed to protest in a democratic manner.

Satyajit Chavan said that the police had arrested him and others under political pressure and "democracy is in danger", appealing to the people of Konkan to unitedly oppose the proposed RRPL project. In Mumbai, Chief Minister Eknath Shinde said that there was no caning (lathi-charge) by the police though videos of the incident were being aired on social media and several local television

Shinde said that the project will not be implemented without taking the locals into confidence, even as the villagers' leader Kashinath Gorle said the agitation has been suspended for 3 days to hold talks with the government.

The Opposition Maha Vikas Aghadi, Swabhimani Shetkari Sanghatana and others have slammed the ruling Shiv Sena-Bharatiya Janata Party regime, accusing it of excesses on the protesting villagers. At least one injured person has been injured, hundreds have been detained,

many fell ill in the fields owing to the scorching 40 degrees Celsius temperature in the afternoon during the agitation. Earlier on Friday morning, Shiv Sena (UBT) MP Vinayak Raut was detained and prevented from going to the soil testing areas.

Nationalist Congress Party's Leader of Opposition Ajit Pawar, Supriya Sule, MP, state Congress president Nana Patole, chief spokesperson Atul Londhe, Sena (UBT) MP Sanjay Raut, SSS president Raju Shetti have criticised the Eknath Shinde government. They called upon the government to immediately hold negotiations with the villagers, understand their problems or objections, and not push through the projects.

Appealing for discussions, Industry Minister Uday Samant reiterated that as assured by the chief minister, the project will not be taken up without the consent of the locals, but made it clear that the government will not entertain 'any outsiders'. The villagers have set preconditions -remove the police force in the region, stop the soil testing immediately, release people under detention, withdrawal of police notices/cases against the protesters, etc., before the talks with the locals on the project.

Protests and a political slugfest again hit the planned Rs 300,000-crore RRPL mega-venture promoted by IOCL, HPCL and BPCL - coming up in Rajapur taluka with the help of Saudi ARAMCO and Abu Dhabi National Oil Company, and would be the world's biggest single location refinery.

The RRPL project will be barely some km from the proposed world's largest Jaitapur Nuclear Power Plant (JNPP) in Ratnagiri, which has also been mired in controversies, strong opposition and protests by the locals since over a decade.

### Bihar Ex MP's release to affect public servants' morale: Madhya Pradesh IAS Body

body representing Indian Administrative Services (IAS) officers in Madhya Pradesh on Friday expressed deep concern and anguish over the release of gangster-turned-politician Anand Mohan, who was serving a life sentence for killing an IAS officer in Bihar three decades ago.

Anand Mohan, a former MP, was released from Saharsa jail on Thursday after being behind the bars for 15 years for the murder of G Krishnaiah, the then district magistrate of Gopalganj, who was beaten to death by a mob in Muzaffarpur district in 1994.

Anand Mohan's name figured in a list of more than 20 prisoners who were ordered to be set free by a notification issued by the Bihar government's law department earlier this week.

His remission of sentence followed an amendment of Bihar Prison Manual, whereby the restriction on early release of those involved in killing of a public servant on duty was done away with.

"The above decision will adversely affect the morale and fortitude of each and every public servant," the association's secretary



Vivek Porwal told a news agency on Friday. The association unanimously disapproves of this decision and urges the concerned state government to reconsider it, he said.

A local court in October 2007 had initially sentenced Anand Mohan to death, but the sentence was later commuted to life term by the Patna High court in December, 2008, when he appealed against the lower court verdict. The Bihar government has drawn flak from the opposition BJP for its decision. BJP MP Sushil Kumar Modi has accused Chief Minister Nitish Kumar of sacrificing law to stay on in power with support from ally RJD.

# MP POLICE GET TOUGH ON MODIFIED VEHICLE SILENCERS, ENFORCE TRAFFIC NORMS

he Madhya Pradesh government has implemented the rules of Section 182 A (3) of Motor Vehicle Act, 1988, according to which, manufacturing and sale of modified silencers for vehicles will be a punishable offence now.

As per the police, the first of its kind rules have been introduced in Madhya Pradesh aiming to prohibit the sale of components or parts of vehicles that can harm the human health and violate the traffic laws. The violation of the rules will amount to the imprisonment of one year along with a heavy fine up to Rs one lakh.

With the implementation of the rules, police have also begun search operations of the vehicles' components manufacturing units, garages and car decorators, and the shops selling modified vehicle silencers across the state.

The first such search operation was carried out in Bhopal a couple days ago, during which car decorators for modified silencers were confiscated. Following which, a Bhopal district court dealing with cases related to Motor Vehicles Act, imposed a fine of Rs one lakh against a shop owner for selling

Anurag Sharma, Additional Commissioner of Police (traffic /crime) of Bhopal said the implementation of Section 182 A (3) of Motor Vehicle Act,



1988 has became the need of hour in order to pun a ban on manufacturing and selling of the vehicle components that are categorised as contravention of the provisions of the traffic norms.

"Generally, the police will impose a fine on the vehicle owners for using modified silencers or other components, whereas, the manufacturers and sellers of such components are equally responsible. Now, they would also be held responsible and the violators would have to face punitive actions, including imposition of heavy fine," Sharma told correspondent.

Sharma also made it clear that the amount of fine against violation of norms would be decided by the court, and not by the police. "It will have an impact as the people will avoid using modified silencers or the other contravention components in their vehicles," Sharma added.

Besides this, the Madhya Pradesh Police have also taken several initiatives to spread awareness, and programmes are being organised involving the local people aross the state. The Commissioner of Police (CP) Bhopal, Harinarayanachari Mishra recently flagged off a 'Yatayat Mitra Yojna', an initiative of the state Home Department which involves local citizens.The Madhya Pradesh High Court has repeatedly slammed the state government and police over growing cases of traffic violations, especially in big cities of the state.

Last month, a petition pointed out that the amended Motor Vehicle Act has not been implemented in the state, the government had then submitted that the amended rules would be implemented in the state within 45 days.

In another stance in September 2022, while hearing a petition stating that "lack of enforcement of the compulsory helmet rule for the two-wheeler riders is responsible for the majority of deaths in road accidents," Madhya Pradesh Chief Justice R.V. Malimath had commented that - "Yes, nobody is seen wearing helmets on the roads".

# Bhopal Municipal Corporation sets up MP's first animal carcass incinerator

n what is claimed to be the first in Madhya Pradesh, Bhopal Municipal Corporation (BMC) has successfully established an animal carcass incinerator in the state capital to ensure safe and proper disposal of dead animals. This plant has been set up at an estimated cost of Rs 4 crore in the Adampur Chawni area in the state capital.

"We used to dig pits and bury dead animals. We could not dispose of them properly. We have set up an animal incinerator plant in the Adampur Chawni area to dispose of animal carcasses safely," BMC commissioner KVS Chouhan said.

"The plant has been set up using the amount which we received to improve the air quality index. The plant is capable of burning dead animals at the rate of 500 kg an hour.



With this, we would no longer have to bury animal carcasses. This new facility will be used to burn carcasses, and the only waste we will have is ashes. It is comparatively safe disposal," Commissioner Chouhan

The plant runs on Liquified Petroleum Gas (LPG) or

Compressed Natural Gas (CNG). Chouhan further said that they are going to start the plant's operation using LPG and shift to CNG later. He said that the animal carcasses can be burnt at this plan at a rate of 500 kg per hour, and it can run for up to 8 hours to 10 hours at a stretch. "The plant is ready, and we aim to start it within a week or so," he said. "The facility would process dead animals found on roads, and it will help to resolve the hazardous problem of disposing of the carcasses," he added.

# SP TO FILE DEFAMATION CASE AGAINST BJP'S POLL SONG

he Samajwadi Party (SP) announced that it will file a defamation suit against the BJP for a campaign song that is not only a "targeted attack on the SP chief but an attempt to vitiate peace and tranquillity, and trigger unrest in the state". On April 24, the verified Twitter handle of the Uttar Pradesh BJP uploaded a 4.27-minute video which was a spin on an SP's election anthem released ahead of the 2022 assembly polls --'Janta pukarti hai Akhilesh aaiye' (People are ready to welcome Akhilesh). Besides pointing fingers at the SP chief, the video includes a grab of the 2013 Muzaffarnagar riots, holding the then Chief Minister Akhilesh Yadav responsible for it. In an apparent response to the BJP's song, the SP has also released a 3-minute song on Twitter, 'Jo janata ko sataye hain, hum unko hatayenge', to highlight the BJP's failures. While the BJP maintained a studied silence on the issue after releasing the video, the SP took exception to it and announced that it would file a defamation case against the twitter handle that first uploaded the video. SP national general secretary Shivpal Singh Yadav, took to Twitter to post an agitated response. "BJP has become a symbol of language that roadside goons use and has turned into a centre that trains on how to indulge in character assassination. Despite conspiracies and injustice, we will come out strong. People want Akhilesh to lead the state to prosperity," he said in a tweet in Hindi.

# OTT to the rescue of the cinema business

The business of cinema has come a full circle. OTT platforms, which majorly depend on films as their prime content provider, are now facing a shortage of supply. Feature films carry a universal appeal and are the biggest draw for eyeballs on the OTT platforms.

People may have followed some web series on OTT, especially during the Covid-19 pandemic lock down and explored content from all over the world. That was because the supply of new films had halted. Still, feature films ruled the OTT platforms, mostly the old ones.

Now that the world was coming closer, thanks to the Internet, people explored all the options available to them during the lockdown. But films remained the main attraction.

So, two major players, Apple and Amazon Prime, have decided to invest up to a billion dollars in film production with the aim to give them a theatrical release. People love to watch a movie in a cinema, but high admission rates combined with the pandemic-borne lockdown drove the entertainment seekers to OTT streaming.

What worked here too were the films, except occasional web series. The catch here is that a movie is a movie only when it is released in cinemas and not directly on an OTT platform. A theatrical release is like an endorsement for a feature film. Also, when a film releases in a cinema, it gets publicity as well as media exposure. In short, it creates public awareness about the film.

In India, we learnt this lesson the hard way very early, a few decades back. This was when the video format came to India. Anybody who could afford a video player (others could get one on rend), rented video cassettes to watch films. Cassettes were available on rent as video piracy thrived.

Some prospect hunters with an aim to make quick bucks misread the demand for films on the video format. They started making feature films in the video format with budgets of as little as Rs 3-5 lakh at a time when the budget for a Hindi film went up to Rs 50-60 lakh.

The market was flooded with over 5,000 video films. Sadly, there were no takers, though the market was gradually going legit, because neither the video rights buyer, nor the viewer cared for films shot on video format. Nobody wanted a film that was not a regular feature film made for cinemas. As a result, investments in about 5,000 video films went down the drain

This fact now seems to have dawned on the OTT big shots in the US of A. They plan big-time investments in feature films, give them a regular theatrical release, which would add majorly to a film's recovery and also qualify it for the OTT platform as a regular film. This will also help the cinema chains survive, considering the deficit of supply which has forced the cinemas to reduce admission rates by a third of the original.

Closer home, the good news for the trade in general and the exhibition trade in particular is that the entertainment arm of Reliance Industries, Jio Cinema, which has been working on putting together a slate of entertainment content for some time, has finally announced an extensive slate of 100 productions in various languages, which include films as well as OTT content.



Jio Cinema has been working on content gathering, but, probably, did not want to announce this till they had a substantial repertoire on hand. Although the company's initial plan was to expand itself in the news media with a channel dedicated to each city or town, an idea one would think was far-fetched and would serve no real purpose, this shift to the entertainment media is welcome. Entertainment has takers all around.

Jio Cinema has been making its moves gradually, one at a time. From the Jio mobile network to acquiring interests in television news media, its progression from a small smartphone screen to the big screen and 5G will finally be allencompassing: from handphone to television to the big cinema screen.

A lot of producers have announced or launched more than one project at a time. Some were just publicity gimmicks; some meant it. But what Jio Cinema is planning is a 100-project slate to start with.

Jio Cinema has interests in all kinds of content. These include films such as 'Dunki' (Shah Rukh Khan), 'Bloody Daddy' (Shahid Kapor), 'Bhediya 2' (Varun Dhawan), 'Stree 2' (Rajkummar Rao- Shraddha Kpoor) and many such regular star cast films. Stars in the company's acquisitions / joint ventures are from all regions. They include Vijay Sethupati, R. Madhavan, Pratik Gandhi, and Arvind Swamy, among others.

Similarly, Jio Cinema's web content includes 'Laal Batti', 'Union: The Making Of India', 'Inspector Avinash', 'Rafuchakkar', 'Bajao' and others offering varied content and actors.

Along with Jio Cinema, the Viacom18 OTT platform, Voot, is also reported to be on a content acquisition spree. Reliance  $\,$ 

has an interest in both Viacom and Voot.

Jio planned to release 'Stree' directly on OTT, but, as an afterthought, decided to give the film a theatrical release; the risks were not high. The film worked wonders and registered a good business. Similar was their experience with 'Luka Chuppi'.

In all probability, had these films been released directly on OTT, they may not have worked or not met with the same success. As I mentioned earlier, a feature film is not accepted till it is screened in cinemas. Web series are fine, but for OTT to succeed, the route is through movies. What Apple, Amazon and Jio Cinema are doing will benefit and assure the survival of all channels of entertainment.

Government wakes up to 51-year-old problem

It has been more than 50 years since the video cassette recorder / player brought home viewing of films to India. It is also the time when video piracy also took roots. Owning a VCR was a luxury and watching a feature film at home was a privilege. Unfortunately, the films which were available on video cassettes were mostly pirated.

There were various ways of pirating a feature film. These included hijacking a film print for a few hours while it was being dispatched to nearby cinemas, or copying prints being sent to overseas markets (usually dispatched a week before a film's India release as it needed to complete censor and other formalities in the respective country), but the cheapest and crudest way to copy a film was to make a camera print while watching a film. The format was new and people did not mind even watching such copies.

Is it not odd that the government has woken up after so many year to the issue of piracy and unauthorised exhibition of films? What is the provocation, 51 years since the problem first reared its head? The government has labelled camcording of a film in a theatre as an offence. Does it still happen? I don't think so.

The piracy as it was done in the 1970s and 80s does not happen now. Yes, unauthorised exhibition of films happens big time and, no, these are not pirated prints as the government believes. The prints are acquired through unauthorized means without the acquisition of rights and are made available through the Internet.

The Government has amended the Cinematograph Act 1952. The new legislation is the Cinematograph Amendment Bill 2023. It provides for blocking websites transmitting unauthorised content.

Films from 1932 onwards, mostly from the later eras, are available on the Net. How does the government plan to determine which film is authorised and which one is not? Most of the OTT platforms operate from countries other than India and blocking a popular portal may not solve the problem because blocking does not guarantee no access. Yes, maybe you could try blocking the revenue flows to such portals.

The Bill does not mention piracy of music, which, probably, generates much more revenue for the pirates and other unlawful content providers.

# BILLS INTRODUCED IN MICHIGAN TO RECOGNISE DIWALI, EID AS OFFICIAL HOLIDAYS

hree legislators, including an Indian-American, in the Michigan State House have introduced a set of bills to establish festivals like Diwali and Eid as official state-recognised holidays.

Led by Majority Floor Leader in the House, Abraham Aiyash, and state representatives Ranjeev Puri and Sharon MacDonell, introduced the legislation to make Diwali, Vaisakhi, Eid al-Fitr, Eid al-Adha and Lunar New Year as official holidays in Michigan.

House Bills 4446 and 4449, introduced by Puri, establish Diwali and Vaisakhi as state holidays.

"Celebrating our cultural diversity is a cornerstone of a vibrant and inclusive society. By recognising these holidays, we are not only showing our respect and appreciation for the traditions and beliefs of our fellow Michiganders, but we are also sending a powerful message of inclusion and unity," Puri said.

A Hindu religious festival, Diwali celebrates the victory of light over darkness, good over evil, and knowledge over ignorance, and Vaisakhi is a spring harvest festival celebrated by both Hindus and Sikhs, a statement released by Michigan



House Democrats read.

"These bills embrace the diverse fabric of our state by recognising various religious and cultural holidays," Aiyash said, introducing Bill 4447, which calls for Eid al-Adha and Eid al-Fitr as state holidays.

"Making these holidays official state holidays will let Michigan's many communities know that they have a place in our great state and deserve to celebrate their joyous occasions like everyone else." At present, Michigan has 12 officially recognised holidays, including Christmas, Thanksgiving, New Year,

Juneteenth, and Martin Luther King Jr Day among the notable ones.

Close to 900,000 Asian Americans live in Michigan, with Indian-Americans making up the largest subgroup, according to Indian American Impact.

Most South Asians reside in Detroit and the surrounding area, in places like Troy, Novi, and Farmington Hills.

Recently, Pennsylvania declared Diwali as a national holiday after senators, Greg Rothman and Nikil Saval introduced a legislation in February this year.

### TURKISH EVACUATION PLANE SHOT AT IN SUDAN

Ankara: The Turkish Defense Ministry said on Friday that its evacuation plane was shot at as it arrived in conflict-torn Sudan, but no injuries were reported.

The Turkish C-130 plane, which was landing at Wadi Seidna Airport outside Sudan's capital Khartoum for evacuation, was shot at, said a statement from the ministry, Xinhua news agency reported.

The plane landed safely, no injuries were reported for the personnel, and the aircraft is parked for inspection, the statement added.

Turkey has been running an evacuation operation since last Sunday for its citizens in Sudan where fierce fighting erupted between the Sudanese army and the paramilitary Rapid Support Forces (RSF).

Sudan's army accused RSF of opening fire on the Turkish evacuation aircraft, while the RSF denied firing at the plane.

# BBC Chairman resigns after Boris Johnson loan row

BC Chairman Richard Sharp resigned on Friday over a report into whether he failed to properly disclose his involvement in the facilitation of a loan to former British Prime

Minister Boris Johnson.

Barrister Adam Heppinstall was appointed by the Commissioner of Public Appointments to investigate the claims which had first appeared in the Sunday Times, says the BBC.

Confirming his resignation, Sharp said the report, which was published on Friday, found "that while I did breach the governance code for public appointments, he states that a breach does not necessarily invalidate an appointment".

He said the report finds he did not play "any part whatsoever in the facilitation, arrangement, or financing of a loan for the former Prime Minister".

But he said with hindsight he should have disclosed his role in setting up a meeting between Cabinet Secretary Simon Case and Sam Blyth -- a businessman who was offering the then PM financial help -- to the appointments panel during the scrutiny process ahead of him taking up the senior role.

# with Akkuyu plant: Erdogan Ankara Agencies power plant as one of the most "import

Turkey has joined the club of nuclear power countries with the nuclear fuel delivery into the first power unit of the Akkuyu power plant, President Recep Tayyip Erdogan said.

"With the delivery of nuclear fuel by sea and air to our plant, Akkuyu has now acquired the nuclear power plant status. Therefore, our country has risen to the league of countries with nuclear power, albeit after 60 years of delay," Erdogan said at a ceremony via video link, joined by his Russian counterpart Vladimir Putin online.

Akkuyu nuclear power plant, Turkey's first nuclear power plant, is being built by Russia's state nuclear energy company Rosatom in Mersin province on the southern Mediterranean coastline, reports Xinhua news

Erdogan underlined that the power plant is "the biggest joint investment" between Turkey and Russia, and vowed that the Ankara govern-

ment will take steps to build a second and a third nuclear power plant as soon as possible. Putin, for his part, hailed the Akkuyu nuclear

power plant as one of the most "important partnerships" between the two countries in their history."This is a flagship project and it brings both mutual economic benefits and, of course, helps to strengthen the multifaceted partnership between our two states," Putin said.

Érdogan "personally pays great attention to the expansion of Russian-Turkish relations", the Russian leader said. A new nuclear industry is being established in Turkey thanks to the Akkuyu Power Plant, Putin said.

In 2010, the two countries reached a deal to let Russia's state company Rosatom build and operate the Akkuyu plant, which is designed with four nuclear reactor units, each with a

capacity to generate 1,200 MW of electricity. Under the deal, the Akkuyu plant was to be constructed with a Russian capital of \$20 billion. The construction began in 2018 and is scheduled to complete in 2026.

Once fully operational, the plant is expected to produce annually 35 billion kWh of electricity to meet approximately 10 per cent of domestic electricity needs.







# **ACTOR SOORAJ PANCHOLI ACQUITTED IN** JIAH KHAN 'ABETMENT TO SUICIDE' CASE

CBI special court here on Friday acquitted actor Sooraj Pancholi, who was accused of abetment in the suicide of actress Jiah Khan

Pancholi, 32, was present in the court along with his parents Aditya Pancholi and Zarina Wahab when Special Judge A.S. Sayyed pronounced the much-anticipated verdict before a packed courtroom this afternoon.

"Due to paucity of evidence, this court can't hold you guilty. Hence acquitted," said Special Judge Savved.



A visibly upset Rabiya, who has been relentlessly pursuing the case since the past 10 years, later said that she will file an appeal against the court verdict.

A relieved Aditya Pancholi reacted by saying, "the truth always wins! God is great!", while his wife Zarina was in tears and barely able to speak.

Nafisa Rizvi Khan, 25, famous as Jiah, was found dead in her Mumbai flat in Sagar Sangeet apartments, Juhu, around midnight on June 3, 2013, sparking a huge sensation in Bollywood cir-

The tragedy took place hours after Sooraj had



left her home after living with her for two days, and later the Juhu Police Station recovered a note

In the note pointing the needle of suspicion at Sooraj, she had narrated her troubled relationship, the ordeal, intimacy, physical and mental abuse and tortures, allegedly perpetrated on her

Based on the note, the Mumbai Police booked

to suicide) on June 10, 2012, and he remained in jail for nearly a month till the Bombay High Court granted him bail of Rs 50,000, on July 1, 2013.

As Rabiya pursued the matter, a year later in July 2014, the Bombay High Court transferred the case to the Central Bureau of Investigation (CBI), after which Aditya Pancholi hit back by slapping a Rs 100 crore defamation suit against Jiah's moth-

The Mumbai Police probe in 2013 had concluded that it was a suicide as Sooraj had broken off their relationship, and her career was not going ahead. Subsequently the CBI also upheld the case as 'suicide' in February 2016.

Undeterred, she challenged the CBI investigation report in the high court which was dismissed. In view of Rabiya's continued allegations of 'murder' against Sooraj, the prosecution attempted to enhance the charges to rape and murder in 2017, and he was charged with 'abetment to suicide' in 2018.

In 2022, Rabiya moved the Bombay High Court seeking to reopen the case, suspecting alleged errors in the previous probe and other things, but her plea was rejected.

She reiterated the allegations that her daughter was "murdered" and sought an investigation afresh by an independent or special agency with help from the Federal Bureau of Investigation as

## CBI to probe Palghar mob-killing case, **Maharashtra tells Supreme Court**

he Maharashtra government Friday told the Supreme Court that it has already recommended a CBI probe into the alleged lynching of three persons in Palghar in 2020 and this led to the closure of proceedings on as many as four pending petitions on the issue.

he Western Railway (WR) on Friday said that its Mumbai division has been gearing up for the upcoming monsoon season to provide seamless services in the rains.

In a statement, the WR said, additional waterways are being constructed through 'Micro -Tunnelling' at flooding prone locations across the Mumbai suburban section. These waterways have been already constructed at 5 locations. Additional 2 recently commissioned, while 5 more to be completed in this year.

It said, WR is committed to provide smooth travel for its commuters, to keep the wheels of trains running and ensure uninterrupted services, especially during the monsoons. Due to the sustained efforts and infrastructure upgradations, the suburban operations have improved in the past few years during the monsoons, and WR ran train services smoothly and normally over Mumbai suburban section with minimum disruptions. despite heavy rainfall. One of the techniques adopted in this direction is construction of additional waterways using micro - tunneling method. Such waterways have been already constructed at 5 locations. Recently, another two waterways were commissioned, while 5 more will be com-



pleted in this year.

According to a press release issued by Sumit Thakur, Chief Public Relations Officer of Western Railway, the topography of the major flood prone areas of previous monsoons such as Bandra, Andheri, Mahim, Grant Road, Goregaon, Vasai Road & Virar were studied in detail and an action

plan was drawn accordingly to suit the requirements of the particular area, the aim being to facilitate quick & smooth discharge of rainwater and prevent water logging.

It said, the WR studied the flooding pattern and devised customized solutions for each flooding locations by adopting modern technology and

advanced micro-tunnelling method. Such waterways have been constructed between Bandra Khar, Goregaon - Malad, Vasai Road Nallasopara, Nallasopara - Virar sections as well as at Nallasopara (South) near culvert no. 79.

Thakur stated that recently, WR undertook the work of construction of waterways at bridge No. 78 between Vasai Road and Nallasopara stations. Three pipes of 1800mm diameter were inserted by micro-tunnelling method. This will prevent negative free board at Ancholi Nallah, quick recession of water during high tide coupled by heavy rainfall in Vasai area. It will also help to reduce flooding in Vasai Yard. Also, the work of insertion of 2 pipes of 1800mm diameter, parallel to culvert 54 has been completed at Goregaon Yard. The work was completed in March'23 and this will help to augment discharge capacity of culvert no. 54 and ease out flooding problem of Goregaon Yard. Further, five more such waterways are being constructed at various locations. Out of these, the work on 2 waterways are in progress & will be completed before the onset of the monsoon while the remaining three will be completed in this year.




## Mendis' 5-wicket haul helps Sri Lanka beat Ireland, sweep series by 2-0
