

ISHITA KISHORE TOPS UPSC, TOP FOUR SEATS BAGGED BY WOMEN

shita Kishore has topped the Union Public Service Commission examinations, results of which were announced on Tuesday.

Interestingly, all the top four ranks in the examination have been bagged by women.

AS per UPSC, this time, a total of 933 candidates have been recommended for appointment, of which 183 are chosen as IAS officers.

Of the 933, 345 are from general category, 99 from Economic Weaker Sections, 263 from OBC, 154 from Scheduled Caste and 72 from Scheduled Tribe category.

Ishita Kishore topped the exam followed by Garima Lohia who secured second rank, Uma Harathi (third), Smriti Mishra (fourth), Mayur Hazarika (fifth), Gahna Navya James (sixth), Waseemm Ahmed Bhatt (seventh), Aniruddh Yadav (eighth), Kanika Goyal (ninth) and Rahul Shrivastava (tenth).

How many marks the candidates have secured in the exams will be announced after 15 days.

The commission has also prepared a reserve list of 178 candidates. For appointment for IAS posts, 180 candidates have been shortlisted.

It had conducted interviews in three phases for 2,589 candidates. The third and final phase of the

interview was conducted on May 18. The commission had announced vacancies for 1,011 posts in civil services.



Bus driver's son cleared exams



New Delhi: The Delhi High Court on Tuesday allowed NDTV founders Prannoy Roy and Radhika Roy to fly abroad from July 25 to August 15, albeit with certain conditions.

Karnataka CM orders 'ruthless action' against provocative social media posts

Bengaluru: Karnataka Chief Minister Siddaramaiah on Tuesday gave clear-cut instructions to the state police to initiate "ruthless action" against provocative posts on social media in the state. Chairing the meeting of top police officers at Vidhana Soudha, he underlined that they should be more careful about maintaining peace and coexistence in the society. "Ruthless action must be initiated against those who disturb the peace and co-existence in the society. The police must also prevent the menace of drugs," Siddaramaiah reiterated.

He also asked the police to look into finding solutions to traffic problems in Bengaluru and reining cyber crimes in the state.

"The people have elected the government for a change with hope and the officers must respond to the problems of the people," he said.

Siddaramaiah asked senior officers to visit the police stations and conduct inspections. The people who come to lodge complaints should not be treated as accused persons and police officers should behave cordially with them. Their woes would be addressed, he said.

"Our government will not tolerate goondagiri, unofficial club activities and drug mafia in the state. If these are encouraged, strict action would be initiated against the officers. We will compliment good workers and if there is dereliction of duty, we will initiate action without any hesitation," he warned.

- Up to 1 billion people could choose to migrate to cooler places, the scientists said, although those areas remaining within the climate niche would still experience more frequent heatwaves and droughts.
- However, urgent action to lower carbon emissions and keep global temperature rise to 1.5 C would cut the number of people pushed outside the climate niche by 80 per cent, to 400 million.

'DON'T DISTURB ME', SAYS SHIVAKUMAR ON ROW **OVER FULL TERM FOR SIDDARAMAIAH**

arely three days after the new D government took over in Karnataka, the tussle over power-sharing between Chief Minister Siddaramaiah and his deputy D.K. Shivakumar has come to the fore. When asked about the row, Shivakumar on Tuesday curtly stated 'Don't disturb me'.

"Let people issue statements on whatever they think. I am not going to talk about it. The AICC will take care of the matters relating to the power and other issues. Our national leaders are there too to handle such issues. Our priority right now is for the overall development of the state," he said.

Shivakumar looked disturbed and maintained a distance from media persons

Minister M.B. Patil on Monday night claimed that Siddaramaiah will complete the tenure of five years. "There is no talk about power-sharing and Siddaramaiah will be the CM for next five years", he stated stirring a controversy.



When his statements triggered speculation in political corridors,

Patil on Tuesday said that he has not made any personal comments over the issue. "I nave reiterated what senior leaders announced in the press conference," he said. Sources said that Shivakumar is upset over the remarks and his media statement 'don't disturb me' was aimed at M.B. Patil. When asked about power-sharing etween Siddaramaiah and

Shivakumar, AICC **General Secretary** K.C. Venugopal had remarked that the power was being given to the people of Karnataka. The high command has not given clarity about the issue so far.

The party seniors are unhappy

about the development and feel that Patil's statement at this stage was unnecessary

There was a cold war between Patil and Shivakumar when the former was inducted in

Siddaramaiah-led Cabinet in 2013 and Shivakumar was kept out. Patil is equally resourceful as Shivakumar is and he is considered to be the blue-eyed boy of

Siddaramaiah. M.B. Patil had attacked Shivakumar that he had destroyed Congress in south Karnataka, He had also called Shivakumar tainted and maintained that in the 2018

elections this could also have worked against the Congress party. After the Patil's fresh salvo,

Shivakumar has not reacted to any of his statements. However, sources explain that he is preparing a parallel Lingayat leadership against Patil. Various Lingayat groups have already objected to the preference given to Patil, who represents a small sub-caste over sub castes with larger population.

Mamata assures Kejriwal of full support over Centre's ordinance on bureaucratic service

T est Bengal Chief Minister Mamata Banerjee on Tuesday assured her counterpart in Delhi and AAP supremo Arvind

Kejriwal of full support of the Trinamool Congress in the Rajya Sabha against the Union government's ordinance to negate the Supreme Court's order handing over administrative services in the national capital to the elected government there.

While the BJP is poised to get the ordinance passed in the Lok Sabha owing to its numerical superiority, the situation might turn tricky in the Upper House where the Trinamool Congress has 12 MPs.

Banerjee made this announcement after an hour-long meeting with Kejriwal and Punjab Chief Minister Bhagwant Mann here. Delhi Education Minister Atishi and AAP's Rajya Sabha member Raghav Chadha were also present at the meeting.

"If all the opposition parties unite against the BJP on this ordinance issue, the saffron party can be surely defeated. If that happens, it will be a moral defeat for the BJP before the 2024 Lok Sabha polls. And if any miracle happens, the fate of the current Union government will be uncertain," Banerjee said.

Kejriwal, on his part, alleged that after any Assembly election, if the BJP does not get the



requisite majority, it first tries to capture power through the backdoor by twisting or pres surising the opposition MLAs. "Even if that tactic is not successful, it tries to take control over the state administration through Governors. This prac-

tice of using Governors against any non-BJP ruled state government has become rampant in West Bengal, Punjab and Telangana,' Kejriwal said. He also said that the Union government tactfully brought the ordinance on the day the Supreme Court was going on vacation.

"They were aware that had the Supreme Court been in session, the matter would have stayed on the very next day," he said.

Expressing gratitude towards Banerjee for extending support on the ordinance issue, Mann said that he is aware as to how the Governor is being used in West Bengal to disturb the functioning of the elected state government. Mann was also vocal about the use of central investigating agencies against the leaders of the opposition parties.

"I congratulate Mamata Banerjee for the manner in which she is fighting against the pressure of the central agencies," the Punjab Chief Minister said. All the three Chief Ministers also agreed on a united move by all non-BJP parties against the saffron acmp in the 2024 Lok Sabha polls.

HC quashes Delhi Mayor's decision of MCD standing committee re-polling, asks to declare results

he high court has quashed Delhi Mayor Shelly Oberoi's decision to hold re-election for six members of the standing committee of Municipal Corporation of Delhi (MCD)



for re-election after finding the election results "politically unpalatable".

Appearing for Oberoi, senior advocate Rahul Mehra had underscored that the re-polling was essential to ensure free and ur elections following the "ruckus" in the House during the polls held on February 24. "There is no prejudice in repolling. Please test if it will cause prejudice to them (petitioners)," the counsel had said.

The court had on December 19, 2015, granted bail to Gandhi and others in the case.

Additional Chief Metropolitan Magistrate Vaibhav Mehta of the Rouse Avenue Court has sought Swamy's response on Gandhi's application.

"The applicant ceased to be a Member of Parliament in March 2023 and as such he surrendered his diplomatic passport and is applying for a fresh ordinary passport. By way of the present application, the applicant is seeking permission and no objection from this Court for issuance of a fresh ordinary passport to him," the application read.

The court has listed the matter for further hearing on Wednesday.

I oncerned over three consecutive blasts in illegal fire- cracker outlets in three different places of the state killing 17 persons in the last seven days, the West Bengal government has decided to put a blanket ban on manufacturing at the state's biggest fire-cracker hub, Champahati in South 24 Parganas district for two months

A notice from Baruipur district police has been sent to the office of the local firecrackers manufacturers' association on Tuesday asking them to honour and follow the ban imposed for the next two months.

District police sources said the two months ban has been imposed to totally clean up the area on this count during

the period. "First we will conduct constant raids and search operations to identify, seize, and destroy illegal fire-crackers from this area. Secondly, we will identify the illegal manufacturing hubs in the area, where manufacturing of illegal fire-crackers has almost become a cottage industry

with even domestic houses running such manufacturing and storing outlets in the backyards," a senior district police official said.

After the cleaning- up exercise is completed, he added, then only those with valid licenses will be allowed to start their respective businesses. "However, henceforth the

police will be strictly monitoring the entire process of manufacturing and storing of fire- crackers here," he

added.

Meanwhile, a high-level meeting chaired by the state DGP Manoj Malviya was conducted at the state secretariat Nabanna on Tuesday afternoon, which was attended by all the districts' Superintendents of Police.

In the meeting, some SPs, sources said, faced the ire of the DGP for intelligence failures about the illegal manufacturing and storing of firecrackers in their respective districts.

"The DGP directed the district police Superintendents to activate their respective district intelligence units on this count. He also asked figures of the quantities of illegal fire-crackers seized from each district," said a state government official aware of the proceedings of the

Earlier, Oberoi submitted before the high court that no prejudice would be caused if polling was held again to elect the six members of the MCD standing committee.

During a special hearing on the petitions filed by the councillors, the high court had on February 25 put a stay on the notice issued by Oberoi.

Petitioners had alleged in the high court that Oberoi acted in a mala fide manner when she called

"What was the mechanism left? Was it so blatantly unfair? They did not allow re-counting. The BJP councillors created a ruckus. Ballot papers and calcu-

lation sheets exchanged hands," Mehra had added.

Another senior advocate appearing for Oberoi, Rajshekhar Rao, had said that no case for court's interference was made out and the authority was only ensuring that the process is done as per the law.

He had claimed that even the note of the Municipal Secretary noted "discrepancy in counting".

Justice Kaurav had reserved his order after conclusion of the submissions by the parties.

A ruckus was created after the Mayor had declared one vote invalid in the election to pick six members of the standing committee.

While staying the notice issued by Oberoi, the court had said that no purpose will be served by conducting fresh elections on February 27.


Jailed former SP MLA booked for rape of Dalit woman

n FIR for rape and criminal intimidation has been registered against former SP MLA Rameshwar Yadav, who is currently lodged in jail.

The FIR has been lodged on the complaint by a 25-year-old Dalit woman, who was allegedly raped by former SP MLA, four years ago, on the pretext of giving her a job.

ASP Dhananjay Singh Kushwaha, said, "The victim claimed that Rameshwar raped her while his younger brother Jogendra Yadav assaulted her. The latter has also been named in the FIR registered under IPC sections 376 (rape), 354-B (assault or use of criminal force to



woman with intent to disrobe), 323 (voluntarily causing hurt), 504 (intentional insult with intent to provoke breach of peace), 506 (criminal intimidation) and sections of the

Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act." In her complaint filed at Jaithra police station in Etah district, the woman claimed that she had met Rameshwar at his residence on February 2, 2019 and requested for a job. "He had promised me a position as a

fourth-grade employee in the education department. Initially, I was asked to work as a domestic help at his house. I agreed in the hope of getting a regular job. A day later, Rameshwar

attacked me while I was working and dragged me to his room. He raped me and then threatened to kill me and my family members, in case I disclosed the matter to anyone," the victim said.

"Four days later, I narrated the entire incident to Rameshwar's brother Jogendra. Instead of helping, he brutally assaulted me and stripped me. I somehow managed to save my life and gathered the courage to file a police complaint against the former MLA and his brother now after I came to know that he is lodged in jail and local authorities do not support them," she added. Rameshwar and Jogendra have over 70 cases pending against them. A majority of these were registered in the last five years.

Female cheetah cub dies at Kuno National Park, fourth death in two months

One of the four cheetah cubs born to Namibian feline Siyaya akka Jwala has died at Madhya Pradesh's Kuno National Park (KNP), officials said on Tuesday.

A senior forest official said, "Our team is trying to ascertain the exact reason behind the twomonth old female cub's death."

Earlier, two cheetahs named Sasha and Uday - brought to India from South Africa - had died in March and April, respectively, while the third cheetah named Daksha died on May 9.

Namibian female cheetah Siyaya, who was later named Jwala by the National Tiger Conservation Authority of India (NTCA), the nodal agency for 'Project Cheetah', had given birth to four cubs at the KNP in March

this year. The four cubs were bron within a week after the first Namibian cheetah died in March. Since then, this was the fourth cheetah to die at KNP since March this year.



A total 20 cheetahs were translocated to India in two phases - eight from Namibia on September 17, 2022, and 12 from South Africa on February 18, 2023.

Cong gearing up for next Assembly polls in 5 states

fter achieving success in the Karnataka Assembly elections, the Congress has now started preparing for Assembly polls in Rajasthan, Madhya Pradesh, Chhattisgarh, Mizoram and Telangana. The Congress has convened a meeting of the party leaders on May 26 to work on the strategies for the upcoming Assembly elections, sources in the know of things said on Monday. A source said "the Congress does not want to waste the momentum" it has got with a thumping victory in Karnataka, where it defeated the BJP. The party wants to ensure the preparations are started at the earliest in the next poll-bound states for a good show, the source said. The party source said that a meeting has been called by the top leadership with the state unit chiefs, party state in-charges and top leaders of the state in the national capital. The source said that Congress President Mallikarjun Kharge and party general secretary (organisation) KC Venugopal will preside over the meeting to collect the overall ground report of the party's preparation in the five poll-bound states. Former party chief Rahul Gandhi, party general secretary Priyanka Gandhi Vadra besides other senior leaders would also attend the meeting. The source said that during the meeting, the top leaders will also discuss the situation in Rajasthan, where party leader Sachin Pilot has been "critical" of Ashok Gehlot-led Congress government. The Congress is looking for a good show in Chhattisgarh, Madhya Pradesh and Rajasthan. Ahead of the assembly polls, the Congress has been promising guarantees in Madhya Pradesh, having resemblance to what the party has delivered in Rajasthan. The Congress on Monday also made several promises for Madhya Pradesh, taking a cue from Rajasthan, Karnataka and Himachal Pradesh.

AFTERSHOCKS OF MANIPUR VIOLENCE FELT ALL ACROSS NE STATES

he after-effects of the recent ethnic violence in Manipur, which claimed 73 lives, injured 250 and caused large scale damage to houses and various other properties, hit the other northeastern states. Several states in the country made special arrangements and

brought out their citizens from strife-torn Manipur. After widespread ethnic violence broke out in Manipur on May 3, so far 6,665 men, women and children have taken shelter in several Mizoram districts while over 3,000 people have sheltered in Cachar district of southern Assam.

Thousands of students and other people, belonging to seven northeastern and other states of the country, were rescued by their state governments after making special arrangements.

Hundreds of students of all the northeastern and other states have been studying in the Imphal based Regional Institute of Medical Sciences, Central Agricultural University and other Central government run institutions.

Non-tribal Meiteis and the tribals belonging to Chin, Kuki, Mizo, Zomi, Chakma have been living both in Manipur, Mizoram and several other northeastern states leading to occasional violent reaction after an ethnic incident in a particular state

The erstwhile princely states of Manipur and Tripura merged with the Indian Union in October 1949. The recent ethnic violence shocked not only Manipur but also other northeastern states due to the similarity among various ethnic people.

In 1993, Hindu-Muslim riots in Manipur claimed the lives of around 100 people and injured over 300 people belonging to the Meitei Pangals (Meitei Muslims) and the Hindu Meiteis. Both the recent ethnic violence and the 1993 communal

riots occurred in the month of May The 1993 riots broke out when Muslim gun smugglers could

not deliver the promised arms consignment to Hindu "criminals" and then beat up some Hindus.

The ethnic violence in Manipur since May 3 have claimed the lives of at least 73 people and injured 250 others, while 1,800 houses were destroyed besides a large number of government and private properties along with religious installations.

Widespread ethnic violence leading to clashes, arson, vandalisation, random destruction of government, private properties including temples and churches broke out in Manipur after a 'Tribal Solidarity March' organised in the 10 hill districts on May 3 to protest against the Meitei community's demand for Scheduled Tribe (ST) status.

Mizoram Chief Minister Zoramthanga, in a letter to his Manipur counterpart N. Biren Singh, had said that he is deeply pained by the violence that has flared up in Manipur and the underlying tension between the Meitei community and tribals there

"At a time when our two states are already facing issues as a result of the political situation in Myanmar and Bangladesh



and the lingering effects of Covid-19, including the prospect of a new wave with more and more cases being detected, such violence only makes things worse," said Zoramthanga, who is also the president of the ruling Mizo National Front.

Zoramthanga requested Biren Singh to exercise his leadership that the people of Manipur know he is capable of and reach out to all parties involved to try and bring an end to this senseless violence.

He assured the full cooperation of his government and the people of Mizoram as they pray for reconciliation and healing in the state of Manipur.

Meanwhile, hundreds of Meiteis, including a large number of students, held a protest in Guwahati in the wake of the violence that paralysed Manipur for many days.

Ten tribal MLAs belonging to the Kuki community have demanded a separate state for the Manipur tribals. The ten legislators, including seven ruling BJP MLAs, sent a memorandum to Union Home Minister Amit Shah in support of their demand.

The 10 tribal MLAs from Manipur, leaders of Indigenous Tribal Leaders' Forum (ITLF), Kuki Inpi Manipur (KIM), Zomi Council, Hmar Inpui (HI) and other Civil Society Organisations (CSOs) from Manipur unanimously resolved to unitedly face the present "ethnic crisis" in Manipur.

The meeting held at Aijal club in Aizawl, Mizoram on Thursday also resolved not to engage in any dialogue with the Manipur government.

Further, the meeting lecided to hold consultations on a wider scale at he earliest to arrive at a common political agenda vith other groups.

The delegates at the neeting expressed their gratitude to the Mizoram government, NGOs, churches in particular and the people of Mizoram in general for providing humanitarian assistance to the displaced people and those affected by the violence.

Ruling Mizo National Front MP C. Lalrosanga had urged Army chief General Manoj Pande to gain the people's trust and confidence, especially of the tribal communities, to control the ethnic strife in Manipur.

The North East Students' Organisation (NESO), an apex body of eight major

students organisations of seven northeastern states, condemned the Manipur government's action evicting the indigenous settlers belonging to the Zo community and the violent incidents that followed.

"The tribals were evicted on the pretext that they are settling on reserve forest whereas the fact is that these indige nous settlers have been residing in these areas for ages.

'The government of Manipur has to take into account that these are the indigenous communities of northeast and have inhabited these lands from their forefathers and they are not illegal immigrants from Nepal or Bangladesh,' NESO chairman Samuel B. Jyrwa and general secretary Mutsikhovo Yhobo said in a joint statement.

The Mizo students' Association, also known as Mizo Zirlai Pawl (MZP), Mizoram's apex students' body, has accused the Manipur government of grabbing Zo ethnic tribals' land in the neighbouring state and evicting them.

"The origin of these problems is the Manipur government's attempts to evict ethnic Zo people from their various settlements so that their lands can be taken from them and these tribal lands can be declared reserved forest, protected forest, wildlife sanctuaries and wetlands," the MZP had said in a statement.



etting another record, Nepal's legendary climber, Kami Rita Sherpa, summited Mt. Everest for an unprecedented 28th time on Tuesday, just a week after he scaled the world's tallest peak for the 27th time

The 53-year-old reached the summit of the 848.86metre peak at 9.23 a.m., reports Xinhua news agency

"Kami Rita Sherpa has made history by scaling Mt. Everest for the 28th time on Tuesday," reported Bigyan Koirala, an official at the mountaineering division of Nepal's Department of

Tourism. "His health condition is stable, and he is currently

descending to the lower camps," informed Migma Sherpa, the chairperson of the Seven Summit Treks, the agency with which Kami has been associated.

On May 17, Kami had ascended the mountain for the 27th time. Another Nepali guide,

Pasang Dawa Sherpa, also made it to the summit for the 27th time on Monday. Kami Rita had scaled Mt.

Everest for the first time on May 13, 1994. Besides Everest, he has

also climbed the K2 and Lhotse (one time each); Manaslu (thrice); and Cho

Oyu (eight).

He holds the record for most climbs over 8,000m'. His mountaineering journey began in 1992 when he joined an expedition to Everest as a support staff member.

Similarly, British mountain guide Kenton Cool also broke his own record as he stood on top of Everest for a record 17 times.

He has the most summits of the Everest by any foreign climber.


A record 478 climbers from 65 countries and regions have been granted permits to climb Mt. Everest during the spring climbing season.

"We are challenging Montana's unconstitutional TikTok ban to protect our business and the hundreds of thousands of TikTok users in Montana," the platform said in a tweet.

"We believe our legal challenge will prevail based on an exceedingly strong set of precedents and facts," it added.

TikTok has been facing immense pressure in the US in recent months, amid cries for a nationwide ban.

Last week, in an effort to protect residents from alleged Chinese intelligence gathering, Gianforte signed a bill ban-




ning TikTok in the US state. It was the first US state to ban this popular short video app.

"To protect Montanans' personal and private data from the Chinese Communist Party, I have banned TikTok in Montana," Gianforte tweeted.

The bill prevents TikTok from operating "within the territorial jurisdiction of Montana" and requires that its app be removed from Montana mobile app stores

Not just TikTok, the Governor also banned Telegram Messenger, Chinese app WeChat, Temu, CapCut and Lemon8.

Montana's new policy will come into effect on June 1.

MUMBAI SEA BRIDGE, INDIA'S LONGEST, WILL ALLOW "Not In PM Race": Sharad Pawar **COMMUTERS TO DRIVE PAST TOLL BOOTH AT 100 KMPH**

ndia's longest sea bridge, the under-construction Mumbai Trans Harbour Link (MTHL), will be the first sea bridge in India to have an Open Road Tolling (ORT) system, allowing commuters to drive past the toll booth at speeds of up to 100kmph without slowing down to pay the toll charge.

Built at a cost of around Rs 18,000 crore, the MTHL, after completion, will cater to around 70,000 vehicles. We visited the 16.5 km long deck that will be completed by May 24. Around 95% of the work has been done, and the bridge will be completed before the year-end.

Work on structures is almost complete. Tomorrow evening, at an event, we are going to connect the bridge to the mainland. The remaining work -road laying, electrical, intelligent transport system (electronic tolling) -will be done after the event. It is possible to achieve the target we set two years ago, to finish by December end



this year." SVR Srinivas, the commissioner of Mumbai Metropolitan Region Development Authority, said. The bridge is not just an "engineering marvel", but also an engine of economic growth, he added. This bridge will connect Mumbai

to the mainland with a commute time of 12 to 15 minutes, cutting down significantly from several hours it takes today, Srinivas explained, adding that it will facilitate ease of movement for raw materials, finished goods, and labour, creating a new supply chain

between Mumbai and the mainland. MTHL aims to connect Mumbai with Navi Mumbai, the financial capital's satellite city, in order to mitigate traffic congestion and promote eco-

nomic development. The bridge will begin in Sewri, South Mumbai, will cross Thane Creek north of Elephanta Island, and will terminate at Chirle near Nhava Sheva. Maharashtra Chief Minister Eknath

Shinde and his deputy Devendra Fadnavis will visit the site on Wednesday evening. The MTHL was planned around 30 years ago to speed up the traffic between Mumbai and Navi Mumbai and also facilitate the traffic from Mumbai to Pune and Goa.

The MMRDA awarded contracts for the project in November 2017, construction began in April 2018, and was scheduled to complete within 4.5 years. However, construction was delayed by around eight months due to the COVID-19 pandemic and is currently expected to complete by December 2023.

Mumbai: Former Lok Sabha Speaker and ex-Chief Minister of Maharashtra Manohar G. Joshi has been admitted to a private hospital for certain complications arising out of a brain tumour, official sources said here on Tuesday. Joshi, 86, was rushed to the P.D. Hinduja Hospital in Mahim and was taken to the ICU under the care of a team of senior doctors and neurosurgeons. A hospital medical bulletin said this afternoon that he was brought there in an emergency semicoma condition, but breathing on his own, and not on a ventilator. His condition was described as 'stable, but continues to need critical management', as per the statement. Former CM and Shiv Sena (UBT) President Uddhav Thackeray, wife Rashmi and other family members and party leaders rushed to the hospital to enquire after Joshi's health. Joshi was the first Shiv Sena CM for four years (1995-1999) when the party bagged power in alliance with Bharatiya Janata Party. Later, he served as the Speaker of Lok Sabha (2002-2004) during the tenure of the late Prime Minister Atal Behari Vajpayee, becoming only the second from the state after the Congress' Shivraj Patil (1991-1996) to occupy the august office.

Mumbai Court Says As Per Rule, Sex Work An Offence Only In Public: Report

sessions court in Mumbai has set aside a magistrate's order and directed a shelter home to set at liberty a 34year-old woman sex worker detained there.

The court said, as per rule, sex work can be called an offence when only one engages in it in a public place causing annoyance to others.

The woman approached the sessions court after the magistrate's court on March 15 this year directed her to be detained at the shelter home in Mumbai for one year for care, protection and shelter.

Additional sessions judge CV Patil set aside the magistrate court's order last month. The detailed order was made available recently

The woman was detained in February following a raid at a brothel in suburban Mulund. Thereafter, an FIR was registered against the accused and she, along with two others, was produced before a magistrate court in Mazgaon.

After perusal of the medical report, the magistrate found she was a major and sent her to the Navjeevan Mahila Vastigriha, Deonar, for one year for care, protection and shelter from the



date of order.

In her plea before the sessions court, the woman denied indulging in any immoral activities.

The sessions court in its order held that the magistrate, only on the ground of antecedent of indulging in similar kind of offence, has detained the victim. The order is under challenge only on the ground of antecedent that the victim was found indulging earlier also in a similar act, but the victim is major. She has the right to do work, the judge said.

"As per rule, to involve in sex work is not itself an offence, but to do sex work in public place so as to cause annoyance to others can be called as offence," the sessions court said.

Further, it noted there was no allegation that the woman indulged in sex work in the public.

In such circumstances, detaining the victim only on the ground of one antecedent of the similar work is not proper, the sessions judge said.

The victim has two kids, they certainly need their mother, and if the victim is detained against her wish, it certainly curtails her right to move freely all over India, the court observed.

Hence considering the legal position, major age of the victim, the magistrate court's order dated March 15 needs to be set aside and the victim needs to be set at liberty, it said.

he Global Chess League (GCL) on Tuesday announced a steller line-up including current World Champion Ding Liren of China and his two predecessors and five-time Champions, Magnus Carlsen of Norway and Viswanathan Anand of India, along with four-time Women's World champion Hou Yifan for the inaugural edition to be held in Dubai next month.

The first season of the Global Chess League - a joint venture between Tech Mahindra and the world chess federation, FIDE, to be played in team format -- will be held at the Dubai Chess and Culture Club from June 21 to July 2, 2023, in association with the Dubai Sports Council.The competition will be held in a one-of-a-kind joint team format at GCL, with each team consisting of six players a minimum of two women chess players per team.

To add to the thrilling level of competition. four more World Champions besides reigning Classical World Champion Ding Liren will be



competing in the Global Chess League. They are 2021 World Rapid Chess Champion Nodirbek Abdusattorov, 2008 Blitz Chess World Champion Leinier Dominguez, threetime Blitz Chess World Champion Alexander Grischuk, and 2018 World Rapid Chess Champion Daniil Duboy. It will also feature top female superstars, including Grandmaster Hou Yifan, a four-time Women's World Chess Champion and the second-highest-rated female player of all time.

At the end of the first 10 targets, Orynbay was the most accurate with 8 hits with four others including Darshna and Ganemat following with seven.Nikolaou was the first to be eliminated after 20-targets as Ganemat and Barbora continued to chase the Kazakh Orynbay, with Darshna trying to catch up, the National Rifle Association of India (NRAI) informed in a release on Tuesday. After 30 hits, the field was

down to four with Ganemat leading with 25, followed by Orynbay with 24 and Darshna and Barbora tied at 22.It was heartening to see the two Indians, in particular, Ganemat getting stronger as 118

the match progressed. The Czech was next to fall at the 40-target mark with 29 to her name, confirming a historic double medal for the Indians.
