UK BEGINS FIRST HUMAN TRIAL OF NEW ZIKA VACCINE

- The vaccine is being trialled by the University of Liverpool.
- India is also reportedly developing a vaccine against Zika.
- Although now not as prevalent as during its peak in 2016, Zika remains an ongoing threat, with thousands of cases of the mosquito-borne virus reported each year, mainly in countries close to the equator.
- Pregnant women continue to be the population at high risk for the infection as the virus can cause severe foetal birth defects.

The UK has begun the first human clinical trials of a new Zika vaccine, after it showed promising results in animal studies. It's hoped that the vaccine, designed to be suitable for use during pregnancy, will generate highly protective and long-lasting immunity. Having shown promising results in animal studies, the vaccine has now moved into a 'first in human' Phase I trial. If successful, the new trial could lead to a major breakthrough in tackling the Zika virus, for which there are still no approved vaccines or treatments available anywhere in the world. "Zika should not be forgotten especially since climate change is contributing to the spread of the Aedes mosquitoes (the mosquitoes that can carry the Zika virus) to countries where immunity is not there. Vaccines like ours will enable us to be better prepared for the next Zika outbreak," said Dr Krishanthi Subramaniam, a tenure-track research fellow who led on the studies demonstrating the effectiveness of the vaccine to lower virus levels in animals. Liverpool researchers used an approach to develop a vaccine based on studies to understand immunity to Zika and other related viruses.



The trial is open to healthy individuals aged between 18-59. Healthy volunteers recruited to the trial will receive two doses of the new vaccine to evaluate its safety, tolerability and its ability to produce an immune response. The vaccine will be assessed in groups of four volunteers at a time, with numbers increasing as evidence of safety accumulates. Up to 40 volunteers in this phase of work is planned which will be taking

place over the next nine months. In addition, the performance of the vaccine will also be assessed in people who have had exposure to other viruses that circulate in the places where Zika virus is found, such as dengue virus, or yellow fever vaccine. The vaccine work was supported by a 4.7 million pounds Innovate UK SBRI Vaccines for Global Epidemics award and includes collaborators from the University of Manchester, the UK Health Security Agency and industry.

Call to accelerate replacement of diesel school buses

- Led by the Canadian Partnership for Children's Health and Environment (CPCHE), a coalition of 34 organisations made the goal of all-electric school bus fleets in Canada the central focus of this year's national Healthy Environments for Learning Day (April 27).
- The joint call for urgent action by relevant decision-makers nationwide closely follows the publication in January of new scientific evidence from British Columbia that even "brief diesel exhaust exposure acutely impairs functional brain connectivity".
- While adult subjects were studied, the new research raises further concerns about impaired brain function and learning ability of children breathing diesel fumes.

Health and environmental advocates have called on communities, school boards and governments at every level to accelerate the electrification of school buses, replacing tens of thousands of diesel-powered school buses spewing toxic fumes that can seriously harm child health and interfere with learning. Other research has warned that diesel exhaust may impede child neurodevelopment, spatial learning, attention and memory, and contributes to a myriad of other physical and mental health problems, as well as climate change. "Faced with the existential threat posed by climate change and mounting scientific evidence of the harm to children caused by traffic-related air pollution, including diesel exhaust, more comprehensive and urgent action is needed to bring electric school bus transportation to all communities across Canada," the declaration says. It underlines that "electric school buses are a viable solution that eliminates diesel bus emissions and exemplifies local action on climate change". The majority of Canada's 50,000 school buses use diesel fuel. Each year,



school buses make 792 million trips to carry roughly 2.2 million children to and from school. CPCHE Executive Director Erica Phipps said: "Buses operating close to schools mean that all children, not just those riding the buses, can be exposed to and affected by diesel exhaust. CPCHE and its collaborators have called on all levels of government to: Accelerate the shift to all electric school bus fleets across Canada, through policy and funding measures that support electric bus procurement, operation and infrastructure; Prioritise electric school bus adoption in communities facing disproportionate exposure to traffic-related air pollution; and Promote and celebrate the electric school bus as a way for children, families and communities to learn about and participate in climate action through the transition to zero-emission transportation in Canada. Along with the call for government action, the campaign is promoting videos and other educational resources to catalyse and inform local efforts to support the shift.

Plant seven trees to get bail: UP Official's unique initiative

Inmates in Bijnor jail in Uttar Pradesh will now have to give an undertaking that they will plant at least seven trees if they wish to get a bail. The initiative has been started by Mange Ram Chauhan, presently posted as SDM in Bijnor district. He had launched a similar initiative when he was posted in Amroha district. As part of the drive, he began taking undertakings from those accused of CrPC sections 107/116/151 and seeking bail. "They had to plant trees on their property, nurture them and provide pictorial evidence of it in court hearings," the SDM said. "Similarly, the two guarantors, too, were supposed to plant one sapling each. Humans cannot survive without plants. When the surroundings are green and pure with plants, then society also thrives and remains healthy," he told reporters. The SDM's effort have apparently borne fruit and he said that so far, close to 20,000 saplings of various tree species have been planted as part



of the initiative in Amroha and Bijnor districts.

I'VE BEEN TERRIBLE AT PARTNER WORK: HRITHIK ROSHAN

Mumbai: Bollywood star Hrithik Roshan spoke about a dancing style he wishes to learn and said that it is "partner work" he is terrible at. Hrithik said: "I've been terrible in partner work. Ancient DNA research confirms West Eurasian genetic imprints in Pattanam

The archaeological site at Pattanam, on the southwestern coast of Kerala's Indian subcontinent in Kerala's Ernakulam district, is believed to be part of the ancient port city of Muziris. Historians consider the city of Pattanam to have played an instrumental role in trade and cultural exchanges between India and the Middle East, North Africa and the Mediterranean regions. At the Pattanam archaeological site, scientists and archaeologists have found human bones, storage jars, a gold ornament, glass beads, stone beads, utilitarian objects made of stone, copper, and iron, pottery, early Chera coins, brick wall, brick platform, ring well, wharf with bollards and a six meter long wooden canoe parallel to the wharf structure



about 2.5 meter below surface level. "These structures indicate a vast urban settlement. The excavations suggest that the site was first occupied by the ingenious 'Megalithic' (Iron Age) people, followed by the Roman contact in the early historic period. It appears that the site was continuously occupied at least from the

2nd century BC to the 10th century AD," said Dr Cheria, from PAMA Institute for the Advancement of Transdisciplinary Archeological Sciences, Ernakulam. Scientists used the DNA from human skeletons to pinpoint the generic ancestry of the people found in the region.

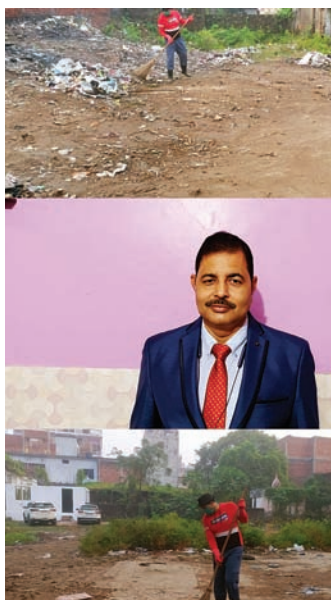
Gorakhpur's 'Jhadu Baba' is a businessman who cleans up streets daily

Once he was going to Jaipur, when he found a book was lying on the seat next to him. There was some mention about Mahatma Gandhi and cleanliness in the book. Showing the book, Shukla's wife told him that if he wants to keep his surroundings clean, then he should learn it from Gandhi ji.

- Famously known as 'Jhadu Baba', Mahesh Shukla of Gorakhpur's Gorakhnath area can be found sweeping the streets daily morning.
- Sweeping is his passion. He is a businessman by profession and runs a computer and camera shop in the city's Shahi Market.
- Shukla has been regularly cleaning his locality and surrounding areas since 2008. He cleans different neighbourhoods between 4 a.m. and 8 a.m.
- Shukla says that he does not do this for gaining any fame, but it is included in his habit. "Due to the awareness, now about 700 to 800 people are associated with us. I do all this work with my own money."

Vivek Tripathi | Gorakhpur

For the last 15 years, he comes out daily with a broom in his hand and cleans up the streets of Gorakhpur in Uttar Pradesh to awaken the spirit of cleanliness among people. He further says that the cleaning work is going on in different parts of the city. "On Monday, Tuesday and Wednesday, the cleaning work is done in Gorakhnath, Rajendra Nagar and Shastri Nagar respectively. While on Thursday and Sunday, I clean Ramgarh Tal area," he elaborates. "So far, around Rs 10 lakh has been spent on this work. There is an expense of about five brooms every week. Apart from this, the kit also includes water bottles. Honoring the cleaning staff of our area is also included in our routine," Shukla adds. "Actually, about 30-40 families reside at the street where I live. There was an electric pole next to my house. People used to throw the garbage there. In search of



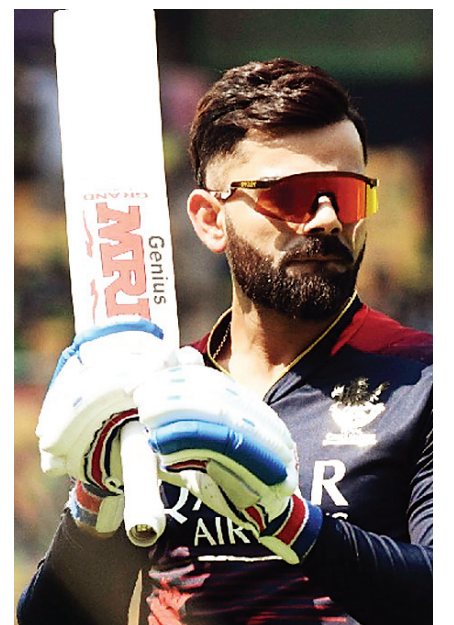
food, animals used to scatter the garbage and I used to feel very bad then. When interrupted, people used to start fighting. Since the garbage was usually disposed of

by women, debating with them seemed inappropriate," Shukla recalls. It worked out, but there were some hesitations in his mind initially, due to which, he used to collect the garbage in late night using broom so that no one should see him cleaning the garbage. Slowly, people started realising that "Shukla ji picks up our garbage" and about 50 per cent people stopped throwing garbage near the pole. All this took about six to seven months. His street became clean due to the initiative started by him and the efforts of the people. "Then I turned to the main road and the parks," he says. The broom and the rest of the kit remain lying in the car. "Wherever I go by car. The morning routine starts with the broom itself. I have also gone to Indore, which is one of the best cities in terms of cleanliness, to see the arrangement there." Chief Minister Yogi Adityanath has also honoured him for his initiative.

CONGRESS CALLED AMBEDKAR 'DAGAABAAZ', PM RETORTS TO 'POISONOUS SNAKE'

Hitting back at the Congress over its "poisonous snake" jibe, Prime Minister Narendra Modi on Saturday said that the grand old party has again started hurling abuses at him.

"A list of abuses has been made and they have humiliated me 91 times," he stated.

Addressing a huge gathering at Humnabad in Bidar district, the Prime Minister launched a scathing attack on the Congress. Instead of wasting their time on a dictionary of abuses, had they utilised their time on good governance and welfare of party workers, the party would not have reached this "pathetic" state.

"Congress has abused the architect of the Indian Constitution and also dared to brand Lingayat brothers and sisters as 'chor' (thieves)," PM Modi asserted.

Prime Minister Modi stated that the top Congress leaders have always bad-mouthed great personalities. "You will be shocked to know about it. Babasaheb Ambedkar explained



everything in detail at a public meeting. The Congress has called him "raakshas" (demon), "rashtra drohi (traitor to nation), 'dagabaaz'

(cheater)," PM Modi stated. Throughout, Congress had abused Ambedkar and humiliated him time and again. Whoever is poor and

working for the nation will be insulted by the Congress. "In the last elections, first they said 'chowkidar chor hai', later they said 'Modi chor hai', and afterwards they said 'OBC chor hai'. During Karnataka elections they are calling Lingayat brothers and sisters as chor (thieves)," he alleged.

"Whoever you have humiliated have given befitting answers and Congress was nowhere to be seen. Great personalities are victims of the Congress.

They targeted Ambedkar, Veer Savarkar and by targeting me, they have brought me in their league. You (Congress) be busy with hurling abuses, I will focus on serving people," PM Modi stated.

He made a pledge to depute the whole of New Delhi for Karnataka's welfare and make it a number one state in the country. "I want a majority government here. I repeat the full majority. A double engine government is needed for development, infrastructure, and FDI. Karnataka should not become the Congress' ATM but emerge as the country's growth engine," he underlined.

Arrested Trinamool MLA drawing double salary as MLA and teacher

Trinamool Congress legislator Jiban Krishna Saha, who was recently arrested by the CBI in connection with the alleged multi-crore recruitment scam in West Bengal, has now been reported to be drawing double salary -- both as an MLA and as a teacher in a state-run school.

The authorities of Debagram High School in Birbhum district, where Saha was a teacher, has reported to the state school education department that despite not attending his teaching duty for a single day since he became an MLA in 2021, Saha had been drawing his salary on a regular basis.

The school authorities have also recommended that the credit of his salary to his bank account should be stopped immediately.

Sources in the school education department said that



the school authorities have sent the recommendations to the office of the district inspector of schools of Birbhum and the papers will be sent to the state education directorate by next week, which again will forward its recommendations to the education department.

The CBI had arrested Saha from his residence on April 17, and he is currently under its custody. Saha is the third Trinamool legislator to be arrested by the central agencies, the previous two being former Education Minister Partha Chatterjee and ex-President of West Bengal Board of Primary Education, Manik Bhattacharya.

BSP MP Afzal Ansari sentenced to 4 yrs in jail, may lose LS membership

BSP MP Afzal Ansari faces disqualification from Lok Sabha after an MP-MLA Court here on Saturday convicted and sentenced him to four years imprisonment in a Gangsters Act case.

The court also imposed a fine of Rs 1 lakh on Afzal Ansari.

As per Parliament norms, any member sentenced to two years or more in prison automatically stands disqualified.

Earlier in the day, the same court convicted and sentenced Afzal's younger brother, jailed gangster-turned-politician Mukhtar Ansari, to 10 years in the same Gangsters Act case.

The court also imposed a fine of Rs 5 lakh on Mukhtar



Ansari.

It may be noted that a case was registered against Mukhtar and Afzal under the Gangster Act for their involvement in the murder of BJP MLA Krishnanand Rai in 2005 and kidnapping of businessman Nandkishore Rungta in 1996.

Afzal Ansari, his brother

Mukhtar Ansari and brother-in-law Ejazul Haque were booked under the Gangster Act in 2007 in this case.

Ejazul Haque has passed away. The hearing in this case was completed on April 1. Earlier, the decision in this case was to come on April 15, but later the date was extended to April 29.

Wife of slain IAS officer moves SC against Anand Mohan's release

The wife of IAS officer G. Krishnaiah, who was lynched in 1994 by a mob led by former Bihar MP Anand Mohan Singh, has moved the Supreme Court against the latter's premature release from prison.

The plea filed by Uma Krishnaiah, the wife of G. Krishnaiah, contended that life imprisonment awarded as a substitute for death penalty has to be carried out strictly as directed by the court, and it would be beyond application of remission.

The plea submitted that life imprisonment handed down to the gangster-turned-politician meant incarceration for his entire natural course of life.

Anand Mohan was released from the Saharsa jail on Thursday morning following an amendment in Bihar's prison rules.

Under fire over the release of Anand Mohan, Bihar Chief Minister Nitish Kumar had claimed during an event on Friday evening that the decision was based on the Centre's 'Model Prison Manual 2016'.

While referring to a book he carried with him,



Nitish Kumar said: "This is a book on Model Prison Manual 2016. Please go through it and tell me

whether any provision says that if an IAS officer gets killed, the convict will have to stay in jail for his entire life?"

"There is no such law in any state of the country. Hence, we have removed it in Bihar. He (Anand Mohan) was serving a jail term for more than 15 years. In depth discussions preceded the decision. Since 2017, 22 meetings of remission ('parihar') have taken place in Bihar and 696 prisoners have been released. A number of inmates were released on my recommendation on Republic Day, Independence Day and birth anniversary of Mahatma Gandhi," he added.

He also asked if there is any difference in law required for common people and a government official.

"Though 27 inmates have been released, why is it that only one person's release is being opposed," he asked. In 1994, Krishnaiah, then District Magistrate of Gopalganj, who hailed from Telangana, was beaten to death by a mob when his vehicle tried to overtake the funeral procession of gangster Chhotan Shukla. The mob was reportedly instigated by Anand Mohan.

WOMAN HELD AT CHENNAI AIRPORT WITH 22 SNAKES

New Delhi: The Customs officials have arrested a woman at the Chennai airport with 22 snakes of various species.

The woman arrived at the Chennai airport on April 28 from Kuala Lumpur by Flight No. AK13. She was intercepted by the Customs officials on the basis of suspicion.

"On examination of her checked-in baggage, 22 snakes of various species were found along with a chameleon. The reptiles were seized under the Customs Act, read with the Wildlife Protection Act," an official said.

The woman was produced before a local court on Saturday, which sent her to 14-day judicial custody.

FORMER BJP MLA SURRENDERS IN SASARAM COMMUNAL VIOLENCE CASE

Former BJP MLA Jawahar Prasad has surrendered before a district court in Bihar's Sasaram in connection with communal violence during Ram Navami celebrations on March 31.

A Non-Bailable Warrant (NBW) was issued against Prasad for his alleged connection in the violence.

Prasad, who was absconding since then, finally surrendered before district court on Friday evening.

Confirming the development, spokesperson for Rohtas police said that an FIR was registered against Prasad in the town police station of Sasaram. "Following his surrender, we have arrested him and the process is to send him to judicial custody," he said.

Besides Prasad, another accused named Mohamad Shahnawaz Alam alias Lakhani also surrendered before court on Friday evening.

The official further said they have arrested 63 accused in connection with the violence. "The district police has obtained

NBW against 38 accused who were involved in communal violence and we are also going to start the process of property attachment against 12 persons as well," he said.

Meanwhile, Bihar Chief Minister Nitish Kumar has said that whoever is the culprit, he/she will be punished.

"The state police are taking action against the accused. We are not directing them for action. I want to tell them that whoever is the accused, the state police will take strong action," he said. "Our government would neither frame nor save anyone. Police are looking after everything and taking action on the wrongdoings. Everyone knows I do not interfere in the work of the police," the chief minister said.

The communal violence erupted in Sasaram and Nalanda during Ram Navami celebrations, just before the rally of Union Home Minister Amit Shah. Following the incidents, the BJP blamed the Nitish Kumar government for failing to control law and order in the state.



TWO ARMY SOLDIERS KILLED IN J&K ROAD ACCIDENT

Jammu: Two army soldiers were killed on Saturday in a road accident in J&K's Rajouri district.

Officials said that two army soldiers were killed when the vehicle they were travelling in went out of the driver's control at Dunganon Nallah in Rajouri district and fell into a deep gorge. "Two soldiers identified as Havaladar Sudhir Kumar and Paramvir Singh were injured in this accident.

"They were shifted to army hospital in Rajouri town where they succumbed," officials said.

Nitish defends Kejriwal on renovation cost row

Bihar Chief Minister Nitish Kumar has come out in support of his Delhi counterpart Arvind Kejriwal -- facing criticism for allegedly spending Rs 45 crore on renovation of his official residence --, saying strong people who are emerging as "threats" to BJP bigwigs are being targeted.

"Criticism started the day a person won elections in

Delhi and gradually made inroads into other states. These attacks reflect the insecurity of the ruling party. Is it right to attack a person just because he has the potential of winning elections?" Kumar said after participating in an event here on Friday evening.

"I knew Arvind Kejriwal even when he hadn't stepped into politics. When he entered politics, he took the people with his huge suc-

cess. Taking on people just because one is insecure is not ethical and I never indulge in it," the Bihar CM underlined.

The BJP has been demanding Kejriwal's resignation ever since reports of him spending Rs 44.78 crore on repair works of his official residence at the civil lines, surfaced. The said was reportedly spent between September 2020 to June 2022 in six installments.

NIGHT CURFEW IMPOSED IN MANIPUR DISTRICTS AMID VIOLENCE

The situation in the trouble-torn Churachandpur district in Manipur remained tense on Saturday, with miscreants setting afire a government building.

The district administration imposed a night curfew from Saturday in the mountainous district, where the agitators also set ablaze an open gym, chairs and damaged other materials on Thursday night.

Police said that since Friday night, some incidents of violence have also been reported in the tribal-dominated Kangpokpi and Tengnoupal districts.

The incidents of violence were triggered after the tribals launched fresh protests against the state government's action against the illegal poppy cultivators and destroying poppy fields in the forest land, especially in the reserve and protected forests in the hilly areas.

Director General of Manipur Police P. Doungel and senior officials on Saturday visited Churachandpur district and reviewed the situation.

Police said that some agitators set afire the office building of the Forest Range Officer in the Tuibong area around Friday midnight, and several fire tenders were pressed into service



to douse the flames.

Churachandpur district administration on Saturday imposed the night curfew for an indefinite period from 5 p.m. to 5 a.m.

A police officer in Imphal said that the situation is still grim though heavy security measures have been taken to prevent fresh incidents of violence. Veteran Congress leader and three-time former Chief Minister Okram Ibobi Singh and state Congress president K. Meghachandra Singh criticised the BJP government and Chief Minister for the "wrong policy in dealing with the tribals and forest lands". After Thursday's incidents of violence, Manipur Chief Minister N. Biren Singh cancelled his Friday's visit to Churachandpur dis-

trict.

Biren Singh was scheduled to address a public gathering at Sadbhavna Mandap in New Lamka Town in Churachandpur on Friday and inaugurate an open gym at PT Sports complex. Saying that his government is committed to protecting people from the drug menace, the Chief Minister on Saturday reiterated that poppy cultivation in the state would be completely wiped out.

The BJP government in the state would not allow poppy cultivation and has been taking continued actions against those involved in such plantations, he told the media.

Vandalism occurred and clashes erupted between demonstrators and police at Sadbhavna Mandap on

Thursday night, leading security forces to lob tear gas shells to disperse a large crowd of local tribals, who also pelted stones at security forces deployed to keep the peace in the bandh-hit town.

There was no major injury on either side. Police claimed that the Myanmarese, who illegally entered into the state, were also involved in the arson incident. Biren Singh said in Imphal that police would take stern action against the trouble makers. The Indigenous Tribal Leaders' Forum (ITLF) has called for an eight-hour shutdown in Churachandpur district on Friday from 8 a.m. to protest the state government's eviction drive from the protected and reserve forests. The ITLF in a statement said that they had submitted several memoranda to the state government expressing their grievances and apprehensions about the survey carried out by the government pertaining to reserve forests and protected forest, wetlands and wildlife, and the eviction of villagers.

In support of their demands, tribals organised protest rallies on March 10, against the state government in three districts -- Churachandpur, Kangpokpi and Tengnoupal, in which five people were injured in those incidents.

SEBI SEEKS MORE TIME FROM SC FOR HINDENBURG-ADANI PROBE

'COMPLEX MATTER'

Sebi, in an application moved in the apex court, said: "Applicant/SEBI most respectfully submits that keeping in view the forgoing circumstances, it would take further time to arrive at verified findings and conclude the investigation... for ascertaining possible violations related to mis-representation of financials, circumvention of regulations and/or fraudulent nature of transactions in respect of 12 suspicious transactions... given the complexity of the matter, SEBI in the normal course would take at least 15 months for completion of the investigation of these transactions, but is making all reasonable endeavours to conclude the same within six months."

The Securities and Exchange Board of India (Sebi) on Saturday moved the Supreme Court seeking six-month extension to complete its probe into the Hindenburg allegations of "stock manipulation" by the Adani Group. Sebi submitted that in order to conduct a proper investigation and arrive at verified findings, it would be just, expedient and in the interest of justice that the apex court extends time to conclude the investigations by at least six months. The apex court, in an order passed on March 2, had set a deadline to submit a status report on May 2, while asking Sebi to expeditiously conclude the investigation and file a status report. Sebi said that replies and documents/information received from the companies would require

reconfirmation and reconciliation, as well as independent verification. "The applicant/SEBI also respectfully submits that in respect of the investigation/examination relating to 12 suspicious transactions, prima facie it is noted that these transactions are complex and have many sub-transactions and a rigorous investigation of these transactions would require collation of data/information from various sources along with detailed analysis, including verification of submissions made by the companies," the application said. It also said that this analysis would include detailed examination of the following: Financial statements of listed entities and unlisted entities; financial statements of offshore entities involved in the transactions; disclosures filed with the stock exchanges including annual reports, balance sheets, quarterly financial state-

ments and other event-based disclosures; minutes of the meetings of their board of directors and audit committee, wherever applicable; bank statements of the concerned entities for the relevant period (the allegations span over a 10 year period); connections/relations are amongst entities, both domestic and overseas; and, contracts and agreements, if any, entered between the entities along with other supporting documents. "The applicant/SEBI further submits that this process of seeking bank statements from the offshore banks would entail taking assistance from offshore regulators, which may be time consuming and challenging. The applicant/SEBI submits that only thereafter, analysis would have to be conducted for the voluminous bank statements," said the application. Sebi said that as is the case in most investigations, every layer of information received often leads to further layers of information that are required, sought, obtained and analysed and this process is particularly time consuming where there is a complex web of transactions. In its order passed on March 2, the Supreme Court had announced an expert committee to examine India's investor protection framework in response to petitions following the crash in Adani Group securities against the backdrop of the Hindenburg Research report released in January. The Adani Group had rejected the report. The apex court had noted that it appears that Sebi is seized of the investigation into the allegations levelled against the Adani Group companies.

Protesting wrestlers receive copy of 1 FIR lodged against WFI chief

The Delhi Police will provide security to seven wrestlers, including a minor, who have come forward with allegations of sexual exploitation against Wrestling Federation of India (WFI) president Brij Bhushan Sharan Singh, said an official.

Won't resign: Brij Bhushan

"Resignation is not a big deal but I am not a criminal. If I resign, it will mean that I have accepted their (wrestlers') allegations. My tenure is almost over (next month). The government has formed a three-member committee and elections will be held in 45 days and my term will end after the elections."

Delhi Police on Saturday said that a copy of one of the two FIRs lodged against outgoing Wrestling Federation of India (WFI) President Brij Bhushan Sharan Singh who is accused of sexual harassment, has been handed over to the top grapplers who are protesting at the Jantar Mantar here. On Friday evening, the police have registered the FIRs against the WFI president in response to the allegations made by the women wrestlers. However, the copy of the other FIR registered under the Protection of Children from Sexual Offences (POCSO) Act has not been given to the wrestlers as it will be given only to the victim's family, the police added. The wrestlers, led by Vinesh Phogat, had reached the Connaught Place police station on Saturday morning. On Friday, Delhi Police had informed the Supreme Court that they will register an FIR and in the evening, two FIRs allegedly were finally registered against the outgoing WFI chief in connection with the sexual harassment allegations made by women wrestlers. Investigation into both the FIRs is being taken up in right earnest, the Deputy Commissioner of Police, New Delhi, Pranav Tayal said.



Priyanka, Kejriwal joins protesting wrestlers

New Delhi: Congress General Secretary Priyanka Gandhi Vadra and Delhi Chief Minister Arvind Kejriwal on Saturday visited the wrestlers protesting against WFI chief. Priyanka Gandhi accused the Centre of "protecting" the outgoing WFI chief. Speaking to reporters, the Congress leader said, "I don't have any expectations from the Prime Minister, because if he had been concerned about these wrestlers, then he would have at least called them and spoken with them. He had called them for tea when they won medals. So, call them, talk to them, they are our girls. There are serious allegations against this person, he should first resign and be removed from the post." Delhi Chief Minister Arvind Kejriwal also met the wrestlers protesting at the Jantar Mantar and urged people to come forward and support the athletes. Kejriwal said, "Regardless of political affiliation, be it the BJP, Congress or AAP, all those who love the country should support the protesting wrestlers. While we will provide them with all the necessary support, I appeal to the Central government to refrain from cutting off basic facilities such as water and electricity."

Mukhtar Ansari gets 10-year jail term in MLA murder case

Ghazipur: The MP-MLA court in Ghazipur on Saturday sentenced gangster-turned-politician Mukhtar Ansari to 10 years in jail for the kidnap and murder of BJP MLA Krishnanand Rai. The court also imposed a fine of Rs 5 lakh on Ansari. Mukhtar Ansari, who's lodged in Banda Jail, was presented through video conferencing. In 2005, seven people, including Krishnanand Rai, were murdered in Basaniya Chatti under the Muhammadabad police station. In 2007, a case was filed under Gangsters Act against Ansari brothers in connection with the kidnapping and murder of Rai. Apart from the Rai murder case, there is also a case of kidnapping and murder of Nandkishore Rungta against Mukhtar Ansari.

ED raids BYJU's; claims it remitted Rs 9,754 cr to foreign jurisdictions

The Enforcement Directorate (ED) has conducted search and seizure operations at three premises of Raveendran Byju and his company 'Think & Learn Private Limited' in Bengaluru under the provisions of Foreign Exchange Management Act (FEMA), an official said on Saturday. The company runs a popular online education portal by the name of BYJU's. During the searches, various incriminating documents and digital data were seized. "FEMA searches also revealed that the company has received foreign direct investment to the tune of Rs 28,000 crore between 2011 and 2023. Further, the company has also remitted Rs 9,754 crore to various foreign jurisdictions during the same period in the name of overseas direct investment," said the official. According to the ED, the company



has booked around Rs 944 crore in the name of advertisement and marketing expenses, including the amount remitted to foreign jurisdiction. It alleged that the company has not prepared its financial statements since financial year 2020-21 and has not got the accounts audited which is mandatory. Meanwhile, BYJU's legal team spokesperson said that the recent visit by officials from the Enforcement Directorate (ED) to one of their offices in Bangalore was related to a routine inquiry under FEMA.

Delhi court extends Sisodia's ED custody in excise policy case

New Delhi: A court here on Saturday extended former Deputy Chief Minister of Delhi, Manish Sisodia's custody till May 8 in connection with the excise policy case being investigated by the Enforcement Directorate (ED). On Friday, Special Judge M.K. Nagpal of the Rouse Avenue Court had denied bail to Sisodia holding that the evidence, prima facie, "speaks volumes" of his involvement in commission of the offence. The judge had also said that the purported medical condition of Sisodia's wife was not a reason to grant him bail in this case. Additionally, he stated that it was impossible to rule out the potential of Sisodia influencing key witnesses in the case. The judge noted that the alleged offence against Sisodia was a "serious economic offence of money laundering" and that he has not been accused of committing the offence in his personal capacity, but rather in his official capacity as a public servant overseeing the Excise Ministry and serving as Delhi's Deputy Chief Minister. On Thursday, the same court extended Sisodia's judicial custody till May 12, in the case being probed by the Central Bureau of Investigation (CBI).

25 per cent Mumbai Metro fare concession from May 1

Citizens aged above 65 years, 'divyang' (disabled) persons and students up to Class 12 can avail of a 25 per cent concession in the fares of Mumbai Metro - Line 2A and 7 - from May 1, celebrated as Maharashtra Day, said Chief Minister Eknath Shinde on Saturday. A statement issued by the Chief Minister's Office said that the benefit will be extended to thousands of holders of the National Common Mobility Card (Mumbai One). The discount will be given on Mumbai One passes for 45 or 60 trips, it said. Shinde called the move a gift to Mumbai residents from Maha Mumbai Metro Operation Corporation Ltd (MMMOCL), which operates and maintains Metro Lines 2A and 7, and the



Mumbai Metropolitan Region Development Authority (MMRDA). Metro 2A (yellow line) connects Dahisar E and DN Nagar in Andheri West, while line 7 runs between Andheri E and Dahisar E (red line). To avail of the concession, divyang persons will need to submit valid documents like medical or government certificates for disability, while senior citizens will have to provide age proof. Students will have to show their or their parent's PAN card along with school ID to be eligible for the concession, said the statement. These documents can be shown at any ticket window on the Line 2A and 7 route, it said. Shinde said his government has made travel free for senior citizens on state transport buses, while women can avail of a 50 per cent concession in bus fares.

Defamation Case: Gujarat HC to resume hearing Rahul Gandhi's appeal on May 2

The Gujarat High Court said on Saturday that it will resume hearing the appeal of Congress leader and former MP Rahul Gandhi against his conviction in a criminal defamation case on May 2. Rahul Gandhi was convicted in March by a metropolitan magistrate's court in Surat for making a remark about the 'Modi surname' during campaigning in Karnataka ahead of the 2019 Lok Sabha elections. The matter is being heard by Justice Hemant Prachchhak after Justice Geeta Gopi recused herself from the case. Senior Congress leader and lawyer Abhishek Manu Singhvi is appearing on Rahul Gandhi's behalf.



Rahul Gandhi had filed a criminal revision application in the Gujarat High Court challenging the order of the Surat sessions court declining a stay on his conviction. He was sentenced to two years in jail, which led to the disqualification of his Lok Sabha membership. If the high court allows his plea, it could pave the way for Rahul Gandhi's reinstatement as a Member of Parliament. After his conviction, the Congress was granted bail and given 30 days to file an appeal.

ChatGPT shows better empathy to patients than doctors

- There has been widespread speculation about how advances in artificial intelligence (AI) assistants like ChatGPT could be used in medicine.
- The study, published in JAMA Internal Medicine, compared written responses from physicians and those from ChatGPT to real-world health questions.
- A panel of licensed health care professionals preferred ChatGPT's responses 79 per cent of the time and rated ChatGPT's responses as higher quality and more empathetic.

ChatGPT outperforms physicians in providing high-quality, empathetic advice to patient questions, according to a study. "The opportunities for improving health care with AI are massive," said John W. Ayers from the Qualcomm Institute within the University of California San Diego. "AI-augmented care is the future of medicine," he added. In the new study, the research team set out to answer the question: Can ChatGPT respond accurately to questions patients send to their doctors? If yes, AI models could be integrated into health systems to improve physician responses to questions sent by patients and ease the ever-increasing burden on physicians. "ChatGPT might be able to pass a medical licensing exam," said Dr. Davey Smith, a physician-scientist, co-director of the UC San Diego Altman Clinical and Translational Research Institute, "but directly answering patient questions accurately and empathetically is a different ballgame."



According to researchers, while Covid-19 pandemic accelerated virtual health care adoption, making accessing care easier for patients, physicians are burdened by a barrage of electronic patient messages seeking medical advice that have contributed to record-breaking levels of physician burnout. To understand how ChatGPT can help, the team randomly

sampled 195 exchanges from Reddit's AskDocs where a verified physician responded to a public question. The team provided the original question to ChatGPT and asked it to author a response. A panel of three licensed health care professionals assessed each question and the corresponding responses and were blinded to whether the response originated from a

physician or ChatGPT. They compared responses based on information quality and empathy, noting which one they preferred. The panel of health care professional evaluators preferred ChatGPT responses to physician responses 79 per cent of the time. ChatGPT messages responded with nuanced and accurate information that often addressed more aspects of the patient's questions than physician responses, the study showed. Additionally, ChatGPT responses were rated significantly higher in quality than physician responses: good or very good quality responses were 3.6 times higher for ChatGPT than physicians. The responses were also more empathetic: empathetic or very empathetic responses were 9.8 times higher for ChatGPT than for physicians. However, the team said, the ultimate solution is not throwing your doctor out altogether. "Instead, a physician harnessing ChatGPT is the answer for better and empathetic care," said Adam Poliak, an assistant professor of Computer Science at Bryn Mawr College.



COURT REJECTS MADHYA PRADESH GOVT'S PLEA TO WITHDRAW 11-YR-OLD CASE AGAINST EX-MLA

A special court has rejected the Madhya Pradesh government's plea to withdraw an 11-year-old criminal case against former MLA Raghuraj Singh Kansana.

Last week, the state's Home Department had agreed to withdraw the 2012 case against the Gwalior-based BJP leader, who is accused of attempt to murder, obstructing public servant in discharging duties and voluntarily causing hurt to a public servant and dacoity.

While hearing the matter, Special Judge of the Gwalior District Court Sushil Kumar Joshi noted that the case involves serious offences, including rescuing criminals from the police custody.

"Hearing of the case is at the final stage, therefore, allowing its withdrawal would neither be in the interest of law nor public," the

court's order said.

In May 2012 when Kansana was the Morena panchayat chairman (then with Congress), a team of Delhi Police had arrived in the district to arrest his brother Sanjeev Singh Kansana in a non-bailable warrant issued by a court in the national capital.

After the Delhi Police took Sanjeev to the Morena City Kotwali, Raghuraj Singh Kansana and his aides freed him from custody and allegedly opened fire at the police team. In response, the Madhya Pradesh Police booked Raghuraj Singh Kansana and aides under IPC sections 307, 186, 353, 332, 224, 225, 398 (attempt to murder, obstructing public servant in discharging duties and voluntarily causing hurt to a

public servant and dacoity) and also provisions of the MP Dacoity and Kidnapping Affected Areas Act.

However, this is not the first time when Madhya Pradesh government attempted to withdraw the case against Raghuraj Singh Kansana.

In 2018 when he was elected as Congress MLA from the Morena seat, then then Kamal Nath-led government proposed to withdraw the case.

However, the state's law department in 2020 conveyed its disagreement to the Home Department.

Few months later, the Madhya Pradesh Congress suffered a major political jolt when Jyotiraditya Scindia along with 22 MLAs, including Raghuraj Singh Kansana, shifted to the BJP.

Infant dies on mother's lap after ambulance arrives 3 hrs late

A six-month-old infant has died due to the unavailability of an ambulance in the Datia district of Madhya Pradesh.

The death of a severely ill infant in the lap of his helpless mother at a community health centre (CHC) allegedly due to unavailability of ambulance has exposed the condition of public health services once again in Madhya Pradesh.

According to reports, a Scheduled Caste woman Renu Jatav, a resident of Baderi village, rushed her child to the Indergarh CHC at 11 a.m. on Thursday.

As the infant was suffering from acute pneumonic symptoms, the doctors present at the CHC referred the child to the Datia district hospital after preliminary treatment.



The helpless mother kept waiting for '108 Ambulance' for more than three hours despite the doctors repeatedly making phone calls.

It was more shocking that there were two ambulances (funded out of the MLA Local Area Development Fund) parked at the CHC, but their services weren't reportedly provided to the hapless mother, as she couldn't afford to pay the bill.

After repeated phone calls, 108 ambulance arrived after three hours, but till then the child had died in her mother's lap. Renu, the mother of the deceased child, blamed

the inadequate treatment at the CHC and delay in ambulance behind her child's death.

Taking cognisance of the matter, a team headed by the SDM, district's Chief Medical and Health Officer (CMHO), local police station-in-charge and tehsildar was sent by Datia District Collector to the Indergarh CHC on Friday to investigate the entire incident.

The team recorded statements of all stakeholders of Thursday's incident. Based on the recorded statements of all stakeholders, the enquiry team will fix responsibility for the alleged negligence. Asked about the delay in arrival of 108 Ambulance, Datia CMHO R. B. Kurele, said, "There is clear cut government protocol to first call on priority the free '108 Ambulance' at the earliest for a patient.

The Mumbai rally is expected to be a tester for the MVA's internal differences that keep bursting in the open at regular intervals, though the partners - Congress-Nationalist Congress Party-Shiv Sena (UBT) swear that all is well among them.

Putting up a united show, the three allies have got into the act with teasers for the rally planned in the Bandra Kurla Complex on Monday, which is also International Labour Day.

Recently, the MVA suffered a major hiccup amid reports that the NCP's Leader of Opposition in the Assembly



Ajit Pawar was planning to quit and switch over to the ruling saffron alliance of Chief Minister Eknath Shinde's Shiv Sena and the Bharatiya Janata Party. However, all the party

bigwigs ranging from NCP President Sharad Pawar have rubbished it as rumours, though his nephew Ajit Pawar has also unabashedly revealed his CM ambitions, keeping the issue

smoking.

The rally will also come in the wake of the strong opposition to the upcoming Arab-supported Ratnagiri Refinery & Petrochemicals Complex in Ratnagiri, with police caning and tear gassing of the protestors on Friday, resulting in strong reactions from the MVA.

The issue is likely to figure in a big way and serve to kickstart the campaign for the upcoming civic elections and later the parliament general elections. The rally will serve as an opportunity to the ex-CM and Sena (UBT) President Uddhav Thackeray to cover lost ground in the birthplace of the original Shiv Sena, founded by his father, the late Balasaheb Thackeray. However, after the vertical split in the party in June 2022, Thackeray lost the party name-symbol to the Shinde faction in Oct. 2022, but the matter continues to flare up at regular intervals.

2 killed, many feared trapped as godown collapses near Mumbai

At least two persons were killed and 10 others injured when a two-storey godown collapsed on Saturday in Bhiwandi city in Maharashtra's Thane district, civic officials said, adding at least 10-15 persons are feared trapped under the debris.

Two bodies have been extricated from the rubble of the ground-plus-two-storey building in Wardhaman Compound that collapsed at around 1.45 pm, Thane Municipal Corporation's Regional Disaster Management Cell chief Avinash Sawant said in the evening.

Two teams of the National Disaster Response Force (NDRF), a team of the State Disaster Response Force (SDRF), 10 fire engines, and



personnel of different agencies are carrying out relief and rescue operations at the site in Valpada in Mankoli area.

The dead included a 40-year-old man and a 26-year-old woman, Sawant said. Earlier, Sawant had said four families resided on the

upper floors and several labourers worked on the ground floor of the building. According to preliminary information, the godown was 10 years old, another official said. Senior officials and Union minister Kapil Patil, the local MP, are at the spot.

Cocaine worth Rs 10L found concealed in footwear; 2 held

Two people, including a Nigerian national, were held by the Mumbai Customs officers with cocaine worth Rs 10 lakh concealed in footwear.

A senior Customs official said that the accused were involved in previous cases too.

"On specific intelligence, the officers of SIIB/Courier Cell, APSC, Mumbai intercepted and seized 99 gms cocaine valued at Rs 10 lakh ingeniously concealed in three pairs of Slippers. A controlled delivery operation spanning over three days led to arrest of an Indian and Nigerian national," said the official.

"In view of the above, it was clear that the accused



had violated provisions of section 8 of the NDPS Act, and had committed an offence punishable under Section 21, Section 23 and Section 29 of NDPS Act. Accordingly, they were placed under arrest under

section 43(b) of NDPS Act," the official said.

The official said cocaine was seized along with concealing material under section 43(a) of NDPS Act.

Further investigation in the matter is on.

NEED TO RISE ABOVE DIFFERENCES: SHARAD PAWAR

Mumbai: There is a different kind of situation prevailing in the country, which is a cause of concern to many, and there is need to rise above political ideologies to strengthen the nation and end hatred, Nationalist Congress Party chief Sharad Pawar said on Friday.

Addressing his party's minority department meeting in Delhi, Pawar said brotherhood and humanity are needed in society to overcome problems faced by it.

"Today there is a different kind of situation prevailing in the country, which is a cause of concern to many. When there is a problem, lot of hard work is needed to find a solution.

If we don't strengthen brotherhood and humanity in society, the problem will not be resolved," Pawar asserted.

"We may have differences and have different political ideologies. We may belong to different religions and castes but we will have to work together to end hatred and create an atmosphere of brotherhood," the former Union minister said.

ED attaches properties worth Rs 4.09 cr in PMLA case

The Enforcement Directorate (ED) said on Friday that it has attached movable and immovable properties worth Rs 4.09 crore belonging to Deepak Kumar, Ramesh Kadel, his relatives and his associates in a PMLA case lodged against Mumbai-based firm Yogeshwar Diamonds and others.

The attached properties include immovable properties and bank balance of one proprietorship concern, Naina Jewellers owned by Deepak Kumar.

The ED initiated investigation under PMLA against Yogeshwar Diamonds and others on the basis of an FIR registered by the Maharashtra Police in 2015, which was later transferred to the Economic Offences Wing, Mumbai Police.

The ED probe revealed that Yogeshwar Diamonds and others remitted funds on the basis of forged entries to companies based in Hong Kong.

Star Grace Limited was one such shell foreign entity which had received huge amount of illegal proceeds of crime through this modus operandi. Documents collected by the ED proved that Deepak Kumar was the director and he was not responding to ED's summons for the last few years. On February 25, on his return from Dubai, Kumar



was arrested by the ED. Presently, he is in judicial custody. "Scrutiny of his and his firm's bank accounts in India revealed that Kumar is part of a larger web of shell entities which are engaged in sending large amount of unaccounted funds to foreign shell entities in the guise of forged/fabricated bills of entry in the diamond trading business," said an ED official.

Kumar was the authorised director of the Hong Kong company, but is not the ultimate beneficial owner of Star Grace Limited. As per the investigation done till date, it is established that Ramesh Kumar Kadel is the beneficiary of these funds who is absconding and not responding to summons by the ED. He is presently in Dubai.

JIAH KHAN'S MOTHER "DESTROYED" CASE AGAINST SOORAJ PANCHOLI: COURT

Actor Jiah Khan's mother "destroyed the case of the prosecution" by giving contradictory statements and withholding facts, the special CBI court which cleared the movie star's boyfriend Sooraj Pancholi of driving her to suicide, has said in its judgment.

"The complainant (Rabia Khan) in her evidence directly blamed both the investigating agencies stating that they had not conducted a proper and correct investigation. By giving such open contradictory evidence, the complainant herself has destroyed the case of the prosecution," the court said.

"The complainant openly shown distrust on the prosecution. When the case of prosecution was of suicide, the complainant stated it was murder case. However, there is no charge of murder in this case. In fact, the complainant herself denied the prosecution's case and disowned her earlier statement. In spite of the said fact, the prosecution requested to declare her hostile and continue the trial with such handicap evidence," it observed.



The CBI court also observed that Jiah Khan's mother Rabia Khan raised doubts on everyone except herself.

"When expert witnesses gave their opinion regarding cause of death of the deceased as suicidal, the complainant took exactly contra-

dictory view stating that doctors have given a wrong opinion. The complainant raised doubts even on the doctor who conducted post-mortem examination. The complainant raised doubts on everyone except herself. The evidence given by the complainant is found

to be full fledged with improvements and constrictions," CBI court judge AS Sayyad said in the 53-page order.

The CBI court also raised doubt on a letter, allegedly written by Jiah Khan on her deteriorating relationship with Mr Pancholi. The letter was found "all of sudden" by Rabia Khan, four days after Jiah Khan's death, in her own notebook, the order said. The court also observed that Rabia Khan refused to hand over the letter for investigation, but got it published in the media.

"The circumstances as above creates serious suspicion regarding the actual author of the said letter," the judge observed.

The judge also questioned the delay in filing the First Information Report, or FIR, in the case. Sooraj Pancholi was acquitted on Friday by the special CBI court in Mumbai.

Reacting to the verdict, Rabia Khan reiterated that her daughter was killed and said she will approach the high court. "The verdict is on alleged suicide, but I have always maintained that Jiah was murdered. This, in fact, strengthens my case", she said. Jiah Khan, 25, was found dead at her Juhu home in Mumbai on June 3, 2013.

WOMAN BOOKED FOR ABETMENT OF SUICIDE AFTER JOBLESS BOYFRIEND ENDS LIFE

Mumbai: A 23-year-old woman has been booked for abetment of suicide after the man she was in a relationship with ended his life recently in Palghar in Maharashtra, a police official said on Friday.

The man, also 23, had lost his job as a ward boy and his joblessness used to cause frequent quarrels between the couple, the Achole police station official said.

"After one such fight on April 15, the man hanged himself from the ceiling of his house. The woman, who knew him for the past seven to eight years, has been booked for abetment of suicide on the complaint of his mother," the official said. Meanwhile, in another incident in Mumbai's Malwani area, a monetary dispute between a son and his father in Malwani area of Mumbai allegedly led to the death of a 31-year-old woman, the wife of his son and later attempted suicide, the police said on Friday.

According to the police, the incident took place on Thursday afternoon when the son- Irfan Sayyed's (35) wife Ayesha and her father-in-law Akbar Sayyed (55) got into a heated argument over a monetary dispute.

The police said that Akbar along with his 70-year-old mother and 40-year-old sister allegedly brutally assaulted the daughter-in-law identified as Ayesha Sayyed alias Heena, frightened by Heena's death, Akbar also tried to commit suicide by consuming poison. He was hospitalized and has been in critical condition.

People in Barsu being attacked under 'Hindutvawadi' govt: Sanjay Raut

Shiv Sena (UBT) leader Sanjay Raut on Saturday alleged that residents of Barsu village in Maharashtra's Ratnagiri district were being brutally attacked by the police for an "Islamic" oil refinery project from Saudi Arabia even as there was a "Hindutvawadi" government in the state.

Talking to reporters, Raut also claimed that there was no coordination between Chief Minister Eknath Shinde and Deputy Chief Minister Devendra Fadnis on the proposed refinery project.

His remarks come a day after the police used tear gas in Barsu and Solgaon villages in Rajapur tehsil to disperse the protesters who are opposing the refinery, and detained Shiv Sena (UBT) MP Vinayak Raut. On Tuesday, more than 100 protesters, mostly women, were arrested for protesting against the project.

A section of local residents are up in arms against the project as they fear that the mega project will adversely affect the fragile biodiversity of the coastal Konkan region



and also hit their livelihood. The Uddhav Thackeray-led Shiv Sena is supporting the protesters.

"There is no coordination in the government. In the case of Barsu, the coordination is only between the Saudi Arabia company, an

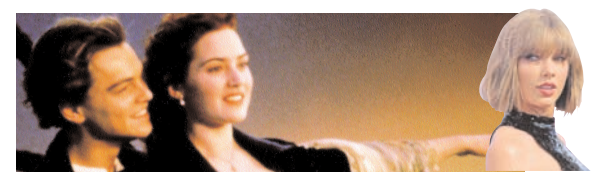
Islamic company; and (there is) a Hindutvawadi government. For an Islamic oil refinery, Marathi manooos from Ratnagiri, the sons of the soil, are being attacked. This is their (the government's) Hindutva," Raut said.

The Rajya Sabha member maintained that there was no confusion in the party on the Barsu issue. Notably, local MLA Rajan Salvi, who is also from the Shiv Sena (UBT), has come out in support of the project.

The project, Ratnagiri Refinery and Petrochemical Limited, was going to be Asia's 'biggest oil refinery', and was proposed to be built at Nanar village in Ratnagiri. It was supposed to be a joint venture between Indian Oil, Bharat Petroleum and Hindustan Petroleum, and Saudi Arabia-owned Aramco and United Arab Emirates' National Oil Company.

However, after opposition from locals, the then chief minister Uddhav Thackeray suggested Barsu as an alternative land to the project.

On Friday, CM Shinde said the proposed refinery project will not be implemented without the local people's consent, and appealed for calm in the area. "We are a people's government and we are not against them. We will not proceed without the local people's consent," the chief minister added.

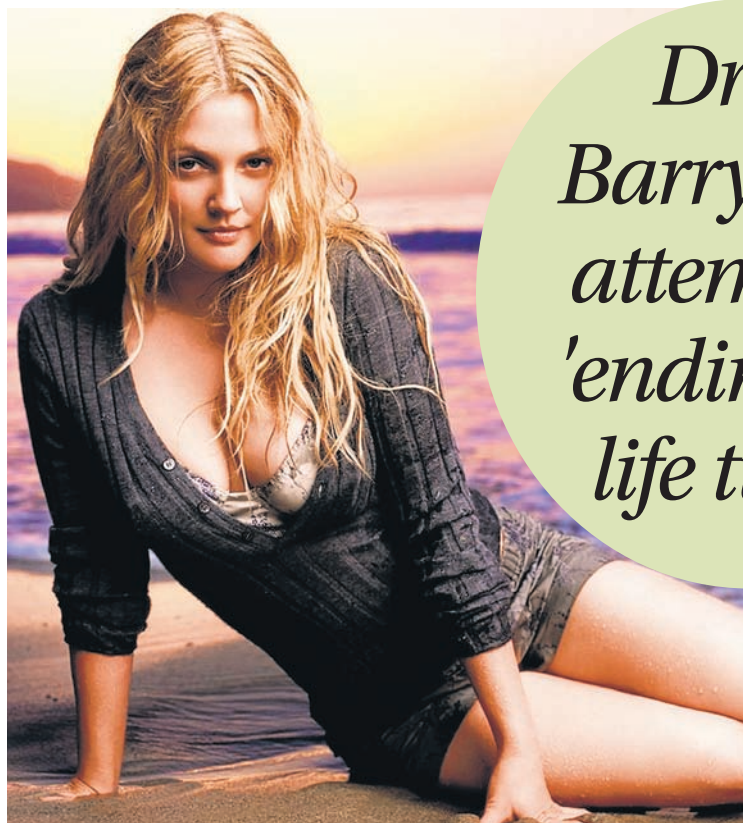
"It felt very normal to me to think about that at the end of every day, and then that wasn't until I ended up actually making an attempt," Madison further noted. "It was, thankfully, obviously unsuccessful."

"I don't know, it just all became too much. I wasn't successful and I want to do something with that," Madison continued. "I want to be able to say I made the choice to live and, what am I gonna do now? What does that mean?" Barrymore later stated that she could relate to Madison because she also attempted to "end her life twice."

She said: "Everybody struggles, so I related on levels that are difficult to talk about and I want to thank you because you're discussing stuff right now that I want to make you feel safe about because I've been there."

Drew, who made her acting debut at the age of five in 1980's 'Altered States', has been open about her struggle with mental health. She was 13 when her mother admitted her to the Van Nuys Psychiatric Hospital near Los Angeles, California, for an 18-month stay.

"I was a real wild child and I just got so out of control that no one knew what to do with me," Drew recalled when revisiting the facility in 2021. "They drove me here in the middle of the night and they walked me through those two doors and when you go through those two doors you do not come out."

The hosts caught a fairy tale start on home soil as Anthony Losilla unleashed a hammer from 17 meters into the top left corner to break the deadlock with only five minutes played, reports Xinhua.

Dortmund remained unimpressed and restored parity two minutes later when Sebastian Haller squared the ball into the path of Karim Adeyemi, who beat Bochum goalkeeper Manuel Riemann from close range.



Bochum remained on the front foot as Takuma Asano tested Dortmund custodian Gregor Kobel with all time and space in the 12th minute.

Both sides continued to exchange attacks as Jude Bellingham forced Riemann into action inside the box in the 26th minute before Asano's shot from a promising position got blocked for a corner nine minutes later.

The BVB increased the pressure after the restart, but they couldn't overcome Riemann, who defused the dangerous shot from

Youssef Moukoko in the 75th minute before neutralizing Bellingham's well-placed shot with a diving save two minutes later.

The visitors thought they had eventually taken the lead, but Mats Hummels' header was ruled offside in the 90th minute. Dortmund kept it bowling but couldn't snatch a win as Bochum's defense stood firm and wrapped up a vital point in the relegation battle. "The first half may have been entertaining for the spectators but for me as a coach, it was a nightmare. The second half was a battle for us. It is hard to keep a quality team like Dortmund at bay, but my boys did well. It is a lucky but important stalemate for us," said Bochum coach Thomas Letsch.

Men's World Boxing Championships

HUSSAMUDDIN AND SHIVA THAPA TO LEAD TEAM INDIA

Two-time Commonwealth Games medallists Mohammad Hussamuddin and World and Asian Championships medal-winner Shiva Thapa will lead the Indian challenge in the Men's World Boxing Championships scheduled to be held in Tashkent, Uzbekistan from April 30- May 14.

The draw ceremony will take place on Sunday and the bouts will start from May 1. Hussamuddin and Shiva Thapa will lead the 13-member Indian team in the Men's World Boxing Championships.

The 29-year-old Hussamuddin, the youngest of six brothers, four of whom are boxers, won bronze medals in the 2018 and 2022 Commonwealth Games. In Tashkent, he will be competing in the men's 57 kg category and will be a medal contender.

Shiva Thapa, who won bronze in the 2015 World Championship in Doha, is the most successful boxer in the Asian Championships with one gold, three silver and two bronze



medals in his kitty. In Tashkent, Shiva will be hoping to emulate his gold in the 2013 Asian Championships in Amman, in the 63.5 kg category.

Govind Sahani, silver medallist in the 74th Strandja Memorial Boxing Tournament in Bulgaria and a gold medallist in the 2022 Thailand Open International Boxing Tournament,

will be India's competitor in the men's 48kg in the event being organised by the International Boxing Association (IBA).

Sahani will be playing in his second World Championships in the upcoming tournament and will be looking to be among the medal winners. The 2021 World Youth

Championship gold medallist Sachin Siwach will be competing in the 54kg weight category having come back strongly and won gold in the Nationals after missing the Asian Championship in Jordan in October 2022 following surgery for appendicitis days before the championships.

Cairo Shotgun World Cup

RANKING ROUND FINISH FOR GANEMAT SEKHON

India's Ganemat Sekhon, shot well to qualify third in the women's skeet competition at the ongoing International Shooting Sport Federation (ISSF) World Cup Shotgun in Cairo, Egypt, before bowing out in eighth place in the ranking round.

Gurjoat Khangura in the men's skeet, however, missed a top-eight finish, when he went out in a shoot-off for the final qualifying spot.

Those were the best Indian results on Day 3 of the competitions which saw the first medals being awarded. Rio Olympic champion Gabrielle Rossetti of Italy won the men's skeet even as teenaged



shot 121 and 118 respectively.

Maheshwari Chauhan shot 118 to finish 18th among contenders while Darshna Rathore shot 110 to end in 26th place. Sanjan Sood, playing for ranking points, shot 104.

Chinese Jiang Yiting, sealed a first World Cup win with a triumph in the women's skeet competition.

Ganemat shot a perfect 25 in the fifth and final qualifying round earlier in the day to finish with a score of 117. That tied her with Italian Chiara Di Marziantonio whom she beat in a shoot-off 2-1 to claim the third spot behind Yiting and German Nadine Messerschmidt who

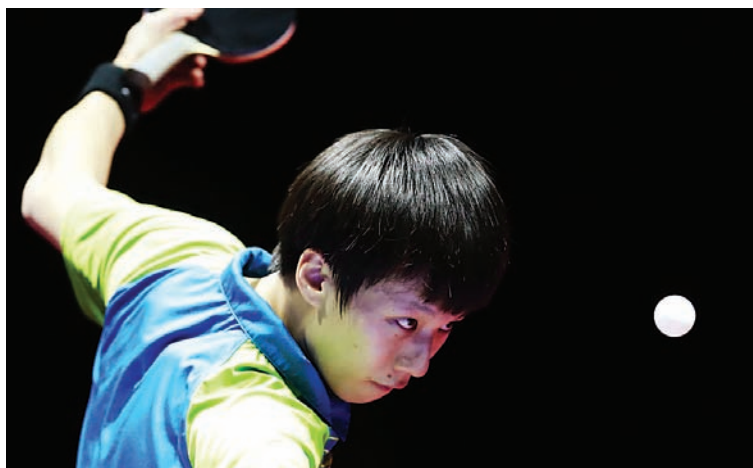

He missed his second bird in the shoot-off to be among the first to bow out and finish in 13th place. Britain's Mitchell Brooker-Smith won the shoot-off after hitting 12 consecutive birds.

Chinese pair wins mixed doubles at WTT Star Contender Bangkok

China's Lin Gaoyuan and Chen Xingtong rallied from two games down to win the mixed doubles title at the World Table Tennis (WTT) Star Contender 2023 here.

Lin and Chen was trailing by 0-5 in the third game after losing the previous two against Lim Jong-hoon and Shin Yu-bin of South Korea, but turned the tide and forced the match into the decider before they won by 7-11, 9-11, 11-9, 11-6, 11-8, reports Xinhua.



Both Lin and Chen returned later for the semifinals of men's singles and women's singles.

Chen went through another five-game thriller 11-6, 8-11, 11-5, 5-11, 11-4 against Adriana Diaz from Puerto Rico to advance to her third final of the tournament after women's doubles and the mixed finals.

Lin had an easier match in the men's singles semifinal when he strolled past teammate Yuan Lichen in three straight sets and also secured his third berth for finals in the tournaments.

Satwik/Chirag make history for India, reach final

India's top men's doubles pair Satwiksairaj Rankireddy and Chirag Shetty became the first Indian duo since Dinesh Khanna in singles in 1965 to enter the final of the Badminton Asia Championships here on Saturday.

The Indian duo sealed a spot in the summit clash after their opponents, the Tokyo Olympic champions Chinese Taipei's Lee Yang and Wang Chi-lin, retired midway through the second game of their semifinal clash.

The 22-year-old Satwiksairaj Rankireddy from Amalapuram in Andhra

Pradesh and the 25-year-old Mumbai-born Chirag Shetty had won the first game 21-18 and were going neck-and-neck with their Chinese Taipei opponents at 13-14 when Lee Yang and Wang Chi-lin withdrew, giving them a walkover.

The Indian duo had themselves assured a medal after 52 years in the men's doubles category when they got the better of Indonesia's experienced duo Mohammad Ahsan and Hendra Setiawan in straight games 21-11, 21-12 in the quarterfinals.

Chirag and Satwik are the lone Indians remaining in the fray in the Asian Championships.

India have thus far won only one gold in the Asian Championships since it was initiated in 1962 -- the gold won by Dinesh Khanna in men's singles in 1965.

Satwik and Chirag will be hoping to bag the second gold for India in this mega event. Apart from the gold won by Dinesh Khanna, India has won 17 bronze medals in various categories in the Badminton Asia Championships since 1962.

Whatever medal they win on Sunday will be the biggest medal in their career. The Indian duo have won five titles on the BWF World Tour and have twice finished runners-up.

Madrid (Spain) | Agencies

World No.2 Aryna Sabalenka advanced to the Round of 16 at the Madrid Open after defeating Colombia's Camila Osorio 6-4, 7-5 on Saturday.

A champion in 2019, Sabalenka will face either Magda Linette or Mirra Andreeva for a spot in the quarterfinals. Coming off a strong 6-4, 6-3 wins over Sorana Cirstea in her opening round, Sabalenka held off a spirited challenge from Osorio. Now ranked No.115 and coming off a one-month injury break, Osorio made good on her main-draw wild card to



advance to the third round of Madrid for the first time. Sabalenka's power game ultimately proved too tough to solve for Osorio. After falling behind an early break at 3-1, Osorio gamely battled her way back into the match. She fended off two break points to close the gap to 3-2 and then, with the Spanish crowd behind her, the 22-year-old broke Sabalenka to level the first set. Sabalenka quickly settled her-

self after her error-prone stretch. She broke Osorio for a second time to lead 5-4 and held her nerve in a deuce game to serve out the opening set. With a set in the pocket, the reigning Australian Open champion clinically moved through the early stages of the second set. After Sabalenka built a double-break lead at 4-1, Osorio took a medical timeout to assess her left hip and leg. On the resumption, Osorio broke Sabalenka for the first time in the set and closed the deficit to 4-3. Osorio continued her march towards a comeback, breaking Sabalenka again as she served for the match at 5-4.

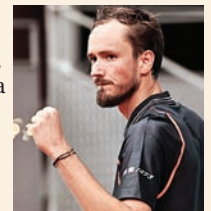

Medvedev stayed patient against the World No. 164 Vavassori, notching a late break of serve in each set to complete an 82-minute triumph.

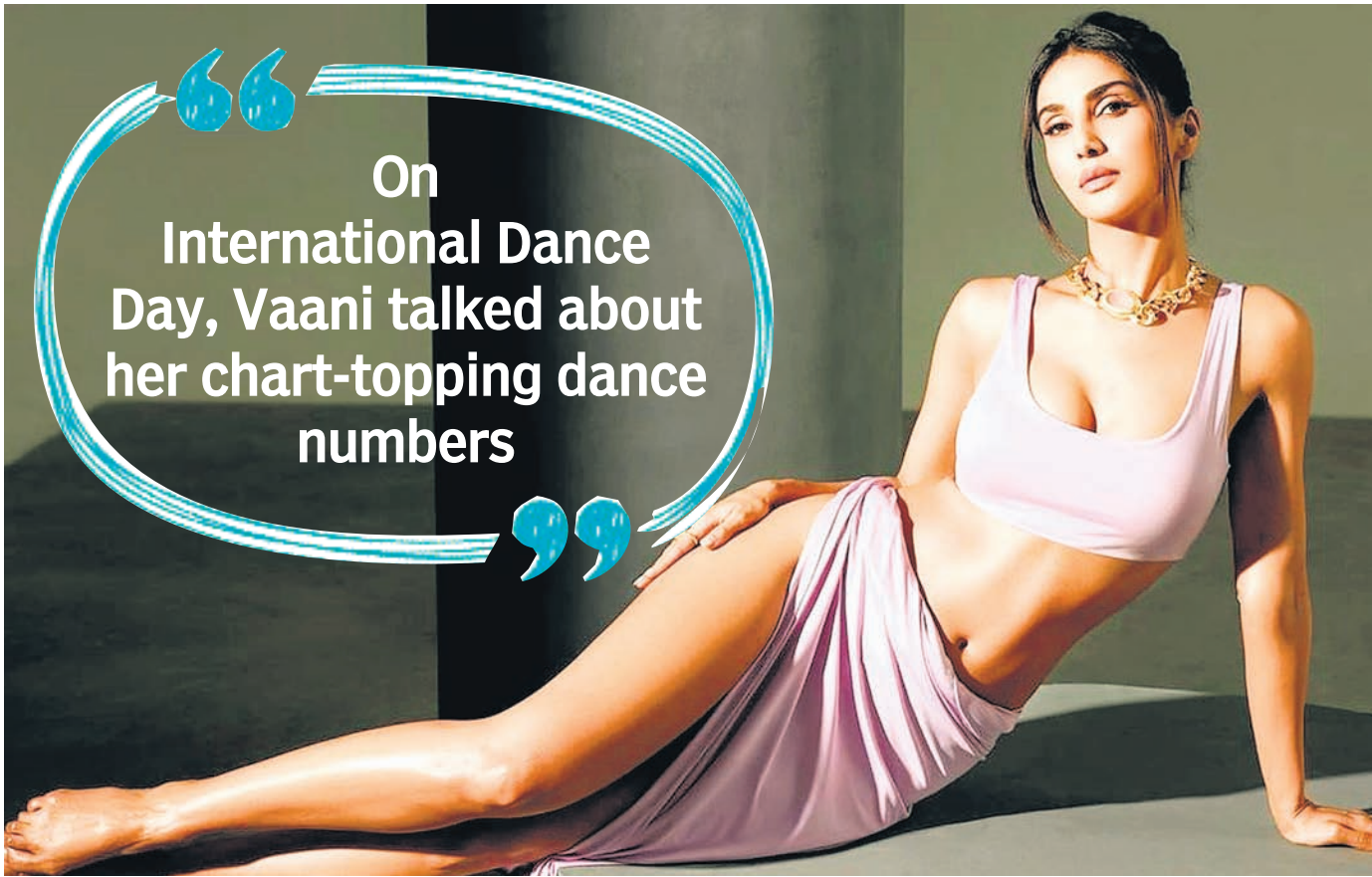
