WRESTLERS HALT PLAN TO IMMERSE MEDALS IN GANGA, GIVE 5-DAY ULTIMATUM

INSENSITIVE SYSTEM HELPLESS WRESTLERS

Agitating wrestlers, including Sakshi Malik, Vinesh Phogat, and Bajrang Punia, handed their medals to Bhartiya Kisan Union chief and Balian Khap head Naresh Tikait, who had reached Haridwar's Har ki Pauri to stop them from putting these into the Ganga as a symbolic act of protest against Wrestling Federation of India Brij Bhushan Sharan Singh, whom they have accused of sexual harassment.

Tikait, along with the wrestlers, have now given five days to the government to sort out their demands, failing which wrestlers will go ahead with their decision to submerge their medals in the Ganga.

A large gathering assembled at Har ki Pauri, witnessing the wrestlers' poignant demonstration after they reached there with their world championship and Olympic medals.

Emotions ran high, and Sakshi,

"We are going to discard our medals in holy river Ganga. These medals are our lives, our souls. There would be no reason to live after leaving them in the Ganga today. So, we will stage a hunger strike until death at India Gate after that. The Prime Minister 'who calls us our daughters', did not even once show his concern 'for us'. Rather, he invited Brij Bhushan Singh to the inauguration of the new Parliament building. He even posed for photographs."

Sport's governing body condemns manhandling of wrestlers

New Delhi: The International Wrestling Union (IWW) on Tuesday condemned the treatment meted out to the protesting wrestlers and their detention following a scuffle with the Delhi Police and said it will hold a meeting with the wrestlers to inquire about their condition and safety. IWW said it will seek further information from the Indian Olympic Association (IOA) and the Ad-hoc body appointed by it for wrestling about its plans for conducting elections for the next governing body. The sport's international governing body also threatened of suspending the Wrestling Federation of India if the election process is not completed within the 45 days deadline.

NE Athletes to return awards

Imphal: Thirteen sports personalities and medal winners in international meets on Tuesday urged Union Home Minister Amit Shah to restore peace and harmony in Manipur at the earliest and to take stern action against Kuki militants, warning they will otherwise return their medals and awards. "Paramilitary forces might have been reluctant to prevent Kuki terrorists from attacking innocent civilians," claimed the signatories, including Arjuna award winner weightlifter Kunjarani Devi, former Indian women football team captain Oinam Bem Bem Devi, boxer L Sarita Devi, Dhyanchand awardee Anita Chanu, Olympian judoka Likmabam Shushila Devi, Olympic medalist Mirabai Chanu, and Dronacharya awardee (boxing) L. Ibomcha Singh.

'Wrestlers will not be allowed to protest at India Gate'

New Delhi: As top Indian wrestlers Bajrang Punia, Sakshi Malik and Vinesh Phogat announced that they will sit on a hunger strike at India Gate, Delhi Police sources said that the wrestlers will not be allowed to protest at the national monument.

"No formal request has been received from the wrestlers thus far. To proceed with any demonstration, the wrestlers must adhere to the protocol by submitting a written communication to the Deputy Commissioner of Police (DCP) concerned. The decision regarding their request will be made based on the established guidelines and procedures," a source said. "India Gate is not a protest site and police will not allow wrestlers to protest there. We will suggest alternate site for protest including Ramleela Ground and Burari," the source added. In their latest move, all the protesting wrestlers, including Punia, Phogat, and Malik headed to Haridwar on Tuesday to immerse all their medals in the holy Ganga. The protesting wrestlers said after that they will come back to Delhi and sit on hunger strike at India Gate.

Vinesh, and Vinesh's cousin Sangeeta were visibly overcome, and their husbands offered consolation as their numerous supporters formed a protective circle. Earlier, after reaching Har ki Pauri,

the wrestlers stood in solemn silence for approximately 20 minutes. Subsequently, they took a seat by the riverbank, clutching their medals and their expressions reflecting profound distress.

Amit Shah visits tribal-dominated Manipur district, announces Rs 10 lakh for victims' families

The Manipur government has announced to take action against those found to be generating, sharing or publishing any wrong information which can worsen the current law and order situation in the state.

Union Home Minister Amit Shah, who had already held a half a dozen meetings since his arrival in violence-hit Manipur on Monday night, on Tuesday visited Churachandpur, one of the districts severely affected by the ethnic violence that ravaged the state since May 3, leaving at least 75 dead and over 300 injured.

According to a senior Manipur government official, during a meeting between the Home Minister and state council of ministers headed by the Chief Minister, it was decided to give compensation of Rs 10 lakh each to those who died during the ethnic violence. A government job would also be provided to a kin of the family whose members were killed in the violence.

The compensation amount would be equally borne by the Centre and the state. Officials said that in the tribal-dominated Churachandpur, Shah held meetings with various Civil Society Organisations (CSOs), influential tribal leaders and local security and civil administration officials.

Earlier in the day, the Home Minister held a series of meetings with various top civil and security officials,



CONGRESS MEETS PREZ, SEEKS HER INTERVENTION

New Delhi: After meeting President Droupadi Murmu on Tuesday, Congress chief Mallikarjun Kharge said that the party has submitted a memorandum demanding her intervention in the Manipur issue so that normalcy can be brought urgently and also assured her support to take any initiative to restore peace, normalcy and harmony.

In a tweet, Kharge said, "It is with a deep sense of loss and hurt that we humbly submitted a memorandum to the President of India, for her kind intervention so that the extraordinary situation confronting Manipur can be redressed and normalcy can be brought in urgently."

"As a responsible political party, the Congress is ever ready to lend support to any initiative to restore peace, normalcy and harmony in Manipur. We humbly submit the following 12 demands for immediate action. Only then there will be peace in the state."

The party in its memorandum has demanded for the formation of a high-level inquiry commission headed by a serving or retired Supreme Court Judge.

150 Medical Colleges May Lose Recognition, 40 Already Penalised: Sources

Around 150 medical colleges of the country are likely to lose recognition of the National Medical Commission -- the regulatory body for country's medical education and medical professionals -- for inadequate faculty and non-compliance of rules, sources have said. Already, 40 medical colleges across the country have lost recognition and must show to the NMC that they are following set standards.

The list of colleges on the NMC's radar includes medical colleges in Gujarat, Assam, Puducherry, Tamil Nadu, Punjab, Andhra Pradesh, Tripura and West Bengal, sources said. The deficiencies were revealed during an inspection carried out by the Undergraduate Medical Education Board of the Commission for over a month, in which they looked into CCTV cameras, lapses in Aadhar linked biometric attendance procedures and the faculty

rolls. Sources said the colleges were not following the criteria, including proper camera installation and their functioning. Biometric facility was not working properly. Many posts in the faculties were also found vacant during the inspection, NDTV reported.

The medical colleges have the option to appeal, sources said. The first appeal can be made at the NMC within 30 days. If the appeal is rejected, they can approach the Union Ministry of Health.

In December, Union health minister Mansukh Mandaviya had warned of action against medical colleges that do not stick to rules or maintain proper faculty. "We have to give quality education to students, we have to produce good doctors," he had said.

Derecognition of 150 institutions could trigger a crisis for the country, where the number of medical colleges and seats for medical students have been inadequate for decades.

10 dead, 55 injured after bus plunges into Jammu gorge

Jammu: At least 10 people were killed and 55 others injured on Tuesday after a bus plunged into a deep gorge in Jammu district, police said.

According to the police, the accident took place in the Jhajjar Kotli area after the driver lost control of the vehicle which was on its way to Katra town from Amritsar.

Confirming the toll to reporters, Jammu SSP Chandan Kohli said the "rescue operation is almost complete and an SDRF team is also present on the spot."

"The bus was carrying more passengers than the prescribed limit which will be probed during the investigation," he added.

Four critically injured passengers have been shifted to the Government Medical College, Jammu.

Tendulkar named 'Smile Ambassador' for Maha oral hygiene campaign

Cricket icon Sachin Tendulkar has been appointed as the 'Smile Ambassador' for the Maharashtra government's oral hygiene campaign titled 'Swachh Mukh Abhiyaan', here on Tuesday.

Chief Minister Eknath Shinde and Deputy CM Devendra Fadnis signed a Memorandum of Understanding (MoU) for five years with Tendulkar for the major state-wide initiative, officials said.

Speaking on the occasion, Fadnis said that the Swachh Mukh Abhiyaan (SMA), an oral health mission, is run by the state Medical Education Department and Tendulkar shall be its 'Smile Ambassador' for five years. "Many celebrities pro-



mote cancer-causing products, but Tendulkar never appears in such advertisements. He will promote oral hygiene among the people, especially the youth," said Fadnis. The 'Swachh Mukh Abhiyaan' is an all-India initiative by the Indian Dental Association (IDA) to create awareness about oral

hygiene and health among the masses. It highlights a five-point oral hygiene agenda like brushing teeth twice daily, rinsing after every meal, eating healthy and nutritious food, avoiding smoking or chewing tobacco to prevent oral cancer, and going for dental check-up at least twice a year.

20 kg drugs worth Rs 200 cr seized in Greater Noida

Greater Noida: Another drug manufacturing laboratory allegedly set up in a house in Greater Noida was busted on Tuesday. The police claimed to have seized 20 kg drugs valued at Rs 200 crore in the international market, and also arrested two foreign nationals.

The police said that the foreign nationals were running the drug laboratory in the Judge Society located near posh Sector Omega 1 of Greater Noida.

The police raided the house on Tuesday at the instance of one of the nine accused arrested on May 17.

Earlier on May 17, the police had arrested nine persons of African origin and recovered 46 kg methamphetamine (MDMA), estimated to be worth Rs 200 crore in the international market, from a house in Theta 2 of Greater Noida.

RAILWAY POLICE ARREST MAN WHO THREATENED TO BLOW UP PATNA STATION

A man who made a threatening call to blow up Patna Junction railway station was arrested from Saharsa district on Tuesday.

The accused was identified as Rajesh Kumar Ranjan, a resident of Saur Bazar, Saharsa. He had left his job in the CRPF and was working in a hardware shop in Saharsa.

"We have arrested the accused with the help of Saharsa police. The accused has confessed to the crime. He claimed that he was angry over his wife having extramarital affairs with two persons -- Deep

Shankar Paswan of Muzaffarpur and Chand Kishore of Jalalgarh Purnea district," said Amritendu Shekher Thakur, SP of Railway Patna.

"The accused said that his wife Pooja Kumar was having an affair with Deep Shankar Paswan but her family members forced her to marry him. After the marriage, she did not break off her relationship. Paswan had purchased a SIM card in his name and given it to Pooja to talk to him. The accused said that she also developed an extramarital affair with Chand Kishore and interacted with the two over the phone," Thakur said.

► About half of the deceased did not visit any health facility during their terminal illness and only one in ten subjects reached an appropriate health facility within the first hour after onset of the symptoms.

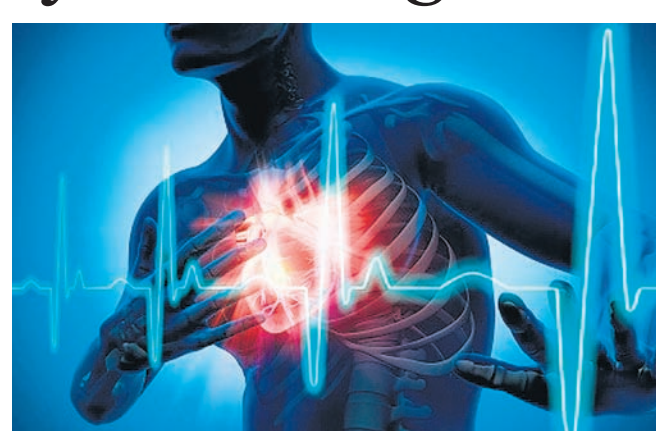
► Those staying closer to a facility or families with higher income were more likely to reach within the first hour. In general, strokes reported greater delays.

55% of cardiac deaths in India caused by delay in seeking care: Lancet

About 55 per cent of the cardiac/stroke deaths reported in India are due to delay in seeking care, according to the first community-based study published in the journal Lancet.

The study, conducted at the All India Institute of Medical Sciences (AIIMS) and Indian Council of Medical Research (ICMR), New Delhi, stated that only a small proportion of patients with cardiac and stroke emergencies reach health facilities early. "Lack of timely care is a predictor of poor outcomes in acute cardiovascular emergencies including stroke. We assessed the



presence of delay in seeking appropriate care among those who died due to cardiac/stroke

emergencies in a community in northern India," said Anand Krishnan, correspondence

author, Centre for Community Medicine, AIIMS, in the study. The findings showed only 10.8 per cent of the deceased reached an appropriate health facility within one hour. "The inability to recognise the severity of illness and financial constraints were identified as major reasons for the delays in seeking care," Krishnan said. The study also identified affordability and accessibility as important factors for delays resulting in mortality and identified better insurance coverage and appropriate equipped ambulance linkages along with programmes to improve recognition of a heart or brain attack among the populace.



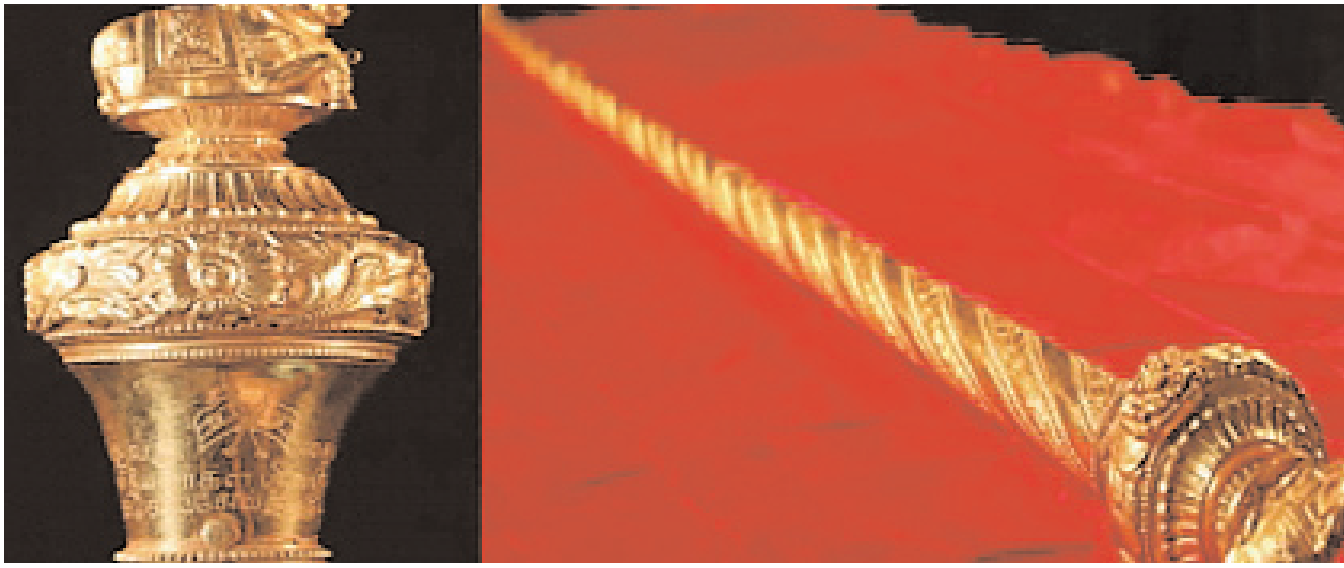
WE DON'T HAVE A MONARCHY TO TRANSFER POWER BY SENGOL: CONGRESS

Panaji: Goa Pradesh Congress Committee president Amit Patkar on Tuesday said monarchy doesn't exist in the country for making use of a 'Sengol' to transfer power. The right to transfer power is with people who have shown the door to the BJP in Karnataka.

He was speaking during the 'Statehood Day' celebrations in Margao. Former MP Eduardo Faleiro, MP Francisco Sardinha, Aldona MLA Carlos Alvares Ferreira, Senior vice president M K Shaikh, Amarnath Panajikar and others were present on the occasion.

Speaking about the inauguration of the new Parliament building,



Patkar said "This is not a monarchy for transfer of power by Sengol, that right is with the people who have shown the door to the BJP in Karnataka. Modi has always tried to misguide people and impress them with unwanted things."

Patkar criticised Prime Minister Narendra Modi for denying President Droupadi Murmu the right to inaugurate the new Parliament building. "Modi is not a king to practice transfer of power using a sengol," he said

"The BJP has spread a fake narrative that because of Pandit Jawaharlal Nehru, the liberation of Goa was delayed. This is wrong and they are trying to spread misinformation," he added. "The BJP is dividing the people

on religion, language and other issues. Modi failed to bring back black money and has taken U turns on all his promises. The time has come to expose their Jumlas and protect our nation," he said.

He said to protect the culture and peace of Goa, there is a need to win both the Lok Sabha seats in 2024.

Eduardo Faleiro said that post liberation a lot of development has taken place in Goa.

Francisco Sardinha said that statehood is a great day for Goa. "We fought against the merger and preserved our identity. Later with the efforts of Rajiv Gandhi our mother tongue Konkani was included in the 8th Schedule of the Constitution and also we got statehood," Sardinha added.

BJP won't sit quietly if K'taka govt surrenders to 'urban naxals': C.T. Ravi

Bharatiya Janata Party national general secretary C.T. Ravi on Tuesday warned that if the Congress government in Karnataka gives control to urban naxals the party won't sit quietly.

Speaking to reporters, Ravi stated that this election's results won't last for a lifetime. Elections will be held again and this should be considered by the Congress leaders.

After Siddaramaiah took over as the chief minister, these urban naxals are coming out from their holes. Now, naxal activities might see a spurt in Chikkamagaluru and other parts of the state, Ravi said.

The state may witness incidents on the lines of Chhattisgarh. "When our government (BJP) was in power they did not wag their tails. Now they have come out in the open. They only believe in bullets not in the ballot," Ravi stated.

He remarked that they have now come

out seeking revision of textbooks and pursuing their agendas. "The patriotism of Hedgewar (RSS founder) and the respect of the Sangh towards the nation can't be questioned by anyone. Hedgewar was the national president of the Congress party once, now they are all set to drop his lesson," he said. "We will wait and see and we know what should be done," Ravi warned.

He demanded that the freebies promised by the Congress party should be provided to the people without any conditions. "I have got 9,000 more votes than the previous election. I won't blame anyone for my defeat. I am in the post of national general secretary. The party has given me an opportunity at the national level," he maintained.

He stated that in the Lok Sabha elections, if India is to win, the BJP should emerge victorious. PM Modi has set a goal to make India a developed nation by 2028. Those with a jihadi mindset are dreaming and have set a target to make India an Islamic country by 2047, he stated.

LIVID OVER SLUR ON SAVITRIBAI PHULE, NCP DEMANDS ACTION AGAINST WEBSITES

The Nationalist Congress Party on Tuesday demanded stringent action against two websites for publishing "derogatory" articles on the legendary Marathi social reformer and pioneering woman teacher, Savitribai Phule.

NCP senior leader Chhagan Bhujbal told media persons that he had already written to the Chief Minister Eknath Shinde seeking strong steps against the websites for the articles published in January 2022.

"I have written a letter to the CM and the Mumbai Commissioner of Police for the slur on Savitribai Phule who is revered all over. However, if



they fail to take action including legal steps, then I shall visit the CoP and demand that a formal complaint be

registered in the matter," he said.

Bhujbal said that he will be accompanied by Leader of Opposition Ajit

Pawar, State NCP President Jayant Patil, and MP Sunil Tatkare among others.

In his letter, Bhujbal, the NCP MLA from Yeola (Nashik), sought legal action against the websites and the author of the article for "derogatory remarks" on Savitribai Phule (1831-1897), and questioning her credentials as a teacher.

He said that the attempts to malign the legendary educator was "highly condemnable, outrageous and painful", with the websites seeking to rearrange and destroy Indian history.

The articles have also stirred a raging debate on social media with many slamming the authors for the references and insinuations against the iconic social reformer.

ALL WOMEN CAN TRAVEL FOR FREE IN GOVT BUSES: K'TAKA MINISTER

Bengaluru: Karnataka Minister for Transport Ramalinga Reddy announced on Tuesday that all women can travel free of cost in the government buses in the state. He made the announcement while speaking to reporters after holding a meeting with Managing Directors of four divisions of the Karnataka Road Transport Corporation (KSRTC).

"The women can travel free of cost in government buses. There are no conditions. In our manifesto, we have not mentioned any conditions on scheme applicable for APL or BPL card-holders. State-wide women can travel at free of cost," he said. "I have spoken to MDs and discussed pros and cons of the scheme. I will submit the report of the meeting, including the cost and other details to Chief Minister Siddaramaiah in this regard. CM Siddaramaiah has already discussed it with the Principle Secretary of Transport department," minister Ramalinga Reddy explained. "The cabinet meeting is scheduled on Wednesday. The details would be discussed in the cabinet and CM Siddaramaiah will make the announcement in this regard after the cabinet meeting," he stated. "I have also discussed the losses incurred during the Coronavirus pandemic. Ours' is a reputed transport corporation in the country.

After meeting Kharge, Gehlot hopes to work together with Pilot

A day after meeting Congress president Mallikarjun Kharge, Rajasthan Chief Minister Ashok Gehlot on Tuesday said that he hoped to work together with former Deputy Chief Minister Sachin Pilot in an effort to resolve the political crisis in the state.

On Monday, Kharge, senior leader Rahul Gandhi, party General Secretary (organisation) K.C. Venugopal, state incharge Sukhjinder Singh Randhawa held a detailed four hour-long discussion with Gehlot and Pilot.

Speaking to the media here, Gehlot said: "If he (Pilot) is in the party then why won't he do this (work together)?"

He was responding to a question when asked if he and Pilot will work together in Rajasthan.

When pressed further, he said: "Last evening's meeting was called to sort out issues and to give a joint



fight in the state."

The Chief Minister said that a position was not important for me. "I have been the Chief Minister thrice in my life and I ask everyone to keep patience".

"And I have also been a minister for three times and the party has given me everything. Today it's my duty to do the work that the high command wants which is to win the election and play the role that they want to do. I have made all the schemes for the people," Gehlot said, adding that trust is earned by giving

trust. "You win trust by giving trust. If everyone will work together then our government will be repeated. If you will remain loyal to the party then as Sonia Gandhi had said in the Convention that the one who keeps patience gets a chance someday," he added.

After Monday's meeting, Venugopal said that Gehlot and Pilot both have agreed to give a joint fight to the BJP in Rajasthan.

The Rajasthan Pradesh Congress Committee has been in a state of turmoil since July 2020, when Pilot staged a revolt seeking a leadership change. Following the revolt, Pilot, who was the Deputy Chief Minister, was removed from the post. He was also removed as the state Congress President. Since then, there has been tensions within the state Congress unit and the crisis further deepened in September last year before the party President's election

AAP MP Sahney writes to Vice-President on exclusion of Punjabi from Panjab University

AAP's Rajya Sabha member Vikramjit Sahney on Tuesday took up the issue of exclusion of Punjabi as a compulsory subject by the Panjab University with Vice President of India Jagdeep Dhanakar, who is also the university's Chancellor. In a letter to the Vice-President, Sahney said Panjab University was established for the students of Panjab and they cannot be deprived of the privilege to study this language in undergraduate courses. He said there are over 200 colleges affiliated to the university and students enrolled with them should also get the facility to study their mother tongue as it has been done by other universities like Punjabi University, Patiala, and Guru Nanak Dev University, Amritsar.



Studies and the Language Faculty have recommended to keep Punjabi as a compulsory subject. In a statement issued here, Sahney cautioned that such decisions against Punjabi and Punjabi will never be tolerated and all the Punjabi-loving people, whether they are Hindus or Sikhs or Muslims, stand united to foil its implementation.

Withdraw decision to drop Punjabi as compulsory subject: SAD to Panjab University

Chandigarh: The Shiromani Akali Dal (SAD) on Tuesday appealed to Panjab University in Chandigarh to withdraw its decision to drop Punjabi as a compulsory subject at the graduation level in all its affiliated colleges even as it warned the varsity that Punjabis would never tolerate this discrimination against their mother tongue. Senior SAD leader Daljit Singh Cheema told the media the syndicate members, who have supported this decision, do not deserve to remain members of the university body, while asking the Vice-Chancellor to reverse this decision immediately.

He also appealed to the staff and students of Panjab University to prevail upon

its administration to withdraw this anti-Punjabi step, asserting "if this is not done, SAD will do its utmost to force the university to respect the sentiments of Punjabis and correct this wrong."

Expressing shock as to how the university could take this step in the first place, Cheema said "Panjab University is part of the state capital which was established by uprooting villages of Punjab. As many as 200 colleges in Punjab are affiliated to the university. The university cannot discriminate against the mother tongue of the region." "It cannot expect students to go to other states and countries to become proficient in their mother tongue."

NAMIBIA STUDY TOUR FOR OFFICIALS AFTER 6 CHEETAHS DIE IN KUNO PARK

Union Forest Minister Bhupender Yadav has said officials involved in the cheetah revival plan will be sent on study tours to Namibia and South Africa from where the felines have been brought to the Kuno National Park in Madhya Pradesh. During his meeting with MP Chief Minister Shivraj Singh Chouhan in Bhopal on Monday, Yadav said he will visit the KNP, located in Sheopur district, on June 6. Money and all logistic support for the safety, conservation and revival of the felines will be provided, the Union minister said. Notably, six cheetahs have died at the KNP since March this year. Three of the four cubs born to cheetah Jwala died earlier this month. Sasha, one of the translocated Namibian cheetahs, died due to a kidney-related ailment on March 27, while cheetah Uday, brought from South Africa, died on April 13.

Cheetah Daksha, brought from South Africa, succumbed to injuries following a violent interaction with a male cheetah during a mating attempt on May 9 this year. The Gandhi Sagar Sanctuary in MP is being readied as an alternative home for the cheetahs, Yadav said, adding that the number of cheetahs in the KNP is less than its capacity. Chief Minister Shivraj Chouhan said he was disturbed by the death of the three cheetah cubs recently. He said it is true that the survival rate of cheetah cubs is low across the world, but his government would make all efforts to ensure the wellbeing of the big cats. Eight Namibian cheetahs, comprising five females and three males, were brought to the KNP and released into special enclosures by Prime Minister Narendra Modi on September 17 last year as part of an ambitious reintroduction programme of the species. Later, 12 cheetahs - seven males and five females - were brought to the national park from South Africa in February this year.

Few cheetahs from Kuno to be moved to Gandhi Sagar Wildlife Sanctuary by Nov

Bhopal: A few African cheetahs translocated to the Kuno National Park (KNP) in Madhya Pradesh will be relocated to the Gandhi Sagar Wildlife Sanctuary in Mandla and Neemach districts of the state by November this year.

Earlier, it was said that the Mukundra Hills Tiger Reserve in Rajasthan will be the first priority for relocating some of the big cat. However, the Cheetah Task Force Committee has now decided to shift some of the big cats from KNP to the Gandhi Sagar Wildlife Sanctuary.

Chandra Prakash Goyal, the Director General of Forest Ministry, who was in Bhopal to attend the National Tiger Conservation Authority's (NTCA) meeting on Monday, said that the Gandhi Sagar Wildlife Sanctuary is the first priority for relocating some of the cheetahs from KNP, and the next habitat (after Gandhi Sagar) for the cheetahs will be the Nauradehi Wildlife Sanctuary, the largest in Madhya Pradesh.

"The Madhya Pradesh government has informed that the Gandhi Sagar Wildlife Sanctuary will be ready to receive the cheetahs by November this year, but the way preparations are going on, I believe that the habitat will be ready to receive the big cats before that. Kuno has space to accommodate 21 cheetahs while 20 cheetahs were introduced there. After that, four cubs were born there. Three cubs and three mature cheetahs have died so far at Kuno, but the number will increase in future," Goyal said.

A senior forest official said that Rs 20 crore will be spent for fencing a 80 sq km area and for developing grassland at the Gandhi Sagar Wildlife Sanctuary, which is spread over an area of 368 sq km. The sanctuary was notified in 1974. Notably, the Chambal River passes through the sanctuary dividing into two parts - one in Mandla district and the other in Neemach. The Nauradehi Wildlife Sanctuary, which is spread over an area of 1,197 sq km, is spread across four districts - Sagar, Damoh, Narsinghpur and Raisen.

RPF arrests two with 22 kg marijuana in Satna

The Railway Protection Force (RPF) has arrested two persons allegedly for smuggling marijuana in Madhya Pradesh's Satna district.

They were arrested by the police at Uchehra railway station on Monday. According to the RPF, the arrested persons have been identified as Sundaram Tiwari, a resident of Panna district, while the other accused has been identified as Raj Chaurasia, a native of Chandauli district in Uttar Pradesh.

Sanjay Mishra, a senior RPF official said around 22 kg marijuana of worth Rs 1.7 lakh was recovered from their possession.

"During the search, we have recovered 10 kg ganja from Sundaram Tiwari, while around 12 kg ganja was recovered from Raj Chaurasia. The duo have been booked under Section 8/20 of the NDPS Act and the case has been handed over to GRP for further investigation," Mishra said.

Main accused held is associated with Bajrang Dal: Digvijaya Singh

Bhopal: Veteran Congress leader and Rajya Sabha MP Digvijaya Singh claimed that one of the two accused arrested for allegedly smuggling marijuana in Madhya Pradesh's Satna district was 'associated' with right wing Bajrang Dal.

The Congress leader said arrested person Sundaram Tiwari, who was arrested by Railway Protection Force (RPF) on Sunday with 10 kg cannabis at Uchehra railway station under Satna district, "is an office-bearer of Bajrang Dal".

Digvijaya has shared some photographs of Sundaram Tiwari (21) with Madhya Pradesh BJP President V.D. Sharma on his official Twitter handle. The Congress leader has also tagged RSS head Mohan Bhagwat and Prime Minister Narendra Modi, seeking an answer from them.

"Bajrang Dal's Panna district co-convenor Sundaram Tiwari has been caught by Railway police for smuggling ganja. Is smuggling of cannabis a is a cultural act? Chief of RSS and Bajrang Dal should give reply on this matter," Digvijaya's social media post read.

Further, he also hit out at the Prime Minister saying the latter has "misused the name Lord Bajrang Bali for such people". "He (PM Modi) should apologise for using Bajrang Bali's name for such people," the Congress leader made this statement while referring to a controversy broke out in the name of Bajrang Bali during Karnataka assembly poll concluded recently.

ORANGE ALERT IN GWALIOR-CHAMBAL; RAIN LIKELY IN BHOPAL, INDORE FOR NEXT 3 DAYS

Bhopal: Storm and rain in Madhya Pradesh sucked the heat out of Nautapa in state. An orange alert was issued in Gwalior-Chambal division, following heavy rain and hail. Strong winds and rain expected for the next 3 days in Bhopal, Indore, Ujjain, Jabalpur, accompanied by thunderstorms at night. Other regions report light drizzle and varying rainfall. Seoni records 2.4 mm, Satna 0.4 mm, and Guna 0.2 mm of rain in the last 24 hours. Bhopal, Indore witnessed winds at a speed of 40 km/h winds, uprooting trees in several areas. Guna, Chhindwara, and Rewa received over 1 inch of rainfall. The Meteorological Department issues hail-storm warnings for Guna and Sheopur. Anuppur, Jabalpur, Mandla, Seoni, Indore, Ujjain, Rewa, Narmadapuram, Bhopal, and Sagar divisions may experience increased wind speeds. Bhopal is predicted to have rain on May 30-31, cloudy weather on June 1, and clear skies on June 2. Madhya Pradesh witnesses 348% more rainfall than normal, with 77.1 mm since March 1.



Bhopal district records 121.3 mm, a significant increase from the normal rainfall of 21 mm. Senior Weather Scientist Vedprakash Singh explains the influence of three systems with southwesterly winds, including the Western Disturbance, cyclonic circulation over Rajasthan, and active trough lines. Moisture from the Arabian Sea also contributes to the high wind speeds and precipitation.

Condoms, Birth Control Pills In Madhya Pradesh's New "Wedding Kit"

Condoms and contraceptive pills were found inside make-up boxes given to brides at a mass wedding event in Madhya Pradesh's Jhabua district on Monday.

A mass wedding event was organised under Chief Minister Shivraj Singh Chouhan's Mukhyamantri Kanya Vivah/Nikah Yojana, a scheme for women from economically weaker sections, in Thandla where as many as 296 couples were wedded. Condoms and contraceptive pills were distributed to newlyweds under the scheme. The packets were found inside make-up boxes that were distributed among the couples as part of the scheme.

Senior district official Bhursingh Rawat laid the blame on the state health department, saying that it is possible that health officials might have distributed condoms and contraceptives as part of an awareness program related to family planning. "We are not responsible for distributing the condoms and the contraceptive pills. It is possible that the health department gave away the material as part of its family planning awareness program. Under the Mukhyamantri Kanya Vivah/Nikah Yojana, we transfer Rs 49,000 directly to the beneficiary's bank account. We are responsible for providing food, water, and a tent, which



amounts to Rs 6,000. I had no idea what was in the packets that were distributed," Rawat said. The Madhya Pradesh government launched the Mukhyamantri Kanya Vivah/Nikah Yojana in April 2006 to provide financial assistance for the weddings of women from economically weaker sections. Under the scheme, the government provides Rs 55,000 to the bride's family. Last month, the scheme came under fire after some brides were made to take pregnancy tests at a mass wedding event in Gadsar area of Dindori. A woman whose pregnancy test came back positive said she had been living with her fiancé before the wedding.

Shamelessness in Shivraj: Congress

"Shamelessness at its peak in Shivraj: The BJP government of Madhya Pradesh has distributed condoms and contraceptive tablets in make-up boxes given under the Kanya Vivah Yojana. Shivraj ji, no shame left?" the Congress said.

The chief medical officer of Dindori had said that tests are usually conducted to verify the age of the bride and groom, to check for sickle cell anemia, and to ensure that they are physically fit.

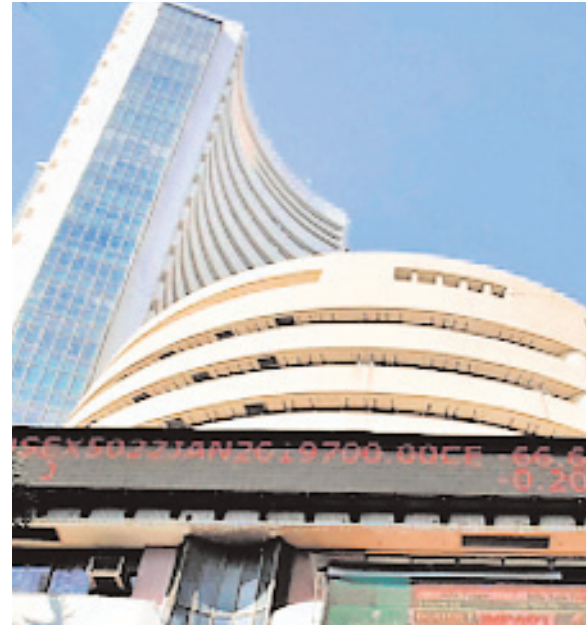
Differences bridged in Rajasthan!

The Congress top leadership brokered a truce between Rajasthan Chief Minister Ashok Gehlot and party leader Sachin Pilot after party chief Mallikarjun Kharge and senior leader Rahul Gandhi pacified both the leaders with assurance of justice and respect, sources said on Tuesday. The meeting to bring the two warring leaders together ahead of the crucial Assembly elections in Rajasthan has brought a much needed relief to the party leadership which deliberated and discussed the issues for over four hours. After the meeting, party General Secretary, Organisation, K.C. Venugopal announced that the Congress will fight unitedly in Rajasthan as he was flanked by both state leaders with smiles on their faces. According to party sources, it was Kharge, who first initiated the talks with Gehlot and was later joined by Gandhi. The two senior leaders, after discussing with Gehlot for over one and half hours, asked Pilot to join the meeting. Once, Pilot came, the party chief and Rahul Gandhi then held meeting with him separately before bringing both the leaders together. The source said that Gandhi dubbed both Gehlot and Pilot as assets to the party and told them that the way in which the Congress won in Himachal Pradesh and Karnataka by sidelining the differences, it need to win Rajasthan together and need to defeat the BJP, which is grappling with internal fights. The source said that both the leaders were told by Gandhi that it has got better prospects in Madhya Pradesh and Chhattisgarh and need to focus completely on Rajasthan. The Gandhi also told Gehlot that he will fulfill the promises that he has made to Pilot and also assured him that his dues will be considered. The source said that as expected by Pilot, the leaders didn't discussed the issues raised by the former Rajasthan state unit chief.

WHY FOREIGN INVESTORS HAVE FALLEN IN LOVE WITH INDIA ALL OVER AGAIN

Indian markets have been on a roll and are now close to their all-time high which were made on December 1, 2022, on a closing basis and an intra-day basis. These levels were 63,583.07 and 63,284.19 points on BSE Sensex and 18,887.60 points and 18,812.50 points on Nifty. The closing levels on Friday, May 26, were at 62,501.69 points and 18,499.35 points, respectively. The difference on a closing basis is about 1,100 points or 1.73 per cent on BSE Sensex and about 400 points or 2.11 per cent on Nifty. These levels could get breached in the coming week or markets may once again fail to cross the all-time high. Results season is almost over and Foreign Portfolio Investors (FPIs), who were aggressive sellers for the better part of 2022 right until August September, have turned buyers. In the first two months of the current calendar year, they were sellers with January being over Rs 41,000 crore and February a smaller Rs 11,000 crore. This converted to a small buy of Rs 2,000 crore in March and about Rs 6,000 crore in April and literally taking off in May with purchases of more than Rs 37,000 crore. What could have changed or what made the FPIs change their view? There are a few factors which have led to this change. Earlier when FPIs sold, our markets fell and vice versa. Now one finds that the domestic institutions, fuelled by the SIPs from retail investors and their investments in mutual funds, are providing the wherewithal to them to face up to the brutal selling of FPIs. This ensures that markets swing less and react much less to serious selling. Further, 2022 and part of the current financial year 2023 have witnessed unprecedented inflation and rising interest rates globally. India was no excep-



tion. The difference however is the fact that inflation in India is now within the comfort zone of its central bank RBI. This also has a longer-term implication in interest rates having peaked in the country and in the near term we could see them declining, albeit gradually. This would make business in India more com-

petitive going forward. Further Indian business has faced up to the challenges of volatile raw material and logistic nightmare during Covid and post Covid quite well. The gradual shift of China+1 also helped India. As a result, services exports from the country zoomed and helped its foreign exchange situation as well. With India being one of the few countries in the world to continue to grow against negative growth in many more, it became a favourite destination for FPIs to hedge their bets. The government focus is on infrastructure and roads, bridges, railways are literally coming up overnight. A large country like India has seen distances and time shrink. This leads to better price for fresh produce, impetus to industry and ensuring timely shipment of goods locally and also for export. Yet another big development is the fact that FPIs have started looking at emerging companies from the midcap space which have the technology and manufacturing edge compared to its global peers. The PLI or production linked incentive scheme across many sectors has made Indian industry much more competitive than ever before. Markets because of various factors like Covid, global inflation and rising interest rates have done literally nothing over the last eight quarters. If one is to look at the BSE Sensex, it has been moving between 52,500 and 62,500 since March 21 till now. Similar levels on the Nifty are 15,700 and 18,500. The net change compared to June 21 is 2,800 points on Nifty and 10,000 points on BSE Sensex. With valuations remaining subdued or unchanged, the Indian markets offer an opportunity to FPIs to make money and it is this opportunity that they seem to be encashing with both hands. Cong allots plum posts to Dalits, oppressed classes in K'taka

The Congress in Karnataka, which came to power following a shift of votes of Dalits and oppressed classes from the BJP, has not only given more number of Cabinet berths to these sections, but has also ensured that they got plum and respectable posts. The major Cabinet berths held by the dominant Lingayat and Vokkaliga communities in the previous BJP government have been allotted to leaders hailing from the Dalit community and the oppressed classes. The Muslim community, which had gone unrepresented in the previous BJP regime, has also been allotted two Cabinet posts held by dominant castes in the previous regime. Chief Minister Siddaramaiah, who takes special care for the empowerment of Dalits, both financially and socially, has ensured that the exploited classes, especially the Dalits, get their due. In his previous term as the Chief Minister,



Siddaramaiah had introduced reservation in government contracts of up to Rs 50 lakh for Dalits for the first time. The BJP had raised the cap to Rs 1 crore ahead of the elections. Senior Dalit leader R.B. Thimmapur has been allotted the most sought after Excise Department earlier held by K. Gopalaiiah belonging to the Vokkaliga community in the previous BJP government. G. Parameshwara, a prominent Dalit

leader, has been entrusted with the Home Department. Though sources said that Parameshwara is not happy with the portfolio, the Congress has managed to pass on the message to the masses by making a senior Dalit leader the Home Minister. Previously, the post was held by Araga Jnanendra belonging to the Vokkaliga community. The right-hand man of Siddaramaiah, H.C. Mahadevappa, has been given the Social Welfare portfolio earlier held by Kota Srinivas Poojari belonging to the Billava community, considered as OBC but does not face the stigma of untouchability. Former Union minister and senior Congressman K.H. Muniyappa has been allotted the Food and Civil Supplies and Consumer Affairs department. The portfolio has assumed importance as the Anna Bhagya scheme, which ensures 10 kg rice to every member of BPL families, will be implemented through the department. Late Umesh

Katti from the Lingayat community held the portfolio in the previous BJP government. Mass leader of the oppressed classes, Satish Jarkiholi, has been allotted the much sought after Public Works ministry, which was held by C.C. Patil belonging to the Lingayat community during the BJP rule. Congress President Mallikarjun Kharge's son Priyank Kharge has been allotted the Rural Development and Panchayat Raj portfolio that was previously held by K.S. Eshwarappa belonging to the Kuruba community. Shivaraj Tangadagi, a Dalit leader from north Karnataka, is given the Backward Class, Kannada and Culture Ministry. In the previous BJP government, the portfolio was held by V. Sunil Kumar belonging to the Billava community, a dominant caste in the coastal Karnataka region.

ELITE MOSCOW SUBURB HIT BY KAMIKAZE DRONES 'WITH BLASTS WITHIN EARSHOT OF PUTIN'S RESIDENCE'

Moscow was attacked on Tuesday morning by suspected Ukrainian kamikaze drones, just hours after Russian President Vladimir Putin unleashed yet another volley of strikes on Kiev, a media report said. Several buildings were damaged in the wealthy suburbs of Moscow, including the elite district of Rublyovka to the south-west of the capital, Daily Mail reported. One drone exploded into a mushroom cloud near the village of Usovo, which is just down the road from Putin's official Novo-Ogaryovo residence, the report said. "[Putin's residence] would be in earshot of the explosion," a local resident said. Explosive drones also struck blocks of flats in Leninsky Prospekt and Profsoyuznaya Street, about six miles from the centre of Moscow, reportedly wounding several residents and damaging the buildings. Ukraine made no immediate comment on the attack, which would be one of its deepest and most daring strikes into Russia



since the Kremlin launched its full-scale invasion of Ukraine more than 15 months ago, Daily Mail reported. Tuesday's early morning raid targeted some of Moscow's wealthiest areas, including a western enclave where Putin and the elite have their residences. Two people were injured while some Russians in two lightly-damaged apartment blocks were briefly evacuated, according to Moscow's Mayor. Russia's Defence Ministry claimed that eight drones sent by Kiev were shot down or diverted, though Baza, a Telegram channel with links to the security services, said more than 25 were involved. It called the incident a "terrorist attack" by the "Kiev regime". Residents said they heard loud bangs followed by the smell of petrol. Some filmed a drone being shot down and a plume of smoke rising over the Moscow skyline, Daily Mail reported. The Kremlin, which has launched a series of deadly airstrikes at Kiev, said there is 'no threat at the moment' for the residents of Moscow.

Air New Zealand to weigh passengers before boarding flights: Report

Air New Zealand will begin weighing passengers departing on international flights from the Auckland International Airport starting from July 2, the media reported on Tuesday. The flag carrier said the programme, which the airline calls a passenger weight survey, is a way to gather data on the weight load and distribution for planes, CNN reported. "We weigh everything that

goes on the aircraft -- from the cargo to the meals onboard, to the luggage in the hold," Alastair James, the airline's load control improvement specialist said in a statement. "For customers, crew and cabin bags, we use average weights, which we get from doing this survey." In order to protect individuals' privacy, the airline said that it will make the data anonymous. As part of the programme, travellers will be asked to stand on a digital scale when they check

in for their flight, CNN reported. The information about their weight is then submitted to the survey but will not be viewable on the agent's screen. They will also place their luggage on another identical scale for separate weighing. "We know stepping on the scales can be daunting. We want to reassure our customers there is no visible display anywhere. No one can see your weight, not even us," James was quoted as saying in the statement.

CLASHES ERUPT AS CHINESE MUSLIMS PROTEST TO SAVE MOSQUE YUNNAN



Singapore: Protesters have clashed with large numbers of police over the planned demolition of a mosque's dome in a largely-Muslim town in Yunnan, China, according to media reports. Social media videos showed crowds outside the 13th-century Najjaying Mosque in Nagu town on Saturday. Scuffles broke out between police and locals, who were hemmed in by hundreds of armed officers, BBC reported. Yunnan, an ethnically-diverse province in southern China, has a significant Muslim population. In Nagu, the Najjaying Mosque had been a key landmark and in recent years had expanded with a new domed roof, as well as a number of minarets.

Volatile ceasefire extended in violence-hit Sudan

The Sudanese Army and paramilitary Rapid Support Forces (RSF) have agreed to a five-day extension of a ceasefire agreement the two warring sides signed on May 20, as relevant parties, including the African Union (AU), are hammering out a road map to ending the protracted conflict. While the two sides affirmed commitment to allowing the safe passage of civilians from conflict areas and protecting civilian supplies, the truce has been constantly breached during the cease-fire period, impeding humanitarian access and restoration of genuine stability, reports Xinhua news agency. The Agreement on a Short-Term



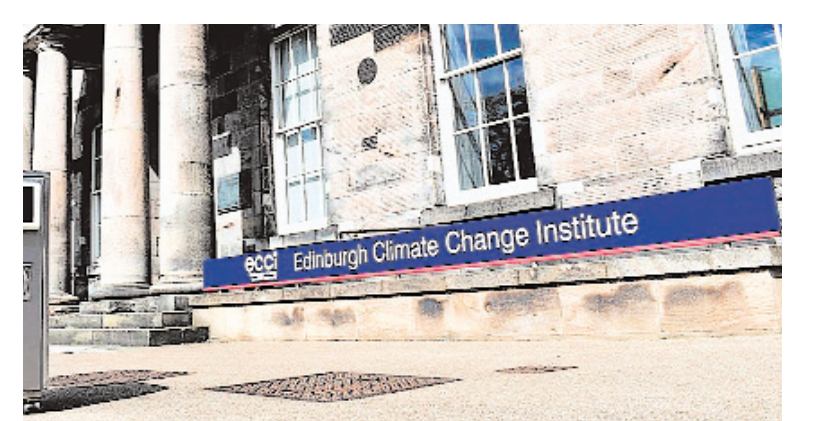
Cease-fire and Humanitarian Arrangements was reached through negotiations that started on May 6 in Jeddah under a Saudi-US initiative with the aim of ending the conflict in Sudan and facilitating access of humanitarian aid to civilians. The seven-day truce, which entered into force on May 22, was scheduled to expire at 9.45 p.m. on Monday. Not

long after the agreement took effect, sporadic clashes were reported between the army and the RSF. In a statement last week, Saudi Arabia and the US said that the cease-fire monitoring mechanism detected serious breaches of the agreement. As relevant parties were working on the extension on Monday, violent clashes broke out in Sudan's capital Khartoum.

Huge thanks to the online course development team here at Edinburgh, and to the wonderful translation work led by our colleagues in the India Consulate, in bringing this important new course to life," Reay said in a statement. The increased

accessibility of the course with the additional language marks a milestone moment for the University Institute, the University statement read. The five-week course focuses on different climate zones across India and how the changes in zones could impact the country's health, agriculture and the economy.

Mumbai Metro 2A, 7 commuters get free accident, disability, death insurance cover

V. R. Srinivas. "We have provided comprehensive insurance coverage to our valued customers. With this policy in place, commuters can now travel with peace of mind, knowing that they have adequate insurance coverage in case of any unfortunate incidents," said Srinivas. All passengers who have a valid ticket, pass, smartcard, QR code, or valid per-



mission to present either in a Mumbai Metro building, a station, in the train or on the station premises barring the external areas like parking lots, cab-stands, foot-overbridges, cycle stands, etc. Srinivas said that apart from all the safety and security measures in place, this insurance policy would

secure a passenger's commute from unforeseen circumstances and enable them travel with a peace of mind. Similar insurance coverage is given to passengers on the Lucknow Metro and outstation trains of the Indian Railways, but for the latter the passengers have to pay a nominal amount as premium.

MPID court orders EOW to probe ex-FMC chief Ramesh Abhishek's role in NSEL crisis

The National Spot Exchange Limited (NSEL) on Tuesday said the Maharashtra Protection of Interest of Depositors (MPID) Court has directed the Economic Offences Wing (EOW) of Mumbai Police to probe the involvement of former Forward Markets Commission (FMC) Chairman Ramesh Abhishek in the Rs 5,600 crore NSEL crisis and submit its report within 40 days. An application was filed by NSEL on a backdrop that the Mumbai EOW filed its final charge sheet in December 2022, but had not investigated the role



of FMC and its then chairman Ramesh Abhishek in the NSEL payment default case. In its recent order, the MPID Court asked the investigating officer to carry out a free and impartial investigation into the role of Ramesh Abhishek, the then Chairman of FMC during the period of offence. Further, the investigating officer has

been directed by the Special Court to submit its report as early as possible, preferably within 40 days from the order date without fail. In its representation to the EOW in 2020, NSEL had highlighted several instances of negligence and failures on the part of Abhishek, which the agency did not investigate. "We are hopeful that the investigation into the role of Ex-FMC Chairman Ramesh Abhishek will be fair and impartial, and will unearth the motive behind the inactions," said NSEL Managing Director and CEO Neeraj Sharma. The crisis was engineered by the ill-advice of FMC chairman to the Department of Consumer

affairs (DCA) that NSEL had violated certain conditions of exemption granted to it under FCRA. This resulted in the DCA issuing Show Cause Notice (SCN) to the exchange in April 2012. Despite a detailed reply to the SCN and a subsequent follow up, there was no decision on the SCN until July 2013, when the exchange was abruptly told to stop functioning, resulting in the payment default crisis, the NSEL pointed out. "Till date, the SCN remains unadjudicated. This goes to show that Abhishek's actions were fraudulent, mala fide, motivated and resulted in deliberately creating the crisis," it alleged.

22 MLAs, 9 MPs May Quit Eknath Shinde Faction, Claims Team Thackeray

The Uddhav Thackeray-led Shiv Sena (UBT) has claimed that 22 MLAs and nine MPs from the faction led by Chief Minister Eknath Shinde, are feeling suffocated due to "step-motherly treatment" by the BJP and could quit. An editorial in Sena (UBT) mouthpiece 'Saamana' has dubbed the MPs and MLAs belonging to the Shinde group as "fowls" in BJP coop and there's no saying when they could be slaughtered. In 2019, the Sena had severed its ties with the BJP for the same "step-motherly treatment", the editorial also mentioned. There are reports are that Shinde group's 22 MLAs and nine MPs are feeling suffocated because of step-motherly treatment by the BJP and they have developed the mindset to quit the group," the editorial said. The Sena MPs and MLAs who



"betrayed" the Thackerays and joined hands with the BJP, has had their "love affair turned sour" and there are "talks of divorce," it added. The matter was raised over the weekend by Sena MP Gajanan Kirtikar, who alleged that his party was getting step-motherly treatment from the BJP. "We are part of the NDA....So our work should be carried out accordingly,

and (NDA) constituents should get a (suitable) status. We think we are being given step-motherly treatment," Mr Kirtikar had said on Friday. His comment came as a shot in the arm for the UBT, which responded the next day. "Shiv Sena distanced itself from the BJP as the party was trying to finish it," said Sanjay Raut, one of the senior-most leaders of the UBT and the editor of Saamana. "The BJP is like a crocodile or python. Whoever goes with them, they are swallowed. Now they (Shiv Sena MPs and MLAs who rebelled against leadership) will realise that Uddhav Thackeray's stand to distance himself from this crocodile was right," added Mr Raut, who is also a close aide of Uddhav Thackeray.

Banner put up by Eknath Shinde-led Shiv Sena torn in Thane district; five booked

An offence has been registered against five persons for allegedly tearing the banner put up by Maharashtra Chief Minister Eknath Shinde-led Shiv Sena party in Maharashtra's Thane district, police said. Based on a complaint lodged by a former corporator, a case under sections 143, (a member of an unlawful assembly) 147 (rioting), 427, (mischievous causing damage to the amount of Rs 50) and other relevant provisions of the Indian Penal Code has been registered with Kalwa police, an official said. As per the complaint, the incident took place in the early hours of May 27, when the motorcycle-borne accused arrived near the complainant's house in Vitawa area of Kalwa and verbally abused him and hurled bricks at him, he said. They also allegedly tore the party's banner announcing the launch of various schemes in the area, the official added. Meanwhile, The Thane city police have registered a case against a member of a political outfit for allegedly defaming Maharashtra Chief Minister Eknath



Shinde's family. An official said on Monday that accused Ajay Jaya of Dharmarajya Paksha made defamatory remarks after the Thane civic body on May 25 pulled down the extended portion of a sweet shop in the Panch Pakhadi area. Following the demolition, Jaya claimed on social media that the action was taken after a relative of the CM had a tiff at the shop, the official said. The shop owner on Monday lodged a complaint with the Naupada police saying that no such incident ever occurred. He said similar action was taken against more shops in the area and that Jaya was trying to defame the CM's family. Police have registered a case under Indian Penal Code section 500 (defamation) and no arrest has been made, added the official.

Farmers to get Rs 6,000 a year under new scheme approved by Cabinet

Chief Minister Eknath Shinde-led Maharashtra government on Tuesday rolled out a new financial scheme under which more than one crore farmers in the state will be paid Rs 6,000 annually. The new scheme, 'Namo Shetkari Mahasannam Yojana', was approved at a Cabinet meeting chaired by Chief Minister Eknath Shinde in Mumbai. CONSTABLE, MEDICAL OFFICER BOOKED IN BID TO DUPE LIC OF RS 2 CRORE

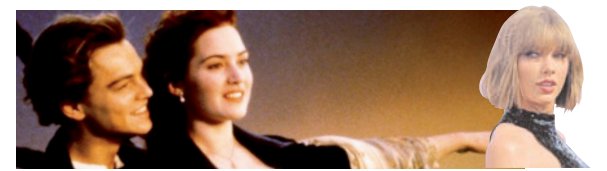

The Shivaji Park police, who have been investigating a conspiracy to fraudulently obtain Rs 2 crore from an insurance company, have framed charges against the medical officer of a civil hospital and a constable, who helped to hand over a body, which was made to appear of the person who had bought the policy, to the accused. The accused had paid Rs 60,000 to the doctor for the job. The constable is still absconding. The cops have filed a 1,200-page charge sheet against six individuals in connection with the case. An offence was registered at the Shivaji Park police station following a complaint by an official from the Life Insurance Corporation (LIC) on February 21. The official alleged that on March 14, 2017, a woman named Nandabai Taksale applied for a death claim mentioning her son Dinesh lost his life in a road accident on December 25, 2016. The policy issued by LIC in 2015 was worth Rs 2 crore and the applicant Dinesh had claimed he was



earning Rs 38.85 lakh from his farm and Rs 2.74 Lakh from his mess annually. On July 5, 2015, the LIC office decided to accept his application and sanctioned a Jivan Anand policy for 35 years worth Rs 2 crore. Dinesh had been asked to pay Rs 1.46 lakh as a premium for the first trimester. In March 2017, during the verification process, LIC officials found that the documents provided by the woman while applying for the policy were forged. Dinesh apparently didn't own any farm or run any mess. There were discrepancies in the documents attached to the death claim. An application was made to the police

station for investigation and during the probe when the cops reached Dinesh's residence they were surprised to find that, his mother knew nothing of this and she said her son was very much alive. After a search was launched, Dinesh was arrested on March 2. The probe revealed that two others, Anil Lakde, 32, and Vijay Malwade, 33, were involved. They were arrested on March 4. The trio had gone to the Shrigonda Civil Hospital and managed to get a body. They prepared documents for 'Dinesh's' and even 'cremated him'. The woman who would later pose as Dinesh's mother while applying for the policy money also played this role in the hospital. Cops have booked all the accused under Section 120B (criminal conspiracy), 420 (cheating), 465 (forgery), 467 (forgery of valuable security, will, etc), 468 (forgery for the purpose of cheating), 471 (using forged document as genuine) and 511 (Punishment for attempting to commit offences punishable with imprisonment for life or other imprisonment) of the Indian Penal Code.

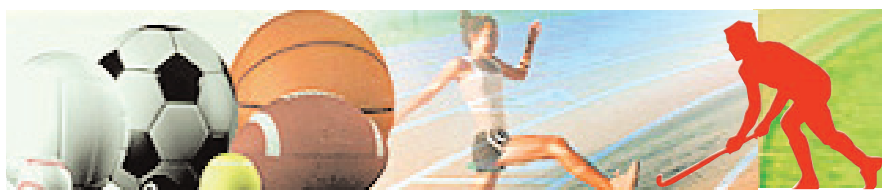

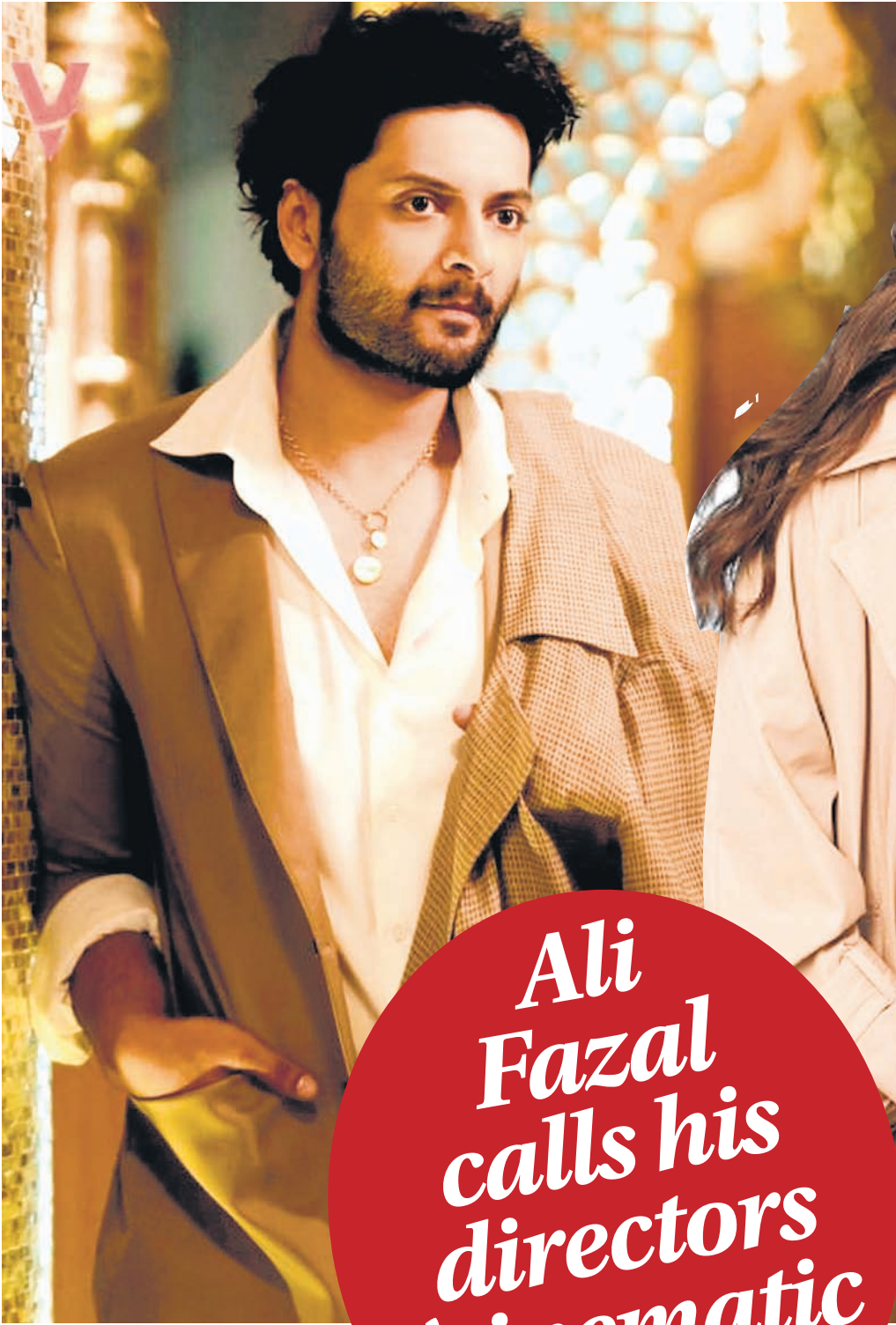
