Two killed, Four injured in shootout between armed groups in Manipur

t least two people were killed and four others injured during a shootout between two armed groups in Manipur's Bishnupur-Churachandpur border areas on Friday, officials said. The incident took place early morning near the Phougakchao Ikhai village.

The injured people have been taken to the Churachandpur hospital.

Para-military and Manipur armed police personnel immediately rushed to the area and launched a search operation to nab the armed cadres.

US ENVOY IN INDIA OFFERS ASSISTANCE

New Delhi: US Ambassador to India Eric Garcetti on Thursday said that his country is "ready to assist" the Centre in its peace efforts to restore normalcy in violence-hit Manipur, though it remains India's internal matter."I don't think it's about strategic concerns, it's about human concerns. You don't have to be an Indian to care when children or individuals die in this sort of violence," Garcetti said in response to a question on whether the US was concerned about the violence in Manipur."We stand ready to assist in any ways if asked. We know it's an Indian matter and we pray for that peace and that it may come quickly," he said.



CONG SLAMS CENTRE OVER US AMBASSADOR'S COMMENTS

New Delhi: Reacting sharply to Garcetti's statement, the Congress said it's very rare for a US envoy to make such a statement on India's internal affairs and that the country has never appreciated any such "interference". "To the best of my recollection going back at least 4 decades in Public life I have never heard a US Ambassador making a statement of this nature about the internal affairs of India,'

Congress leader Manish Tewari said. "We faced Challenges in Punjab, J&K , North East over the decades and surmounted those with sagacity & wisdom. I doubt if the New @USAmbIndia @ericgarcettz is cognisant of the convoluted & torturous history of US-India relations & our sensitivity about interference perceived or real, well intentioned or mal intentioned into our internal affairs," Tewari said.

Peace meet of 10 political parties slams PM for his silence

Imphal: A Peace Convention of 10 parties, including the Congress, AAP, four Left parties, here on Friday strongly condemned Prime Minister Narendra Modi, for his total silence on Manipur turmoil "as he has neither spoken a single word on the situation nor appealed for peace and restoration of normalcy in the state as yet in the last 65 days".

Accusing Chief Minister N. Biren Singh for the ethnic violence and asking him to quit from his post, the Convention resolved that the need of the hour is to restore peace and normalcy, bridge the unprecedented divide among the ethnic groups and heal the wounds of the people. The Peace Convention expressed gratefulness to Congress leader Rahul Gandhi for his two-day visit to Manipur as a 'Peace Messenger' and hoped that the Parliamentary team of 5 MPs of the Left parties, who came to assess the situation in Manipur, to recommend, through Parliament, to the Center to take necessary action to restore normalcy, peace and tranquillity in the state and to urgently resolve the ongoing violence in the state. Manipur state Congress President Keisham Meghachandra, Nationalist Congress Party state President S. Iboyaima Singh, Janata Dal-United state President K. Rahul Gandhi's request in defamation case rejected by Gujarat High Court

CONGRESS SAYS, RESPECT HIGH COURT JUDGEMENT, WILL APPROACH SUPREME COURT

The Congress party on Friday staged protests against the Gujarat court's verdict on Congress leader Rahul Gandhi in different states, terming it as Bharatiya Janata Party's 'political vendetta'.

he Gujarat High Court turned down Congress leader Rahul Gandhi's request seeking a hold on his conviction in a defamation case over his 2019 Modi surname remark

The Gujarat High Court said, "Refusal to stay conviction would not in any way result in injustice to the applicant. There are no reasonable grounds to stay conviction. The conviction is just, proper and legal.'

The High Court said there were "as many as 10 cases pending" against Rahul Gandhi and he was "seeking a stay on absolutely non-existent grounds. A stay on conviction is not a rule", said the judge. Soon after the Gujarat High Court on Friday denied stay on the conviction of former Congress president Rahul Gandhi in a 'Modi surname' remark defamation case, the Congress said that it respects the court judgement and would approach the Supreme Court. The party termed the judgement "disappointing but not unexpected." Addressing a press conference here at the party headquarters, Congress



leader and senior lawyer Abhishek Manu Singhvi said: "Today, a single judge bench of the Gujarat High Court passed an order dismissing

Rahul Gandhi's application asking for a stay on conviction. This is highly disappointing, but it is not unex-

CONGRESS TO HOLD 'MAUNA

New Delhi: The Congress on Friday asked all the state units chiefs to hold one-day 'Maun Satyagraha' (silent protest) in front of Gandhi statues in all state headquarters in solidarity with former party chief Rahul Gandhi on July 12. In a communication to all the state presidents, Congress General Secretary (Organisation) KC Venugopal said: "The entire world has seen how Rahul Gandhi has consistently been questioning and exposing the relationship between Modi and Adani, on various platforms. His courageous pursuit has forced the Prime Minister and BJP to resort to crooked measures leading to his conviction and disqualification from the membership of Lok Sabha."

Balasore triple train tragedy: CBI arrests senior Railways engineer, two others

ave after taking over the probe of the triple train accident in Odisha's Balasore in which 292 people died and over 800 injured, the Central Bureau of Investigation (CBI) arrested three people in connection with the case, including a senior Railways engineer.

"The agency has arrested

Arun Kumar Mahanta, posted as Senior Section Engineer in Balasore, Mohammad Amir Khan, posted as Section Engineer at Soro, and Pappu Kumar, a technician posted at Balasore in connection with the case," a CBI official told reporter. The official said that they have been arrested under Sections 304 (culpable homicide not amounting to murder) and 201 (destruction or concealment of evidence) of the Indian Penal Code.

TOMATOES AT RS 250 A KG

Uttarkashi: The humble tomatoes are now going at princely rates up north, with the kitchen staple going at Rs 250 per kg in Gangotri Dham and Rs 180 to 200 per kg in Uttarkashi district.

seller said tomatoes ha dearer in the region all of a sudden.

"Consumers are bearing the brunt of the rising prices of the tomatoes in Uttarakashi. People are not even willing to buy them. In Gangotri, Yamunotri, tomatoes are going at Rs 200 to Rs 250 per kg,"

Rakesh, a vegetable seller told news agency. Many attributed the sharp rise in the vegetable prices to the prevailing heatwave in key tomatogrowing areas, as well as heavy rains, leading to a disruption in supply chains.Tomatoes also have a relatively lower shelf life, which is also believed to be having a bearing on their prices. In Chennai, tomatoes are currently selling at Rs 100-130 per kg.Faced with a price pinch, the Tamil Nadu government has started selling tomatoes at a subsidized rate of Rs 60 per kg at ration shops in state capital Chennai in a bid to bring some respite to the consumers amid the price spiral.Like many states, Karnataka has also seen tomato prices go through the roof in recent days.Tomato prices in Bengaluru range from Rs 101 to 121 per kilogram. The high prices have been attributed to the sudden temperature increase in March and April, resulting in pest attacks on the tomato yield higher market rates.

ED attaches assets worth Rs 52 cr of Sisodia, his wife, others

n a major move, the Enforcement Directorate said on Friday that it has attached assets worth Rs 52.24 crore belonging to arrested AAP leader Minister Manish Sisodia, his wife and some other accused persons in connection with the Delhi excise policy case.

The ED said in a statement that the agency has attached assets worth Rs 52.24 crore belonging to Sisodia, Amandeep Singh Dhall, Rajesh Joshi, Gautam Malhotra and others in connection with the case.

The agency said that the attached assets include immovable properties worth Rs 7.29 crore -- including two immovable properties of Sisodia and his wife Seema Sisodia, land/flat of Joshi or Chariot Productions Media Pvt Ltd and land/flat of Malhotra

The probe agency said that the attachments also include movable assets worth Rs 44.29 crore, including bank balances of Sisodia worth Rs 11.49 lakh, Brindco Sales Pvt Ltd worth Rs 16.45 crore, and others. This was the second attachment in the



case by the agency. The ED had earlier attached properties worth Rs 76.54 crore of AAP communication in-charge Vijay Nair, Sameer Mahandru, Amit Arora, Arun Pillai and others.

Delhi court summons Brij Bhushan Singh in sexual harassment case

elhi's Rouse Avenue court has summoned Brij Bhushan Singh, a Member of Parliament from the Bharatiya Janata Party (BJP) and the former Wrestling Chief of India, in connection with allegations of sexual harassment made by the country's leading female wrestlers.

The court took note of the charge sheet filed in the case, responding to the claims made by six women wrestlers who have accused Singh of engaging in sexual harassment and intimidation.

The summons were issued by the Rouse Avenue court, requiring Singh to appear before the court on July 18. Additionally, Vinod Tomar, former Assistant Secretary of Singh, has also been summoned by the court.

The Delhi Police's charge sheet running over 1,000



pages was filed before Chief Metropolitan Magistrate Mahima Rai of Rouse Avenue Courts for the offences under Sections 354 (Assault or criminal force to woman with intent to outrage her modesty), 354A (making sexually coloured remarks), 354D (stalking) of Indian Penal Code (IPC) against accused

Brij Bhushan Sharan Singh. Tomar has been accused of offences under Sections 109 (abetting officer), 354, 354A, 506 (criminal intimidation) of the IPC. Reportedly, the charge sheet contains statements of around 200

Global temperatures the highest in at least 100,000 years

The planet's temperature has soared again to levels not seen in the modern record-keeping era, marking the fourth straight day of record temperatures. These alarming new records are likely the highest temperatures in "at least 100,000 years", one scientist told CNN.

he global average daily temperature climbed to 17.23-degree Celsius on Thursday, according to the University of Maine's Climate Reanalyser, which uses data from the US National Centers for Environmental Prediction, CNN

It's been a week of record-breaking temperatures. On Monday, the average global temperature reached 17.01degree Celsius, the highest in the NCEP's data, which goes back to 1979. On Tuesday, it climbed to 17.18degree Celsius, where it remained on Wednesday. Before this week, the record in NCEP's data was 16.92degree Celsius, which was set in August 2016, CNN reported.Though

this week's records are not yet official, another global climate tracking agency confirmed several in its own data. The European Union's Copernicus Climate Change Service said that Monday's and Tuesday's global temperatures were also records in its data, which dates back to 1940. While the records are based on observational data sets that only go back to the mid-20th century, they are "almost certainly" the warmest temperatures the planet has seen over a much longer time period, according to Jennifer Francis, a senior scientist at Woodwell Climate Research Center, CNN reported.

Scientists know this because of the many millennia of climate data extracted from proxies like tree rings, ice cores and coral reefs - data that is a cornerstone to their understanding of

the climate system and how humans have contributed to rapid global

"The climate change is out of control. If we persist in delaying key measures that are needed, I think we are moving into a catastrophic situation, as the last two records in temperature demonstrates." **Antonio Guterres, Secretary** General, UN

Sex in case of breach of promise for marriage cannot be deemed rape: Orissa HC

Cuttack Agencies n a landmark verdict, the

Orissa High Court has held that in a relationship, initially started and developed genuinely with friendship but souring after the male partner decided not to marry his partner, sexual intimacy should not always be branded as a product of mistrust and mischief, thereby accusing him of rape.

This judgement was delivered by a bench of Jutice R.K. Pattanaik on July 3, while hearing a petition challenging the legality of criminal proceedings initiated against a man in a case where a relationship had gone sour after seven years.

The court observed that in case that a relationship goes sour and a person decides not to marry his partner, the sexual intimacy that preceded should not always be con-

sidered as rape. Terming the act as dissimilar to having sex under the false promise of marriage, Justice Pattanaik said: "There is a subtle difference between breach of promise, which is made in good faith but subsequently could not be fulfilled, and a false promise to marriage. In the former case, for any such sexual intimacy, an offence under Section 376 IPC (sexual assault) is not made out, whereas, in the latter, it is, since the same is based on the premise that the promise to marriage was false or fake from the very beginning, which is given on the understanding by the accused that it would be broken finally."

The court, considering the complaint and other materials, said that is of the view that the entire story unfolded revealed the existence of friendship and thereafter, a relationship which was developed under different

IN CHHATTISGARH PM SAYS CONGRESS AN OBSTACLE IN DEVELOPMENT; CM BAGHEL HITS BACK

rime Minister Narendra Modi on Friday attacked the Congress calling it a 'panja' -- an obstacle -- in the development of Chhattisgarh.

Attacking Congress, PM Modi claimed 36 promises were made by the Congress. "Five years have passed. The truth is Congress has done a liquor scam worth thousands of crores in Chhattisgarh. And its complete information is in the newspapers," he said.

He said, "This is the 'panja' of Congress, which is snatching your rights. This 'panja' has decided that it will loot and ruin Chhattisgarh."

Modi was on a visit to Chhattisgarh's capital Raipur where he inaugurated several projects and also laid the foundation stones for the upcoming projects.

He said that it is only the BJP which understands the people of Chhattisgarh and knows their needs. "Foundation stone and inauguration of projects worth more than Rs 7,500 crore have taken place in the state,"



he said. However, the Chhattisgarh Chief Minister Bhupesh Baghel hit back at Modi saying his visit has started spreading lies in the state and BJP leaders are continuously misleading

the farmers that paddy is procured with the money of the Centre. "You are the Prime Minister. You the biggest lie in the name of farmers that the center takes 80 per cent of the state's paddy procurement. If the role of your government is this much in paddy purchase of the states, then why are farmers in your Lok Sabha constituency Varanasi forced to sell paddy at Rs.1000-1200 a quintals," Baghel asked.

Later, Prime Minister launched 29 development projects worth around Rs 12,110 crore here on Friday.

Addressing a public meeting at Wazidpur, the Prime Minister said that his government had ensured that the benefits of schemes reach the beneficiaries. "We have been sending the benefits to the people and also talking directly to them to ensure that they have received the benefits of the schemes. This leaves no room for middlemen or scams," he said.

Modi said that those who have got houses from the government are now

witnessing an appreciation in costs. He thanked the people of Varanasi for ensuring the victory of BJP in the recent municipal polls and for supporting the journey of development.

Delhi HC seeks response from NDMC on historic mosque's potential demolition

he Delhi High Court on Friday directed the New Delhi Municipal Council (NDMC) and Delhi Police to respond to a petition filed by the Delhi Waqf Board, expressing concerns over the potential demolition of a historic mosque that stands strong for over 150 years at the Sunehri Bagh Road roundabout in Lutyens' Delhi.

In a bid to gather accurate information, the court also instructed all parties involved to conduct a joint inspection at the site.

Justice Prateek Jalan has issued a notice on a plea seeking to protect a mosque from potential harm caused by the NDMC while listing the matter for further hearing on August 14.

During the proceedings on Friday, the court also emphasised the need for a practical and holistic approach, urging both parties to adopt a reasonable perspective.

The judge highlighted that indigenous properties are not exempt from acquisition as long as statutory conditions are met. He stressed the importance of treating all religious structures equally and applying consistent policies.

Consequently, the court ordered a joint inspection to take place on July 12 at 3 p.m., with the option for further inspections if necessary. "Notice shall be issued. The concerned



parties are instructed to conduct a joint inspection on July 12, 2023, at 3 pm, and may schedule additional inspections as required. The NDMC is authorised to notify any other relevant authority about the inspection," the court said."The respondents are directed to submit their response to the petition along with the necessary records within a period of two weeks. The report of the joint inspection should be presented as well," the court ordered. The petitioner's advocate, Wajeeh Shafiq, informed the court that the authorities had conducted an inspection at the site without the petitioner's presence.

The plea also stated that the mosque had been in existence for over 150 years and served a large number of worshippers, hosting daily prayers, Friday prayers, and Eid prayers. It alleged that the congestion in the area was not due to the mosque but rather due to uncontrolled vehicle parking on both

Inter-state arms trafficker supplying high-end weapons to Delhi criminal networks held

n inter-state arms trafficker supplying highend weapons to several criminal gangs, including infamous Kapil Sangwan alias Nandu outfit in Delhi and its surrounding areas, has been arrested by the Special Cell, an official

The accused, identified as Mohd Sajid alias Rashid, 38, a resident of JJ Colony near Wazirpur, used to purchase an illicit pistol of .32 bore for around Rs 30,000 and used to sell the same to the criminals for around Rs 40,000.

Special Commissioner of Police, Special Cell, H.G.S. Dhaliwal said that an information was received that Sajid, who is previously involved in several criminal cases, is indulged in smuggling of illicit firearms from Uttar Pradesh and is supplying



the weapons to the gang members of different syndicates, including the group of most wanted gangster Kapil Sangwan.

"The team deployed sources and made efforts to collect more information about Sajid and his

activities. After persistent hard work, specific information was received that Sajid would come near Uttam Nagar Bus Terminal to deliver a consignment of illegal firearms to some member of Nandu gang on the night of June 28," he said.

A trap was laid and Sajid was apprehended. "On search, eight illegal firearms (five sophisticated pistols of .32 bore and three single shot pistols of .315 bore) were recovered from his possession, said Dhaliwal.

On interrogation, it was revealed that when Sajid used to work as a meat contractor in Ghazipur Murga Mandi, he came into contact with Ashok and Hazi, who inducted him into the business of arms trafficking. "Hazi was a Meerutbased arms supplier. Thereafter, Sajid started supplying arms to criminals in Delhi," the Special CP

SC issues contempt notice to Yati Narsinghanand for derogatory remarks

he Supreme Court on Friday sought a response of Hindutva leader Yati Narsinghanand in a contempt of court petition filed against him for allegedly making derogatory and baseless rema the top court.

A bench of Justices A.S. Bopanna and M.M. Sundresh issued the notice on the contempt petition filed by activist Shachi Nelli over Narsinghanand's controversial statement that "those who believe in this system, in these politicians, in the Supreme Court, and in the Army will all die the death of a dog.'

In January 2022, the then Attorney General (AG) K.K. Venugopal had granted consent to activist Nelli who had sought to initiate contempt proceedings against Narsinghanand over his remarks against the Supreme Court and constitution.

In his consent letter, AG Venugopal had said that the statement made by Narsinganand was "a direct attempt to lower the authority of the Supreme Court" and "would certainly amount to contempt of the



Supreme Court of India". In an interview given by Narsinghanand last year, he had allegedly said, "We have no trust in the Supreme Court of India and the Constitution. The Constitution will consume the 100 crore Hindus of this country. Those who believe in

this Constitution will be killed.

Those who believe in this system, in

these politicians, in the Supreme Court, and in the Army will all die the death of a dog.'

"This is perhaps the most vicious attack on the Supreme Court in its history. To permit these remarks to pass unaddressed will be to allow this attempt of lowering the authority of the apex court to succeed, if not wholly then in considerable measure," wrote activist Shachi Nelli to the Attorney General while seeking his consent to initiate criminal contempt proceedings against Narsinghanand.

Earlier, Yati Narsinghanand was in the headlines across the country because of his open call for the "genocide of Indian Muslims" in

Five Congress MLAs suspended for entire session from Tripura Assembly

ive MLAs of the opposition parties in Tripura were suspended for the day by the assembly speaker amid an uproar. Their suspension was, however, revoked later in the day.

Session started, the opposition members - belonging to Tipra Motha Party (TMP), CPI-M and the Congress raised slogans, demanding action against BJP MLA Iadab Lal Debnath, who was caught on camera watching an obscene video in the assembly earlier this year.

Leader of the opposition Animesh Debbarma moved an adjournment motion to discuss the row over the BJP MLA- which was rejected by the Speaker, triggering protests.

The members started raising slogans while state Finance Minister Pranajit Singha Roy had just started presenting the annual budg-



uproarious scenes as the MLAs jumped into the well forming a chain, and some even walked on the tables.

Assembly Speaker, Biswa Bandhu Sen, amid the uproar, announced the suspension of five MLAs - Sudip Roy Barman (Congress), Navan Sarrkar (CPI-M) and Brishaketu Debbarma, Nandita Reang and Raniit Debbarma (TMP).

Later all the opposition members staged a walkout protesting the Speaker's

decision and demanding disciplinary action against Debnath.

Earlier, a video allegedly showing Debnath watching an obscene video while the session was on, went viral on social media, drawing sharp criticism.

The 55-year-old leader, who is also the secretary of BIP's Tripura state unit, however, said that when he received a phone call then a site was automatically opened and he immediately

training program on Melioidosis diagnosis was successfully conducted at AIIMS Bhopal on July 7th. The program aimed to raise awareness among clinical doctors and clinical microbiologists in Madhya Pradesh regarding the endemicity of this infection in

The training program was attended by esteemed clinical faculties and microbiologists from major government and private hospitals in Madhya Pradesh, including GMC Bhopal, LNMC Bhopal, MGMC Indore, GRMC Gwalior, and Sri Aurobindo Institute of Medical Sciences Indore. Furthermore, faculties from various institutes across India participated virtually in the program. The Chief Guest at the event was Prof (Dr) Ajai Singh, the Executive Director and CEO of AIIMS Bhopal. He expressed his satisfaction in seeing this neglected disease being recognized in the state. However, he also expressed concern over the



presence of this infection in Madhya Pradesh. Prof Singh emphasized that future research efforts should be directed towards not only diagnosis but also the prevention of this fatal disease. The training program was conducted under the extramural projects funded by the Indian Council of Medical Research (ICMR) and was awarded to Dr. Ayush Gupta, Associate Professor in the Department of

Microbiology at AIIMS Bhopal. Dr. Harpreet Kaur, Scientist F from the Epidemiology and Communicable Disease Division of ICMR, attended the event virtually from New Delhi. Dr Kaur expressed her satisfaction with the efforts of clinicians and microbiologists at AIIMS Bhopal in managing the cases of Melioidosis and raising awareness about this fatal disease. Melioidosis is a multisystemic

infectious disease caused by the bacterium Burkholderia pseudomallei. Traditionally, it has been reported in coastal states such as Karnataka, Tamil Nadu, and Orissa. While previously unknown in Madhya Pradesh, the Department of Microbiology at AIIMS Bhopal has been diagnosing cases of Melioidosis for the past three years. This disease has a high mortality rate, with a majority of cases found in rural areas, particularly among individuals associated with agricultural activities. During the event, a laboratory manual for the diagnosis of Melioidosis was also released, providing clinicians and microbiologists with valuable resources to aid in the identification and management of this infectious disease. The successful completion of the training program marks an important milestone in raising awareness about Melioidosis in Madhya Pradesh. By equipping medical professionals with the necessary knowledge and resources, the program aims to contribute to the prevention and early detection of this potentially fatal infection.

India's private consumption to cross \$2.4 trillion amid increased prosperity

Thile the macro picture has been bleak for the last two quarters, India's private consumption, which dipped to \$2.2 trillion in Q3-Q4 in FY23, is on its way up and expected to cross \$2.4 trillion in the fourth quarter of FY24, a report showed on Friday. Indicators across emerging sectors, such as credit card spends, air travel and sales of vehicles, show signs of recovery in Q1 FY24 (April-June period), according to the report by Redseer Strategy Consultants. The Indian macros are best positioned with a GDP of \$6.5 trillion and a retail goods market size of \$2 trillion, with the private final consumption expenditure (PFCE) at \$4 trillion. According to the report, India's digital ecosystem is already at the gold standard with over 350 million active digital payment users, more than 50 million digital-using merchants and over 50 per cent digital ad share. Other categories expected to accelerate with long-term growth, include education, personal vehicles, personal care, food, and clothing. "Premiumisation, brand proliferation and digitisations being the core consumption

themes across sectors. While the journey so far has been turbulent, India's Internet is poised to be in cruise control momentum until the end of the decade at a 25 per cent CAGR," the findings showed. Although the total number of Internet transactors is 350 million, the mature Internet transactors who are frequent online buyers have plateaued around 40-45 million. Solving key concerns among nonmature online transactors, such as complex ordering processes, lack of trust, and better offline offerings, is also needed to improve the total user base and high-frequency users, the report mentioned.

THE CRICKETING SPIRIT **EVAPORATED MANY MOONS AGO**

he words of Sherlock Holmes, the famous detective come to mind -"Elementary My Dear Watson" when one reviews the Jonny Bairstow stumping incident.

In a tight situation, especially, during a critical Ashes Test match, every cricketer on the ground is looking to get that one extra bit of advantage. The batter tries to stay on the wicket, whereas, the fielding side hopes to get one. The 10 modes of dismissal for a batsman are foremost on the mind of a fielding side.

Aspiring Cricketers right from their elementary days are taught to not fall victim to them. Bairstow, unfortunately, in a world of his own, forgot the basic rule, that the ball is not dead until the umpire says so. Strolling up to meet his non-striker captain at the other end with the ball in play was a folly that even a schoolboy cricketer would have avoided. The reason is, that school and club cricket is where one actually learns the importance of the rules of how one can get out. This is a growing-up process in cricket when one is still unaware of the rules and consequences that may arise by not adhering to them.

Jonny Bairstow knows he made an elementary error and quite rightly has kept quiet for others to debate the issue, rather than for him to get embroiled in it. The famous "Spirit of Cricket" and lack of "fair play" are some words that emerge from such incidents and "gamesmanship" from others, opposing it.

As an international Indian cricketer, I have been through many such incidents wherein opposition players and teams have tried every means in the book to try and get me

Yes, I have fallen victim to it on several occasions, annoyed at making myself vulnerable to the 10 commandments of getting out in cricket. I was once "run out" by a bowler as a non-striker for unintentionally being out of the batting crease. I remember when I was "timed out" for not coming to the wicket in the 2 minutes stipulated and for "hitting the ball twice". The last was in anger in exchange for a verbal retort by the bowler. On all these occasions my team lost and I learned over time to be careful and not careless.



Cricket used to have that aura of being a gentleman's game. One that was played hard but fair. This feeling, unfortunately, when assessed today, dates back to the initial days of Test cricket. Incidents of unfair play then were few and far between.

Douglas Jardine, the famous England captain in the Ashes series of 1932 in Australia, a gentleman by all accounts, was the first one to put a spoke on the spirit of the game.

In trying to stop the Australian runmachine, Sir Don Bradman, and to win the Ashes series utilized the famous "Bodyline

tactics" to demolish Australia. He did not break the rules of cricket then, however, he destroyed the very essence of the game.

In today's parlance, his tactics would have been the case study of success for several of the top business schools around the world. Jardine undertook many hours of research to plan and implement his winning ways and although it proved successful, his fellow gentlemen and members of the MCC disapproved of it quite vehemently.

The irony is that 91 years later at the famous Long

talked and upheld the spirit of the game, booed and made ugly remarks of cheating when the Australian team came back to the pavilion victoriously.

The Long Room for a visiting cricketer playing at Lord's is like walking through history when one is going out to bat or field. There is an aura that engulfs one. It gives one a halo-like experience and evokes thoughts that take one back to the legends who have walked through it, earlier. The Mecca of crick et is how Lord's is identified and quite rightly so, being the centre point of all cricketing matters in the past.

The boisterous and uncanny behaviour of its members has truly tarnished the very ingredients of what it stood for. A behaviour that one disapproved of from the spectators at the cheaper stands has now entrenched itself amongst the so-called elite members as

Personally, as a former cricketer, the onus of playing fair lies in the actions of a cricketer. Winning is important, however, how one achieves it, is even more important. The rules are there for one to follow and sense should prevail when one applies it.

One marvel at Courtney Walsh not running out Saleem Jaffar in a crucial World Cup

Cricket has had umpteen number of such heartwarming and wonderful gestures as well in the years gone by. The famous line that comes to one's mind is, "Playing is not about winning and losing but how you play the

The Australians may feel that they have done nothing wrong in getting Jonny Bairstow out and quite rightly so. However, subconsciously they know it was not in the right spirit to do so.

The spirit of the game of cricket, however, had evaporated many moons ago, and one wonders whether it will ever come back



Xinhua news agency. Locals have confirmed that there is no more missing kids under the rubble.

The rescue teams said that the landslide was triggered by heavy rain lashing the area since Wednesday.

Ukraine claims of making advances against Russian troops in Bakhmut

he Ukrainian military on Friday claimed that troops were making advances against Russian posi-Bakhmut amid fierce fighting.

The battle for the city in the Donetsk region has been the longest and bloodiest since the war began in February 2022. It has little strategic value, but is important symbolically both for Kiev and Moscow.

The capture of Bakhmut would bring Russia slightly closer to its goal of controlling the whole of Donetsk, one of four regions in eastern and southern Ukraine annexed by Russia last September following referendums widely condemned outside Russia as a

Speaking to Ukrainian TV on Friday, military spokesman Serhiy Cherevatyi said: "The defence forces continue to hold the initiative there (Bakhmut), putting pressure on the enemy, conducting assault operations, advancing along the northern and southern flanks."In particular, over the past day,

they (Russian troops) have advanced more than one kilometre.'

On a similar note, a spokesperson for the Ukrainian armed forces general staff said troops had had "partial success" near the village of K just southwest of Bakhmut, the Independent reported.

Friday's development comes just over a month after Deputy Defence Minister Hanna Maliar had confirmed that Ukrainian troops were making advances on the eastern front around Bakhmut, which she described as the "epicentre of hostilities"

In May, the US had said that it believed more than 20,000 Russian soldiers had been killed in the battle for Bakhmut and another 80,000 wound-

Ukraine however, has not released figures on its casualties in Bakhmut, but admitted to sustaining heavy loss-

There were about 70,000 people liv-

ing in Bakhmut before the invasion, but only a few thousand remain in the devastated city, once best known for its salt and gypsum mines and huge winery.

Spiro also accused Meta of SWEDISH PROSECUTION CHARGES GRETA THUNBERG WITH DISOBEYING LAW ENFORCEMENT

he Swedish Prosecution Authority has charged climate activist Greta Thunberg with disobeying law enforcement after she allegedly refused to leave a

protest site last month. "The prosecutor has filed charges against a young woman who, on June 19 this year, participated in a climate demonstration which, according to the prosecution, caused disruption to traffic in Malmo," CNN quoted the Authority as saying in a statement on

Thursday. The woman "refused to obey the police command to leave the scene", it added. While the statement does not identify the climate activist by name, Annika Collin, a spokesperson for the Swedish Prosecution Authority, told CNN that the woman referred to is Thunberg. "The criminal classification is disobedience to law enforcement. According to the prosecutor, the act was committed with intent," the Prosecution Authority's statement added. Six dead in Milan retirement home fire

Milan: Six people were killed and 81 others injured in a fire at a retirement home in Milan on Friday, media reports said.

A fire alarm was raised at the Casa dei Coniugi home for the elderly in the early hours of Friday, reports the BBC. According to Milan Mayor Giuseppe Sala, the blaze was put out quickly but rescuers had to bring everyone out 'almost one by one by the arm".

"Six deaths is a very heavy toll," he told reporters, adding that all evidence pointed to the fire erupting in a room where two women had been living. They were killed by the fire, he said, while the four other deaths were caused by smoke inhalation. "The fumes are as lethal as the fire," the BBC quoted the Mayor as saying. According to Italy's state-run Ansa news agency, five of the six victims were women. All those taken to hospital were suffering from smoke poisoning,

Russian state TV takes aim at Prigozhin

Moscow | Agencies

or the first time since the failed Wagner rebellion last month, the Russian state TV has embarked on an apparent campaign to discredit the mercenary group's chief Yevgeny Prigozhin by showing personal and damaging details.

Before the rebellion on June 24, Russian TV had portrayed a positive image of the Wagner mercenary group, which has fought alongside the Russian military during its invasion of Ukraine, the BBC reported.

But from July 1-5, the country's state-run network Rossiya showed images taken during searches at his opulent home outside St Petersburg, arguing that his riches reflected very badly on him.

"Let's have a look how this fighter for the truth lived, someone who has two criminal convictions and who kept claiming that everyone else was a thief," the BBC quoted a commentator



on '60 Minutes', a Rossiya talk show, as saying.

"Let's have a look at the palace built for this campaigner against corruption and crime," the commentator added.

The footage showed piles of cash, various weapons, the house's opulent interiors and vast gardens complete with a parked helicopter, an assortment of wigs and apparently fake passports issued to the Wagner chief in different names.

Later, similar footage was shown as part of Rossiya's main evening news bulletin, which featured ingots of gold and "suspicious packets of white pow-

It also dwelt at length on Prigozhin's criminal past.

He received his first criminal conviction in 1979, aged just 18, and got a suspended two-anda-half year sentence for theft.

Two years later, he was sentenced to 13 years in jail for robbery and theft, nine of which he served behind bars, the BBC reported.

"They say that it is the experience and connections he received from crime lords behind bars which helped him walk the path from a hot dog seller to an authoritative master of cauldrons and pans," Rossiya 1's correspondent said referring to Prigozhin's past role as a caterer for the Kremlin.


ANDHERI SUBWAY CLOSED FOR TRAFFIC DUE TO WATERLOGGING

NEED TO KNOW BOUNDARIES OF 3 WORDS: HIGH COURT ON IT RULES AGAINST FAKE NEWS

he Bombay High Court on Friday said before it considers the effects of amended Information Technology (IT) Rules on the fundamental rights of citizens, it needs to know the boundaries and limits of three words - 'fake, false, and misleading'. It asked if opinions and editorial content on any

policy of the government can also be held as misleading, and sought to know if it was permissible in law for a statute to have unbound and limitless discretionary authority. A division bench of Justices Gautam Patel and Neela Gokhale said this while hearing a bunch of


petitions challenging the IT Rules that empower

the Centre to identify fake, false, and misleading

information posted on social media against the government and its business Stand-up comedian Kunal Kamra, the Editors Guild of India, and the Association of Indian Magazines filed petitions in the high court against the rules, terming them as arbitrary, and unconstitutional, saying that they would have a "chilling

effect" on the fundamental rights of citizens. "What are the limits and boundaries of these three words - fake, false, and misleading? Before we get into the effect of the Rules on fundamental rights of citizens, as claimed by the petitioners, we need to know this. If these words were capable of limits and bounds, then we need not go into the effect," the court said.

The bench also sought to know what is construed as government business and what is not.



The court said the Rules say action would be taken when some content/information is fake, false, and misleading and some authority, in this case the Fact Checking Unit (FCU), is assuming the power to unequivocally say that the content is

"Having an FCU is fine, but what we are concerned about is with the authority conferred on this FCU. What we find extremely and seriously problematic is these words - fake, false, and misleading," Justice Patel said.

The court questioned if this would also include opinions and editorial content.

"I do not know or cannot make out what the boundaries of these words are. Is it permissible in law for a statute to have unbound and limitless discretionary authority like this? What are the limits and boundaries of these words," Justice Patel

The bench noted that as per the Rules, the FCU would be determining whether a statement or content posted is true or not.

"I have a problem with this. How can someone say with finality that this is false. What is the source of this power? At most, the FCU can say whether the information is credible or not. Even a civil court cannot authoritatively pronounce what is true. At the most, it can make the comment on probability," Justice Patel said.

The bench questioned if the opinion of a person and editorial content fall in the Rules.

"For example, criticism of government figures about the country's economy. The figures may come from government sources, but the analysis of the same would be different. Does that make this false, fake, and misleading information?" the court asked.

"One may find an editorial hard-hitting, but does that make it false, fake, or misleading," Justice Patel said.The bench said it would continue hearing the matter on July 13.

The Union government had earlier assured the court that it would not notify the FCU till July 10. The bench on Friday said this statement shall

stand extended till July 14. On April 6 this year, the Union government promulgated certain amendments to the Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules, 2021,

including a provision for a fact-checking unit to flag fake, false, or misleading online content related to the government. The three petitions sought the court to declare

the amended Rules unconstitutional and direct the government to restrain from acting against any individual under the Rules.
