SC constitutes committee of 3 women ex-judges, appoints ex-IPS to monitor Manipur probe

TO BUILD A SENSE OF TRUST

The Supreme Court on Monday said that it will constitute a three-judge committee headed by Justice Gita Mittal, former Chief Justice of the Jammu and Kashmir High Court to look into "humanitarian" issues like relief, rehabilitation, remedial, etc., in the violence-hit Manipur.

bench comprising Chief Justice of India D. Y. Chandrachud and Justices J. B. Pardiwala and Manoj Misra said that the effort of setting up such a committee is to restore a sense of rule of law in the northeastern state.

Justice Shalini Joshi, retired judge of Bombay High Court and Justice Asha Menon, former judge of the Delhi High Court will also form a part of the three-women judge committee.

The top court said that it is not constituting any SIT in the matter but will appoint former IPS Dattatray Padsalgikar to monitor the investigation, who will report back to it.

In relation to the FIRs, which were transferred to the CBI by the state government, the top court said that five officials not below the rank of deputy SP will be brought on deputation to the central agency for overseeing the investigation into gender violence cases. It clarified that these officers, who are nominated by the Director General of Police from diverse states, will be bound to function within the administrative set up

In relation to other FIRs registered in Manipur, 42 SITs will be formed by the state government at district levels to be headed by officials not below the rank of SP. The Supreme Court said that these SITs will be supervised by seven DIG rank officials hailing from other states. "Each officer (DIG) will monitor six SITs to see that the investigation is going correctly," said the Supreme Court.



It said that each of these 42 SITs will have at least one investigating officer, not below the rank of Inspector, from another state.

During the hearing, Attorney General R. Venkataramani submitted before the top court that the state government is handling the issue at a very mature level.

He said that the Manipur government will form the SITs at district levels, which will be monitored by DIG, IG and additional DG rank officials on a weekly basis. In addition, the Director General of Police will himself monitor the investigations fortnightly, he said.

MEITEI WOMEN STAGE PROTEST AGAINST ASSAM RIFLES

Imphal: The Meira Paibi, an organisation of Meitei women, on Monday staged protests against Assam Rifles in five districts of the Manipur Valley, alleging that the para-military force had "unleashed atrocities" on the Meitei people. Hundreds of women carrying placards and banners held demonstrations throughout the day, demanding withdrawal of the Assam Rifles from the five valley districts -- Imphal East, Imphal West, Thoubal, Bishnupur, and Kakching. A Meira Paibi leader said that they organised these protest demonstrations as the Assam Rifles is "continuously brutally torturing and harassing the innocent people, including elderly men and

MEITEI BODY URGE PM NOT TO DIVIDE MANIPUR AS DEMANDED BY TRIBALS

New Delhi/Imphal: A day before the tribal leaders' meeting with Union Home Minister Amit Shah in New Delhi to press for their demand for creation of a separate state for tribals, the Coordinating Committee on Manipur Integrity (COCOMI), apex body of the Meitei community, on Monday urged Prime Minister Narendra Modi not to divide Manipur and to introduce the National Register of Citizens (NRC).The COCOMI submitted its memorandum to the Prime Minister's Office highlighting the resolutions adopted in the mass rally held on July 29 in Imphal.

The other demands of the COCOMI include an end to the present ethnic conflict, and eliminating foreign (illegal immigrants) and Chin-Kuki "narco-terrorism".

After submitting the memorandum in the PMO, COCOMI coordinator Jeetendra Ningomba, in a video message, claimed that the foreign elements, including some of the leaders of the Kuki-Zomi outfits with which Suspension of Operation pacts were signed, are directly involved in the Manipur conflict and they should either be eliminated or pushed out of the territory of India.

Punjab and Haryana High Court stays demolition in Nuh

Chandigarh | Agencies

he Punjab and Haryana High Court on Monday restrained the Haryana government from the ongoing demolition drive in Nuh district that witnessed communal violence last week.

The violence had led to the death of six people.

The high court headed by Justice G.S. Sandhawalia took suo moto cognizance of the matter and asked the state government to not carry out any further demolition exercise until further orders.

The restraining order is yet to be released and the matter will be taken up post-lunch on Monday.

In the past five days, the local administration demolished over 750 buildings, including houses, shops and other structures.

Officials claimed that the demolished structures were built on government land



and were used by the suspects during the communal clashes

Advocate Mohammad Arshad, appearing for the victims in the matter, alleged that the demolition drive has been ongoing in Nuh since August 3 without any prior notice to the occupants.

Mazar set on fire in Gurugram

Gurugram: Unidentified individuals set fire to a mazar in Gurugram's Khandsa village early on Monday, police said. A complaint was lodged by the mazaar's caretaker Ghasite Ram. This incident occurred while Section 144 was in effect in Gurugram, a measure put in place due to communal clashes originating from the Nuh district and spreading to various parts of the city and nearby regions in the previous week. On Monday, the district administration decided to lift the Section 144 restrictions."An FIR has been filed against unknown individuals under sections 34, 153A, 188, and 436 of the IPC in relation to the mazar arson case," said a senior police official.

everal journalists in India allegedly received funds from China, Enforcement Directorate (ED) sources said on Monday.

This revelation came to light during an investigation into a PMLA case related to Newsclick studio. However, as of now, the ED has not made any official statement regarding the matter.

As per the sources, an investigation was conducted under the PMLA into PPK Newsclick Studio for an alleged fraudulent infusion of foreign funds amounting to Rs 38.05 crore over a span of three

The funds received were allegedly distributed to

several journalists. During the probe, ED sources said that the agency uncovered that Neville Roy Singham provided around Rs 38 crore to News Click between

Singham, an American citizen originally from Sri



Lanka, is claimed by the ED to be associated with the Communist Party of China.

In February of this year, the ED conducted raids at the Gurugram office of News Click and seized

The ED's case is based on an FIR lodged by the Economic Offence Wing (EOW) of Delhi Police in

The name of activist Gautam Navlakha emerged during the course of the investigation, leading the agency to question him as well. ED's investigation revealed that Prabir Purkayastha allegedly paid Rs 20 lakh to Navlakha. It was also discovered that Navlakha and Purkayastha established a firm in

association with an American arms supplier. The ED found that a few American-based firms -Justice and Education Fund Inc, GSPAN LLC, and Tricontinental Ltd Inc -- provided funds to News Click. All three firms are registered at the same address in the US.Additionally, a Brazil-based firm, Centro Popular Demidas, also sent money to Newsclick.

Newsclick has called the ED probe a "fictitious

DRUNKARD STRIPS WOMAN ON ROAD IN HYDERABAD

Hyderabad: In a shocking incident, an inebriated man stripped a woman passing on the road at Balaji Nagar on the outskirts of Hyderabad, police said on Monday

The accused, identified as Peddamaraiah, not only misbehaved with the woman but also stripped her publicly in the incident that took place around 8.30 p.m. on Sunday near Balaji Nagar bus stand under the limits of Jawahar Nagar Police Station of Rachakonda Police Commissionerate. Peddamaraiah, a labourer and habitual drunkard, was accompanied by his mother and shockingly, she did nothing to stop him. Some passers by filmed the incident on their mobile phones instead of intervening to save the woman. He misbehaved with the woman by touching her inappropriately while she was walking on the road. As the woman tried to save herself by pushing him and briskly walking away, an enraged Peddamaraiah pounced on her and started tearing off her clothes. His mother did nothing to save the woman. As another woman, riding a bike, stopped to question him, the accused also tried to attack her. The victim stood disrobed on the road for about 15 minutes. After the accused left the place, some people came forward to cover her and informed the police. On a complaint by the victim, aged 28, police registered a case and

arrested the accused.

DIAL installs 12 multi-product feminine hygiene vending machines at IGI

7ith an aim to enhance women's hygiene accessibility at Indira Gandhi International (IGI) airport, the Delhi International Airport Limited (DIAL) on Monday said that 12 multi-product feminine hygiene vending machines have been strategically installed right outside all women's restrooms at Terminal 2.

"These state-of-the-art vending machines offer an array of essential prodacts for women, catering to their diverse hygiene needs. In the future, this initiative will be extended to Terminal 3 and Terminal 1 as well, ensuring that women travellers across the airport have easy access to these essential products," said

DIAL in a statement issued on Monday. "The newly installed vending machines are revolutionary in their design, offering a wide range of sanitary products, including menstrual cups, tampons, sanitary pads, toilet seat covers, intimate wipes, and panty liners," said a DIAL official.

Price of tomatoes, chilli heated up veg and non-veg thalis by 34%, 13% in July

According to the report, in July, the cost of cooking a vegetarian thali at home stood at Rs 33.7 (June rate Rs 26.3) whereas the cost of non-vegetarian home meal was at Rs 66.8 (June rate Rs 60).

According to CRISIL, a vegetarian thali comprises roti, vegetables (onion, tomato, and potato), rice, dal, curd, and salad. For a non-vegetarian thali, chicken has been considered instead of dal. Broiler prices for July 2023 are estimated.

CRISIL said out of the 34 per cent rise in the cost of vegetarian meals, 25 per cent can be attributed to the 233 per cent hike in tomato price last month. In June, the tomato price was Rs 33/kg and shot up to Rs 110/kg in July.

he cost of preparing a vegetarian thali at home has gone up by 34 per cent while that of a non-vegetarian thali went up by 13 per cent in July as compared to the input prices that prevailed in June 2023, CRISIL said in a report.

Tomatoes aside, the other ingredients that heated up the cost side last month as compared to June were the prices of onion that went up by 16 per cent, potato by 9 per cent, chilli 69 per cent, and cumin by 16 per cent.

However, given the lower quantities of these ingredients used in a thali, their cost contribution remains lower than some of the vegetable crops, CRISIL said.

On the other hand, the cost of a non-vegetarian thali rose at a slower pace as the price of broilers,



comprising more than 50 per cent of the cost, likely declined 3-5 per cent on-month in July, the report notes. ""A 2 per cent on-month decline in the price of vegetable oil provided some respite from the increase in cost of both thalis," the report said.

DELHI HC SEEKS CENTRE'S STAND ON PIL AGAINST 'ILLEGALLY' CONSTRUCTED RELIGIOUS STRUCTURES

elhi High Court on Monday sought Centre and Arvind Kejriwal-led government's response on a plea by five seeking direction for removal of illegal and unauthorisedly constructed religious structures from public spaces here.

A division bench of Chief Justice Satish Chandra Sharma and Justice Saurabh Banerjee issued notice and sought a stand of the Central government through the Ministry of Home Affairs, Delhi government, Delhi Police, Public Works Department and the Municipal Corporation of Delhi in the Public Interest Litigation (PIL).

The PIL by five petitioners - Preet Singh, Sunil Antil, Neeraj Chauhan, Rajesh and Ashok Kumar Mittal - says that illegally constructed mosques, mazar and dargah may give rise to communal disharmony.

".... such illegal activities are rapidly increasing with intention to capture more and more land illegally and unauthorisedly in the name of pseudo religion due to which the national



integrity and national interest is being jeopardised," the plea states.

It says that the mosques, mazar and dargah in question, illegally constructed on public land, are in violation of the directions of the Supreme Court, and the situation is so alarming that such activities might give rise to "communal disharmony and is affecting public as well as law and

order, but the respondents are negligent in performing their constitutional responsibilities and duties as no action is being taken against such illegal construction for political reasons thereby giving a jolt to the secular fabric of the Constitution."

The PIL says that such illegal constructions lead to road accidents. "The Mazars at public roads are

creating day to day trouble for the pedestrians. The persons holding the charge of mazars spread 'Chadar' and coerce the public to pay donations and in this way a huge amount is collected by adopting all nefarious acts. The matter becomes worse on Thursdays when the organisers collect huge amount of money creating superstitions in the mind of public. On Thursday evening even some times road is blocked by the organisers. Quwwalis are organised and traffic is obstructed. The unsocial elements take advantage of the situation and a number of mishappenings including outraging the modesty of women occur," the plea says.

The plea sought for the court to issue an appropriate writ.

"...directing the Respondents to ensure that no religious or any type of constructions in the shape of Mosque, Mazaar, Dargah, Graves or any other religious constructions whatsoever name it may be called, are constructed at public land, parks, playgrounds, roads, highways or any other place of public utility," it says.

Tationalist Congress Party (NCP) State President Jayant Patil on Monday denied that he had any meeting with Union Home Minister Amit Shah in Pune on Sunday and Maharashtra Deputy Chief Minister Ajit Pawar has confirmed the same.

Ajit Pawar, who heads the breakaway NCP faction, said that Patil was in Mumbai with NCP President Sharad Pawar and not in Pune as speculated.

Patil himself dismissed the reports that he had met Shah and was now on way to joining the Bharatiya Janata Party (BJP).When asked, Shiv Sena (UBT) MP and Chief Spokesperson Sanjay Raut scoffed at the reports and said that Patil is a true NCP

loyalist and would not make any such moves, as claimed. BJP's Deputy CM

Devendra Fadnavis also joined in and asserted that there was no Shah-Patil meeting as claimed and termed it as 'rumour-mongering' by some persons.

Delhi court on Monday posted for August 21 Union Jal Shakti Minister Gajendra Singh Shekhawat's defamation complaint filed against Rajasthan Chief Minister Ashok Gehlot for 'misleading statements' against him in connection with the Sanjivani Credit Cooperative Society scam.

Before the court of Additional Chief Metropolitan Magistrate (ACMM) Harjeet Singh Jaspal of Rouse Avenue Court, Gehlot appeared virtually for the hearing since sessions/revision court's Special Judge M K Nagpal had, on August 1, said that his physical and personal appearance before the magistrate on August 7 may not be practically convenient and necessary.

"It is pertinent to mention here that vide order dated August 1, 2023, Revision Court (Ld. ASJ Special Judge, CBI-09) has directed this court to allow the accused to



appear through VC and has further directed that this court shall not insist

on the accused furnishing bail bonds

today," ACMM Jaspal noted.

Accordingly, he directed the accused to furnish bail bonds on the next date of hearing and appear in person for the said purpose, unless otherwise directed by the revision court. The magistrate then posted the matter for hearing on August 21 for scrutiny of documents in the case.

'...let the matter be taken up before this court on 21.08.2023. Be kept for scrutiny of documents/further proceedings," the judge said.

When Gehlot had moved to sessions court against the magistrate's order, which had, on July 6, issued summons to him in the case, and had ordered him to appear on August 7, Judge Nagpal had refused to stay the proceedings.

The judge saw no ground for staying the proceedings.

The judge had directed the ACMM not to insist on the physical presence of Gehlot on August 7, and permitted him to join the proceedings through Video Conferencing (VC)

HEAVY SHOWERS AHEAD FOR NORTH, NORTHEAST INDIA: IMD

he India Meteorological Department (IMD) on Monday heavy rainfall in Uttarakhand, north Uttar Pradesh, Bihar, Sikkim and over Northeast India during next three days.

Subdued rainfall activity is expected over the remaining parts of the country during next one week.

In a bulletin released by the weather forecast agency, it said that in Northwest India, there will be light to moderate scattered rainfall with some fairly widespread activity, including isolated instances of heavy rainfall over Uttarakhand from till Thursday.

"Uttar Pradesh will experience similar conditions from Monday to Wednesday, while Himachal Pradesh is expected to see this on Monday. East Uttar Pradesh could encounter isolated heavy rainfall from Monday to Wednesday, and Uttarakhand along with West Uttar Pradesh on Wednesday. The rest of the region is anticipated to have subdued rainfall for the next week," said the IMD. Moving to East India, there will be



light to moderate fairly widespread to widespread rainfall, with isolated episodes of heavy rainfall. "West Bengal and Sikkim are likely to experience this on Monday and Tuesday, while Bihar and Jharkhand will have these conditions from Monday to Wednesday," the IMD predicted.

"Gangetic West Bengal could see isolated very heavy rainfall Monday, and Bihar on Monday and Tuesday," the weather agency said.



he Economic Offence Wing (EOW) of Odisha police has unearthed a pan-India crypto currency-based Ponzi scam involving money of more than Rs 1000 crore, a police official said on Monday.

The EOW has arrested the head of STA Crypto Token namely Gurtej Sigh Sidhu (40), from Sri-Ganganagar, Rajasthan and its Odisha unit head Nirod Das. Sidhu is a native of Faridkot, Punjab and Nirod belongs to Bhadrak district of Odisha.

Sidhu was frequently changing his location in places like Goa, Lonavala, Mumbai, Delhi, Faridkot, Bhatinda, Hanumangadh and Sri Ganganagar. A team of EOW led by DSP Sasmita Sahoo was tracking his movement and finally able to arrest him, said an EOW official.

Acting on an intelligence input that a crypto currency-based Ponzi scam is being run in Odisha especially in Bhadrak, Balasore, Bhubaneswar, Mayurbhanj, Jajpur, Kendrapada and Keonjhar districts, the EOW has conducted an enquiry.

During the investigation, the EOW found that STA through some upline members are very active in these dis-

tricts and they have been using various propaganda tools to persuade people to join in this scheme and earn huge money in a very short time.

The members have started using the STA Token like a legal tender in their day to day business. It is estimated that more than 10,000 people from Odisha have already been mem-

Though STA is not authorized by RBI or any other authorities to collect deposits, it runs a huge Ponzi (Pyramid) scheme in the garb of crypto tokens. The firm uses the socially popular terms like green energy, solar technology etc. to mask its crypto-Ponzi scam.

The STA website is hosted from Iceland but its business and activity is limited to India only and it is headed by one David Gez, a young Hungarian (Europe) national who has visited India multiple times.

According to the EOW, both David and Gurtej Sidhu have travelled to many places in India including Odisha and have attended various STA programs. They are always seen using luxurious lifestyles like star hotels, expensive cars, fancy clothes, surrounded by bouncers, hero's wel-

come in meetings etc. The Ponzi firm conducts several publicity programs at various places to spread its membership. They use fancy hotels, motivational speakers, music, lunch/dinner etc. in such meetings to brainwash future mem-

Led by religious guru SantPancham Das and office bearers of the AhirwarMahapanchayat, the delegation submitted that Karrapur village (which is around 15-18 km from Badtuma village, where the temple will be built) has a 600 year old association with SantShiromani Guru Ravidas.

"Around 600 years back, while SantShiromani Guru Ravidas was travelling from Banaras to Chittorgarh, he had taken a night halt at Kuntalpur (modern day Karrapur village) and addressed the Ravidassia sect people."As Karrapur village has a centuries-old association with Guru Ravidas, his

Man, Daughter Rescued After Car Falls In Waterfall

man jumped into the plunge pool of a waterfall in Indore in Madhya Pradesh after a car fell into it and managed to save one of the occupants, while the other was saved by those in the vicinity who followed suit.

A video of the incident, which took place in Simrol, some 60 kilometres from Indore city, on Sunday, went viral on social media. In the video, the red car can be seen coming towards the edge of a rock surface and falling into the plunge pool after flipping over once, during which its front door opened and then shut again.

A man close to the pool can be seen jumping in and swimming towards the car, from which screams of a young girl could be heard. In the video, others can be seen climbing down from the edge of the rock surface and moving towards the car.

"I saw a car falling into the waterfall. A man and his 13-year-old daughter, who were the two occupants of the car, were trying hard to get off even as the vehicle was sliding. However, the car fell while the duo was inside," Sunil Mathew (26), who works in a private firm, said.

They were drowning. I jumped in and saved the man inside the car. His daughter was saved by those around. I was in shock for some time looking at the incident but then gathered courage to jump in," he said.

Mathew said he is happy that both father and daughter were saved. Meanwhile, Superintendent of Police (Rural) Sunil Mehta said the incident took place due to the negligence of

1.36 Crore People Come Out Of Poverty Due To Maximizing Development Initiatives

s many as 1.36 crore people have come out of the vicious cycle of poverty between 2015-16 and 2019-21 in Madhya Pradesh. The intensity of poverty has come down from 47.25% to 43.70% in the state. Madhya Pradesh has contributed 10% in reducing the burden of poverty in the country.

Madhya Pradesh has registered a decline of 15.94% in the number of poor in a span of five years. The number of poor persons has decreased from 36.57% in 2015-16 to 20.63% in 2019-21. Madhya Pradesh has speedily reduced poverty among all the states. NITI Aayog will present its report on Multidimensional Poverty on August 8 in a program being organized at KushabhauThakre International Convention Center Bhopal. A policy brief will be launched on the journey of lifting 1.36 crore people from poverty. The Chief Minister Shivraj Singh Chouhan will deliver address on the occasion.

Minister for Finance JagdishDevda, Chief Secretary ShriIqbal Singh Bains will be present. NITI Aayog Vice Chairman Suman K Berry and Member Dr V K Saraswat will discuss the achievements and development journey of Madhya Pradesh. Vice Chairman of State Policy and Planning Commission, Prof. Sachin Chaturvedi, Member of Prime Minister's Advisory

Council, Prof. Shamika Ravi, Chairman of MP State Statistics Commission, Shri Praveen Srivastava, UN Resident Coordinator, ShriShombi Sharp will make special comments. Dr.YogeshSuri, Senior Advisor, NITI Aayog will make an opening remark on Multidimensional Poverty Indicators

Alirajpur, Barwani, Khandwa, Balaghat, and Tikamgarh have shown impressive gains in terms of reduction in the number of poor. These facts have been revealed in the second report of NITI Aayog on Multidimensional Poverty Index-2023

WHAT IS MULTIDIMENSIONAL POVERTY? According to globally accepted parameters, the poverty is not measured only in terms of monetary wealth. Deprivation of health, nutrition, clean water, electricity, quality of life, schooling, sanitation, child mortality, maternal mortality, housing, bank account, assets, cooking fuel etc. are also the parameters.

In Madhya Pradesh, 1.36 crore people have been elevated from the poverty line, which is indicative of tremendous improvement in health, nutrition, clean water, electricity, quality of life, school education, sanitation and other parameters. This number is more than twice the total population of countries like Singapore and Libva.

All India National Family Health Survey-4-(2015-16) reported that the number of poor in Alirajpur was 71.31 percent, which has come down to 40.25% in

NHHS-5 (2019-21). Thus there has been an improvement of 31.5 percent. In Barwani, it has come down from 61.60 percent to 33.52 percent. Thus there is an improvement of 28.08%. The poverty percentage in Khandwa has come down from 42.53 to 15.15% showing an improvement of 27.38 percent. There has been an improvement of 26.48 percent in Balaghat, and 26.33 percent in Tikamgarh.

There has been a drastic reduction in poverty in the country. About 135 million people have come out of poverty in five years. The Global Multidimensional Poverty Index-2023, makes it clear that within 15 years, 415 million people have risen above poverty in the country. Obviously the quality of life has improved.

Lack of health facilities, education and quality of life are also taken care of in the Global Multidimensional Poverty Index. It has 12 parameters. It also used data from the All India National Family Health Survey. The data is released by the International Institute of Population Sciences in coordination with the Union Ministry of Health and Family Welfare. The Multidimensional Poverty Index 2023 shows the change in poverty between NFHS 4 (2015-16) and NFHS 5 (2019-21).

The Sustainable Development Goals include reducing the poverty at least half by 2030. The country is moving faster towards achieving this target

ahead of the target. The speedy development works in Madhya Pradesh and control over the situations that cause the poverty are creating possibilities for achieving the goal of eradicating poverty.

REDUCTION IN POVERTY IN RURAL, URBAN

There has been a decline of 20.58% in the population of poor in the rural areas of the State. It was 45.9% in NFHS 4 (2015-16) which has come down to 25.32% in NFHS-5 (2019-21). The intensity of poverty has also declined by 3.75% (47.57% to 43.82%) and the poverty index has almost halved from 0.218 to 0.111. The urban poor population declined by 6.62%. It was 13.72% in NFHS 4 (2015-16) which has come down to 7.1% in NFHS-5 (2019-21). The intensity of urban poverty has been reduced by 2.11% (44.62% to 42.51%

REDUCTION IN POVERTY DUE TO DEVELOP-

MENT IN EVERY SECTOR

The most notable improvement is access to sanitation. There has been a decrease of 19.81% in people deprived of sanitation. There has been a reduction of 16.28% in the number of people without cooking fuel, 15.12% in the number of people without housing, 13.6% in the number of people without nutrition. There has been a reduction of 9.54% in the number of people deprived of maternal health services, 8.84% reduction in drinking water shortage.

Bihar, UP, TN top 3 states with maximum Jan Dhan beneficiaries

Sihar, Uttar Pradesh and Tamil Nadu are the top three states with the highest number of beneficiaries of Pradhan Mantri Jan Dhan Yojana (PMMY) in 2022-23. *During 2022-23, a total of 6.23 crore* Jan Dhan accounts were opened. According to Finance Ministry data, Bihar tops the list of states with maximum beneficiaries of the scheme, which stood at 84,89,231 in 2022-23. *Uttar Pradesh held the second posi*tion with 68,08,721 beneficiaries, while Tamil Nadu stood third with a total of 64,06,513 PMMY beneficiaries. Under PMMY, collateral-free institutional credit of up to Rs 10 lakh is provided by the member lending institutions (MLIs), i.e., scheduled commercial banks (SCBs), non-banking financial companies (NBFCs) and micro finance institutions (MFIs). Any individual, who is otherwise eligible to take a loan and has a business plan for small business enterprise can avail loan under the scheme for income generating activities in the manufacturing, trading and service sectors, and also for activities allied to agriculture across three loan categories, i.e., 'Shishu' (loans up to Rs 50,000), 'Kishore' (loans above Rs 50,000 and up to Rs 5 lakh) and 'Tarun' (loans above Rs 5 lakh and up to Rs 10 lakh).

Community members raise concerns as state govt rolls out 'bulldozer justice'

s Haryana follows demolition of alleged accused persons houses by using oulldozer in similar lines with neighbouring saffron states while dealing with the recent communal riots, in which six people were killed, concern raises in the minority community which question the 'selective' clean up of the government.

Zamil Khan, a resident of Nuh, expressed concern over the recent events where armed Hindu activists shouted provocative slogans during a procession. He pointed out that instead of taking action against these activists, the police seemed to be selectively targeting Muslim properties during the dem-

He questioned the authorities, saying: "The authorities have chosen to demolish homes and shops belonging to Muslims only. Why haven't they taken any action against those responsible for the violence and those who openly brandished weapons during the

Zamil Khan believed that this approach was an attempt to appease Hindutva groups that sought to disrupt the social harmony and communal amity that had existed in the area for many years. His home had been demolished, leaving him with the question of where to go next.

Haroon Khan, whose shanty and juice booth near Nalhar medical college were demolished, expressed his innocence, stating that he had no involvement in the riots or any association with such individuals.

His juice booth was his means of supporting his family, and he was now worried about how to provide



for his family of three after the demolition

A Hindu resident, working as a construction laborer, also acknowledged that both communities' poor people had suffered due to the violence. He decided to leave the area with his wife and three children and return to his village in Orissa for safety and stability.

Nearly 45 illegal commercial shops, comprising pharmacy stores, were razed to the ground near a medical college in Nuh. The authorities bulldozed illegal structures on 2.6 acres of land around SKHM Government Medical College on Nalhar Road, the same place from where a woman judge along with her 3-year-old daughter, who had gone to buy medicines, was caught in the crossfire.

It was around 1 pm on July 31 when Additional Chief Judicial Magistrate (ACJM) Anjali Jain went out to buy some medicines from SKHM Medical College in her car

along with a gunman, her toddler daughter and one more employee who was driving the vehicle.

While they were returning after an hour and reached the Bus Stand on the Delhi-Alwar road, they saw a mob of 100-150 people that had already gathered there.

"Within no time, the mob started pelting stones at our car and torched other vehicles. After some time, the rear glass of our vehicle was shattered by a stone and then the mob began firing at our car," an FIR that was lodged on the complaint of the Process Server Tek Chand (a Court employee),

accessed by Correspondent, read. To save their lives, all occupants of the car, including ACJM Anjali Jain and her daughter, stepped out of their vehicle and hid themselves in the workshop of the old bus stand.

TRUMP CALLS FOR RECUSAL OF JUDGE **IN 2020 US ELECTION FRAUD CASE**

ormer HS President Donald Trump has called for recusal of the judge in the 2020 election fraud case. Trump took to his social media platform, Truth Social, on Sunday morning to express his displeasure with a federal indictment for attempting to overturn the 2020 election. He described the case as "the ridiculous freedom of speech, slash fair elections case" and said that his legal team would immediately be asking for recusal of the judge

Trump has said that he will ask the judge to step aside on what he called very powerful grounds", the BBC

He gave no details of his grounds for asking her to step down.

The former President has said there is "no way" he can get a fair trial with the judge assigned to his case.

Federal judge Tanya Chutkan, who is overseeing the Trump case, was Barack Obama.

Judge Chutkan previously ruled against Trump's efforts to shield evidence from the House January 6 Committee and has faced frequent attacks from Trump allies in recent days. Trump had described her and the Department of Justice (DOJ) as "highly partisan and very corrupt", the BBC reported.

She is the only federal judge in Washington who has delivered sentences against defendants in cases related to the 6 January Capitol riot that are longer than the sentences that the DOJ asked for, according to NBC News.

According to DOJ, any judge of the US shall disqualify themselves in any proceeding in which their impartiality might reasonably be questioned.

UKRAINE DETAINS INFORMANT FOR PLOTTING AIRSTRIKE **DURING ZELENSKY'S VISIT**

Kiev: The Ukrainian Security Service (SBU) on Monday announced that it has detained a female information for Russia "who was prepar ing an airstrike in the Mykolaiv region during the visit of President Volodymyr Zelensky".

In the statement, the SBU said the allege informant "on the eve of the recent trip of the President of Ukraine to Mykolaiv region, was gathering intelligence about the planned visit" late last month, reports CNN.

The Security Service further said that the alleged conspirator "tried to establish the time and list of locations of the approximate route of the Head of State in the territory of the region".

However, SBU agents had obtained information about the "subversive activities of the suspect" and adopted additional security measures. In monitoring the communications of the woman, the SBU had established that she also had the task of identifying the location of electronic warfare systems and warehouses with ammunition of the armed forces. According to the investigation, the perpetrator was a resident of Ochakov, southern Ukraine, and a former saleswoman in a military store on the territory of one of the military units of the region.

In a decision published by the country's top court on Sunday, the justices instructed the state to respond to arguments and explain why the new law should not come into effect until after the next elections, to avoid it from being perceived as a tailor-made law designed to benefit Netanyahu, Xinhua news agency reported.

The court also set an expanded panel of 11 justices to hold the follow-up hearing scheduled for September 28, after the court held a first hearing on Thursday.

Netanyahu's far-right coalition passed the law in March, changing the conditions under which a prime minister in Israel could be declared

Following a crisis meeting on August 4, military chiefs of the Ecowas regional trading bloc which comprises 15 West African countries, including Nigeria, Senegal, Togo and Ghana, announced that they had drawn up a detailed plan for the possible use of force if Bazoum was not reinstated by 11 p.m. on August

"All the elements that will go into any eventual intervention have been worked out here, including the resources needed, the how and when we are going deploy the force," the BBC quoted Abdel-Fatau Musah, Ecowas commissioner for political affairs, peace and security, as saying in a statement.

"We want diplomacy to work, and we want this message clearly transmitted to them (Niger's junta) that we are giving



them every opportunity to reverse what they have done"

But as of early Monday morning, Niger's coup leaders have showed no no sign of willingness to cede power.

On Sunday thousands of their supporters rallied defiantly at a stadium in the country's capital Niamey.


Bazoum was detained on July 26, and Gen Abdourahmane Tchiani, commander of the presidential guard, later proclaimed himself the new leader. In response to the bloc's warning, a

junta spokesman said that Niger's armed forces were ready to defend the country.

excited crowd, it seemed to be in an aggressive mood, so I had to calm it down... After the people retreated some distance away, it relaxed and then opened its hood in a 'striking' position to convey that he is the 'Boss' there," smiled Kamble.

The entire operation lasted a nailbiting 15-20 minutes with the Thackeray household and others gawking as Kamble tricked the cobra into his bag.

Then he informed the Thane Forest Division's Round Officer (Borivali-Bandra) Roshan Shinde and as per the rules, the cobra was released back into its natural habitat.

A relieved and grinning 'Tiger' Thackeray personally came out to thank and appreciate Kamble for his efforts. Kamble said that many snakes have been displaced by the ongoing



Edelweiss Financial Services Ltd (EFSL) has attempted to 'connect' a NCLAT verdict with the suicide of ace art director Nitin Desai -- both 24 hours apart.

In a filing to the BSE on Sunday, the EFSL confirmed that it had extended loans of Rs 150 crore (2016) and Rs 35 crore (2018), as stated in the Raigad Police FIR (August 4) to Desai's ND Art World Pvt. Ltd (NDAWPL), "at prevailing markets

However, NDAWPL encountered financial difficulties in 2019 and went into default, and attempts to improve its financial condition failed to bear fruit.

The loans were taken over by CFM Asset Reconstruction Co. Pvt. Ltd which also initiated

legal proceedings. The Edelweiss ARC acquired a portfolio of assets from CFM under an auction process which included NDAWPL, and continued with the legal actions ini-

Eventually, the NDAWPL was admitted under IBC by the National Company Law Tribunal (NCLT) on July 25.

"Nitin Desai's appeal against the NCLT order was dismissed by the Honourable Appellate Tribunal (NCLAT) on August 01, 2023, and he took his life the following morning," the EFSL said in the filing.

The Edelweiss has not referred to the series of allegations levelled in the Raigad Police FIR, based on a complaint by Desai's widow, Neha on August 4.

Denying any wrongdoings, the Edelweiss Group has reiterated that it is "deeply saddened" by Desai's tragic demise, and it is "a big loss to the Indian film industry", assuring it "will cooperate fully" with the authorities" in the case, and that "pursuing recoveries on NPA accounts is not just a right of creditor but also an obligation".

The FIR has named Edelweiss ARC Managing Director and CEO R. K. Bansal, C-MD Rashesh Shah, Smit Shah, Keyur Mehta (both of a subsidiary) and Jitendra Kothari (Interim Resolution Professional). Incidentally, the FIR mentions that after the insolvency resolution proceedings were initiated, the studio officials and Desai's lawyer Vrunda Vichare had informed Neha Desai that NCLT's Kothari would reach the studio with bouncers to take control of the property on July 29 -- four days after the NCLT ruling and three days before the NCLAT verdict, both against Nitin Desai.


The FIR cites a recording left behind by Desai for Vichare, where he had narrated how 2-3 investors were ready to invest in the studio, but the Edelweiss and its honchos demanded 'double-triple the dues' and pressurised him in different ways.

'Smit Shah, Keyur and Bansal have looted my studio for their selfish motives... they didn't accept my proposals... they tried to trap me," said a desperate sounding Nitin Desai in the recordings quoted in the FIR.

"Ya lokaani majhi vaat lavli aahe(These people have destroyed me)," were Desai's words, adding that "these monsters threatened, pressured" him, forced him to sell off his prime office in Powai's Hiranandani Complex, and conspired to finish him off, as per the FIR.

Athletics: World body ratifies world records for Kipyegon, Girma and Perez

Lausanne (Switzerland) Agencies

orld Athletics, the governing body for track and field on Monday ratified World Records set this season by Kenyan Faith Kipyegon in women's 1500m and 5000m and Ethiopian Lamecha Girma in men's 3000m steeplechase.

Also ratified was the World Record in the non-Olympic Games event, the women's 35km race walk, by Maria Perez of Spain. Kenya's Kipyegon has achieved three world records since June and two of those marks - in the women's 1500m and 5000m have now been officially included in the record books. Her women's mile record set in Monaco on July 21 is pending ratification

The first of Kipyegon's world records was set at the Golden Gala, a Wanda Diamond League meeting, in Florence on June 2. On that occasion, the two-time world and Olympic champion ran 3:49.11 to break the women's world 1500m record of 3:50.07 that had been set by



Ethiopia's Genzebe Dibaba in Monaco on 17 July 2015, the World Athletics informed in a release on Monday.

Though her original plan was not about the 5000m, and she was rather aiming for the 1500m record again, Kipyegon went for the world record of 14:06.62 set by Ethiopia's Letesenbet Ĝidey in Valencia on October 7, 2020. Kipyegon broke it, running 14:05.20 in just her thirdever race at the distance. Speeding up with every stride, she hit the bell in 13:04.1 and covered the final lap in 61.1 seconds for a 1.42second improvement on Gidev's mark. Perez achieved her world record in Podebrady on May 21, clocking 2:37:15 to improve the women's 35km race walk mark by 29 seconds.

Test Indies' wicketkeeper-batter Nicholas Pooran has been fined 15 per cent of his match fee for breaching Level 1 of the ICC Code of Conduct during the second T20I against India in Guyana, the International Cricket Council (ICC) informed on Monday.

Pooran was fined for criticising the umpires for not reviewing an incident on their own, for which he had to use a player review and survived. He went on to help West Indies win the second T20I at the Providence Stadium in Guyana on Sunday and take a 2-0 lead in the 5-match series.

Pooran was pulled up for breaching Article 2.7 of the ICC Code of Conduct for Players and Player Support Personnel, which relates to public criticism in relation to an incident occurring in an international match.

Pooran admitted to the offence and accepted the sanction of a reprimand that was proposed by match referee, Richie Richardson of West Indies, and as such there was no need for a formal hearing. In addition to this, one demerit point has been

added to Pooran's disciplinary record, for whom it was the first offence in a 24-month period. The incident occurred following the review of an






