The Finance Ministry on Monday said that the Central government's expenditure on social services has registered a Compound Annual Growth Rate (CAGR) of 5.9 per cent between the fiscal years 2014 and 2023. The capital expenditure on social services has seen an even more robust growth, with an 8.1 per cent CAGR over the same period, indicating the creation of societal assets. Notably, programmes aimed at ensuring universal access to basic amenities, including Ujjwala Yojana, PM-Jan Aarogya Yojana, PM-Jal Jeevan Mission, and PM-AWAS Yojana, have gained prominence.

n the next three years, India is expected to become the thirdlargest economy in the world, with a GDP of \$5 trillion, the Finance Ministry said in a review of the Indian economy just days before the Interim Budget (Feb 1).

This is not the Economic Survey of India prepared by the Department of Economic Affairs. That will come before the full Budget after the general elections, the ministry said.

Ten years ago, India was the 10th largest economy in the world, with a GDP of \$1.9 trillion at current market prices. Today, it is the fifth largest with a GDP of \$3.7 trillion (est. FY24), despite the pandemic and despite inheriting an economy with macro imbalances and a broken financial sector, the review said.

This 10-year journey is marked by several reforms, both substantive and incremental, which have significantly contributed to the country's economic progress. These reforms have also delivered an economic resilience that the

# **DECLINE IN YOUTH** UNEMPLOYMENT

New Delhi: The Finance Ministry in a review of the Indian economy just days before the Union Budget said at the state level, the decline in the youth unemployment rate has been led by the states with a larger share of the young population, such as Uttar Pradesh (with 6.9 crore youth as per MoHFW's population estimates for 2021), Bihar (with 3.5 crore youth), and Madhya Pradesh (with 2.3 crore

According to the PLFS, youth (age 15-29 years) unemployment rate has declined from 17.8 per cent in 2017-18 to 10 per cent in 2022-23, while youth LFPR has expanded from 38.2 per cent to 44.5 per cent over the same period. For the proportion of employed youth to rise from 31 per cent to 40.1 per cent in these six years is a feat for a populous country on the upside of a demographic transition, the review said.

#### MIDDLE CLASS PROPELLED E-COMMERCE **MARKET: ECONOMY REVIEW**

**New Delhi:** The Indian Economy Review prepared by the Ministry of Finance ahead of the Interim Budget (Feb 1) said that the proliferation of internet connectivity and smartphones in India, coupled with rapid urbanisation and the rising influence of India's middle class, have propelled the e-commerce market. During the Covid pandemic, the Aarogya Setu and CoWin apps helped track and contain the spread of the virus and facilitate the vaccination of many people in a short period of time. Using these digital infrastructure, India was able to provide support to many households quickly. In the first months of the pandemic, about 87 per cent of poor households received at least one benefit. The Indian Economy Review said the PM eVIDYA was another initiative launched with the use of digital technology to bridge learning gaps during the pandemic. The digital world has also built sever merce platforms for merchandise, food, and transport services that proved critical during the lockdowns. As per a report by UNICOMMERCE on 'India E-Commerce Index 2023136', the overall order volume witnessed a growth of 26.2 per cent in FY23, indicating a flourishing e-commerce landscape in India, supported by a 23.5 per cent rise in annual Gross Merchandise Value (GMV) as compared to FY22.India's e-commerce market is expected to reach \$163 billion by 2026, with online sales accounting for over 25 per cent of the sales across major non-grocery

### Women employee can now nominate children for family pension

he government on Monday amended rules granting the women employee the right to nominate their son(s) or daughter(s) for family pension instead of her husband.

Minister of State (Independent Charge) Jitendra Singh said that the Department of Pensions and Pensioners' Welfare (DoP&PW) has introduced an amendment to the CCS (Pension) Rules, 2021 which will now allow a female government employees or pensioners to grant family pension to their eligible child/children after their own demise, instead of their spouse.He said that the amendment will address situations where marital discord leads to divorce proceedings or cases filed under acts such as the Protection of Women from Domestic Violence Act, Dowry Prohibition Act or the Indian Penal Code.He said that previously, the family pension was granted to the spouse of a deceased government servant or pensioner, while other family members became eligible only after the

spouse's ineligibility or disbursed accordingly," the demise. DoP&PW said. "The new amendment

It said that if a woman employee is survived by a widower with no eligible child, the family pension will be payable to the widower. It said that for cases where

the deceased female government servant or pensioner is survived by a widower and children who have attained majority but are still eligible for family pension, the family pension will be payable to such children.

It said that similarly, the families of missing employees covered under NPS can now get a family pension within six months of lodging FIR and not wait for seven years after which the employee is considered deemed

### BMC bans illegal posters, hoardings, banners on all Mumbai roads

Court order, the BrihanMumbai Municipal Corporation has banned any illegal posters, banners, hoardings or announcements on all public roads in the city and suburbs, an official said here on Monday.

n wake of a Bombay High

The BMC has published a list of locations where such displays are authorised, and will now initiate a campaign to remove the illegal displays in other areas. The civic body has also appealed to citizens, social organisations, and political parties to refrain from erecting any such hoardings,



banners or posters without the prior permission of the department concerned at the ward level. The issue was also discussed at a state-level committee chaired by the Additional Chief Secretary, Home, recently to discourage such unauthorised displays on public roads, pathways, etc.The BMC said that violators will be penalised under the Maharashtra Prevention of Defacement of Property

Act, 1995 and Mumbai Municipal Corporation Act, 1888.In 2022, the BMC had initiated several drives and uprooted over 16,300 illegal posters, banners, hoardings, announcements, flags, etc from main and arterial roads, and conducted regular campaigns against the public nuisance in different parts of the city and suburbs.

There have been instances when such illegal hoardings/banners have posed a risk to pedestrians or vehicles by obstructing the view of traffic signals, and hindering visibility of major heritage buildings or monuments or scenic locations.

he hearing in the high-profile honey-trapping and blackmailing scandal, that rocked Madhya Pradesh four-and-half-years ago, was deferred to February 10 on Monday as the Special Investigation Team (SIT) failed to submit its report on whether Congress leader Kamal Nath has a 'pen-drive' purportedly containing evidence of the case.

Claiming that the new SIT chief Adarsh Katiyar, who took charge recently, was on training in Coimbatore, the team sought some more time to submit the report.

Subsequently, a District Court of Indore fixed February 10 as the next date of hearing.

The court was hearing a petition filed by lawyer Yavar Khan seeking to know how the pen drive related to the sensational case had fallen into the hands of former Chief Minister Kamal Nath.Khan filed the petition after Nath at a press conference



here on May 21, 2021 claimed that he had in his possession the pen drive containing evidence of

The court had earlier sent notices to the police and Kamal Nath to reply to the petition. The SIT constituted by the state government to probe the matter was supposed to present its report on the notice sent to Kamal Nath in this regard.

Importantly, Kamal Nath had earlier issued a clarification that he had only watched the 29 second-clip relating to the scandal.

In his clarification, he had said that the police produced the pen drive before him when he was the Chief Minister, but, he had returned the pen drive to the police after watching the clip. The scandal came to light on September 19, 2019 when an engineer of Indore Municipal Corporation (IMC) filed a complaint with a police station in Indore alleging that he was being blackmailed with the release of a video of him in a compromising position if he did not pay Rs 3 crore to a woman.

All the six accused are now out on bail.

#### **US issues record-high 1.4 mn** visas to Indians in 2023

New Delhi: Bringing down the visitor visa appointment wait times by 75 per cent, the US Consular Team in India processed a recordsmashing 1.4 million US visas in the year 2023.

Stating that the demand across all visa classes was unprecedented -- with a 60 per cent increase in applications compared to 2022 -- the US Embassy and Consulates said on Monday that Indians now represent one out of every 10 US visa applicants around the world. In addition, visitor visas (B1/B2) rebounded to represent the second-highest number of applications in the US Mission's history -- over 700,000. The US Embassy and Consulates said that it met this demand through a three-month staffing surge in Mumbai early in the year, by increased permanent staff levels, and through the employment of innovative technical solutions. Last year, the US consular team in India issued over 140,000 student visas -- more than in any other country in the world setting a record for the third year in a row.

► An advanced technique called Nuclear Lucknow | Agencies Magnetic Resonance (NMR) is employed to analyse the metabolism of the liver cells and blood cells in a highly growing stage.

▶ This revealed abnormal changes in cell cycle, including energy formation and utilisation, such as the accumulation of a substance called succinate in the liver tissue, increased breakdown of ketones, and alterations in how the body processes amino acids in advanced stages of HCC.

Importantly, these metabolic changes in cells were found to closely align with the progression of liver cancer, potentially serving as early indicators of the upcoming disease.

new research has shown that liver cancer, a growing health challenge often diagnosed in its advanced stages, can be prevented by changing the metabolic programming of cells as a target thera-

The research, conducted over six years, is a collaborative effort of scientists from CSIR-Central Drug Research Institute (CSIR-CDRI), Central Institute of Medicinal and Aromatic Plants (CIMAP), and Centre of Biomedical Research (CBMR), SGPGIMS, Lucknow.

The research, published in the renowned international journal Elsevier, also unravels crucial



insights into the metabolic mysteries behind Hepatocellular Carcinoma (HCC), a challenging form of liver cancer. Besides delving into the intricacies of HCC, the research opens avenues for targeted therapies.

In their research work, CDRI's Mugale and his team utilised an animal model of HCC induced by a substance called Diethylnitrosamine (DEN), mirroring the development of the disease in humans.

The study revealed changes like decreased body weight, higher levels of certain enzymes in the blood, and alterations in the liver structure observed through special staining and microscopy techniques during the progression of HCC.

"Our team used advanced techniques like Immunohistochemistry (IHC) to identify elevated levels of specific markers in the cancerous liver, providing insights into the enhanced cancer-causing potential. They also delved into the role of a signalling pathway called STAT3-NFKB, uncovering its impact on the cell's metabolism, which was found to be a key driver in the malfunction

#### **GOVT BANS SIMI FOR 5 MORE YEARS**

New Delhi: The Central government on Monday banned the Students Islamic Movement of India (SIMI) for five more years and declared it an 'unlawful association'.

"The ban on SIMI has been imposed under Section 3(1) of the Unlawful Activities (Prevention) Act (UAPA) 1967 for a further period of five years," the Ministry of Home Affairs said. The ministry said that the ban on SIMI has been imposed vide Gazette Notification Number S.O. 564(E), dated the 31st January, 2019.

# **NITISH KUMAR SHOULD NOT REPEAT OBSCENE REMARKS AGAINST WOMEN: BJP WOMEN LEADERS**

Patna: A day after the formation of the NDA Government in Bihar, Deputy Chief Minister Samrat Choudhary, on Monday claimed that he will tonsure his head and remove his turban in Ayodhya.

The BJP's Samrat Choudhary had taken the oath that he would remove his turban, which he had donned after his mother's death, only after he removes Nitish Kumar from the post of Chief Minister of Bihar.

However, in a twist of fate, Nitish Kumar retained his post as Bihar Chief Minister and now Samrat Choudhary has to work under him as the Deputy Chief Minister.

When asked about his vow, Samrat Choudhary said, "After my mother died in 2022, I tonsured my head and tied a turban. When, I became the Leader of Opposition in Bihar's legislative council soon after that, I took an oath that I would remove my turban only after removing Nitish Kumar from the post of Chief Minister of Bihar. As the BJF is my second mother, I would do anything for my second mother."When the national leadership of the BJP decided to go with Nitish Kumar as the Chief Minister, it was a sentimental moment for me. I told our top leadership that I will go to Ayodhya and remove the turban and shave my head and place it at the feet of Lord Ram," he said.

# Maha cop, journalist nabbed for honey-trap sextortion racket in Gadchiroli

Police in Maharashtra's Gadchiroli have arrested a journalist and a policeman among others for allegedly running a major honey-trap sextortion racket, an official said on Monday.

The accused are: policeman Sushil Gawai, journalist Ravikant Kamble, and their accomplice Rohit Ahire, all hailing from Nagpur.

Besides, a woman associate who was part of the sextortion gang, identified only as Ishani, has also been arrested, while the police are on the lookout for another unidentified woman who is absconding.

According to a complaint lodged with the police, a government employee from Gadchiroli had gone to Nagpur on January 3 on official duties, where his old friend Gawai arranged for an accommodation at a hotel in the Hingna area of the city.

However, there were two other women already in the room, who threatened the complainant (government servant) with rape charges if he did not pay them Rs 10 lakh, and later, the other accused also joined in.

They warned him of filing a police complaint with evidence, ruining his reputation, and other dire consequences if he did not comply with their demands.



Pretending to help out, the complainant's friend Gawai claimed that he had already paid up around Rs 2 to 3 lakh from his pocket, while Kamble had also reportedly chipped in with Rs 28,000 to silence the two women.

They demanded that the complainant should refund the money they had already allegedly paid up on his behalf, plus make arrangements for the remaining cash to save his image, and hush up the matter to avoid any legal hassles, said a police official.

Finally, after over three weeks of these demands, the government servant lodged the complaint and the police team nabbed the four accused in the case within hours. Further investigations are underway.

# Upset over unnatural sex demand, woman in UP bites husband's private parts

### NOT HEART ATTACK, BUT HUSBAND KILLED MADHYA PRADESH SDM: POLICE

The doctors at the community centre, on the other hand, told the police that by the time the officer was brought there, she was already dead.

Subsequently, the police sealed the officer's resi-



rogation. It was revealed that Nisha was allegedly killed by her husband for not making him the nominee in service, insurance and bank records, Dindori SP Akhil Patel to mediapersons on Monday. According to Patli, Sharma suffocated her wife with a pillow on Sunday, sat near the corpse for six hours and then took the body to the nearby community health centre, where the doctors there

### Varanasi's Gyanvapi mosque: Plea in SC seeks ASI survey of entire sealed area, including 'Shivling'

he Hindu plaintiffs in Varanasi's Gyanvapi case have moved an application before the Supreme Court seeking directions to Archaeological Survey of India (ASI) to survey the 'Shivling' and entire 'wazukhana' (ablution pond) area of the mosque area - which had remained sealed since May 2022.

In October 2022, the Varanasi District Judge rejected the application filed by Hindu side for conducting scientific survey of Shivlingam, mainly on the ground that there is an order of sealing passed by the Supreme Court. "The survey of the entire premises has been

conducted except the sealed area by ASI and now it is necessary that the sealed area be also surveyed by ASI, otherwise, the very purpose of survey would be frustrated as there will be no report of ASI regarding the area under seal," said the application filed before the apex court.

The application filed through advocate Vishnu Shankar Jain said that the plaintiffs and the Hindus, in general, have every right to have dar-

"Therefore, the selection of 'golden' as the colour code would ensure better visibility on trains and will be more convenient for the passengers," he said.

# Operation launched to nab tiger from BJP leader's farmhouse in UP

orest officials have launched a search operation to locate and secure a tiger, which was spotted inside the premises of BJP leader Munindra Awasthi's farmhouse in Sandana village of Uttar Pradesh's Sitapur district. The big cat was spotted at Awasthi's house on Saturday night and had been roaming freely for the past 24 hours according to Dinesh Gupta Forest Ranger, Sitapur district. Awasthi's farmhouse is situated in

Khevatarampur village of Naimisharanya police station area. According to forest ranger Gupta, a dedicated team combed the farmhouse

on Sunday, and efforts were intensified to locate and secure the tiger. "Visual surveillance, including the use of drones, has been employed since Sunday evening to monitor the move-

ments of the tiger," he said. The Forest Department team has yet to successfully apprehend the tiger. Divisional Forest Officer (DFO) Sitapur, Brij Mohan Shukla, said, "Plans are in place to employ a cage in the



Sandana area to safely contain the tiger. The tiger will not be tranquillized as the it is not aggressive." He said that 10 to 12 members from the forest and police department were involved in the operation. The presence of a tiger within a res-

idential area has raised concerns among

locals in the area. In December last year,

a tiger resting atop a wall in Pilibhit in Uttar Pradesh drew a massive crowd before being rescued by forest officials. A team of forest department officials

rescued the big cat that had ventured into a man's house in the Athkona village, located nearly 20 km from Pilibhit Tiger Reserve forest.

# god to worship: Mamata

est Bengal Chief Minister on Monday took an indirect dig at the BJP over the recent 'Pran Pratishthan' ceremony of the Ram Temple at Ayodhya, saying no one has the right to dictate others as to which god one should worship.

"What do they think? I will only worship the god that they suggest? I am not ready to allow that. I have studied Ramayana. I have studied the Bible, Guru Granth Sahib and Tripitaka as well," the Chief Minister said while addressing an administrative review meeting in Cooch Behar on Monday. Banerjee also indirectly ridiculed BJP for not referring to "Sita Mata" or "Mata Koushyalya".

"They never speak about them or the sacrifices they

made," Banerjee said. She also accused the BJP of ignoring the popular religious places and religious festivals in West Bengal. "They never speak of the Madan Mohan



Temple or the Jalpeshwar Temple. They never speak of Durga Puja. I have said this before and I am saying this again, religion is about personal faith, but festivals are for all," she said. Banerjee also accused the

BJP of "unnecessarily targeting" her over the issue of corruption."My party will not take the responsibility of personal corruption by just 1 per cent of the leaders. Similarly, the state government will also not take the responsibility. Now the 'dacoits' are addressing us as 'thieves'. I do not accept any salary as the Chief Minister. I even pay the bill for a single cup of tea. So do not lie and call me a thief," the Chief Minister said.

The officials said that a total of 26 districts of Rajasthan and 13 districts of Madhya Pradesh will get direct benefits by connecting Chambal, Parvati and Kalisindh rivers.

The MoU was signed by two respective chief ministers in presence of Jal Shakti Minister Gajendra Singh Shekhawat in New Delhi.

Madhya Pradesh Chief Minister Mohan Yadav said that Chambal belt is very important from the point of view of agriculture and a proper implementation of this scheme will be of great benefit."Along with agri-



culture, industrial development and tourism will also get a boost. Like

Pradesh are also included in this scheme. Maximum benefits will be belt," the Madhya Pradesh Chief Minister said.Rajasthan Chief Minister Bhajan Lal Sharma said that ERCP was pending for a long time.

The tenure of five Rajya Sabha members from the state is ending on April 2. The election process for this has also been announced. Out of these five seats, BJP has MPs on four seats, whereas, only one seat is with Congress. The MPs from the Rajya Sabha seats that are falling vacant in the state are currently BJP's Ajay Pratap Singh and Kailash Soni, who are also from the state. Whereas, Dharmendra Pradhan and L Murugan are members from outside the state. Whereas, Rajmani Patel is from Congress.

BJP has 163 members in the Assembly and support of 39 MLAs is required for one member, thus four Rajya

# Won't contest LS polls, says Digvijaya Singh

mid speculation of whether Congress stalwarts in Madhya Pradesh will contest the forthcoming Lok Sabha election, former Chief Minister Digvijaya Singh has said that he was not keen on contesting the polls.

Congress veteran leader said he won't contest the Lok Sabha election as his Rajya Sabha tenure has two more years to go. The two-time Chief Minister was elected as MP for the Upper House of Parliament in June 2020, and therefore, the six-year tenure will end in June 2026.

During an interaction with the press reporters in his home district Rajgarh on Sunday, he said, "The question of contesting the elections does not arise because I am a member of Rajya Sabha and still have over two years."



Singh ruled out the possibility of contesting the Lok Sabha election. However, the political circle was full of speculation that the Congress may field him from Rajgarh this time. Over the past week, Singh has been taking meetings of party workers in Rajgarh, Raghogarh and Khilchipur -- all these Assembly segments fall in the Rajgarh Lok Sabha constituency. Sources in the Congress told IANS that there were very rare chances for the Congress to further give tenure as Rajya Sabha MP to Digvijaya Singh and wanted

him to contest the Lok Sabha

Singh had contested from Bhopal Lok Sabha seat in 2019 but lost to BJP's Pragya Singh Thakur by a margin of 3.65 lakh votes.

Rajgarh Lok Sabha seat is the home turf of Singh, who hails from the Raghogarh Assembly segment (Guna district) which falls under the Rajgarh parliamentary constituency. Singh had represented Rajgarh LS seat in 1984 and 1991.

He said the Congress party will decide the candidate for Rajgarh Lok Sabha constituency. Of the total 29 Lok Sabha seats in Madhya Pradesh, the BJP holds 28 and the Congress one. In the Assembly elections held last year in the state, the Congress recorded its worst performance under Singh and another veteran Kamal

The court further asserted that according to section 499 of the Indian Penal Code (IPC), "Making any imputation against a deceased person amount to defamation if the imputation would be harmful to the reputation of that person if he were alive, and is intended to hurt the feelings of his family or near relatives."

Hearing the matter, the court said. "Dr. Rakesh Pathak is not a member of Mahatma Gandhi's family or is a close relative, hence he does not have the jurisdiction to file the complaint. Therefore, it is rejected under Section 203 of the Code of Criminal

Notably, addressing the gathering

fter the consecration of Ramlala in the Ram temple in Ayodhya, innovative initiatives are being taken towards strengthening relationships in the society. An initiative has been taken in Satna district of Madhya Pradesh, where 'Ram' and 'Ramayana' are being used to end the bitterness in family relationships.

# Inside Madhya Pradesh's Cow shelters, never ending wait for funds

cow protection board, a cow cabinet and around 2400, Government or government aided cow shelters across the state -- and still the elderly cows of Madhya Pradesh do not have enough to eat. An inspection of 4 cow shelters across Bhopal by NDTV showed that the authorities of the shelters do not get regular payments from the state government.

During elections, Congress promised to increase the financial assistance for cows to Rs 40 per day from Rs 20 per day if voted to power. Former Chief Minister Shivraj Singh Chouhan's

promise of purchasing cowdung and cow urine, has also not materialised. There are about 140 cows at the Maa Gayatri

Gaushala in the middle of Bhopal city. The shelter is located in the premises of the Gayatri temple. President of the Gaushala trust, Subhash Sharma, said the grant of Rs 20 is not only insuffi-

cient, it comes only once in four to five months. The cowshed being in the middle of the city, many come here to feed their animals.

At Kokta Mahamrityunjay Gaushala outside the city, there are more than 600 cows. The civic body leaves injured and destitute cows here. Most of the cows are old and do not give milk. Govind Vyas, chairman of the gaushala, has been running this shelter for 20 years. A retired bank employee, he said they have to spend Rs 60-70 per cow just on fodder. The grant falls far short of

requirement. Even that comes once in every six or seven months, he said. He uses money from his pension to take care of the cows

Brijesh Vyas, a member of the same gaushala, said he has appealed to the government several times. "Rs 20 cannot cover the cost of water, let alone fodder. Today the price of chaff is Rs 700 a quintal. At least 25 kg of straw is required for a cow's fodder each day," he said. The Nandini Gaushala in Bhopal's Kaliyasot, which has 75 cows, received the last grant in August. The owner said there is a delay of 6-7 months in receiving government grants.

There are two types of cow shelters in Madhya Pradesh -- 618 are cowsheds recognised by the government, which have about 1.5 lakh cows. Besides, there are 1,800 cow shelters built on government land with MNREGA funds, which have 2.80 lakh cows. The government claims it pays Rs20 every day for each of the 4 lakh-plus cows as grant. The dues till December 31 are paid, it said.

"It is true that the grant is less," said Lakhan Patel, the minister for Animal Husbandry and Dairy. "Efforts are being made to increase it. But our biggest problem is that people leave animals on the roads," he added. Last year, the state had passed a law increasing the Rs 1000 penalty for those found guilty of neglecting cattle or any other animal. Data from the police helpline indicated that 45,800 distress calls about stray cattle were received in the last seven years - meaning on an average, 18 calls are received a day

Madhya Pradesh has a Gau Samvardhan Board (cow protection board) from the last two decades. Three years ago, then Chief Minister Shivraj Singh Chouhan announced the creation of a "cow cabinet" meant to protect cattle and promote the use for dairy products.

The website of the Gau Samvardhan board has not been updated since the sate elections. It says "Chief Minister Shivraj Singh Chouhan" is its president and Prem Singh Patel -- former animal husbandry minister who lost the election -- is the Vice-

#### SP, Congress restless in UP following political developments in Bihar

ihar Chief Minister Nitish Kumar snapping ties with INDIA bloc and again joining NDA has come as a jolt to alliance partners in Uttar Pradesh between Samajwadi Party (SP) and Congress. Both parties feel that the developments in Bihar have undermined their position in UP against the BJP. Nitish Kumar not only laid the foundation of the INDIA bloc, but had also worked to unite the opposition on a single platform by meeting with leaders of different political parties and convincing them to join hands against the BJP. Akhilesh had worked hard to knit the opposition alliance with Nitish Kumar, holding a series of meetings with Kumar in Delhi to draft the strategy for the Lok Sabha election. They had even addressed a joint ress conference in Lucknow to send a message of the alliances of the two top OBC leaders among the masses. The caste census conducted by Nitish Kumar in Bihar had set the ground for the INDIA bloc to target the NDA. Moreover, to break the hold of the BJP over Kurmi voters, the opposition alliance had planned to field Nitish Kumar from either of the three seats -- Phulpur, Mirzapur and Ambedkar Nagar in UP, as these three seats have strong OBC presence. SP sources said Akhilesh tried to contact Kumar to convince him to stay in INDIA bloc but his efforts proved futile. An immediate impact of Nitish Kumar joining the BJP will be that the SP and the Congress will now have to work overtime to keep the alliance intact - even if it means compromising on the number of seats. If the alliance cracks up in UP, the INDIA bloc will be in danger and the advantage will clearly go to the BJP.

# A MOMENT OF NATIONAL RESURGENCE

The extensive ceremony of the inauguration of the Ram Temple at Ayodhya on January 22, with Prime Minister Narendra Modi as the principal invitee performing all the religious duties pertaining to the installation of the deity of Ram Lalla, has proved to be a national event that electrified the belief system of Hindus across India - including those who were living abroad. This happened in a manner not seen in this country's history before.

The Prime Minister was at Ayodhya both as a Hindu and as the chief of the political executive governing the nation and this established, in the Indian context, the principle that holding a high political office did not mean that a leader should shy away from his or her religious commitments.

Secularism means that India granted complete freedom of worship and did not put a denominational stamp on the national or state government - it also at the same time, did not deny people in power their right to publicly own their faith.

Apart from the basic democratic concept of 'one man one vote' - that was in play regardless of caste, creed or gender - the only other secular requirement of governance would be that policy should not discriminate between sections of the citizenry.

The address of Prime Minister Modi was free of any suggestion of religious 'exclusivism' and it effectively countered the narrative of 'majoritarianism' and allegation of any other form of bias and largely focused on the importance of socio-cultural unity as a powerful instrument of national advancement.

The extraordinary turnout of people associating with the ceremony was no doubt driven by the historicity of the event - but they also had a clear perception that it is precisely the Hindu faith that alone had unacknowledged even after Independence. The fact that the temple construction was started only after the Supreme Court gave its judgement in its favour through a constitutional Bench - this was highlighted by the Prime Minister freed the event of any communal projections. If the inauguration of Ram Temple at Ayodhya enhances the political status of Prime Minister Modi in the eyes of the people, nobody can grudge it - the voter it should be remembered is an astute judge of the merit

In his scintillating address on the occasion, Prime Minister Modi declared that Lord Ram was the 'spirit of the Constitution' and Ram Temple a 'symbol of national consciousness' that liberated the people from 'slavery' and a 'colonial mindset'. This latter was a reference to the historical subjugation of the Hindu religion as also to the British game of dividing India into communities and creating a minority-majority issue in politics.

He validated the place of glory that Hinduism enjoyed in India's nationalism by affirming that "Ram is the faith of India, the foundation of India and the idea of India" and went on to add that "Ram was also the law of India, the leader of India as well as the poli-



He put a stamp of eternity on it by saying that Ram was not only the present but also the future of India. The speech was remarkable for steering clear of any sectarian overtones and for emphasising how the story of Ram established that differences between

'high' and 'low' did not exist for him. Prime Minister Modi emphasised that "there should be humility in victory", that Ram was "a solution, not a problem" and recalling how the opponents of Ayodhya temple warned of catastrophic consequences, asserted that "Ram was not a source of fire but of energy". Many leaders in India have misled the minorities into believing that giving respect to the religion of the majority amounted to encouraging 'majoritarianism' - they knew only too well that the Constitution would not permit any political moves in that direction. They in fact injected religion into politics by demanding "a share in governance on the basis of community identity".

So long as the minorities had religio-cultural freedom and the same political rights and economic opportunities that others had, they should have no problem about being a part of the political umbrella that the nation provides through the universal adult franchise. If because of numbers the majority sends more members to Assemblies and Parliament it does not violate the intrinsic strand of secularism that runs through a democratic state like India.

It is time the Hindu majority of India was consciously involved in building nationalism which is a sentiment to be shared by all communities here.Communal politics in India was pushed to a point where 'nationalism' was considered a 'diminishing' concept if not a politically 'abusive' word - all in the name of 'sensitivity' of the minorities - and there was even an endorsement of the suggestion that saluting the national flag or standing during the singing of national anthem should be made optional.

India no doubt had to suffer the unfortunate parti-

tion on communal lines in the process of achieving freedom - that was bound to produce a spill over - but many minority leaders of India continued to base their politics on the Hindu-Muslim divide which came in the way of national advancement and reconstruction.

A sense of belonging to the cultural heritage of the nation and adherence to the human value system shared by all Indians, should not be impeded by politics and it goes to the credit of Prime Minister Modi that he has been able to legitimise the concept of 'Vasudhaiva Kutumbakam' within India and at the global level as well. The Prime Minister has taken this idea from the esoteric to the level of practicality in the international arena at a time when the world was marked by divisions, stealth attacks and disregard for human values and it is no surprise that he has emerged as a global leader whose influence mattered on the issues of war and peace. Prime Minister succeeded in turning the inauguration of Ram Temple into a starting point for a new nation-building effort, in this light. The civilisational content of a nation today is a factor of newfound importance working for its strength. In a composite scenario marked by a multireligious and multi-lingual setting, people need to have a deeper sense of unity on the strength of a shared value system, the historical sense of ups and downs and an idea of friendship and adversaries in the present. 'Religion' defines the relationship of an individual with his or her God and presumably makes a positive contribution to 'culture' that determines how the individual would treat others in socie-

A collectively acceptable code of ethics can run through the nation provided notions of 'supremacism' were not flaunted by the followers of any faith the assimilative character of

Hinduism stood out in this context. for its adherence to the idea that "God was one but the paths to reaching Him could be many". Prime Minister Modi's advocacy of this approach in his Ayodhya address befitted the occasion and was timely as well.

India should set an example of how nationalism strengthens democracy and vice versa. We should take notice of how China under President Xi Jinping has evolved a new doctrine of 'Marxism with Chinese characteristics' which has been acknowledged as 'Xi's Thought' in the CPC constitution - like the Mao's Thought was in the party 's history - but also how he has called for realisation of the 'civilisational strength' of China for national advancement.

India can more than match China on the point of civilisational history in terms of its vintage and richness on all fronts and it is a matter of great satisfaction that Prime Minister Modi in his address at Ayodhya brought out in adequate measure, the civilisational gift that India was able to offer to the entire world. In going through the rigorous practices prescribed for his duty as the principal invitee at the religious ceremony at Ayodhya, Prime Minister Modi was conducting himself as a pious Hindu in his own personal right but it is in his public address that he stood out as the leader of a diverse nation, a torch bearer of nationalism and as a Prime Minister who was totally dedicated to carrying India forward towards prosperity and peace. He talked of the demographic dividend of India accruing from the population of the young, exhorted people to have optimism and expressed his confidence that the installation of Ram Temple was a transformative moment that marked the advancement of a united India 'for a thousand years ahead'. He mandated all Indians to follow the mission of 'Ram to Rashtra'.

The temple has already showcased Indian talent in the fields of sculpture & arts, mobilisation of internally available material resources, technological progress, management techniques and the country's acumen for national discipline.

# **NYC MAYOR UNVEILS GANDHI STATUE OUTSIDE HINDU TEMPLE AFTER 2022 VANDALISM INCIDENTS**

Tew York City Mayor Eric Adams Assembly Member Jenifer Rajkumar have unveiled a new Mahatma Gandhi statue, more than a year after the previous one was vandalised twice outside a Hindu temple in the state.

Located in front of Shri Tulsi Mandir on 111th Street in Richmond Hill, the Gandhi statue was knocked over, spray painted with the word "dog", and battered with a sledgehammer on August 3 and 16, 2022.

"Last year, the statue of Gandhi that stood in South Richmond Hill was destroyed. But our solidarity and spirit to rebuild was not. Today, we stood with the community to say in one voice: Hate has no place in our city," Mayor Adams said, unveiling the statue last week.

We embody the values of justice for which Gandhi gave his life," Mayor Adams said at the event attended by



members of the Indian-American com-

Rajkumar, who was at the forefront, calling for an investigation into the incident as a hate crime against Hindus and Indians, posted a video of the ceremony on X and said it was "exciting" to unveil the statue along with Mayor Adams.

"EXCITING! Watch myself and @NYCMayor unveil the new Mahatma Gandhi Statue at Tulsi Mandir at the site last year's hateful vandalism. It was historic moment for our Richmond Hill community as we came together to show that our love will conquer all hate," she wrote on X.

After the first attack, Rajkumar brought together several elected offiincluding House Representatives Foreign Affairs Committee Gregory Meeks, to condemn the attack and demand police action.

As the first Hindu elected to the New York State legislature, Rajkumar said, "When the Gandhi statue was vandalised, that really flew in the face of all of our beliefs and it's very disturbing for the community".

US President Joe Biden vowed on Sunday in a statement to hold accountable those responsible for the killing of three US service members and cast blame on Iran-backed militant groups.

# 42 KILLED IN FRESH COMMUNAL CLASHES NEAR SOUTH SUDAN

t least 42 people were killed, including a UN peacekeeper, during clashes last week in the Abyei Administrative Area between armed youth of the Twic community of neighbouring Warrap state and Ngok Dinka of Abyei, officials confirmed.

Rou Manyiel Rou, the Secretary General of Abyei Special Administrative Area, said on Sunday that the attacks in Nyinkuac, Majbong, and Khadian areas by armed youth from the Twic community in collaboration with Nuer youth loyal to their spiritual leader Gai Machiek also left 35 people wounded, Xinhua news agency

"As we face these barbaric coordinated attacks, the government of Abyei Special Administrative Area condemns in the strongest terms possible the attempt by Twic and their allied armed youth to defy the presidential order issued recently by President Salva Kiir to end the conflict between



Ngok Dinka and Twic communities," Manyiel told Xinhua in an interview. President Kiir's order issued

on January 18 called on security forces to expel from Warrap state the Nuer spiritual leader Gai Machiek and his loyal Nuer youth in a bid to resolve the conflict between Ngok Dinka and the Twic communities. The order also called on security forces to summon and arrest politicians from both warring communities who appeared to incite violence between the two communities.

Manyiel called for the speedy deployment of neutral security forces along the border between Twic County and the

Abyei Administrative Area. Simon Aguek Chan, the Commissioner of Twic County of Warrap state, said that their youth were not involved in the violence in the Abyei Administrative Area.

Aguek added that the fighting was between armed Nuer youth staying within Abyei and the local Ngok Dinka youth.

"The Nuer armed youth who fought with Abyei youth on

Saturday are the ones who have been killing people in Twic, they have heavy machine guns and I believe they are from organised forces because the weapons they have are not supposed to be for civilians," he

The United Nations Interim Security Force for Abyei (UNIS-FA) condemned the series of armed attacks that took place on Saturday in the Abyei Administrative Area, which resulted in the death of a UN peacekeeper from Ghana.

"The Mission confirms that the inter-communal clashes that took place in the Nyinkuac, Majbong, and Khadian areas led to casualties and the evacuation of civilians to UNISFA bases to provide safety for those caught up in the violence. Efforts are underway to verify the number of those killed, injured, and displaced in the

violence," it said in a statement. It added that the UNISFA base in Agok came under attack by an armed group that repelled by was peacekeepers.

#### Israeli army kills over 350 in Gaza's Khan Younis during past 48 hrs: Hamas



he Hamas-run government in Gaza said in a statement that the Israeli army killed at least 350 Palestinians in the past 48 hours in Khan Younis in the southern

# SC grants 15-day extension, asks Maha Speaker to decide defection pleas in NCP split by Feb 15

he Supreme Court on Monday granted a 15day extension to Maharashtra Assembly Speaker Rahul Narwekar for deciding the pending defection petitions in the NCP split case.

Earlier, the top court had ordered the Speaker to announce his decision by January 31 on disqualification petitions filed by the Sharad Pawar faction of the Nationalist Congress Party (NCP) against the Ajit Pawar faction.

During the hearing, a bench headed by CJI D.Y. Chandrachud was apprised by Solicitor General Tushar Mehta that the Speaker would conclude the proceedings in the next two days and for dictation of orders in disqualification proceedings, the deadline may be extended by three weeks.

"Final hearing shall commence from 30th January and conclude on 31st January and matter will be closed for final orders. For dictation of orders, the Speaker needs three more weeks," submitted SG Mehta.

Singhvi, appearing for Sharad Pawar-led faction, said that order does not take three weeks to be dictated. "Your lordships may give him one week," Singhvi said. Responding, SG Mehta said that a three-week

He said: "It must be ensured that maximum number Marathi youths should get employment in this. The Employment Cell is prepared for it".

Raj Thackeray urged his activists that the full details of the jobs should be prominently posted in all the party office, and the candidates must be given full guidance on how to fill in the applications online, tips on clearing the interviews, etc., so that the highest number of Marathis can get these rail-

This spells a sea-change for the aggressive Raj Thackeray of the fledgling MNS (founded in 2006) who had allegedly instigated attacks against North Indians in the state, including railway recruitment candidates in October 2008, and on other occa-

# JADEJA, RAHUL RULED OUT OF INDIA'S SECOND TEST AGAINST **ENGLAND; SARFARAZ, WASHINGTON, SOURABH CALLED UP**

eft-arm spin all-rounder Ravindra Jadeja and middleorder batter K.L Rahul have been ruled out of India's second Test against England, starting in Visakhapatnam on February 2 The Board of Control for Cricket in

India (BCCI) said in a statement that Iadeja sustained a hamstring injury during batting in India's chase of 231 on the fourth day of the first Test in Hyderabad while Rahul complained of a right quadriceps pain, with the medical team monitoring the progress of the duo.

It further said the men's selection committee has added right-handed batter Sarfaraz Khan, left-arm spinner Sourabh Kumar and off-spin allrounder Washington Sundar to India's Test squad for the Visakhapatnam Test.

The injuries to Jadeja and Rahul come as further big blows to the Indian team, especially after losing the Hyderabad Test by 28 runs and trailing 0-1 in the five-match series against England. The hosts are already without talismanic batter Virat Kohli, who pulled out of the first two Tests due to personal reasons, as well as senior pacer Mohammed Shami nursing an ankle injury.

On Day Four of the Hyderabad Test, Jadeja had been seen clutching his hamstring and was in discomfort after being run out for just two by a sensational direct hit from England skipper Ben Stokes, while attempting

Jadeja and Rahul were India's top run-scorers with 87 and 86 respectively in their first innings total of 436 in Hyderabad, with the former also clinching figures of 3-88 and 2-131 with this left-arm spin. Washington has played four Tests

for India, picking six wickets and slamming three fifties. He has earned a recall into the Test set-up after his last appearance in the format came against England at Ahmedabad in March 2021, Sourabh had been a member of India's Test squad for the home series against Sri Lanka in March 2022 and was called up as a replacement for Jadeja for the away series against Bangladesh later in the year. Sarfaraz, meanwhile, has got his well-deserved, but long-awaited maiden call-up to the Indian Test team. Sarfaraz, a prolific run-getter in the last three seasons of domestic cricket for Mumbai, recently smashed a brilliant 161 as India A defeated England Lions by an innings and 16 runs in the second four-day match in Ahmedabad.

In the same game, Sundar had picked figures of 2-25 and 0-35 respectively while making 52 with the bat, Meanwhile, Saurabh slammed 77 with the bat and had figures of 1-35

and 5-104 respectively in that match. BCCI also said Madhya Pradesh off-spinner Saransh Jain has been named as a replacement for Sundar in the India A squad for the third and final multi-day game against England Lions starting February 1 in Ahmedabad. s the Mercedes SUV car he was driving from Roorkee to New Delhi burst into flames on that fateful day of December 30, 2022, young Indian wicketkeeper-batter Rishabh Pant for a few moments felt that his 'time in this world is up'.

Pant sustained injuries to his head, back and feet including two cuts on his forehead and a ligament tear to his right knee and also hurt his right wrist, ankle and toe and suffered abrasion injuries to his back. He underwent plastic surgery for his facial injuries, lacerations and abrasions.

In a candid conversation with Star Sports 'Believe' series, featuring real heroes of the game who have overcome the odds to become champions, Rishabh Pant delved into the harrowing experience that nearly cost him his life and the remarkable resilience that propelled him towards redemption. Pant narrated his journey towards glory for the first time and the programme will be exclusively broadcast on Star Sports Network on Thursday (February 1), 7 PM onwards.

In the promo shared by Star Sports, Pant vividly recounted the chilling moments of his near-fatal car accident at the end of 2022.

"First time in my life I felt like my time in this world was up. During the accident, I was aware of the wounds, but I was lucky as it could have been even more serious. I felt that someone saved me. I asked the doctor how long will it take for me to recover, he said it

### Jasprit Bumrah reprimanded for breaching ICC Code of Conduct during Hyderabad Test

It also added that one demerit point has been added to Bumrah's disciplinary record, for whom it was the first offence in a 24-month period. The incident occurred in the 81st over of England's second innings, when Bumrah, after completing his follow through, deliberately stepped in Ollie Pope's way as the batter went for a run, leading to inappropriate physi-

Bumrah, who had figures of 2/28 and 4/41 in



and accepted the sanction proposed by Richie Richardson of the Emirates ICC Elite Panel of Match Referees, so there was no need for a formal hearing. On-field umpires Paul Reiffel and Chris Gaffaney, third umpire Marais Erasmus and fourth umpire Rohan Pandit levelled the charge.Level 1 breaches carry a minimum penalty of an official reprimand, a maximum penalty of 50 per cent of a player's match fee, and one or two demerit points. Demerit Points to remain on a Player or Player Support Personnel's disciplinary record for a period of twenty-four (24) months from their imposition following which they will be expunged.



I used to get angry seeing them. We're human beings too. In recent times, many people call my father a


She further mentioned: "I didn't know what it meant.
