

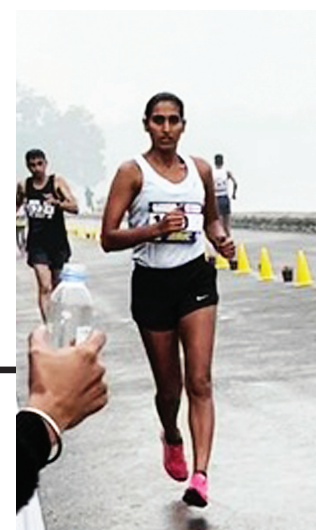

## RBI BARS PAYTM PAYMENTS BANK FROM ACCEPTING DEPOSITS AFTER FEB 29

The RBI has barred Paytm Payments Bank Ltd (PPBL) from further deposits or credit transactions or top ups in any customer accounts, prepaid instruments, wallets, FASTags, NCMC cards, etc., after February 29, 2024, other than any interest, cashbacks, or refunds which may be credited anytime.

The action has been taken after a Comprehensive System Audit report and subsequent compliance validation report of the external auditors revealed persistent non-compliances and continued material supervisory concerns in the bank, warranting further supervisory action, the RBI said in a statement on Wednesday.

"Withdrawal or utilisation of balances by PPBL customers from their accounts including savings bank accounts, current accounts, prepaid instruments, FASTags, National Common Mobility Cards, etc. are to be per-



mitted without any restrictions, up to their available balance, the RBI order states.

Apart from this, no other banking services like fund transfers (irrespective of name and nature of services like AEPS, IMPS, etc.), BBPOU and UPI facility should be provided by the bank after February 29, 2024, the order states.

The Nodal Accounts of One97 Communications Ltd

and Paytm Payments Services Ltd. are to be terminated at the earliest, in any case not later than February 29, according to the order.

Settlement of all pipeline transactions and nodal accounts (in respect of all transactions initiated on or before February 29, 2024) shall be completed by March 15, 2024 and no further transactions shall be permitted thereafter, the order further states.

### YOUR FASTAG WILL BE DEACTIVATED TOMORROW IF YOU HAVEN'T DONE THIS. SEE HOW

**New Delhi:** There is an important update for those planning to take road journey in the next few days. According to National Highways Authority of India (NHAI), the deadline to get Know Your Customer (KYC) done for your FASTag is ended yesterday, January 31. Those who fail to get the KYC done, their FASTag is inoperative from February 1. FASTag is a pre-paid tag facility for vehicles that allows non-stop movement of traffic without having to wait at the toll plazas. A FASTag is usually affixed on the windscreen of the car.



The FASTag KYC check has been introduced to enhance the efficiency of the electronic toll collection system and provide seamless movement at toll plazas. The highways body said it took the initiative after it was informed that more than one FASTag has been issued for a particular vehicle and FASTags being issued without KYC in violation of RBI's mandate.

#### What to do for FASTag KYC update?

The NHAI released the notification regarding the January 31 deadline in December last year. But if you are among those who forgot to update the KYC of your FASTag, here's what you can do:

Most of the bank branches close by 4pm, so people will have to avail online facility instead of an in-person solution. Open the FASTag website of the bank that have issued your RFID document. To access the required page, you can Google the name of the website with the keyword 'FASTag'.

Log in using your registered mobile number and entering the OTP received.

Go to My Profile section and click on the KYC tab. After filling in the required details like address proof and submit and it will be done. The KYC page will then show your KYC status. Documents required to complete FASTag KYC: Registration certificate of the vehicle.

Address proof  
A passport-size photo  
Passport, Voter's ID, Aadhar Card, Driving licence and PAN card can be used as identity and address proof.

## Champai Soren set to be next Jharkhand CM as Hemant Soren quits, arrested

Jharkhand Chief Minister Hemant Soren on Wednesday went to the Raj Bhavan to tender his resignation to the Governor, while members of the ruling coalition were reaching there to stake claim for a new government to be headed by senior JMM leader Champai Soren.

Champai Soren is currently the Transport Minister.

The fast-paced developments came as the ED, which was questioning Hemant Soren at his residence since the afternoon in a money laundering case probe linked to an alleged land scam, informed him that it was arresting him as it was not satisfied with his answers to their queries. Meanwhile, Chief Secretary L. Khiaingte, DGP Ajay Kumar Singh, and other top officials reached the CM's residence and security



there was tightened.

The ED, which was questioning Hemant Soren at his residence since the afternoon, informed him that it was arresting him as it was not satisfied with his answers to their queries. Subsequently, it was announced that Hemant Soren had challenged the ED probe and his arrest in a writ petition in the Jharkhand High Court on Wednesday but the matter was not heard

and is likely to be mentioned on Thursday for hearing.

Hemant Soren, who was reportedly "missing", resurfaced in Ranchi on late Tuesday, reaching his Kanke Road residence at around 1:50 p.m. The ED had been on the lookout for him in Delhi since Monday morning. They searched for him at several places including his Delhi residence and Jharkhand Bhawan, but did not find him.

### 109 STUDENTS FALL ILL AT SCHOOL NEAR MUMBAI, FOOD POISONING SUSPECTED

**Thane:** As many as 109 students of a private ashram school, including 63 girls, were rushed to a government hospital in Thane district after showing symptoms of food poisoning on Wednesday, an official said.

The ashram school (residential schools for tribal children) is located at Bhatsai in Shahapur taluka on the outskirts of Mumbai.

Shahpur tehsildar Komal Thakur told media that barring four students, all were discharged from the hospital after treatment.

In the morning, students were served food brought from outside, including a sweet dish. After consuming the food, 109 students -- 63 girls and 46 boys -- complained of vomiting, nausea and dizziness, and they were immediately rushed to a government hospital, she said. Samples of food items served to the children were collected and sent for laboratory examination, said Thakur. The local police were carrying out a probe into the incident, she added.

## Growth of core sector slows to 14-month low of 3.8% in Dec

The growth rate of India's eight core sector industries slowed to a 14-month low of 3.8 per cent in December, official figures released on Wednesday showed.

The growth of the cement and electricity segments fell to a crawl of 1.3 per cent and 0.6 per cent, respectively, during the month under review. Production of crude oil contracted by 1 per cent in December.

The fertiliser and steel sectors grew by 5.8 per cent and 5.9 per cent, respectively, year-on-year in December. The coal sector performed better than the other segments to register a double-digit growth of 10.6 per cent in the month, although this was the lowest pace of growth recorded since June 2023.

The core sector growth for November was provisionally put at 7.8 per cent, which was on Wednesday revised to 7.9 per cent.



Considering the April to December period, infrastructure output grew 8.1 per cent in the same period of the previous fiscal year.

ICRA chief economist Aditi Nayar said, "The core sector expansion halved to a 14-month low of 3.8 per cent in December 2023 from 7.9 per cent in November 2023, with a moderation in growth across six of the eight constituents. Following the tepid core sector growth in December 2023, we project the IIP expansion for that month at a bleak 1-3 per cent."

## Ladakh Shepherds stand up to Chinese soldiers, viral video wins hearts

A group of Ladakh shepherds bravely stood up to Chinese soldiers who tried to stop them from grazing sheep near the Line of Actual Control (LAC). Local shepherds had stopped grazing animals in this area following the 2020 Galwan clash. A video of them arguing with PLA troops and asserting that they were on Indian territory has won hearts on social media.

Chushul councillor Konchok Stanzin hailed the resistance shown by the local shepherds and praised the Indian army for supporting them. "It is heartening to see the positive impact made by @firefurycorps\_IA in Border areas of Eastern Ladakh in facilitating the graziers and nomads to assert their rights in traditional grazing grounds along the north bank of Pangong. See how our local

people are showing their bravery in front of the PLA claiming that the area they are stopping is our nomad's grazing land. PLA stopping our nomads from grazing in our territory. Seems it is never-ending process due to different lines of perceptions. But I salute our nomads, who always stand to protect our land and stand as the second guardian force of the nation." The video shows at least three Chinese armoured vehicles and several soldiers on the spot. The vehicles blare an alarm, apparently signalling the shepherds to leave. But they stand their ground and are seen arguing with the PLA troops. The shepherds insist that they are grazing on the Indian territory. On a couple of occasions, when the altercation escalates, some shepherds appear to pick up stones. But the video does not show violence breaking out.

## Rear windscreen of Rahul Gandhi's vehicle smashed in Bengal's Malda District

The second phase of the Congress' Bharat Jodo Nyay Yatra from Malda District in West Bengal on Wednesday started on a sour note as the rear windscreen of Rahul Gandhi's vehicle was smashed through Dewanganj area in the morning.

State Congress leaders have claimed that in all probability the rear window screen got smashed because someone threw a stone or brick on it.

However, the state Congress President in West Bengal and five-time Lok Sabha member Adhir Ranjan Chowdhury did not name any political party while making this accusation.

"You understand yourself, whose handiwork this could be. Rahul Gandhi's Nyay Yatra had been facing hurdles since the time it entered West



Bengal last week," said Chowdhury, who was with Rahul Gandhi in the vehicle when its rear windscreen was smashed.

According to Chowdhury, all possible attempts have been made to disrupt the rally since the beginning. "This phenomenon started

last week at Cooch Behar," he said. According to him, the opposition started with the destruction of the flexes set up by the state Congress workers to welcome Rahul Gandhi.

"Since then, such hurdles have been created one after another," Chowdhury said.

However, the national-level Congress leaders did not utter a single word on incident.

Significantly, Rahul Gandhi's yatra at Malda coincides with West Bengal Chief Minister's administrative review meetings in the same district.

## CPI-M responsible for spoiling Trinamool's relationship with Congress: Mamata

West Bengal Chief Minister Mamata Banerjee on Wednesday accused the CPI-M of being responsible for deterioration of her Trinamool Congress' "amicable" relationship with the Congress.

"I was with the Congress at one point of time. My understanding with Congress leadership was quite amicable. But because of the CPI-M, our relationship with Congress got spoiled," she said while addressing an administrative review meeting at Malda district.

Again holding the Congress responsible for the failed seat-sharing arrangement, Banerjee said excessive demands from the section of its leaders ultimately prompted her to take a decision of moving alone in West Bengal. "I thought of working together for the sake of the bigger national interest. They do not have a representative



in the West Bengal Assembly. They just have two Lok Sabha seats from the state. So I was willing to offer two. I also ensured their victory from those two seats. But they refused to accept that offer. Then I thought it was enough. I will not be able to move along with the CPI-M, which conspired to kill me again and again. They have killed so many people in West Bengal," she said.

Banerjee also said that the Congress' understanding with the CPI-M will actually benefit the BJP in West Bengal. "So it is better that the Trinamool Congress contests alone and make an all-out effort to defeat BJP," she said.



# 16 AIIMS, 315 MEDICAL COLLEGES ESTABLISHED IN LAST 10 YEARS: PRESIDENT MURMU

President Droupadi Murmu on Wednesday said that as many as 16 AIIMS and 315 medical colleges have been established in the last decade while the number of MBBS seats has more than doubled during the period.

President Murmu made the remarks while addressing the joint sitting of both Houses of the Parliament.

In her address, the President said that in the National Education Policy, emphasis has been laid on education in mother tongue and Indian languages.

"Teaching of subjects like engineering, medical, law has been started in Indian languages. To provide quality education to school students, my government is working on more than 14,000 PM Shri Vidyalayas. Out of these, more than 6000 schools have started functioning," she added.

"The school dropout rate in the country has reduced due to efforts of my government. The enrolment of



girls in higher education has increased. Enrolment of Scheduled Caste students has increased by about 44 per cent, that of Scheduled Tribe students by more than 65 per cent and that of OBC by more than 44 per cent. Under Atal Innovation Mission, 10,000 Atal Tinkering Labs have been established to promote innovation. More than 1 crore students are involved in it," she added. President Murmu further said that

in the last 10 years, the government has done "unprecedented" work in the field of tourism. "Along with the number of domestic tourists in India, the number of foreign tourists coming to India has also increased... The reason for the growth in the tourism sector is owed to India's growing stature. Today the world wants to explore and know India." "Apart from this, the scope of tourism has also increased due to

excellent connectivity. Building of airports at various places is also advantageous. Now, North East is witnessing record tourist arrivals. Now there is heightened excitement about Andaman-Nicobar and Lakshadweep islands," she said. About development of pilgrimage destinations and historical sites across the country, she said that the government has made pilgrimage in India easier now. "In the last one year 8.5 crores of people have visited Kashi. More than 5 crores of people have visited Mahakaal. More than 19 lakh people have visited Kedarnath. In the 5 days of "Pran Pratishtha", 13 lakh devotees have visited Ayodhya Dham itself." President Murmu said that there is "unprecedented expansion" of facilities at pilgrimage sites in every part of the country. The government "also wants to make India a leading destination for meetings and exhibitions related sectors. For this, facilities like Bharat Mandapam, Yashobhooni have been created. In near future, tourism will become a major source of employment", she added.

## SC imposes Rs 12 lakh cost on 6 Maharashtra cops for illegally detaining three persons

The Supreme Court has imposed a cost of Rs 12 lakh on six Maharashtra Police personnel for conspiring and abetting illegal detention of three persons and getting their rented property demolished without any court order.

"Out of the six police personnel, three are constables, one is a Head Constable, one is a Sub Inspector, and one is an Inspector. They shall suffer a cost of Rs 50,000 per constable, Rs 1 lakh by the Head Constable, Rs 1.50 lakh by the Sub-Inspector, and Rs 2 lakh by the Inspector, totalling Rs 6 lakh for each case with the above distribution," said a bench of Justices Vikram Nath and S.C. Sharma.

The bench said that this amount will be deposited within 4 weeks in the Armed Forces Battle Casualties Welfare Fund and thereupon,



the proceedings of the two complaint cases will stand closed. If the proof of deposit is not filed within the stipulated time, the petitions filed before the Supreme Court by the police personnel would stand dismissed, it added.

On March 9, 2022, three tenants were held for about 24 hours in the police station and in the meantime, their rented premises were demolished by relatives of the former owner with the support of the local police.

At the police station, the

tenants were also forced to sign some documents, apparently giving their consent to vacate the premises voluntarily. Thereafter, two tenants moved an application before a Magistrate for registration of FIR against relatives of former owner, subsequent purchasers, and six police personnel namely, Shatrughna Atmaram Patil, Jaipal Manikrao Hire, Milind Ashok Bhamare, Suryakant Raghunath Salunkhe, Nilesh Subhash More, and Sunil Kautik Hatkar.

## Andhra to introduce syllabus of Geneva-based education body in govt schools

The Andhra Pradesh government on Wednesday signed an MoU with the Switzerland-based International Baccalaureate (IB) in introducing IB curriculum in government schools.

The IB syllabus will be first introduced to students of class I from the academic year 2025-26 and as they are promoted to upper classes every year, they would be learning the upgraded lessons making IB part of all classes in government schools by 2035 and IB syllabus would be taught to students of Class XII in 2037.

School Education Principal Secretary Praveen Prakash and Chief Education Officer (Director of Education Innovation) of IB Anton Beguin exchanged MoU copies in the presence of the Chief Minister Y.S. Jagan Mohan Reddy at the Camp Office here. Speaking on the occasion, the Chief Minister said that it is a great satisfying



programme as it paves way for integrating IB syllabus and practices with the syllabus of students of Classes I to XII. In countries like India, quality education is necessary for students to make them competitive at the global level, he said, adding that the MoU with the IB offers a good future and helps them get high-paid jobs in the ever-competitive job market. Compared to the western countries, it is necessary to upgrade the present educational system and syllabus in India for enhancing problem solving abilities of students, the Chief Minister said, adding that IB curriculum integration with the school syllabus would help achieve

this objective. As per the MoU, IB experts will impart training to teachers in government schools, education department officials at mandal and district level, officers and staff of the SSC and Intermediate Boards and APSCERT in handling IB syllabus. This will make them part of the IB global teaching network. A new journey has begun and it helps set a new standard in the educational system, he said. IB Director General Olli Pekka Heinonen, who participated in the programme virtually from Geneva, said this is their biggest MoU of its kind and it would be an inspiration for other countries and regions.

# AAP, Congress protest over 'rigging' in Chandigarh mayoral polls

Leaders of the Aam Aadmi Party (AAP) and the Congress protested outside the Sector 17 police station here on Wednesday against the alleged rigging in the Chandigarh Municipal Corporation's mayoral elections.

They demanded the police to register a case against Anil Masih, the presiding officer appointed for the elections.

In their statement, the councillors and leaders of both the parties accused the BJP of rigging the elections, saying Masih deliberately cancelled the votes of eight councillors so that the BJP could make their mayor.

AAP leader Sunny Ahluwalia met the SHO, demanding to register a case against the presiding officer, handed him video clips and other materials related to 'rigging' in the elections.

Later, he met the Senior



Superintendent of Police and demanded immediate action against Masih.

Ahluwalia told the media that the BJP "is the biggest threat to our country's democracy", adding that as per the strategy, the BJP managed all officials related to the elections and made its mayor by rigging the polls.

He said all AAP and Congress councillors have submitted an affidavit in the Punjab and Haryana High Court stating that they voted for Kuldeep Kumar Tita as the mayor.

"We will continue our fight until the wrongfully appointed mayor steps down," he added.

Meanwhile, the high court has issued a notice to the corporation and the local administration, seeking their reply within three weeks.

Both AAP and the Congress have appealed to the high court to hold fresh mayoral elections.

## Smuggled in from Myanmar, drugs worth Rs 30 cr seized in Mizoram; 2 held

The Assam Rifles along with other law enforcing agencies in separate raids have recovered drugs worth over Rs 30.17 crore in Mizoram and apprehended two drug peddlers, officials said on Wednesday.

The Assam Rifles along with the officials of Special Narcotics Police Station, CID (Crime), recovered 34.99 gm heroin valued at Rs 17.49 lakh from the Zembawak area in Aizawl and apprehended one person on Tuesday night. In another operation, the para-military personnel accompanied by other officials recovered over one lakh highly-addictive methamphetamine tablets worth Rs 30 crore from the Zokhawthar bordering



Champhai district on Tuesday night and arrested one drug trafficker. The recovered drugs and the accused persons have been handed over to the police for necessary legal proceedings under the Narcotics Drugs and Psychotropic Substances (NDPS) Act 1985. An Assam Rifles statement said that the ongoing smug-

gling of illegal drugs is a major cause of concern for the state of Mizoram and India. Officials said that the methamphetamine tablets smuggled in from Myanmar have been one of the most trafficked drugs in recent years, which have huge demand in northeastern states, and other parts of India and neighbouring Bangladesh.

# Tejashwi is a child, he does not know anything about Bihar: Nitish Kumar

Bihar Chief Minister Nitish Kumar, without taking the name of Tejashwi Yadav, said that he is a child who does not know anything about the state.

After his exit from the INDIA bloc, Nitish Kumar for the first time interacted with media persons and slammed RJD leader Lalu Prasad Yadav and the Rabri Devi government.

"There was nothing in Bihar. No roads were available before 2005 and people used to walk to their destinations. People were not stepping out in the evening due to crime. I have done development work after coming to power in 2005. Today, you are travelling on roads, you are seeing buildings. Who did it? It is I. Tejashwi was a child who did not know anything," Kumar said.

Speaking on the jobs given to teachers in 17 months of the Mahagathbandhan government in



Bihar, Nitish Kumar said: "All he (Tejashwi Yadav) is claiming is absolutely rubbish. He is taking credit for teacher recruitments but he does not know anything. His claim is false. It was my vision to give jobs under 'Saat Nischay Part 2 programme,'" Kumar said.

Reacting to Congress leader Rahul Gandhi's

claim that he forced Kumar to conduct a caste based survey in Bihar, Nitish Kumar said: "This is an absolutely false claim. He is taking the credit for the caste based survey. We were planning for the caste based survey since 2019-20. We held an all-party meeting and then went to Prime Minister Narendra Modi to meet him on this issue. He said that the Centre would not conduct the caste based census but you are free to do it. Hence, we have conducted this survey." When asked about the action against the Lalu Prasad Yadav family, Nitish Kumar said: "This is an old case and the questioning is taking place here. I am just watching the news. No one informed me about it. It is a matter at the higher level (Centre)." Nitish Kumar also spoke about leaving the INDIA bloc, saying: "I suggested to them another name for the alliance but they did not accept it. They had not done anything on the alliance."

### Approval of Rs 164 crore 49 lakh for superspeciality hospital under Medical College, Rewa. Decisions of the Council of Ministers under the chairmanship of Chief Minister Dr. Yadav

The meeting of the Council of Ministers was held in the Ministry under the chairmanship of Chief Minister Dr. Mohan Yadav. The Council of Ministers has decided to amend the Madhya Pradesh Start-up Policy and Implementation Plan, 2022. According to the amendment, start-ups of the state will be provided financial assistance for participation in national and international events. On participation in domestic events, reimbursement of 75% of the expenditure incurred per event up to a maximum of Rs 50 thousand will be given and on participation in events outside the country, 75% of the expenditure incurred per event up to a maximum of Rs 1 lakh 50 thousand will be reimbursed. A start-up will be given assistance maximum 1 time in 1 financial year and maximum 2 times in the entire lifetime. The Council of Ministers gave revised administrative approval of Rs



164 crore 49 lakh for the expansion of the Superspeciality Hospital under the Medical College, Rewa. Additional sanction of Rs 25 crore 31 lakh has been given for the expansion

of Super Specialty Hospital Rewa. This amount will be spent on construction of new ICU beds, cath lab, private ward and purchase of furniture etc. It is noteworthy that earlier

approval of Rs 139 crore 18 lakh was issued for the construction of superspeciality hospital under Medical College, Rewa. Now it has increased to Rs 164 crore 49 lakh.

Giving this information on its In the BJP government, illegal mining will be curbed in Madhya Pradesh with the help of AI technology. Here, in Bhand district of Chambal division, challenging the government and administration, illegal mining of sand was started after performing regular puja. Here, sand is being extracted illegally from the Sindh River at the Indurkhi mine. This area comes under Raun police station area. On Tuesday evening, the Machand Chowk police team which had come to arrest the tractor-trolley which was illegally transporting sand was attacked by the sand mafia. Outpost in-charge SI Kamalkant Dubey has suffered a head injury. The sand of Sindh river found in Indurkhi village of



Bhand district is considered good for building construction. This sand mine has not been tendered for the last two years, but the mine has not been closed. The mafia secretly extracts sand from here and sells it. Local people say that the mafia has got political protection.

There are about 72 sand mines on the Sindh river in Bhand district. These mines are to be tendered. Tenders have also been called by the Mineral Department, but till now the tenders of any company have not been opened. Meanwhile, the revenue generated by the administration and the gov-

ernment due to illegal sand extraction is being affected. The police of Raun police station of Bhand was attacked by the sand mafia on Tuesday evening. The Machhand outpost in-charge was assaulted. He got hurt. An attempt was made to snatch a rifle from a constable. Machhand outpost in-charge SI Kamalkant Dubey had reached Tehanpur Ghat in Dohai and Nayagaon area on the information of illegal transportation of sand. He had received information that a tractor-trolley was taking out sand from the Sindh River illegally. As soon as the police arrived, the mafia attacked. The number of accused was high. There were only 5 to 6 soldiers in the police team. Machhand outpost in-charge has suffered a head injury. After the incident, Raun, Machand and Umri police stations have become active. Police have started searching for the accused everywhere. Some family members of the accused have also been detained by the police.

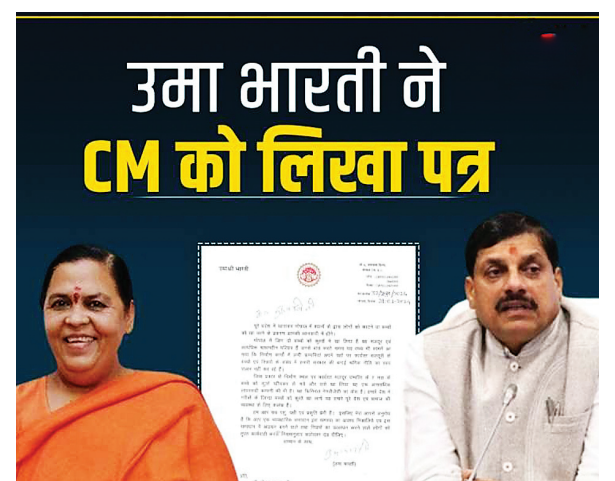
## SCHOOLS WILL NOT START IN BHOPAL BEFORE 9.30 AM

**NIKKI HALEY HOPES TO STOP TRUMP'S BULL RUN IN THE PRESIDENTIAL GOP PRIMARY**

Nikki Haley, the fiercest challenger to ex-president Donald Trump in the GOP 2024 primary, banks on the most unlikely ally, Democrats, who might flip, to vote for her on her home turf South Carolina, to stop Trump's bull run in the presidential race.

Nikki Haley, the former UN ambassador appointed by Trump himself, will try to slow down Trump's seemingly inevitable march toward the GOP nomination. Haley is banking on a bloc of home state voters she's never needed to court before, the Democrats, media reports said.

Trump's absolute dominance in the Iowa primary, narrow win in New Hampshire, seems to have instilled an aura of invincibility around his primary campaign. Haley hopes to pierce that and salvage an sense of viability past South Carolina, and she is planning to expand her coalition beyond anti-Trump Republicans and independent-minded voters - a task that would almost certainly include at least small pockets of Democrats not sold on re-electing President Joe Biden or those willing to switch sides to try to stop Trump from getting the GOP nomination, NBC reported.

The political maths is being made more complicated by the incentive for Biden and Democrats to generate a "monster turnout" after making South Carolina the party's first sanctioned nominating contest, and there is less evidence of any cross voting in the Palmetto State.

"Democrats do not vote in Republican primaries here, just like Republicans won't vote in Democratic primaries," said former South Carolina Republican Party Chairman Katon Dawson. "We tried and tried and tried, I spent money doing it. We found there was not much there. Haley says she does not 'have to win' her home state of South Carolina but needs 'momentum'. In both New Hampshire and Iowa, Haley faced criticism from opponents that she was targeting Democrats to offset her disadvantage with Republican primary voters, an idea her campaign has rejected. Officials have not, however, disputed that they are trying to expand the Republican base.

"The Republican Party has to be a story of addition again, not subtraction. Trump lost races we should have won in 2018, 2020 and 2022," Haley spokeswoman Olivia Perez-Cubas said. "If Republicans want to start winning again, we have to start bringing in new voters, including conservatives, independents and Democrats who are fed up with Joe Biden."

Some Republicans feel there are still three



weeks between the Democrats' primary on Saturday and the Republicans' February 24 primary that creates a unique opportunity for Haley to pick up voters who might not ordinarily vote in a GOP primary. In South Carolina, people can vote to take part in either party's primary. So if a voter does not cast a ballot in the Democratic primary, Haley's team will have three weeks to crunch the numbers and come up with a plan to target the exact set of voters who have yet to vote in the state, NBC said. "Haley should absolutely look to turn out every voter possible in the primary, and with the democratic Presidential Primary being held three weeks prior, there should be ample time to identify those who did not vote in the primary and encourage them to vote in the Republican Primary," said Alex Stroman, a former executive director of the South Carolina GOP.

He said South Carolina not requiring party registration "gives us the best candidates to win general elections." Haley needs to juice turnout among those independents, moderates and true Republicans to improve on her results in New Hampshire and launch her into Michigan and then Super Tuesday states," Stroman said referring to the March 5 round of primaries in 16 states.

Jay Parmley, executive director of the South

Carolina Democratic Party, said they have heard from some Democrats planning to vote for Haley. "Yeah, we have heard that is happening. It might be smart for Haley, but it's stupid for Democrats to vote in the Republican primary," he said. "She is just as bad as Donald Trump. My call to Democrats is, 'If you didn't vote for her as governor, why you would vote for her as nominee?'" "We are doing everything we can to talk to Democrats and get them to vote. Now we have some saying they may vote for Haley to try and stop Trump," Parmley added. "That's just stupid." Haley has portrayed herself as the eager beaver politician ready to take head on the establishment in both political parties, an opportunity she has in her home state. Both the Biden and Trump camps have signalled to Haley to drop out so that they can turn their focus to a general election matchup they view as already set. On the night of the New Hampshire primary, Biden said in a statement that it is "now clear" that Trump will win the GOP nomination.

Democratic strategists say they expect many of their party's voters to cast ballots for Biden on Saturday, making them ineligible to participate in the Republican primary three weeks later. Moreover, there's little love lost between Haley and Democrats in the state she gov-

erned from the political right. "There is no major effort by Democrats to vote for Nikki Haley. She was not good for us when she was governor. So there's no need to think she would be good for us as president," said Clay Middleton, a long-time Democratic operative who is serving as a senior adviser to the Biden campaign in South Carolina.

"Our goal as a campaign is to make sure that we contact voters and show them, remind them, what the president has done for South Carolinians and for African Americans, in particular, and show that appreciation by voting on February 3."

Middleton noted that Biden, Vice President Kamala Harris and "a slew" of top surrogates have visited the state in recent weeks, a group that includes Democratic National Committee Chairman Jaime Harrison, a South Carolina native, California Gov. Gavin Newsom and Rep. Ro Khanna, D-Calif. Biden spoke at a 'First in the Nation' dinner Saturday in Columbia, which highlighted his decision to make South Carolina's primary the opening contest on the party's calendar.

**ISRAELI ATTEMPT TO CONTROL EGYPT-GAZA BORDER 'UNACCEPTABLE': EGYPTIAN OFFICIAL**

Any Israeli attempt to control the Philadelphi Corridor along the border between Egypt and the Gaza Strip is "unacceptable," an Egyptian high-ranking official said.

"No new arrangements have been discussed with Israel regarding the Philadelphi Corridor on the border, and any Israeli unilateral moves in this regard are unacceptable," the unnamed Egyptian official was quoted on Tuesday as saying by Egypt's Al-Qahera News TV.

The remarks came a week after Diaa Rashwan, the chairman of Egypt's State Information Service, warned that Israel's retaking control of the Philadelphi Corridor would violate its 1979 peace treaty with Egypt, Xinhua news agency reported.

The Philadelphi Corridor is a 100-metre wide, 14-km-long buffer zone along the Egypt-Gaza border.

Israeli Prime Minister Benjamin Netanyahu has recently expressed his desire to retake control of the corridor to ensure future demilitarisation of Gaza and prevent the alleged smuggling of



weapons into Gaza through border tunnels. Rashwan also denied last week the Israeli claims about the weapon smuggling from Egypt to Gaza. The Rafah border crossing between Egypt and Gaza

has been a major lifeline to provide humanitarian aid to the Palestinians in the war-ravaged enclave, which has witnessed relentless Israeli bombings and a massive military offensive since October

7 last year. The Israeli attacks in Gaza have so far killed 26,751 Palestinians and wounded 65,636 others, according to data released by Gaza's Health Ministry on Tuesday.

**Imran Khan, Bushra Bibi sentenced to 14-year imprisonment in Toshakhana case**

An accountability court on Wednesday sentenced former Pakistan premier Imran Khan and his wife Bushra Bibi to 14 years imprisonment in the Toshakhana case, local media reported.

The verdict comes a day after the PTI founder was sentenced to 10 years imprisonment in the cipher case by a special court established under the Official Secrets Act.

Accountability court judge Mohammad Bashir presided over the hearing at Rawalpindi's Adiala jail, where the former Khan is incarcerated, The Express Tribune reported.

Imran and Bushra were also barred from holding any public office for the next 10 years and were fined around Rs1,574 million, The Express Tribune reported. The judge also asked the two to record their statements under Section 342 of the Code of Criminal Procedure and closed the right of cross-examination of the prosecution witnesses.



The couple were indicted in the reference on January 9.

Reacting strongly to the verdict, the PTI termed it as "complete destruction of every law" and claimed the former premier and first lady, have faced

"yet another kangaroo trial".

The party further said no right of defence was given to either Imran or Bushra and the case has "no basis" to stand on in any higher court, similar to the cipher trial.

**US FIGHTER JET CRASHES OFF S.KOREA'S WESTERN COAST; PILOT RESCUED**

Seoul: A US F-16 fighter jet crashed in waters off South Korea's west coast on Wednesday and a pilot was rescued after ejecting from the aircraft, multiple sources said. The fighter jet fell in waters near Gunsan, 274 km south of Seoul, at around 8:40 a.m., sources familiar with the matter said.

Gunsan is home to the US Air Force's Kunsan Air Base, which operates F-16 aircraft, Yonhap news agency reported. "The fighter jet crashed into the water and the rescued pilot is safe," the source said, asking for anonymity.

**Indian national sentenced for nearly \$2.8mn healthcare fraud in US**

New York: A 43-year-old Indian national in the US state of Michigan has been sentenced to nine years in prison for orchestrating a nearly \$2.8 million healthcare fraud.

Yogesh K Pancholi from Northville was also found guilty of wire fraud conspiracy, engaging in money laundering, aggravated identity theft, and witness tampering.

According to court documents and evidence presented at trial, Pancholi owned and operated Shring Home Care Inc, a home health company based in Livonia, Michigan, a Department of Justice release said.

Despite being excluded from billing Medicare, Pancholi purchased Shring using the names, signatures, and personal identifying information of others to conceal his ownership of the company.

In a two-month period, Pancholi and his co-conspirators billed and were paid nearly \$2.8 million by



Medicare for services that were never provided.

Pancholi then transferred these funds through bank accounts belonging to shell corporations and eventually into his accounts in India.

After being indicted, and on the eve of trial, Pancholi, using a pseudonym, wrote false and malicious emails to various federal government agencies.

In those emails, he alleged a government witness

had committed various crimes and should not be allowed to remain in the US in an attempt to keep the witness from testifying.

In September 2023, a federal jury in the Eastern District of Michigan convicted Pancholi of conspiracy to commit healthcare and wire fraud, two substantive counts of healthcare fraud, two counts of money laundering, two counts of aggravated identity theft, and one count of witness tampering.

Pancholi's case was investigated by the FBI Detroit Field Office and the Department of Health and Human Services Office of the Inspector General (HHS-OIG).

The Justice Department's Criminal Division has been making efforts to combat healthcare fraud through the Health Care Fraud Strike Force Program.

Since March 2007, this program, currently comprised of nine strike forces operating in 27 federal districts, has charged more than 5,400 defendants who collectively have billed federal healthcare programs and private insurers more than \$27 billion.

**Australia sees 40% rise in sexual assault cases since 2013**

Australia has recorded 40 per cent rise in sexual assault cases since 2013, a government report said.

In an annual report published on Monday, the federal government's principal review body, the Productivity Commission, said that 123.7 out of every 100,000 Australians reported being sexually assaulted to police in 2022, an increase of 42.8 percent from 86.6 out of every 100,000 people in 2013, Xinhua news agency reported.

The highest numbers of such cases were reported from New South Wales, the largest of Australia's states and territories, with 152.2 out of every 100,000 people having made

complaints to police in the state in 2022, more than double the 71.2 out of every 100,000 people in the Australian Capital Territory. The national rate of armed robbery reports fell from 24.3 out of every 100,000 people in 2013 to 18.1 in 2022, and homicide rate fell slightly from 1.9 victims per 100,000 people to 1.6 in the same period, the report said. Mark Dreyfus, Australia's attorney-general, said the inquiry would look into how the government can improve the justice system experiences of victims and survivors of sexual assault.

In January, the federal government announced an Australian Law Reform Commission review into justice system responses to sexual violence.

164 crore 49 lakh for the expansion of the Superspeciality Hospital under the Medical College, Rewa. Additional sanction of Rs 25 crore 31 lakh has been given for the expansion

of Super Specialty Hospital Rewa. This amount will be spent on construction of new ICU beds, cath lab, private ward and purchase of furniture etc. It is noteworthy that earlier

approval of Rs 139 crore 18 lakh was issued for the construction of superspeciality hospital under Medical College, Rewa. Now it has increased to Rs 164 crore 49 lakh.

Outpost in-charge SI Kamalkant Dubey has suffered a head injury. The sand of Sindh river found in Indurkhi village of



Bhand district is considered good for building construction. This sand mine has not been tendered for the last two years, but the mine has not been closed. The mafia secretly extracts sand from here and sells it. Local people say that the mafia has got political protection.

There are about 72 sand mines on the Sindh river in Bhand district. These mines are to be tendered. Tenders have also been called by the Mineral Department, but till now the tenders of any company have not been opened. Meanwhile, the revenue generated by the administration and the gov-

ernment due to illegal sand extraction is being affected. The police of Raun police station of Bhand was attacked by the sand mafia on Tuesday evening. The Machhand outpost in-charge was assaulted. He got hurt. An attempt was made to snatch a rifle from a constable. Machhand outpost in-charge SI Kamalkant Dubey had reached Tehanpur Ghat in Dohai and Nayagaon area on the information of illegal transportation of sand. He had received information that a tractor-trolley was taking out sand from the Sindh River illegally. As soon as the police arrived, the mafia attacked. The number of accused was high. There were only 5 to 6 soldiers in the police team. Machhand outpost in-charge has suffered a head injury. After the incident, Raun, Machand and Umri police stations have become active. Police have started searching for the accused everywhere. Some family members of the accused have also been detained by the police.

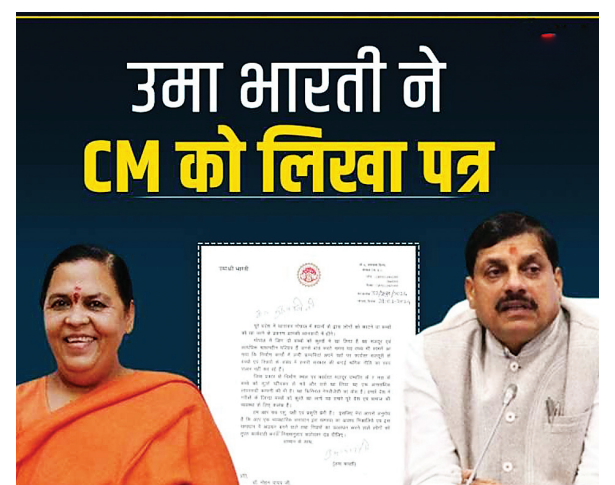
## SCHOOLS WILL NOT START IN BHOPAL BEFORE 9.30 AM

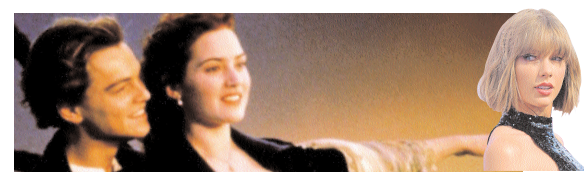

Walk Team Championships to be held in Antalya, Turkey.

During the Turkey competition, top 22 teams will get automatic qualification for the Olympic Games. The final selection of the national team for Turkey will be done in March. In the men's 10km event, Sahil of Punjab out-classed more experienced athletes to claim gold. Sahil, 22, a college-going student from Patiala clocked 39:25.00. He had finished fifth in the

men's 20km race walk on Tuesday. Paramjeet Singh Bisht of Uttarakhand was second with a time of 39:36.00, while Asian bronze medalist Vikash Singh of Delhi was third with a time of 39:47.00.

Goa's Vijay Omkar Vishwakaram won the men's 35 km race with a time of 2:39:19.00, while the women's 35km gold went to Bandana Patel of Uttar Pradesh, whose gold-medal winning time was 3:11:06.00.

## 'I won't quit': Murray hits back at suggestion 'tarnishing his legacy'

Former world No. 1 Andy Murray has staunchly dismissed suggestions that he is tarnishing his legacy and affirmed his determination to continue fighting on the court.

Murray, currently facing a winless streak in ATP Tour since October 2023, has faced recent setbacks, including first-round exits in the Brisbane International, and Australian Open. At 36, Murray's recent form has prompted speculation about the future of his tennis career. However, the three-time Grand Slam champion remains resolute, asserting that he won't quit the sport despite the difficult phase he is currently experiencing. Responding to an article questioning whether he should consider calling time on his career, Murray expressed his determination on social media platform X (formerly Twitter). "Tarnishing my legacy? Do me a favour," Murray declared. "I'm in a terrible moment right now, I'll give you that. Most people would



quit and give up in my situation right now. But I'm not most people, and my mind works differently. I won't quit. I will keep fighting and working to produce the performances I know I'm capable of. "The sentiment was echoed by former world No. 1 Andy Roddick, who offered support to Murray, emphasizing that accomplishments and legacy endure beyond transient challenges. "Preach! Imagine telling an accomplished iconic adult your opinion on what they should choose for work and when they should do it. Can't take a legacy away. accomplishment lives forever," Roddick remarked. Murray has faced a tough stretch, losing eight of

his last nine matches, and there's a possibility he could drop out of the top 50 in the ATP rankings. While acknowledging the difficulties and expressing concerns about his recent performance, Murray remains committed to the sport. He disclosed that there's a "definite possibility" he might not play in Grand Slam events again after his first-round exit at the Australian Open but acknowledged the need for improvement in his game. "If I play like today, I won't win many matches playing that way," he added. "Practice is not the same thing, I'm totally aware of that. I also know what good tennis is, and played well before."

## Para swimmer Shams Aalam set two national records, wins six medals at Reykjavik International Games

Laugardalslaug (Iceland), Jan 31 (IANS) Indian para swimmer Shams Aalam Shaikh emerged victorious on the international stage, clinching a remarkable six medals and setting two national records at the Reykjavik International Games.

At the Reykjavik International Games, Shams shattered expectations by setting new national records in the 100m butterfly and 100m backstroke S5 events. His stellar performances in the pool showcased not only his physical prowess but also the indomitable spirit that propelled him to overcome significant obstacles. Shams Aalam Shaikh's medal tally at the event included one gold, two silver, and three bronze medals, a testament to his exceptional skill and tenacity. His achievements in Iceland add to an already illustrious career that includes representation of India at prestigious events such as the Asian Para Games in 2018 in Jakarta, Indonesia, and the 2022 World Para Swimming Championships in Madeira, Portugal. Hailing from Rathos Village in Madhubani District, Bihar, the 24-year-old athlete faced a formidable challenge early in life when a benign tumor in his lower back immobilized his lower half, despite unsuccessful surgeries. Undeterred by the tragedy, Shams, along with his parents, shifted base to Mumbai, where he found sol-



ace and purpose in swimming. This journey marked the beginning of an extraordinary saga of determination

and triumph over adversity. In a noteworthy feat in 2017, Shams broke the record for the longest open-sea swim-

ming by a paraplegic, covering an impressive 8km in four hours and four minutes along the shores of Goa.

## Avani, five others all set for Women's Amateur Asia Pacific

As Avani plays her fourth WAAP, Vidhatri and Mannat are making a second appearance and the remaining three are debutants. Incidentally, Heena's sister, Ceerat, played in the 2022 edition at the same course.

As per the list of players entered this week, Avani is one of the top 10 stars. Some of the players ranked above the World No. 42 Avani, are World No. 4 Minsol Kim of Korea, Japan's Hinano Muguruma (22), Sayaka Teraoka (23), Mamika Shinchi (33), Rin Yoshida



(38) and defending champion from Thailand Eila Galitsky (40th). Rianne Malixi of the Philippines is 43rd.

Avani, who has been planning to turn pro at some point in 2024, has had some success in 2024 with a second place finish at the Australian Masters of Amateurs and is a winner of the Queen Sirikit Cup in 2023 and was fourth at World Amateur Team Championships. She also won a pro event in Europe and was in Top-10 at numerous Ladies European Tour events, including the Hero Women's Indian Open in 2023. After the WAAP, Avani has been invited to play at the Magical Kenya Ladies, then the Sage Valley Invitational and Augusta National Women's Amateur. Avani has played at both events in the past.

## Jack Leach doubtful for England's second Test against India due to knee injury

England's left-arm spinner Jack Leach is highly doubtful for playing in the second Test against India, starting in Visakhapatnam on Friday, after sitting out the side's first training session held on Wednesday.

Leach jarred his left knee while fielding during England's thrilling 28-run win over India in the series opener at Hyderabad last week. He aggravated the injury later on in the same match, bowling with a swollen joint and took out the wicket of Shreyas Iyer in the second innings.

"He's a tough kid, Leachy, so I'm not sure. You can never really write him off. We'll see how he pulls up in a couple of days," said opening batter Zak Crawley to reporters.

Leach's injury means England may not be able to execute their plan of playing four spinners in Visakhapatnam, with uncapped off-spinner Shoab Bashir likely to get a debut in case the senior spinner is not fit in time for the second Test.

Bashir has played just six first-class matches and has 10 wickets to his name. He arrived in India during the Hyderabad Test after visa issues owing to his Pakistani heritage forced him to return home to London and get the visa there. "He's a great kid, he's got a lot about him. He knows what he is trying to do with his bowling, and he



backs himself. I like that and feel like if he got his chance in this series he would go well," added Crawley.

Though England have a 1-0 lead in the five-game series, but Crawley, who was a member of the 2021 touring party winning the opening game in Chennai, before suffering a slide to lose the series 3-1, isn't taking India lightly. "Whoever they pick, they're going to be a very good team. They're a top side in their own conditions. There are four games left and we need to stick to what we do well. Hopefully the results come from there but we're not getting too far ahead of ourselves. We're preparing for this one like it's the first game, we're staying where our feet are and we'll see where that takes us."

India will be missing the services of KL Rahul and Ravindra Jadeja due to injuries, but Crawley stated England are focused on what they need to go for getting things right in Visakhapatnam.

"We haven't spoken about that, to be honest. As I said, it sounds a cliché, but we stick to what we do well, we're not too worried about what they're doing. Two very good players missing, but I'm sure looking at their depth, they've got two very good players coming in. So that won't change anything for us too much."

"We just try and play the same, read the conditions on day one and see what happens from then. They're absolutely a top side in their own conditions. There are four games left, we have got to stick to what we do well and hopefully results come from there," he said.

## Vishnu Saravanan secures India's first Paris 2024 quota in sailing

Indian sailor Vishnu Saravanan secured the country's first Paris 2024 Olympics quota in sailing at the ILCA World Championship 2024 in Adelaide, Australia.

Competing in the one person dinghy event at the Adelaide Sailing Club, Saravanan accumulated 125 nett points over six days and secured the 26th position on the overall leaderboard. Notably, he claimed the fifth spot among eligible sailors to secure quota place for the Paris Olympics.

"Vishnu Saravanan has secured India's 1st #ParisOlympics quota in Sailing at the ILCA 7 World Championship, held in Adelaide.

"Clinching one of the 7 Olympic quotas available at the event, #TOPScheme Athlete Vishnu outsailed many Asian sailors to finish 26th overall and secure the Paris berth," Sports Authority of India shared the post on X.

In the 2023 World Sailing Championships held last year, Saravanan narrowly



missed securing a spot for the Paris Olympics. Finishing 23rd in the overall race standings, he fell just seven places short of obtaining one of the 16 Paris quota places available. The ILCA 7 Men's World Championship served as a qualifying event for Paris 2024 with seven quotas on offer for countries which had not qualified for the Olympics earlier.

The other six quotas on offer at the Adelaide meet went to Guatemala, Montenegro, Chile, Denmark, Turkey and Sweden. Last year, the 24-year-old won the bronze medal at the Asian Games in Hangzhou in the same sailing category.

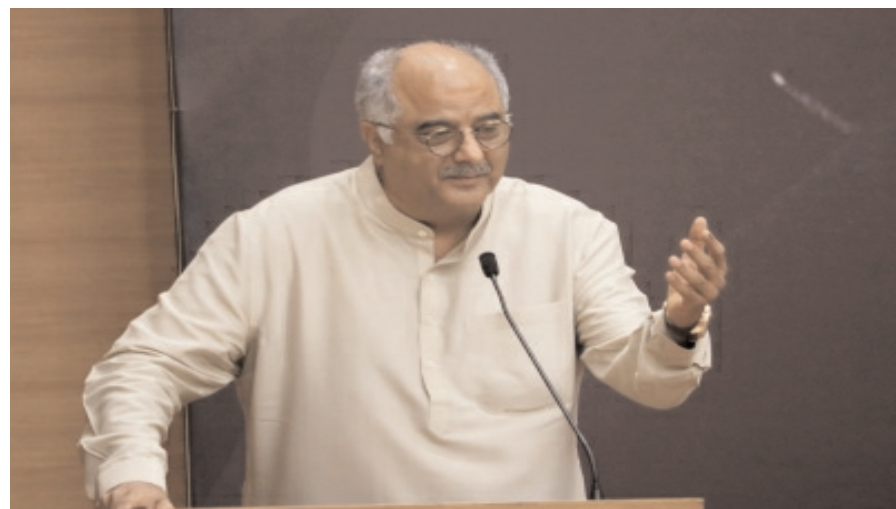
## Kareena Kapoor wishes 'queen of hearts' Amrita Arora on 43rd b'day

Arun Vir Singh, Chief Executive Officer, YEIDA, said, "Following the guidelines of the public-private partnership, the proposed bids will be presented before the committee of secretaries, and subsequently, they will be forwarded to the state government cabinet for

the necessary approvals."

"Once the Cabinet gives its approval, the highest bidder will receive the letter of award," Singh added.

"We are pleased to be chosen and are eager to commence work at the site once all necessary procedures are completed. Our goal is to develop the Film City project within a span of three years. In the initial phase, we plan to develop commercial facilities on 75 acre out of the total 230 acre," said Ashish Bhutani, Chief Executive Officer of Bhutani Group.

On November 23, 2021, YEIDA issued a global tender for the Film City developer selection; however, no one came forward to take up the project.

In response, YEIDA revised the Detailed Project Report, and on November 7, 2022, a second global tender was issued, with no interest shown this time as well.

On September 30, 2023, YEIDA issued the tender for the third time, setting January 5, 2024, as the last date for bid submissions.

Subsequently, on January 27, YEIDA opened the technical bids, qualifying four companies and paving the way for the opening of the financial bid on Tuesday (January 30).
