he death toll has risen to eleven and 167 are injured in a massive fire that broke out following multiple explosions at an

illegal firecracker factory in Madhya Pradesh's Harda district. Many injured have been taken to various hospitals. Police along with locals rescued several

persons living nearby the factory. As per the information, at least 100 homes located near the factory have been vacated to ensure the safety of people.

The incident occurred at the firecrackers factory located in Bairagarh villege in Harda district, around 150 km from Bhopal. A green corridor has been set up to rush the injured persons to AIIMS and Hamidiya hospital in



Bhopal.

Treatment of 142 injured is going on in Harda District Hospital, 25 in AIIMS of Bhopal and Narmadapuram Hospital. Relief and rescue operations are underway. Fire brigade vehicles have been called from the surrounding area to control the fire. Similarly, a green corridor was also made

persons were rushed to different hospitals. At present, the the state government was unclear about the exact number of casualties in the incident.

However, reports suggested that several persons burnt alive and bodies were spotted on road outside the factory. The fire broke out at 11:30 a.m. on Tuesday, and effort to douse the blaze was still going on at the time of going for print. Chief Minister Mohan Yadav chaired an emergency meeting with senior officials and has passed necessary instructions regarding this. Minister Uday Pratap Singh along with some senior officials has been sent to Harda, CMO said in an official communication.

State Chief Minister Dr. Mohan Yadav wrote on Twitter regarding this accident, 'Received very sad news of fire in firecracker factory in Harda. Minister Uday Pratap Singh and senior officials are reaching the incident site. He has asked the Medical Colleges in Bhopal and Indore and the Burn Unit in AIIMS Bhopal to make necessary preparations to provide better treatment to those burnt and injured in this accident. Besides, fire brigades are also being sent from Indore and Bhopal.

After the explosion of firecrackers in the factory and the fire taking a huge form, many nearby houses have also come under the grip of this fire. Not only this, the bricks and stones thrown from the houses in the area around the factory also hit the people passing through the streets. Many people were also seen unconscious on the road. Relief and rescue work is going on at the accident site. More than a dozen JCBs are engaged in removing the debris, while fire brigade vehicles are deployed to control the burning fire and rising smoke at various places.

IRAN WAIVES VISA REQUIREMENT FOR INDIAN TOURISTS

New Delhi: Indian tourists do not need a visa for visiting Iran with a new policy coming into effect from February 4, according to a statement issued by the Embassy of Iran here on Tuesday.It is important to note that the 15-day period cannot be extended, the statement clarified. The visa-free entry applies only to individuals entering Iran for tourism purposes. Indians who visit Iran for business or educational purposes would have to apply for visa under the respective categories. Those who want to visit Iran more than once within the six-month time span will have to obtain a visa. The statement also made it clear that the visa-free entry would be applicable only to those Indian tourists who arrive in Iran by air. Those coming to Iran via the land route through Turkey, Afghanistan, Pakistan or any neighbouring nation would not be allowed to enter without a prior visa.Iran now joins the list of countries like Thailand, Malaysia, Sri Lanka and Vietnam, which have recently waived visa requirements for Indian visitors.

HARDA FIRECRACKER FACTORY **OWNER ARRESTED IN RAJGARH**

Bhopal: Rajeev Agrawal, who is the owner of the Harda firecrackers factory has been arrested in Rajgarh. Due to his negligence, there was an explosion in the factory and a dozen people lost their lives. Due to his negligence, hundreds of people suffered lifelong pain. The officers remained kind to him and he continued running the factory without permission.

So far 11 people have died in the blast in the firecracker factory of Harda. Many people are injured. The negligence of the administration has come to light in the Harda Blast. His empire is spread over two and a half acres. Hundreds of people lived around two and a half acres of land.

Mumbai: The Sharad Pawar camp on Tuesday described as the "murder of democracy" the Election Commission's decision to declare the Ajit Pawar faction as the real Nationalist Congress Party which it claimed was taken under pressure, whereas ex-Union minister Praful Patel welcomed the ruling.

The Commission also allotted the NCP symbol 'wall clock' to the group led by Ajit Pawar. "This is the murder of democracy. What happened is unfortunate," former Maharashtra minister Anil Deshmukh said. The poll panel gave this ruling under "pressure from above," Deshmukh told a TV channel.

On the other hand, senior NCP leader Praful Patel said the EC ruling proves that the majority of party workers and elected representatives are with Ajit Pawar

First endo-robotic surgery performed at Kochi hospital on 75-yr-old woman

Endo-robotic surgery is the name of the procedure in which the lower part of the head and neck cancer reaching the food pipe is removed using a combination of endoscopic surgery and robotic surgery.

The woman was diagnosed with cancer in the beginning of the food pipe (post-cricoid region). Initially, she took radiation treatment, but the cancer did not respond.

Subsequently, a comprehensive examination revealed no signs of the disease elsewhere in the body.

octors at the VPS Lakeshore hospital here successfully conducted the first ever endo-robotic surgery on a 75vear-old woman.

Robotic technology can play a significant role in reducing the morbidity of head and neck surgery. However, robots



cannot be used for cancer below the voice box, because the

robotic arms cannot reach below it.

But the doctors at the hospital came up with a new surgical method to solve this problem.

Typically, surgical removal of the voice box and food pipe is the course of action in this condition, followed by the reconstruction of the food passage using tissue from other parts of the body. This surgery is known to pose significant challenges to the patient, including loss of the natural ability to speak and eat.

The part of the cancer that the robot couldn't reach within the food pipe was incised using a gastro endoscope, while the upper part was approached from the oral cavity using robotic surgery. The whole cancer-affected area was removed en bloc and intra operative pathology reports were used to confirm the completeness of cancer removal.

Post-surgery, the defect of surgery was reconstructed using tissue from the inner part of the cheek with the help of the robot. This was also a novel approach to reconstruct such defects. The hospital informed that the patient is currently recovering, having regained the ability to talk and drink water. The doctors are optimistic that with some more days of rehabilitation, the woman will be able to eat more comfortably.

"ISN'T THIS SHEER HOOLIGANISM?": ARVIND MP Assembly's budget session begins today **KEJRIWAL ON PROBE AGENCY RAIDS**

elhi Chief Minister Arvind Kejriwal launched an attack on the BJP-led Centre over the Enforcement Directorate (ED) searches of premises of his personal assistant (PA) and others, saying all these actions were aimed at "crushing the Aam Aadmi Party".

In a post on X, Mr Kejriwal said the ED didn't find a single penny, no jewellery or illegal property papers despite a raid that lasted 16 hours.

They raided Manish Sisodia's house, nothing was found there. They raided Satyendra Jain's place, nothing was found there. They raided Sanjay Singh's place, nothing was found there. Can ED enter anyone's house without any reason? Is this not sheer hooliganism?" Kejriwal said.

"It is clear that all these raids and arrests are being done only out of political malice, to harass us, to crush the Aam Aadmi Party. It's been two years since they started investigating. Not a single new penny or any evidence was found," he added.

This country is run by law and the Constitution. India is not anyone's inheritance. This country has 140 crore people. People will never tolerate this kind of hooliganism," the Chief Minister said.

Earlier today, AAP leader and Delhi minister Atishi today also slammed the ED raids on party members' homes, and accused the BJP-led Centre of trying to "scare and silence" the party using probe agencies.



The ED searched premises of Mr Kejriwal's personal assistant Bibhav Kumar and others as part of a probe into charges that bribes generated from "irregularities" in the Delhi Jal Board (DJB) tendering process were routed as election funds to the AAP.

"Yesterday, I posted on Twitter about doing a big expose on the ED today. In response, to threaten AAP and silence the party, the ED has been raiding the residences of people related to the Aam Aadmi Party since 7 am today," Atishi said. "This is the way the BJP is trying to threaten the

AAP and intimidate its leaders to suppress their voices. I would like to tell the BJP and Prime Minister Narendra Modi and their agencies that

AAP is not scared of their threats," she said. Atishi claimed that despite an investigation of two years, ED has not been able to recover anything.

"For the past two years, AAP leaders have been threatened like this. In the name of 'liquor scam', investigating agencies CBI and ED have been raiding AAP leaders now and then in Delhi. But despite such investigations for nearly two years, ED has not been able to find anything," she said.

She recalled how many accused, witnesses, and government witnesses have come forward and told that they were pressured to record their state ments.Responding to her, Union Minister and BJP MP Meenakshi Lekhi launched a sharp attack on the AAP and Mr Kejriwal, ramping up the bitter spat between the two parties over alleged corruption in the city's liquor excise policy and the water development authority.

An apoplectic Ms Lekhi held Prime Minister Narendra Modi up as an ideal for Kejriwal to follow, declaring PM Modi had (when he was Gujarat Chief Minister) "sat for 12 hours answering questions"; the reference was to PM Modi being questioned by a special team investigating the 2002 Gujarat riots.

That is how you face... instead of drama and corruption like Kejriwal," Lekhi thundered.

The Assembly secretariat has received a total 2,303 questions from the legislators from both the ruling BJP and the opposition Congress for the session, while 233 attention seeking proposals are put up before the Assembly. While the Mohan Yadavled BJP government is prepared to set its mark with

several public interest Bills to be presented during the session, the opposition Congress is also set to corner the government on various matters, including farmers issues and the law and order situation in the state. On the eve of the session, the Congress led by its state unit chief Jitu Patwari and leader of opposition (LoP) Umag Singhar, chalked out a plan during a meeting with party legislatures on Tuesday. "However, the decision is taken only on the basis of the strength of MLAs which is sheer injustice done to us and Sharad Pawar. We are moving the apex court and expect its verdict before the Lok Sabha elections are announced," said Patil.

Convict was running firecracker factory in Harda: Congress

It was decided in the meeting that liquor shops in Madhya Pradesh will now be located only one and a half kilometers away from religious places and schools. Before the first budget session of the 16th Assembly of Madhya Pradesh, a cabinet meeting was held under the chairmanship of Chief Minister Dr. Mohan Yadav in Mantralaya. In this meeting, mainly the draft of Vote on Account to be presented by the government in the budget session was discussed. Along with this, the government will also present the second supplementary estimate for the year 2023-24 in the Assembly. said on Monday. Tension further built up as people from Hindu

and Muslim communities came face-to-face, with a large crowd from both sides gathering outside a police station. The incident happened on Sunday. However, quick action by the police brought the

situation under control and prevented an untoward incident in the region where incidents of communal violence were reported in the past too.

It all started after a group of youth belonging to Hindu community allegedly beat up a Muslim tailor on Saturday night.

While the miscreants were beating up a tailor near the mosque, an Imam, who was passing by, tried to stop the fight. The Imam was allegedly pushed by youths who were beating up the tailor.As



the message of the thrashing of Imam spread, numerous people from the Muslim community assembled at a local police station and demanded action.While the people from Muslim community were staging a protest to press their demand to arrest the persons who allegedly thrashed Imam, a video surfaced on social media, which escalated the tension further.

Seeing that, many people from both sides had gathered outside the police station. In a video that

surfaced on social media, a cop was seen confronting an aggressive crowd, warning them to leave the spot otherwise "the police will handle the situation in their own way". The aggrieved crowd from both sides later dispersed. Eventually, four youths, who thrashed the tailor and Imam. were booked under relevant charges and action was assured by the police.

Chief Minister Mohan Yadav on Monday asked the police to take quick action against those who tried to create violence. Subsequently, at least 40 people have been booked.

He has ordered a magisterial inquiry into the matter.Damoh SP Sandeep Sharma said the situation was under control and no further disputes were reported in the last 24 hours in the region. He further said that those tried to take the law in their hands will be punished as per the law.

"Four persons mainly responsible for the situation have been booked under Section 294, 323, 506, 427 and 34 of IPC. Further investigation in the matter is underway," Sharma added.

RSS TO HOLD 6-DAY BRAINSTORMING SESSION IN MP Man gets 30 years in jail for raping girl in temple

pholding the conviction of a man for raping a seven-year-old girl in a temple in Madhya Pradesh in 2018, the Supreme Court has sentenced him to 30 years in jail while noting that his action was barbaric.

The victim girl's grandmother lodged an FIR against the man who was 40 years old at the time of the crime, for kidnapping and raping the minor. The convict took the victim to a temple and committed raped her.

After finding the man guilty, the trial court awarded him the capital punishment under Section 376 AB (rape on woman under 12 years of age) of the Indian Penal Code. The Madhya Pradesh High Court, however, commuted the same to life imprisonment for the remainder of the convict's natural life.

A bench of Justices C T Ravikumar and Rajesh Bindal took into account the present age of the petitioner and the fact that he has already undergone incarceration.

While modifying his sentence, the top court also imposed a fine of Rs 1 lakh on the convict.

Noting how the incident may haunt the victim,



the top court said every visit to any temple may hark back to the unfortunate and barbaric action to which she was subjected to.

"It is noted that if the victim is religious, every visit to any temple may hark back to her the unfortunate, barbaric action to which she was subjected to. So also, the incident may haunt her and adversely impact her future married life," the bench said.

'Then, we are also to take into account the present age of the petitioner and the fact that he has already undergone incarceration. On consideration of all such aspects, we are of the considered view that a fixed term of sentence of 30 years, which shall include the period already undergone, must be the modified sentence of imprisonment, the bench said.

The top court said the High Court had lost sight of the fact that despite conviction under Section 376 (2) (i) and sections of the POCSO Act, no separate sentences were imposed on the man for the offence under the POCSO Act by the trial court, as the capital sentence was imposed on him."In terms of the provisions under Section 376 AB, IPC, when a sentence of imprisonment for a term not less than 20 years which may extend up to life imprisonment is imposed, the convict is also liable to suffer a sentence of fine which shall be just and reasonable to meet the medical expenses and rehabilitation of the victim which we quantify as Rs 1 lakh and the same shall be paid to the victim," the bench said.

How childhood trauma affects brain?

Researchers have found how childhood trauma affects brain development and rewires vital pathways, a finding that may pave the way for treatments. The team from University of Essex in the UK uncovered a disruption in neural networks involved in self-focus and problem-solving. The findings, published in the journal **Biological Psychiatry: Cognitive Neuroscience** and Neuroimaging, suggests that those under age 18 who have experienced abuse will likely struggle with emotions, empathy and understanding their bodies. "Currently, sciencebased treatments for childhood trauma primarily focus on addressing the fearful thoughts and avoidance of trauma triggers. This is a very important part of trauma treatment. However, our study has revealed that we are only treating one part of the problem," said Dr. Megan Klabunde at the varsity-s Department of Psychology. "Even when a child who has experienced trauma is not thinking about their traumatic experiences, their brains are struggling to process their sensations within their bodies. This influences how one thinks and feels about one's 'internal world' and this also influences one's ability to empathize and form relationships." Dr. Klabunde reviewed 14 studies involving more than 580 children for the research, which re-examined functional magnetic resonance imaging (fMRI) scans using AI. The study discovered a marked difference in traumatised children's default mode (DMN) and central executive networks (CEN)-two large scale brain systems. The DMN and the posterior insula are involved in how people sense their bodies, their sense of self and their internal reflections New studies are finding that the DMN plays an important role in most mental health problems-and may be influenced by experiencing childhood trauma. The CEN is also more active than in healthy children, which means that children with trauma histories tend to ruminate and relive terrible experiences when triggered.

t has been several years since highprofile economic offenders such as ijay Mallya and Nirav Modi made/ headlines by fleeing the country, leaving a trail of unpaid debts amounting to thousands of crores from Indian banks.

Their departure thrust the nation into a web of financial challenges and raised poignant questions about the effectiveness of legal processes and probe agencies tracking their movement. It also triggered a broader conversation about accountability and the resilience of the financial system. Sources say that a joint team of the Enforcement Directorate (ED), Central Bureau of Investigation (CBI), and National Investigation Agency (NIA), is actively working to identify properties belonging to such financial fugitives in the UK and other coun-

tries. The goal is to seize the 'proceeds of crime' acquired by these financial fraudsters.

A joint team is also working on the extradition of arms dealer Sanjay Bhandari, who fled the country in 2016 amidst investigations into multiple defence deals.

Bhandari, allegedly linked to Robert Vadra, husband of Congress General Secretary Privanka Gandhi Vadra, is said to have acquired properties in London and Dubai, and transferred them to shell companies associated with Vadra's alleged aide. Bhandari, Nirav Modi, and Mallya,

all three declared fugitive economic offenders (FEOs) are expected to be extradited to India, but they still have pending appeals against their deportation.

The government has already attached their assets in India, with some properties sold to recover funds for outstanding bank dues.

Under the Mutual Legal Assistance Treaty (MLAT), India and the UK are obligated to share information on criminal investigations related to economic offenders.

While the Union Home Ministry typically handles MLAT, the Ministry of External Affairs (MEA) has taken charge due to diplomatic engagements requiring all requests to be routed through the MEA.

Meanwhile, in a recent setback for Vijay Mallya, who fled from the country on March 2, 2016, the UK High Court ruled in favour of his extradition to India, dismissing his appeal. However, Mallya's legal team has obtained permission to appeal to the UK Supreme Court, further extending the extradition process.

In March last year, the CBI submitted an additional chargesheet in a bank fraud case related to Mallya in a Mumbai court.

The chargesheet stated that while Kingfisher Airlines faced a severe cash crunch in 2008, and lenders were still attempting to recover loans defaulted in 2015-16, Mallya acquired a property valued at Rs 80 crore in the UK and another worth Rs 250 crore in France. The CBI had said that evidence obtained from the UK, through a Letter Rogatory, indicated significant diversions to Mallya's motor-racing team, Force India Formula-1 Team Ltd (F1F1), from Kingfisher's account with HSBC Bank, London.

Information provided during the opening of Swiss bank accounts linked to Mallya in 2014-15 stated that he was neither a politician nor a member of any political party.

The chargesheet also revealed that Mallya was slated to receive \$75 million (\$40 million upfront and the remainder in the form of \$7 million annually from 2017 to 2021) from Diageo PLC in exchange for stepping down from the position of Chairman of United Spirits Limited (USL) and refraining from competing with Diageo PLC in Asian liquor markets. The amount constituted an asset that Mallya was obligated not to alienate, as per the terms of the personal dated guarantee agreement December 21, 2010, executed by him



lently issuing Letters of Undertaking (LoUs).During the investigation, the CBI conducted searches at 42 premises and arrested fifteen persons.

"A large number of witnesses were examined and voluminous documents were collected. Investigation revealed that the accused officials of the PNB, in conspiracy with said owners of the firms and others, had fraudulently issued a large number of LoUs to overseas banks for obtaining Buyer's credit in favour of said three firms without any sanctioned limit or cash margin and without making entries in the CBS system of the bank, he says. The investigation further revealed that the fraud was allegedly perpetrated despite the circulars issued by RBI.

Meanwhile, a Mumbai Magistrate's court issued a proclamation notice against Mehul Choksi in connection with a cheating case filed by the Mumbai Police's Economic Offences Wing.Another high-profile fugitive, Lalit Modi, the man credited with transforming cricket with the Indian Premier League (IPL), found himself embroiled in financial controversies during his tenure as the league's chief commis

irregularities and money laundering Lalit Modi left India in 2010 and has since been in the UK.

His case brings attention to the intersection of sports and financial impropriety, exposing how influential figures can exploit positions in the world of sports for personal gain.

Experts argue that the challenges faced by Indian authorities are multifaceted, citing extradition laws, varying legal systems, and international human rights considerations as significant roadblocks.

Critics emphasised the need for a streamlined and efficient extradition process, underlining the importance of international cooperation in tackling economic offences.

Vineet Jindal, a Supreme Court lawyer says that extradition treaties alone will not fetch the desired results for India. "Extradition often involves conflicting sovereign interests. While the requesting state seeks to prosecute offenders pursuant to its sovereign power, the state where the fugitive is located has sovereign interests as well," he says."These include treaty obligations, different laws, the prerogative to grant asylum, and higher standards of protection of human rights,' Jindal adds.According to Jindal, the newly passed bill which is yet to be implemented, the Bharatiya Sanhita Bill has been legislated keeping in mind the importance of a balanced, evidence-based approach to crime prevention."The bill's aims are pragmatic as it not only gives harsh penalties but also has a humanistic approach towards the offenders. This would prevent the convicts from getting asylum in foreign countries as the offenders would be given an opportunity of rehabilitation in the home country itself," he says.

"Through this, it also synchronises with the global criminal laws, as it has the features that essentially are framed to bring restorative justice,' **Jindal** adds.

The command said in a statement that the strikes were launched at nearly 3:30 p.m. Sanaa time, and the targets were deemed "an imminent threat to US Navy ships and merchant vessels in the region".

Yandex NV, the Dutch parent company of the Yandex group has entered into a definitive agreement with a purchaser consortium to sell all of the Yandex group's businesses in Russia and certain international markets.

The total consideration for the sale will be 475 billion ruble (around \$5.2 billion) and at least 50 per cent will be paid in cash. "Since February 2022, the Yandex group and our team have faced exceptional challenges. We believe that we have found the best possible solution for our shareholders, our teams and our users in these extraordinary circumstances," said John Boynton, Chairman of the Board of Directors of Yandex NV.

"The proposed transaction will allow shareholders to recover some value for the businesses that we are divesting, while unlocking new growth potential for the international businesses we will retain and enabling the divested businesses to operate under new owner-



ship," Boynton said in a statement. Following the successful completion of the transaction, in full compliance with international sanctions where applicable, the company will hold no interest in its businesses in Russia. The Russian government welcomed

the deal."This is exactly what we wanted to achieve a few years ago when Yandex was under threat of being taken over by Western IT giants," said Anton Gorelkin, deputy head of the Russian parliament's committee on information policy. "Yandex is more than a company, it is

an asset of the entire Russian society," he added. Launched in 1997, the firm is the largest technology company in Russia. It had more than 30 offices worldwide in 2018. Its main competitors in the Russian market are Google, Microsoft, VK. and Rambler.

Cape Breton Regional Municipality of Nova Scotia has declared a local state of emergency with some places in the region receiving up to 80 centimetres of snow, Xinhua news agency reported, citing local media.

"Residents are directed to shelter in place and advised to clear snow from their home's entryways, walkways and driveway to facilitate home access," a news release from municipality read. the "Residents should also remove snow from ventilation points at your home." Do not travel.



Roadways are being cleared for emergency response and travel of essential workers. The process is slow and ploughs require several passes to deal with the significant accumulation," the news release said. CBC News reported that the airport in Sydney, Nova Scotia, had received more than 90 centimetres of snow by Monday morning, while downtown Sydney was pummelled with 150 centimetres.CTV News

More N.Koreans negative about leader Kim Jong-un, hereditary power succession: Report

Seoul Agencies growing number of North Koreans have negatively assessed Kim Jong-un as a political leader

and harboured doubts about whether the Kim family's hereditary power succession is legitimate, a report showed on Tuesday. Seoul's Unification Ministry released the 280-page report on North Korea's economic and social situation for the first time on Tuesday. The report is based on in-depth interviews with 6,351 North Korean defectors conducted

between 2013 and 2022. Yonhap news agency reported. It showed 43.8 per cent of the North Korea's defectors said they thought Kim Jong-un taking power was inappropriate when they lived in North

Korea. For those who fled North Korea between 2016 and 2020, some 56.3 per cent gave a negative assessment of Kim as a leader.

"Negative public sentiments toward the 'Paektu bloodline'based leadership system have been increasing and this perception appears to be gaining traction since Kim Jong-un assumed power (in late 2011),' the report showed.

North Korean propaganda has idolised the ruling family as the "Paektu bloodline," claiming that Kim's late father, former leader Kim Jong-il, was born on Mount Paektu, the highest peak on the Korean Peninsula, despite the fact that he was born in the far eastern Russian city of Khabarovsk.

Nearly 55 per cent of the North Korea's defectors who fled the North Korea between 2016 and 2020 said they had a negative opinion of the Kim family's power succession. Some 42.6 per cent held such a view among those who escaped the country between 2011 and 2015.

Kim Jong-un has brought his teen daughter, Ju-ae, to public events since late 2022 in an apparent bid to demonstrate his commitment to the third hereditary power succession. The National Intelligence Service, Seoul's spy agency, said it sees Ju-ae as the "most likely successor". Amid a sluggish economy, more North Koreans have been doing various activities in the "private" economy, including selling goods at markets, cultivating unauthorised lands, smuggling and engaging in housing con-

struction projects.

Markets are playing a critical role in the livelihoods of North Koreans, as the food rationing system has collapsed. Around 91 per cent of the North Korea's defectors said life was not sustainable without markets, and

for those who fled the North Korea after 2012, some 68.1 per cent of their income came from "non-official" income sources.

"The influence of markets has been expanding to healthcare, education, transportation and information infrastructure from the necessities of life, such as food, clothing and shelter, as well as energy, water and sewage," it said.North Korea has been suffering from a chronic food shortage amid prolonged UN sanctions on Pyongyang's nuclear and missile programmes.

Chile wildfire death toll hits 122

aging forest fires in central Chile's Valparaiso region have claimed at least 122 lives, the Chilean government said on Monday.



"The rule of gangsters continues in Maharashtra... MLAs of the ruling party shoot inside the police station. Why did the gangsters become so strong? Who is responsible for this state of affairs," demanded Raut of the MVA bloc.

Reacting to the MVA charges, Shiv Sena Minister Deepak Kesarkar said that many people call on the CM daily. "We cannot stop them from meeting the CM or clicking pictures with him. The allegations have no basis," said Kesarkar.



Citing examples, Wadettiwar said that the Chief Minister Eknath Shinde's son, Dr. Shrikant E. Shinde held a meeting with a known gangster Hemant Dabhekar -- an aide of the slain Pune don Sharad Mohol. Pictures of Dabhekar allegedly visiting the CM's official residence 'Varsha' to felicitate Dr. Shinde on his birthday are viral on the social media. Another Pune baddie Nilesh Ghaiwal called on the CM at 'Varsha' and photos of that trip are also doing the rounds on social media, embarrassing the ruling coalition. Deputy CM Ajit Pawar's son created waves when he wittingly or unwittingly called on a notorious history-sheeter

Gajanan Marne in Pune, leading to many red faces in the breakaway NCP row (AP) last month. Even as a muchconcerned father, he pulled the ears of his son for the indiscretion, Ajit Pawar himself came under a cloud when a purported shady element,

Asif Mohammed Iqbal Shaikh, alias Asif Dadhi, allegedly having links with the banned SIMI terror outfit, called on him. "How can people expect law and order from rulers who entertain goons?" demanded Wadettiwar sharply, adding that the mafia is getting the full backing of the Mahayuti regime.

Raut said that gangsters are roaming around freely with the blessings of the state government, and asked who is feeding them".

The MVA's hit-list came just a day after a worried group of ruling Shiv Sena Ministers called on Deputy CM Devendra Fadnavis and complained to him about the allegations hurled against the CM by a BJP MLA Ganpat Kalu Gaikwad. "Shinde is trying to establish a kingdom of goons in the state. He deceived Uddhav Thackeray, he will betray the BJP also. He owes me crores of rupees. Shinde should quit if Maharashtra has to be administered well. This is my humble plea to Fadnavis and Prime Minister Narendra Modi," Gaikwad blurted out before he was whisked off by the Thane Police, early on Saturday.

Rattled by the political ramifications of Gaikwad's allegations, which the Shiv Sena has termed as 'baseless

India's EV charging station count rises to 12,146; Maharashtra leads, Delhi 2nd

he number of electric vehicle (EV) charging stations that are operating in the country has gone up to 12,146 as of February 2 this year, Minister of State for Heavy Industries, Krishan Pal Gurjar, said in a written reply in the Lok Sabha on Tuesday.

The data provided by the minister shows that Maharashtra leads with 3,079 EV charging stations followed by Delhi with 1,886, while Karnataka is at the third spot with 1,041 charging stations.

The top three states are followed by: Kerala (852), Tamil Nadu (643), Uttar Pradesh (582), Rajasthan (500), Telangana (481), Gujarat (476) and Madhya Pradesh (341), making up the top 10 list

The Ministry of Heavy Industries (MHI) has been making consistent efforts for facilitating the promotion of EVs in India. The FAME-II scheme inter-alia included financial support in the form of subsidy for setting up of public charging infrastructure to instill confidence among the EV users, the minister



Further, the Ministry of Power has taken several initiatives to accelerate the deployment of public EV charging infrastructure in the country.

The government has issued guidelines and standards for charging infrastructure, which enable the owners of EVs to charge their vehicles at their residence/office using their existing electricity connections.

A revenue sharing model for provision of land at promotional rates for public charging stations has also been introduced and provision has been made for providing electricity connection to Public Charging Station (PCS) within stipulated timelines.

The government has also prescribed the single part EV tariff for public charging stations, This amount cannot exceed Average Cost of Supply (ACoS) till 31.03.2025.

The guidelines specify a ceiling of Rs 2.50 per unit and Rs 3.50 per unit of electricity used for slow AC charging of EVs at PCS during the solar and non-solar hours, respectively.

Additionally, a ceiling limit of Rs 10 per unit and Rs 12 per unit of electricity used for DC fast charging of EVs at PCS during the solar and non-solar hours, respectively, has also been specified.


Average cost of supply (ACoS) by DISCOMs to PCSs during solar hours shall have a rebate of 20 per cent and a surcharge of 20 per cent during all other times.

The Green Energy Open Access Rules, 2022, has been notified with the objective of further accelerating renewable energy adoption, ensuring access to affordable, reliable, sustainable and green energy for all, the minister added.

Mumbai docs successfully treat woman with rare Ewing's sarcoma of breast

48-year-old woman with rare Ewing's sarcoma of the right breast has been **D**given a new lease of life after doctors here successfully treated her. Ewing's sarcoma or PNET (primitive neuroectoderm tumor) are rare, cancerous round cell tumor of the bone and soft tissue usually occurring in children and young adolescents. So far only 15 cases of Ewing's sarcoma of the breast have been reported worldwide, according to a study published in Annals of Clinical Case Reports in July 2022. The prognosis of the Ewing's sarcoma of the breast in very large tumour or metastatic tumours (spread beyond breast) is fatal. The patient Pratiksha Mane, first presented at OPD of Jaslok Hospital & Research Centre, Mumbai, in October 2023 with a mobile painless lump in the right upper quadrant of her breast. It was a large tumour but resectable and non-



metastatic. A PET CT confirmed the disease to be localised to the right breast with no spread elsewhere in the body. Following a comprehensive evaluation the doctors decided to proceed with breast conservation surgery. The surgery involves the removal of the tumour with wide margins and reconstruction using the patient's own muscle and skin from the back, was performed in a single sitting. The procedure was a resounding success, with Mane experiencing an uncomplicated recovery and being discharged within a week, said the multidisciplinary team of doctors led by Satish Rao, Consultant Surgical Oncology at the hospital.

The WR vigilance probe has revealed that the accused -- whose identity has not been disclosed -- had allegedly collected Rs 9-10 lakh per candidate, and used to make forged documents with the assistance of a Kolkata-based associate

Thakur said that a total of 180 blocked

numbers were found in the smartphone of the accused, probably belonging to the victims who had paid him huge amounts to get a lucrative railway job.

Speaking as part of a panel at a SAG screening of 'Barbie', she said, "There's no way to feel sad when you know you're this blessed."




