

Nayab Singh Saini takes oath as Haryana CM with five Cabinet colleagues

11TH HOUR CHANGE

The BJP's attempt to fight anti-incumbency in Haryana, which it has ruled since 2014, has seen another big name being dropped. Anil Vij, arguably the best-known leader from the Haryana BJP after now former chief minister Manohar Lal Khattar, has not found a place in the new cabinet led by Nayab Singh Saini. Five other ministers, who were part of Khattar's cabinet, took oath with Saini at a swiftly organised ceremony on Tuesday evening, hours after the chief minister and his entire cabinet resigned.

irst-time BJP MP Nayab Singh Saini was sworn in as the Haryana Chief Minister on Tuesday, along with five Cabinet colleagues

Saini's name was unanimously decided during the party's meeting after incumbent Manohar Lal Khattar and the entire cabinet, comprising three members of Deputy Chief Minister Dushyant Chautala's JJP --

stepped down in the morning. With a stronghold over the OBC community that comprises eight per cent in the state, Saini, who touched the feet of Khattar before and after taking the oath in Hindi, will be the Chief Minister for seven months till the state goes to the polls

The Saini caste has a sizeable population in Kurukshetra, Yamunanagar, Ambala, Hisar, and Rewari districts.

Kanwar Pal Gujjar, Mool Chand Sharma, Ranjit Singh Chautala, J.P. Dalal, and Banwarilal took oath as ministers.

Governor Bandaru Dattatreya administered the oath of office to them at a ceremony in Raj Bhavan in Chandigarh. However, former Home and Health Minister Anil Vij was conspicuously absent from the oath-taking ceremony that started 20 minutes before the scheduled time.

Vij left the morning meeting as soon as Saini's name was proposed. The outgoing Cabinet comprised



14 ministers, including Khattar and three members of the JJP.

In the 90-member Haryana Assembly, the BJP has 41 MLAs, while the JJP has 10. The ruling combine also enjoys the support of six of the seven independents, taking it past the halfway mark of 45 seats.

As per sources, Khattar will be contesting the Lok Sabha elections. He is expected to be fielded from Karnal.

Khattar's own man Sanjay Bhatia also a Punjabi face who won by a margin of 6.5 lakh votes in 2019, the second-highest victory margin in the country, may replace Saini as the party's state chief.

In 2019, the BJP had won all the

state's 10 seats.

Political observers told IANS that Saini's elevation to the top post is being seen as to consolidate the non-Jat and OBC votes. Also, it is an attempt to counter anti-incumbency against Khattar, who has been at the helm since 2014. In the caste politics of Haryana, the Jat -- a landowning community that accounts for around 25 per cent of the state's population -support is largely divided among the Congress, the Jannayak Janata Party, and the Indian National Lok Dal (INLD).BJP insiders say apart from being an OBC and close to Khattar, old association with the RSS also helped Saini to reach the helm.

THE CAUSE OF CHANGE

New Delhi: The BJP is towing a fine line in Haryana ahead of the Lok Sabha elections, sending multiple messages through the change in in the top post. Sources said the change made it necessary for the whole cabinet -- including Deputy Chief Minister Dushyant Chautala of JJP to resign -- which was what the party was aiming for. The BJP and JJP (Jannayak Janata Party) had fallen out over seat sharing in the state. While the BJP wanted to contest all 10 Lok Sabha seats, the JJP, which failed to win any in the 2019 Lok Sabha election, wanted at least two seats. But an acrimonious break-up with JJP or sacking of Chautala from the cabinet would have sent a wrong message to Jats, a substantial chunk of the state's population.

The BJP, sources said, chose to take a roundabout way.

A second set of message was sent through the choice of state BJP chief Nayab Saini, a strong leader of the Other Backward castes, to fill the shoes of Chief Minister Manohar Lal Khattar -- one that showed the party

supporting the non-Jats as well. Chaudhary Birendra Singh's son and BJP MP from Hisar Brijendra Chaudhary joining the Congress last week is also linked to this, sources said.Around 20 per cent of Haryana's population are Jats, the rest belong to other communities.

CAA will not take away citizenship, **Amit Shah assures minorities**



Gogoi, Nakul Nath, and Vaibhav Gehlot figure in the second list of Lok Sabha candidates released by the party on Tuesday. Nakul Nath (Chhindwara),

ongress leaders Gaurav

Vaibhav Gelot (Jalore), and Gaurav Gogoi (Jorhat) are sons of former Congress Chief Ministers Kamal Nath (Madhya Pradesh), Ashok Gehlot (Rajasthan), and late Tarun Gogoi (Assam).

The list contains 43 names of candidates from Assam (12), Gujarat (7), Madhya Pradesh (10), Rajasthan (10), Uttarakhand (3), and Daman and Diu (1). Rahul Kaswan, who switched over from the BJP a couple of days ago, has also been nominated from

Rajasthan's Churu. Announcing the candidates, Congress General Secretary, Organisation, K.C. Venugopal



said 76.7 per cent of the second list candidates comprise SC/STs, OBCs, and Muslims. He said 25 of the candidates were below 50 years of age, 8 were aged between 50 to 60, and 10 were aged 61 to 72.

However, the names of perceived heavyweights of the party were missing from the list. The second list still does not feature candidates from crucial states like Uttar

Pradesh and Delhi. The first list released last week had 39 candidates, including Rahul Gandhi from Kerala's Wayanad, as well as Shashi Tharoor from Thiruvananthapuram, and Venugopal himself from Alappuzha.



he State Bank of India (SBI) on Tuesday evening submitted data on political contributions made through electoral bonds to the Election Commission of India (ECI), in accordance with the Supreme Court's order.

The Election Commission will now collate and release the data by 5 p.m. on Friday, as per the court order.

The Supreme Court had on Monday rejected SBI's plea to extend the March 6 deadline for submitting the data to the ECI.

A bench headed by Chief Justice D.Y. Chandrachud came down strongly on the bank for "willful disobedience" of its orders and warned it of contempt proceedings on Monday.

The SBI had claimed that it would take a considerable amount of time to collect. cross-check and release the data, which was stored in two silos to maintain secrecy.

In a verdict delivered on February 15, the Supreme Court struck down the Electoral Bonds Scheme 2018 as unconstitutional and ordered the SBI to forthwith stop their issuance. It also asked the SBI to

submit details of the electoral bonds purchased since April 2019 to the ECI by March 6 for publication on the official website of the poll "SBI must disclose details

of each Electoral Bond

encashed by political parties which shall include the date of encashment and the denomination of the Electoral Bond. SBI shall submit the above information to the ECI within three weeks from the date of this judgment, that is, by March 6, 2024," the SC had said in its February 15 order.

Web portal for citizenship seekers launched, 'CAA-2019' mobile App to come soon

he Ministry of Home Affairs (MHA) on Tuesday launched a web portal for facilitating the registration of people, seeking citizenship under the Citizenship Amendment Act (CAA), 2019.

The MHA informed on X, that a mobile app called CAA-2019 will also be launched soon to expedite the applications by non-Muslim migrants seeking Indian citizenship.

The web portal and mobile app for seeking citizenship under CAA will not only simplify the procedure but also enable non-Muslim migrants to apply for the same, via their mobile phones. The migrants, who escaped Pakistan, Bangladesh and Afghanistan to India before 2015, can apply under the scheme. They will have to first register themselves on the web portal and mobile App and create individual logins, before filling applications for the same.

Notably, the Centre on

Monday notified the rules for

CAA implementation and also released the application formats which could be filled by migrants for getting Indian citizenship. The law granting citizen-

ship to refugees pertaining to six religions other than Muslims was cleared by Parliament in 2019.

As per the rules of CAA,

any Hindu, Sikh, Buddhist, Jain, Parsi or Christian who came to India before December 31, 2014, suffering atrocities and persecution on religious grounds in countries like Pakistan, Bangladesh and Afghanistan, can seek Indian citizenship without producing a valid passport of these countries

or a valid visa from India.

PRIME MINISTER MODI WITNESSED THE 'BHARAT SHAKTI' EXERCISE AT POKHRAN

Prime Minister Narendra Modi during his visit to Rajasthan's Pokhran on Tuesday witnessed the 'Bharat Shakti' exercise, showcasing the power of homegrown defence equipment across the three services.

Prime Minister Modi hailed the indigenization in the country's defence sector and also underlined the need to reduce dependence on other powers and focus on building self-reliant India. He also stressed on attaining 'Atmanirbharta' (self-reliance) in various sectors ranging from edible oils to modern aircraft.

"A self-reliant India in the defence sector instils confidence in the Armed Forces," the Prime Minister asserted.

Interestingly, Prime Minister Modi's dream of attaining 'atmanirbharta' and making India a self-reliant country is not new. About 26 years ago, when India conducted a series of 5 nuclear tests at the Pokhran range on May 11 and 13, 1998, it left the world bewildered and stunned about the country's capabilities. At that time



also, he had described it as the power and manifestation of India's self-reliance.

An audio clip shared by the 'Modi Archive' X handle, shows how Narendra Modi, then a BJP worker, delivered a powerful speech in 1998, post Pokhran tests and saluted the country's scientists for making it a highly secretive and highly successful operation.

"100 taka Swadeshi! - 100 per cent Made In India," he then thundered, while claiming that the whole world was left in shock over India's nuclear tests. The extract from his then speech also shows how he celebrated the success of the Pokhran nuclear tests in 1998, highlighting how the scientists involved in the programme were all Indian -- even their education, and how they achieved the feat using indigenous technology.

He showered lavish praise on noted scientist A.P.J. Abdul Kalam, the man credited for the 1998 nuclear tests and also boasted about his Indian education and that too in Tamil language.

India's retail inflation eases to 4-month low of 5.09 per cent in January

India"s retail inflation slowed to a four-month low of 5.09 per cent in February bringing some relief to household budgets, official figures released on Tuesday showed.

The retail Inflation in January was a tad higher at 5.1 per cent.

There was a sharp decline in cooking oil prices during February which came down by as much as 11.67 per cent. The price rise in spices slowed to 13.51 per cent compared to 16.36 per cent in January.

However, the data show that vegetable prices shot up by as much as 30.25 per cent in January while pulses turned costlier by 18.9 per cent. The prices of cereals went up by 7.6 per cent.

The consumer price inflation is now above the 4 per cent midpoint of the RBI's 2-6 per cent target range and is the main reason why the central bank is not going in for a cut in interest rates to spur

economic growth. The RBI is keen to keep inflation under control to ensure stability and has held the repo rate steady at 6.5 per cent for six consecutive times in a row in its bi-monthly monetary policy reviews.

The latest inflation data comes weeks before the RBI's Monetary Policy Committee (MPC) meets again on April 3-5

ICRA Chief Economist Aditi Nayar said barring food and beverages, the inflation across all other sub-groups eased in February 2024, indicating that the momentum in the non-food items continued to track a welcome moderation.

The food and beverages inflation printed above the 7 per cent mark for the fourth month in a row. While the food and beverages inflation posted an unpleasant uptick in February 2024 vis-a-vis January 2024, this was not broad-based, with seven of the 12 sub-items witnessing a moderation in their YoY inflation print, she added.

Ex-CM Thackeray counters dynastic politics charge made by top BJP leadership

Shiv Sena (UBT) chief, Uddhav Thackeray on Tuesday strongly countered the charge of dynastic politics levelled by Prime Minister, Narendra Modi, and Union Home Minister, Amit Shah, against him and other Opposition leaders.

Daring the top BJP leadership to talk about their lineage, the former Maharashtra Chief Minister said he was proud to talk about his family's contribution to society.

"Basically, I don't need to tell you about my family. My father, my grandfather, great grandfather, great grandfather were all in public service. Everyone made sacrifices for the welfare of the people," he said at a mass outreach programme at Ralegaon Village, Yavatmal District in Maharashtra's Vidarbha region.

"Everyone has seen what I did during the Coronavirus pandemic. My grandfather's father Sitaram Thackeray did great work during the plague epidemic. At that time our family was living in Panvel. There was a plague in our country and people were dying due to it

"In those difficult times, there was no one to carry dead bodies. At that time, Sitaram Thackeray carried the dead bodies. In the



end, he also got plague and died. This is the history of the Thackeray family," said the Shiv Sena (UBT) chief while rebutting the charge of nepotism.

He was responding to HM Shah's swipe at him at a recent rally he addressed in Jalgaon District in North Maharashtra that Uddhav Thackeray wants to make his son (Aaditya) the Chief Minister, instead of a Shiv Sainik, while NCP(SP) chief Sharad Pawar is keen to make his daughter Supriya Sule the Chief Minister of Maharashtra.

Tears of joy: Pakistani Hindu refugees in Delhi celebrate notification of CAA rules

Hindu refugees living in a cramped settlement near Majnu Ka Tila in Delhi, as the Citizenship (Amendment) Act (CAA) rules were notified on Monday. Since Tuesday morning, the people living in the refugee camp were seen distributing sweets and playing with colours.

Dharamveer Solanki, regarded as a leader by the Pakistani Hindu community in Delhi, shared his elation with reporter, and said that the refugees would now obtain Indian citizenship after waiting for over a decade. Expressing immense happiness, Solanki told reporter, "I am glad I decided to return to my homeland in 2013. We have been waiting for this for over a decade now. We are extremely happy that we will be finally called Indian citizens."

Among the jubilant refugees numbering over 500, is Kamal, who has been living in a slum without legal



recognition for decades.

"This moment is like a second birth, not only for me and my family but for my entire community and for those who were living here without any authority for decades," said Kamal.

Another refugee, Brij Lal, likened the occasion to Holi and Diwali, two of the most celebrated festivals in Hindu culture Lal attributed this milestone to
Prime Minister, Narendra Modi,
describing him as no less than an
"avatar (incarnation)" for their community. The implementation of the
CAA has been a subject of heated
debate since its inception. However,

for refugees like Solanki, Kamal, and

opportunity for a better life in their

Lal, it represents a long-awaited

adopted homeland.

The Union Home Ministry on Monday notified the rules for the CAA, paving the way for granting of citizenship to non-Muslims -- mainly Hindus, Sikhs, Jains, Buddhists and Parsis -- facing persecution in neighbouring countries like Pakistan, Bangladesh, and Afghanistan, who had migrated to India before December 31, 2014.

"Immigrants qualifying for citizenship under CAA will have to submit applications in an online mode, for which a web portal has been created," an MHA spokesperson said.

The CAA was an integral part of the BJP's 2019 Lok Sabha poll manifesto and was enacted by the Parliament in December 2019 amid large-scale demonstrations from the Muslim community, backed by Opposition parties. Monday's announcement came on the back of Union Home Minister, Amit Shah's assertions that the CAA would be implemented before the Lok Sabha elections, slated for April/May.

You might lose everything if you apply on CAA portal: Chief Minister, Mamata Banerjee

Test Bengal Chief Minister, Mamata Banerjee, on Tuesday issued a note of caution against enrolling on the Citizenship Amendment Act (CAA) portal, saying applicants might ultimately lose everything.

"Some of you might be happy over the CAA notification. If you are happy, then I am also happy. But when you are sad, I am also sad. I am telling those who will be enrolling at the CAA portal, try to understand something. How can one be granted fresh citizenship when one is already a citizen? Without citizenship how could one cast votes for such a long time?" the Chief Minister questioned, while addressing a public meeting at Habra in North 24 Parganas District on Tuesday afternoon.

"Once you apply at the portal, you will become an illegal immigrant from a genuine citizen. Once you become an illegal immigrant what will happen to your property or profession? You will be sent to detention



camps. Those will also become illegal. So think again and again before you apply," the Chief Minister

She also claimed that the CAA was a ploy to divide Bengal and ultimately drive away Bengalis from India.

"In Delhi a number of Bengalispeaking people have been harassed after they were branded as Bangladeshis," the Chief Minister

According to her, the CAA notification is yet another ploy of the BJP to create division among people.

"That is why besides Bangladesh and Pakistan, it has also included Afghanistan, though it does not have any international border. Why weren't Sri Lanka and Myanmar,

who have borders with India, included? This is just a ploy to polarise some religions against one particular religion," she said.

From the dais she also raised a war cry that she would not allow introduction of CAA or NRC in West Bengal."I will oppose that, even if I have to sacrifice my life for it," the Chief Minister said.

Coast Guard seizes Pak boat with Rs 480 crore drugs off Gujarat coast; six held

In an overnight joint operation on the intervening night of March 11 and 12, the Indian Coast Guard (ICG) apprehended a Pakistani boat off the coast of Porbandar, Gujarat, with six crew members and narcotics valued at around Rs 480 crore on board.

The boat was apprehended about 350 km from
Porbandar in the Arabian Sea in a sea-air coordinated operation involving ICG ships and Dornier Aircraft.
The operation exhibited well-coordinated efforts between the ICG, NCB, and ATS Gujarat.

The ICG said that on specific intelligence inputs from the security agencies, the ICG strategically positioned its ships in the Arabian Sea on Monday.

The ICG also deployed its Dornier aircraft to scan and locate the boat in the likely areas. After an exhaustive search in the area, the ICG



ships, accompanied by teams from the NCB and ATS Gujarat, arrived at the location and identified the boat, which was moving suspiciously in the dark.

On being challenged by

the ICG, the boat tried to escape but was deftly chased and forced to stop by the ICG ships.

The boarding team immediately embarked on the ship for preliminary checking.

It was found to be a Pakistani boat with six crew

members. After further searches, 80 kg of drugs worth about Rs 480 crore were recovered from the

The boat, along with its crew, has been apprehended and brought to Porbandar for further investigation.

This was the 10th such apprehension by the ICG, in collaboration with the ATS Gujarat and NCB, in the last three years, leading to a total seizure of 517 kg of narcotics worth about Rs 3,135 crore.

CONGRESS WORKER KILLED, HANGED FROM A TREE IN K'TAKA

Gadag: An incident of a Congress worker being killed and hanged from a tree by some miscreants came to light on Tuesday near Dambala village in Mundaragi taluk of Gadag district in Karnataka.

The deceased was identified as Sharanappa Sandigoudra, a local Congress leader from Doni village.

According to the police, the killers attacked him when he was going on a bike and chased him after he fell off the vehicle. They threw chili powder into his eyes and stabbed him with sharp-edged weapons.

Later, they hung his body from a tree and escaped from the spot.The Congress party had organised a convention of the beneficiaries of guarantee schemes at Dambala village and the incident created tension in the area. The Mundaragi police reached the spot after villagers spotted the body hanging from a tree.

IAF's Tejas aircraft crashes in Rajasthan, pilot safe

Tejas aircraft of the Indian Air Force (IAF) crashed near Jaisalmer in Rajasthan on Tuesday during an operational training sortie, said IAF officials.

Sharing the information on X, the IAF officials said, "One Tejas aircraft of the Indian Air Force met with an accident at Jaisalmer, on Tuesday during an operational training sortie. The pilot ejected safely. A Court of Inquiry has been constituted to find out the cause of the accident."

Sources said that this helicopter was coming for the 'Bharat Shakti-2024' exercise being held at Pokhran Field Firing Range, which crashed near Jawahar Colony, Jaisalmer. Last month too, a Hawk trainer



aircraft of the IAF met with an accident in West Bengal during a training sortie. Both the pilots ejected safely. The plane had crashed in the civilian area near the Kalaikunda Air Force Station but there was no loss of life or damage to the civilian property.

Court in UP's Hapur sentences ten to life terms in mob lynching case

A court in UP's Hapur district on Tuesday convicted all ten persons accused in the 2018 mob lynching case and sentenced them to life imprisonment.

Above 40 people must test for glaucoma

rf you have a family history of glaucoma, are over 40 years of age or experiencing symptoms such as pain in the eye, pressure, headaches, or seeing rainbow-coloured halos around lights, it is essential to undergo an eye test. Ignoring these signs may lead to irreversible peripheral vision loss associated with glaucoma. Siddharth Agrawal, faculty at the ophthalmology department of KGMU, said glaucoma is caused by a buildup of fluid within the eye, leading to pressure that can damage the optic nerve. He underlined the importance of regular eye checkups, especially for those above 40. He advised people to be especially vigilant if they have a family member with glaucoma, experience frequent spectacle changes, or have any discomfort in their eyes. Another faculty at KGMU's ophthalmology department, S. K. Bhaskar, said the fluid buildup inside the eye, called aqueous humor, needs to drain properly to maintain healthy pressure. Excessive steroid use can also contribute to eye problems. He said due to awareness, more patients are being diagnosed, and the number of glaucoma patients has grown by 10 per cent in the past five years, partly due to increased awareness and better detection methods. However, many people mistake glaucoma for cataracts, delaying proper treatment. Unlike cataracts, glaucoma causes permanent vision loss if left untreated. Bhaskar emphasised the importance of eye pressure and retinal tests for anyone over 40 experiencing vision problems. Early detection allows for timely treatment and helps prevent vision loss, he added.

Udaipur home to 17 roosting, 12 nesting waterbird species: First-of-a-kind study

n one of the only studies in the world that has documented the roosting and nesting waterbird community inside Udaipur city in Rajasthan reveals the city famous for its centuries-old artificial lakes is home to 17 waterbird species roosting and 12 nesting species. And they used 23 species of trees for these two activities.

Trees used for both activities were in locations that had a relatively smaller amount of built up area (compared to random locations), suggesting the waterbirds were trying to find less noisy and disturbed areas for these activities.

The study says waterbirds were also choosing sites that had a lot of wetlands nearby, indicating the artificial wetlands of the city were attractive to these species to conduct their most critical activ-

The research was done as part of the PhD graduate thesis of Kanishka Mehta from the Mohanlal Sukhadia University in Udaipur. The thesis was advised by Swati Kittur, Vijay Koli and K. S. Gopi Sundar, the Co-chair of the IUCN Stork, Ibis and Spoonbill Specialist Group.

"The research focused on Udaipur and asked the broad question of whether the city is providing refugia for waterbirds. The city is famous for its artificial lakes that erstwhile kings constructed to cool the city during the summer months. We, therefore, wanted to know if these artificial wetlands were attracting waterbirds," Sundar told correspondent on Sunday

Specifically, the study addressed the question of roosting and nesting sites of waterbirds in the entire city of Udaipur, which has been nominated for the Wetland City Accreditation (WCA) scheme under the Ramsar Convention.

"Some of the questions we wanted to answer are: Where did waterbirds in Udaipur roost and where did they nest? Did they use the same sites for both activities? What sort of trees or other structures were used to roost and nest? Which species of waterbirds were using Udaipur for roosting and which ones were nesting within the city limits?" he explains.

The study was unusual in that it documented the entire waterbird assemblage in the city that was roosting or nesting inside the city.

A waterbird is a bird that lives near and walks or swims in water, especially rivers or lakes.

"Such studies are very rare," Sundar says. In keeping the focus relatively wide, the study discovered the following species roosting and nesting inside Udaipur: the little cormorant, Indian cormorant, great cormorant, little egret, intermediate egret, great egret, cattle egret, pond heron, grey heron, purple heron, black-crowned night heron, glossy ibis, black-headed ibis, red-naped



woolly-necked stork.

The bird species with the highest number of roosts in the city were the pond heron, cattle egret and the red-naped ibis

The bird species with the highest number of nest sites in the city were the cattle egret, rednaped ibis and the Asian openbill stork.

Researcher Kanishka Mehta, who has now completed her doctorate, says there is some information previously from other cities around the world documenting nesting waterbirds, but studying the full assemblage of roosting waterbirds has never been attempted before.

Also, this study covered the full city. Usually, a part of the city, such as waterbodies, is covered for studies. "Our study is, therefore, able to provide insights on what aspects of the entire city are being sought after by different waterbird species," says Vijay Koli, assistant professor at Mohanlal Sukhadia University.

The study was conducted between December 2020 and September 2021. The effort, therefore, covered one full nesting season, and also provided adequate time to understand where waterbirds were roosting in the city.

Sundar explains urban ecology is a relatively new subject in India, and most of the work has been carried out on tree diversity, and in cities such as Bangalore and Delhi, that are mega cities. Cities of India, and other cities in the tropics

high level of diversity. This has been surprising for scientists since most of the work on cities has been from cities in temperate areas where diversity is very low inside the city

Studies in temperate regions have given rise to assumptions that crowded cities of the tropics and subtropics must not have too much biodiversity due to the disturbance that people's activities provide for wild animals like birds.

The few cities where such studies have been conducted in India have shown fairly high levels of bird diversity. This study in Udaipur is one of the first in a small city of India that has been conducted across the whole city using careful meth-

"Since waterbird nesting and roosting has not been studied in other Indian cities, we are unable to compare our findings. However, with the results seen in Udaipur, we suspect that cities in India are very important locations for waterbirds. This has been entirely overlooked by scientists and conservation groups and is an exciting discovery," he explains.

Indian cities are showing themselves to be very important refugia for urban wildlife. Some of this is worrying to people since species like leopards can cause some conflict

and injury to people Other wild species like birds,

bees and butterflies are, however,

logical functions.

The government should, therefore, be considering our cities as being multifunctional systems where elements planned for humans can also be useful for a number of wild species. Considering cities to be multifunctional in policies will have multiple benefits. Interactions with nature are an important element of mental wellbeing for humans, which means that city planning should ideally consider both humans and wildlife of that particular region.

"Cities in Assam can be planned for wildlife found in that state, and Udaipur's planners can focus on wildlife such as waterbirds that are resident in the city," adds Sundar.

The study showed the enormous importance of old trees and also dead trees as waterbird roost and nest sites. As trees age, notwithstanding whether they are exotic species such as eucalyptus, or native ones such as neem, they become invaluable habitats inside the city.

Old trees used to be a common element of roads as roadside trees planted to shade travelers. Udaipur's waterbirds still use old roadside trees for roosting despite the enormous disturbance that traffic could be causing.

India assails 'disguised veto' at UNSC anti-terrorism panel protecting Pakistan-based terrorists

ndia has assailed the secretive "subterranean" working of the Security Council Lsanctions committee on terrorism, accusing it of allowing a system of "disuised veto" in blocking the listing of Pakistan-linked terrorists.

"For genuine, evidence-based listing proposals for globally sanctioned terrorists to be blocked. without giving any justification, is uncalled for and smacks of doublespeak when it comes to the council's commitment in tackling the challenge of terrorism," India's Permanent Representative Ruchira Kamboj said on Monday.

Speaking at a meeting of the Council on its working methods, she said that "while we do get to know of the decisions of these committees on listing, the decisions on rejecting listing requests are not made pub-

"This", she declared, "is a disguised veto".

China has repeatedly blocked the listing of Pakistan-linked terrorists as international terrorists subject to UN sanctions.

The most recent action was blocking last year the designation of Laskhar-e-Taiba's Sajid Mir, the mastermind of the 26/11 terrorist attack on Mumbai in 2009, as a global terrorist by the body named the 1269



Committee for the Council resolution setting it up to sanction those with al-Qaeda, the Islamic State or related terror groups.

Calling for transparency in the working of the Council committees known as subsidiary bodies which were "inhabiting a subterranean world with their own custom-made working methods and obscure practices, which do not find any legal basis in the charter or any of the Council's resolution," Kamboj said that the selection of chairs of the panels should an open process with "exhaustive consultations".

She pressed the case for Council reforms that expands both permanent and elected membership.

In a reference to the Council's vetowielding permanent membership frozen in the post-World War 2 era of the 1940s, she pointed out that "with both feet firmly fixed in the past" it has been unable to act on the wars raging in Ukraine and Gaza.

The "need is a Security Council that bet-

ter reflects contemporary realities, the geographical and developmental diversity of the multipolar world of today, including the voices of the developing countries, and underrepresented regions like Africa, Latin the Pacific," Kamboj said.

"We ask those blocking progress on this vital issue to heed calls for genuine reform and contribute to making this Council truly fit for purpose for the 21st century," she added.

The main hurdle to reforms is the position of a minority group, Uniting for Consensus, led by Italy and includes Pakistan as a leading member.

"We can no longer hide behind the smokescreen of the Intergovernmental Negotiations (for reforms) by delivering entrenched national positions in a process which has no timeframe and no text," she

The backdrop of Ukraine and Gaza and as such, the question as to how much the Security Council has been able to deliver on peace and security, with both feet firmly fixed in the past is a larger question.

She said the negotiations should be based "on text and not through speaking as each other or past each other as we have done for the past three decades".

Explosion reported near commercial ship off Yemen coast

n a milestone development, the Dharavi Redevelopment Project Pvt. Ltd. (DRPPL) will embark on a 'digital survey' of lakhs of informal slum residents of Dharavi on March 18, officials said.

The DPPL -- a joint venture between the Adani Group and Maharashtra government -- will create a 'Digital Dharavi', or an advanced library of one of the world's largest slum settlements.

It will be used by the state government to determine the rehabilitation eligibility criteria of this chunk of Dharavi residents in the proposed redevelopment project.

The survey by DRPPL and the state government will be one of the largest urban rejuvenation projects in the world, and will be the first step towards making Mumbai 'slum-free', said an official spokesperson for the joint venture. "It is the beginning of transforming Dharavi into a world-class township, a state-of-the-art city within Mumbai. We urge all Dharavikars to support this exercise, which will enable us to execute the rehabilitation process and ultimately provide them with their dream home," said the DRPPL spokesperson.



The digital survey will begin from the Kamla Raman Nagar, and a unique number shall be given to each informal tenement, followed by a laser mapping of the respective lane, known as 'Lidar Survey', and a trained team will visit every tenement with an indigenously developed

application to scan the documents.
The DRPPL has also activated a
toll-free helpline number (1800-2688888) to respond to the queries and
concerns of the Dharavikars, the
spokesperson added.

For decades, Dharavikars have been waiting for redevelopment to

commercial establishments, and the digital survey marks the process of transforming Dharavi into a world-class township that will reshape the

Dharavi will enjoy a five-year holiday in State Goods and Services Tax (SGST) payment to boost and help formalise their businesses, which is also as per the tender conditions (IANS, February 26). Dharavi encompasses several thousands of industrial and commercial units manufacturing garments and leather items, with many being vendors for large national and international brands sold across the world, with a turnover estimated to be in millions of dollars.

They are keen to formalise their businesses to expand and get a fillip, both locally and globally. The DRPPL has engaged world-renowned city and infrastructure planning experts - the US-based design firm Sasaki, and the UK-based town planners Buro Happold - to design a world-class city in place of Dharavi.

It will be a human-centric transformation, rebuilding spaces and reinventing the very essence of community living, dovetailing state-of-the-art imperatives of transportation connectivity, electricity, water, and internet while enabling a hygienic environment with civic amenities.

Mumbai coastal road to save USD 100 million annually in carbon emissions: BMC chief

The opening of the coastal road's south-bound carriageway between Worli and Marine Drive will reduce travel time from 40 minutes to just 9 minutes and save nearly USD 100 million annually in carbon emissions through fuel savings, Mumbai civic chief Iqbal Singh Chahal has said, reported a news

The first phase of the Mumbai coastal road project was inaugurated by Chief Minister Eknath Shinde on Monday morning. The public has been allowed to use it from 8 am on Tuesday.

"The travelling time will be reduced from 40 minutes to 9 minutes now, and it would save nearly USD 100 million annually in carbon emissions through fuel savings," Chahal said on Monday.

The Mumbai coastal road of 10.58 km length and 16.5 km of interchanges, being built at a cost of Rs 14,000 crore, consists of four lanes on each side along with two 12.19 metre diameter tunnels of 2.07 km length, he said. These are the largest tunnels by diameter built by tunnel boring machines in the country, Chahal said.

"It is for the first time in India that a four-lane coastal road has been built 100 per cent on land reclaimed from the sea and stands on

monopiles only," he said.
"The project has been
executed by the
Brihanmumbai Municipal

Corporation (BMC) in record time as the actual construction work commenced only in June 2020 after vacation of stay order by the high court even though work order was issued in October 2018. The northbound carriageway of the coastal road will be ready by May 2024," he said.

The Mumbai coastal road will have 175 acres of coastal gardens that will be developed over time, said Chahal, who is the BMC's administrator.

Maha govt constitutes SIT to probe violence during Maratha agitation

The Maharashtra government has constituted a Special Investigation Team (SIT) to investigate the allegations of conspiracy and violence during the Maratha agitation in Maharashtra. Nashik Commissioner of Police Sandeep Karnik will be the head of the SIT, reported a news agency.

The SIT was formed on the instructions of the Maharashtra assembly speaker after the matter of threats issued to Deputy Chief Minister Fadanvis was raised in the Assembly by BJP MLAs. On February 28, speaking in the Maharashtra Legislative Council, CM Eknath Shinde said "Many leaders have on the issue of Martha reservation, Jarange patil raised demands for Maratha reservation he didn't had any political background and even I went to him. Keeping all the protocols aside I visited him twice. But now he is making remarks against DCM, our ministers and on the government... why? He is using low level language against the DCM, this language is not of karaykarta it's a political language. There are many other castes leaving in the

state but this is an attempt to creat conflict between castes too. We won't tolerate such language against anyone. So let SIT investigate the matter and let the truth come out (doodh ka doodh paani ka pani hone do)."

"We have given reservation to Maratha and it will stand in the court too all the guidelines and norms of court has been studied properly and accordingly. We have given reservation, there is no injustice done on any other community but people are spreading rumours that this reservation won't stand in court why? Who is spreading this?" the Maharashtra CM said.

Jarange-Patil's Maratha reservation campaign is accused of receiving financial support from 'political associates,' and it is alleged that he made inflammatory remarks during the course of the campaign.

The Maharashtra State Government had indicated that if Jarange Patil's Maratha agitation for the Maratha Reservation is politically motivated, funded, and intended to cause unrest, a comprehensive SIT inquiry would be conducted to assess its implications on law and order in the state.



Hardik Pandya picked figures of 2-22 on his return to competitive cricket action after almost four months at the D.Y. Patil T20 Cup, where he captained Reliance 1 in the opening game of the competition against Bharat Petroleum Corporation Limited (BPCL).

Pandya was out of competitive cricket action after sustaining a left ankle injury during India's league match against Bangladesh in the 2023 Men's ODI World Cup in Pune on October 19. Shortly after, he was ruled out of the campaign and put on a long recovery plus



rehab route to ensure his long-term availability for future events.

In December 2023, he was traded to Mumbai Indians from Gujarat Titans and became the side's skipper, replacing five-time championship-winning captain Rohit Sharma in the top job ahead of IPL 2024, starting on

Mumbai Indians will play their first match of the season against Gujarat Giants on March 24 at Ahmedabad.

LCT provides opportunities for retired players to continue playing: Harbhajan Singh

Sharing his experience from the league, Singh highlighted its significance for retired players and said, "Leagues have started happening with retired players for the past two to three years. It provides opportunities for retired players to continue playing in a competitive environment, whether they're colleagues from abroad or the national team

He also hailed the LCT 90ball format for offering a balanced cricketing experience. "The LCT 90 format adds a new dimension to the game. "It strikes a fine balance between length and skill, allowing players to showcase their talents across various aspects of the sport."

"It's different from other formats, with four power plays and the option for the batsman to choose their powerplay between 10 to 15. Additionally, the best bowler can bowl four overs, making it favourable for retired play-



ers," he explained. Reflecting on his initial reaction to the 90-ball format, Singh noted the simplicity of the options available "Whenever a new format is introduced, it takes time to adapt. However, as a batsman, having the choice of powerplay against strong bowlers is advantageous," he remarked. Singh also praised the format for allowing longer gameplay compared to T10 cricket. "In T10, there's limited time for play, but in the LCT 90 format, longer play is possible. This works to our advantage, especially when we have strong bowlers like Malinga," he added. Unlike the rapid pace of T10 cricket, LCT 90 encourages a strategic approach, fostering intense battles between bat and ball. Singh highlighted the format's capacity to challenge players, elevating the quality of competition and spectator engagement. As Legends League Trophy Season 2 unfolds, Harbhajan Singh's support for the LCT 90 ball format is expected to spark discussions within the cricketing community. With his esteemed reputation in the sport, Singh's advocacy validates LCT 90's potential to redefine limited-overs

Ranji Trophy: Musheer Khan surpasses Sachin to become youngest Mumbai batter to score century in final

Team Absolute Mumbai usheer Khan broke legendary Sachin ▲Tendulkar's 29-year old record to become the youngest Mumbai batter to score a century in the Ranji Trophy final against Vidarbha, here at the Wankhede Stadium.

Aged 19 years, 14 days Musheer scored 255 balls hundred in the second innings of the Mumbai in the final. Sachin held the record for the youngest Mumbai batter to hit a Ranji final hundred when he scored twin centuries against Punjab in the 1994/95 season, a month short of his 22nd birthday, which helped Mumbai win the title.

Incidentally, Sachin was also present in the stands at the time when Musheer achieved the milestone, watching the youngster break his record.

Mumbai went into the second day of play, having gained a 119-run lead in the first innings. As openers Prithvi Shaw and Bhupen

Lelwani fell short, Musheer and captain Ajinkya Rahane braved a top-order wobble. Both players achieved their half-centuries, bringing the

overnight. After Rahane was dismissed for 73 on day 3, Musheer, continued to amass runs alongside Shreyas Iyer. In the 90th over of the match, Musheer achieved his second First-Class ton in three games. However, his scintillating innings ended for the score of 136 when he was trapped lbw by Harsh Dubey at the stroke of Tea.

Earlier, Sarfaraz Khan's younger brother Musheer turned his maiden First-Class century into a double ton during the quarterfinal match against Baroda. He became the second-youngest batter from Mumbai to accomplish the record after Wasim Jaffer.

ICC Player of the Month for February

ndia batter Yashasvi Jaiswal has been named the ICC Men's Player of the Month for February 2024 while Australia allrounder Annabel Sutherland won the corresponding ICC Women's Player of the Month award. For Yashasvi Jaiswal, the month was a canvas upon which he painted his brilliance with the strokes of his bat. Jaiswal was on top of his performance with a double-century (209) in the first inning of the second Test at Visakhapatnam and then slammed his second doublehundred of the series in the second inning (214) of the third Test. Jaiswal scored 560 runs in his first three Tests, including an astonishing 20 sixes. Jaiswal's innings helped India make a comeback in the series after losing the first Test. The back-toback double hundreds at the age of 22 years and 49 days made him the third youngest batter in the world to record two double centuries in Tests after Sir Donald Bradman and Vinod Kambli. "I'm really happy to achieve the ICC award and I hope I will be getting more in the future," Jaiswal said to ICC. "It's one of the best and this is my first five-match series series. I really enjoyed it, the way I have played and the way it's been and we won the series by 4-1. It's been an incredible experience with all my mates And I really enjoyed it," he added. Jaiswal also rated his Rajkot knock of 214* as his crowning achievement. "I think when I celebrated my double century in Rajkot, I think that was something which I really enjoyed and felt. And I was, I was living," he added. The young Indian opener created several records in February and equalled the



long-standing Test record for most sixes in a Test inning (12) during his Rajkot knock. To his credit, he carried his form into March, reaching the milestone of 1,000 Test runs, becoming the second-quickest Indian to the landmark. Meanwhile, Australia all-rounder Annabel Sutherland became the fifth Australian player to claim the ICC Women's Player of the Month Award, joining the esteemed ranks of previous winners Alyssa Healy, Rachael Haynes, Tahlia McGrath and Ashleigh Gardner. Sutherland rewrote the record books with her marathon double century in the one-off Test against South Africa. Her blistering knock of 210, achieved in just 248 balls, set a new benchmark for the fastest double century in Women's cricket surpassing fellow Australian Karen Rolton (306 balls). "It's a massive honour to be named the Player of the Month and a nice way to cap off a successful home summer for the team," Sutherland said to ICC. "South Africa are always a strong opponent and to be able to perform against them in a home Test is something I'm proud of.



"40 years in the industry has not been a cakewalk, it has been quite a struggle. Apart from being a fashion designer, I am also a costume designer, a housewife, and a mother. Being able to juggle these roles and seamlessly transition from one role to another was quite a task, Lulla told , when asked about her 40 years in the fashion industry.

The designer, who has worked on over 300 films and has been designing wedding dresses since 1985, said that "time management and good organisational skills can be an asset.""Luckily for me, my workplace was my home in the beginning, and later on, it was closer to home, so it was a huge advantage,

and it helped me manage both my roles at work and home," added Lulla.

The designer, who has been feted with the National Film Award for Best Costume Design in 2009 for 'Jodhaa Akbar' and 2012 for the Marathi language film 'Balgandharva', talked about being a female designer in the industry.

Lulla said that "gender inclusivity has always been a norm in our industry."

"Back when I started working, we had many stalwarts, who were working in the films and the industry - and they were women. We had a good space in those times, where there were no restrictions to only men. At that point, many women were managing the creative aspect of costume and fashion design, for female actors."

For male actors, it was a male designer, said Lulla, who crafted an unforgettable pearlencrusted lehenga for actress Aishwarya Rai Bachchan's mehendi ceremony.

"But today, there is a lot more room and inclusivity where male designers design for women and female designers design for men



have gotten in the scene and it has always been a common aspect of the industry from that time," she added.

Over her 40 years run in the industry as a fashion stylist and a costume designer, Lulla has created the look for leading Bollywood

personalities including Late star Sridevi, Juhi Chawla, Kareena Kapoor Khan, Shilpa Shetty, Deepika Padukone, Priyanka Chopra Jonas, Rajinikanth, Shah Rukh Khan and Hrithik Roshan. How is it working with the Indian

"It has been a beautiful journey working with the Indian Film Industry. This year marks my 40th year in the fashion industry and in 2026, it will be my 40th year in films.
