

WON'T ALLOW THIEVES TO HAVE A SOUND **SLEEP, WILL EMPTY THEIR COFFERS: PM MODI**

rime Minister Narendra Modi on Tuesday said that the 'looters' of public wealth will have a tough time and his government in the third term will not only deprive them of a sound sleep but also empty their coffers.

PM Modi's stern message for 'looters and plunderers' came at a public rally in Jharkhand's Koderma and was directed at the rampant corruption under the INDIA alliance government in the state

Notably, a mountain of cash, amounting to Rs 35 crores was recovered during ED raids from the servant of the personal secretary of Jharkhand Congress minister Alamgir Alam.

"I will not let the thieves sleep peacefully. I will take away their sleep and also empty their coffers. You are the owner of this money. No one can steal or loot it. Our govt is taking strict action against them," said PM Modi at the public rally and added that his political rivals are peeved over him because of this. "It's because of our government's zero-tolerance on corruption, INDI alliance is hurling



abuses at me," he said.

He held the 'Shahi Parivaar' responsible for criminals and ruffians 'gaining ground' in the state and exploiting people for their personal prosperity. "I had said from the Red Fort, I will spend my life to free the country from corruption, nepotism and appeasement. The INDI alliance of JMM-Congress-Left is the biggest model of all these evils," the Prime Minister pointed out.Notably, PM Modi was addressing the public rally

in Jharkhand, hours after filing the nomination from the Varanasi Lok Sabha constituency in UP.Addressing the huge gathering, PM Modi listed out many milestones of his government and explained how the Centre's welfare policies were benefitting the people."Rs 5 lakh free medical treatment is our guarantee for all. Our government has built 4 crore houses for the poor and marginalized, after returning to power, we will ensure that others also get this benefit. In

Koderma alone, 1.25 like puccas houses have been built," he informed,

drawing applause from the gathering. "In the third term, free ration for 80 crore people will continue for another five years while farmers will continue to get the benefits under Kisan Samman Nidhi Yojana," he added.

He also slammed the ruling dispensation in Jharkhand and said that despite the state being a powerhouse of mining resources, the locals haven't benefitted from it.

Earlier, May 14 (IANS) Prime Minister Narendra Modi on Tuesday declared his total assets amounting to Rs 3.02 crore in his poll affidavit filed along with his nomination papers for the Varanasi Lok Sabha constituency. According to the affidavit, PM Modi

has Rs 52,920 in cash and fixed deposits worth Rs 2.85 crore in the State Bank of India (SBI).

The gross total value of his assets is Rs 3,02,06,889. He has not declared any immovable assets. The Prime Minister doesn't own a house or a car, the affidavit said.

As per the document, PM Modi's income increased from Rs 11.1 lakh in 2018-19 to Rs 23.56 lakh in 2022-

Sharing the video, Rahul tweeted, "Amethi and Raebareli are not just Lok Sabha seats for us but also our karmabhoomi. Whenever the residents of these constituencies remember us, we will be right there."

The video features the then pictures and clippings of Indira Gandhi, Rajiv Gandhi and Sonia Gandhi at the hustings in these con-



stituencies. Over the next few days, the party is likely to push this narrative not just on social media but also promote it aggressively on the ground. With the initiative, they seek to renew the Gandhi family's age-old connection with people in these bastions and also woo the fresh voters by showcasing the family's 100-year-old 'seva' there.

Priyanka has already been vigorously campaigning in these two constituencies by holding public meetings and organising the nukkad sabhas.

She has been setting the tone of the campaign by asserting from various platforms on how the four generations of the Gandhi family stood with the people of the constituency.

Bhupesh Baghel, former Congress CM, addressing a public gathering today, also invoked Indira Gandhi and said that the people of Raebareli will not just vote for electing a Lok Sabha member but for electing the country's next Prime Minister, this time.

n a major breakthrough, the Pune zonal unit of the Directorate General of GST Intelligence (DGGI) has busted a multi-state fake input tax credit (ITC) racket worth over Rs 145 crore and arrested one person from Rajasthan, official sources said here on Tuesday.

The operation was carried out by the Pune zonal unit over the weekend after starting a probe involving some firms in Pune and Goa, and finding that the tentacles spread across Maharashtra, Rajasthan, Delhi, Karnataka, Tamil Nadu and Telangana, with the possibility of other states not ruled out.

The sources said that the scam involved



Kumar, the alleged mastermind of the bogus firms and the whole racket, was operating from Jaipur. "We finally traced his exact location based on some e-commerce deliveries and SIM operators' inputs. The team raided his home on Friday, found incriminating evidence and arrested Kumar," said a DGGI Pune zonal unit official.

The GST sleuths also uncovered his unique modus operandi whereby they created many fake identities of proprietors/authorised signatories, using SIM cards based on forged Aadhar cards to have full control of filing the GST registrations, returns, payments, cancellations, getting OTPs, etc at any time as per their convenience.Kumar was produced before a Jainur court, which granted tra sit remand, and was brought to Pune where a Chief Judicial Magistrate's Court sent him to 14 days remand on Monday. The sources said that further investigations are underway to trace out more fake firms that may have been created for committing fraud, the involvement of other associates/scamsters in this racket, mapping the end beneficiaries and recovering the cheated amount.

50 bogus firms which used fake/morphed/amended copies of documents and then claimed huge amounts of ITC without any actual supply of goods.

The sleuths of the zonal unit probed the CDRs, CAFs, and pattern of filing returns and analysed bank accounts to conclude that the syndicate, operating from different cities/states in the country, was creating bogus firms using aliases or fake identities



using forged legal documents and even by-passing the unique biometric requirements for issuing SIM cards.

This bank is under the control of the CPI(M), which is a big force in Kasargod, the northernmost district of the state

On Tuesday, following a complaint from the president of the society, the local police

swung into action and registered a case against the secretary -- K. Ratheesan, a top CPI(M) leader in the locality Ratheesan has been suspended and is presently on the run.

The police have named Ratheesan as the sole accused. He is alleged to have given gold loans on fictitious names and extended loans to some without taking

Viral Sandeshkhali video: Calcutta HC bars police from taking coercive action against BJP leader



single-judge bench of the Calcutta High Court on Tuesday barred the West Bengal Police from initiating a probe or adopting coercive action in connection with a sting operation involving a local BJP leader from Sandeshkhali, which had gone viral recently

In the purported video, local BJP leader Gangadhar Kayal could be heard claiming that the protests staged by the women against alleged sexual harassment by local Trinamool Congress leaders in Sandeshkhali were orchestrated by the BJP.

On May 10, Kayal approached the single-judge bench of Justice Jav Sengupta, claiming that his voice was doctored in the video using artificial intelligence.

In his plea, he also sought protec-



tion from coercive action against him by the state police.

On Tuesday, Justice Sengupta's bench barred the state police from

initiating a probe or adopting coercive action against Kayal for the time being. The matter will next come up hearing on May 17.

After the video surfaced on May 4, Kayal, a mandal president of the BJP in Sandeshkhali, first approached the CBI claiming that his voice was doctored in the clip using artificial intelligence.The CBI, following an order from the Calcutta High Court, is already conducting a probe into the complaints of sexual harassment, illegal land grabbing, and extortion in Sandeshkhali by a section of the local Trinamool Congress leaders.

Referring to the ongoing CBI probe which is court-monitored, Justice Sengupta on Tuesday questioned the basis on which the FIR was registered against Kaval in the matter. He also said that the FIR could have been registered after obtaining the necessary permission from the judicial magistrate.

Advocates cannot be sued under Consumer Protection Act for professional negligence: Supreme Court

he Supreme Court on Tuesday ruled that advocates cannot be held liable under the Consumer Protection Act for deficiency of services.

A bench presided over by Justice Bela M Trivedi said that the very purpose and object of the Consumer Protection Act, 2019 was to provide protection to consumers from unfair practices

and unethical business practices only, adding that the legislature never intended to include professions or professionals under the statute.

"We have distinguished 'profession' from 'business' and 'trade'. We have said that a profession would require advance education and training in some branch of learn-

ing or science. The nature of work is of skilled and specialised one, substantial part of which would be rather mental than manual.... a professional cannot be treated equally or at par with a busi-



nessman or a trader or a serv ice provider of products or goods as contemplated in the Consumer Protection Act" said the bench, also comprising Justice Pankaj Mithal. However, the Apex Court

clarified that an advocate could be sued for professional negligence in an ordinary course of law.

Earlier in 2007, the National Consumer Disputes Redressal Commission (NCDRC) had ruled that the services rendered by advocates fall under the purview of the Consumer Protection Act.On appeal, the apex court, in an ad-interim order passed in April 2009, staved the implementation of the NCDRC ruling during the pendency of the appeals.

up this entire matter. The mother of the victim girl also complained about the role of the sub inspector and the police also registered a case. Finally, Sub Inspector Prakash Singh Rajput has been taken into custody by the police.

ONE POLLING PARTY MEMBER KILLED IN **BUS-TRUCK COLLISION IN MANDSAUR**

Bhopal: One member of a polling party was killed and nine others injured when the bus they were travelling in met with an accident in Madhya Pradesh.

The incident occurred on Tuesday morning when the polling party was returning from the polling booth to Mandsaur district headquarters.

Mandsaur was among the eight Lok Sabha seats where the fourth phase of Lok Sabha elections was held on Monday.

Police said the private bus collided with a truck on the Muvasara-Mandsaur highway. A home guard died on the spot and those injured in the collision were rushed to a nearby hospital

The condition of three of them was critical, police said.

same time, votes were also sought through sending audio-video messages on mobile and through Twitter. 8.5 thousand rupees were spent on this. Arun spent a total of Rs 7.45 lakh through other ads. BJP's Alok Sharma stood second. Whose expenditure was Rs 83 thousand, which is only 10 percent of Arun Srivastava's expen-

This payment has also been added to the election expenses. For this, Collector Singh has sent a report to the Nodal Officer of Expenditure on Monday. On the other hand, other candidates uploaded videos on social media but did not spend money on it.

A total of 22 candidates were in the fray for Bhopal Lok Sabha seat. He made his election videos very viral on Instagram and Facebook, but other Congress candidates also got their videos boosted. 



ig news has come for those who go to visit and worship at the famous Bijasan Mata temple of Sehore. Vehicular movement has been restricted in Salkanpur. This restriction has been imposed due to Devi Public Works work in Salkanpur temple complex. Devi Lok is being developed here by Madhya Pradesh State Tourism Development Corporation for which many constructions are being done. For this reason vehicles have been banned in the temple premises.

Vehicular movement has been banned in the Salkanpur temple complex till June 13. An order in this regard has been issued by Additional District Magistrate Vrindavan Singh. The special thing is that during this period there will be no ban on vehicles on Saturday and Sunday

According to the order, a ban has been imposed on cars, bikes etc. on the road access road to Salkanpur temple. Now no vehicle will be able to ply from entrance number 1 of Salkanpur Devi Temple to the temple on Rehti-Budni road. This order has been issued under Section 144 of the Code of Criminal Procedure 1973 in view of the public interest and safety of life and property. Till June 13, only vehicles engaged in



construction work or government vehicles will be able to come here.

The Salkanpur temple complex is being developed as Devi Lok Salkanpur temple. Many constructions are being done for this by Madhya Pradesh State Tourism Development Corporation. Along with material and columns etc., stone statues are also being installed for the construction work in the Salkanpur temple complex. Necessary arrangements are being made by the construction agency at the road entrance of the

temple. The order of ban on cars and bikes will be strictly implemented by the police. This order of ban on vehicles will remain in force from Monday to Friday. All vehicles will be free from this restriction on Saturday and Sunday. The district administration has also said that there will be exemption from restrictions on vehicles on any special day or festival etc. This order of ban on cars and bikes will remain effective till June 13, 2024. Violation of the order will be considered a punishable offence.

For timely transportation of organs, green corridors were created on Sunday between Alchemist Hospital, Panchkula, to Max Hospital Saket, Delhi, and PGIMER as well. *Neeraj Goyal, associate director (kidney* transplant), Alchemist Hospital, said the significance of organ transplantation in restoring health and vitality to patients. *While emphasising the importance of* awareness regarding organ donation, Medical Superintendent Paramjit Maan said many precious lives could be saved through transplantation. It is expected that soon the importance of joint family will start increasing again in the society and awareness will spread among people that they should live together in a family which has many benefits. This step and resolution of life taken in the name of human relationships and family tradition will be a unique gift to the family in welcoming tomorrow.

No exemptions for India firms, says US on Chabahar deal

Indian is first international UN employee killed in Gaza conflict; Guterres condemns attack

Arul Louis United Nations n Indian working for the United Nations in Gaza has become the first non-Palestinian staffer to be killed during the current Gaza conflict when his



earlier worked for the Indian Army. Israel Defense Forces said that according to an initial inquiry, Monday's attack happened in an active combat zone and that it was not made aware of the vehicle's Russia aiming to build buffer zone near Kharkiv: ISW

vehicle was attacked on its way to a hospital in Rafah. The victim was identified as Col. Waibhav Anil Kale, who had started working a month ago as a security coordinator for the UN in Gaza, according to The Washington Post, which quoted unnamed informed sources.

Kale, who worked for the UN Department of Safety and Security (DSS) joins the roster of more than 200 Indians who have died in the service of the UN.

The majority of them - 179 - are peacekeepers but many other Indian civilians, who like employees of the DSS are not peacekeepers, have died working for the UN in various capacities in trouble spots.

Earlier, Secretary-General Antonio Guterres's Spokesperson Farhan Haq, who announced the death, did not identify him pending notification to his family and government.

Haq said that Guterres condemned the attack and called for a full investigation.

Another UN employee was injured in the Monday attack, he said.

The blame for the attack has not been fixed because the situation remains murky in Rafah.

Haq did not say who carried out the attack.

Al Jazeera broadcast clips showing windows with bullet holes on the attacked vehicle flying UN flags and bearing large UN markings.

From the nature of the damage, it did not appear to have been an air or heavy artillery attack.

He said that Monday's victim was the first international employee of the UN killed in Gaza since October 7, although 188 Palestinian employees of the UN Relief and Works Agency (UNRWA), the UN arm for humanitarian services for Palestinians, have been killed.

"We will be working with the authorities on the ground to get restitution for all of those who have been killed," Haq declared. The Post said that according to its

sources, Kale was a 46-year-old father of two teenage children.

Other media reports said that he had

Haq said that the DSS staffers were in the vehicle with clear UN markings that was in a convoy engaged in "their regular work [for which] they go to different locations to assess security conditions. And this was the European Hospital in Rafah".

Asked what the UN was doing to seek justice for the UN employees killed in the conflict, Haq said, "In all cases, we are going to set up measures for accountability".

"A lot of that, as you know, requires ultimately for an end to the conflict so that we can work these out," he said.

Guterres reiterated his call for a humanitarian ceasefire and the release of the hostages taken by Hamas, which sparked the conflict with an attack on Israel in which about 1,200 people were killed and 128 were kidnapped.

Israel's retaliation on Gaza, from where Hamas launched the attack, has killed about 34,000 Palestinians, most of them women, children or the aged.

Last month, four foreigners and three Palestinians working for a non-profit organisation, were killed in Gaza.

Russian forces advancing near Ukraine's north-eastern city of Kharkiv will likely limit their push to the rapid creation of a buffer zone between the two countries, according to US military experts. That goal is apparently being prioritised over a deeper offensive into the Kharkiv region, the Washington-based Institute for the Study of War (ISW) wrote in its latest report on Monday. Geolocated footage published on May 13 shows that Russian forces that crossed the border last week had entered Hlyboke, some 30 kilometres north of Kharkiv, and raised a flag in the centre of the village.

Further images showed that Russian troops had advanced southwest of the village of Oliynykove. The Ukrainian General Staff reported that Russian troops had achieved some success near Lukyantsi, also just to the east of Hlyboke.

Russia launched an offensive into the Kharkiv region on May 10, after which the Defence Ministry reported the capture of several villages.

According to Ukrainian President Volodymyr Zelensky, the military is doing everything in its power to prevent Russia from expanding the front and has launched counterattacks.

"The area has been reinforced," Zelensky said in his evening video message on Monday. Russian forces that invaded Ukraine in February 2022 initially took large areas of the Kharkiv region but not the city itself before being driven back by a Ukrainian counter-offensive that autumn. Kharkiv is Ukraine's second-largest city, with a pre-war population of 1.4 million people.

few hours after India and Iran signed a 10-year agreement regarding the Chabahar port, the US has said there will be no exemptions for Indian firms dealing with Iran from sanctions already in force.

This signals a dramatic shift away from the previous exemption from sanctions granted by the Trump administration in 2018 when the then-president rescinded the Iran nuclear deal signed by his predecessor President Barack Obama.

Vedant Patel, the Principal Deputy Spokesperson for the US State Department, told reporters on Monday that while the agreement was a bilateral matter between India and Iran and that India was free to run its foreign policy the way it wants, "any entity (or) anyone considering business deals with Iran ... need to be aware of the potential risks that they're opening themselves up to the term risk of sanctions".

Asked if there will be no exemptions, the Spokesperson said, 'No."

He was responding to questions on the agreement signed by New Delhi and Tehran that allows India to operate the Chabahar port for 10 years.

4,000 animal and plant species affected by smuggling worldwide

Wildlife trafficking has not substantially reduced over the past two decades, despite positive signs in reducing trafficking of iconic species like elephant and rhino, the UN Office on Drugs and Crime (UNODC) reported in Vienna on Monday.

"The global scope and scale of wildlife crime remain substantial with seizures during 2015-2021 indicating an illegal trade in 162 countries and territories affecting around 4,000 plant and animal species," the office's third edition of the World Wildlife Crime Report says.

During the six-year period, around 13 million individual animals and plants had been

It further corrodes good governance and the rule of law through corruption, money-laundering and illicit financial flows," the agency said.

Zelensky asks Blinken for Patriot air defence of Kharkiv

Krainian President Volodymyr Zelensky has asked US Secretary of State Antony Blinken for Patriot air defence systems for Kharkiv, which is routinely threatened by Russian missiles.

Two of these systems are necessary to protect Ukraine's second biggest city and its surrounding area, which borders Russia, Zelensky said in Kyiv during Blinken's surprise visit.

US assistance for the campaign against the Russians was of crucial importance, and air defence was the "biggest deficit," Zelensky said.

According to Ukrainian media reports, to



Blinken promised Ukraine weapons aid that could change the situation on the battlefield.

Blinken said on X: "I returned to Kyiv today to demonstrate our unwavering sup-

port for Ukraine as they defend their freedom against Russian aggression."

The visit, which, as usual, was not announced for security reasons, is Blinken's fourth since the start of the war in February 2022 and is also the first visit since the US approved a long-delayed aid package of \$61 billion.

Ukraine has been on the defensive for months due to a lack of weapons, ammunition and soldiers.

Russia has been bombarding Kharkiv, and last week Russian troops also began a ground offensive on the border and have already captured several Ukrainian villages.

After 14 deaths, axe to fall on illegal hoardings dotting Mumbai

day after a gigantic hoarding, measuring 120x120 or 14,400 square feet crashed killing At least 14 persons, the Mumbai Suburban District Disaster Management Authority (MSD-DMA) has decided to wield the axe on all illegal hoardings that violate various norms, an official said. As per the MSDDMA orders issued late on May 13, the concerned local authorities have been ordered to raze three other huge hoardings in the vicinity of the monster hoarding, owned by one Bhavesh Bhinde of EGO Media Co., that suddenly tumbled in the heavy winds and dust-storm.

Simultaneously, Mumbai's Pant Nagar Police Station has lodged a complaint against Bhinde invoking charges of culpable homicide not amounting to murder.

Bhinde has been reportedly absconding since Monday night and police have started a probe into the incident.

As per some reports, the EGP Media Co. was earlier "blacklisted" by the Central Railway (CR) and it is not clear how the firm was allowed to erect the mammoth hoarding, billed as the biggest in Mumbai, and commanding a huge hiring price from the advertisers.

The hoarding, weighing hundreds of kilos along with the supporting metal rods and girders, got uprooted in barely seconds in the squally winds, and crushed several homes and a petrol pump in Pant Nagar area of Ghatkopar east, with the current casualties standing at 14 deaths, plus 88 injured



and around 60 more rescued.

The BrihanMumbai Municipal Corporation (BMC) official said that the civic body is scrutinising its records to ascertain the exact number of mega-hoardings that flout the norms and bring them down immediately.

As per the norms, considering the Mumbai skyline and other aspects - like the location, height from the ground, other structures in the vicinity, the material it is made of, etc. - the hoarding size permitted is 40x40 feet (1,600 sq.feet), explained the official

The permission for the hoarding was allegedly given by the then Railway Police chief Quaiser Khalid, and the Bharatiya Janata Party has alleged that the accused Bhinde is reportedly linked with the opposition Shiv Sena (UBT) leaders. Last evening, Chief Minister Eknath Shinde visited the tragedy site and ordered the BrihanMumbai Corporation and Mumbai Police to thoroughly investigate the incident, carry out a special audit of all illegal hoardings across the city and take remedial measures.

An ex-gratia of Rs 5 lakhs for kin of deceased

Mumbai: Maharashtra CM Eknath Shinde, addressing the Ghatkopar hoarding collapse incident, stated that the government would cover the expenses of the injured and provide a Rs 5 lakh ex-gratia to the families of the deceased. Expressing sorrow over the Ghatkopar hoarding collapse, CM Shinde assured support to the injured and announced compensation for the victims' families.

"It is a painful and sad incident, I visited the spot yesterday. The government will bear all the expenses of the people injured in this incident. Rs 5 lakh as compensation will be given to the next kin of the victims," said CM Shinde.

According to an ANI report, CM Shinde also promised strict action against the hoarding's owner, stating that a case of culpable homicide has been registered. CM Eknath Shinde said, "Strict action will be taken against the owner of the hoarding. A case of culpable homicide has been registered.'

inancial markets play a crucial role H in capital mobilisation and allocation, and the stability of government is the first criterion for the Indian stock indices to make a difference to the growing economy, Finance Minister Nirmala Sitharaman said here on Tuesday. Addressing an interactive 'Viksit Bharat 2047' session focused on the Indian financial markets at the Bombay Stock Exchange (BSE), the Finance Minister said, that standing here at the BSE, "I want to clearly lay before you that Prime Minister Narendra Modi's third term will be a stable, good governance regime"

"More governance and less government is what we are looking forward to. We are confident that PM Modi will complete his third term where India will become the third largest economy," FM Sitharaman told the gathering.

The performance of the Indian stock market is being aided by a good gross

BSE

domestic product (GDP) growth forecast, inflation being at a manageable level, and political stability at the central government level.

"This has made India the fastestgrowing economy. Most investors who visit India are keen to see where their money can be placed or parked," the Finance Minister said.

India has fared relatively well compared with other countries as far as the government debt to GDP ratio is concerned and the country is the third least indebted nation among low- and middle-income countries (LMIC).

The Finance Minister said the stability in policy -- particularly taxation -- predictability in policy-making and the softtouch regulatory framework are the high points in which markets function without volatility

The performance of India's financial markets has also exceeded people's expectations in the recent past.

"It has performed with distinction at a time when global markets are fluctuating, there is so much volatility, and a fear of uncertainty setting in most markets. Even in this atmosphere, Indian stock markets have performed very well, attracting both foreign and domestic investors," the Finance Minister said.

"The adoption of technology has made a big difference to the performance of the stock market," she added.

Sunil Mathur, Managing Director and Chief Executive Officer, Siemens Limited, said: "Siemens Energy India Limited and Siemens Limited will script new paths as two independent, publicly-listed companies. The demerger will enable both companies to pursue their specific strategies, focus on their core portfolios and to take decisions on capital allocation. This will enable the full value of each of the businesses to be unlocked for the benefit of the shareholders.

The process of demerger, including receipt of requisite approvals, and subsequent listing of Siemens Energy India Limited is expected to be completed in 2025.

Bhima Koregaon-Elgar Parishad case: SC ECI defers biennial polls to 4 Maharashtra grants bail to Gautam Navlakha

he Supreme Court on Tuesday ordered Gautam Navlakha, an accused in the Bhima Koregaon-Elgar Parishad case, to be released on bail. Observing that the completion of the trial would take "years and years", a bench presided over by Justice M.M. Sundresh refused to extend the stay granted by the Bombay High Court on the implementation of the bail order.

However, the Bench, also comprising Justice S.V.N. Bhatti, added a condition that Navlakha should deposit Rs 20 lakh with the authorities at this stage, as a part of the expenses incurred on him during house arrest.

The apex court took note of the submission made on Navlakha's behalf that the activist-journalist



remains incarcerated for over four years and there exists a likelihood of prolonging trial proceedings since charges are yet to be framed in the case. In December last year, the Bombay High Court granted bail to Navlakha, who has been in custody since April 14, 2020, for his alleged links with Maoists. However, a division bench of Justices A.S. Gadkari

and Shivkumar S.Dige of the High Court deferred the implementation of its order for three weeks after the anti-terror agency sought a stay for filing a special leave petition in the Supreme Court. This stay was extended from time to time by the apex court. Navlakha, 73, has been in continuous custody in jail and after a Supreme Court order, was placed

under house arrest in November 2022, on account of his advanced age and health conditions.

Navlakha, along with the other accused was arrested and charged by the Pune Police and later by the National Investigation Agency (NIA) for plotting to overthrow the government and instigating the caste riots at the Bhima Koregaon memorial near Maharashtra's Pune on January 1, 2018 which left one youth dead, and created a political turmoil in the state.

A former office-bearer of the PUDR, he was also accused of Maoist links, furthering the agenda of the outlawed CPI(Maoist), possessing incriminating documents, supporting Kashmir separatists, and other offences. His earlier bail applications were rejected by the Special NIA Court.





Women's cricket: India to host South Africa for multi-format series between June & July

The Board of Control for Cricket in India (BCCI) on Tuesday announced the fixture of South Africa's visit to the country for three T20Is, as many ODIs, and a women's Test match. Chennai will host a women's Test match for the first time since 1976 after West Indies played a red-ball match against India.

After hosting England and Australia last year in Mumbai, the Indian women will play a Test match against South Africa in the home series in June. South Africa previously played a Test match in India back in 2014, when India recorded an innings victory. The home series will start with ODIs in Bengaluru, scheduled for June 16, 19, and 23, as part of the 2022–2025 ICC Women's Championship while Chennai's M.A. Chidambaram Stadium in Chepauk will host the one-off Test and the three T20Is.

The Test match has been scheduled for June 28 to July 1. It will be India's third Test in six months and South Africa's third Test ever. The T20Is are likely to be held on July 5, 7 and 9.

Barcelona's next game is away to already-relegated Almeria, while Real Sociedad face Valencia ahead of a vital game away to Betis, which could decide who plays in Europe next year.

IPL 2024: Ravi Shastri believes 'Impact Player' rule contributed in thrilling finishes



A s the IPL's Impact Player rule drew some criticism from experts, former Indian cricketer and ex-head coach Ravi Shastri favoured the rule saying it has contributed to a number of thrilling finishes in the tournament.

BCCI introduced the Impact Player rule in the 2023 edition of the Indian Premier League (IPL).

"The Impact Player rule is good. You have to evolve with the times," Shastri told Ravichandran Ashwin on his YouTube channel. "You know, it happens in other sports as well. It's got tighter finishes. You have to evolve with the times and I think it's a good rule. You saw the number of tight finishes we had in last year's IPL. So, you know, it has made a big difference."

Jay Shah, the BCCI secretary, himself said last week that the Impact Player rule is "not permanent" and a



call on its use in subsequent editions of the IPL will be taken after a discussion with stakeholders following the conclusion of 2024 T20 World Cup. "Impact Player is like a test case. We have implemented it slowly. The biggest advantage of it is that two Indian players are getting a chance in each game, which is the most important," Shah had told reporters at the BCCI headquarters in Mumbai on Thursday. "We will consult with the players, franchises, broadcasters and take a call. This is not permanent but I am not saying that it will go." While some believe the rule hin-

ders the growth of allrounders, including Indian captain Rohit Sharma, Ashwin gave the example of Dhruv Jurel, who started as an Impact Player in the IPL 2023 and made his Test debut for India a year later.

"You know when any new rule comes in, there will be...people will try and justify why that's not right," Shastri said. "But in time when you see the scores - 200 and 190 - and then like you mentioned individuals grabbing that opportunity and making the most of it, people will start relooking at how they think about it."

Still, DC head coach Ricky Ponting had expressed his satisfaction with the IPL keeping the Impact Player if it was contributing to a "better spectacle" during the competition. However, he acknowledged that as a coach, he wasn't too fond of the regulation, referring to it as a "nightmare". Delhi Capitals (DC) players Axar Patel and Mukesh Kumar were among those who spoke out against

the Impact Player rule.
