## Rape to include marital rape for purpose of MTP Act: Supreme Court

The Supreme Court on Thursday said that all women, including the unmarried, are entitled to safe and legal abortion, and also the meaning of rape must be understood as including marital rape, solely for the purposes of the Medical Termination of Pregnancy (MTP) Act and any rules and regulations framed there under. And, married women may also form part of the class of survivors of sexual assault or rape, it added.

A bench, headed by Justice D.Y. Chandrachud, said it is not inconceivable that married women become pregnant as a result of their husbands having "raped" them and the nature of sexual violence and the contours of consent do not undergo a transformation when one decides to marry.

"The institution of marriage does not influence the answer to the question of whether a woman has consented to sexual relations. If the woman is in an abusive relationship, she may face great difficulty in accessing medical resources or consulting doctors," it added.

The bench, also comprising Justices A.S. Bopanna and J.B. Pardiwala, said the state has a positive obligation under Article 21 of the Constitution to protect the right to health, and particularly reproductive health



of individuals.

"Married women may also form part of the class of survivors of sexual assault or rape... A woman may become pregnant as a result of non-consensual sexual intercourse performed upon her husband. We would be remiss in not recognising that intimate partner violence is a reality and can take the form of rape," said Justice Chandrachud, who authored the judgment on behalf of the bench.

"The right of every woman to make reproductive choices without undue interference from the state is central to the idea of human dignity. Deprivation of access to reproductive healthcare or emotional and physical wellbeing also injures the dignity of women," it added.

Justice Chandrachud said if women with unwanted pregnancies are forced to carry their

pregnancies to term, the state would be stripping them of the right to determine the immediate and long-term path their lives would take.

"The rights of reproductive autonomy, dignity, and privacy under Article 21 give an unmarried woman the right of choice on whether or not to bear a child, on a similar footing of a married woman," it added.

On July 21, the top court had allowed a 25-year-old to abort her 24-week pregnancy arising out of a consensual relationship. In the judgment, the top court dealt with various aspects of the issue, including forced pregnancy. The woman had moved challenged the Delhi High Court, which refused to entertain her request to terminate her 24-week foetus, under Rule 3B, dealing with categories of women entitled to abortion, of the MTP Rules, 2003.

## ADULTERY CREATES PAIN IN FAMILY

The Supreme Court on Thursday said that adultery creates pain in the family and the armed forces should have disciplinary proceedings against their officers for the offence.

A five-judge bench, headed by Justice K.M. Joseph, said adultery can shake discipline, which is of paramount importance, in the armed forces, while adding that family is the unit of the society and everybody is dependent on it. The bench made these observations after Additional Solicitor General Madhavi Divan, representing the Centre, submitted that a plea seeking clarification of the 2018 judgment has been filed. In 2018, the top court, on a plea filed by NRI Joseph Shine, struck down Section 497 of the IPC, dealing with the offence of adultery, holding it unconstitutional.

During the hearing on Thursday, the top court said the 2018 verdict cannot be referred to halt disciplinary proceedings against guilty. The top court was informed that disciplinary actions taken in the Army are gender neutral.

The bench said: "Adultery creates pain in a family. We have held so many sessions as judges in the high courts and seen so many families torn."

The bench further added that armed forces must have some kind of assurance that action will be taken and it should not be the scenario that by citing Joseph Shine (2018 judgment), it is claimed that nothing can be done, as it was informed that the Armed Forces Tribunal (AFT) quashed disciplinary proceedings against certain army personnel charged with adultery, citing the judgement. The bench told the Centre's counsel that it can challenge the individual orders of the AFT. After hearing arguments, the top court has scheduled the matter for further hearing on December 6.

## Won't contest Cong prez poll, Sonia Gandhi to decide Raj CM issue: Gehlot

After over an hour-long meeting with Sonia Gandhi at her residence here, Ashok Gehlot said that he will not contest the Congress presidential poll and the issue of Rajasthan chief ministership will be decided by her.

Gehlot said, "In this environment I don't want to contest and the issue of chief ministership will be decided by the party high command. Whether I remain the CM will be decided by Madam (Sonia Gandhi)... I am a loyal soldier of the Congress from Indiraji's time. I have expressed regret and sadness over whatever happened in Jaipur."

Earlier, while entering Sonia Gandhi's residence at 10 Janpath, Gehlot was seen carrying a set of papers. On one of the papers, it was written -- "Whatever has happened is sad and I am also hurt."

"I have always acted as a loyal soldier of the party. The incident that happened on the day of the legislature party meeting has left everyone shaken. It gave a message as if I wanted to continue as the Chief Minister, so I apologised to her," Gehlot said after the meeting.

The meeting came a day ahead of the last date of nomination for the Congress presidential poll. Ahead of Thursday's meeting, Sonia Gandhi's emissary Mukul Wasnik had met Gehlot.

Congress' initial plan was to field Rajasthan Chief Minister Ashok Gehlot for the top party post, but the high-octane drama in Jaipur has miffed the Gandhis.



## DIGVIJAYA FINALLY JOINS RACE FOR AICC CHIEF

Meanwhile, senior leader Digvijaya Singh to file nomination for the post of Congress president for which election is scheduled to be held on October 17. Sources close to Singh said that the decision to contest the polls was his personal one, and none from the Gandhi family asked him to do so.

The Madhya Pradesh Congress seems to have united to support Digvijaya Singh. More importantly, hours after Digvijaya Singh took the nomination form from the party headquarters in New Delhi and announced that he would file his nomination for the AICC president's election, state Congress head and ex-chief minister Kamal Nath called a meeting of Congress leaders at his residence in Bhopal and asked them to reach Delhi to back Digvijaya Singh.



## MHA orders sealing of three premises linked to PFI in Delhi

After banning the Popular Front of India (PFI) and its affiliates, the Ministry of Home Affairs (MHA) has now ordered the sealing of three premises in Delhi being operated by the extremist organisation.

In a notification issued on Thursday, the Home Ministry has directed Delhi Police Commissioner Sanjay Arora to seal the three premises where illegal activities were being carried out by the PFI.

The three premises include F-30/1B, Ground Floor, Zaid Apartment, near Royal Hotel, Shaheen Bagh, Delhi; N-44A-1, Hilal House, Ground Floor, Abul Fazal Enclave, Jamia Nagar, Delhi; B-27/2 3rd Floor Thokkar No 7 Jamia Nagar, Delhi.

According to information, the process of



freezing the bank accounts of PFI and its associates in Delhi has also been started.

Earlier on Wednesday, the Home Ministry banned the PFI for 5 years, saying that this organisation has links with global terrorist organisations and is involved in many terror cases.

## Strengthening India's military prowess govt's top priority: Rajnath Singh

Defence Minister Rajnath Singh on Thursday said that strengthening India's military prowess has been the Narendra Modi government's top priority ever since it came to power since 2014, with focus on equipping the services with state-of-the-art weapons and equipment through an 'Aatmanirbhar' defence industry.

Terming the armed forces as the very reason behind the strength and confidence of the nation, he said that India's "international image has completely been transformed due to the bold decisions taken by Prime Minister Narendra Modi as well as the gallant deeds of the armed forces".

"There was a time when India wasn't taken seriously on international platforms. Due to the efforts of our Prime Minister, today we have become an assertor from a mere observer. The Indian military is respected all over the globe. Our friendly foreign countries have trust in them. It is one of the major reasons India has emerged as a powerful nation.



Today, we are the fifth largest economy in the world, strongly moving forward," he said while addressing armed forces personnel in Assam's Tezpur.

Rajnath Singh said that the government's efforts have resulted in making a strong military which is fully capable of protecting the nation from all kinds of threats. He lauded the armed forces for instilling

a sense of national pride and patriotism among the people, especially the youth, by displaying their strength and courage from time to time.

He commended the dedication and sacrifice of the soldiers posted at the borders, bravely protecting the sovereignty, unity and integrity of the country.

Defence spokesman Lt. Col. Manish Shrivastava said that the Defence Minister, accompanied by Army chief Gen Manoj Pande earlier on Thursday visited Anini village in Dibang valley of Arunachal Pradesh.

Rajnath Singh made an on-the-ground assessment of defence preparedness along the Line of Actual Control by taking stock of the entire gamut of security-related aspects.

Another Defence spokesman Lt. Col. A. S. Walia said that Singh complimented the soldiers for high standards of professionalism and dedication towards duty while safeguarding the territorial integrity and sovereignty of the nation braving the harsh weather conditions and inhospitable terrain.

## TERRORIST ARRESTED FROM J&K'S SRINAGAR

Srinagar: One terrorist belonging to Ansar Gazwat-ul-Hind (AGH) terror outfit has been arrested in a joint operation by the police and the army from central Kashmir's Srinagar district, officials said on Thursday.

"One categorised terrorist of AGH terror outfit namely Junaid Ahmad Parray of Nawakadal arrested by a joint team of Srinagar Police and 24 RR from Palpora, Srinagar," police said.

Arms and ammunition including one pistol, magazine, and live rounds have been recovered. Police have registered a case under sections of UAPA. Investigation is underway.

## 'HE IS 70 YEARS, IN AN OVERCROWDED PRISON': SC ON GAUTAM NAVLAKHA PLEA FOR HOUSE ARREST

The Supreme Court on Thursday directed the Talaja jail Superintendent to immediately shift Gautam Navlakha, jailed in Bhima-Koregaon case, to Mumbai's Jaslok hospital for treatment.

Senior advocate Kapil Sibal, representing Navlakha, submitted that his client is suffering from ailments. A bench of Justices K.M. Joseph and Hrishikesh Roy told the Centre's counsel: "He is 70 years and an undertrial in an overcrowded prison... Nature of crime is serious, but it is alleged not proved... You want the man to die in jail?"

Centre's counsel replied "No, not all" and submitted that a letter of adjournment was circulated. The bench sought the presence of Solicitor General Tushar Mehta and passed over the matter.

After Mehta's arrival in the court, Justice Joseph told him: "Your humanitarianism is put to test." He replied: "My concern for national integration is put to test", and added that the petitioner is challenging an April order now,



therefore he cannot say the other side should not get an opportunity to file a reply.

Mehta, while opposing Navlakha's house arrest plea, vehemently argued that Navlakha has skin allergy, dental problems, and colonoscopy which are not serious ailments to shift him to house arrest.

He said he did not press the prayer for colonoscopy before the trial court and added that he can visit a dental surgeon of his choice daily. He added that if Navlakha has health problems, then he should be in a hospital and not at his sister's house. Sibal replied that his client is over 70 years old and could be a threat? Mehta pointed out at the possibility of destruction of evidence, if Navlakha's house arrest is allowed and added that he is facing charges under the UAPA for supporting Maoist activities. "This is an abuse of the process of law. I appeal to your lordships' conscience," said Mehta.

After hearing detailed arguments, the top court directed the Superintendent of Talaja Jail to take Navlakha to Mumbai's Jaslok hospital for treatment and required medical check-up and clarified that he remains in police custody.

## NGT seeks to reduce pollution in Ganga from tanneries in realistic manner

The National Green Tribunal (NGT) has directed the Uttar Pradesh Pollution Control Board to take remedial measures to prevent pollution in the Ganga River from tanneries in a "realistic manner".

"UPPCB needs to monitor remedial measures to prevent pollution from tanneries in a realistic manner, issuing guidelines, roster operations, sealing of drums/pedals, cutting down production capacities, closing the tanneries till compliance is achieved," a bench headed by NGT Chairperson, Justice Adarsh Kumar Goel (retd), said in a recent order.

"We may consider the situation of pollution of River Ganga due to untreated/partially treated effluents (sewage and industrial) being discharged through irrigation canal at Jajmau," the order said.

The bench, also comprising Judicial member Justice Sudhir Agarwal, and Expert members Prof A Senthil Vel and Dr Afroz Ahmad was dealing a matter with two issues of water pollution in

Jajmau, an industrial suburb on the banks of Ganga. The first issue relates to the chromium dumpings at Rania, Kanpur Dehat and Rakhi Mandi, Kanpur Nagar which have been in existence since 1976 and contaminating ground water adversely affecting their health and depriving the inhabitants of access to drinking water.

Another issue is continuing water pollution by tanneries discharging untreated industrial effluents, containing toxic chromium into the irrigation canal through an inadequately functioning effluent treatment plant at Jajmau.

The green court note that, on both the issues, some progress has been achieved but still chromium dump remains and effluent continues to be let out through drains.



"Thus, it is clear that health risk remains on account of delayed inaction. UPPCB with other concerned agencies have to ensure that no waste is lying at any other site," the order said.

The green court also directed the state pollution body and the Central Pollution Control Board to immediately find out suitability of setting up of pilot plant model to treat chromium by way of setting up of a filtration process and application of biotechnology to remove chromium as being done at other places for removal of arsenic/fluoride within three months.

# TRP scam spooks again: ED books 16 for money laundering; 'exonerates' Republic TV

The Enforcement Directorate (ED) has virtually 'exonerated' Republic TV and R. Bharat -- English and Hindi news channels owned by Arnab R. Goswami, but the agency has booked 16 others of various private television channels and a market research group, for alleged money-laundering charges in the sensational TRP scam that erupted two years ago.

The ED charge sheet was filed on September 26 on behalf of Assistant Director Pawan Kumar before the Special PMLA Court Mumbai, and has sought initiation of proceedings, among others, to confiscate the provisionally attached properties of all the accused as stipulated under the Prevention of Money Laundering Act, as they were bought from the proceeds of the crime.

The ED has urged the Special Court to take cognisance and issue process against all the accused individuals (for arrest), order the confiscation of their movable and immovable assets, seize their passports, etc. Presumably giving a 'clean chit' to Goswami and his news channels, the



ED termed its investigations under PMLA as "at variance" with the probe initially conducted by the Mumbai Police, as "no such evidence is forthcoming" in the statements of the

accused/witnesses, digital data evidence and analysis of the raw data provided by Broadcast Audience Research Council (BARC). The ED said that the Mumbai

Police -- which had first exposed the scam in 2020 -- relied on a forensic audit report of Acquisory Risk Consulting Pvt. Ltd., that contended how the TRP calculation methodology was tinkered with and controls used to favour specific channels, was superficial and based on analysis of limited aspects.

The Mumbai Police had named Republic TV, India Today and other channels as allegedly involved in the TRP scam that had shaken up the country's media industry and sparked a massive political uproar.

However, the ED probe has detected instances of TRP manipulations not only in Mumbai and Maharashtra but also Kerala, Madhya Pradesh, Karnataka, Assam, Telangana, Andhra Pradesh, and has called for the FIRs filed by the respective state police for investigations. "From the investigations and evidence gathered, it is clearly established that the (16) accused committed the offence of money laundering... and are liable to be prosecuted and punished... and the provisionally attached properties involved in the money-laundering are liable to be confiscated... as per the PMLA," the ED concluded.

## NCB MUMBAI SEIZES 3.20 KG HIGH GRADE BLACK COCAINE COMING FROM BRAZIL

NCB also nabs the carrier and receiver at different cities in an operation spanning 3 days

In an unprecedented enforcement activity, NCB-Mumbai has delivered another blow to the international drug syndicate and seized Black Cocaine from a Bolivian lady at Mumbai Airport and a Nigerian national has also been apprehended from Goa in this connection. The said seizure is rare. In pursuance of credible input wherein it was noted that a South American national would be arriving at Mumbai through flight with a consignment of drugs which would be further passed around Mumbai and nearby states. The input was closely monitored and carefully analysed after which a Bolivian lady was identified to be travelling from Brazil to Goa with layovers at Addis Ababa and Mumbai. Accordingly, the NCB-Mumbai officials proceeded to the Mumbai Airport and a discreet surveillance perimeter was setup to physically identify the Bolivian lady. On 26/09/2022, shortly, after the flight landed, the said lady was identified who was moving around to board the connecting flight to Goa. Thereafter, she was questioned in routine manner about her purpose of visit and contents in her luggage to which she could not give satisfactory reply. Consequently, a thorough search of her luggage led to discovery of false cavities wherein 12 packets tightly packed were recovered. Upon checking the packets,



black coloured substance was found. Upon questioning the lady she confessed that the material is Black Cocaine which weighed a total of 3.2 kgs. She confessed that she was ought to deliver the said consignment to a foreign receiver in Goa.

Immediately, a follow up action scheme was planned to further identify the receiver person in Goa. Intensive follow up activities and techint analysis led to identification of the receiver and a trap was laid out in a hotel in Goa and a Nigerian person was apprehended. The information revealed by the Bolivian lady corroborated with the details of the apprehended Nigerian. Later on, the Nigerian person also confessed about being part of the international drug syndicate. This Nigerian person is a Drug Trafficker who was staying in Goa and supplying drugs to various peddlers in multiple states. Further investigation is in progress.

## Man shoots girlfriend on road, gets killed by vehicle while fleeing

In a shocking double tragedy, a young woman was shot dead by her boyfriend in Boisar town, and as he was attempting to flee the spot, was knocked by a military truck and died later, police said here on Thursday.

The incident occurred on Wednesday afternoon when Neha Mahato, 21, and her boyfriend Krishna Yadav, 25, had a heated argument on the road near a private hospital in Saravali.

Suddenly, Yadav whipped out a revolver and shot Neha in the head from point blank range, killing her instantly.

As the shocked locals rushed there, Yadav panicked and fled the spot but barely a couple



of hundred metres away was knocked down and crushed under the wheels of the military vehicle.

He was rushed to a local hospital by the Boisar Police, where he was pronounced dead.

The Boisar Police have recovered the weapon from Yadav and have sent it for a forensic analysis, and his autopsy report is awaited to ascertain if it was an accident or suicide.

As per police preliminary probe, Yadav and Neha had been going steady for a year but he was not willing to marry her.

Neha's family had given an ultimatum for marriage failing which they would fix her alliance elsewhere.

## Maha Official, Professor Among four Detained For Seeking Bribe From Student

The Anti-Corruption Bureau (ACB) on Wednesday detained a senior official of the Maharashtra government's Directorate of Technical Education, a woman professor and two others for taking bribe to facilitate admission of a student in an architecture college in Thane district, officials said.

The ACB officials also recovered Rs 3,15,000 cash from those detained, which they had collected from 11 students, including the complainant in this case, they said. Deputy Superintendent of



Police (Thane ACB) Ashwini Patil said in a release that the process of registering an offence against the four at the Mira Road police station

under the Mira Bhayandar-Vasai Virar police commissionerate was underway. Those detained were identified as Jitendra Ramdasji

Nikhade Assistant Director of the Technical and Joint Director Divisional Officer at Bandra, Rupali Hitendra Gupte professor at K.L. Tiwari College of Architecture located at Mira Bhayandar, Santosh Rangrai Hubale office superintendent of the college and Shreya Santosh Bane senior clerk. The complainant's daughter was pursuing a course in an architecture college, which shut down. In order to get admission in K.L. Tiwari College and also to grant the change of subject, the principal of the college demanded Rs. 30,000, the ACB said. Professor Gupte asked the complainant to hand over

the money to the office superintendent and when the complainant met Hubale, he made a demand of Rs 30,000 to be given to the Joint Director of Technical Education, it said. After that, the complainant approached the Thane unit of the ACB. Based on the complaint, the anti-graft agency laid a trap at the college office on Wednesday and caught Bane accepting Rs 15,000 from the complainant on behalf of the superintendent and the professor, it said. During the inquiry and the raid, it came to light that the accused had similarly demanded Rs 30,000 from 14 students, the ACB said.

## Keep an eye on closed factories to check drug menace: Navi Mumbai top cop tells officials

Navi Mumbai Police Commissioner Bipin Kumar Singh has asked officials to keep a watch on closed factories in the town to check narcotics are not manufactured there, in the wake of a number of cases of drugs seizure in neighbouring Mumbai in the recent past. During a meeting of the dis-

trict-level narcotics committee on Wednesday, Singh said several containers arrive at Uran and the Jawaharlal Nehru Port Trust in Navi Mumbai, and asked the Coast Guard to keep an eye on them to prevent any movement of narcotics. Singh also directed the officials to check if narcotics were being manufactured at chemical factories in industrial zones in the Navi Mumbai Municipal Corporation limits. He said a large stock of banned drug MD was recently seized in Mumbai and officials should check if drugs were being manufactured in the chemical and pharmacy units in Navi Mumbai. During the meeting, Deputy Commissioner of Police (Crime) Suresh Mengde said 20 out of the total 83 units in Navi Mumbai region have already been inspected and the others would be checked within the next couple of months.

## Man stabbed to death in Mumbai, two arrested

Police arrested two people for allegedly stabbing a person to death in the Mankhurd area, officials said Thursday. They said the police had to rely on

technology to arrest the suspects. The police said in a tweet that they began investigating the case after the deceased's brother complained to them about the stabbing incident. They said there was very little informa-

tion about the incident. The brother of the deceased did not know why someone would kill his brother. So, the police department relied heavily on technical expertise to nab the suspects. "A complaint was received at the Mankhurd Police Station that an unknown person brutally killed the complainant's brother by stabbing him for unknown reasons. In the absence of any evidence, on the basis of information and technical expertise, two accused were arrested and the murder was exposed," the Mumbai Police tweeted. A further investigation is underway.

## SHARAD PAWAR'S ONE STATE TOUR IS ENOUGH FOR OPPOSITION TO RETURN TO POWER: SUPRIYA SULE

Shinde said that the radical Muslim outfit had planned to create unrest and a communal divide.

## Bombay High Court grants bail to JJ Hospital doctor held in fatal car crash

Mumbai: The Bombay High Court has granted bail to a resident doctor of the state-run and city-based JJ Hospital, who was arrested on the charges of culpable homicide not amounting to murder after his car rammied into a motorcycle earlier this year, killing the rider.

A single bench of Justice Bharati Dangre in her order passed on September 26, a copy of which was made available on Wednesday, noted that since the investigation in the case was over, accused doctor Rihan Kalathil's further incarceration was unnecessary.

Kalathil's car had collided with the motorcycle in the early morning of March 28 this year on a bridge in south Mumbai. Due to the collision, the motorcycle rider,

25-year-old Aditya Desai, was fell from the bridge and was declared dead in the hospital later.

While the police claimed that Kalathil was heavily drunk, the latter in his bail plea refuted it, and said he was not drunk to the level that he could not control his car.

In his plea, Kalathil had said he could not be charged under the Indian Penal Code



(IPC) section 304 II (culpable homicide not amounting to murder), and that at the most he ought to be charged under the lesser section of 304 A (causing death by negligence). Justice Dangre in her order noted the basic

rule of criminal system was "bail is the rule and jail is an exception. Punishment begins after conviction and every man is deemed to be innocent until duly tried and pronounced guilty," the court said while granting bail to

Kalathil on a bond of Rs 50,000.

The court in its order took note of the witness statements that there was no divider on the said road and that Kalathil was driving his car in the middle of the road, but was not speeding.

It added that when Kalathil saw a bike approaching from the opposite direction, he swerved to the right but unfortunately the bike too swerved to the same side and there was a head-on collision.

Justice Dangre noted that the witness statements prima-facie reflect the conscious sense of Kalathil, who made an attempt to avoid the head-on collision, instead of establishing the prosecution case that the alcohol had disturbed his metabolism. The court added that in the present case, the level of alcohol in the blood of Kalathil was below the prescribed limit. Kalathil's counsel Aabad Ponda claimed that Kalathil was a doctor by profession and a meritorious student, whose further studies were being hampered due to his arrest.

Advocate Rizwan Merchant, appearing for victim Aditya Desai's mother, opposed the bail and said the family had lost their sole breadwinner.

## Iran women get support from UN

In recent days Iran has seen deep public unrest, with demonstrations and protests taking place in some 80 cities, triggered by the tragic death of Mahsa Amini, who was detained by authorities in Tehran on September 13 and died, while in custody, three days later. In a statement on Wednesday, the New York-headquartered UN Women said that "it stands with the women of Iran in their rightful demands to protest injustice without reprisal, and to be free to exercise their bodily autonomy, including their choice of dress; and also supports them in seeking accountability, and the upholding of their basic human rights as stipulated in the Charter of the UN". "We call on relevant authorities to support and enable the expression of their full human rights in a safe environment without fear of violence, prosecution, or persecution. "We align with the remarks by the High Commissioner for Human Rights on the need to ensure the rights to due process and release for all women who have been arbitrarily detained and with the Special Procedures of the Human Rights Council, in the call for the Iranian authorities to hold an independent, impartial, and prompt investigation into Amini's death, to make the findings of the investigation public and to hold all perpetrators accountable. According to the Iran Human Rights (IHR), a Norway-based organisation, at least 76 protesters have been killed by Iranian security forces in the 11 days of unrest across the country against Amini's death. The organisation also said that hundreds of people have also been arrested, including 20 journalists. The anti-government demonstrations have spread to more than 80 cities and towns across Iran since Amini's funeral on September 17.

# SUNDARBANS IN THE EYE OF STORM AS CENTRE-STATE TUSSLE STALLS MGNREGA WORK

Cyclonic storms are nothing new to the Sundarbans region of West Bengal. But with the Union Government stopping fund allocation under the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) since December 26 last year citing non-compliance with directives, the low-lying islands known for their mangroves have become all the more vulnerable.

This year, no construction or repair of earthen embankments to prevent seawater incursion and erosion was carried out in areas with human settlements in the delta. Same was the case with mangrove plantation along the rivers. With no work coming their way, families of MGNREGA workers struggled to make ends meet. Their pending wages also remained unpaid.

"Sand overlay during seawater ingress means no farming can be done on that land for the next three to four years," explained Prasanjit Mandal, the chairman of Bali-based Sundarban Foundation. He said the stoppage of MGNREGA funds has affected small projects meant for tackling climate change. Krishnapada Mandal and his wife Behula Mandal live on the banks of the Bidyadhari on the island of Bali, where frequent cyclones have become a norm since 2009. A cement embankment and mangroves offer relative protection to them from the ravaging sea, but they still live under the constant fear of storms.

"Climate change has shaken us. We never faced such recurring storms in our childhood. Fish population is down by 25 per cent. Forest mangroves are fine, but those in the village and near the river are affected," Krishnapada said. Experts attributed the decline in mangroves to the frequency and intensity of cyclones, with even fresh attempts to reinstate them being threatened by increased salinity of water, overgrazing and erosion.

Pending MGNREGA dues The Indian Sundarbans, which accounts for 41 per cent of the country's mangroves, are spread over 13 blocks of South 24 Parganas and six blocks of North 24 Parganas districts. In June 2020, West Bengal Chief Minister Mamata Banerjee announced plans to boost their numbers by planting another five crore mangroves. However, the Central



fund issue jeopardised the plan.

While admitting that workers were not paid, Additional Principal Chief Conservator of Forests and Director of Sundarbans Biosphere Reserve Rajesh Kumar told 101Reporters, "We do not pay them directly. The payment is done through the District Magistrate's Office, where their job cards are made." He acknowledged that allocations under the scheme were closed at present.

Payments of over Rs 20 crore were pending under various heads, including workers' wages, administrative charges and material costs, according to a letter sent on June 22 by the South 24 Parganas Forest Division to the Chief Conservator of Forests and Joint Director of the Sundarbans Biosphere Reserve. It said over 11 lakh person-days were created in South 24 Parganas under the MGNREGA for planting and maintaining mangroves, besides preparing nurseries.

On September 23, MGNREGA workers from various districts, led by the Paschim Banga Khet Mazdoor Samity, blocked roads in protest and filed complaints across police stations in Purulia, Nadia, West Medinipur and North 24 Parganas districts against the MGNREGA programme officers from several blocks, who they claim "resorted to trickery to make innocent workers work, knowing that they cannot pay wages to them". Women suffer the most

"We built earthen embankments and planted mangroves for 100 days from last year to this January. However, we were paid only for 35 days. This year, we have not even received our job cards," alleged Utpal Pramanik, an activist and MGNREGA worker from Gurguria Bhubaneswari gram panchayat of Kulturali block in South 24 Parganas district.

Paschim Banga Khet Mazdoor Samity state committee member Anuradha Talwar told 101Reporters that workers cannot be punished for corrupt practices, including use of JCB machines, inflated man-days, bogus muster rolls, ineligible cardholders and unlisted work.

"Over 50 per cent of the MGNREGA workers here are women. Men generally migrate in search of work. The scheme ensures employment within five km of their homes. Hence, the withholding of funds has affected women the most. Spending on children's education has come down. In some households, even food-related expenses have to be curtailed," she said.

Local solutions to climate crisis Though MGNREGA's role in building climate resilience in local communities is increasingly appreciated, poor planning and management threaten to derail its potential. According to Dr Abhra

Chanda, Assistant Professor, School of Oceanographic Studies, Jadavpur University, a clear concept should be in place if MGNREGA works have to make a difference. "Though dense mangroves and pucca dams may be the most effective protective measures against extreme weather, only mud dams are built in abundance in the Sundarbans," he told the Reporter in an email interview.

Citing how lack of foresightedness failed the works, he said, "If the government strives hard to protect the island periphery with concrete embankments that can last for a century, local people can be deployed under the MGNREGA in their construction. However, if we restrict ourselves to building non-scientific kutcha embankments, the work taken up would be futile and cannot offer any long-term solution to the recurrent problems." He additionally called for working on a comprehensive river rejuvenation plan to increase the flow of freshwater into the mangrove forest, the most effective way to ensure its conservation.

But with the MGNREGA in limbo, such ambitious plans may have to wait, even as the Sundarbans runs out of time.

## Austria starts checks at Slovak border to stop illegal migrants

Vienna | New York

Austria has started checks at its border crossings with Slovakia to prevent people-smuggling, Interior Minister Gerhard Karner said here. Karner said that the controls will be enforced for an initial period of 10 days at 11 border crossings between the two countries. Xinhua news agency reported.

The checks came into effect at 12 a.m. on Thursday. Noting that controls have been in place at Austria's border crossings with Hungary and Slovenia since September 2015, Karner said this latest move is aimed at ensuring that human traffickers do not use Austria as an



alternative. "We have to be faster than the smugglers," he said. The number of asylum seekers in Austria has increased significantly in the past few months.

According to the country's Interior Ministry, more than 56,000 asylum applications were registered in Austria

between January and August this year, an increase of 195 per cent over the same period last year.

Most of the applications were filed by Indian nationals, many of whom travelled to Austria with the help of smugglers, according to Austrian broadcaster ORF.

## ISRAEL READY TO SHARE NUKE TECH WITH ARAB NATIONS UNDER PEACE DEAL

Tel Aviv: Israeli Atomic Energy Commission (IAEC) Director General Moshe Edri said his country is "ready" to share its state-of-the-art nuclear technology with Arab nations that have signed a peace deal with the Jewish state.

Edri made the rare remarks in an address to the 66th General Conference of the International Atomic Energy Agency (IAEA) convening in Vienna, reports Xinhua news agency.

Edri said Israel has been hopeful that the normalization deals signed in 2020 with the United Arab Emirates, Bahrain and Morocco will "mark a path forward for meaningful direct dialogue within our region, including in the nuclear fora".

Such a move will be made under the IAEA umbrella, the Israeli nuclear chief added. Israel rarely comments on its nuclear capabilities.

## S.Korean Prez, Kamala Harris share concern over N.Korea

South Korean President Yoon Suk-yeol and visiting US Vice President Kamala Harris on Thursday shared their concern about North Korea's nuclear and missile programs. Yoon and Harris met for 85 minutes at the presidential office and discussed a wide range of issues, including ways to strengthen the bilateral relationship, and key regional and international issues, Yonhap News Agency quoted deputy presidential spokesperson Lee Jaemyoung as saying. "President Yoon and Vice President Harris expressed serious concern about North Korea's recent ballistic missile launches and legalization of its nuclear force policy," he said at a press briefing, noting Harris reaffirmed the ironclad US commitment to the defence of South Korea. The two sides also agreed to plan a visit by Yoon to the US next year to mark the 70th anniversary of the alliance. On the controversy sur-



rounding Yoon and US President Joe Biden's meetings in New York last week, Harris said that Washington is not bothered by it at all, according to Lee. The spokesperson did not elaborate on which controversy Harris was referring to, but it apparently included the uproar in South Korea over Yoon's remarks caught on hot mic, which were initially reported as including vulgar language in reference to US Congress and Biden.

The his the Vice President's Harris first visit to South Korea since taking

office in January 2021. The last time a US Vice President visited South Korea was in February 2018, when Mike Pence led a delegation to the PyeongChang Winter Olympic Games. Harris landed in Seoul just hours after North Korea fired two short-range ballistic missiles into the East Sea in apparent protest of an ongoing South Korea-US military exercise involving an American aircraft carrier. The North had also conducted a similar short-range ballistic missile test on Sunday.

## LARGEST REFINERY IN FRANCE SHUT OVER STRIKE

French multinational energy and petroleum company TotalEnergies has started to shut down the country's largest refinery in the Normandy region as a result of a strike over wage demands. "The discontent is so strong in Normandy that the strikers demanded this morning the shutdown procedures of the largest refinery in France," Xinhua news agency quoted Thierry Defresne, General Confederation of Labour (CGT) secretary of the European Enterprise Committee of Total Energies, as saying on Wednesday.

According to the French daily Le Figaro, the shutdown does not jeopardise the supply of service stations in the short term even if the plant represents 22 per cent of France's refining capacity.

Total Energies said it has stocks that can last between 20 days and one month in addition to the country's strategic stocks, the newspaper reported. Citing the CGT union, Le Figaro reported that only two of the six refineries would remain operational, as four have already been halted due to maintenance and workers' strikes.

The strike at Total Energies began on Tuesday and will last until Thursday. It will coincide with the country's "interprofessional" strike called by three national unions for Thursday.

The CGT demands a 10 per cent wage hike for 2022, more employment opportunities and a massive investment plan in France. The labour action comes on the heels of strikes held by Total Energies employees with the same demands on June 24 and 28.



## Swedish economy will shrink in 2023: Govt agency

The Swedish economy is set to shrink next year due to inflation and increasing interest rates, a government agency said.

The gross domestic product (GDP) per capita is expected to decrease by 0.7 per cent in 2023, the Swedish National Institute of Economic Research (NIER) said in a report.

"High inflation and rising mortgage interest rates erode the purchasing power of households, and they have a gloomy view of the future," Xinhua news agency quoted the report as saying.

Households are assumed to receive some compensation for high electricity prices from the state, but will still have to reduce consumption in the future, it added.

The Swedish central bank Riksbank recently raised its policy rate by 100 points to 1.75 per cent, and NIER believes that further raises are imminent.

The agency predicts that the policy rate will stand at 2.3 per cent by

the end of the year and remain at the same level during 2023, before falling back to 1.8 per cent in 2024.

The year-on-year consumer price index with a fixed interest rate (CPIF) is expected to reach 7.7 per cent at the turn of the year, before falling to 4.6 per cent in 2023 and to 0.5 per cent in 2024.

During the following two years, it is expected to increase again, but stay slightly below Riksbank's 2 per cent target.

Unemployment is also expected to increase from 7.4 per cent this year to 7.7 per cent in 2023, before peaking at 8.0 per cent in 2024.

Meanwhile, according to NIER, Swedish consumers have a gloomy view of the year ahead.

The consumer confidence indicator has yet again reached a record-low level, this time of 49.7 (baseline 100). This is considerably lower than in the summer of 2021 when the confidence indicator among consumers stood at 110.

Among retailers, the confidence indicator also decreased, from 91.3 in August to 81.7 in September.

## 'GEN BAJWA ADVISED IMRAN THAT PM HOUSE UNSAFE FOR IMPORTANT CONVERSATIONS'

FIVE SENTENCED TO SEVEN YEARS RI IN VYAPAM SCAM

Bhopal: A Special CBI court in Bhopal on Thursday convicted five people and sentenced them to seven years rigorous imprisonment in connection with the Vyapam scam.

Satish Dinkar, Special Public Prosecutor representing CBI in the court, said the sentenced people were involved in scam in police constable exams held in 2013.

The convicted were the part of an "engine-bogie" system wherein seating arrangements were manipulated so that a paid smarter student was seated between two others to copy answers. Of the five sentenced, four identified as Kamal Kishor, Amar Singh, Nagendra Singh, Suresh Singh, had used dummy candidate in exam, while one person had appeared for exams in place of other candidate.

"A total of 32 witnesses related with this particular case were cross-examined in the court. On the basis of their testimony and documents of 200 pages related with scam, Justice Nitraj Singh Sisodia, who is hearing Vyapam case, pronounced the judgement on Thursday," Dinkar said.

Out of 160 cases related with multi-layer Vyapam Scam that was unearthed in 2013 and further investigated by the CBI, Bhopal district court is hearing 54 cases, while others cases are being heard in different courts in Indore, Gwalior and Jabalpur.

Dinkar claimed that around 50 per cent cases have been nixed, while the trial in main case, which has over 1300 accused (engine-bogi) part, is underway. Notably, all key accused in the case, including employees of Madhya Pradesh Professional Examination Board or Vyapam, are out on bail.

ASI finds temples, Buddhist caves, Mughal era coins

The Archaeological Survey of India (ASI) has found ancient caves, remains of Buddhist structures, temples, mural inscriptions bearing names of cities like Mathura and Koshambi and Mughal era coins during exploration in Bandhavgarh forest reserve area located in Madhya Pradesh's Rewa district.

During exploration from May 20 to June 27, an ASI team, led by Superintending Archaeologist of Jabalpur circle Shivakant Bajpayee, has found 26 temples or remains of temples, 26 caves, two monasteries, two votive stupas as well as 24 inscriptions along with 46 sculptures and around 20 water structures. The ASI has also found coins belonging to Sharqi dynasty of Jaunpur Sultanat.

"Twenty-six temples or remains of temples discovered during the fresh round of



exploration works belong to the Kalchuri period - 9th to 11th century CE, while 26

caves dating to 2nd century B.C. to 5th century A.C. period," as per ASI's claim.

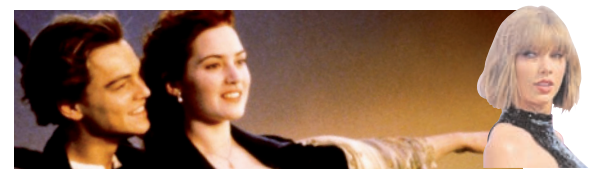
The exploration of nearly 170 sq km of core forest area that was not accessible to the public for around a month also led to the discovery of the remains of Buddhist structures predating the Hindu rulers of the region.

Notably, this exploration project has been restarted after a gap of 85 years. Earlier, the exploration in Bandhavgarh forest area was carried out in 1938.

The exploration project will be carried out further also and the ASI team is expecting to identify 100 more caves in the forest reserve area of Bandhavgarh.

According to Bajpayee, the first phase of exploration work was carried out in Tala range of Bandhavgarh. Notably, Tala is a town located in outer circle under Rewa district. In the next phases of exploration, the ASI team will cover the remaining area of Bandhavgarh forest from Khitauli to Magadhi range.

## Melek Mosso cuts hair on stage to express support for Iranian women

**M**elek Mosso, a Turkish singer, cut her long hair on stage to express support for Iranian women protesting the tragic loss of Mahsa Amini, who was held in custody by officials in Tehran on September 13 and died in custody three days later.

Mahsa Amini, 22, was brutally murdered by Iran's "morality police" for showing a bit of her hair and breaking the strict dress code laws.

The killing of Mahsa Amini has sparked nationwide outrage.

Protesters are taking a stand against the totalitarian regime, chanting slogans like "Let women live in freedom" and "I will kill whoever killed my sister."

A video of Mosso standing on stage and cutting her long black hair has gone viral. She is dressed entirely in white. The crowd could be heard cheering for the singer while she was chopping her hair. The Turkish singer took to Instagram to share the video. In Turkish, she wrote: "If you want to grab us by the hair and drag us into your darkness, we will cut that hair too! Freedom should be equal for all in the world. All women deserve to live humanely in this world! The various restrictions and atrocities done to my sisters wherever they are in the world breaks my heart."

"Mahsa Amini who was killed at such a young age and many whose lives were taken away in the clashes in recent days... I stand with the Iranian people and the women fighting for their freedom @bahman\_ghobadi (Iranian director) in a video I watched, he called out to Turkish artists: 'Your support right now will have a tremendous impact on civil protests. Like this. If artists in Iran hear your voice, they will be braver about supporting their people.'"

"I invite all artists to encourage and support the people who are struggling out there I WOMAN, LIFE, FREEDOM! ZEN."

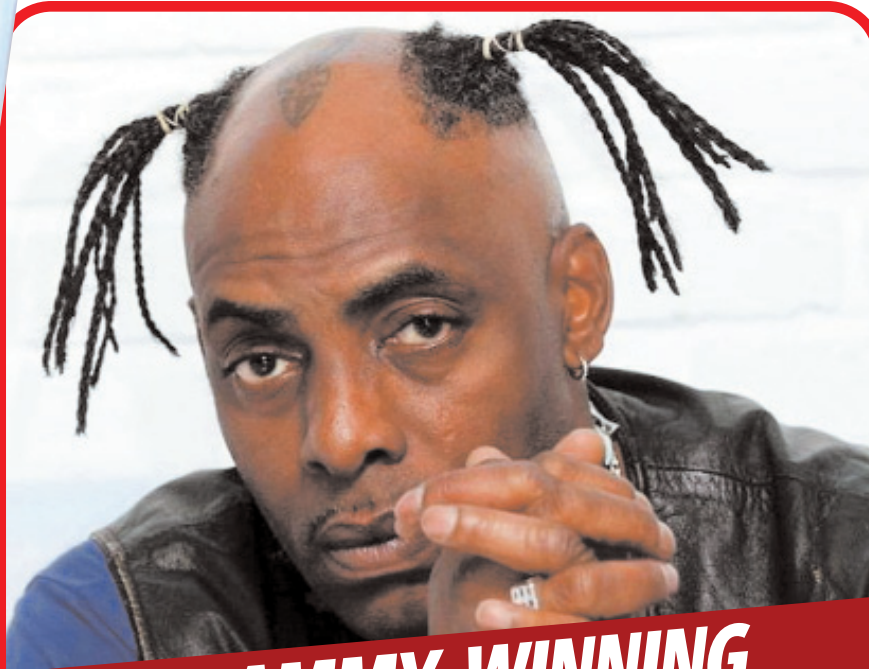


## MacKenzie Scott filed for divorce from Dan Jewett, more than a year after they got married

Coolio rose to prominence in the Los Angeles rap scene in the 1990s, landing his big break with the song 'Gangsta's Paradise' for the 1995 film 'Dangerous Minds,' starring Michelle Pfeiffer.

It quickly became one of the most popular rap songs of all time, topping the Billboard Hot 100 for three weeks and finishing in 1995 as the number one single in the United States. At the Grammy Awards in 1996, 'Gangsta's Paradise' was nominated for record of the year and best rap solo performance, with Coolio winning the latter.

## Jasprit Bumrah to be ruled out of T20 World Cup with back stress fracture: Report

Ahead of the T20 World Cup starting in Australia next month, India have been dealt with a huge blow with pace spearhead Jasprit Bumrah to be ruled out of the showpiece event due to back stress fracture.

Earlier, before the first T20I between India and South Africa at Thiruvananthapuram, the Board of Control for Cricket in India (BCCI) had said that Bumrah was ruled out of Wednesday's match after complaining of back pain during practice session on Tuesday.

"Jasprit Bumrah complained of back pain during India's practice session on Tuesday. The BCCI Medical Team assessed him. He is ruled out of the first T20I," BCCI had said in its statement on Twitter.

But, now a report in Insiderpost says that the medical team will take a



call on Bumrah's availability for the T20 World Cup, who could be out for four to six months even without the

need of surgery. "It's concerning. But we haven't had a full medical report on Jasprit

yet. As soon as he complained of back pain, he was taken off practice. The medical team is monitoring him.

Bumrah, who was out of international cricket since July this year, had missed the T20 Asia Cup in the UAE due to back injury, for which he underwent rehabilitation at the National Cricket Academy (NCA).

The report added that the same back injury which had kept Bumrah out of the Asia Cup has aggravated into a back stress fracture. "Bumrah is expected to head to London for better treatment next month. If he requires surgery, he could miss more than six months of action."

In case of Bumrah being absent from T20 World Cup, the senior men's national selection committee have options in Mohammad Shami or Deepak Chahar, who have been slotted in as travelling reserves for the tournament.

## SURYAKUMAR BECOMES HIGHEST RUN-SCORER FOR INDIA IN A CALENDAR YEAR IN T20IS

Charismatic India batter Suryakumar Yadav's string of fine performances in the last few series has seen him become the highest run-scorer for India in a calendar year in T20Is, which bodes well for Rohit Sharma's team as it aims to reclaim the T20 World Cup crown it won nearly 15 years back.

During the opening T20I against South Africa at Thiruvananthapuram on Wednesday, Suryakumar smashed another unbeaten half-century (50 off 33 balls) as India defeated the visitors by eight wickets with 20 balls to spare in a low-scoring game. Chasing 107 for victory, opener KL Rahul's 51 followed by Surya's unbeaten 50 made the task of achieving the win a cakewalk and take a 1-0 lead in the three-match series. Suryakumar continued his incredible run in T20Is this year, completing more than 700 runs in the format in the year, according to ICC. His tally of runs in T20Is in 2022 is a record for an Indian batter with Surya going past Shikhar Dhawan's 689 runs in 2018 in the format. Coming in at No.4 on Wednesday, with India reeling at 17/2 in the seventh over, Surya slammed two maximums off the first three



balls he faced to ease the pressure and give the Indian innings a change in momentum after a sluggish start.

He remained unbeaten on 50 off 33 balls as India scaled the target with more than three overs to spare.

Surya has taken his tally of sixes to 45 in 2022 already, a record in all T20Is, with three more months to widen the gap with Rizwan. While Rizwan took 26 innings to make 42 sixes, Suryakumar has broken the record batting five times fewer.

Surya is up to second position in the latest ICC Men's T20I Player Rankings with 801 rating points after his half-century in the third and final T20I against Australia in Hyderabad.

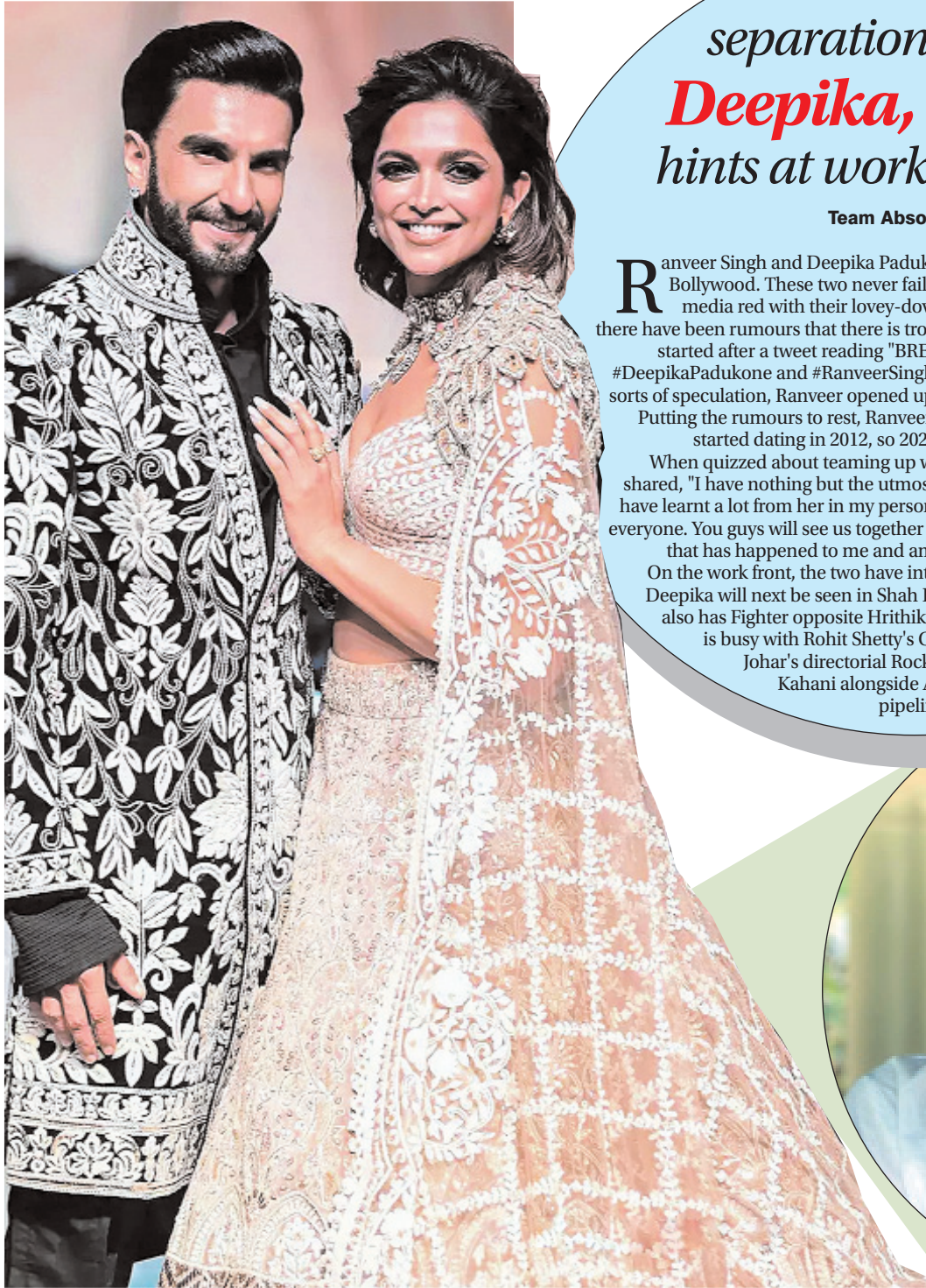
