MAJORITY IN INDIA WANTS COUNTRY TO LEAD FIGHT AGAINST CLIMATE CHANGE TO STOP

## GLOBAL WARMING

More than half of people in India (55 per cent) say India should reduce its own emissions of the gases that cause global warming immediately without waiting for other countries. In contrast, only 6 per cent say India should reduce its own emissions only if rich countries go first, and 17 per cent say India should reduce its own emissions only if all the other countries of the world reduce their emissions at the same time. Additionally, 8 per cent say India should not reduce its emissions under any circumstances, while 15 per cent say they don't know or did not provide a response.

significant number of Indians are of the opinion that policy makers and the leadership in the country should not wait for other countries and institutions before taking concrete steps to mitigate the impact of climate change and global warming. This is perhaps because a majority of Indians are now con-



vinced that global warming presents a clear danger to their lives and livelihoods, apart from endangering the prospects of future generations. This was revealed by a nationwide survey conducted of Climate Change Communication. The survey was conducted between October 2021 and January 2022 and covered a scientifically designed random sample size of 4619 adult Indians who were above 18 years of age.

The percentage of people in India who say India should reduce its emis-

sions immediately is 19 percentage points higher than in 2011, while the percentage who say India should reduce its own emissions only if rich countries go first (-11 percentage points), and the percentage who say India should not reduce its emissions under any circumstances (-5) are both lower than in 2011. Speaking on the subject, Dr. Anthony Leiserowitz of Yale University said, "A majority of people in India (59 per cent) say that in the future India should use either "much more" (42 per cent) or "more"

(16 per cent) renewable sources of energy, like solar panels and wind turbines, than it does today. Relatively few respondents (12 per cent) say India should use either "much less" (3 per cent) or "less" (9 per cent) renewable energy, and 13 per cent say India should use the same amount of renewable energy as it does today." Dr. Jagadish Thaker of the University of Auckland, said, "Most respondents (54 per cent) also say India should use "much less" (23 per cent) or "less" (31 per cent) fossil fuels, like coal, oil, and gas, than it does today. Few respondents (13 per cent) say India should use "much more" (8 per cent) or "more" (5 per cent) fossil fuels, and 18 per cent say India should use the same amount of fossil fuels as it does today."

The survey further reveals that 83 per cent of Indians want formal training for citizens about global warming. This is up 13 per cent since late 2011 when a similar survey was conducted. Besides, while 6 per cent stated they already do, another 57 per cent was definitely willing to join a citizen's campaign against global warming. India has been an active participant and supporter of the Paris Agreement and policy makers claim that the country will control, curb and reduce its carbon footprint before the target years set by global agreements.

### **UK Prime Minister Truss quits,** another chance for Sunak

he ruling Conservatives will race to find a new Prime Minister of the United Kingdom in a week, after Liz Truss dramatically, though not unexpectedly, resigned as head of government on Thursday after only 45 days in office - the shortest period for any British Premier in history."I cannot deliver the mandate on which I was elected by the Conservative party," Truss declared standing in front of the door of her office cum residence - 10 Downing Street. In effect, Britain will hav an incredible and unprecedented third Prime Minister in

three and a half months. Truss added she had agreed with Sir Graham Brady, chairman of the 1922 Committee - the body that conducts internal elections in the Conservative party - that the leadership election

will be completed within a week. Speculation was swirling in Westminster and Whitehall about the Indian origin former Chancellor of the Exchequer Rishi Sunak - who



lost the contest to Truss in the summer - once again throwing his hat into the ring. There was, however, no confirmation of this from him. Apart from Sunak, the names of Ben Wallace, the Secretary of State for Defence, Penny Mordaunt, Leader of the House of Commons, and even Johnson are doing the round. Wallace refused to bid for the leadership in the summer, but could be a unifying figure and thereby a frontrunner, if he stands. BBC reported Jeremy Hunt, the current Chancellor, will not fight an election for the Prime Ministership.

#### Google finned Rs 1,337 cr for anti-competitive practices

In a significant decision, the Competition Commission of India (CCI) on Thursday imposed a penalty of Rs 1,337.76 crore on Google for abusing its dominant position in multiple markets in the Android mobile device ecosystem, apart from issuing a cease and desist order against the tech giant. Google has been given 30 days' time to submit the requisite financial details

and supporting documents. The antitrust watchdog, which began investigating Google several years ago after receiving complaints from homegrown companies, also ordered the company not to offer any incentives to smartphone makers to exclusively carry its search services.

The Commission examined

various practices of Google with regard to licensing of tem and various proprietary mobile applications of Google (Play Store, Google Search, Google Chrome, YouTube, etc). During the course of inquiry, Google argued about the competitive constraints it faced from Apple. Apple's business is primarily based on a vertically integrated smart device ecosystem which focuses on sale of high-end smart devices with state-of-the-art software components. Whereas Google's business was found to be driven by the ultimate intent of increasing users on its platforms so that they interact with its revenue earning service, i.e., online search which directly affects sale of online advertising serv-

### AFSPA extended in 8 districts, 1 sub-division of Assam

he Assam government Thursday said it has extended the Armed Forces (Special Powers) Act, 1958 (AFSPA) in eight districts and one sub-division for six months after a review of the law and order situation. The government, however, withdrew the controversial law from West Karbi Anglong district as the situation there has "considerably improved".

The six-month extension of AFSPA is effective from October 1, Home and Political Department Principal Secretary Niraj Verma said in an order. The order dated October 15 and released on Thursday stated that nine districts and one sub-division were kept under the AFSPA since April 1 as a "disturbed area" after withdrawing the legislation from the rest of the state.



Districts which continue to be disturbed areas are Tinsukia, Dibrugarh, Charaideo, Sivasagar, Jorhat, Golaghat, Karbi Anglong and Dima Hasao besides Lakhipur sub-division of Cachar in the Barak Valley.

The act was imposed in Assam in November 1990 and has been extended

every six months since then after a review of the situation by the state government. AFSPA allows security

forces to conduct operations anywhere and arrest anyone without any prior warrant. It also gives a certain level of immunity to the security forces in case of an operation going wrong.

# Pilots Flying Over Pacific Ocean Spot Several UFOs: Report

**NEW YORK** | Agenc

nidentified Flying Objects (UFOs) are being sighted in the sky over the Pacific Ocean for the last two months, according to a UFO researcher.Ben Hansen, former FBI agent and host of the Discovery+ show, 'UFO Witness', procured footage and air traffic control recordings of mid-air UFO sightngs by the pilots, reported New York Post.

Pilots from Southwest Airlines, Hawaiian Airlines and several others spotted multiple aircraft in the region. A former military pilot said that he witnessed several aircraft flying above him.While flying a charter jet off the Los Angeles coast, Pilot Mark Hulsey radioed the air traffic control on



August 18, asking, "We've got a few aircraft to our north here and he's going around in circles, much higher altitude than us. Any idea what

they are?' The controller said that he

was not sure. In just 23 minutes, Hulsey reported that he spotted seven such aircraft, flying above him between 5,000 to 10.000 feet, which was initially three.

In the recording, Hulsey says, "They just keep going in circles. I was an F-18 pilot in the Marine Corps, and I'm telling you, I've done many intercepts, I've never seen anything like this.'

Hansen said that the pilot who has claimed that he spotted strange lights was seen by upwards of 15 different commercial flights. And at least six pilots are willing to go on record with their names and everything if asked to do so by any investigative agencies," he

An FAA spokesperson told a leading publication that whenever a pilot reports strange sightings to an air traffic control facility, it documents it, NDTV reports.

Last year, the Department of Defense launched a new outfit tasked with finding and identifying UFOs in restricted airspace after Washington officials admitted they could not explain the phenomena of UFO sightings, reported the New York Post.

## DELHI HC SAYS LOOKOUT CIRCULAR IS A COERCIVE MEASURE

he Delhi High Court has observed that Lookout Circular (LOC) is a coercive measure and is to be issued to ensure surrender of a person evading summons or

"An LOC is a coercive measure to ensure that a person surrenders and interferes with petitioner's right of personal liberty and free movement. LOC is to be issued in cases where the accused is deliberately evading summons/arrest or where accused fails to appear in the court despite issuance of Non-Bailable Warrants," Justice Anoop Kumar Mendiratta noted in a recent order while quashing an LOC against a petitioner.

In an earlier order on July 11, 2010, also, the Delhi high court had held that the LOC could be issued only against an accused who is deliberately evading his arrest or is not appearing before the Trial Court despite NBWs issued against him in cognizable offences under IPC or other penal laws. Justice Mendiratta was dealing with a plea against the LOC



issued to one Mohd Kashif in connection with a Customs case.

The petitioner urged that the LOC appears to have been wrongly opened since the investigation is already over and he is no more required for the purpose of any

Kashif's counsel pointed out that the petitioner was required to return to Dubai, failing which he will lose his job and his NRI VISA is liable to be cancelled. Additional Commissioner of Customs submitted that the case of smuggling of 7.790 kgs Gold through baggage was booked at the IGI Airport by the Customs Department. During the investigation, it appeared that the petitioner had smuggled 6 kg gold in the past, aided and assisted by two passengers, namely Syed Salman and Shazeb.

The petitioner did not join the investigation in spite of repeated summons issued against him, it was submitted. Later LOC was issued against the petitioner by the competent authority after due diligence and consideration.

However, it was further submitted that the LOC issued against the petitioner was reviewed by the competent authority and recommended for withdrawal to the issuing authority, i.e., Deputy Director (Bureau of Immigration) last month.

After the submissions of the parties, the court said: "In the facts and circumstances, the LOC issued against the petitioner is hereby quashed and the order dated 17.08.2022 passed by learned CMM is set aside," while allowing the petitioner to leave for abroad (Dubai).

No fine for not wearing mask, Delhi govt issues orders

he Delhi government on Thursday issued an order stating that the provision to impose a penalty of Rs 500 on the general public for not wearing a face mask in public places stands withdrawn.

This comes after the Delhi Disaster Management Authority (DDMA) in a meeting on September 30 decided to stop levying the penalty on not wearing a mask at public places.

However, "in crowded public places, all public are advised to wear masks", the government stressed, says the order from the Health and Family Welfare department of Delhi Government.

"Though wearing of masks was useful in maintaining the Covid Appropriate Behavior yet it was agreed that the order of compulsory wearing of masks under the Epidemic Act may not be extended



beyond 30.09.2022. Hence a Fine of Rs 500/- for not wearing masks in public places would also stand withdrawn after 30.09.2022," the DDMA had said in the meeting.

The decision was taken amid the declining trajectory of fresh Covid cases on a daily basis in the city. The national capital recorded 107 fresh Covid cases with a posi tivity rate of 1.64 per cent on Wednesday, according to the data shared by the health department. No Covid-related fatality was reported in the

On Tuesday, Delhi had reported 141 new Covid-19 cases with a positivity rate of 2.04 per cent.

#### CHINESE WOMAN CLAIMING TO BE BUDDHIST MONK NABBED IN DELHI ON SUSPICION OF SPYING

50-year-old Chinese woman who was allegedly involved in anti-India activities, has been apprehended by the police in the national capital. Cai Ruo, who claimed to be a 'Buddhist monk', is being suspected to be a Chinese spy, sources said.

A source told correspondent that Cai Ruo is a "welltrained and cunning individual who tried to mislead the investigators by claiming that Chinese Communist leaders wanted to kill her and therefore, she fled to India".

She had been living in India as "Dola Lama, a Nepalese national".

She had also managed to procure a "Nepalese Identity Card" to claim that she was a resident of Kathmandu.

Even as she spoke with the Delhi Police personnel fluently in English, she did not know the Nepali language.

she speaks fluent Chinese. Later, on cross-checking and verification, the police

came to know that she had a Chinese passport issued in her name, and she had been residing in India on the basis of that passport. In 2020, she entered Nepal

through the Raniganj border area in the Indian state of West Bengal. Later, she again entered India after managing to procure Nepalese IDs.

According to the source, she is a resident of Hainan Province in China, as per her records available with the Indian authorities. She had allegedly been trying to create unrest across the country.

## SC UPHOLDS 20% QUOTA FOR IN-SERVICE CANDIDATES

he Supreme Court on Thursday refused to interfere with a Bombay High Court judgment, which upheld the Maharashtra government's decision to provide 20 per cent reservation for in-service candidates in postgraduate medical admissions in the state.

A bench, headed by Justice D.Y. Chandrachud and comprising Justice Hima Kohli, said the court is of the view that the high court judgment does not call for interference, and it is not possible to accept petitioners' contention that the government's decision should not be applicable in the current academic year due to change in rules midway.

Counsel, representing the petitioners, submitted that the government resolution was issued after the admis-



sion process had commenced, and cited an apex court judgment, which had observed that rules of the game

process has been initiated.

Advocate Abhay Dharmadhikari, the standing counsel for the Maharashtra government, submitted that there was no change in rules governing the admission and the brochure issued by the state government specifically stated the in-service reservation.

"From the academic year 2022-23, government approval is being given to reserve 20 per cent seats for inservice candidates for admissions to PG medical and diploma courses in government and civic-run medical colleges in the state," the Maharashtra government resolution

The top court passed the order on a plea by some persons challenging the high court judgment, which declined to grant them any relief.

## Over 13,000 kg firecrackers seized in 19 days: Delhi Police

#### Bihar: Acquitted in 26-yr-old case, elderly man dies of heart attack

n elderly person died due to heart attack soon after he was acquitted in a 26-year-old case in Bihar's Banka district.

The deceased has been identified as Nago Singh (76), a native of Jhunka village under Belhar police station in the district.

Nago Singh, along with four others, were booked in a crop destruction case in 1996. The court's decision came on Wednesday evening.

His advocate Devendra Prasad Singh said: "Nago Singh was on bail and he believed that he was innocent and was wrongly framed in the case. When the court's decision came in favour of him and the other accused persons, they were all

relieved and expressed their satisfaction. But Nago Singh, after hearing the news of his acquittal, collapsed on the ground. His family members took him to the health centre inside the court premises where he succumbed."

"The court acquitted Nago Singh and others in the absence of evidence," he

The family members of the deceased said that for Nago Singh, it was a case of justice delayed is justice denied.

"He always said that he was innocent. Still he went to jail and was currently out on bail. He fought this case for 26 years to prove that he was not guilty, and eventually the court ruled in his favour," a family member of Nago

Singh told local reporters. The hearing was held in the court of Additional

Session Judge Piyush Kumar, who directed all the accused persons to be physically present in the court. After the final hearing, Kumar acquitted all the accused persons in this case

This is not the first case where a person was acquitted after so many years. On October 11, a person was acquitted after 43 years in Buxar district.

The case goes back to

1979, when a group of people was booked for their alleged involvement in physical assault, firing and attempt to murder of a local trader in Chaugai village under Murar police station in Buxar district.The acquitted person named Munna Singh was just 10-year-old at that time, and the trader had named him in his complaint. # Mamata calls Sourav Ganguly victim of political vendetta

This is a shameful political vendetta," Banerjee said while interacting with mediapersons here on Thursday.Her comments came after the BCCI made it clear that it will back current ICC chairman Greg Barclay to retain the post. However, she avoided naming Union Home Minister Amit Shah and his son and BCCI secretary Jay Shah on this count, even after mediapersons specifically asked whether she was hinting at the



father-son duo."You all are journalists. You surely have some information... You will understand this better," the Chief Minister said. The accused couple lived in the neighbourhood of Takkar, who was found hanging from a ceiling fan in her house in Saibag Colony of Madhya Pradesh's Indore city on Sunday. A five-page suicide note was found at the spot in which Takkar named Rahul Navlani for harassing her, officials earlier said. "Police teams were looking for the couple and one such team was able to arrest Rahul Navlani on Wednesday,"Tejaji Nagar police station in-charge R D Kanwa said. "Rahul was trying to escape from Indore



but was nabbed before he could do so," the official said, adding that he was being questioned over suspicion that rose during the investigation into the case.

Asked whether his wife was also nabbed, Kanwa said he was not aware of it. State Home Minister Mishra said police were retrieving data from the gadgets seized from the arrested accused

The data will be analysed and action will be taken into the matter accordingly, he added. The actor's family members had earlier alleged that Navlani was troubling her since he came to know about her plans to get married, officials said. A case was registered against Navlani and his wife under Indian Penal Code Section 306 (abetment of suicide), police said.

#### TUSSLE FOR MUSLIM VOTES

The BJP and the Bahujan Samaj Party (BSP) in Uttar Pradesh are now locked in a tussle for the Muslim votes, ahead of the Lok Sabha elections in 2024. In an unprecedented move, BSP president Mayawati appointed former MLA Imran Masood as party's coordinator for western UP, within an hour of his quitting the Samajwadi Party (SP) to join the BSP on Wednesday. The BSP, which does not have any Muslim leader worth his name left in the party, is now banking solely on Imran Masood to woo Muslims in western UP. Masood, who belongs to an influential Muslim family in Saharanpur, has hopped from the Congress to SP and now BSP within the past one year, eroding his own credibility. Mayawati's declared dependence on Imran Masood, especially for the upcoming municipal polls, shows the BSP's desperation to win back Muslims and regain its relevance in UP politics before the general elections. The BJP, on the other hand, is going full throttle to win over the Pasmanda community among Muslims, which reportedly accounts for around 70 per cent of the Muslim population and are socially and economically backward. The party is preparing to give a substantial number of tickets to Pasmanda Muslims in the upcoming municipal polls. The mood in the BJP is upbeat, especially after the party won the bypolls in Azamgarh and Rampur, both dominated by Muslims. UP chief of All India Pasmanda Muslim Mahaz, Waseem Raeen, said that results are a clear indication that Muslims are no longer averse to the BJP. The group is now focussed on projecting "the right picture" to the marginalised sections of Muslims. If the BJP succeeds in wooing Pasmanda Muslims, there would be no stopping the party from returning to power in 2024 -- a fact that is making the BSP work doubly hard towards regaining lost ground among Muslims now.

## **POJK LOCAL BODY POLLS: A FARCE UNDER** THE WATCHFUL EYES OF MILITARY

fter a lapse of 31 years, Pakistan occupied Jammu & Kashmir (PoJK) is going to hold local body elections on November 27. According to the schedule released by the Azad Jammu Kashmir Election Commission, candidates have been asked to submit their nomination papers between October 14 and 22.

On October 22, the approved list of the nomination papers of the candidates will be published. Election symbols will be allotted on October 31.

For 31 years, Pakistan has purposefully deprived the people of PoJK from local representation. Therefore, creating space for local politics to be dominated by tribe and cast affiliations.

Since 1990s, Pakistan has focused more on cross-border terrorism with catastrophic results for the people of Jammu and Kashmir.

In 1990, the genocide of Kashmiri Pandits as well as the targeted assassinations of Hindu and pro-Indian Muslim politicians and provocative acts of stone pelting by paid goons destroyed the social and cultural fabric of my people.

It is only after the abrogation of Articles 370 and 35A of the Indian Constitution that peace and development has returned to the Valley and once again our social and cultural fabric has begun to repair

The local body elections due on November 27 are not going to be able to establish a tranquil grass root level democratic system in PoJK. The reason is simple. The nomination form to apply to become a candidate in the forthcoming elections demands one to sign an oath of allegiance to Islam, Pakistan and PoJK's accession to Pakistan.

I present to you with the text of the oath for you to judge the hypocrisy of the Pakistani government's claim to support the move-

ment for the right of self-determination of my people.

It states: "I solemnly declare that I believe in the theology of Pakistan, the ideology of State's accession to Pakistan and the integrity and sovereignty of Pakistan.

I am sure that the regular reader of my work would by now understand the nature of the conflict of Kashmir. It began when in October 1947 Pakistan attacked and occupied the western parts of Jammu

For 75 years, Pakistan has refused to withdraw its troops from our lands despite the fact that the UN resolutions have named Pakistan an aggressor and asks Pakistan to withdraw from PoJK to facilitate a referendum to decide the fate of this part of the world.

However, Pakistan calls for our allegiance as a condition to represent our own people. By asking our people to believe in the theology of

Pakistan simply means that other religious groups have been made out cast. What is the theology of Pakistan? It is based on the communal hate ideology of Jinnah's two nation theory that divides citizens of a nation state on the basis of

What is meant by the ideology of State's (PoJK's) accession to Pakistan? It means to divide my people on the basis of communal hate between Hindus and Muslims, which implies that since the majority population of the so-called Azad Jammu and Kashmir is Muslim, we would support our accession to Pakistan. This is a serious breach from even the resolutions of the United Nations that have given us the right to choose between India and Pakistan.

Therefore, someone like myself, who advocates PoIK's accession to India, cannot become a local councilor in PoJK. Someone who is of

Hindu or Sikh or even Christian faith cannot become a local coun-Here is the text of the nomination

form that demands of the candidate to declare: "I believe in the absolute and unqualified finality of the Prophethood of Muhammed (Peace be upon Him), that I do not recognise such a claimant to be a Prophet or a religious reformer, nor do I belong to the Quadiani Group or the Lahori Group or call myself

Lahori Group is an offshoot of the Quadiani movement and split shortly after the death of the founder of Ahmadiya Movement, Mirza Ghulam Ahmed, in 1903.

With so many restrictions in place, how can one expect a broadbased local body government to come into being in PoJK?

local bodies election due on November 27 are taking place as an attempt to keep the people glued together in the name of conservative jihadi Islamic narrative of twonation theory. No wonder, as I write, 33,000 military and security personal have begun to pack their bags to be stationed on each and

every polling station in PoJK. Local body elections under the watchful eye of the Pakistan military itself speaks volumes about the credibility and transparency of this farce that is taking place after 31

## Indonesia bans all syrup and liquid medicines after death of 99 children

he deaths of nearly 100 children in Indonesia have prompted the country to suspend sales of all syrup and liquid medication, the media reported.

It comes just weeks after a cough syrup in The Gambia was linked to the deaths of nearly 70 children, the BBC reported.

Indonesia said some syrup medicine was found to contain ingredients linked to acute kidney injuries (AKI), which have killed 99 young children this year.

It is not clear if the medicine were imported or locally produced.

On Thursday, Indonesian health officials said they had reported around 200 cases of AKI in children, most of who were aged under five.

Earlier this month, the World Health Organization (WHO) issued a global alert over four cough syrups



that were linked to the deaths of almost 70 children in The Gambia.

The WHO found the syrups used there -- made by an Indian pharmaceutical company -- contained "unacceptable amounts" of diethylene glycol and ethylene glycol. The syrups have been "potentially linked with acute kidney injuries", said the organisation.

Thursday said the same chemical compounds were also found in some medicines used locally.

"Some syrups that were used by AKI child patients under five were proven to contain ethylene glycol and diethylene glycol that were not supposed to be there, or of very little amount," said Budi Gunadi Sadikin, BBC reported.

However, he did not disclose how many cases involved the toxic medicines.Indonesian authorities said the cough syrups used in The Gambia were not sold locally.

One epidemiologist said the true death toll could be even higher than

reported. "When cases like these happen, (what we know is) the tip of the iceberg, which means there could be far more victims," Dicky Budiman, an epidemiologist from Griffith University told BBC Indonesia.

#### **TURKISH TEAMS DEFUSE ANOTHER MINE IN BLACK SEA**

Ankara: The Turkish Defence Ministry said that underwater demolition teams disabled another mine in the since the start of the ongoing Russia-Ukraine war on February 24.

The mine was detected off the coast of the Kivikov district in the northwestern province of Kirklareli and teams from the Underwater Defence were dispatched to the scene, Xinhua news agency quoted the Ministry as saying on Wednesday.

"The mine has been secured and defused by the teams," it noted.

In April, Turkey detected three mines in the waters of the Bosphorus Strait, which connects the Black Sea with the Marmara Sea. The Turkish navy and its mine-hunting vessels are monitoring the Black Sea for stray mines, according to the Ministry. The Ukrainian navy had deployed mines near the ports of Odesa, Ochakov, Chernomorsk and Yuzhny since the start of the war, Russia had said in March. However, Ukraine has refuted the claim.

#### IRAN IMPOSES SANCTIONS ON BRITISH OFFICIALS, **INSTITUTES FOR 'BACKING TERRORISM'**

**Tehran** Agencies

he Iranian Foreign Ministry has imposed sanctions on a and individuals for "supporting terrorism and terrorist groups, promoting and instigating terrorism, violence and hate-mongering and violation of human rights".

The ministry issued a statement on its website saying the move was made within the framework of the related legal regulations and sanction mechanisms as well as a "response in

kind", Xinhua news agency reported. "Iran holds the British government responsible and accountable for supporting terrorists and violators of human rights who organise and instigate rioting and acts of terrorism in Iran from UK soil," said the statement.

The listed entities included the National Cyber Security Center of Britain, the British Government Communications Headquarters, as well as Volant Media, Global Media, DMA Media and anti-Iranian TV channels they support, namely BBC Persian and Iran International, according to the statement.

Iran's sanctions have also targeted several



individuals, including British Minister of State for Security Tom Tugendhat, and British military commander in the Gulf Don MacKinnon.

The sanctions will prohibit the targeted individuals from obtaining visas and entering Iran and will freeze their assets and bank accounts inside Iran.

Earlier in the day, Iranian Foreign Minister Hossein Amir-Abdollahian said they will target people and institutes that have played a role in imposing medical sanctions on Iran and promoting "violence and extremism" which have caused insecurity in the country following the death of 22-year-old Mahsa

#### Ukrainians asked to 'charge everything' as missile strikes hit power plants



## Authorities call for continued Covid measures in Europe amid renewed surge

fresh autumn wave of Covid-19 infections has started in many European countries, and experts are calling for strengthened vaccination efforts and tighter health measures as cases are set to keep rising this winter. Greece confirmed 55,242 cases in the week of October 10-16, an increase of 8 per cent compared to the previous week. Of the new weekly infections, 21 per cent are reinfections, Xinhua news agency quoted the National Public Health Organisation as saying in a report.

The report also said that during the week, 1,351 Covid-19 patients were admitted to hospitals, up 23 per cent compared to the previous week.

In the Netherlands, the number of people hospitalised with Covid-19 has continued to rise, reaching its highest level since April 15.

The National Institute for Public Health and the Environment said that new infections may rise sharply



in the near future.

Finnish National radio Yle reported earlier this week that the current rate of deaths caused by Covid-19 in the country was five times the EU average. So far in October, the Finnish Institute for Health and Welfare has reported 261 deaths.


"Although we are not where we

were one year ago, it is clear that the Covid-19 pandemic is still not over. We are unfortunately seeing indicators rising again in Europe," said a joint statement released by European health agencies on October 12.

"Preparedness measures need to continue in the European region, we should not let our guard down," said Organization (WHO) European Regional Director Hans Kluge, European Center for Disease Prevention and Control (ECDC) Director Andrea Ammon and European Commissioner for Health and Food Safety Stella Kyriakides.

"The potential co-circulation of Covid-19 and seasonal influenza will put vulnerable people at increased risk of severe illness and death. Together with public health measures, vaccination remains one of our most effective tools against both viruses," they said, urging countries to "prioritise protecting the most vulnerable groups by co-administering influenza and Covid-19 vaccines whenever feasible".

On Monday, the Italian health ministry recommended the use of new bivalent Covid-19 vaccines for the third booster shot for vulnerable people, which should be administered 120 days after the second booster.

Pormer Maharashtra chief minister Uddhav Thackeray, who is fighting a legal battle to claim the legacy of the Shiv Sena founded by his father late Bal Thackeray, on Thursday claimed that not just the future of party but democracy in the country was at stake.

Uddhav Thackeray was addressing a function at the Shiv Sena Bhavan in Dadar area of Mumbai where he inducted former minister Sanjay Deshmukh from Yavatmal into his faction.

Addressing a gathering after the induction,
Thackeray said despite claims that the Shiv Sena had split and was finished, people were still coming to him.

The Thackeray-led Maha Vikas Aghadi government collapsed in June this year after a rebellion led by MLA Eknath Shinde.

Eknath Shinde was later sworn in as the chief minister with the BJP's support.

The Election Commission earlier this month barred the Shiv Sena factions led by Thackeray and Shinde from using the party name and its election symbol 'bow and



arrow' in the November 3 Andheri East Assembly bypoll. It allotted 'Shiv Sena -

Uddhav Balasaheb Thackeray' as the party name for the Thackeray faction, and 'Balasahebanchi Shiy Sena' (Balasaheb's Shiv Sena) as the name for the Shinde group. The EC also allotted new poll symbols to the rival groups. Uddhav Thackeray on Thursday said, "The common man and especially civilised people of the state are not agreeing with what has happened and are extending their support. They tell me don't give up, fight, we are with you. We don't agree with

what's happening."

"People whom I thought
would never be politically
close are coming out in sup-

port. Similarly, people of different religions and regions are extending support. It is not just the future of Shiv Sena but the democracy of the country is at stake," the former chief minister added.

He said people need to ask themselves whether democracy will stay alive or they would go back to slavery. "My future and that of my party will be decided by the people and the party cadre," he said.

Sanjay Deshmukh, who joined the Thackeray faction on Thursday, was an MLA for two terms from Digras in Yavatmal.He had earlier been with the Shiv Sena and also served as a minister in the Congress-led Democratic Front government between 2002 and 2004. He was also

## L&T's sacked contract workers start sit-in agitation

head of Diwali, hundreds of contract workers sacked by the Larsen & Toubro's defence production plant in Maharashtra's Talegaon last year, have started a 'sitin' agitation outside the Pune Labour Commissionerate for reinstatement, salaries and other demands, officials said here on Thursday.

The contractual labourers, number over 250, whose services were terminated abruptly in October. 2021, are members of the Bharatiya Kamgar Sena (BKS) and are on a warpath accusing the L&T-appointed contractors of harassment at work-place, unfair labour practices like transfers and terminations, denial of salaries or Diwali bonus.

"The problems started after they decided to join the BKS last year... Attempting to break their unity, the contractor and the company connived to transfer many workers to far-off places outside Maharashtra, which we have strongly opposed," BKS General Secretary Dr. Raghunath Kuchik said.

Since the past one year, they have been denied their salaries, bonus and other emoluments promised to them, by both the contractors and L&T, which is the 'principal employer', said Dr. Kuchik, who is also a Deputy Leader of Shiv Sena (Uddhav

Balasaheb Thackeray) party.
On Thursday, the BKS representatives met the Labour ommissionerate officials who have summoned the

L&T top executives from Mumbai on October 31 to resolve the issue.

When contacted, Assistant Labour Commissioner Pravin Jadhav said that the company, L&T through its contractors had indulged in certain "unfair labour practices" including indiscriminate transfers of contract workers to far-off locations, besides other issues which are being investigated in detail.

"Moreover, the L&T and its contractors have not fully implemented the interim orders of the Pune Labour Court in March-April owing to some miscommunication, but the Labour Commissionerate is taking all steps to resolve the issue amicably," Jadhav

added.Among the sacked contract workers' demands are reinstatement at their original workplaces, payment of full back-wages and other benefits for the past 12 months, full implementation of the Labour Court's directives in March 14 and April 12 (2022). An internal probe report of the Labour Commissionerate has pointed a needle of suspicion at the L&T allegedly for failing to comply with the court's directives, not sticking to the commitments made in at least 8 joint meetings conducted by the Commissionerate officials which has vitiated the industrial atmosphere

here.Despite several attempts by

reporter, the company officials were

not available to give their version in the matter.On his part, Kuchik pointed out that the L&T unit is engaged in defence production for which is making huge profits and not doing charitable work, so it is their duty to ensure that the contract workers are properly compensated for their labour.

The BKS leader slammed the L&T for being 'insensitive' towards the plight of its own poor contract labourers, trying to crush their rights to unionise by transfers or sackings, denying them their rightful payments due for one year, and called upon the company to give justice on priority or the sit-in agitation will be carried out indefinitely.

### ADANI TO INSTALL 1.80 MN SMART METERS FOR BEST POWER CONSUMERS

The Adani Group has bagged a bid to install 10.80 lakh (1.80 million) "Smart Meters" for electricity consumers of the Bombay Electric Supply & Transport (BEST), which will 'empower' the distributor to cut-off the power supply of bill defaulters automatically, officials said here on Thursday.

The BEST has awarded the Rs 1,250 crore project to Adani Transmission Ltd (ATL)'s Advanced Metering Infrastructure (AMI) partner, and the installation of Smart Meters will be completed in two-and-half years, said the company's Distribution CEO Kandarp Patel.

Besides installing the Smart Meters for all the users along with the related communication and cloud infrastructure, the ATL shall also maintain them for a period of seven-and-half years for the



BEST on a design-build-finance-own-operate-transfer basis, he added.

This project -- billed as the biggest of its kind in the country -- will cover end-to-end Smart Metering for distribution infrastructure and end consumers of BEST, with complete energy accounting and zero manual intervention.

It will also empower BEST power consumers -- all located in south Mumbai -- to monitor online consumption patterns and take prompt corrective action if needed, in addition to options like prepaid billing, net-metering facilities for housing complexes and commercial buildings with roof-top solar energy plants, etc.

solar energy plants, etc.
Simultaneously, the BEST will be able to carry out 'remote connection and disconnection' for bill defaulters, while the power regulators could offer consumers 'friendly time of day tariffs' and increase overall efficiency in electricity distribution, said officials.Patel said the project is in line with the company's long-term goals "to deliver customer value through the potential of technology and digitalisation" and achieving power for all by 2022.

## Prominent Mumbai realtor jumps to death from 23rd floor flat

Prominent realtor, Paras S. Porwal, jumped to his death from his 23rd floor flat at Chinchpokli tower in south Mumbai on Thursday, the police said.

Porwal was associated with various companies, including Rajyog Developers Ltd. He had completed several commercial and residential projects in the city and suburbs in the past three decades.

Realty circles claimed that he was reportedly undergoing certain financial problems that may have prompted him to take the extreme step.

Coming just ahead of Diwali, in which the realty sector experiences a boom, the Porwal incident sent shockwaves in the building construction industry even as the police initiated their probe.

## Man climbed onto Mumbai Skywalk roof, then dramatic rescue

24-year-old man climbed on the roof of a skywalk in Mumbai allegedly under the influence of drugs on Wednesday, said police. In dramatic footage from Wednesday morning, the man was seen being persuaded by officials to climb down the skywalk at Nana Chowk.

The man identified as Shakil Ahiya now faces a police case under the drugs law, added officials.

Gamdevi police, on being alerted about the incident, reached the spot with fire brigade personnel to rescue the man. Seen sitting on the edge of the roof, he stood up when the officials approached him, trying to convince him to get down from there. One of the officials slowly approached him and got hold of him. They



dragged him towards another side and pinned him to the roof. The rescue operation took around two hours.

Under the skywalk, some stood holding a large cloth to act as a cushion if the man jumps. Vehicular movement was disrupted due to the rescue efforts at the junction.

The man was allegedly under the influence of drugs at the time of the incident, according to Mumbai Zone-2

"Necessary precautionary measures are being taken. The parents need have any anxiety," Bommai said.



ewly-elected BCCI president Roger Binny on Thursday said the board can't decide on its own whether the Indian cricket team will visit Pakistan for the 2023 Asia Cup or not as the travel-related decisions are taken by the government.

The BCCI president's comment came after he was posed with a question on the recent decision of India to not travel to Pakistan for the 2023 Asia Cup.

"That is not the BCCI's call. We can't say where our team has to go. Whether we leave the country or teams coming into the country, we need clearance. Once we get clearance from the government then we go with it. We can't make decisions on our own. We have to rely on the government," Binny said at an event organised by Karnataka State Cricket Association in Bengaluru.

The Asia Cup is scheduled to be played in Pakistan in September next year. However, BCCI secretary Jay Shah, who is also the president of the Asian Cricket Council (ACC) recently said that the Indian team will not travel to Pakistan for the Continental championship and demanded that the event be moved to a neutral venue.

Shah's comment ruffled some feathers in Pakistan and the Pakistan Cricket Board (PCB) then requested the Asian Cricket Council to convene an emergency meeting

The PCB in its statement had also mentioned that if India did not travel across the border for the tournament then such a move could jeopardise Pakistan's participation in the ODI World Cup, which is set to be held in India in 2023.

#### UAE defeat Namibia; help Netherlands enter Super 12 stage

That's when Wiese stepped up to hit three fours and as many sixes in his 36-ball stay at the crease and shared a 70-run stand with Rubel Trumpelmann with the eighth wicket, a record partnership in T20 World Cup history, as dew started to settle in.

But Wasim took out Wiese in the final over and gave away just six runs in the final over to knock Namibia out of the competition and propel the Netherlands to enter Super 12 stage from Group A alongside 2014 champions Sri Lanka.

Chasing 149, Namibia lost their opening pair of Stephen Baard and Michael van Lingen in the first three overs. Namibia's troubles increased when Nicol Loftie-Eaton was trapped lbw while captain Gerhard Erasmus (castled by Karthik Meiyappan) and JJ Smit (run out at bowler's end) were out in quick succession in the eighth over.

Netherlands by 16 runs in a decisive Group A match of the first round at Kardinia Park, Geelong, to confirm Super 12 qualification in ICC Men's T20 World Cup. After Mendis's knock helped the 2014 T20 World Cup champions post 162/6 in their 20 overs, the Netherlands opener Max O'Dowd made an unbeaten 71 off 53 balls, laced with six fours and three sixes and was the long ranger for his side.

The Netherlands' hopes of reaching Super 12 are now on the Namibia-UAE clash happening later in the day, with a UAE victory giving them the ticket to continue their journey in the tournament.

The American advanced to the Round of 16 with a 6-3, 4-6, 6-3 win over Ajla Tomljanovic. The victory kept Keys in contention for one of the three remaining spots at the WTA Finals.

## India's tour of Bangladesh to begin with three ODIs, followed by two Tests in December

The Bangladesh Cricket Board (BCB) on Thursday announced the schedule for Indias tour of Bangladesh, which will begin with three ODIs from December 4, 7 and 10 to be held at the Sher-E-Bangla National Cricket Stadium in Dhaka.

After the end of the ODIs, India will play two Tests against Bangladesh, firstly at Chattogram from December 14 to 18 at the Zahur Ahmed Chowdhury Stadium, and then the second Test at the Sher-E-Bangla National Cricket Stadium in Dhaka. After the tour ends, India will depart Bangladesh on December 27.

Both Tests are a part of the ICC World Test Championship cycle, where India are currently placed fourth with 52.08 percentage points. Bangladesh, on the other hand, are in the last position in the championship table with 13.33 percentage points. This will be the first time that India will tour Bangladesh since 2015. In that tour in 2015, the lone Test ended as a draw while Bangladesh emerged victorious in the ODI series 2-1.

In an official statement, BCB
President Nazmul Hassan felt thrilled
about the prospect of multi-format
meetings between the two sides in
December. "The Bangladesh-India
matches in recent history have given us
some epic contests and fans from both
countries are eagerly waiting for another
memorable series. I thank the Board of
Control for Cricket in India (BCCI) for
working closely with the BCB in confirming the schedule. We look forward
to welcoming the Indian team to
Bangladesh."

BCCI Secretary Jay Shah echoed the same sentiment as expressed by Hassan. "I extend my best wishes to the



Bangladesh Cricket Board for the upcoming bilateral series featuring India. The India-Bangladesh contests generate tremendous interest among the fans thanks to the massive fan following the two teams enjoy"


