Wheat, flour prices soar, expected to remain high till new crop arrives

n the past one month, prices of wheat and flour have soared by 5 per cent and 4 per cent, respectively, and commodity

watchers expect them to remain high till the new crop arrives, which is bad news for the consumers of the two essential commodities.

In the past one year, wheat prices

have gone up by 15 per cent, while flour prices have increased by 23 per cent, and with the new crop expected only in April 2023, the prices are expected to remain high, market watchers said.

Owing to the Russia-Ukraine war, global demand for wheat has increased sharply while production has been low, which has led to the spike in prices of the commodity. As of now, the government has

227 metric tonnes of wheat, which is just 22 tonnes more than the buffer stock norms of 205 metric tonnes. However, if sources are to be believed, the government does not have any plans to sell wheat in the open market or apply stock limit. Sources also pointed out that the government is monitoring the situation and the inter-ministerial committee will review the prices of wheat this week.



WhatsApp bans over 23 lakh malicious accounts in India in Oct

eta-owned WhatsApp on Wednesday said it banned over 23 lakh bad accounts in India in the month of October in compliance with the new IT Rules 2021 which are being amended to put more responsibilities on social media platforms. Between October 1 and October 31, 23, 24,000 WhatsApp accounts were banned and 8,11,000 of these accounts were proactively banned, before any reports from users, said the company. The messaging platform, which has more than 400 million users in the country, received 701 complaint reports in October in India, and the records 'actioned' were 34.

INDIAN STANDARDS TO BE PART OF CURRICULUM IN **EMINENT INSTITUTIONS**

New Delhi: With a view to introduce Indian standards as an integral part of the curriculum in eminent institutions. the Bureau of Indian Standards (BIS) has partnered with six top engineering institutes of India. Officials said that this initiative is for institutionalising the engagement of BIS with the institutes for securing the active participation of academia.

The partnership was signed with the Indian Institute of Technology BHU, Malaviya National Institute of Technology Jaipur, Indian Institute of Technology Indore, Indian Institute of Technology Patna, Indian Institute of Technology Madras and National Institute of Technology Trichy on November 28, 2022 for establishment of a 'BIS Standardization Chair Professor' at these institutes.

The official emphasized on the need to engage with start-ups and incubation centres at academic institutions in the formulation of new standards and compliance with the existing.

Bilkis Bano moves SC, challenges premature release of 11 convicts

The premature release of convicts on August 15 set off a huge controversy, with political parties and civil society organisations demanding the decision be rolled back. The convicts, in fact, received a 'heroic welcome' amidst fanfare, triggering controversy.

- In the aftermath of their release, several activists and leaders from opposition parties moved the Supreme Court challenging the Gujarat government's decision to set convicts free.
- When the matter came up for hearing, the state government in its affidavit told the court that the release of convicts was based on their "good behaviour" and that they had already spent 18 years in jail. It had also told the court that the decision had the approval of the Union home ministry.

ilkis Bano has approached the Supreme Court challenging the premature release of 11 convicts who gang-raped her and killed her family members, including her three-old daughter in 2002. She has also sought the review of the Supreme Court's earlier judgment that allowed the Gujarat government to make a decision on the remission of the convicts, LiveLaw reported. Chief Justice D.Y. Chandrachud said he will look into the matter

today, November 30 evening, and decide on the listing of the petitions. Advocate Shoba Gupta, appearing on behalf of Bano, sought to know from the CJI if the matter would

come up before a bench headed by Justice Ajay Rastogi since he is now part of a constitutional bench hearing.Justice Rastogi had earlier authored the verdict that allowed the Gujarat government to consider remission pleas of the convicts, which Bano has opposed. Bano's advocate, Gupta, urged the CJI that the matter be heard in an open court.To this, CJI said, "Only court can decide that. The review has to be heard first. Let it come before Justice Rastogi."The convicts walked out of the Godhra sub-jail on August 15, after a Gujarat government panel approved their application for remission of sentence under the state's 1992 remission policy.

In May, a bench led by Justice Rastogi had said that the Gujarat government had the jurisdiction to consider the remission pleas of the convicts since the crime took place in Gujarat. The apex court bench had overturned Gujarat high court's earlier ruling that remission pleas must be considered by the state of Maharashtra since the trial was transferred out of Gujarat.

PUNJAB POLICE CANE-**CHARGE PROTESTING** FARMERS IN SANGRUR

Chandigarh: Punjab Police on Wednesday cane-charged protesting farmers and farm

labourers outside Chief Minister Bhagwant Mann's rented house in Sangrur town.Mann is currently campaigning in Gujarat for the assembly polls.

Tens of thousands of farmers assembled there over their demand, including an increase of minimum daily wages to Rs 700 under the Mahatma Gandhi National Rural Employment Guarantee Act 2005 (MGNREGA), implementing fivemarla plot schemes for Dalits and allotment of the third part of common panchayat land on lease to the community.

They were protesting under the flag of Sanjha Mazdoor Morcha, a joint front of eight labour unions.

In the evening, as they marched towards the chief minister's residence, the police resorted to the cane-charge to disperse them.

Maha minister compares CM Shinde with Chhatrapati Shivaji, sparks row

fresh row erupted in Maharashtra politics after a Bharatiya Janata Party minister Mangal Prabhat Lodha compared Chhatrapati Shivaji Maharaj's escape from Agra Fort in 1666 from Mughal clutches with the 2022 political rebellion against the party (Shiv Sena) by Eknath Shinde who later became the Chief Minister.

At a commemoration function atop the historic Pratapgad Fort on Wednesday afternoon, Lodha - a prominent realtor, made the comparison which drew strong reactions from the Opposition Maha Vikas Aghadi allies.

"Chhatrapati Shivaji Maharaj went out of Agra, so is Shinde. As Aurangzeb had barred the Maharaj, someone also had stopped Shinde. Chhatrapati Shivaji Maharaj came out for 'Swarajya', Shinde did it for Maharashtra," claimed Lodha.

The BJP minister's comments left CM Shinde and Deputy CM Devendra Fadnavis aghast and the large audience virtually speechless, while the Opposition slammed him, with one of

the allies launching demonstrations. Nationalist Congress Party (NCP)'s Leader of Opposition Ajit Pawar attacked Lodha, demanding 'control' over people who make such statements even in the presence of the CM.

"These people who keep making such statements must be controlled. After one stumbles, the other becomes cautious. But, it seems there is competition among them. Can Chhatrapati Shivaji Maharaj ever be compared like this,' fumed Pawar. Shiv Sena (UBT) leader and ex-Minister Aditya Thackeray condemned the comparison of Chhatrapati Shivaji Maharaj with those whom Maharashtra considers as 'gaddaar' (traitors).Congress Legislature Party Leader Balasaheb Thorat said that this has become a trend, with Chhatrapati Shivaji Maharaj being insulted by the Governor, the BJP spokesperson and now a minister.

"The Chhatrapati is the pride of the state. We strongly condemn the minister's statement. He must apologise for it or the people of the state will never forget it," demanded Thorat.

n a dramatic late night development on Tuesday, the new NDTV board approved the resignations of Prannoy Roy and Radhika Roy as directors of RRPR Holding Private Ltd (RRPR), the promoter group vehicle of New Delhi Television Ltd (NDTV).

This means that the existing and longstanding promoters and management of NDTV has exited the company. The Adani group takeover is thus complete.

The board also appointed Sanjay Pugalia and Senthil Chengalvarayan as directors on RRPRH board with immediate effect.

It needs to be mentioned that NDTV's promoter firm RRPR Holding had on Monday stated that it had transferred shares constituting 99.5 per cent



of its equity capital to Adani groupowned Vishvapradhan Commercial (VCPL), thus completing the official takeover of NDTV by the Adani group.

The transfer of shares will give the Adani group control over a 29.18 per cent stake in NDTV. The open offer, which began on November 22, has seen shareholders tender 5.3 million shares, or 31.78 per cent of the issue size of 16.7 million shares, so far, the exchange data showed. The open offer will close on December 5.

GDP GROWTH HALVED TO 6.3% IN SEP QUARTER OF CURRENT FISCAL

New Delhi: As India's GDP growth halved to 6.3 per cent in the September quarter of the current fiscal from 13.5 per cent in the June quarter, economists said that the fall is in line with broader expectations, including RBI's own forecast.The drastic fall in GDP growth in July-September period was mainly due to moderating of a favourable base effect.

The GDP had expanded by 8.4 per cent in September quarter of 2021-22, according to data released by the National Statistical Office (NSO).

GDP growth was boosted by the performance of private consumption expenditure and gross fixed capital formation, whereas government expenditure displayed a discouraging contraction in Q2 FY2023, on account of the modest de-growth in the Centre's non-interest revenue expenditure. Additionally, net imports nearly doubled as compared to the year-ago period, exerting a drag on the GDP growth. Moreover, discrepancies stood at a 10-quarter high in Q2 FY2023, which suggest substantial revisions in the sectoral growth prints may lie ahead.

'Entities registered as companies to be allowed to provide local news'

The Cable Television Networks Rules, 1994, permit Multi-System Operators (MSOs) to transmit their own programming service, either directly to their own subscribers or through one or more Local Cable Operators.

- These own programming services referred to as Platform Services (PS), which also include most 'local-channels', are exclusive programming services being generated at local level offered by MSOs.
- All PS channels will be placed together under genre 'Platform Services' in the Electronic Programme Guide (EPG) along with their Maximum Retail Price and option for activation / de-activation of PS as per the applicable orders / directions / regulation(s) of TRAI.
- MSOs offering PS, to retain recording of all PS channel programmes for a period of 90 days, said the guidelines.

As per the guidelines issued by the Ministry of Information and Broadcasting for Platform Services, MSOs (Multi System Operators) not registered as "company" and desirous of providing local news and current affairs are mandatorily required to apply within three months with Ministry of Corporate Affairs for conversion into "company".

The guidelines said that a simple online registration process for PS channels by MSOs is at nominal fees of Rs 1,000 per PS channel. It also said that the total number of permitted PS channels per operator is to be capped at 5 per cent of the total channel carriage capacity.

In accordance to the Rule 6(6) of the Cable Television Networks Rules, 1994; the Ministry of Information and Broadcasting on Wednesday issued the guidelines in respect of 'Platform Services' provided by MSOs in India.

To cater to the need of the local language and culture of the subscribers, the cap on PS channels shall be computed at the level of state/ union territory.

Also, additionally, 2 PS channels shall be permitted at the level of each District to cater to the need of local content at the District level.

Besides, all PS channels will have to carry a caption as 'Platform Services' to distinguish them from the registered TV channels.

The guidelines included that the content of the PS to be exclusive to the platform and is not to be shared directly or indirectly with any other Distribution Platform Operator.

However, sharing of live feeds from the religious places like Temples, Gurudwaras etc., shall be permitted.



GOVT TELLS TELCOS NOT TO INSTALL 5G BASE STATIONS WITHIN 2.1 KM FROM AIRPORTS

he Department of Telecommunications (DoT) has sent a letter to telecom providers Bharti Airtel, Reliance Jio and Vodafone not to install C-band 5G base stations within the 2.1 km range of Indian airports with immediate effect, as C-

Band 5G can create problems with the aircraft's radio (radar) altimeters, which they rely on during takeoff and landing, and to help avoid crashing into mountains. The DoT letter, seen by IANS, said

that the telecom service providers (TSPs) are advised that "in the area 2,100 meters from both ends of runway and 910 meters from centre line of runway of Indian Airports shall have no 5G/ IMT base stations in the 3,300-3,670 MHz".

"The base station, nodal or repeater installed in the periphery of 540 metres surrounding the area, the maximum power must be limited to 58 dBm/ MHz in 3,300-3,670 MHz range," the letter said.

Airtel has installed 5G base stations at airports in Nagpur, Bengaluru, New Delhi, Guwahati and Pune, While Jio has installed 5G base stations in the Delhi-NCR area.



According to the DoT letter, the Ministry of Civil Aviation has provided the buffer and safety zone sketch and has requested to ensure mitigation measures while implementing Cband 5G spectrum, in and around the airport areas in view of the safety concerns for operation of aircrafts.

The DoT asked telecom providers to ensure downward tilting of 5G base stations to an extent such that the 5G emissions do not interfere with radio altimeters. The new rule will be applicable till the replacement of all aircraft Radio Altimeters filters is ensured by the DGCA.

"It is expected that the Directorate General of Civil Aviation (DGCA) will proactively ensure the above in a time-bound and expeditious manner. DGCA is requested to inform DOT as soon as the above task is complete to enable lifting of the restrictions," read the DoT letter.As high-speed 5G wireless networks roll out across the world, pilots in the US are also reporting frequent problems with the aircraft's radio (radar) altimeters

According to an analysis of reports by IEEE Spectrum (the world's leading engineering magazine) made to NASA's Aviation Safety Reporting System (ASRS), complaints of malfunctioning and failing altimeters soared after the rollout earlier this year of high-speed 5G wireless networks, which use similar C-band frequencies

In January this year, at least three flights above Tennessee in the US simultaneously experienced altimeter errors that made it "impossible to maintain assigned altitude", according to one of the pilots. One jet lost its autopilot complete-

ly, and reportedly had fire trucks waiting for it on landing. According to the report, in

February, a passenger plane on approach to the Louis Armstrong International Airport in New Orleans experienced erratic low-altitude warnings as it flew below 1,000 feet.

In March, a commercial jet landing on autopilot at Los Angeles International Airport suddenly went into an aggressive descent just 100 feet above the ground.

All three incidents -- and many more this year -- were linked by pilots to problems with the aircraft's radio altimeters, according to the report.

BS-IV vehicle scam: ED attaches properties worth **Delhi Excise Policy Scam: Arora** Rs 22 cr, Ashok Leyland's role being probed sent to ED custody till Dec 7

Delhi Court on Wednesday sent Amit Arora, Director of Buddy Retail, to seven days Enforcement Directorate (ED) remand in connection with the alleged Delhi Excise Policy scam. The ED sought 14 days of custody, however, the court gave a week's time. Arora was arrested by the probe agency from Gurugram this morning.

Last week, the economic intelligence agency filed its first charge sheet in the matter.

Arora, the accused number ninth in the ED and Central Bureau of Investigation (CBI)'s FIR, is the owner of Buddy Retail Private Limited. Running over 3,000 pages, the first charge sheet was filed against businessman Sameer Mahendru.

There are allegations that Arun Ramchandra Pillai, a resident of Kokapet in Hyderabad, used to collect undue pecuniary advantage from Mahendru for onward transmission to accused public servant Vijay Nair.



The ED filed its case on the basis of the FIR of the CBI. On Friday, the CBI filed its first charge sheet in the matter. It has charge sheeted Vijay Nair, Abhishek Boinpally, Sameer Mahendru, Arun Ramchandra Pillai, Mootha Gautham, and two public servants -the then Deputy Commissioner of Excise Department Kuldeep Singh and the then Assistant Commissioner of Excise Department Narender Singh.

he Enforcement Directorate (ED) on Wednesday said that it has attached properties worth Rs 22.10 crore of firms in a Prevention of Money Laundering case relating to the BS-IV vehicle scam, and the role of Ashok Leyland was also being probed.

The properties are in the names of firms connected to Diwakar Road Lines and Iatadhara Industries Pvt Ltd. of former Andhra Pradesh TDP MLA J.C. Prabhakar Reddy, and another firm C. Gopal Reddy & Co and family members.

The Supreme Court had in 2017 ordered that vehicles that were not compliant to BS IV emission norms should not be sold in India by any manufacturer or dealer from April 1, 2017, and that the registering authorities were also prohibited.



However, Jatadhara Industries Pvt Ltd (JIPL) and C. Gopal Reddy and Co in contravention to the aforesaid Order purchased BS-III vehicles from

Ashok Leyland Ltd at discount and fraudulently registered the same as BS-IV vehicles by fabricating the invoice copies. Investigation revealed that some of the registrations were done in Nagaland, Karnataka and Andhra Pradesh.

'The ED has gathered evidence in the form of fabricated invoices from RTO authorities in Nagaland and original invoices issued by Ashok Leyland as scrap for some vehicles and established the crime. The crime proceeds generated by owning and selling these vehicles have been quantified as Rs 38.36 crore," the ED said.As a result of the investigation and searches, movable properties to the extent of Rs 6.31 crore consisting of bank balances, cash, jewellery and receivables as well as 68 number of immovable properties to the extent of Rs 15.79 crore belonging to accused and their family members have been attached

Further investigation was in progress, including the role of Ashok Levland in the entire scam.

K'TAKA FARMER GETS RS 8.36 FOR SELLING 205 KG ONIONS, RECEIPT GOES VIRAL

Liquor den raided in Gujarat's Rajkot, families of accused create ruckus

Gadag, (Karnataka): The receipt of a farmer from Karnataka's Gadag district showing that he received only Rs 8.36 after selling 205 kg of onions, has gone viral on social media, prompting netizens to question the state's ruling BJP government over the plight of farmers during its regime. But this is not the story of just one farmer in Gadag. All onion growers in the district are getting less than Rs 10 per their produce in Bengaluru's Yeshwanthpur market.

The farmers travel a 416 km-long distance to reach Bengaluru from Gadag.

In Pavadeppa Hallikeri's case, whose receipt has gone viral, the wholesaler priced the farmer's 205 kg produce at Rs 200 per quintal, deducted Rs 377 for freight charges and another Rs 24 for porter charges.

Another farmer from the district who had gone to the Bengaluru market with 212 kg of onion, got a total of Rs 1,000. But, after deducting the porter commission, transport charge, hamali charges, he only received Rs 10.

The farmers managed to reap a good crop following the incessant rain creating havoc.

But, the crash of prices of the onion crop has devastated the lives of farmers of the entire district, explain locals. The people are demanding that the Minister for Agriculture B.C. Patil, who is also a district in-charge minister of Gadag district, to come forward and help the farmers.

The resignation came a day after the new NDTV board approved the resignations of founders Prannoy the company.


The board also appointed Sanjay Pugalia and Senthil Chengalvarayan as directors on RRPRH board with immediate effect.

Mumbai in a bus. Cops will check all the major points where the bus had stopped and then go on to Goa to investigate the matter. The inspector (crime) at Nerul police station is handling the case. Tamina Alem, a Malwani resident, died on the bus on Sunday. She was allegedly coming to Mumbai from Goa with her friend after she sustained injuries while learning to ride a scooter on Friday. Forensic experts have concluded that the primary reason behind her death is a head injury. Her viscera have been reserved for histopathological analysis.

Senior Inspector Tanaji Bhagat of Nerul police station said, "The primary cause of the death mentioned by the forensic expert is head injury. It is hard to believe that her friend was unaware of the injury. Her mother has told us that she had spoken to Alem the morning of the day she died." "We need to conduct a more detailed investigation. We have to reverse track the bus route and check CCTV camera footage wherever the bus stopped. If necessary, a team can be sent to Goa for further investigation," said Bhagat.

The bus driver and the cleaner, in their statement, said the woman was fine when she boarded the bus, but fell unconscious when the bus stopped at Kohinoor Hotel in Satara. Alem's friend Sachin Kittu, who had gone down to get tea, had asked the driver to take the bus to a hospital, but he refused. They allegedly also had a fight, but the bus driver and cleaner denied beating up Kittu, said a police source.

special court in Mumbai has relied on a DNA test report and sentenced a 41-year-old man to 20 years' imprison-And sentenceu a 41-year-old inter to 20 year-old step-daugh-ment for repeatedly raping his 16-year-old step-daughter since 2019 and impregnating her, even the victim turned hostile during the case trial.

Special Judge Anis Khan, designated to hear cases related to the Protection of Children from Sexual Offences (POCSO) Act, in the order passed on Tuesday said in such peculiar circumstances, DNA tests are an effective tool for investigation as well as to establish the proof of guilt of the accused.

"The DNA report clearly indicates the accused was the biological father of the foetus of the victim girl," the court said in the order, a copy of which was made available on Wednesday.

"It is, indeed, sad that a very serious and heinous offence has been committed by a step-father on his step-daughter who is a child below 18 years," it said.



Merely because the victim and her mother have turned hostile does not mean it would lead the prosecution case to fail, the court said. As per the prosecution, the accused had been raping the girl since October 2019.

In June 2020, the girl informed about the offence to her mother following which a police complaint was lodged.

During a medical examination, it was revealed the girl was 16 weeks pregnant. The pregnancy was later terminated.

During the trial, the victim and her mother turned hostile.

The court in its judgement said the victim and her mother in their statements before the court claimed the accused was the only earning member of their family and hence they want to forgive him and bring him out of jail.

The statement given by the victim is sufficient to prove she is under emotional pressure from her mother and hence has denied the incidents," the court noted.

"In these peculiar circumstances, DNA tests are an effective tool for investigation as well as to establish the proof of guilt of the accused. In the present case, the DNA test has proved that the accused and the victim were the biological parents of the foetus," the court said. The procedure of collection of blood samples, submission of the same to a lab and further analysis was done properly and hence the final DNA report has to be accepted, the court said.

ONLY 9% WOMEN CANDIDATES IN FRAY IN GUJARAT POLLS

plitical parties are relying largely on male candidates in the Gujarat Assembly polls as only 9 per cent women candidates are in the fray this time. The 182-member Gujarat Assembly will go to the polls in two phases on December 1 and 5, while the counting of votes will be taken up on December 8. Incidentally, the women participation has gone up as compared to the 2017 Assembly polls. This time, a total of 138 (9 per cent) female candidates are contesting the elections, as compared to 122 (7 per cent) in 2017out, a report by Association for Democratic Reforms (ADR) said on Tuesday. BJP has fielded 9 per cent women candidates, whereas Congress and AAP have fielded 7 per cent and 4 per cent women candidates in Gujarat polls, respectively. As per the report, 997 (62 per cent) candidates have declared their educational qualification to be between 5th and 12th standard, while 449 (28 per cent) candidates have declared having an educational qualification of graduate or above. The report said that 48 candidates are Diploma holders and 85 candidates have declared themselves to be just literate while 42 candidates are illiterate. Similarly, 561 (35 per cent) candidates have declared their age to be between 25 and 40 years, while 861 (53 per cent) candidates are aged between 41 and 60 years. There are 197 (12 per cent) candidates who have declared their age to be between 61 and 80 years, while two candidates are aged above 80 years.

CLIMATE CHANGE WARRIORS ON AN ASSERTIVE STREAK

fter successfully getting a Loss and Damage Fund established, the climate

change warriors have also launched legal actions against unresponsive governments.

It seems that Climate Change is now gaining real traction and importance for the common people more and more, but our politicians are not ready to take any notice of these changes, which are going to have immeasurable negative impact on the lives of billions of people across the globe.

Besides calls for wealthier nations to provide compensation to underdeveloped countries to cover the costs of severe damage and losses, citizens of some countries have also initiated legal proceedings against their governments for inadequately addressing the climate change fallouts.

The month of November saw two environment-related incidents taking place. First, at the latest COP summit at Sharm El Sheikh in Egypt, termed as 'Africa's COP', the voice of the most-vulnerable and mostaffected countries was heard with an agreement to establish a loss and damage facility.

However, progress is still snailpaced in terms of raising ambitions to curb greenhouse gas emissions. Leaders attempted to keep that goal alive at the Egypt conference. but did not increase calls to reduce carbon emissions.

November also saw hundreds of activists, including Greta Thunberg, marching through the streets of Stockholm to a court to file a lawsuit against the Swedish government for what they claim is insufficient climate action.

Lawsuit by Swedish citizens

Over 600 young activists signed an 87-page document, which would serve as the foundation for the lawsuit, which was filed in the Stockholm District Court.

They want the court to rule that the country's climate policies violate the human rights of its citizens. According to Anton Foley spokesman for the youth-led initiative Aurora, which prepared and filed the lawsuit, Sweden has never treated the climate crisis as a crisis. Sweden is failing to fulfil its responsibilities and is breaking the law.

Earlier, in one of the most highprofile cases, Germany's highest court ruled last year that the government's climate targets must be adjusted to avoid undue burden on the young. The German government responded by pushing back its target for net zero emissions by five years to 2045 and laying out more ambitious near and medium term steps to achieve that goal.

What emerges from this is that people all across the world are increasingly becoming aware of the damages wrought by the Climate Change, and also understanding that who is the main culprit for unleashing this catastrophe, in pursuance of greed and lucre.

What is loss and damage?

The Alliance of Small Island States at international climate negotiations in Geneva in 1991, first introduced the concept of loss and damage, but it was not seriously considered again until 2013 at the COP-19 climate conference

in Warsaw, Poland.The Warsaw International Mechanism for Loss and Damage was created with the aim of enhancing knowledge of the issue and finding ways to approach it. There has been little progress since then.The Glasgow COP, last year rejected a proposal made by members of the G-77 group of over a hundred developing countries and China for a formal loss and damage financial facility. Instead, in a bureaucratic manner, the Glasgow Dialogue was established for further discussion on the issue and it's funding.Critics have described the dialogue as "an excuse to delay further action." It seems as if the rich countries are dragging their feet on financing any such endeavour.

While historically, between 1751 and 2017, the US, the European countries and the UK were responsible for 47 per cent of cumulative carbon dioxide emissions, as compared to just 6 per cent from the entire African and South American continents. Yet, the culprits have been slow to make financial contributions to ease the impact on the most affected countries.

In 2010, Global North nations agreed to pledge \$100 billion annually by 2020 to help developing countries adapt to the impacts of climate change.

But according to the Organisation for Economic Cooperation and Development (OECD), which tracks funding, in 2020 wealthy countries pledged just over \$83 billion. That was a 4 per cent increase on the previous year, but it still falls short of the agreed amount.

What's the impediment?

Though in principle, developed nations acknowledge the need to address loss and damage, some amongst them argue for financing through existing climate funds, insurance schemes and humanitarian aid. Their reluctance is reflected in the European Union's briefing, for example, which said that it was "open to discussing L&D (loss and damage) as a topic but hesitant about creating a dedicated L&D fund"

Former British Prime Minister and WHO ambassador for global health financing, Gordon Brown has realistically opined that the announcement of the new initiative -- the global loss and damage fund -- to right historical wrongs by compensating climate-hit developing countries, might be a good feel factor but the real question is whether the developed world will really loosen its purse strings? This breakthrough, he says,

brought back memories of another initiative, the 100 billion pounds a year agreed at the 2009 Copenhagen climate summit to help poor

countries mitigate

the effects of the climate crisis Brown says further that that

money has never fully materialised. If 13 years' experience of the 100 billion pounds fund that never was is anything to go by, eulogies of praise will soon turn into allega tions of betrayal. Far from the loss and damage fund narrowing the credibility gap on climate action, it is likely to bridge nothing if money fails to flow from rich to poor.

What is needed, however, is not less but more aid to help developing countries tackle the dramatic consequences of an unprecedented series of crises. Indeed, developing countries, unlike advanced economies, had no fiscal, mone tary, or social space at the onset of these crises, to raise the issue.

One key priority for the global community should be not only to increase aid but also to make it much greener to help developing countries tackle the challenge of climate adaptation in an effective manner. Green aid encompasses financial and technical assistance to governments and direct investments in projects in both mitigation and adaptation to climate change.

PROTESTERS TURN STREETS INTO WARZONES IN CHINESE CITY

Putin is failing in his brutal war of aggression: NATO chief

rotesters screamed as they threw glass bottles at scores of cowering hazmat-clad riot police in China, as demonstrators continue to defy President Xi Jinping's brutal Communist regime and his disastrous zero-Covid policies, media reported.

The sound of shouts and the smashing of glass pierced the night air in the southern Chinese city of Guangzhou, as the defiant and frustrated protesters clashed with riot police carrying shields.

Hundreds of riot police, seen wearing hazmat suits for the first time. advanced towards the protesters and were seen dragging the screaming protesters away to unknown locations in dystopian scenes. The violent protests mark some of the strongest dissent China has seen for over 30 years - but despite Beijing cracking down on protesters with ruthless violence, demonstrators are still defiant-



tral government. The protests mark the most overt threat against Xi's government and his brutal Communist regime since he took power 10 years ago, Daily Mail reported. In

Guangzhou, angry protesters threw anything they could find - including glass bottles - at the police officers,

who cowered under their riot shields. The violent clashes prompted a fierce rebuke, with officers dragging screaming protesters away to unknown locations. Earlier on Tuesday night, locals shopping in a market watched on as a steady stream of riot police officers marched in formation through the streets of Guangzhou. The arrival of hundreds of riot police escalated tensions in the city and video shows demonstrators throwing glass bottles at the officials in chaotic and violent scenes

The riot police were seen tightly bunched together, with rows of officers protecting themselves from the incoming onslaught of glass with their see-through shields.

In the video, people could be seen screaming and shouting in frustration at the brutal crackdown against protesters who are demonstrating against Xi's zero-Covid policy which has seen millions placed under strict lockdowns for months, Daily Mail reported.

ATO Secretary General Jens Stoltenberg said that Russian President Vladimir Putin is "failing in his brutal war of aggression" in Ukraine and is "responding with more brutality".

He made the statement on Tuesday while attending a forum in the Romanian capital of Bucharest. In his opening remarks, Stoltenberg said that in response to Russia's full-fledged invasion of Ukraine, "we are raising the readiness of our troops".

We have doubled the number of NATO battlegroups from four to eight, including one in Romania, led by France," he said.

The Secretary General stressed that NATO allies and the alliance are not a party to the conflict in Ukraine, "but we are providing unprecedented support" to Kiev for as long as it takes.

"Because Ukraine is a nation that has the right to self- defence, a right which is enshrined in the UN Charter.'

According to the NATO chief, Putin is trying to "weaponise winter".

"To force Ukrainians to freeze or flee. He is trying to break the will of the brave Ukrainian people. And to divide all of us who support them." Stoltenberg went on to say that NATO

and its allies have made additional pledges to the alliance's Comprehensive Assistance Package for Ukraine which will fund urgent non-lethal support, including fuel and generators, as well as help fix critical energy infrastructure badly damaged by massive Russian missile and drone strikes.

"We realise that it is extremely important that President Putin is not able to win in Ukraine. That will be a tragedy for Ukraine, but it will also make the world more dangerous and much more vulnerable," he added.

Later at a press conference with the NATO chief also in Bucharest, Ukrainian Foreign Minister Dmytro Kuleba said the last time he met senior officials of the alliance, his three words were "weapons, weapons".

'US WORKING TO IMPROVE EARLY WARNING SYSTEM AGAINST N.KOREAN MISSILE LAUNCHES'

Washington: The US is working to further improve its missile warning system, the commander of US Space Command has said, following a barrage of North Korean missile tests that included multiple intercontinental ballistic missile (ICBM) launches.

"We are looking at how we integrate a sensor architecture that gives us as much warning as possible in terms of any type of missile activity out of North Korea,' Gen James Dickinson said on Tuesday in a webinar hosted by the Mitchell Institute for Aerospace Studies, a Washington-based research organisation.

Dickinson said the Space Command is currently working to integrate existing US assets into "an architecture where we can provide both the US and our allies and partners as much advanced warning as possible", adding, "We are also looking at how we can incorporate commercial sensors in the same respect.'

His remarks come after a recent series of North Korean missile launches, Yonhap news agency reported.Pyongyang fired over 30 ballistic missiles since late September, also conducting its 10th ICBM test of the year on November 18.

Since the start of the year, the North launched an annual record of 63 ballistic missiles, far exceeding the previous record of 25 in 2019.

United Nation's envoy warns of dangerous escalation in Syria

N Special Envoy for Syria Geir Pedersen has warned of a dangerous escalation in the war-torn Arab nation.

"In repeated briefings, I have warned of the dangers of military escalation in Syria. I am here in person today to tell you that escalatory dynamics are indeed taking place, and this is worrying and dangerous," he told the Security Council in a briefing on Tuesday

For many months there has been a slow increase in mutual strikes between the Syrian Democratic Forces (SDF) on one side, and Turkey and armed opposition groups on the other, across northern Syria and with violence spilling over into Turkish territory, he said.

On November 20, a week after the bombing in Istanbul,



which Turkey attributed to the Kurdish People's Protection Units (YPG) in and the Kurdistan Workers Party (PKK) -- a claim that the SDF denied -- Turkey launched what it called the "Claw-Sword Air Operation".

There were also reports of SDF strikes on Turkish forces and armed opposition-controlled areas and inside of Turkish territory, said Pedersen

"Once can never predict when and how the tigers will react.... Luckily for us, that we did not take any sudden action, but sat quiet and watched the tigress move on," Raveena said.

"We were on the tourism path, which mostly these tigers cross. And Katy the tigress in



this video as well, is habituated to coming close to the vehicles and snarling, she added. Contending that tigers

are the kings where they roam, they (the visitors) were 'silent spectactors' as any sudden movements can startle them (the big

cats) also, she pointed out.

The video which went viral on the social media, shows the safari jeep purportedly near the tigress, camera shutter sounds are audible as also the tigress roaring at them in the sanctuary. Following an uproar, the MP Forest Department authorities ordered a probe on Tuesday (November 29), and all those who were on that safari shall be questioned.

Raveena added how "close encounters of all kinds are pretty regular and uploaded by all" on social media. "God forbid it happens to be a famous person in the vehicle. n a major update in the myserious death of an 18-year-old MP girl in Puri, the Odisha police formed a SIT on Wednesday to probe the case. The girl was a resident of Bina and had gone to Jagannath Puri on a family trip. Her death under mysterious circumstances had sparked protests in her hometown, after which CM Shivraj Singh Chouhan ordered a high level probe into the matter.

After the CM's intervention, Sagar and Odisha police have been cooperating to solve the the case together. The Odisha police informed about forming a SIT to Sagar SP Tarun Nayak over a telephonic call. Madhya Pradesh DGP Sudheer Saxena also talked to Odisha DGP over a call to speed up the probe and bring justice to the victim's family members. In a letter addressed to the Sagar SP, Odisha police, has said that in view of the

seriousness and sensitivity of the matter, a special investigation team has been formed. The team will comprise of Sadar SDPO, KC Mund, and DSP, Manobrata Satapathy. According to reports, the 18-year old girl

had gone with her family members to offer puja at Jagannath Puri in Odisha. The family decided to stay at a hotel in Puri from where the girl went missing on November 23. The girl had reportedly come down from the hotel, to pick up clothes that had fallen down. When she did not return, the family members filed a complaint with the police. Later, on November 26 her body was found on the Penthakota beach in Puri. The girl was found floating face down in undergarments and had severe injuries on her body. Receiving information about this, the victim's family members alleged that she was raped and said, "Her face was burnt with acid and her fingers were mutilated." After recovering the dead body, a postmortem was conducted by Penthakota Marine PS in-charge, Bamdev Nanda in the presence of the district scientific team. The team of doctors that conducted the postmortem said that prima facie, the victim's death can be attributed to drowning.

sneopur woman donates property, life savings worth Rs I crore to Temple Trust

n elderly woman donated her share of L property worth nearly Rs 1 crore to Chhimchhima Hanuman Temple Trust in Sheopur district of Madhya Pradesh. Shiv Kumari Jadon is a teacher in one of the government schools of Khitarpal village in Vijaypur area.

According to reports, she took the decision to donate all her life savings, assets and property to the Trust as she was disappointed with her husband and sons' behav-

iour. Shiv Kumari ensured her two sons received their official share and then transferred her own share of property, gold & silver ornaments and bank balance to Chhimchhima Hanuman Temple Trust. Reportedly the

woman mentioned in her will that the authorities of the temple trust should conduct her funeral instead of family members. Also, she said the amount received from the life insurance policy post her death along with gold and silver will belong to the

temple trust.

Brecovered all 17 rifles which were looted by unidentified miscreants from a post set up by the forest department in Burhanpur district, an official said. The incident occurred at Bakdi post under Navra forest area of Nepanagar tehsil around 9:30 pm on Monday.

Superintendent of police (SP) Rahul Kumar Lodha said, "Police recovered all the firearms on Wednesday during a search operation launched after the incident." SP Lodha addressing the media persons here informed that the accused fled leaving the weapons near the pond at the Bakdi forest outpost.

Earlier, on the night of November 28, about 15 to 20 unidentified assailants attacked Bhola Barela, a security guard posted at the forest department's outpost armoury and his wife, and looted 17 rifles and cartridges kept in the cup-



board of an armoury

On the complaint of Barela, police registered a case against unidentified miscreants under Section 395, 397 (dacoity) of IPC and began an intensive search operation in the area. Joint teams of police and forest department raided Bakri and Jampati villages. The weapons recovered from the spot

include 16 pieces of 12 bore guns, one Bharmar gun, which totals to 17 guns. 652 pieces of cartridges of 12 bore guns and 82 pieces of fired cartridges were also recovered.

The total value of the seized material is about Rs 4.45 lakh. The accused are still on the run and police teams are looking for them.

Indore: An application in the district court by honey trap case accused Shweta Vijay Jain, seeking an order to let her operate her bank account was rejected. The court refused to allow



her to do transactions from the bank account. The accused had also pleaded to get the money seized by the police delivered to her but this demand was also rejected. The court had earlier dismissed another similar application filed by another accused in the same case.

In her application, Shweta Vijay Jain had sought permission for transactions from the bank account saying that her children's studies were being affected as the bank account has been freezed. She had said that the children's school fee has not been deposited. She feared that her children would be forced to drop out of school if the fee was not deposited.

The court, after hearing arguments had reserved the order which was issued on Tuesday.

Farmers in Ratlam wait for insurance payouts of loss sustain years ago

n 2018, when heavy rain destroyed his soybean crops, Sunil Patidar of Shivpur was not worried as he had insured his crops under the Pradhan Mantri Fasal Bima Yojana (PMFBY). He filed for mid-seasonal crop loss claim immediately, expecting to use the money for the next crop cycle. Four years on, he still awaits the insurance amount.

"I had taken a loan to sow soybean on my six bighas, but rains destroyed everything. The Patwari (revenue officer) surveyed the place and sent a report to the insurance company. Subsequently, my compensation of Rs 4,500 per bigha was approved. In total, I was to receive Rs 27,000," Sunil tells Reporters. Everything was in order, but the ICICI Bank allegedly misnamed Shivpur village as Sevria while submitting the claims information to the insurance company. Result: Sunil is yet to receive his money



According to reports, 38 complaints related to the 2020 kharif season remain unresolved till date. Launched by Prime Minister Narendra Modi on January 13, 2016, the scheme aimed at reducing the insurance premium burden on farmers who take loans for their crops, besides protecting them from the vagaries of weather.

A uniform premium of only 2 per cent for all kharif crops and 1.5 per cent for all rabi crops will be paid by the farmers and the remaining premium will be paid by the gov-

ernment, so that the farmers are provided the full sum insured for crop loss in the case of natural calamities. There is no upper limit on government subsidies. Even if the remaining premium is 90 per cent, it will be borne by the government.

Farmers complain that crop loss surveys are not conducted on time. Often, there is a delay in updating information on the insurance portal also. "Floods damaged my soybean crops. Patwari came on time to survey the loss, but the insurance company employee did not reach out for verification. I complained to the tehsildar and he contacted the insurance company. Fifteen days have passed, nothing has happened," says Rameshwar Lal of Sejavda village.

"We staged a dharna at the Collectorate under the banner of Bhartiva Kisan Sangh. That did get us an extension in 2020 from March 1 to March 10 to make an online portal entry. But even then, the insurance amount was not received," the farmers say.

Acknowledging that 38 farmers in the district have lodged a complaint with the CM helpline, he says the amounts were not received mostly due to closure of bank accounts. "In such cases, banks return the amount to the insurance company. We are making efforts to get the money back." Farmers, however, say there is a need to decentralise the functioning of insurance companies by launching offices or help centres at the local level.

ctor Evan Peters, who plays Jeffrey Dahmer in Netflix's hugely successful 'DAHMER - Monster: The Jeffrey Dahmer Story', explained the arduous prep he did to portray the notorious serial killer. The actor plays Dahmer in Ryan Murphy's 'DAHMER - Monster: The Jeffrey Dahmer Story', and while the series has garnered its fair share of criticism, Peters' visceral performance has been widely praised. In a conversation with Murphy and the series' ensemble cast, released on November 28, Peters detailed the arduous work that went into capturing Dahmer's ominous essence

"He has such a distinct voice, and that dialect," Peters said.

"I worked with dialect coaches and then created this 45-minute

audio composite that I listened to every day to stay in the accent,

but also to really get into the mindset for the day and all the scenes we were shooting. I tried to attempt to understand what he was thinking and going through. I just tried to stay in it because it was too hard to go in and out of it."

Murphy pointed to a 1994 Dahmer interview, the only network television interview Dahmer ever granted, that Murphy personally suggested as inspiration.

Peters said he "watched as much as I could," which also included courtroom footage of Dahmer. However, it was more than just the voice that Peters focused on.

"I studied how he moved," he said. "He had a very straight back. He didn't move his arms when he walked.

In fact, Peters took things into his own hands literally. Murphy revealed that Peters actually wore lead weights around his hands to work on Dahmer's distinct posture. "In the beginning it was important for me to get how that felt," Peters said. "As we

were shooting, I let that go. In the beginning I wore wardrobe's shoes, jeans and glasses. I had a cigarette in my hand at all times, just trying to get all of these external second-

nature so I wasn't thinking about it when we were shooting."




