# BJP ENJOYS LANDSLIDE **VICTORY IN GUJARAT**

**Gandhinagar** Agencies

he BJP scored a phenomenal victory in Gujarat, Prime Minister Narendra Modi's home state, smashing the Congress's record in a strong performance ahead of the 2024 national election. The Congress, pulverized in Guiarat, won in Himachal

The BJP has won 156 seats in Gujarat in yet another super-sized victory powered by PM Modi. The Congress, which delivered a strong performance in 2017, dropped to its worst Gujarat tally ever, 17. With a dispirited and belated campaign, the party had "conceded" long before the election.

The Aam Aadmi Party (AAP) of Arvind Kejriwal celebrated the silver lining after a disappointing show in Gujarat (five) and Himachal Pradesh (zero) - its "national party" status

because of the Gujarat vote share. Despite its energetic, all-in campaign, AAP failed to dent the BJP in "Fort Modi". What it did was to eat into the

Bhupendra Patel, who took over as Chief Minister a year ago, will be sworn in for a second term on December 12 (Monday). Home Minister Amit Shah

had said Patel would return as Chief Minister if the BJP won again.

The Congress, focused on its big picture Bharat Jodo Yatra, was seen as putting up a token campaign in Gujarat, where it won 77 seats in 2017, and in Himachal Pradesh, where the trend of the last few decades gives it a bonus

#### Congress gets majority in Himachal with 40 seats, BJP shrinks to 25 The newly-elected Congress MLAs of Himachal Pradesh will meet in Chandigarh

on Friday in the presence of state in-charge Rajeev Shukla and special observer and Chhattisgarh CM Bhupesh Baghel. At the meeting, a decision may be taken to empower Congress President Mallikarjun Kharge to nominate the legislative party leader.

he Congress on Thursday got an absolute majority in the Himachal Pradesh Assembly elections, winning 40 seats - six over than the halfway mark of 34 in the 68-member House, while the outgoing BJP was reduced to 25.

Many of the outgoing ministers including Suresh Bhardwaj, Ram Lal Markanda, Sarveen Chaudhary, Rakesh Pathania, Govind Thakur, Virender Kanwar, and Rajiv Saizal lost the election. Three Independents, comprising two BJP rebels and one Congress, emerged victorious. Himachal Pradesh has not voted any incumbent government back to power since 1985.

Thakur retained his stronghold Seraj in Mandi from where he has won six consecutive elections by a margin of over 22,000 votes over Chet Ram of the Congress. Prominent victorious



Doctors and nurses - treating demonstrators in secret to avoid arrest - said they first observed the practice after noticing that women often arrived with different wounds to men, who more commonly had shotgun pellets in their legs, buttocks and backs, The Guardian reported.One physician from the central Isfahan province said he believed the authorities are targeting men and women in different ways "because they wanted to destroy the beauty of these women", The Guardian reported.

The winds are likely to turn into a

severe storm by December 8's evening and maintain its intensity till December 9's morning. The storm is likely to weaken into a cyclonic storm and cross North Tamil Nadu and Puducherry coasts with a wind speed of 85 kmph around Friday midnight.

According to Weather Department, heavy rains may begin in Delta districts on Thursday evening and the IMD said that the rain intensity may peak on Friday night as cyclone gets closer to the coast. Chennai will have heavy rains on December 9 and 10 with rains expected to be around 20cm. The Weather Department said that rains will be extremely heavy in Kancheepuram, Chengalpattu, and Villupuram districts, and a red alert was declared in the three districts.

#### India's growth to depend on fiscal management, says Uday Kotak

ndia's performance in terms of absolute GDP, per capita income and current account as well as fiscal management will accentuate it's growth, Uday Kotak, Managing Director of Kotak Mahindra Bank, said on Thursday

Speaking at CII's Global Economic Policy Summit 2022, Kotak said that India is the fifth largest economy in the world and can rise further upwards.

However, it's growth would depend on economic performance in terms of absolute GDP and absolute per capita income and doing well on current account and fiscal management,



he said.Kotak added that for building Indian companies of global standards, the manufacturing scale needs to be enhanced.

This, he said, would be possible through cutting-edge innovation rather than being dependent on arbitrage alone.Speaking on interest rates, Kotak said that India's rate trajectory would depend on directions provided by the US Federal Reserve.

## PARLIAMENT CAN ENACT A LAW BUT POWER TO SCRUTINISE IT LIES WITH COURT, SC TO CENTRE ON JUDGES' APPOINTMENT

he Supreme Court on Thursday said that the scheme of the Constitution requires it to be the final arbiter of law and while the Parliament has the right to enact a law, the power to scrutinise it lies with the court, as it heard a contempt plea against Centre for breaching the timeline for judicial appointments.

The top court also made it clear to the Centre that the existing Memorandum of Procedure (MoP) for appointment of judges to the apex court and the high courts has been settled and should be complied

It also observed that Centre sending back recommendations reiterated by the collegium is in breach of its judicial directions.

The top court pointed out there was an instance where the names were sent back after 2 years, and stressed that government views are taken into account when judges' names are recommended for

A bench, headed by Justice Sanjay Kishan Kaul and comprising Justices Abhay S. Oka and Vikram Nath, took objection to the Centre citing opin-



collegium system, as an excuse to delay clearance to the recommendations made by the collegium.

It said that once the aspect of the MoP is settled by the judgment of a constitution bench of the top court, the Centre cannot get over the issue by referring to observations made by two judges, former Chief Justice Ranjan Gogoi and Justice J. Chelameshwar. The bench told Attorney General R. Venkataramani: "You have conveniently picked up some views of the judges and included that. How can that be done?'

"You may want some changes but in the meantime, the collegium along with existing MoP has to work.

Now it looks just like a blame game.' The bench added that the MoP issue is over now and asked, is it logical to latch on to the observations made by 2 judges when there is a Constitution Bench decision?

On the aspect of MoP, Justice Kaul orally observed that the government can make suggestions but it cannot re-agitate the issue of MoP that has been settled by a constitution bench judgment. He told the AG that 2 out

tuning of procedure is required, but in the meantime, the collegium system coupled with the MoP is to be followed.

The bench also took objection to the government's stand that the new MoP is yet to be finalised. "You say Justices Ranjan Gogoi and Chelameshwar said that MoP needs a relook. But then so what... even if two judges opine something... how does it change the collegium decision," the bench queried the AG, noting that MoP was settled in 2017.

On the aspect of recommendations reiterated by the collegium, the bench told the AG: "Sending back second time reiterated names is a breach of our earlier direction."

It noted that the AG submitted that in such a scenario earlier, such sent back names were actually dropped. "We don't know why the names were dropped," said the bench. The bench said according to the apex court judgment in the second judges' case, once names were reiterated by the collegium, they have to be confirmed.

The bench told the AG, "Once the collegium takes a view you have a right to object within a reasonable period of time... you have to enforce

# AAP set to join club of India's national parties

fter the vote counting for the Gujarat assembly polls started on Thursday morning, the Aam Aadmi Party got into a celebratory mode to welcome the achievement of national recognition irrespective of the poll results not going in their favour.

"Through the votes of Gujarat, the Aam Aadmi Party is becoming national party. For the first time, politics based on education and health is getting recognition in the country. Congratulations to the people of India", senior AAP leader Manish Sisodia said in a tweet on Thursday morning. Even with the early trends not favourable to the AAP in Gujarat, the party started celebrating the feat of becoming a national party.

However, the party is now all set to become the ninth national party after getting around 13 per cent vote share in the Gujarat assembly polls. A political party needs to be recognised in at least four states to become the national party. While to be recognised as a party in the state, it needs to win at least two seats and 6 per cent of votes.

With the AAP's government in Delhi and Punjab and recognition as state party in Goa, the AAP has also achieved the status of a state party in Gujarat by securing five seats and 13 per cent vote share, which is enough to be recognised as a 'national party,' the ninth in the country. "Thanks to miraculous leadership of CM Arvind Kejriwal, Aam Aadmi Party has



become a national party in just 10 years. Aam Aadmi Party is no longer limited to Delhi and Punjab, but has become the national party of India. Gujarat is called the fortress of PM Modi and Amit Shah, Kejriwal has breached their fortress today", said senior AAP leader Sanjay Singh while commenting on this. He said that ten years ago the AAP was formed, till now the people of Delhi formed our government thrice in Delhi and now we have our government in Punjab also".

After getting the national party status, important advantages among others will include that it's symbol broom will be reserved for party candidates across the country. The AAP's candidates will now appear on the top of EVM alphabetically and may also get office space in the heart of Delhi and the party can include as many as 40 star campaigners


## After Gujarat results, K'taka min claims many Cong leaders set to join BJP

"We are bound to take care of land, water bodies, forests and its people that in a nutshell complete the nation," he added.






The bail was granted with conditions by Justice Jasmeet Singh.

The elder son of the woman resided in the US, police said. "A case has been registered against the duo under relevant sections of Indian Penal Code (IPC) including 302 (Murder) and 201 (causing disappearance of evidence of offence), and further investigation is underway," the official added.



The Thackerays sought dismissal of the PIL on the ground that it was filed on assumptions and without any factual foundation.

The petition, filed by behaviour and soft skill consultant and city resi-



dent Gauri Bhide, sought a direction to the CBI and the ED to conduct a "thorough and impartial" investiga-

tion against Thackeray and his family. The bench heard the matter briefly in the morning session and closed it for orders. However, in the afternoon session, Pai mentioned the matter once again to inform the court of the

state government's stand. "The Mumbai Police's Economic Offences Wing (EOW) has initiated a preliminary enquiry into the allegations," Pai told the court.

#### Paris moment 'impossible' if world leaders fail to unite behind nature

Tith the onset of two-week negotiations of the COP15 biodiversity summit, the Cambridge Institute for Sustainability Leadership (CISL) is urging heads of government, including the UK, to show strong leadership on nature and commit to attending future summits to drive ambition and progress.

This week's UN Convention for Biological Diversity (CBD) conference aims to agree on a post-2020 Global Biodiversity Framework (GBF) outlining what countries need to do in the next decade and beyond to regenerate and live in balance with the natural world. World leaders are not expected to turn up to the negotiations in Montreal, Canada and CISL is calling on heads of governments to commit to attend future biodiversity summits to underline the vital nature of this agenda to support all life on earth and help combat climate change.

Humans are causing an unprecedented decline in nature and the ecological services it provides for free. One million species of plants and animals are threatened with extinction and WWF's recent Living Planet Report reveals global wildlife population has seen average decline of nearly 70 per cent in just 50 years.

The survival and traditions of entire communities are threatened by deforestation and over-exploitation, while environmental degradation increases the risk of emergence of zoonotic diseases, including Ebola and Covid-19.

Science confirms nature is key to the fight against climate change. A recent UN report outlines how the protection and restoration of nature is one of the greatest strategies for tackling climate change, not just because it absorbs carbon from the air, but because forests, wetlands and other ecosystems act as *buffers against extreme weather, protecting* houses, crops, water supplies and vital infrastructure.

# IS THE GOVT CROSSING THE RUBICON IN THE APPOINTMENT OF JUDGES?

he tussle between the Government and the Supreme Court for the appointment of judges is not new. The Judges of the Supreme Court and the High Courts are appointed under Articles 124 and 217 of the Constitution of India, 1950 respectively. In the first eight years of the Constitution, from 1950 to 1958, over 200 judges were appointed to the High Courts, and there were only seven instances where there was some disagreement on the names of judges to be appointed.

The attempt to undermine the independence of the judiciary first originated in 1973, after the Kesavananda Bharti judgement, which struck down some constitutional amendments by holding that the basic structure of the Constitution could not be amended. The Government of the day decided that only those judges who were committed to its ideology should be appointed. This set into motion the process of supersession of judges.

One such example was when A.N Ray was appointed as the Chief Justice of India superseding Justices Shelat, Hegde, and Grover, who, by convention of seniority were next in line for the position. The subversion of independence of the judiciary became a major issue, and the manner of appointment of judges was first raised in S.P Gupta's case

In the said case, the majority of judges held that primacy in judicial appointments was with the Government and it could disregard the opinion of the Chief Justice in the matter  $% \left\{ \mathbf{r}^{\prime }\right\} =\mathbf{r}^{\prime }$ of appointment and transfer of judges and the Chief Justices. The rationale behind the judgement was that the Constitution has devised an effective mechanism for the appointment of judges which strikes a just balance between the judicial and executive.

It is the executive which is a purely elected body made accountable to the people. The judgement was in consonance with the practice followed in the US, wherein the power vests with the executive in making judicial appointments with the advice and consent of

However, the judgment soon led to partisan appointments and the issue was referred to a larger bench for reconsideration.

In 1993, the view in S.P. Gupta's case was reversed by the bench of nine judges in the Supreme Court Advocate-on-Record Association case, which wrested control in the



matter of judicial appointments from the executive and vested it with the judiciary.

The primary reason behind the decision being that the judiciary is best suited and has the best opportunity to assess the true worth of candidates to be appointed as superior judges to high constitutional functionaries.

It is from the Supreme Court's Advocateon-Record Association judgement in 1993 that the idea of the Collegium stems. A Collegium meant the Chief Justice plus three senior-most judges of the court, whose consent was necessary for appointment of judges In 1998, in the Presidential Reference case, the Collegium was widened to five judges. As per the said judgement, the Chief Justice must consult two senior judges (later increased) of the Supreme Court and collectively form an opinion in making judicial appointments.

This case restricted the role of the Government only in returning a name recommended by the Collegium for reconsideration on matters such as antecedents and personal character, which, at times, the Government through their various agencies such as the Intelligence Bureau may be in a better position to know. However, if after considering the recommendation of the Government, the Chief Justice of India reiterates its initial recommendation, then that appointments ought to be made by the Government.

In 2014, to overturn the Collegium system,

the Government introduced the National Judicial Commission Appointment Act, 2014 (NJAC) which proposed a method of appointment of judges to the Supreme Court and High Courts in the country through the participation of the judiciary, executive and emi-

The NJAC, however, had a short life span. In 2015, the Supreme Court struck down the Act in its entirety for having inadequate representation of the judicial component in the NJAC, and failing to preserve the independence of the judiciary in the matter of judicial appointments.

The judgement once again confirmed the primacy of the judiciary in judicial appointments, with the Government having the limited role of returning recommendations to the Collegium, for

reconsideration. Later judgements of the Supreme Court further laid down a four months' timeline for the Government to act upon the Collegium's recommendations and make appointments.

In 2021, the Supreme Court in the judgement of M/s Project Pvt. Ltd observed that the High Courts were functioning with only 50 per cent of their sanctioned strength, with only 664 judges appointed

against the sanctioned strength of 1080 judges. Further, there were about 220 recommenda-

tions by the Collegium of the Supreme Court and the Government is simply sitting over these recommendations without getting the approval of the President for months.

The court in another case recently observed that names for the appointment of judges have been pending for over a year and a half. Such an inordinate delay in processing the names recommended by the Supreme Court Collegium directly affects access to jus-

On November 29, 2022, the names of 10 judges recommended for elevation by the Collegium were returned by the Central Government. As per the news reports, some names that had been reiterated by the Collegium have also been returned.

This is not permissible in view of the ninejudge bench judgement. The Central Government cannot return the names recommended once they have been reiterated and confirmed. Since the NJAC has been struck down and the Collegium system has been upheld, the Government is bound to comply with the judgement of the Supreme Court.

The conduct of the government in not taking any action over the files for the appointment of judges for a very long time, and rejecting the names that were reiterated by the Collegium contrary to the settled law may lead to serious legal consequences.

The first three words in our Constitution are "We the People".

The Constitution is for the common man. The delay in judicial appointments leads to delay in justice. Criminal appeals are pending in the courts for more than 10 years. A trial takes an average of at least five to seven years to conclude. The position is no different in civil cases. One cause of delay could be attributed to the courts not functioning with their full sanctioned strength.

Therefore, the standoff between the Government and the Supreme Court must be resolved at the earliest. Till then the Government is bound to follow the law for complete access of justice to the common

# Threat of nuke war rising, says Putin

Russian Flestdent Vladimir Putin has said the threat of a nuclear Moscow had not "gone mad" and would not use its nuclear weapons first.

Speaking at Russia's annual human rights council meeting, he also said the war in Ukraine could be a "lengthy process", the BBC reported.

"Such a threat is growing, it would be wrong to hide it, Putin warned while talking about the prospect of nuclear war via video link from Moscow.

But he asserted that Russia would "under no circumstances" use the weapons first, and would not threaten anyone with its nuclear arsenal. "We have not gone mad, we are aware of what nuclear weapons are," he said,



adding: "We aren't about to run around the world brandishing this weapon like a razor." The President also boasted that Russia had the most modern and advanced nuclear weapons in the world, and contrasted its nuclear strategy to the US, who he said had gone further than Russia by locating its nuclear weapons on other

"We do not have nuclear weapons, including tactical nuclear doctrine only

# UK univs luring Indian students with 'bring your family' offers: Report

niversities in the LIK are naving education agents that recruit Indian students to lure them with an offer, which allows them to bring along their families to the country, a media report said.

According to the Telegraph, commissions are paid to agents who market "graduate visas" and help potential Indian students get visas for their spouses and children.

A graduate visa, previously known as the post-study visa, gives one permission to stay in the UK for at least two years after successfully completing a course in the country.

Indians received 41 per cent of the total number of Graduate Route visas after it was introduced in 2021, according to recent UK immigration statistics. While some agents come up with offers assuring a "full-time job" for a spouse as well as a two-year "stay" in the country, others tell



prospective students to hurry as the UK could soon put restrictions on dependents. The report comes as immigration situation in the country is becoming a migraine for the Conservative party-led government with net migration numbers rising to an estimated record of 504,000 in the year to June. While ministers are considering curbs on the number of dependents allowed into the UK and

restricting foreign students attending "low-quality" courses, experts warn that the restrictions will bankrupt UK universities, which depend on foreign students for money.

The British High Commission revealed recently that it granted 1.27 lakh student visas to Indians in the year ending September 2022, an increase of 273 per cent over the same period in 2019. According to

reports, India surpassed China to for the UK with 161,000 students, including 33,240 dependents, coming to the UK last year. New Way Consultancy (NWC) says it works for more than 70 universities and is paid on commission for each student it recruits, the Telegraph reported. NWC said that foreign students and their dependents contributed to the UK economy not just through fees of 10,000 pounds to 26,000 pounds but also via an NHS surcharge of 400 pounds a year for the student and 600 pounds for a dependent.

"International students are not migrants, they never stay here," Moe Sobahan, NWC's recruitment head told Telegraph. He warned that curbs on graduate work visas will force Indian students to shift to countries like Australia and Canada, ultimately leading to the end of the student mar-

# Jabalpur bride gets beautician arrested for messing her make-up

beautician has been booked after her assistant allegedly spoilt the make-up of a bride and also for issuing threats when her family members protested in Madhya Pradesh's Jabalpur, police said on Wednesday.

The bride, a resident of city's Ghamapur area, had booked an appointment with the beautician, who runs a beauty parlour in Kotwali Bazar, for her marriage on December 3, said City Superintendent of Police (CSP) Prabhat Shukla.

The beautician had taken advance payment from the bride's family and assured to reach the venue on time on marriage day to complete the make-up work, he said, citing a complaint.

After the beauty parlour owner didn't reach the venue, the family of the bride contacted her, but she told the latter to come to the outlet for make-up. Shukla said. The CSP said when the soon to be married woman reached the parlour, the



beautician, instead of doing her makeup, assigned the task to her assistant who messed up the work.

Angry over the beautician's behaviour, the bride's mother registered a complaint at the Kotwali Police Station on Tuesday.

The complainant also accused the

beauty parlour owner of misbehaving and threatening them when the bride's mother contacted her for messing up the make-up work, he said.

A case was registered against the beautician under Indian Penal Code (IPC) sections 294 (obscene act) and 506 (criminal intimidation), Shukla said.

# Bad days of many MLAs of Madhya Pradesh

he slogan of 'Achhe Din' has been heard in the country's politics for many years, but bad days have come for two MLAs of Madhya Pradesh. One is Congress MLA Ajab Singh Kushwaha, who has been convicted by the court in a fraud case and has been sentenced to two years imprisonment, while the same is BJP MLA Rahul Lodhi, whose election has been declared void by the Jabalpur High Court. Assembly elections are going to be held in the state after about a year and all the claimants from the current MLA are also busy in the preparations for the elections. There is no good news coming for the two MLAs. Ajab Singh Kushwaha, Congress MLA from Sumavali assembly constituency in Morena district, is accused of selling government land claiming it as his own for about Rs 75 lakh. In this case, a person named Purushottam Shakya had filed a complaint in Maharajpura, Gwalior and said that MLA Ajab Singh had sold this land to him. But did not get possession. The police had also registered a case on



this. It has been told that while hearing the matter, the court of Gwalior has sentenced MLA Ajab Singh and others to two years imprisonment and also imposed a fine of

Rs 10,000 each. After this decision, the membership of the Congress MLA is under threat. According to the rules, if an MLA is punished for two years or more, then he will lose his membership of the Legislative Assembly and at the same time he will be ineligible to contest elections for six years.



Another case is of BJP MLA Rahul Lodhi from Khargapur in Tikamgarh district. The decision of the High Court Jabalpur has come against Lodhi, nephew of former Chief Minister Uma Bharti, in which the election has been declared void. It is alleged that he did not enter the correct information about himself in the nomination for the election. He hid his stake in a company, against which Congress candidate Chanda Singh Gaur went to court.

It has been told that the way for both the  $\operatorname{MLAs}$  to go to the High Court is open, but

## Labuschagne, Head's tons lead Australia's domination over West Indies

antastic centuries by Marnus **◄** Labuschagne and Travis Head led Australia's domination over West Indies as hosts racked up 330/3 on the opening day of the second (pink-ball) Test at Adelaide Oval, here on Thursday.

Labuschagne (120) and Head (114) were unbeaten at the crease when play was stopped on Day 1. They had put on an unbeatable 199-run stand for the fourth-wicket.

After Australia won the toss and opted to bat, it was an ominous beginning for the visitors despite dismissing David Warner (21) cheaply once more

Labuschagne and Usman Khawaia then took full toll on the West Indies bowlers and it forced visitors to introduce the spin of Roston Chase inside



the 10th over with no success. Khawaja quickly moved into 40s before West Indies bowled three maidens but they weren't rewarded for the pressure. It was eventually Devon Thomas -- originally picked as

a reserve 'keeper in the squad -- who ended the 95-run Labuschagne-Khawaja stand by getting the latter LBW on 62. Thereafter, Steve Smith walked in but he was dismissed for an eight-ball duck when Jason Holder completed a smart return catch.

The wicket brought the pair of Head and Labuschagne together and they troubled the West Indies for the rest of the day. Labuschagne reached his century with a square drive for four while Head joined him in the feat with an off-drive.

West Indies turned to the second new ball as soon as it was available, but even under lights the shiny pink ball refused to do their bidding and they walked off with 330 runs against them on the board at stumps.

The game began on a fast note with Aizawl having an edge over NEROCA. The hosts enjoyed the majority of the possession in the early minutes of the game but didn't find any goalscoring opportunity. R Lalthanmawia went closest in the sixth minute when the winger cut inside from the left, beating his marker in the process to shoot, but his effort didn't produce the required

Midway through the first half, the



game burst into life as Aizawl created three back-to-back chances. In the 24th minute, Lalthanmawia on the left wing dribbled past his marker

and put a cross inside the six-yard area for R Ramdinthara, who failed to control the ball. With just a minute left in the first

half, Kisekka put the ball into the net but before he could celebrate, the referee called for a foul as the Ugandan had pushed NEROCA's centre-back Thokchom James Singh in the

Henry Kisekka helped his team create multiple chances with Ramdinthara and Lalrinfela making

n their five T20Is against Australia starting from Friday at the DY Patil Stadium, India have left out off-spin all-rounders Sneh Rana and Dayalan Hemalatha as well as bighitting batter Kiran Navgire, who was seen as a finisher in the side.

Instead, they have brought in left-arm fastbowler Anjali Sarvani, who topped the bowling charts in the Senior Women's T20 Trophy (with 17 scalps) and Senior Women's Inter-Zonal T20 Trophy (10 wickets). Alongside her, leg-spin allrounder Devika Vaidya also marks a return to the T20I setup after eight years.

"The members of the team have performed well, especially the new girls who have done really well in the domestic circuit. If you talk about Anjali, she took the highest wickets and then others have done well too and won matches for their respective teams. Selection depends on your performances and those who have done well are in the side."

"For Sneh Rana and all are good players; in the upcoming tournaments whenever they'll do well, they'll definitely come back. We are always having an eye on them. It's not like if



today they are not on the side, we are ignoring them. Definitely they are part of the system and when they perform, they will come back," she said in the pre-match press conference.

"We have played really well, and the last three months have been very special for the way we played. We are looking very positive and with Hrishi sir (Hrishikesh Kanitkar as batting coach) in, he also brings in a lot of positivity."

Harmanpreet revealed that opener Shafali Verma and wicketkeeper-batter Richa Ghosh will not play all five T20Is against Australia due to the duo being a part of the India squad for the inaugural Under-19 Women's T20 World Cup in South Africa.

## Injured Shami doubtful for Bangladesh Test series: Reports

ndian pacer Mohammed Shami, who is already out of the ongoing threematch ODI series due to injury, has not fully recovered from the right shoulder strain and is unlikely to be available for the Test series against Bangladesh.

According to a report, the NCA staff will draw a roadmap for veteran bowler's recovery and rehab. At this stage, there is no clear information on his comeback. The Indian team is already struggling in the ODIs in Bangladesh and the absence of Shami will be a big blow for the visitors ahead of the Test series.

The player last played for India in the Twenty20 World Cup in Australia last month. He was initially part of the



ODI squad for the Bangladesh series but had to be withdrawn and Umran Malik was named as his replacement. However, it has been learnt that there is no immediate plan to rush in a replacement for Tests as more than 30 players are in Bangladesh, including those part of the India A squad. The Indian team will be free to retain any player if it wants. As far as the ODI squad is concerned, no replacement is being named for the three players --Kuldeep Sen, Deepak Chahar

and Rohit Sharma -- who are

not unavailable for the third and final ODI on December 10, due to different injuries.

Siraj, Thakur and Umran are available for selection and the selection committee sources have said there is no immediate need for a replacement for a series that has already been lost, the

report further said. Meanwhile, skipper Rohit has arrived in Mumbai for scans following the thumb injury he sustained during the second ODI and a decision on his participation in the Tests will be taken in the next 24 hours.

If not for the first game, Rohit's availability for the second and final Test will also be explored. Shubman Gill, a specialist opener, is part of the Test squad and can fill in alongside KL Rahul.

## India announces home schedule with series against Sri Lanka, New Zealand & Australia

ndia men's team will be hosting Sri Lanka, New Zealand, and Australia in series featuring all formats, including the four-match Test series for the Border-Gavaskar Trophy, in the 2022/23 home schedule announced by the Board of Control for Cricket in India (BCCI).

India men's 2022/23 international home season comprising nine ODIs, six T20Is and four Tests will commence with a three-match T20I series against Sri Lanka in January. The matches will be played on January 3, 5 and 7 in Mumbai, Pune and Rajkot respectively.

After that, three ODIs between the two teams will be played on January 10, 12 and 15 at Guwahati, Kolkata, and Thiruvananthapuram respectively. Sri Lanka last toured the country in February-March 2022, where they lost T20Is and Test series.

The action will then move to a

three-match ODI series against New Zealand wherein Hyderabad, Raipur and Indore will play hosts to matches on January 18, 21 and 24. The second ODI on January 21 between India and

New Zealand will be a marquee ODI for the city of Raipur as they will host their first international fixture.

India will also play a three-match T20I series against New Zealand, who visited the country in November-December 2021. Matches between the two teams will be played on January 27, 29 and February 1 at Ranchi, Lucknow, and Ahmedabad respectively.

February will also mark the start of the Border-Gavaskar Trophy in Nagpur from February 9-13. The next three Test matches between India and Australia will be played in Delhi (February 17-21), Dharamsala (March 1-5) and Ahmedabad (March 9-13). Delhi will be hosting a Test match after five years.

The series will also be the last edition of the Border-Gavaskar Trophy being a four-match Test series feature, with the Future Tours Programme (FTP) saying that the series will become a five-match fixture. India

men's home season will then conclude with a three-match ODI series to be held in Mumbai (March 17), Visakhapatnam (March 19) and Chennai (March 22).



Talking at length, he discussed the projects in his filmography that he believes are failures, either due to poor box office numbers or conflicting artistic results. Discussing his 2022 action film 'Shamshera', he said it was

"by far the hardest film I've worked on. It was a big box office disaster, but the biggest mistake I made on Shamshera was that I stuck on a beard." He was referencing the prosthetic beard he wears during the film. Over rapturous laughter from the crowd, he continued:

"When you're shooting in the heat, and you stick on a beard, it's like your face is melting." Ranbir continued to discuss his 2017 family drama 'Jagga

Jasoos', which he described as "another disaster."

"It's a film that I produced. It was a passion project. It was directed by Anurag Basu. It was a very heartwarming and sweet idea, but it didn't do well, which really hurt," he said. "That's the only film in my career that hurt me." "It's been pretty bad these last few years," he told of the situ-

ation at the Indian box office.

"The entire culture of going to a theatre for a community viewing of a movie seems like it's dying, and it's only there for the big ticket films, but I hope with strong storytelling, and renewed vigour, Indian cinema comes back.

## **BLURR: TAAPSEE PANNU STARRER IS** DERATELY GRIPPING THRILLER

The film is a remake of the popular Spanish film Julia's Eyes.

It begins on a mysterious note of Gautami attempting suicide and later her sister Gayatri setting out to unravel the mystery behind the same. As the film progresses, you also witness Taapsee's husband Neil telling her not to stress, but you also see her being hell-bent on joining the dots.

A suspense thriller that relies on situations and dialogues, and is primarily shot in one location, must engage you enough to sit with rapt attention. Director Ajay Bahl's outing leaves much to be desired on this front.



The movie becomes monotonous and repetitive quickly; though it picks up pace in the second half when things turn perplexing. The first half is too slow, but the film picks pace in second half albeit with bewildering developments. The climax twist may seem mind-bending only to viewers unfamiliar with the genre, but it does not excite them enough.

Talking about other technical aspects, even the cinematography, lighting, camera work, visual effects, and technical aspects are perfect for the genre, and play a role in spiking the interest. But it's the banal dialogues that blow off the steam. Even editing


could have been a bit crisp. When it comes to music, the film has

no songs; however, the background score is overall in sync with the mood of the film.

Speaking of performances, without a question, Taapsee Pannu is Blurr's star. She has often shown that she can bravely carry a film and that's what she does. She embodies her role to the fullest. Gulshan Devaiah as Gayatri's husband Neil leaves a mark despite his limited presence. Whereas, Abhilash Thapliyal comes as a surprising element, but underplays his part.

#### **CONCLUSION**

If thrillers are your favorite genre, you might feel a bit deceived by this Taapsee Pannu film.
