

'Chinese hackers targeted AIIMS server, **OPD** functioning online partially'

Team Absolute New Delhi

he cyber attack on servers of the All India Institute of Medical Sciences was carried out from China, a top source said on Wednesday. However, all the data

has been successfully retrieved. According to the Health Ministry source, the hackers targeted five physical servers of the hospital, but the data from these five servers have

been retrieved now. Meanwhile, the hospital has also started functioning on online mode partially in some departments. The OPD appointment has been started through the online mode to some extent, a hospital source said.

The source said that some online and offline new and follow-up registrations have started being made at the new Rajkumari Amrita Kaur (RAK) OPD.

However, the online co-ordination between the ward admission and the discharge process has not been started yet. Therefore, the discharge is being done on the manual mode. The Smart Lab has also not been connected online yet in the hospital. The AIIMS servers were reported hacked for the first time on November 23. A case of extortion and cyber terrorism was registered by the Intelligence Fusion and Strategic Operations (IFSO) unit of the Delhi Police two days later.

However, police had denied any random demand from the hospital. Delhi Police in a statement had said that no such demand has been brought to the notice of AIIMS administration.



REVEAL AFTER NIA PROBE: IT MINISTER

New Delhi: The identity of those responsible for the cyber attack on the server of Delhi's AIIMS would be known once the NIA completes its investigation in the matter; the Parliament was told on Wednesday. Responding to a question on the incident by BJP MP Sukanta Majumdar during Question Hour, IT and **Communications Minister** Ashwini Vaishnaw said that in the case of AIIMS, its network had grown as a flat network over a period of time, and is now getting fully updated into a hierarchical system in which the users' login password, privileges of administrator and other aspects are being redefined. About the identity of the cyber attackers, Vaishnaw



said: "That as and when the investigation by the NIA is complete, we would actually come to know who the attackers were. But definitely, we have taken all the required measures for making sure that the network is protected." On December 12, Congress MP Shashi Tharoor had sought a thorough investigation into the matter while speaking in Lok Sabha.

NUMBER OF CYBER ATTACKS **STEADILY RISING, 12.67 LAKH DURING NOV 2022**

New Delhi: The number of cyber attacks in India has recorded a steady growth over the past few years, and the total number as reported to and tracked by the Indian Computer Emergency Response Team (CERT-In) in the current year stands at 12,67,564 (till November), the Parliament was told on Wednesday.

The corresponding number of such incidents in 2018 was 2,08,456 which increased to 3,94,499 in 2019, to 11,58,208 in 2020 and 14,02,809 in 2021, Minister of State for Electronics and IT Rajeev Chandrasekhar told the Lok Sabha in a written reply.

He said that with the borderless cyberspace coupled with anonymity, along with rapid growth of Internet, rise in cyber attacks and cyber security incidents is a global phenomenon and the government is fully cognisant and aware of various cyber security threats. The Indian Computer Emergency Response Team (CERT-In) is mandated to track and monitor cyber security incidents in India. In the recently notified cyber security direction, CERT-In has now made it mandatory for all incidents to be mandatorily reported to it. Further, the Ministry of Home Affairs has issued National Information Security Policy and Guidelines to the Central Ministries as well as state governments and Union Territories with the aim of preventing information security breaches and cyber intrusions in the information and communication technology infrastructure.

'PLA was planning to set up observation post near Arunachal's Holy waterfalls'

ike in Galwan, the Chinese People's Liberation Army (PLA) was planning to set up an Observation Post (OP) on the Line of Actual Control (LAC) at Yangste in Tawang, Arunachal Pradesh, when the Indian Army personnel intervened. This was revealed by a senior army officer posted in Arunachal Pradesh. As per laid down guidelines, no OP or similar structure can be set up close to the LAC by either side.

"It is already extremely cold there. Within the next couple of weeks, all areas close to the LAC will be under several feet of snow. On the Indian side, final preparations are being made to stock our forward positions with adequate supplies. There is a lot of troop movement as well. The PLA is certainly interested to learn more about our preparations for the winter, hence the decision to set up the OP," the army officer said.

While the PLA does have surveillance cameras, they are at a distance from the LAC. Drones are also used but a direct view is always considered the best to plan any move. In Galwan, the clash with the PLA started after the Indian Army demolished an OP that the Chinese refused to dismantle.

Locals at Tsechu, a small town closest to the point where Indian and Chinese troops

clashed on Friday are extremely unhappy with the PLA for disturbing the peace of the region.

"This happened barely a few hundred metres from Chumi Gyatse, a waterfall (a collection of 108 smaller waterfalls) that is considered holy by us Monpas from both sides of the LAC. The Indian Army respects our sentiments and never does anything to disturb the sanctity of the place. This is the second time that the PLA has created a ruckus here," one of them said.

The PLA has cause for concern. Over the last few years, the Indian Army, with help from the Arunachal Pradesh government, has created a lot of infrastructure in that region.

While this has helped locals, it has also aided in quicker and easier movement of soldiers and equipment to the border.

"In Galwan, our brave soldiers were taken by surprise. But we were prepared this time. As soon as we detected movement by the PLA towards the LAC, we knew how to react. They were trying to access higher ground to set up the OP but we stopped them and forced them to return. The Chinese kept on saving that the whole region is their territory but we were not interested. The injuries suffered by a few of our soldiers are minor ones," the army officer added.

he Enforcement Directorate (ED) on Wednesday said it has attached immovable and movable assets worth Rs 78.63 crore in connection with an investment fraud case in which one Nowhera Sheikh, and others have been named as accused.

The current attachment included properties worth Rs 37.58 crore of a Hyderabadbased firm SA Builders & Developers wherein Sved Akhtar is partner, and the bank balance of Rs 41.05 crore of a Bangaluru based builder, Neelanchal Technocrats Pvt. Ltd. (Sallarpuria Group).

Prior to this, the ED had provisionally attached properties worth Rs 300 crore in the same case.

In 2018, the ED registered the money laundering case against Nowhera Sheikh and others who had collected more than Rs 5,000 crore from public as investment against false promise of unreasonably high 36 per cent annual return on investment but failed to repay even the principal amounts. Thus, they

duped thousands of innocent investors.

The ED learnt that Sheik and her Heera Group of companies had transferred Rs 148 crore to one SA Builders and Developers for purchasing properties situated at Tolichowki, Hyderabad but properties only worth Rs 70 crore were actually registered which were earlier attached in the hands of Heera Group.

The remaining funds of Rs 78 crore which were part of crime proceeds were found to be parked with the SA Builders and Developers.

The ED also learnt that SA Builders and Developers had transferred Rs 41 crore out of above Rs 78 crore to Neelanchal Technocrats Pvt. Ltd and 4 other shell entities in Kolkata and Shillong. All these funds were ultimately routed back to Sallarpuria Sattva group as loans.

The ED had in November conducted searches at the office of the Sallarpuria Sattva group in Bangalore and unearthed the above money trail and subsequently attached immovable properties and bank balances of Rs 78 crore as equivalent value of the crime proceeds.

ing barely half a km away from the Union Carbide factory in Bhopal have been made to survive on their own under the open sky as their homes built in an illegal colony were recently demolished by the administration.

India among top three countries originating IoT malware: Microsoft

ndia is among the top 3 countries originating Internet of Things (IoT) malware infection in 2022, a Microsoft report said on Wednesday. IoT devices offer significant value to organisations in the country looking to modernise workspaces, become more data-driven and ease demands on staff through shifts like remote management and automation. "Therefore, the cyber-threat landscape is real and security is the need of the hour. Microsoft aims to help incident responders and security specialists better understand their environments and prevent potential incidents," said the tech giant.

The International Data Corporation (IDC) estimates there will be 41.6 billion connected IoT devices by 2025, a growth rate higher than traditional IT equipment.

With increasing connectivity



across converging IT, Operational Technology (OT) and IoT, organisations and individuals need to rethink cyber risk impact and consequences, said the report.

Microsoft observed a spike in threats across traditional IT equipment, OT controllers and IoT devices like routers and cameras fueled by the interconnectivity many organisations have adopted over the past few years.It identified unpatched, highseverity vulnerabilities in 75 per cent of the most common industrial controllers in customer OT networks. "As OT systems underpinning

energy, transportation, and other infrastructures become increasingly connected to IT systems, the risk of disruption and damage grows as boundaries blur between these formerly separated worlds," said Vasu Jakkal, corporate vice president, security, compliance, identity, and management at Microsoft.

For businesses and infrastructure operators across industries, the defensive imperatives are gaining total visibility over connected systems and weighing evolving risks and dependencies, Jakkal added.

Modern threats like sophisticated malware, targeted attacks, and malicious insiders are difficult for traditional security measures to contain.

Microsoft also observed over 1 million connected devices publicly visible on the Internet running Boa, an outdated and unsupported software still widely used in IoT devices and software development kits (SDKs).

RELIANCE INFRA VS DMRC ROW: SC DIRECTS HC TO ENFORCE ARBITRATION AWARD IN 3 MONTHS

he Supreme Court on Wednesday told Attorney General R. Venkataramani, "we should not repeat again that on one hand, you give speeches everywhere that India should be a model arbitration hub", as it pulled up Centre for its failure to pay an arbitral award for Rs 4,500 crore following a lawsuit filed by Reliance Infra against Delhi Metro Rail Corporation (DMRC).

The apex court directed the Delhi High Court to proceed with the execution of the Rs 4,500 crore arbitration award granted in favour of Delhi Airport Metro Express Pvt Ltd (DAMEPL), a Reliance Infrastructure arm, and take it to a logical end within three months.

A bench of Justices B.R. Gavai and Vikram Nath said the award in favour of the DAMEPL has reached finality, and emphasised that law regarding the execution of the award is not different for the government or its statutory corporations.



The AG, representing the Centre, objected to the maintainability of the DAMEPL's appeal and pointed out the lack of funds. "I do not have money or gold in some bank account that I can just give it. It has to go through a process," he said. Senior advocate Harish Salve, representing the DAMEPL, said the government is not committing itself to giving the money and added that if they are unable to commit funds, let their properties be attached.

As the AG said: "The government will pass it in the bill to apportion funds", Salve submitted: "Do not let this circus continue." The AG replied that it is a serious

matter and added: "do not call it a circus please". Salve contended that if DMRC were to be a private party, then the apex court would have

directed payment within two weeks. The bench said that in ordinary circumstances, the court would not have entertained the matter. "The arbitration award passed in favour of the petitioner has reached finality as the appeal filed by respondent has been dismissed," said the bench.

The top court said: "We, therefore, direct the high court to proceed expeditiously and take it to its logical end within a period of three months."

Concluding the hearing in the matter, Justice Gavai remarked: "We should not repeat again that on one hand you give speeches everywhere that India should be a model arbitration hub...'

The AG replied that has nothing to do with this case.

The apex court was hearing a plea seeking enforcement of the arbitration award in favour of the DAMEPL to be paid by the DMRC.

4 Meghalaya MLAs switch to BJP; party calls it 'significant development'

ssam Chief Minister Himanta Biswa Sarma said on Wednesday that the switching of four Meghalaya legislators to the BJP is a "significant development" for the saffron party in the state where Assembly elections are scheduled to be held in February next year.

Sitting Independent MLA Samuel Sangma, Benedict Marak and Ferlin C.A. Sangma of the National People's Party (NPP) and H.M. Shangpliang of Trinamool Congress joined the BJP in the national capital on Wednesday in presence of Sarma and BJP spokesperson Sambit Patra.

Samuel Sangma is an independent MLA and was an associate member of the United Democratic Party (UDP) before joining the BJP on Wednesday.

After the joining, Sarma, also the convener of BJP-led anti-Congress front North East Democratic Alliance (NEDA), made the four leaders meet BJP's national president J.P. Nadda.

Identifying the four leaders as "experienced and respected political figures", the Assam Chief Minister said that under Prime Minister Narendra Modi government, the northeastern region has undergone tremendous development in every sector since the NDA government came to power at the Centre in 2014.

"With massive development and restoration of peace, three BJP governments returned to power in Assam, Arunachal Pradesh and Manipur," he told the media in Delhi expressing his optimism that the BJP would achieve "spectacular performance" in the upcoming assembly polls in Tripura, Nagaland and Meghalaya.

With two MLAs -- Pynthorumkhrah (Alexander Laloo Hek) and South Shillong (Sanbor Shullai), BJP is a partner of the Meghalaya Democratic Alliance (MDA) government, dominated by the NPP headed by Chief Minister Conrad K. Sangma.

Shullai is now a cabinet minister of the MDA government and in-charge of five departments including Animal Husbandry and Veterinary and Labour Departments.

The BJP in Meghalaya has for the past more than two months threatened to with draw support from the MDA. The UDP is also one of the constituents of the ruling MDA, a 6-party alliance government.

However, the NPP, BJP and the UDP had already announced that they are going to contest Assembly elections early next year as separate entities.

Teachers' scam: Judicial custody of Partha, Arpita extended to Jan 7

special Prevention of Money Laundering Act (PMLA) court on Wednesday extended judicial custody for former West Bengal Education Minister and Trinamool Congress secretary general Partha Chatterjee and his close associate Arpita Mukherjee till January 7 in connection with their alleged involvement in the multicrore teachers' recruitment scam in West Bengal

Meanwhile, Chatterjee has also moved a plea in the same court for exemption of his name from the supplementary charge sheet filed by the Enforcement Directorate (ED) in the teachers' recruitment scam on December 7. However, the matter could not be heard on Wednesday as the ED's counsel informed the court that they need some more time to present his line of argument in the matter. The next hearing in the matter has been scheduled on January 31 next year.



On Wednesday, neither counsel for Chatterjee nor the one for Mukherjee moved any bail pleas on behalf of their clients. Instead, Chatterjee's counsel appealed to the court to direct the ED to submit a report on its progress of investigation in the matter.

At the same time, Chatterjee's counsel also questioned how the central agency was appealing for extension of his custody without seeking any remand or submitting any progress report on the investigation.

Local BJP leader and Asansol Municipal Corporation's former Mayor Jitendra Tiwrai was also present on the occasion. The stampede happened after Adhikari left the spot which witnessed an assembly of around 5,000 persons.



Pandit has directed all field officers and enforcement squads to stay vigilant on the medicines coming from outside the state, and intensify the raids on all suspicious points, persons, stockists and shops.The officials were also asked to take stringent action against those found guilty. 

Cong warns Pateriya of expulsion from party over remarks against PM

rejected and he was sent to 14-day judicial custody. However, Pateriya, who is also the Congress vicepresident in Madhya Pradesh, maintained that he didn't use 'offensive' words and is a 'follower of Mahatma Gandhi'. "It's a fight of ideology. I haven't

said those words. I am a follower of Mahatma Gandhi," he told reporters outside the courtroom and showed a victory sign. Pateriya was minister in Digvijaya Singh-led cabinet in the state (1993-2003) and is considered close to Singh. The state Congress unit including former chief minister Kamal Nath has condemned Pateriya's alleged remarks, however, some senior leaders stood in his favour. Though the Congress leaders who favour Pateriva did not made any official statement, they unofficially claimed that he was politically targeted.

Veteran Congress leader and Leader of Opposition in Madhya Pradesh Assembly, Govind Singh has opposed Pateriya's arrest. "I oppose Raja Pateriya's arrest, BJP should not hype false incidents. Raja in his speech firstly clarified that he meant defeating Modi and he apologised later. His arrest is not justified. THREE WOMEN LABOURERS, **TWO CHILDREN DEAD AS TRACTOR FALLS INTO CANAL**

Madhya Pradesh: Three women sugarcane workers and two children were killed after the tractor-trolley in which they were traveling fell into a canal in southern Maharashtra's Solapur district, police said on Wednesday. The deceased hailed from Madhya Pradesh's Barwani district.

The incident took place on Tuesday night near Karkamb village when a group of migrant workers engaged by local farmers for sugarcane harvesting were returning to their camp after the day's work, said a police official. "Due to the driver's error, the tractor-trolley veered off the road and fell into the dry canal. While four persons died on the spot as the trolley fell on them, one person died in hospital," said Shirish Sardeshpande, Superintendent of Police, Solapur.

The United recognised 10 groundbreaking efforts, including the cleaning of the Ganga from around the globe for their role in restoring the natural world. The initiatives were declared World Restoration Flagships and are eligible to receive UN-backed promotion, advice, or funding. In revealing the World Restoration Flagships, the UN Decade seeks to honour the best examples of large-scale and longterm ecosystem restoration, embodying the 10 Restoration Principles of the UN Decade on Ecosystem Restoration. The UN Decade acknowledges the time needed for restoration efforts to deliver results. Until 2030, regular calls for World Restoration Flagships will be launched. In expectation of increased funding to the UN Decade's Multi-Partner Trust Fund (MPTF), additional submissions are being considered, including restoration drives from Pakistan, Peru, and an initiative focusing on Somalia and other droughtaffected countries. India's ground-breaking initiative is restoring the health of the Ganga, India's holy river. The focus of a major push to cut pollution, rebuild forest cover and bring a wide range of benefits to the 520 million people living around its vast basin. Climate change, population growth, industrialisation and irrigation have degraded the Ganges along its arcing 2,525kilometre course from the Himalayas to the Bay of Bengal. Launched in 2014, the government-led Namami Gange initiative is rejuvenating, protecting and conserving the Ganga and its tributaries, reforesting parts of the Ganga basin and promoting sustainable farming. It also aims to revive key wildlife species, including river dolphins, softshell turtles, otters, and the hilsa shad fish. Investment by the Indian government is up to \$4.25 billion so far. The initiative has the involvement of 230 organisations, with 1,500km of river restored to date. Additionally, there has been 30,000 hectares of afforestation so far, with a 2030 goal of 134,000 hectares.

IS NITISH KUMAR LOSING POLITICAL RELEVANCE IN BIHAR?

n Bihar, there are three political forces -- RJD, BJP and JD(U) -- and whenever two have come together, they have formed the government in the state. It was proven in 2010, 2015 and 2020.

Now, such a situation is changing in Bihar as Nitish Kumar-led JD(U)and Tejashwi Yadav-led RJD are jointly running the government in Bihar, but they are failing to convince the voters. Is the myth of the two-party-making-government breaking now? Are Nitish Kumar and Tejashwi Yadav losing relevance in Bihar -- these are the big questions in Bihar these days.

After the formation of the Mahagathbandhan in Bihar in August this year, three by-elections took place and the BIP, which is the lone opposition party in the state, has managed to win two seats of Gopalganj and Kurhani. Even the Mokama seat was not won due to RJD or Tejashwi Yadav. It was the impact of Bahubali leader Anant Singh, who helped his wife Neelam Devi to win the bypoll.

Prashant Kishor, who is currently in East Champaran for his Jan Suraj Padyatra, said: "You are talking about uncle (Nitish Kumar) and nephew Tejashwi Yadav but they are only cheating the people of Bihar. What is the capacity of the unclenephew government in Bihar, they lost two out of three bypolls. The seat of Mokama was won due to Bahubali leader Anant Singh. They are unable to win bypolls and teach me.'

"Tejashwi Yadav had promised to give 10 lakh jobs from the first signature when he came to power. Is the ink of his pen dried up or the pen is broken? Why is the cabinet meeting not taking place on jobs?' Kishor asks.

"Tejashwi Yadav is nothing without Lalu Prasad Yadav. What is the knowledge and understanding Tejashwi has? He became MLA for

the first time in 2015. Who knows him before? I helped Nitish Kumar and Lalu Prasad Yadav in 2015 and then Mahagathbandhan came in power," Kishor said.

The result of the Kurhani bypoll has given a clear message that the anti incumbency factor is creeping against Nitish Kumar and it is rising. He is the longest serving chief minister of Bihar, still the development works are not taking place as it was expected.

"The voting patterns in Bihar are changing now. The Mahagahtbandhan government promised 20 lakh jobs and youths of Bihar are expecting jobs from Nitish and Tejashwi. Unfortunately, they are not giving jobs in accordance with the promises they have made in the past. Caste factor is relevant in Bihar, but if the political parties



would only depend on it and make a plan accordingly to win the election, it is the biggest mistake in the current situation. You cannot fool the people, you have to deliver. I personally believe that the antiincumbency against Nitish Kumar is affecting Tejashwi Yadav," said Rajan Sharma, a retired government employee of the education depart-

> ment. "Nitish Kumar and Tejashwi Yadav were claiming in the past that they are giving joining letters in various departments is also a big fraud. The people are not fools, they knew the game of joining letters. The join ing letters they are giving to the people are old employees and the jobs were given during the tenure of the NDA government," said another person Kamal Kant Sahani, a resident of Boring road Patna.

"The Mahagathbandhan government is failing on several issues like liquor ban, inflation, crime, corruption, issues of farmers, Industries, food processing units and others. When Tejashwi Yadav was the leader of opposition in the Bihar Assembly, he used to raise the issue of unemployment, lack of industries and food processing units. The Mahagathbandhan leaders blame the BJP for running communal agendas to polarise the voters and while the saffron leaders blame them for the return of Jungle Raj, corruption, scams, etc. None of the political parties have public oriented blueprints to improve their lives," said Sanjay Kumar Pandey, a resident of RK Puram Patna.

"Nitish Kumar and Tejashwi Yadav campaigned jointly in Kurhani but the result did not come according to their expectation. The poor people of Bihar are not pleased with the ill policies of Nitish Kumar. Liquor ban has penalised the poor people more than the middle class and high-earning people of Bihar. In every liquor tragedy, 95 per cent of the people are poor who consume the country-made liquor. Various leaders like Jitan Ram Manjhi pointed out that over four lakh people have been serving jail term and majority of them are below poverty line people, Dalit people who are against Nitish Kumar," Pandey said.

"We have learnt from childhood that the crime or criminals have no caste and religion. Similarly, a person served jail term in liquor violation, how could their families give votes on the basis of caste and communities. This is a simple logic and explanation Nitish Kumar has to understand for his survival in the politics of Bihar," Pandey said.

He had previously said that they would make "criminal referrals" to the Department of Justice (DOJ). It would be up to the DOJ to determine whether it would pursue any prosecution based on the committee's recommendations.

Former President Donald Trump has repeatedly lashed out at the panel and its members made up of seven Democrats and supporters stormed the Capitol in Washington, D.C., and disrupted a joint session of Congress to affirm the 2020 presidential election results.

Approximately 140 police officers were assaulted.

Authorities have linked at least five deaths to the mayhem.

Over 900 individuals have been arrested in nearly all 50 states for crimes related to the breach of the Capitol, including more than 275 individuals charged with assaulting or impeding law enforcement.

5 year-old Indian kid falls to death from Dubai high-rise

five-year-old child of Indian descent died after falling from a high-rise buildng in Al Qusais, east of Dubai, police

said. The girl fell through a tiny window that opened from the ninth floor of the family's apartment near Al Bustan centre at around 9.30 p.m. on December 10, the Khaleej Times reported.

"It is a very small window and almost physically impossible for a child to get through," a neighbour said.

"I am not sure how it happened, but it is heartbreaking," he said, adding that the child "was an active and sweet girl who always smiled".After finishing official documentation in the UAE, the family is expected to fly the child's body back to India for last rites, the paper reported. The five year-old's death is a third such mishap to occur this year in UAE.

Last month, a three-year-old child of Asian descent died in Sharjah after falling from the 14th floor of a building in the Al Taawun area.

In February, a 10-year-old Asian child died after falling from the 32nd floor of a residential tower located on King Faisal Street, Sharjah.

Biden signs bill on same-sex marriage

S President Joe Biden has signed a new landmark bill which establishes statutory authority for same-sex and interracial marriages.Biden signed the Respect for Marriage Act on Tuesday before thousands of guests on the South Lawn in the White House.

"Marriage is a simple proposition. Who do you love? And will you be loyal to that person you love? It's not more complicated than that,' CNN quoted the President as saying.He said the law recognises that "everyone should have the right to answer those questions for themselves without the government interference", and secures the federal "protec-



tions that come with marriage"."For most of our nation's history, we denied interracial couples and same


sex couples from these protections ... "It failed to treat them with equal dignity and respect."And now, this law

requires an interracial marriage and same-sex marriage must be recognized as legal in every state in the nation,

Biden was quoted as saying. The House of epresentatives had passed the legislation in a 258-169-1 vote on December 8, with 39 Republicans joining the Democrats in support, after getting through the Senate a week before with 12 Republican senators.

The new law officially voids the 1996 Defense of Marriage Act, which defined marriage as between a man and a woman.It mandates that states honour the validity of out-of-state marriage licenses, including same-sex and interracial unions.The legislation was introduced this summer after a conservative Supreme Court justice signaled that rulings on marriage equality and contraception should be reconsidered

AMIT SHAH TURNS MEDIATOR, MEETS CM SHINDE AND BOMMAI, SAYS WILL RESOLVE DISPUTE IN CONSTITUTIONAL WAY

he Chief Minsters of Karnataka and Maharashtra have agreed not to press their claims in the decades-long state border dispute till the Supreme Court takes a call on the matter, Union Home Minister Amit Shah said after a meeting with the two leaders. His meeting with Karnataka Chief Minister Basavaraj Bommai and Maharashtra Chief Minister Eknath Shinde was held amid a flare-up of the dispute that dates back to 1957.

Over the last weeks, trucks from Maharashtra have been attacked in Karnataka and buses of the southern state have been defaced by workers of the Uddhav Thackeray faction of the Shiv Sena

"There has been an agreement that till the Supreme Court delivers its verdict, the state governments will not make any claim. The dispute should be resolved through talks. A committee will be formed with three ministers from each state," Shah told reporter after the meeting.

A senior police officer will be deputed to look into the law-andorder issue so travelers and traders from neither state face any problems. Police cases will be filed against those who fan discontent on social media, Shah said.

He has also appealed to opposition parties in both states not to politicise issue and wait for the top court's ver-



dict

Maharashtra had been upset over the inclusion of Marathi-speaking areas -- including Belgavi, part of the erstwhile Bombay Presidency -- in Karnataka during the reorganisation of states on linguistic lines. It also laid claim to 814 Marathi-speaking villages which are currently part of Karnataka. Karnataka maintains the demarcation is final and there can be no change.

While the matter is pending in the Supreme Court, calming down frayed tempers in the two BJP-ruled states --

one of which will have its assembly elections next year -- is expected to take deft handling.

In Karnataka, the ruling BJP has come under opposition pressure in the run-up to the election. Senior Congress leader Siddaramaiah has accused the BJP of reaping "political benefits" out of the controversy. "Belagavi border issue, which could have been resolved through negotiations, is now allowed to grow so that BJP can take benefits," the Congress leader said.Karnataka has built a second assembly building in Belgavi to

assert its claims. A legislature session is held once a year at the 'Suvarna Vidhana Soudha', modelled on the Vidhana Soudha, the seat of legislature in Bengaluru. In Maharashtra, Opposition Maha Vikas Aghadi has been vocal, with Nationalist Congress chief Sharad Pawar declaring that it is time to take a stand

Eknath Shinde -- who became chief minister with the BJP's backing has also pointed out that party founder Bal Thackeray supported "the demand to make Belgaum (Belagavi) a part of Maharashtra"

To avoid Shraddha Walkar-type tragedies, state sets up panel on inter-faith marriages

he state government has set up a 10-member panel to keep an eye on 'inter-caste marriages', ostensibly to prevent Shraddha Walkar-type incidents in future, even as the Opposition cried foul, here on Wednesday.

Women & Child Welfare Minister Mangal Prabhat Lodha said that the panel was formed after much deliberation to avoid tragedies involving children of intercaste marriages, particularly if the girls go against their family wishes or are estranged.

The ruling Balasahebanchi Shiv Sena-Bharatiya Janata Party have welcomed the move while the Opposition Nationalist Congress Party slammed the decision terming it as "rubbish, retrograde, nauseating step to spy" on who marries whom.

The panel will serve as a forum for such women and their families where they can get counselling and communicate to resolve issues, and it will study various other policies and laws pertaining to the issue and recommend improvements or solutions. The move comes barely days after Deputy Chief



Minister Devendra Fadnavis indicated that the state would consider enacting a law on 'love-jihad' after studying similar legislation in other states. Lodha clarified that the panel was not against such (intercaste/interfaith) marriages, but specifically intended to help those women who have been cutoff from their families and attempt to bring them together. The panel will collect all information on registered/unregistered intercaste/interfaith marriages, those that were solemnised

only in religious places, wed-

dings after the couple eloped,

newly-married women and

help contact their families if

they have severed relations,

and arrange counsellors for such parents not ready to resume relations.

The BSS Spokesperson Krishna Hegde and BJP's Ram Kadam welcomed the initiative terming it as a step in the 'right direction'. NCP former Minister Dr. Jitendra Awhad pounced on the government with a strong reaction against the decision.





In her statement, Dr Pawar said, 'The Maharashtra government's one-sided decision to scrap the selection committee insults the

democratic procedures. I have decided to resign as a member of the Maharashtra State Literature and Culture Board." Kulkarni said, "Ghandy's book is not even banned, still the Maharashtra government back-tracked its own decision to award the translated version of it. This kind of treatment by the government will discourage people in future to be part of such processes. If the board is not going to support us, then I better quit. Please accept my resignation.'

A Government Resolution (order) issued on Monday stated that the decision of the selection committee had been reversed for "administrative reasons", and the award, which included cash prize of Rs one lakh. has been withdrawn. The committee too has been scrapped, the GR added.

Fake call centre that 'sold'

Ex-Mumbai CoP Param Bir Singh withdraws libel viagra to Americans busted case against Arnab Goswami, fined Rs 1,500


umbai's former Commissioner of Police Param Bir Singh - who was suspended just a fortnight prior to his retirement - on Wednesday unconditionally, withdrew his libel suit of Rs 90 lakh against Republic TV Chief Editor Arnab Goswami and his company ARG Outlier.

Permitting Singh to withdraw his suit, the Mumbai city civil court also imposed a cost of Rs 1,500 payable to Goswami, who had to engage a lawyer to defend himself.

Singh, who retired in June 2022, had filed the defamation suit in 2021 seeking Rs 90 lakh plus annual interest of 12 per cent from Goswami for allegedly defaming him and portraving him in a bad light.

Challenging it, Goswami's legal team questioned the maintainability of the suit as Singh - who shot into limelight after exposing the sensational TRP scam in 2020 - was no longer the Mumbai police chief, and raised other points.

On Wednesday, Singh filed an application to withdraw the suit without any conditions, which was allowed and a token cost imposed.



Goswami's lawyers informed that the court that there was no out-of-court settlement and it was (Singh's) decision to withdraw it and they had no objections, and even demanded costs for the "immense torture" Goswami had undergone

Noting that the plaintiff didn't want to pursue the matter and sought to unconditionally withdraw the suit, the court allowed the same and asked Singh to pay up Rs 1,500 to Goswami.

Singh - who has family connections with a senior BJP leader from Nagpur - came under a cloud after a SUV laded with 20 gelatin sticks and a threat note to industrial tycoon Mukesh Ambani and his family was recovered near their iconic home Antilia on February 25, 2020, sparking off a national-international furore.

However, later he fell from grace with the erstwhile Maha Vikas Aghadi government after he hurled "hearsay" allegations of corruption and misuse of office against the then Home Minister Anil Deshmukh, who is currently in jail since past 13 months in cases lodged by the Enforcement Directorate and the Central Bureau of Investigation.

he Borivli police have busted a fake call centre that cheated US citizens on the pretext of selling them aphrodisiacs banned in their country, at a 50 per cent discount. The products would not be delivered after the payment was made, said the police. According to the police, the bungalow at Gorai in which the call center was run, was earlier used to run coaching classes. The accused had taken the bungalow on rent and ran the call center under the pretext of "Lifestyle Fitness Centre" since March. An informer alerted Senior Inspector Ninad Sawant of the Borivli police station about it. "Under the supervision of DCP Ajay Kumar Bansal, a special team was formed and many officers from the Anti-Terrorism Cell, Cyber Cell, and Detection were sent for a raid. In the presence of Inspector Vijay Madye, personnel detained 16 people including two women, and seized 11 hard disks and computers from the spot," a police officer said. Eleven of the employees were let off.

During interrogation, it was found that the accused would call people in the USA on the pretext of selling them sex performance



enhancers like Viagra, Cialis, Levitra, and jellies, and would pretend to book their order and take money for it. After the payment through credit and debit card, the person who ordered the products was left waiting for a delivery that was never made. Five people were arrested including the call centre owner, while the mastermind is still at large.

"The mastermind, Shadab Shaikh, is at large. He had been arrested in a similar case in the past in Mumbai and also in another state. We are searching for him," said another police officer. The accused have been arrested under sections 276, 417, 419, 420, and 34 of IPC and sections 65, 66(K), 66(D), 72(a), and 75 of the IT Act. "They were produced before the court on Wednesday and remanded in police custody till December 17," said Senior Inspector Ninad Sawant of Borivli police sta-

Man knocked down, 'run over' by bus, walks up to a miraculous escape!

n unidentified middleaged Mumbai man was knocked down by a bus in Powai, and it ran over him even as other horrified pedestrians watched on.

The incident happened at 2.40 p.m. on Tuesday, just outside the Everest Heights Buildings near LakeSide complex in the fashionable Powai area and was captured in a CCTV that was shared late on Tuesday, and immediately went viral on social media networks.

The stunning 45-seconds video has captured vehicles moving slowly on a narrow but crowded road without a divider and several pedestri-

group of 94 former BMC corporators has written to CM Eknath Shinde, alleging a "lack of transparency" and "corruption" in the Brihanmumbai Municipal Corporation ever since the term of the city's 227 corporators ended this March. The elections to the wealthiest civic body were scheduled for this October but have been postponed on account of the issues of OBC reservations and delimitation of wards pending in the courts. State-appointed administrator and Municipal Commissioner Iqbal Singh Chahal is now the lone administrator of the BMC and his writ runs unchallenged.

The lead signatories of the letter included floor leaders of Shiv Sena Mayor Kishori Pednekar, Samajwadi Party leader Raees Sheikh, Congress LoP Ravi Raja, and NCP's leader Rakhi Jadhav.

The letter stated that a" lack of transparency and accountability, ad hoc and arbitrary transfer, finan-



cial mismanagement" has led to the collapse of civic administration and governance of Mumbai.

"Ninety-Four former BMC corporators from different political parties, including Shiv Sena, NCP, Samajwadi Party and MNS, have written a letter to Maharashtra CM Eknath Shinde, alleging lack of transparency and financial mismanagement in BMC under the rule of state-appointed administrator and municipal commissioner, Iqbal Singh Chahal," said Opposition leader in BMC and Congress leader Ravi Raja.

Refuting the allegations, BMC commissioner Chahal said, "There is no lack of transparency as 100 per cent of resolutions pertaining to decisions taken by BMC are transparently available on the BMC website for anybody's scrutiny, without exception (since the tenure of Administrator started w.e.f March 8, 22)."

"The financial position of BMC is excellent. The financial reserves of BMC have increased from Rs 77,000 crores in 2020 to Rs 87,000 crore as of today. So, there is no question of financial mismanagement or collapse," Chahal added.

Pujara would fall ten runs short of his century as left-arm spinner Taijul Islam took him out to complete his three-wicket haul after beating him several times in the day, Iyer remained unbeaten on 82 off 169 balls on an absorbing day of Test cricket.Bangladesh, despite getting six wickets and Taijul being their standout bowler, would be wondering how the day would have been if they hadn't dropped Pujara and Iyer on 12 and 67 respectively.

Pant's arrival brought a flurry of runs for India, through his trademark pull and sweep off the spinners

Pujara began the final session with a handsome cut through cover on width offered by Hossain. Taijul troubled Iyer, but he brought out an authoritative drive off the front-foot against Ebadot. Pujara cashed on Taijul's short balls to hit successive fours, first of which got him his fifty.



Three overs later, Iyer pulled Shakib through mid-wicket to notch up his fifty. After Taijul beat him on the outer edge, Iyer danced down the pitch on the very next ball to lift over wide mid-on for four, before whipping Mehidy with disdain over midwicket.Bangladesh had success in the next over as Taijul turned it just enough from middle-and-off stump line to beat the outside edge of Pujara and knock off the off-stump, sending him back for 90 off 203 balls. Rahul opened the face of the bat to steer a length ball from Khaled

Ahmed but chopped on. In the next over, Kohli tried to flick through legside on backfoot, but was trapped right in front of middle stump by a sharp turning in delivery from Taijul.

ionel Messi kept his World Cup dream on track as he scored one and set up another as Argentina romped home into the final of the FIFA World Cup with an emphatic 3-0 win over 2018 finalists Croatia at Lusail Stadium on Tuesday night.

At the end of half time La Albiceleste led 2-0 as Messi converted a spot kick in the 34th minute to give them the lead and Julian Alvarez struck with a sublime solo effort to give the South American side a comtable 2-0 lead going into the half time break. Argentina kept the scoring tempo to add a third one in the 69th minute with Alvarez netting his second of the match.Croatia were fully in control in the opening 25 minutes or so with Argentina not being able to make any telling breakthroughs, but once Argentina were awarded their penalty they did not look back as the momentum shifted quickly Croatia dominated the ball, controlling more than 60 percent of possession. Still, they managed to do precious little with it, failing to register a single shot on target. Argentina was ready to sit back and battle as Croatia advanced up the field. Messi scored the opening goal of the game against Croatia 11 minutes
