LONDON SOLICITOR CLAIMS CHINA WAS READY TO SETTLE BORDER DISPUTE IN 2001

A BORDER BOMB

British Indian solicitor in London, Sarosh Zaiwalla said the Chinese government was willing to discuss 'with an open mind' India's demands on the long-standing boundary issue between the two countries in 2001 in back-channel talks. "This meant," he wrote in his memoirs Honour Bound, "setting up a second-channel, confidential meeting between the political leaders of China and India to find a practical resolution at a senior level to settle the border dispute".

aiwalla wished to remind people of what he regrets as being an opportunity lost in the context of recent fighting between Indian and Chinese soldiers at the front between the two countries in Tawang in Arunachal Pradesh.

He further stated the then Chinese ambassador in Britain Ma Zhengang worked with him on a note on the subject, which Zaiwalla forwarded to the Indian government. But he never heard

He maintained: "I gave the note which I had prepared, with the ambasador's input and approval, to Maneka Gandhi, who confirmed to me Singh. (As it happens, Maneka was at that time my client and had been a min-

ister in the Vajpayee government.)" He recorded in his book: "When I met Jaswant Singh at an event in the Washington Hotel in London a few



months later, he said to me airily, 'I have given your note to my department to consider'.He continued: "Had the Indian government taken this seriously, China would have had to respond, and they could have resolved the matter. For China in those days the focus was on economic development and not military might. Zaiwalla recalled that in his conversation with Ambassador Ma, the latter initially signalled: "What we want is a proper borderline to be drawn between the countries. China wants the original border of Tibet to be the border with India. The line drawn by the British Raj as the border between Tibet and India cannot be considered the

To that, Zaiwalla is said to have replied: "For India to part with any territory would not be acceptable for the Indian people, especially after the 1962 border war.'

The lawyer claimed he also brought to the diplomat's attention, 'the fact that at the time the border as drawn by (Henry) McMahon (then foreign secretary of British ruled India) was agreed by Tibet and India, Tibet had a government. Therefore, there had been a legal and binding acceptance by Tibet and India of the location of the border'. He added: "This in turn would be binding on China."

Zaiwalla was certain: "In my conversations with him, the ambassador accepted that all these points could be discussed.'

In course of their exchanges, Zaiwalla revealed he suggested to the Chinese ambassador that China should lease a corridor to India through its territory to enable Indian pilgrims to visit the Hindu pilgrimage sites in Mansarovar and Kailash. "The ambassador indicated that it could be discussed in exchange for India ceding some of its territory in the Himalayan mountains, where no one lived and there was no evidence of any mineral deposits," was Zaiwalla's memory.

'PLA SOUGHT UNILATERAL CEASEFIRE AT YANGSTE TO FREE 63 SOLDIERS'

Kolkata: An untrained eye could mistake them for Chinese-made walking sticks used by trekkers in the high-altitude terrain. But Indian Army soldiers know better. Walking sticks for trekkers have firm grips and a pointy end for a better grip while going up or down slopes but they do not have lethal spikes sticking out.

These are specially-designed clubs for China's People's Liberation Army (PLA) personnel, the likes of which were used during the Galwan clash in 2020.

Over a hundred of them, seized from PLA soldiers between December 8 and 9These clubs are also designed to emit bright flashes during a clash in the night to temporarily disorient the opponent.

On December 8, the Indian Army stopped a PLA patrol that had crossed over the LAC. While other members of the team rushed back, three PLA soldiers were captured. The matter could have been resolved peacefully but the PLA decided to launch a counter attack to free the three Chinese soldiers.

This happened on December 9. By then, the Indian Army was aware of what was to take place and were prepared. The PLA 'riot squad' arrived with over 300 personnel. Indian Army soldiers not only beat them back but captured 60 PLA soldiers with their spiked clubs. The retreating PLA soldiers left behind several more such clubs in a bid to get away from the blows the charged up Indians were landing upon them," the source added.

Faced with a situation of having as many as 63 of their own in Indian custody, the PLA immediately called a truce. A flag-meeting was convened and the Chinese soldiers were handed over. Their clubs and others collected from the scene of the skirmish were retained by the Indian Army and are neatly lined up in a room now. China will never reveal how many of their soldiers were injured but the nine Indian Army personnel being treated at an Army Hospital in Guwahati are doing fine. This was a strong message sent back to China that there will be no repeat of another Galwan.



Social media toxicity affects collective narrative, makes it divisive and destructive: SRK

ollywood superstar Shah Rukh Khan on Thursday said the social media is often driven by a narrowness of views that "enclose" collective nar rative and makes it more divisive and destructive.

In his address at the inauguration ceremony of the 28th Kolkata International Film Festival (KIFF) here, he said that the collective narratives in recent times have often been shaped by social media, which is often driven by a narrowness of views that limits human nature to its baser self.

"This sense of negativity often increases the social media consumption and such pursuits often enclose collective narrative and makes it more divisive and destructive," said Shah Rukh Khan, who is also the brand ambassador of West Bengal. He said that cinema now has a more important role to play in spreading that message of collective narrative.

"I hope that festivals like KIFF and the city like beginning of this positivity at this point of time," the Bollywood superstar said.

His comments became significant in view of the recent social media attacks by certain groups on his next release "Pathaan". Almost echoing the

Cyber criminals withdraw cash from 147 bank accounts in Jharkhand

yber criminals allegedly withdrew cash rangng from Rs 7,000 to Rs 24,000 from as many as 147 accounts in different banks in Dhanbad district of Jharkhand by using the fingerprints of account holders after cloning them. Complaints regarding the matter have been made to the cyber police as well as the banks.

Most of the people from whose accounts money has been withdrawn are those who had availed the banking



services at customer care centres or franchise centres instead of the branches, and had given their fingerprints on the machines there. It is suspected that there may be collusion of customer service centres employees with cyber criminals in these cases.

People complaining to the cyber police and banks say that they neither received a call from anyone, nor did they share ATM PIN and OTP with anyone, nor did they ever click on any link, but thousands of rupees were withdrawn from their account.

It is being said that illegal withdrawals ranging from Rs 7,000 to Rs 24,000 have been made from the accounts of most of the people two-three times. Businessmen, doctors, women were among those whose accounts were target-

AGNI 5 NUCLEAR-CAPABLE MISSILE, TEST-FIRED SUCCESSFULLY

New Delhi: The night trials of nuclear capable ballistic missile Agni 5 was successfully conducted on Thursday in Odisha, a Defence official said. The missile is capable of striking targets at ranges up to 5,000 km with a very high degree of accuracy. The range of the missile can be further increased based on the results of the testing, the official added. The Agni 5 ballistic missile tested on Thursday evening is lighter than before. The official said the test was conducted in an attempt to validate advanced technologies and new equipment on the missile which weighs lesser now. The launch was carried out for a predetermined range and validated all operational parameters of the system, the official added.

World Cup fever leading to critical eye and heart problems: Doctors

t a time when India is in the grip of the FIFA World Cup ever with millions of viewers being glued to television sets or other forms of digital screens, two top doctors from Kolkata have cautioned against people being affected by "Digital Eve Strain" syndrome. According to them, the common symptoms of this "Digital Eye Strain" syndrome are extreme headaches, blurred vision, irritation in the eyes, redness and gritty sensation and excessive tearing.

According to them, apart from these factors, the prolonged sleep

matches disturbs the human body's normal homeostasis which directly affects eye health along with the other systems like heart and nerves. It may cause severe dry eyes, dark circles and puffiness of eyelids, the opthalmologists warned.

According to Dr Joyeeta Das, consultant opthalmologist with Disha Eye Hospitals, certain precautions like having the room welllit while viewing such matches, keeping the digital screens in eye protection mode, taking short breaks in between matches and power naps during the breaks, can reduce these physical complexities

She said that one must avoid contact lenses while viewing matches and also avoid rubbing the eyes. "Most important is that one should not be deprived of

sleep at any cost,' Das said. According to Dr PS Karmakar, consultant cardiologist with Techno India Dama Hospital, this constant viewing of high-tension world cup football matches has also an immense adverse effect on the human heart. According to him, the cheering and the anxiety from the beginning to the end of the game leads to an acceleration of the normal impulse rate of a human heart, which results in

No Proposal To Grant Constitutional Status To Minorities Commission: Centre

he government on Thursday told the Lok Sabha that there is no proposal at present to grant constitutional status to the National Commission for Minorities

In a written response to a question in the lower house by Congress leader Adhir Ranjan Chowdhury, Minority Affairs Minister Smriti Irani said the National Commission for Minorities (NCM) was established as a statutory body with the enactment of the National Commission for Minorities Act,

1992 by Parliament. This Act came into force with



effect from May 17, 1992, she said.

"Under section 2 (c) of the said Act, the central government has notified five religious communities namely, Buddhists, Christians, Muslims, Sikhs, and Zoroastrians (Parsis) as minority communities, there is no proposal, at present, to

grant constitutional status to the National Commission for Minorities," she said.

Subsequently, the central government further notified the Jain community as a minority community vide notification on January 27, 2014, the minister said.

In response to another question as to whether it is true that the number of beneficiaries has decreased under the Pre-Matric and Post-Matric scholarship schemes in 2020-21 in comparison to 2019-20, Irani said there is state-wise/community-wise quota for fresh scholarships under pre-matric and post-matric scholarship

INTRODUCED 'HEALTHY SUBSTITUTE' FOR ILLEGALLY-BREWED HOMEMADE LIQUOR, PUNJAB GOVT TO SC

he Punjab government has told the Supreme Court that to wean away consumers of illicit homemade liquor from its use, the government has introduced, in the current excise policy, a cheap variant of country liquor having 40-degree strength, which is a "healthy substitute"

The state government, in a counter-affidavit, said the Excise Department has been regularly carrying out massive enforcement drives against manufacture and use of illicit homemade liquor/spurious

The state government's response came after the Supreme Court expressed concern at increasing illicit liquor trade in the state.

In the affidavit, the state's Department of Excise and Taxation gave details on the steps to eradicate the menace of spurious liquor. It said to wean away illicit homemade liquor consuming sections of the society from its use, the state government has introduced a cheap variant of country liquor having 40 degree strength. "This liquor is going to be a healthy substitute for illegally brewed homemade liquor. The field officers of the department have been entrusted with the task of giving their requirement of 40 degree country liquor based on ground inputs so that the same can be made available in illicit liquor prone areas in near future," it said.

The affidavit said awareness through local print and electronic media including cable TV will be started on war footing level and wherever necessary, social media will also be used for the purpose

The state government said the campaign against illicit distillation of liquor will be started by spreading awareness regarding ill-effects of homemade illicit liquor by using means, including popularising the department's already existing reward scheme



information regarding such manufacturing and sale. The state government, in a separate affidavit, said an Inspector General rank police officer has been nominated at the state level to monitor investigation of cases registered under the Punjab Excise Act, 1914. A circular has been issued to all the field units to ensure action against manufacture, smuggling and sale of illicit liquor, which shall invariably lead to registration of a criminal case under the relevant provisions of 1914 Act or the Indian Penal Code, it added. The state government said any default would entail departmental action against the delinquent officer/official.

On Thursday, the matter came up for hearing before a bench of Justices M.R. Shah and C.T. Ravikumar. Senior advocate Ajit Kumar Sinha, representing the state government, along with advoso that more and more informers come to share the cate Ajay Pal, referred to the steps taken by the

authorities in the matter and said the state has implemented all directions issued by the top court.

Counsel further added that a circular has been issued holding local police accountable if illegal liquor manufacturing units are found. The bench cited the Bihar hooch tragedy, where 39 people lost

After hearing the arguments, the bench said, "Let us see how it progresses. We will monitor it" and scheduled the matter for further hearing after win-

The affidavit filed by the department said: "There will be complete coordination with Police Department at district level and the resources available with Police Department like trained man power, drones and boats for river side searches etc shall be pressed into service during cordon and search operations carried out in illicit liquor prone

"All the vacant posts in the Punjab state excise force shall be filled immediately to increase the availability of manpower to fight this menace of illicit distillation of liquor effectively. Similarly, the department will ensure that all the posts of excise inspectors as per sanctioned strength are filled."

On December 5, the Supreme Court pulled up the Punjab government over the issue of sale of spurious liquor in the state, saying Punjab is a border state and this is a very serious matter. The top court asked the state government to come up with specific steps to curb the menace of spurious liquor, while adding that the youth will be finished.

The apex court was hearing a plea arising out of a September 2020 order of the Punjab and Haryana High Court, which disposed of a petition seeking transfer of some FIRs registered in Punjab in relation to distillation of spurious liquor, its sale, and inter-state smuggling to the CBI.

Tith the toll in the Saran liquor tragedy at 39, Leader of Opposition in Bihar Assembly Vijay Kumar Sinha targeted Chief Minister Nitish Kumar, accusing his government of "committing a mas-

"Nitish Kumar should take responsibility on moral grounds and resign from his post. If the government recommends the case in such a massacre, the names of a number of officials and leaders will come in it," Sinha said."Over three dozen people have lost their lives in a liquor tragedy and if they are unable to prevent such incidents, they have no right to stay in power. After so many deaths, the Chief Minister of Bihar, instead of giving a statement on it, had blamed us. The behaviour of the Assembly Speaker is also not appropriate. The state government is trying to suppress the voice but they would not make us silent," he said.

Mehrauli murder: DNA of Shraddha's bones matches with her father

he brutality involved in Shraddha Walkar's murder by L her live-in partner, Aaftab Amin Poonawalla, was officially confirmed after the DNA extracted from bone pieces recovered in the Mehrauli forest area matched with her father's samples, sources said on Thursday.

Special Commissioner of Police (Law & Order), Sagar Preet Hooda, said that police have received the DNA test report from the CFSL and the polygraph test from the FSL,

The third narco test report is still awaited. The post-narco test of Poonawalla had also concluded on December 2. His test was conducted inside the Tihar prison by the FSL

Poonawalla and Walkar had shifted on May 15, three days before her murder. The bone samples were sent for DNA analysis to the Central Forensic Science Laboratory.

"It is a positive development and a push to ongoing investigation. We will be able to present a powerful case now in the court," said an official. "The autopsy of the bones will be conducted at the All India Institute of Medical Sciences (AIIMS). The investigators will prepare a questionnaire and send it to the medics who will prepare the autopsy report which will help gain all relevant information regarding the case," said sources.

As all the recovered body parts are decomposed, it is very difficult to get any significant result from the autopsy, said an official, adding that a portion of jaw or a fragment of skull recovered may help investigators in determining the time of death by the

MAN HELD IN CHANDIGARH FOR SPYING FOR ISI, 'SIKHS FOR JUSTICE'

Man held for duping several youngsters on pretext of job in Merchant Navy

elhi Police's Economic Offences Wing (EOW) has arrested a man for allegedly cheating youngsters on the pretext of providing them jobs in Merchant Navy, an official said on Thursday.

The accused has been identified as Akash Thakur alias Avadh Bihari, a native of Jehanabad district in Bihar. Last year, on May 21, the EOW had registered a case under relevant sections of IPC after receiving a joint complaint from one Sanjay Yadav and others.

"The complainants had alleged an Ocean Galaxy Marine Private Limited through its director namely Akash took money from them



on the false promise to get

them a job in the Merchant Navy. A total of 30 victims had paid between Rs 3 to 4 lakh each," said Jitender Kumar Meena, Deputy Commissioner of Police (EOW). "After taking money, Akash absconded and he was also declared a proclaimed offender. However, on December 14, after receiving specific inputs that he was running a tour and travel office in the name of 'Dhanlaxmi' in Vipin Garden,

a police team apprehended him," said the DCP.

Akash, in 2019, opened a consultancy company Crown Marine Management Private Ltd at Dwarka Sec-11, Delhi.

"He did not have the licence from the Director General of Shipping, Ministry of Shipping, which is necessary to run this type of recruitment company. Later, he purchased another company Ocean Galaxy Marine Private Ltd which has a licence of DG Shipping and started to work from District Centre in Janakpuri. Through his company, he took money from the complainants on false promises to get them a job in the Merchant Navy and absconded," the official

45 adopt Buddhism in Gujarat, VHP says not averse to this conversion

he Vishva Hindu Parishad (VHP) here said on Thursday that it was not averse to the group of 45 people adopting Buddhism in Balasinor Taluka of Gujarat's Mahisagar

The group had converted even before their applications were approved by the district collector. The conversion took place on Tuesday. Reacting to this, Vishva Hindu Parishad (VHP) state spokesman Hitendrasinh Rajput said, "Buddhism is a wing of Hinduism, it is mentioned in the Darshan Shastra, but we are against abusing Hindu deities. People are being lured to convert on some promises. It is like bribing them."

The VHP reaction came after the news was reported in regional dailies. According to reports, 45 persons from three districts converted to Buddhism without prior permission of the district magistrate as per the rule of the Gujarat Freedom



Religion Act, 2003. Under this Act, any person who wants to quit the religion in which one is born and adopt another religion, will have to take prior permission from the district magistrate or collector."There is no violation of the law," defended by Kamlesh Mayavanshi, who too has adopted Buddhism along with 44 others. His defense was, "All those, who wanted to quit Hindu religion, had applied to the district collector a month ago, according to norms.

Gujarat, where elections were held on December 1 and 5. The party won 156 out of the total 182 Assembly seats, while the Congress could bag only 17 seats.

The main reason behind the success of BJP in Gujarat is that it is the home state of both Modiji and Amit Shah, due to which the voters got influenced," Nath told reporters.

The former chief minister and his son Nakul Nath, who is a Congress Lok Sabha member from Chhindwara, were here for taking part in various programmes.

When asked about Madhya Pradesh Chief Minister Shivraj Singh Chouhan announcing the suspension of officials from stage during his visits in various parts of the state, Nath dubbed it as "drama".

"It is all drama and nothing else. He announces from the dais, but has he suspended them on paper?" Nath asked.

These are tactics to grab media attention, he alleged. "He (Chouhan) has nothing to tell people and therefore keeps searching for new excuses to remain in the limelight. It clearly reflects his frustration and he only knows how to misuse police, administration...," he claimed.

Earlier this month, Chouhan suspended four officials for alleged dereliction of duty while addressing a programme in the tribal-dominated Betul district.

MISCHIEVOUS DRAGON

he US Pentagon has said that China continues to amass forces and build military infrastructure across the Line of Actual Control (LAC) with India. Addressing a briefing, Brigadier General Pat Ryder, Press Secretary of the Department of Defense (DoD), said the DoD continues to closely watch developments along the line of actual control at the India-China border. "We have seen the PRC continue to amass forces and build *military infrastructure along the so-called* LAC. But I would defer you to India in terms of their views. "It does reflect though, and it's important to point out, the growing trend by the PRC to assert itself and to be provocative in areas directed towards US allies and our partners in the Indo Pacific. "And we will continue to remain steadfast in our commitment to ensuring the security of our partners. And we fully support India's ongoing efforts to deescalate this situation," he added. Ryder's remarks came as a response to a series of queries on the recent clashes between *Indian and Chinese soldiers along the LAC* in Arunachal Pradesh. The clashes were the first in nearly two years. The queries posed to the spokesperson was: "How much is the Pentagon concerned that this clash could lead to a bigger military confrontation? Is the Pentagon willing to provide more military support to India to help them handle China's military threats at the border?" On December 9, troops from China's People's Liberation of Army the LAC in Arunachal Pradesh, but Indian soldiers firmly contested their way, leading to a clash between the two. Sources said that although no loss of life or major injuries were reported but both some Indian and Chinese troops received some minor injuries.

POJK RESERVES THE RIGHT TO REBEL

he International Human Rights Day was observed globally on December 10. It was a day when civil society organisations and several political parties held seminars and corner meetings in Pakistan occupied Jammu Kashmir and Gilgit Baltistan (PoJK/GB) as well as among the exiled diaspora

Human rights have three aspects: Social rights, political rights and economic rights. The people of PoJK/GB have been deprived of these three categories of rights since October 22, 1947, when Pakistan attacked and illegally occupied our lands.

Social rights include workers' rights at their work place, social security, cultural rights, housing, access to clean drinking water and food, uninterrupted flow of electricity, access to health care and education


In PoJK/GB even the line men working to fix electric cables hang ing from high power wires on tall poles are not provided with proper safety gear. At most workplaces there are no medical facilities or even toilets.

There is no social security cover for the general population of four million. Our vibrant Kashmiri and Dogra culture has been strangled by imposing the hegemony of an Islamic (read Arab) religious narra-

Hundreds of thousands live in houses made of tin metal or are forced to live on rent due to lack of a national housing program for the

Curable diseases such as hepatitis and cholera keep recurring due to lack of clean drinking water. Lack of proper affordable diet has left millions which has stunted

Hospital buildings are faced with shortage of doctors and medicine, and hundreds of thousands of our children are unable to attend school due to abject poverty and are forced to enter the child labour



market. Schools face a severe shortage of teachers, toilets and dispensaries or a playground.

Hence, we have been denied our first and basic human right which is our social right.

Political rights that were usurped by the occupation force of Pakistan remain denied to this day. Only those political parties are allowed to operate in PoJK/GB which openly claim their affiliation with the ideology of two-nation theory of Muhammed Ali Jinnah and sign an oath of allegiance to Pakistan.

Candidates, who aspire to participate in elections for legislative assembly or the local bodies, are only permitted to do so if they sign an oath that they support the accession of PoJK/GB to the Islamic republic of Pakistan.

All forms of political dissent are

brutally crushed and political activists who dare to challenge Pakistani occupation are often assassinated.

rights deals with economic rights. In PoJK/GB there has never been any attempt by Pakistan to develop an industrial infrastructure. Millions are unemployed and

The third component of human

are forced into economic exile in Europe, the US and the Middle East to perform no-to-low skill jobs so that they can send remittances to their families back home

All natural resources such as rivers and forest land remain under the tight control of the Government of Pakistan. Our natural resources are plundered day and night and precious stones, gold, and rubies worth billions of rupees are stolen each year. Our forest trees are cut

down and sold in the timber markets of Pakistani Punjab. Not a single penny from this plunder comes our way

Due to lack of funds the PoJK/GB government is unable to purchase wheat and other food essentials or pay wages to thousands of employees of several government and semi-government institutions such as forest department, health workers, and others. Lack of power and electricity has left hundreds of businesses go burst which has increased the number of unemployed and those in destitute.

The list of human rights violations and abuse we face in the PoJK/GB due to being under the occupa-

tion of Pakistan

However, we have one right that we have the liberty to exercise. This is the right to fight the social, political and economic oppression of Pakistan by rebelling against the above mentioned injustices we

This right we are exercising now as thousands of our oppressed people not only refuse to accept the occupation of our territories by Pakistan but are now giving the rebellion a direction to get liberation from Pakistan.

THREE DEAD, DOZENS INJURED AFTER TORNADOES RIP THROUGH LOUISIANA

t least three people were killed and dozens others injured after a massive winter storm spawned intense tornadoes across the US state of Louisiana, authorities confirmed on Thursday.

One person was killed, and eight others were injured on Wednesday when a tornado ripped through Killona, a small neighbourhood in St. Charles Parish, Xinhua news agency reported.St. Charles Parish sheriff's office tweeted that multiple residences were heavily damaged in Killona as police were checking residences for injured or trapped people.

Earlier on Wednesday, rescuers found the body of a 30-year-old woman under the debris one street away from her home destroyed by an EF-2 tornado hitting Keithville on Tuesday night, according to the Caddo Parish sheriff's office.

The body of her eight-year-old son was also found in the forest about a half mile away from their home. More than 30,000 homes and busi-



nesses in the area were left without power Wednesday afternoon after another tornado battered the New Orleans metro area including Gretna and Arabi, which were hit by an EF-3

In Farmerville, Louisiana, rescuers searched overnight for victims of a tornado that struck a neighbourhood on Tuesday evening, which injured nearly 25 people, some critically, local media outlet KNOE reported.

Peru declares state of emergency in wake of violent protests

eru declared a 30of emergency in the wake of the violent protests against the impeachment and subsequent arrest of former President Pedro Castillo.

"We have agreed to declare a state of emergency for the entire country, due to the vandalism and violence, and the seizure of highways and roads," acts that are being controlled by the National Police and the Armed Forces, Defence Minister Alberto Otarola said late Wednesday following a meeting of the Council of Ministers.

The violent protests, which have left seven people dead in the south of the country, "require a forceful and authoritative response from the gov-



The state of emergency temporarily suspends the right to assembly and to freedom of movement, among other constitutional guarantees.

Political unrest was sparked by the ouster of Castillo on December 7, and has been spreading from the south of the country to northern cities, such as La

Among the protesters demands are early elections and Castillo's release from custody.

On Monday, protesters had blocked roads and set fire to vehicles, and an estimated 2,000 stormed the airport in Arequipa, blocking the runway and forcing flights to be suspended for several hours. Police finally dispersed

them with tear gas.

Iran expelled from UN panel on women; India abstains on vote

n an unprecedented move, Iran has been expelled from the UN's Commission on the Status of Women (CSW) in a vote on which India abstained.

The US proposal at the UN Economic and Social Council to remove Iran from the panel received 29 votes, while there were eight votes against and 16 abstentions in the 54member elected body.

The vote came after intense lobby ing by the US following widespread protests in Iran sparked by outrage against the edict compelling women to wear hijabs.

US Permanent Representative Linda Thomas-Greenfield told the Council that CSW, which is "the premier UN body for promoting gender equality and empowering women" cannot function if it is "undermined from within" by Iran."Iran's membership at this moment is an ugly stain on the

Commission's credibility," she said. Thomas-Greenfield spoke of Mahsa Amin who died after being held by "morality police" in September and called her a "martyr".

Her death sparked the protests during which, Thomas-Greenfield said, "government security forces have reportedly detained and tortured thousands of people, killed hundreds of peaceful protestors, and badly injured many more. Men supporting women in the streets are now being targeted with the death penalty".

The Commission is made up of 45 countries which are elected by the Council to four-year terms.

Iran's term, which began this year, was to have run through 2026.

Iran's delegate countered that the US and its allies practice racial discrimination against minorities "including women and girls" and "support rioters in other independent countries under the pretext of promoting human rights".

US REPORTS 50% INCREASE OF WEEKLY CHILD COVID CASES

Washington: About 41,000 child Covid-19 cases were reported in the US in the week ending December 8, an increase of about 50 per cent over the weekly average in the previous eight weeks, according to the latest report by the American Academy of Pediatrics (AAP) and the Children's Hospital Association.

Almost 15.1 million children in the country have tested positive for Covid-19 since the onset of the pandemic in early 2020, reports Xinhua news agency.

About 127,000 of these cases have been added in the past four weeks, according to the report. Reported cases are likely a "substantial undercount" of Covid-19 cases among children, said the report.

There is a need to collect more age-specific data to assess the severity of illness related to new variants as well as potential longer-term effects, said the report.

It is important to recognize there are immediate effects of the pandemic on children's health, but importantly there is the need to identify and address the long-lasting impacts on the physical, mental, and social well-being of this generation of children and youth, said the AAP.

Covid global health emergency hopefully ends next year: WHO chief

he chief of the World Health Organization (WHO) has said that he hopes that Covid-19 will no longer be a global health emergency sometime next year.

Addressing a press briefing in Geneva, WHO Director-General Tedros Adhanom Ghebreyesus said that the WHO Covid-19 Emergency Committee will discuss next month the criteria for declaring an end to the Covid-19 emergency, Xinhua news agency reported.

"We're hopeful that at some point next year, we will be able to say that Covid-19 is no longer a global health emergency," he said.

He added, however, that the SARS-CoV-2 virus, the culprit behind the Covid-19 pandemic, will not go away.

"It's here to stay, and all countries will need to learn to manage it alongside other respiratory illnesses including influenza and RSV (Respiratory

Syncytial Virus), both of which are now circulating intensely in many countries," he said.

The WHO chief said one of the most important lessons from the pandemic is that all countries need to strengthen their public health systems to prepare

for, prevent, detect and respond rapidly

s directed by Union Home Minister Amit Shah, Maharashtra will soon set up a committee of ministers to study and take measures to resolve the long-pending boundary row with Karnataka, Chief Minister Eknath Shinde said here on Thursday.

Assuring that the state government is standing behind the Marathi people in the disputed border areas, he assured that steps will be taken to solve their grievances and problems. Deputy Chief Minister Devendra Fadnavis said that till the border issue is pending in the Supreme Court, the government will adhere to the instructions of Shah and make all efforts to ensure that peace is maintained in the region.

The duo's comments came after their meeting with Shah, Karnataka CM Basavraj Bommai and home minister Araga Gyanendra in New Delhi late on Wednesday.

At the meeting, Shah said he



has advised both the states to maintain a status quo till the outcome of the case in the apex court. He also directed both states to form a committee of three ministers from each side to coordinate, visit the disputed areas, study and resolve problems of the people there.

Shah also advised the two states that till the SC verdict, no state will make allegations or counter-allegations against each other, neither state will make claims/demands on each other and ensure that the situation doesn't deteriorate.

Welcoming Shah's initiative,

Nationalist Congress Party National Spokesperson Clyde Crasto said it remains to be seen

On his part, Fadnavis claimed that a few organisations were trying to create disturbances and said the Centre has warned of stringent action against them. uburban train services on Mumbai's Harbour and Trans-Harbour lines operated by the Central Railway (CR) were disrupted during the morning peak hours on Thursday due to a technical snag in the signalling system at a Navi Mumbai railway station, officials said.

Passengers said that even after the resumption of services, the locals got delayed by at least 20 minutes on the Harbour line during the morning rush hour, although the delay was slightly less on the Trans-Harbour line. 
James Gunn is writing a new feature film about "Superman"




