JOSHIMATH SINKING CRISES: BADMINTON COURT CAVES, WALLS COLLAPSE

QUESTION IS... WHEN?

The "sinking town" of Joshimath in Uttarakhand is on the brink of disaster with cracks in hundreds of buildings. The scale of damage is most visible at the Jaypee power plant, currently the most dangerous building in town.

Because of the extent of destruction at the residential complex of Jaypee, people have been banned from entering the campus.

At the badminton court, the cracks in the walls are so wide that a human hand can slip in, an NDTV team found. The floors are sagging, and the windows are askew in the complex.

The doors are barely hanging off hinges and parts of the roof are crumbling.

Some of the rooms are barely standing. A light nudge can bring the wall crashing down. In the toilet, the floor has caved.

The entire complex has been declared a "red zone" - which indicates most dangerous - and it is widely believed by locals as well as experts that the residential building could collapse any minute.

Residents say for the past few days, ground water has been gushing beneath the surface at a high speed, and it is this water that has weakened the walls and floors. Cracks in buildings are oozing this brown muddy



water.

Across the temple town, which is the gateway to popular pilgrimage sites like Badrinath, massive cracks have appeared in buildings and roads after years of unplanned infrastructure building, including hydropower projects.

Many have fled their homes and around 600 houses and hotels are sinking in the town of around 20,000 people.

Thousands of residents are being evacuated to safety. The state government will demolish the most damaged buildings in the next few days.

The town also hosts a major Indian army base and a strategic road to the

Joshimath: While the cracks that have appeared in the buildings of Joshimath are widening, the administration has been facing the opposition of the affected people in the demolition drive.

In a meeting between the administration and the locals, it was announced that a compensation of Rs 1.5 lakh would be provided to the affected families, which was refused by the locals.

CRACKS APPEAR IN HOUSES IN ALIGARH

Aligarh: Several houses in Aligarh have also started developing cracks.

Coming after buildings developing cracks in Joshimath in Uttarakhand, it has created panic among the local residents.

According to the locals, a pipeline was laid by the government under the Smart City scheme, which is now reportedly leaking, leading to the development of cracks.

Houses in the Kanwariganj area have reported cracks and leaks.

"It has been 3-4 days. We have intimated about the same to the department, but no assistance has been provided so far. We are being forced to live in terror," said Mansoor Ali, a local resident.

The region is prone to earthquakes and has seen disasters in recent years blamed on melting glaciers and incessant construction and drilling in the mountains. In 2021, at least 200 people were killed in flash floods in Joshimath and surrounding areas in a disaster partly blamed on excessive development.

'Naatu Naatu' wins the Best Original Song Award

As India is all set to bring home the Golden Globes 2023 award for the song 'Naatu Naatu' from S.S. Rajamouli's magnum opus 'RRR', young singer K.S. Harisankar, who has lent his voice to the track in Malayalam, finds himself on cloud nine.

On hearing the news of the track bagging the award for the Best Original Song at the 80th Golden Globes, the dentist-turned-singer congratulated the entire team of the film.

"It was an unforgettable experience for me when I sang the song as all the leading lights of the film, including Rajamouli Sir were there. Normally, I sing songs of a different genre and many asked me if it was me who had sung the Malayalam version. Am extremely happy," said the 29-year-old.

Incidentally, Harisankar hails from a family of legendary musicians and was trained by his maternal grandmother K. Omanakutty besides two of his uncles M.G. Radhakrishnan and

M.G. Sreekumar who are leading lights in the music industry here.

'Naatu Naatu' was in competition with 'Carolina' from 'Where the Crawdads Sing', 'Ciao Papa' from 'Guillermo del Toro's 'Pinocchio', 'Hold My Hand' from 'Top Gun: Maverick', 'Lift Me Up' from 'Black Panther: Wakanda Forever'.

Receiving the honour was music composer M. M. Keeravani, who dedicated



the award to Rajamouli and the actors Ram Charan and NTR Jr.

'Joy of film watching': Rajamouli

Los Angeles: "Where will I put my trophy? In my heart!" With these words S.S. Rajamouli ended his chat with 'The Hollywood Reporter' on the Golden Globes red carpet.

Looking very patrician in his black dhoti and kurta, with a red-bordered back shawl, Rajamouli responded to the anchor reacting to the scenes at LA's iconic Chinese Theatre the previous night, where the audience started dancing to 'Naatu, Naatu' on the aisles.

"Isn't that great? To take the audience out of their seats and make them dance," Rajmouli said. "I think it comes from the joy of film watching."

He noted: "I don't think America has ever seen that kind of reaction from the audience. Back in India we do. ... Humans are humans across the globe wherever they are."

All flights grounded across US after massive computer outage

All flights across the US currently remain grounded after a huge computer outage left the passengers stranded, international media reported.

Passengers have been left waiting on the tarmac after the Federal Aviation Administration (FAA) suffered a nationwide system error, which has left flights grounded indefinitely, Mirror reported.

The system, critical for relaying essential information to flights, has been out since Monday evening, and it's now starting to affect services in and out of the US, as per the reports.

The FAA notified that the system was down via an Air Traffic Control System Command Center (ATCSCC) advisory, stating that the US



NOTAM system failed at 20:28 UTC. It said that technicians were working to restore the system, but that there was no estimated time for the resolution of the problem, media reports said.

According to the Air Traffic Control System Command Center: "The NOTAMS outage continues with no cur-

rent estimate time of restoration. A hotline has been activated." Bettina Inclan, who has been left waiting at Ronald Reagan Washington National Airport, tweeted: "Update from our United pilot - The down system doesn't let him check flight plans and follow federal regulations," Mirror reported.

World Bank downgrades 2023 global growth forecast to 1.7%

Global economic growth is projected to slow to 1.7 per cent in 2023, 1.3 percentage points below the forecast made in June last year, marking its third-weakest pace in nearly three decades, the World Bank Group said in its latest Global Economic Prospects report.

Given such adverse shocks as high inflation, rising interest rates, sluggish investment and the Russia-Ukraine war, global growth has slowed "to the extent that the global economy is perilously close to falling into recession", Xinhua news agency quoted the report as saying.

The downgrade reflected "synchronous policy tight-



ening aimed at containing very high inflation", as well as deteriorating financial conditions, declining confidence and energy supply disruptions, it said.

Noting that the adjusted global growth forecast is overshadowed only by the

2009 and 2020 global recessions, the report said in 2024, the global economy is on track to grow by 2.7 per cent.

More specifically, the report said that growth for advanced economies is projected to slow to 0.5 per cent in 2023, 1.7 percentage points below the June forecast.

US economic growth has been downgraded by 1.9 percentage points to 0.5 per cent, the weakest performance outside of recessions since 1970.

The Eurozone economy is projected to grow at 0 per cent, down 1.9 percentage points from the previous forecast.

Meanwhile, the report said that growth for emerging and developing economies is projected to slow to 3.4 per cent in 2023, 0.8 percentage points below the June forecast.

It added that global trade volume will grow 1.6 per cent this year, down 2.7 percentage points from the previous forecast.

KHEMKA GETS 55TH TRANSFER IN 31 YEARS

Chandigarh:

The Haryana government has transferred senior IAS officer Ashok Khemka for the 55th time in his career of 31 years. Khemka, Additional Chief Secretary in the Science and Technology Department, has been posted as Additional Chief Secretary, Archives Department. The 1991-batch IAS officer's transfer comes days after he wrote to Chief Secretary Sarvesh Kaushal, saying he did not have enough work with the merger of his Science and Technology Department into the Higher Education Department. In the letter, he indicated that the workload in the Science and Technology Department "was not more than two-three hours per week", said a communication by him.



Cold wave conditions likely in northern, central states after January 14: IMD

The IMD said that cold day to severe cold day conditions are very likely to continue in some parts of Uttar Pradesh on January 11, while cold day conditions are also very likely to continue in isolated pockets over Uttarakhand, Punjab, Haryana, Chandigarh and Delhi on January 11 and over Bihar on January 11-13.

The India Meteorological Department on Wednesday predicted cold wave conditions after January 14 for central and northern parts of the country.

The cold wave conditions are very likely in isolated pockets over Punjab, Haryana, Chandigarh and Delhi and Rajasthan on January 15, 16, said the IMD.

It also added that a fresh spell of dense to very dense fog is very likely in isolated pockets during night and morning hours over Punjab and Haryana, Chandigarh and Delhi during January 14-16.

The gradual rise in mini-



mum temperatures by 2-4 degrees Celsius is very likely over many parts of East India during next three days and no significant change thereafter. Gradual rise in minimum temperatures by

2-3 degrees Celsius is very likely over many parts of Central India during next three days and fall by 2-4 degrees Celsius thereafter", said the IMD.

However, it added that no

significant change is likely in minimum temperatures over Gujarat state during next 24 hours and gradual fall by 3-5 degrees Celsius thereafter.

The IMD said that due to

continuation of prevailing light winds and high moisture near surface over Indo-Gangetic plains, dense to very dense fog is very likely to continue in some parts during night and morning hours over Uttar Pradesh and Bihar during next 24 hours and in isolated pockets for subsequent four days.

"Dense fog is very likely in isolated pockets during night and morning hours over Uttarakhand, Punjab, Haryana, Chandigarh and Delhi, West Madhya Pradesh during next 24 hours. Dense fog very likely to continue in isolated pockets over Sub-Himalayan West Bengal, Assam and Meghalaya and Tripura during next 48 hours", the IMD said.

March against politics of fear and hatred: Rahul Gandhi

Congress leader Rahul Gandhi, spearheading the Bharat Jodo Yatra, on Wednesday said the march was against the politics of fear and hatred promoted by the BJP and the RSS, and their attempt to divide India on the lines of religion, caste and language.

"That is not our history", he said, "our history is of love, mutual brotherhood and unity among people". Addressing a public meeting before beginning the Punjab leg of the march, Gandhi said he felt humbled to have visited the site of the martyrdom of the two young sons of Guru Gobind Singh, who chose to lay down their lives in the fight against injustice and intolerance.

He also thanked the people and the party workers for participating in the yatra so early in the morning despite the biting cold.

Drawing a clear, ideological distinction between the BJP and the Congress,



Gandhi said, "while they (BJP) practice the politics of hatred, violence and fear, we practice the politics of love, unity and brotherhood". Gandhi said in the journey of about 3,000 km so far, he had met diverse sections of the people, including farmers, traders, small shopkeepers, labourers, unemployed youth and students. "The purpose of this yatra is to listen to people rather than telling our own point of view."

Former Aam Aadmi Party

MP from Patiala, Dharamvir Gandhi, and film actress Jonita Dhoda also joined the yatra.

Gandhi also interacted later with senior ex-servicemen and a panel of Punjabi historians, economists, sociologists, and agricultural experts.

He was on the 117th day of the Bharat Jodo Yatra that began in Kanyakumari on September 7, 2022, and will culminate with the hoisting of the tricolour in Srinagar on January 30.



'MUSLIMS MUST ABANDON THEIR BOISTEROUS RHETORIC OF SUPREMACY', SAYS RSS CHIEF

Rashtriya Swayamsevak Sangh (RSS) Sarsangchalak Mohan Bhagwat said in a recent interview that 'there is no harm to Muslims living today in Bharat, but at the same time, Muslims must abandon their boisterous rhetoric of supremacy'.

In a comprehensive interview with RSS mouthpiece 'Organiser', Bhagwat extensively talked about many issues, including why Hindu society is becoming more aggressive about its faith, beliefs and values.

He said that the newfound aggression among Hindus is a result of their awakening to the reality that they have been at war for over a thousand years.

"The simple truth is this is Hindusthan and it should remain Hindusthan. There is no harm to the Muslims living today in Bharat. If they wish to stick to their faith, they can. If they want to return to the faith of their ancestors, they may. It is entirely their choice," Bhagwat said.

Speaking further on the issue, he said that there is no such stubbornness among Hindus.

"Islam has nothing to fear. But at



the same time, Muslims must abandon their boisterous rhetoric of supremacy. We are of an exalted race; we once ruled over this land, and shall rule it again; only our path is right, rest everyone's is wrong; we are different, therefore we will continue to be so; 'we cannot live together' -- they must abandon this narrative. In fact, all those who live here -- whether a Hindu or a Communist -- must give up this logic," Bhagwat said.

Talking about Hindu society, Hindu dharma and Hindu culture, Bhagwat said, "It is natural for those at war to be aggressive. The Hindu society has been at war for over 1,000 years - this fight has been going on against foreign aggressions, foreign influences and foreign conspiracies. The Sangh has offered its support to this cause, so have others. There are many who have spoken about it. And it is because of all these that the Hindu society has awakened. It is but

natural for people at war to be aggressive."

Speaking further on the issue, the RSS chief said, "So there is a war to defend the Hindu society, Hindu dharma and Hindu culture. Foreign invaders are no longer there, but foreign influence and foreign conspiracies have continued. Since this is a war, people are likely to get overzealous. Although this is not desirable, yet provocative statements will be uttered."

Bhagwat also said that Lesbian, Gay, Bisexual and Transgender (LGBT) people have a right to live and deserve social acceptance.

"This is biological, a mode of life. Now there is much fuss over the issue; but we will have to acknowledge this too. We want them to have their own private space and to feel that they too are part of the society," Bhagwat said.

"The LGBT issue is not a new one; they have always been there. These people also have a right to live. Without much hullabaloo, we have found a way, with a humane approach, to provide them social acceptance, bearing in mind that they are also human beings with an inalienable right to live," he added.

If govt feels victims are entitled, pay them, SC tells Centre in Bhopal gas tragedy case

The Supreme Court on Wednesday told the Central government it was not prohibited from granting relief to the Bhopal gas tragedy victims, and it cannot absolve from itself from the welfare state principle saying that its stand was that it "take it from them (successor firms of Union Carbide Corporation) (and) "as and when taken from them", it will pay.

A five-judge constitution bench headed by Justice Sanjay Kishan Kaul and comprising Justices Sanjeev Khanna, Abhay S. Oka, Vikram Nath and J.K. Maheshwari, grilled Attorney General R Venkataramani, representing the Centre, as to how could it file a curative petition without filing the review.

The bench told the AG that the central government was not prohibited from granting relief to the Bhopal gas tragedy victims.

It said: "Their (successor firms of Union Carbide Corporation) argument is that you are opening the whole thing. You said we are not opening the whole thing... you are saying accept more liability. If they are willing, then no problem, but they are saying 'No you chose to enter into a settlement, not under any duress or pressure that is nobody's case, can't be.'"

The bench further added that if the government feels victims are entitled to be paid more, "please pay them... the question is what we should do in curative petition... Pay them, most welcome to do".

The bench told the AG as a welfare society "if you are so concerned you want to pay more; you should have paid more".



As the AG replied that if Union of India was delinquent, then all these questions would have been answered, but somebody else is delinquent, the bench said: "No, absolutely no... you as a welfare state adopt a different principle whatsoever, whether you are liable or not."

Justice Kaul said, "I am saying, is it I don't want to pay but I can get it from...". The AG then said the question is who should back the liability to pay.

The bench said: "Have you paid them extra, you want to absolve yourself from the welfare state principle, and want to say I will take it from them, as and when taken from them, I will pay." The top court is hearing a curative petition filed by the Centre in December 2010 for enhanced compensation for the victims of Bhopal gas tragedy. On Tuesday, the apex court had pulled up the Centre for pursuing its curative plea seeking an additional Rs 7,844 crore from successor firms of Union Carbide Corporation (UCC) for giving compensation to the victims of the Bhopal gas tragedy. The hearing in the matter will continue on Thursday.

Fresh worry of Shiv Sena-UBT as Thackeray's term as party chief ends on Jan 23

Over seven months after a split, the Shiv Sena-UBT is beset with a fresh worry as the five-year tenure of party President Uddhav Thackeray is slated to end on January 23.

Sena-UBT MP Anil Desai said that the party has written to the Election Commission seeking permission to hold organisational elections including of the President and its national executive.

"Our lawyers have sought the ECI's clearance to conduct the intra-party elections before the end of Thackeray's term as party chief. If the ECI has any reservations to this, then it should extend his tenure as party President until a final decision is taken," he said. After the split in June,



the Shiv Sena-UBT and the Balasahebchandra Shiv Sena are currently engaged in a bitter dispute before the EC for the party name (the original 'Shiv Sena') and its iconic symbol (Bow and Arrow). Owing to

certain exigencies, in October 2022, the ECI had given new names and symbols to the two factions - Shiv Sena-UBT got the symbol of a Flaming Torch and the BSS of 'Two Swords & Shield'.

6 KILLED IN UP AS DUMPER DRIVES INTO TEA STALL

Rae Bareilly: Six people were killed and four others injured when a dumper rammed into a kiosk in Gurbuxganj area of Uttar Pradesh's Rae Bareilly district on Wednesday.

A police spokesman said that the accident took place on the Banda-Bahraich highway when due to the dense fog and poor visibility, the dumper rammed into the roadside tea point.

"Ten persons sitting in the kiosk were mowed down by the dumper of which six died on the spot," the police said. The deceased have been identified as Lallai, Lallu, Ravindra, Vrindavan and Shiv Mohan. "Ashok Bajpai, Ram Prakash Tiwari, Dipendra Lodhi and Shrawan Lodhi sustained serious injuries in the incident and have been admitted to the district hospital," the police said.

Air India 'pee-gate' Delhi court denies bail to accused

Delhi court on Wednesday denied bail to Shankar Mishra, who is accused of urinating on an elderly female co-passenger, while in a drunken state, on a New York-New Delhi flight in November last year.

Metropolitan Magistrate, Patiala House courts, Komal Garg, who had reserved the verdict earlier, rejected the plea, saying that the alleged act of accused of relieving himself upon the complainant is "utterly disgusting and repulsive" and the act itself is sufficient to outrage the modesty of a woman. "The egregious conduct of the accused has shocked the civic consciousness and needs to be deprecated," it said, noting that the accused was voluntarily drunk and had consumed alcohol during the



flight and the said fact has not been denied by him. "It has also come on record that accused has tried contacting the victim and the possibility of accused influencing the witnesses

cannot be ruled out. Further, as per the report of the IO, the other witnesses are yet to be interrogated and the investigation is at a very initial stage," the court said.

CBI raids 50 locations in FCI-linked corruption case; recovers Rs 60L

The CBI has been working on a specific input which suggested that corrupt methods were underway in the FCI.

On Tuesday, the CBI had arrested a deputy general manager Rajeev Kumar Mishra when he was about to accept a bribe of Rs 50,000 from one Ravinder Singh Khera in Punjab.

The CBI said that two days ago, it had lodged an FIR in connection with the case against 74 people including government officials, private entities, agents and mills owners. Raids are currently underway in Delhi, Punjab and Haryana.

Two locations in Delhi are being raided by senior CBI officials while in Punjab, raids are going on in Ludhiana, Patiala and Amritsar.

DELHI GOVT NOTIFIES REVISED FARE FOR AUTO AND TAXIS



New Delhi: The Delhi government on Wednesday notified the revised fare for auto rickshaws and taxis in the city.

The revised fare approved for auto rickshaw for, meter down fare for initial 1.5 km has been increased to Rs 30 from Rs 25 earlier, while the per kilometre fare has been increased to Rs 11 from the earlier Rs 9.50. However, the night charge from 11 p.m. to 5 a.m. will be same 25 per cent extra.

The revised fare approved for taxis for meter down fare for initial 1.5 km has been increased to Rs 40 for both AC and non-AC, from Rs 25 for both, while the per kilometre fare for non-AC been increased to Rs 17 from earlier Rs 14, while for AC cabs, it will now be Rs 20 from earlier Rs 17. However, the night charge from 11 p.m. to 5 a.m. will be same 25 per cent. The last revision in the auto rickshaw fares happened in 2020 while that for taxis, including black and yellow Taxis, economy taxis and premium taxis, happened nine years back in 2013.

Self-styled godman jailed in Haryana for abusing 100 women

A fast-track court in Haryana has sentenced a self-styled godman to 14-year jail for sexually abusing about 100 women.

Fatehabad, Balwant Singh, convicted Billu Ram, a.k.a. Amarपुरi, a.k.a. Jalebi baba, on January 5. The quantum of punishment was awarded on Tuesday. The court also slapped a fine

of Rs 35,000 on him. He was booked under various sections of the Indian Penal Code (IPC), the PoCSO Act and the IT Act on the complaint of the then SHO of the Tohana police station on July 19, 2018. The SHO in the complaint said he got a video on the mobile phone in which the accused was seen abusing women sexually. Later, the police found 120 videos of the accused in which he was seen abusing women.

Poverty, debt burden drive ex-U-16 Bengal cricketer to suicide

Rohit Yadav, a member of the U-16 Bengal cricket team for the 2019-20 season, has committed suicide at his ancestral residence in Howrah district on Wednesday.

His stiff body was discovered on the bed of his room by his family members on Wednesday morning. The body was immediately rushed to a local hospital where he was declared brought dead.

After initial investigation, the local police believe that the young cricketer probably committed suicide by consuming poison. His body has been sent for autopsy following which the exact reason of death would be ascertained.

His family members claimed that lack of funds to pursue his



cricketing career coupled with huge debt from the market pushed him to depression, due

to which he may have committed suicide. According to the family mem-

bers, Rohit took loans from his acquaintances for the purpose of purchasing sports goods.

However, since his family did not have any steady source of income, he was unable to repay the loans and as a result the lenders started putting pressure on him. His family members claimed that to repay the debts, Rohit resorted to fresh lending from other sources, which led him to a debt trap.

It is learnt that he appeared restless for the last couple of days, but none of his close associates and friends could imagine that this would finally prompt him to take the extreme step.

Rohit was first included in the 35-member U-16 squad of the Cricket Association of Bengal (CAB), and later he even made his room into the playing XI.

'IT MIGHT TAKE 5 YRS TO COMPLETE TRIAL', JUDGE TELLS SC IN LAKHIMPUR KHERI CASE

A trial court in Uttar Pradesh, which is hearing the Lakhimpur Kheri violence case, has informed the Supreme Court that it might take five years to complete the trial in normal course. The cases involve Ashish Mishra as the prime accused, who is son of Union minister Ajay Kumar Mishra.

A bench comprising Justices Surya Kant and V. Ramasubramanian noted that the sessions judge says that in normal course, it may take five years. The sessions judge, in a letter sent to the apex court, said there are 208 prosecution witnesses, 171 documents, and 27 forensic science laboratory (FSL) reports in the case. The top court was hearing a bail plea filed by Ashish Mishra. During the hearing, the top court asked the Uttar Pradesh government counsel to confirm whether four accused in a separate case lodged over the killing of three occupants of the car, which allegedly mowed down farmers, are still in custody.



Vivek Kumar Dewangan discussed in detail about the opportu-

nities, difficulties, challenges and solutions in the field of renewable energy. They appraised about their projects. Queries and doubts were resolved after the session. MoUs signed MoUs worth Rs. 16,000 crore were signed in the presence of Energy Minister Pradyuman Singh Tomar, New and Renewable Energy Minister Hardeep Singh Dang, Energy Development Corporation Chairman Girraj Dandotia. Two killed, 11 injured as truck collided with a bus

1 child or youth died every 4.4 seconds in 2021

More than 5.0 million children under age 5, including 2.3 million newborns, along with 2.1 million children and youth aged 5 to 24 years -- 43 per cent of whom are adolescents -- died in 2021, according to a report released by the UN Inter-agency Group for Child Mortality Estimation. The global under-5 mortality rate fell by half since the start of the century, while mortality rates in older children and youth dropped by 36 per cent, and the stillbirth rate decreased by 35 per cent. However, gains have reduced significantly since 2010, and 54 countries will fall short of meeting the Sustainable Development Goals target for under-5 mortality. Unless swift action is taken to improve health services, almost 59 million children and youth will die before 2030, and nearly 16 million babies will be lost to stillbirth, warn the agencies. Children born in sub-Saharan Africa are subject to the highest risk of childhood death in the world -- 15 times higher than the risk for children in Europe and Northern America. Mothers in these two regions also endure the painful loss of babies to stillbirth at an exceptional rate, with 77 per cent of all stillbirths in 2021 occurring in sub-Saharan Africa and South Asia. Nearly half of all stillbirths happened in sub-Saharan Africa. The risk of a woman having a stillborn baby in sub-Saharan Africa is seven times more likely than in Europe and North America, the reports show. Similarly, more than 40 per cent of stillbirths occur during labour, most of which are preventable when women have access to quality care throughout pregnancy and birth. For children that survive past their first 28 days, infectious diseases like pneumonia, diarrhoea and malaria pose the biggest threat, according to the reports.

RELIEF RALLY IN THE OFFING - EXTENT OF SAME DEBATABLE



Trading in the calendar year began on a positive note with markets gaining on the first two trading sessions. They lost ground on the next three sessions with Friday witnessing a sharp sell-off.

BSESENSEX ended the week with losses of 940.37 points or 1.55 per cent to close at 59,900.37 points while NIFTY lost 245.85 points or 1.36 per cent to close at 17,859.45 points. The broader markets saw BSE100, BSE200 and BSE500 lose 1.32 per cent, 1.25 per cent and 1.17 per cent respectively. BSEMIDCAP lost 0.58 per cent while BSESMALLCAP lost 0.50 per cent.

The India Rupee remained unchanged at Rs 82.72 to the US dollar. Dow Jones began the new year on a negative note and lost on the first trading day. It then gained, lost and had a sharp rally on Friday, gaining a massive 700 points. The week ended with gains of 483.36 points or 1.46 per cent at 33,630.61 points. There was one listing of a primary market issue from Radiant Cash Management Services Limited during the week. This issue had a poor response during subscription and the size of issue was reduced. The fresh issue which was for Rs 60 crore was reduced to Rs 54 crore, while the offer for sale of 331.25 lakh shares was reduced to 212.22 lakh shares. Further, even though the anchors were allotted shares at the top end of the price band of Rs 99, the remaining investors were allotted at the lower end of the price band of Rs 94. Merchant bankers were also allotted shares as part of their underwriting arrangement.

The share debuted on the bourses on Wednesday at Rs 99.30, a gain of Rs 5.30 or 5.63 per cent. They closed even higher at Rs 104.70, a gain of Rs 10.70 or 11.38 per cent. At the end of the week shares closed at Rs 107.95,



a gain of Rs 13.95 or 14.84 per cent. The better performance of the share post listing is to do with the lower IPO size and it becoming imperative for the merchant bankers to justify their pricing and valuation for the company.

The IPO market has taken a break temporarily and is likely to become active after the celebration of the India festival, "SANKRANT" also popular for kite flying on 15th of January. One should see a sudden rush of IPOs post this day into the week ending just before the Union

Budget is presented on Wednesday, the 1st of February. Parliament session would begin a day earlier on the 31st of January.

The week ahead would see a spate of results from the IT pack with TCS declaring results on Monday the 9th of January, HCL Tech and Infosys on Thursday the 12th of January and Wipro on Friday the 13th of January. This would give a good indication of what's happening in the IT space with cost pressures or pricing pressures and new order wins.

During the course of the last couple weeks of trading, the market seems to be making lower tops which is a bearish signal by itself. If one recalls, the lifetime highs were made on the 1st of December 2022. These were at levels of 63,583 on BSESENSEX and 18,887 on NIFTY. The next two lower tops were made on 14th December at 62,835 and 18,632 points respectively. The third and final one was made last week on 3rd January at 61,343 and 18,265 points. It is

therefore imminent that if this bearish pattern is to be negated, we need to cross these levels at the very outset.

Monday would see our markets rising sharply on the back of positive news flow from the US as far as job data and possibility of interest rate hike not being as quick as anticipated happening. At the same time, one must remember that FPI's have been sellers over the last 11 consecutive days. Would they use the buoyancy on Monday to press further sales or turn positive? Not sure.

Coming to the markets in the week ahead, as already mentioned they would open positive on Monday. How much and how far this rally would go is debatable.

For the ensuing rally to be sustainable and meaningful, markets need to cross the first hurdle of the previous top of 61,343 and 18,265 and sustain them. Any failure to do so would result in further pressure as we would have made yet another lower top. On the support side, strong support does exist at levels of 59,650-59,750 and 17,770-17,800 levels. Any violation of these levels could lead to a further fall of 0.5 per cent to 1 per cent which could be a swift one. My gut feel for the moment is that currently neither the breakout or the breakdown looks likely in the coming week. The strategy should be to sell on rallies and keep a sharp lookout on US markets for news flow. Finally, budget expectations could start being talked about in another ten days' time when the present rally or move is over. Trade cautiously.

Originated from Pakistan, deadly shipment of uranium seized at Heathrow airport

London | Agencies

Counter-terror cops and security services in the UK have launched a probe after a deadly shipment of uranium was seized at London's Heathrow airport, a media outlet reported. The undeclared nuclear material can be used in a dirty bomb.

It was destined for Iranian nationals in the UK, originated from Pakistan and arrived on a flight from Oman, The Sun reported.

A source said: "The race is on to trace everyone involved."

The package, suspected of being smuggled to UK-based Iranians, arrived in the hold of a passenger jet.

Specialist scanners detected the potentially lethal uranium as it was ferried to a



freight shed, triggering alarms.

Border agents swooped and isolated the unregistered shipment in a dedicated radioactive room.

Counter-terror police were alerted and a security probe launched into who sent the cargo.

It originated from Pakistan and arrived at Terminal 4 on an Oman Air jet from Muscat, The Sun reported.

Cops were understood to be targeting an Iran-based firm with UK premises where the material was due to go to mystery recipients. No arrests have been made.

Extreme weather events cause \$270bn loss in 2022: Report

Hurricanes, floods and other natural disasters inflicted \$270 billion in damage worldwide in 2022, less than the "extremely costly 2021" with \$320 billion, a German reinsurer said in a report. "2022 joins the recent run of years with high losses," the report by Munich Re said.

The costliest natural disaster in 2022 was Hurricane Ian in the US, which caused losses of around \$100 billion, Xinhua news agency cited the report as saying.

"Climate change is taking an increasing toll," Thomas Blunck, member of the Board of Management of Munich Re, said in a statement.



The natural disaster figures for 2022 were dominated by events that were more intense or occurred more frequently, he added.

The second costliest and greatest humanitarian disaster in 2022, with at least 1,700 deaths, was the severe flooding in Pakistan resulting from a "record-breaking monsoon rainfall". Rainfall there in

August was five to seven times heavier than usual, and accelerated glacier melt due to high temperatures "significantly increased the flooding", the report said.

In many countries in Europe, the summer of 2022 was marked by extreme heat and drought followed by severe thunderstorms. In France as well as in parts of Spain,

heavy storms brought "hailstones the size of tennis balls" that caused losses in the billions.

Germany also saw an "exceptional year for weather" and logged one of the two warmest years on record, the National Meteorological Service (DWD) said.

Temperatures were 2.3 degrees Celsius above the value of the internationally valid reference period (1961-1990).

As a result, the river Rhine, Europe's busiest waterway, saw water levels fall to record lows, forcing ships to carry less cargo.

"It is difficult to quantify the indirect economic consequences of climatic events like these," Munich Re said.

FOUR KILLED IN MASSIVE FIRE IN IRAN

Tehran: A massive fire that broke out in a company in Iran's northern province of Qazvin killed at least four people and injured two others, Iranian Students' News Agency (ISNA) reported. The victims were employees of the company in the industrial city of Alborz, Amir Hosseinpour, general manager of Elvand municipality's fire department and safety services, was quoted by ISNA as saying on Tuesday. The two injured men, who were hospitalised, sustained 60 per cent of burn injuries, said Hassan Esmaili, the Head of the Qazvin Provincial Medical Emergency and Accident Management Centre as quoted by Xinhua news agency report. The fire, which had been put out, caused property damage to the company, but its nearby buildings were spared, said Hosseinpour. Firefighters were working to clean up the area, while the cause of the accident was under investigation, Hosseinpour added.

Indian-American reality show star gets 78 months jail for wire fraud

An Indian-American reality TV star has been sentenced to 78 months in prison for running a nationwide telemarketing fraud scheme that targeted "vulnerable, elderly victims".

Jennifer Shah, 49, who starred in 'Real Housewives of Salt Lake City', previously pled guilty to one count of conspiracy to commit wire fraud in connection with telemarketing.

In addition to the prison term, Shah of Salt Lake City, Utah, has also been sentenced to five years of supervised release.

The court ordered her to forfeit \$6,500,000, 30 luxury items, and 78 counterfeit luxury items, and to pay \$6,645,251 in restitution.

"With today's sentence, Jennifer Shah finally faces the consequences of the many years she spent targeting vulnerable, elderly victims," Attorney Damian Williams said in a statement last week.

These individuals were lured in by false promises of financial security, but in reality, Shah and her co-conspirators defrauded them out of their savings and left them with nothing to show for it.

"This conviction and sentence demonstrate once again that we will continue to vigorously protect vic-



tims of financial fraud and hold accountable those who engage in fraudulent schemes," Williams said.

According to court documents, from at least 2012 until her arrest in March 2021, Shah was an integral leader of a wide-ranging, nationwide telemarketing fraud scheme that victimised thousands of innocent people.

The scheme principally involved selling those victims so-called "business services" in connection

with the victims' purported online businesses (the "Business Opportunity Scheme").

Shah knowingly and intentionally facilitated the sale of "leads" a contact information for potential victims who had been identified as susceptible to the scheme's lies -- to sales floors that were perpetrating the Business Opportunity Scheme and, during the latter portion of her participation in the scheme, owned and operated one of the sales floors that was part of the scheme, the court noted.

Many of Shah's victims were elderly or vulnerable, and suffered significant financial hardship and damage, a US attorney office statement said.

The victims were defrauded over and over again at Shah's direction until they had nothing left. She and her co-conspirators persisted in their conduct until the victims' bank accounts were empty, their credit cards were at their limits, and there was nothing more to take.

The reality show star took a series of increasingly extravagant steps to conceal her criminal conduct from the authorities -- she directed others to lie, she put businesses and bank accounts in the name of others, she required payment in cash, she instructed others to delete text messages and electronic documents, etc.

BIDEN 'SURPRISED' TO LEARN CLASSIFIED DOCUMENTS TAKEN TO HIS PRIVATE OFFICE

US President Joe Biden said he was "surprised" that classified documents from when he was Vice President in the former Barack Obama administration, were taken to one of his former private offices.

"I was surprised to learn there were any government records that were taken there to that office," Xinhua news agency quoted Biden as saying reporters in Mexico City where he had a trilateral summit with the leaders of Mexico and Canada.

The President said he doesn't know "what's in the documents" that were found in a locked closet when his attorneys were vacating office space at the Penn Biden Center in Washington, D.C.

The Penn Biden Center is a think tank about a mile away from the White House, affiliated with the University of Pennsylvania and named for Biden who had served as the Vice President from January 2009 to January 2017.




White House special counsel Richard Sauber issued a statement on Monday, saying that Biden periodically used this space from mid-2017 until the start of his 2020 presidential campaign.

This discovery of "what appears to be Obama-Biden Administration records, including a small number of documents with classified markings" was made in early November of 2022, according to the statement.

"They found some documents in a box in a locked cabinet, or at least a closet. And as soon as they did, they realised there were several classified documents in that box," Biden said on Tuesday.

The attorneys "did what they should have done" by immediately calling the National Archives, he added.

The classified documents found inside the Penn Biden Center closet are reportedly US intelligence memos and briefing materials that covered topics including Ukraine, Iran and Britain.




MAHA TOPS, GUJARAT 2ND IN CARE RATINGS ON PERFORMANCE

Maharashtra tops the overall ranking list prepared by credit rating agency CARE Ratings scoring high on social, financial inclusion, and fiscal categories. It is followed by Gujarat with second rank faring well in economic and fiscal categories, while Tamil Nadu ranks third with an edge in social and governance categories, CARE Ratings said.

According to CARE Ratings, the rankings are based on seven pillars -- economic, fiscal, social, infrastructure, financial inclusion, environment, and governance -- and covers 46 indicators to rank the major states in the country. The ranking report attempts to provide a comprehensive quantitative evaluation of states' performance.

"The State Ranking study is aimed at capturing the comprehensive performance of the states. This study highlights the areas in which the various states have shown healthy performance and the areas which need further attention of the policymakers.



Maharashtra, the financial capital of the country, tops the ranking with a favourable score not just in financial inclusion but also for the state government finances and social indicators. In this comparative study, the leading states could offer the others a model to follow," said Mehul Pandya, Managing Director and CEO, CARE Ratings.

While the Union Territories were excluded from the study, CARE Ratings had the states into two categories -- Group A (large states) and

Group B (Northeast, hilly and small states).

The comprehensive coverage is consistent with shifting viewpoints around the world, where reducing income disparity, governance, environmental protection, and sustainability are becoming increasingly important, CARE Ratings said.

"We have looked at the performance of the states not just in terms of economic growth, physical infrastructure and investment, but also given due importance to social indicators,

environmental aspects, governance and financial inclusion. This is with the recognition that inclusive and sustainable growth is the need of the hour.

"As expected the top few ranks have been taken by the Western and Southern states. Western states have scored high on the fiscal and economic category, while southern states have outperformed in the social and environmental category," said Rajani Sinha, Chief Economist, CARE Ratings.

Among the northeastern states, Sikkim leads due to better scores in economic, social, infrastructure and environment categories.

As expected, Maharashtra topped in financial inclusion with best performance in credit/GSDP ratio, NBFC sanctions and health insurance penetration. It also fared well in mutual fund penetration.

According to the study, the Southern states topped in environment due to relatively favourable performance in terms of air quality, solid waste management, forest cover and renewable installed capacity.

Bombay HC quashes FDA order, allows J&J to produce baby powder

The Bombay High Court on Wednesday quashed the Maharashtra FDA's order cancelling the licence of pharma giant Johnson & Johnson to manufacture its baby powder from the Mulund plant.

A division bench of Justice Gautam S. Patel and Justice Shivkumar G. Dige termed the Food & Drugs Administration's action as unreasonable and therefore "arbitrary" - while setting it aside, paving the way for J&J to resume production and sell its baby powder.

It observed that it is not reasonable that the moment one sample from a batch is found to be of substandard, the company's manufacturing licence is cancelled.

"This seems to us to be extreme and there's nothing to show that FDA has consistently adopted such a stringent standard with other J&J products or other manufac-



turers," said the judges. In a drastic move on September 15, 2022, the FDA Joint Commissioner had cancelled J&J's licence to manufacture baby powder products and also told the company to recall its market stocks, after which the company challenged the decision in the high court.

Observing that while a watchdog like FDA is necessary, Justice Patel and Justice Dige said that proceedings

cannot be protracted with a "harsh delay" like this for weeks and months, and the watchdog must do its job properly to guard and protect the interests of the consumers.

The judges also frowned at "the now usual excuse of Covid" on the delays for a test on a sample collected in October 2018 - well before anyone could imagine Covid - and the delays continued until 2022.

Arya Chandorkar wins Children II category at National Show Jumping

ED RAIDS NCP LEADER HASAN MUSHRIF, FAMILY, AIDES ON CORRUPTION CHARGES

In a dawn swoop on Wednesday, the Enforcement Directorate (ED) raided the home and certain locations linked to senior Nationalist Congress Party (NCP) leader Hasan Mushrif, his family members and some other persons in Kolhapur and Pune for alleged charges of corruption and money laundering.

The simultaneous raids, carried out at 7 locations in the two cities, came after Bharatiya Janata Party (BJP) ex-MP Kirit Somaiya hurled various allegations of financial irregularities against Mushrif.

He has also accused the NCP leader and his associates of corruption and money laundering of hundreds of crores pertaining to deals through defunct companies, grabbing a sugar mill, besides amassing huge properties,



etc. Teams of around two dozen sleuths swarmed at Mushrif's home in Kagal town of Kolhapur around 6 a.m., and other places connected with the NCP leader, amid tight security, confiscated certain documents and other evidence, and the raids continued for over 12 hours. On the radar of the probe agencies for some time, Mushrif, 68, has vehemently denied the accusations and wondered if the "people of a particular community are being targeted". "No notice or intimidation

was given. We were all raided by the IT Department even four years ago. We have provided all the information. I have repeatedly said that I have nothing to do with all this, the companies, the factories or the persons as alleged," he said.

The former BJP lawmaker cited several instances and reeled off figures of alleged financial deals involving Mushrif, his associates, officials and others through shell or bogus companies, and how the funds were reportedly routed for other illegal deals worth hundreds of crores of rupees. Among other things, Somaiya has charged Mushrif of grabbing control of the Appasaheb Nalawade Gadhinglaj Cooperative Sugar Mill Ltd, huge payoffs and money-laundering of massive amounts through murky transactions which benefited him, his family or associates.

SANJAY RAUT'S JIBE AFTER PROBE AGENCY RAIDS ON SHARAD PAWAR'S PARTY LEADER

Mumbai: Shiv Sena (UBT) leader Sanjay Raut today dubbed "pressure politics" the Enforcement Directorate's action against former Maharashtra minister and NCP MLA, Hasan Mushrif.



The Central agency conducted searches at multiple premises in Maharashtra as part of a money laundering investigation against Mushrif and others. The raids are understood to be linked to a probe related to alleged irregularities in the operations of some sugar mills based in the state that are linked to Mushrif, officials said. "This action is pressure politics but Mushrif will come out of this phase," Raut told reporters. He said Mushrif is a leader from the Opposition who is putting up a fight which is against a particular ideology. "Be it me, Anil Deshmukh or Nawab Malik (who all were arrested by ED in separate cases)...some BJP leaders had talked about putting Hasan Mushrif behind bars. Such language was used against Bhavana Gawli (MP), Yeshwant Jadhav (both members of the Eknath Shinde faction of Shiv Sena) and many important leaders who are part of the government now. "But they get relief and those in Opposition are facing pressure politics," Raut said, adding Mushrif is a fighter and the entire Opposition is with him.

No pre-arrest bail for Shinde faction leader, wife in BJP activist attack

A court here in Maharashtra on Wednesday rejected the pre-arrest bail applications of a leader belonging to 'Balasahebanchi Shiv Sena' (BSS), his wife, and a former city corporator booked in connection with the attack on a BJP functionary last month.

Additional sessions court judge AS Bhagwat noted the applicants are not entitled for anticipatory bail currently as it could hamper the investigation.

Police on December 31, 2022, registered an FIR against ten persons, including BSS leader Vikas Repale, his wife, and an ex-corporator, for allegedly attacking BJP activist Prashant Jadhav in Thane city over putting up a banner. A cross complaint was also registered against Jadhav, who was injured in the attack and hospi-



talised.

The BSS faction is headed by Maharashtra Chief Minister Eknath Shinde who shares power with Bharatiya Janata Party, Deputy CM Devendra Fadnavis handles the Home ministry.

In their pleas seeking pre-arrest bail, the Repale couple and the ex-corporator stated they were falsely implicated in the case over politi-

cal enmity. The prosecution opposed the applications filed by the trio citing the safety of witnesses.

Advocate Makrand Abhyankar, who appeared for the complainant Prashant Jadhav, also opposed the bail applications.

"After considering the FIR, it appears the names of the applicants are prominently appearing in the FIR and specific act of violence are attributed to them along with other people. The use of weapons like sticks, iron rods, sharp weapons has also been alleged with allegations of beating on head, private parts. The alleged offence required in depth investigation and hence strong prima facie case is appearing against the applicants. "In such circumstances, grant of anticipatory bail will hamper the investigation. The applicants are not entitled for anticipatory bail," the court said.

MAN ARRESTED FOR RAPING 60-YEAR-OLD PARALYSED WOMAN

Nashik: A man in his early twenties has been arrested here for allegedly raping a bed-ridden 60-year-old woman, police said on Wednesday.

The incident took place in the Upnagar area of Nashik city early Tuesday morning, said an official.

The woman, who has suffered a paralysis attack, lives alone in her house of corrugated iron sheets and is bedridden for the last seven years. Her brother lives nearby, the police official said. Around 1 am on Tuesday, a 22-year-old man entered the house and allegedly raped her repeatedly after threatening her with dire consequences if she raised alarm. He also clicked her photographs before leaving, she said.

The woman told her brother about the incident when he came in the morning to give her tea, following which a police complaint was registered. The suspect was arrested and further probe is on, the police official added.

Thane Central Jail, saying the abatement of suicide charge was not applicable in this case. Additional sessions court judge RD Deshpande adjourned the hearing till January 13, when Khan's bail plea is likely to be decided.

In a marathon telecast that stretched over three hours, 'The White Lotus', was named best limited or anthology series for its Sicily-set second season.

Their victories came as the tarnished awards show attempted to relaunch itself as a star-studded celebration of movies

and television after being forced off the air in 2022 in the wake of a series of controversies, reports 'Variety'.

'The Banshees of Inisherin,' a comic look at the dissolution of a friendship, won a leading three prizes, including awards for its screenplay and the lead performance of Colin Farrell.

'The Fabelmans,' a warm-hearted look at Steven Spielberg's childhood, also won a directing prize for the filmmaking icon.

If the evening had a theme, it was one of reinvention and renewal.

Several of the winners described themselves as being given golden opportunities after being cut out from or overlooked by a business that failed to appreciate their talents. That included best actress in a motion picture musical or comedy winner Michelle Yeoh, an action

star turned an awards season darling with her turn in "Everything Everywhere All at Once," who talked about the ageism and racism she faced. It was a theme that was amplified by Farrell, who thanked his "The Banshees of Inisherin" writer and director Martin McDonagh for helped to rechart his career path when he cast him in the 2008 black comedy "In Bruges." And echoed by best supporting actor winner Ke Huy Quan, a former child actor who had stopped acting before he was cast as Yeoh's husband in "Everything Everywhere All at Once."

The focus of the evening was on the fantasies and fables being spun on the big and small screen alike, but glimmers of the painful reality being experienced in parts of the world managed to break through the glitz and glamour.



Zendaya wins Best actress in TV series



Murphy, says 'Variety', started with Morgan in the original 'Coming to America' and its 2021 sequel; he worked with Curtis on 'Trading Places' in 1983.

Murphy has previously been nominated for six Golden Globes, winning in 2007 for his performance in 'Dreamgirls', for which he was also Oscar-nominated.

ICC T20I batting rankings

SURYA KUMAR EXTENDS LEAD ON TOP OF THE TABLE

Dubai | Agencies

Star India batter Suryakumar Yadav, who is making a habit out of breaking records, is inching closer towards the all-time ICC men's T20I batting rankings, extending his lead on top of the table from 883 rating points to 908 in the latest update on Wednesday.

Following up his 36-ball 51 in the second T20I, Surya blasted a majestic century -- his third in six months -- in the series decider in Rajkot recently. The 51-ball 112 not out was laced with seven fours and nine sixes, not sparing an inch of the stadium with his sublime 360-degree hitting.

Unsurprisingly, he was the Player of the Match as India put on a colossal total of 228/5 and went on to register a massive 91-run win. His stunning returns in both games puts him second in the all-time T20I batters rankings, just seven rating points behind England's Dawid Malan (915). Suryakumar was placed fifth in the all-time list during the previous update of the rankings but has now leapfrogged Babar Azam (896), Virat Kohli (897) and Aaron Finch (900) over the last week, as per ICC. The right-hander batter had to wait for a long time for the India cap, making his T20I debut after turning 30. But there has been no stopping him ever since



as he has gone to rack up runs consistently at a rate not seen before. In 45 T20Is, Surya has accumulated 1578 runs at a phenomenal strike rate of 180.34, the highest for any batter with more than 250 T20I runs. In the ICC Men's T20 World Cup 2022, he finished as the third-highest run-getter with 239 runs in six matches while striking at an eye-watering 189.68.

All three of his fifties -- against South Africa, Zimbabwe and Netherlands -- proved to be crucial knocks under the cir-

cumstances and in the case of the latter two, turned the tide in favour of India.

Suryakumar will not have to wait for too long to gun for Malan's record as New Zealand are set to travel to India for a white ball tour consisting of three ODIs and three T20Is later this month. The T20I series will kick off on January 27 in Ranchi and good returns against the fifth-placed Kiwis could see Surya break yet another record, something he has made a habit of.

AUSTRALIA, INDIA PLAYERS GAIN BIG IN LATEST ICC PLAYER RANKINGS

Dubai: Australia's star performers from their Test series win against South Africa have been richly rewarded in the latest ICC Men's Test Player Rankings released on Wednesday while India stalwarts Virat Kohli and Rohit Sharma were also the big gainers in the ODI section.

Usman Khawaja was the biggest mover, following his stunning century in the third and final Test against South Africa in Sydney -- he moved up to 8th in the Men's Test batters' rankings. Performers from the drawn Test between Pakistan and New Zealand also made big gains, with Tom Latham, Devon Conway and Saud Shakeel making big moves. Meanwhile, Virat and Rohit moved up in the ODI batting rankings. Kohli, who scored a stunning century in India's victory against Sri Lanka in the first ODI in Guwahati, has moved up two spots to 6th. On the other hand, Rohit also scored an aggressive 83 and has gained a spot to sit at 8th. Sri Lankan skipper Dasun Shanaka scored a fighting ton despite his side losing and has gained 20 spots to move to 61. Meanwhile, in the bowling charts, Mohammed Siraj is the biggest gainer after scalping two wickets in the first ODI, moving up four spots to 18.

Sindhu loses to Marin; Prannoy and Satwik-Chirag pair advance

Two-time Olympic medallist PV Sindhu couldn't manage to get the winning start in 2023 as she suffered a loss at the hands of familiar foe Rio 2016 champion Carolina Marin of Spain in the opening round of Malaysia Open Super 1000 badminton tournament, here on Wednesday.

In men's singles, Prannoy overcame Commonwealth Games champion Lakshya Sen in three games, 22-24, 21-12, 21-18 in the first round. The men's doubles pair Satwik and Chirag trounced the world No. 9 Korean combination of Choi Sol Gyu and Kim Won Ho to win 21-16, 21-13.

After losing the closely fought opening game, Prannoy took the second game and was trailing 2-7 in the decider before scripting a comeback to clinch the match in one hour and 15 minutes. Prannoy, the only Indian left in the fray in the singles event, will take on Indonesian Chico Aura Dwi Wardoyo to set up a potential quarterfinal clash with second-seed local player Lee Zii Jia. Sindhu's loss ended India's challenge in the women's singles category as Malvika Bansod lost world No. 2 Korean An Se Young 9-21, 13-21.

Coming back to action after a five-month-long injury layoff, Sindhu lost 12-21, 21-10, 15-21 in her first match since the 2022 Commonwealth Games gold medal win. It was the first meeting between the Rio 2016 finalists since Marin beat Sindhu at the Swiss Open final in 2021.

The Spaniard dominated the opening game right from the start and clinched it easily 21-12. But the Indian ace bounced back in the second game with a healthy 11-5 lead at the time of the interval and quickly raced to 21-10 to force the decider. In the deciding game, Marin restored her momentum and headed into the break with an early lead and wrapped up the match with ease after the change of sides.

However, a backhand volley winner in the 4-4 game gave Badosa a breakpoint, which she converted after a wide rally backhand by



Kanepi. Kanepi, though, returned to level footing immediately, as Badosa double faulted the next game away when serving for the match. But Badosa used heavy, deep returns to reclaim her break and lead 6-5, where she successfully served out the win on the second time of asking. Badosa will next meet No.11 seed Beatriz Haddad Maia, who defeated another lucky loser, Amanda Anisimova, earlier in the day.

Rafael Nadal and Iga Swiatek named top seeds for men's, women's singles draw

With U.S. Open winner Carlos Alcaraz of Spain withdrawing due to an injury, his compatriot Rafael Nadal has been given the top billing in the men's singles draw in the Australian Open, starting in a few days.

In women's singles, Poland's Iga Swiatek, the World No. 1 in the WTA Rankings, was expectedly named the top seed with Tunisia's Ons Jabeur as the second-ranked player.

Nadal is the second highest-ranked player in the ATP Rankings and will be the top seed in the Australian Open with Norway's Casper Ruud as the second seed. The 22 Grand Slam titles winner is gunning for his 23rd title in the Majors to further widen the gap with Novak Djokovic (21).

Andrey Rublev (6th seed), Felix Auger-Aliassime (7th), Daniil Medvedev (8th), Taylor Fritz (9) and Holger Rune of Denmark complete the top 10 in the Australian Open men's singles seedings.



In the women's singles section, Jessica Pegula of the USA is seeded third followed by Caroline Garcia (4th), Aryna Sabalenka (5th), Maria Sakkari (6th), Coco Gauff (7th), Daria Kasatkina, Veronika Kudermetova (8th) and Veronika Kudermetova is ninth while Madison Keys complete the top 10 seeds for the Year's first Grand Slam.

INJURY FORCES MARIN CILIC TO WITHDRAW

New Delhi: Marin Cilic of Croatia announced his withdrawal from the year's first Grand Slam on Wednesday, due to his knee injury that ended his run of seven consecutive Australian Open appearances.

Former world no 3 sustained a knee injury last week during a warm-up ahead of his quarterfinal match at the Tata Open Maharashtra, where he was competing as a top-seed player.

The 2014 US Open champion, Cilic, is the new name on the list of players, who will miss the first Major of the year. Earlier, World No. 1 men's singles player Carlos Alcaraz of Spain has opted out of the 2023 season's first major after picking up an injury while training.



'Naaagin' 6' actress Mahekk Chahal, who was admitted to hospital in first week of January after she felt severe chest pain, is now back home.

The actress shared in detail about cough and cold led to lung infection and pneumonia. Mahekk said: "I was basically travelling a lot in December. I went to the US and was having a slight cold and cough. I just took it casually and then after coming back, I went to Delhi and despite having a cold and cough, I just kept traveling, went to Jaipur and then again back to Mumbai. I started shooting for my show 'Naagin'. I was taking warm water and Vitamin C that we usually take but never realised the seriousness of my deteriorating health."

The actress, who emerged as the winner of 'Bigg Boss 5' and also participated in the action-based reality show 'Khatron Ke Khiladi 11', revealed further on how things became worse for her in January.

She in fact, shared a video also on her Instagram handle where she talked about her health and mentioned that never take cough and cold lightly.


She added: "In January I started having pain in my chest, although normally in such a situation you feel pain in your throat, but I felt in my chest. My oxygen level went extremely down and all the symptoms were quite similar to Covid. I collapsed and was rushed to the hospital where doctor asked me to undergo a CT scan immediately."

The actress continued to recall how both of

her lungs got infected: "Then it came out that both my lungs were infected with pneumonia. And the doctor is like you will have to get oxygen because you're not able to breathe properly until I don't put you on some medication for your chest, it won't go. And then after that, I was in the hospital for more than a week."

"After nine or ten days I'm back, my mom is taking care of me and it will take time for me to recover," she concluded.

I feel that saying sorry and saying thank you are extremely vital in life. You should constantly say these words whenever you get the opportunity."


