Justice Joseph orally told a counsel, representing The News Broadcasters & Digital Association: "You (the news channels) create divisions amongst the society, or whatever opinion you want to create is much faster... "Freedom of speech, the greater the freedom the better marketplace of ideas is very good. In the marketplace of ideas we have to also see populace... are we really a fully developed country?... are the audience mature enough to receive this kind of information that is dished out. If freedom is exercised with an agenda, then you are not actually serving the people."

he Supreme Court on Friday said the television channels are creating divisions in society, as they are agenda-driven and compete to sensationalise news, and anchors who try to create divisions in the society through their programmes should be taken off air.

It emphasised that a free and balanced press is wanted in India. A bench of Justices K.M. Joseph

and B.V. Nagarathna orally observed that channels are competing against each other, they sensationalise things, and serve an agenda.

As counsel said they are guidelines for anchors, Justice Joseph asked: "How many times have you taken off anchors, have you dealt with anchors in a way you send a message, see ultimately who controls the content of the programme anchor and editorial... if anchor himself or herself are part of the problem.'

He added that the visual medium can influence much more than a newspaper and asked if the audience, are "mature enough to see this content?'

On her part, Justice Nagarathna said: "We want a free and balanced press in India... free but balanced."

DAUGHTER/SISTER'S RIGHTS IN FAMILY PROPERTY DO NOT CHANGE: GUJARAT HC

Ahmedabad: The Gujarat High Court on Friday pointed out that society's mindset towards daughters and sisters needs to be changed, as it held that even after marriage, they have equal rights in the property.

Annoved with the petitioner's submission, the Chief Justice observed: "This mindset that once the daughter or sister in the family is married, we should not give her anything, this should be changed. She is your sister, born with you. Just because she has married, now her status in the family does not change. Thus, this mindset should go."

The court also pointed out: "If the son remains son, married or unmarried, a daughter shall remain a daughter, married or unmarried, if the act does not change the status of the son; the act of marriage cannot and shall not change the status of a daughter."

NRSC studying in detail Joshimath sinking with satellite images

Chennai/Dehradun

he National Remote Sensing Centre (NRSC) is analysing in detail the satellite images of the land subsidence at Joshimath, said a senior official of the Indian space agency.

Part of Indian Space Research Organisation (ISRO), the Hyderabad-based NRSC had, on Thursday, put out a preliminary report on the land subsidence showing that

the entire Joshimath may sink.The pictures are taken from the Cartosat-2S satellite. Hyderabad-based NRSC has released satellite images of areas that are sinking. In the images, the entire town, including the Army's helipad and the Narasimha temple, has been marked as a sensitive zone. According to the report, the land subsidence was slow between April and November 2022, during which Joshimath had sunk by 8.9 cm.But between December 27, 2022 and January 8, 2023, the intensity of land subsidence increased and the town sank by 5.4 cm in these 12 days.The satellite images

show that the Joshimath-Auli road is also going to collapse due to the land subsidence. Crown of the subsidence is located near Joshimath-Auli road at a height of 2180 m, NRSC

Tehsildar Surendra Dev said that the administration had inspected the areas earlier also and had identified 27 unsafe buildings. Along with this, a geological survey and major remediation plan were recommended. A team of IIT Roorkee has surveyed the areas twice.

s countries like China and Japan bear the maximum brunt of the global Covid surge, India has survived the immediate threat and according to health experts, majority of the population has got either natural immunity or vaccine-induced immunity to all coronavirus strains currently active in the

Given the exposure of the Omicron variant in India in the last one year, there is hardly any possibility of any significant public health problem to be caused by Covid in near

"We will not see any surge in serious cases of Covid-19 in India in the near future. However, we need to prepare



and strengthen our epidemic response system by taking lessons from the last two years," Dr. Harshal R. Salve, Professor at Centre for Community Medicine at AIIMS, New Delhi, told reporter. While China saw a massive

surge in Covid and hospitalisation, especially in the month of December, Japan that is reeling under the eighth wave of the pandemic, has reported record coronavirus-related deaths almost every single

According to Dr Anita Mathew, Infectious Disease Specialist at Fortis Hospital in Mulund, Mumbai, in the last two and half years, India has seen three waves of Covid-19 with different variants like Delta, Omicron and its subvariants in circulation, which caused an "endemicity".

In India, we have a large population that has already been infected with Covid, thus the combination of infection and vaccination has developed a certain amount of herd immunity, said heath experts.

The current variant in China is not the new one; it's a part of the Omicron family and India is likely to see a wave only if we have a new subvariant that "we haven't been exposed to in the past,a said the doctor.

CCI ORDER STRIKES A BLOW TO ACCELERATING DIGITAL ADOPTION IN INDIA: GOOGLE

s the fight between Google and the Competition Commission of India (CCI) reaches the Supreme Court, the tech giant on Friday said India is at a juncture where the stakeholders must come together to bring down barriers to access and make safe and secure smartphones available to all, supported by a flourishing digital ecosystem.

Google said that foundational disruptions at this stage could set us back years and undo the deep investments and effort made by original equipment manufacturers (OEMs), developers, and the industry overall.

"It is a crucial moment for India and our hope is that we, along with all the stakeholders of this vibrant ecosystem, can continue to build on top of this foundation," said the com-

The Supreme Court on Wednesday agreed to examine an appeal by Google against a decision by the National Company Law Appellate Tribunal (NCLAT), declining to stay a



Rs 1,337.76 crore penalty imposed on it by the CCI for alleged anti-competitive practices.

Google said that the "directions in the CCI's order" strikes a blow at the ecosystem-wide efforts to accelerate digital adoption in the country.

Google is appealing these directions before Indian courts. While there has been a lot of reporting and debate on the subject, it is critical that our users and stakeholders understand the full import of what lies at stake," the company said in a blog

CBI gets prosecution sanction against Lalu Prasad in land for job case

he Central Bureau of Investigation (CBI) has got the prosecution sanction from the Ministry of Home Affairs against former Union Minister of Railways and Bihar Chief Minister Lalu Prasad in connection with a case related to land for job

An official said the CBI furnished the prosecution sanction letter before the concerned court.

The CBI had in October last year in its chargesheet named 16 accused including Lalu Prasad, his wife, daughter, then GM of Central Railways, then Chief Personnel Officer (CPO), pri-



didates in the matter. The CBI had said that during the investigation, it has been found that the accused

GM Central Railways and CPO, Central Railways engaged persons as substitutes in lieu of land either in their name or in the name of their close relatives.

This land was acquired at prices lower than the prevailing circle rate and much lower than the market rate.

"The candidates have used false TC and submitted false attested documents to the Ministry of Railways," the CBI has alleged in the chargesheet.

The CBI has learnt during the probe that Lalu Prasad's wife Rabri Devi and daughter Hema Yadav were gifted land in connection with the land for job scam by job seekers who were later appointed in

TN Assembly passes Bill on compulsory Tamil paper in state govt recruitment exam

Bill mandating a compulsory Tamil language paper for recruitment to Tamil Nadu gov ernment services was passed by the state Assembly on Friday.

The bill amends the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 for the purpose. Tabling the Bill, Finance and

Human Resources Management Minister Palanivel Thiaga Rajan recalled that a compulsory Tamil language paper was introduced for direct recruitment to all competitive examinations in the state, through the government order of December 1, 2021. It was meant to protect the interests of Tamil youths, he said.

"To give statutory effect to the said executive order, the government have decided to amend the Tamil Nadu Government Servants (Conditions of



Service) Act, 2016 (Tamil Nadu Act 14 of 2016) suitably and to validate any action taken or anything done based on the said order," he said.

The minister pointed out that unlike the legislation enacted by the erstwhile AIADMK government

which permitted the candidates to clear the Tamil paper within two years from the date of recruitment, as per the legislation brought by the DMK government, the Tamil language paper is compulsory for

Al 'pee-gate': Now, accused Shankar Mishra says woman urinated on own seat

fter claiming that "unzipping" was not for the Mishra, accused of urinating on an elderly female co-passenger, while in a drunken state, on a New York-New Delhi flight last November, told the court on Friday that it was the woman who peed on her own seat.

Mishra's claim came after a sessions court issued notice on an application by the Delhi Police requesting his custody.

'I'm not the accused. There must be someone else who peed or it must be her who urinated," he told the court.

He further claimed that the woman was suffering

from some prostate-related disease. Moreover, he said that "the seating system was such that no one could go to her seat".

"Her seat was such that it could only be accessed from behind and in any case, the urine could not reach the seat's front area. Also, the person sitting ind the complainant did not make any such complaint," he said. On January 11, Mishra's counsel contended that

his actions, while obscene, were not intended to sexually harass the victim.

Metropolitan Magistrate, Patiala House courts, Komal Garg, who had reserved the verdict earlier, denied Mishra's bail plea, saying that the alleged act of accused of relieving himself upon the complainant is "utterly disgusting and repulsive" and the act itself is sufficient to outrage the modesty of a

As Mishra had failed to join the investigation even after notice under section 41A CrPC being issued to him, his conduct "does not inspire any confidence", the court had observed.

Himachal restores old pension scheme for 1.36 lakh employees

YOUTH COMMITS SUICIDE WHILE ON VIDEO CALL WITH GIRLFRIEND IN W.BENGAL

Local police have confiscated his mobile phone for further investigation. Sujal's family members said that the victim was in a relationship with a local girl and both were about to get married. However, tiff between the two started recently when Sujal spotted his girlfriend going with another

Sujal had also seen the Facebook status of her girlfriend who had uploaded her picture with that youth there. Feeling betrayed, Sujal thought that her girlfriend was trying to sever the relationship.

HC allows foreign Hindu-Christian couple to register marriage in Delhi

he Delhi High Court on Friday granted permission to two foreign nationals from Canada and the US, working in the national capital, to have their official wedding ceremony and register their marriage here.

A bench of Justice Prathiba M. Singhm, dealing with a plea filed by a Hindu-Christian couple seeking registration of their marriage in India, suggested the pair approach the Sub-Divisional Magistrate on January 17 to submit the form for solemnisation of

The couple, who has been living in India for six months, wants to marry and continue living here.

The couple was shown an error message and barred from proceeding further on submitting their particulars on the Delhi government's official website as under the Special Marriage Act, 1954, they were needed to register their marriage. The message read: "At least one party should be Indian".

The couple, however, questioned the authority concerned at the Sub-Divisional Magistrate's office and said that no bar for foreign citizens to solemnise their marriage in India, especially when they have been residing in India.

The couple was told that if they apply for the same offline, there is no such procedure.

Meanwhile, the department's counsel submitted that it is considering making changes in the portal for the registration of the marriage.

The bench, moreover, directed the city government to place on record a status report on what steps are being taken to amend the guidelines and make changes to the e-portal. As the guidelines and the e-portal

Anjali death case: 11 policemen suspended

suspension of the staff of three PCR vans and two pickets and disciplinary action against them, the Ministry also issued several directives, including addition of murder charge under Section 302 of the Indian Penal Code, against the accused in the sensational hit-and-drag case. The ministry has sought an explanation from the area's DCP on the security situation on the day of the incident, and action in case any dereliction of duty is ascertained. It has also

he Supreme Court on Friday granted bail to a medical practitioner, who also claimed to be a whistleblower in the sensational Vyapam scam, in a case of alleged violence during a protest in Madhya Pradesh.

A bench of Chief Justice DY Chandrachud and Justice PS Narasimha took note of the submissions made by senior advocates Kapil Sibal and Vivek Tankha that accused Anand Rai, an ophthalmologist, is in jail for the last 60 days in connection with a criminal case lodged under various sections of the Indian Penal Code (IPC) and the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act.

"This man is an ophthalmologist. He says he is also the whistleblower in the Vyapam scam. The allegation is that he was part of a mob which attacked the (district) collector. How long will you keep him in jail?" the bench asked Solicitor General Tushar Mehta, who appeared in the matter on behalf of the Madhya Pradesh government. It also took note of the fact that the chargesheet has not been filed by police in the case and granted bail to Anand Rai, subject to the conditions to be imposed by the trial court. "To remove the impression, there were four-five FIRs against



the whistle," Mehta said. Kapil Sibal, assisted by lawyer Sumeer Sodhi, said the accused was kept in solitary confinement during his judicial custody. The submission was refuted by Solicitor General Tushar Mehta. The law officer said Anand Rai, being a government employee, be directed not to take part in such dharna as one of the bail conditions. Anand Rai was arrested on November 15, following the registration of an FIR. The trial court and the high court had dismissed his bail pleas. Vikas Pargi of Ratlam district in Madhya Pradesh had lodged a complaint against Rai and others in relation to a protest during which stones were allegedly pelted on a convoy of the local MP, a few MLAs and the collector, who had gone to attend events in the memory of tribal freedom

Govt's goal is to cut down on accidents by 50% by 2024 end

nion Minister for Road Transport and Highways, Nitin Gadkari, along with Minister of Heavy Industries, Mahendra Nath Pandey, officially inaugurated the Auto Expo 2023 on Thursday. In his inaugural address, Gadkari urged the auto industry to enhance safety features in vehicles to reduce deaths due to road accidents. Gadkari said in his opening remarks that the government's goal is to cut down on accidents by 50 per cent by the end of 2024, as he requested the auto industry to take suo moto action for road safety as the government doesn't want to make anything mandatory. Gadkari said: "We aim to make India's automobile industry the world leader in terms of manufacturing, but our goal is to cut down on road accidents by 50 per cent by the end of 2024." The minister claimed that many young individuals between the age group of 18 and 34 die in road accidents. He emphasised that as road infrastructure has improved, so too has the pace at which cars are driven. The minister also asked the auto sector for assistance on the scrapping front. During the scrapping process, the cost of raw materials for the automotive industry was reduced by 33 per cent, while sales increased by 10-12 per cent. Additionally, becaus people who are going to junk their car are going to buy a new one, your turnover will rise. He also suggested the auto companies to offer discounts to buyers of new cars who present their scrappage credentials. According to Gadkari, it is possible to repurpose metals and semiconductors from scrapped vehicles, which will lower the price of finished goods.

A SCAM CALLED FILM REVIEWS

ilm critics too can have a history.

Really? Of course they do and it is a long one. Not surprisingly, it is a chequered history with mostly grey shades.

Once upon a time, this was entirely a print media domain. There were some popular critics who people followed and believed but not enough to spend on a film. The genuine critics left their mark on the reviews they wrote. The print media does not enjoy the privilege alone

Now we have online critics and FM radio critics. Initially, these online critics wrote for an established portal, but, soon, some realised that they need not belong or be answerable to an editor. The Net gives one all kinds of freedom. Some decided to start their own blogs or video reviews.

Thanks to social media, these online critics started gaining mileage, so much so that a few of them have a following of more than the circulation of some print media publications!

There are a few online, independent film critics who enjoy hits in some lakhs. This one who goes by the name Deeksha Sharma has as many as 34.4 lakh followers; KRK, the Dubaibased film producer-turned-online film critic, has 11.7 lakh followers, while the other two, Palat Tera Dhayn and Suraj Kumar, both have over 7.2 lakh followers. Don't think any official media critic enjoys this kind of numbers, not even the so called trade experts.

Now, that is what is called 'The times are a-changing'.

Film reviews have always been about a quid pro quo. Critics used to be a small community. The broadsheets never cared about films except for obits of major stars, but, usually, they all carried a film review every Sunday following a film's release. By that time, the people had decided if the film was a hit or a flop and in some cases, a film fared so poorly that it was withdrawn from the cinemas even before the review appeared!

The critics were a privileged lot. The filmmakers trusted them enough to hold special screenings for them a couple of days before the film's theatrical release; the practice still continues with most makers.

Once the press screening was done, it was left to a film's PR man to do the rest, such as

getting a preferred headline and picture to be used. Then an envelope, or lifafa, would reach each critic, who did the needful in exchange for the fayour.

A reader mostly checked the picture and the caption. Few bothered to read a review in detail. But, for all those critics, this money never reached home. It was spent on bar hopping. Easy come, easy go. This was all hush hush.

The filmmakers have one perpetual weakness. They like to hear only good things about themselves and their films. If you do otherwise, you are an enemy for life.

Very soon, the critics as well as the media understood this and started exploiting the weakness. Not only the critics, but also the media organisations started saying what the makers liked to read. Now, it was no more a matter of passing a petty cash lifafa. Deals were struck officially.


Actually, film reviews in the media were never taken seriously. People who loved cinema always counted on word of mouth. Anybody could become a critic, but a rare few could be objective. A film review was the point of view of an individual. There were critics who judged a film by its maker's name. For instance, a Hrishikesh Mukherjee or a Gulzar film would get high ratings, while a Manmohan Desai film would be panned, merit and commercial success notwithstanding.

Logically as well as practically, a critic should be able to judge a film from the audience's point of view. Except the trade papers, no other critic had that capacity!

So what are the new film critics all about? Simply put: Money. There is also another breed, the ones who want to see themselves being acknowledged as critics! This kind gives all films reviews '5 Stars' and brings this to the notice of the PR concerned. The PR concerned, in turn, would use them to publicise the film! These are not really critics, nor do they belong to any publication.

It is all a scam, this business of film reviewing. It always has been.

One particular critic comes to mind. A former high-level government employee, he reviewed films for a major newspaper. When we came out of press screenings, a Hindi



media critic would explain everything to him, from what the title meant to what the film was all about! No wonder, sometimes, I enjoyed his conversation with the Hindi critic more than the film I had watched.

Then there was a Delhi-based critic. For a '5 Star' review the price was Rs 5 lakh for some actors; others got only four stars for the same amount.

The final blow came when the management of publications decided to hop on to the review business. No more the critic, the marketing department called the shots. The stars a film review earned was now commensurate with the ad budgets! The corporate houses running the film industry were easily convinced. Besides, the critics were no longer reviewing a film for their readers, the people; they

were doing it to please the film-

maker or the star.

Earlier, a press screening for a film would be held in a limited capacity, say, 30 to 50 seats, preview theatre, now it needs a 200-to-400-seat multiplex screen, thanks to the digital media as well as to self proclaimed '5 Star' critics. Some of them literally seemed to be obsessed with the number of stars they would give a film, the rest invited to a press screening knew what was expected of them.

Looks like nobody trusted the moviegoer to judge a film, but sadly no critic ever decided for people and, among numerous others, the 1975 film 'Sholay' is the biggest example of this. The film was panned by all critics, but it went on to create a history.

'Putin will nominate his chosen heir this year rather than risk being toppled'

Validimir Putin will nominate his chosen successor this year rather than risk being toppled as the Russian President's popularity continues to plummet amid a series of military defeats in Ukraine, his former ally has claimed, the media reported.

Putin will seek to hand over power to a chosen heir and retire to his 1 billion pounds Black Sea 'palace' rather than risk the ignominious fate of toppled tyrants like Muammar Gaddafi, said Abbas Gallyamov, Putin's former speechwriter, Daily Mail reported.

The Russian leader will seek to give up power to a technocrat successor who could negotiate an end to the war with Ukraine and the West, and probably not fight the 2024 election, he told Khodorkovsky Live You Tube channel.

Gallyamov said the despot will likely nominate a 'trusted underling' as presi-



dent -- like the Mayor of Moscow, Sergey Sobyanin, Prime Minister Mikhail Mishustin, or his deputy chief of staff Dmitry Kozak, Daily Mail reported.

Putin's circle no longer see him as a 'guarantor of stability' and are alarmed by the rise of Yevgeny Prigozhin, head of the well-armed Wagner private army, which is so far loyal to the Kremlin but could turn on an elite seen as failing in

the war, Gallyamov said.

They fear being slaughtered with
Prigozhin's sledgehammer -- the extrajudicial punishment given to his jail
convict soldiers who refuse to fight or
seek to defect to Ukraine, Daily Mail
reported.

One of Prigozhin's former Wagner mercenaries, who changed sides in the Ukraine war, Yevgeny Nuzhin, 55, had his head taped to a brick wall and was beaten to death with a sledgehammer in November when he was captured by his former colleagues.

Prigozhin praised the defector's execution and said that a 'dog receives a dog's death' in response to the video of Nuzhin being bludgeoned to death.

Since Putin's war began, his allies like Prigozhin and Chechen warlord Ramzan Kadyrov have begun jockeying for power and prominence, suggesting that they could one day want to supplant him, Daily Mail reported.

SPACEX GEARS UP TO LAUNCH INTERNET SATELLITE SERVICE STARLINK IN S.KOREA

Seoul: Elon Musk-run SpaceX has applied for business registration with South Korean authorities to roll out its network of satellite internet service Starlink, sources said on Friday. SpaceX filed the request with the Ministry of Science and ICT earlier this month to launch Starlink in the country, according to the sources.

SpaceX is expected to set up a subsidiary here to qualify for registration, reports Yonhap news agency. Starlink uses a range of radio frequencies known as the 28 GHz band to provide high-speed broadband to remote and rural areas. It is not yet known whether the company will use the same range once it begins service. It might not apply for frequency and instead offer service using ground stations in China and Japan. Starlink said on its website it will start its internet service in the country sometime during the second quarter of this year. Musk-run affordable satellite internet service Starlink has reached 1 million active paid subscribers, which now includes private jets, cruises, boats and more.

Philippines rain, floods kill 17

Manila | Agencies

eavy rain which have triggered floods and landslides in the Philippines since
January 1 have killed 17 and affected over 500,000 people, a government disaster agency said on Friday. The National Disaster Risk Reduction and Management Council said in a report that it has tallied 17 deaths in five regions from rains brought about by the combined effects of low-pressure areas, the northeast monsoon, and the shear line, reports Xinhua news agency.

The authorities were looking for two

more missing people.

The weather has affected 13 regions, mainly in central and southern Philippines.

These areas have been grappling with flooding over the Christmas weekend that persisted after the New Year.

The agency said the disaster dis-

placed more than 70,000 people who

were temporarily housed in over 120 evacuation centres.

An area in the southern Mindanao region and four areas in central Philippines were under a state of calamity.

In a statement released on Friday morning, the state weather bureau warned that a low-pressure area, now located 85 km east of Surigao del Sur province, will bring more rain in Bicol region and central and southern Philippines.

Potential new unmarked graves found at Indigenous school in Canada

ore than 2,000 anomalies and a child's remains were found during radar search at the site of a former residential school for Indigenous members in Canada, local media reported.Star Blanket Cree Nation, a First Nations band in Saskatchewan, Canada, said it has located the anomalies after completing phase one of a groundpenetrating radar search at the site of the former Qu'Appelle Indian Residential School, operated from 1884 to 1998 in the village of Lebret, Saskatchewan, about 80 km northeast of Regina, Xinhua news agency quoted CTV News as saying in a report.The anomalies found have not been confirmed to be human remains and could be stones, soil or pieces of wood, however, a



jawbone fragment was discovered which was believed to be 125 years old from a child who was five or six years old at the time, the report said. Prime Minister Justin Trudeau said on Thursday in a statement that he was "profoundly saddened and disturbed" to learn of the findings. "Residential schools are part of the historic and ongoing

racism, discrimination, and

injustice that Indigenous

Peoples face. We all have a

responsibility to learn from our past to build a better future," Trudeau said.

The school initially opened in 1884 and according to the Truth and Reconciliation Commission report, the school had a high death rate. After its first nine years of operation, the school claimed to have discharged 174 students, 71 of whom had died. The institution closed in 1998 after operating for 114 years, the CTV news report said.

Japan's plan to dump Fukushima radioactive water into sea to start this yr

The Japanese government on Friday said a controversial plan to release radioactive wastewater from the crippled Fukushima Daiichi nuclear plant into the Pacific Ocean will start in the spring or summer.

The schedule of the plan was confirmed during a meeting of cabinet ministers at the Prime Minister's office earlier in the day, reports xinhua news agency.

During the meeting, financial support for fishing communities which will suffer reputational damage when the radioactive water is dumped into seas where they fish, was endorsed, as stipulated by a revised policy on the disposal of the treated water.

Japan's fishing industry has vociferously made clear its ardent opposition to the plan, as it will almost certainly cause further damage to the industry's reputation in the already



maligned region.

The government believes a new
50-billion-yen (\$388 million) fund

under the revised policy will somehow help the fishing communities, whose stock following the release of the toxic water in their fishing areas, will almost certainly be considered tainted, regardless of to what degree the toxic water is treated.

Under the plan, the water, which contains hard-to-remove radioactive tritium as a result of being used to cool down melted nuclear fuel at the stricken plant, will be discharged through an underwater tunnel into the Pacific Ocean after being treated.

The plant had its key cooling functions knocked out after being battered by a massive earthquake-triggered tsunami in 2011, resulting in the worst global nuclear crisis since Chernobyl in 1986.

The tainted water being stored in tanks at the plant is expected to soon reach capacity and the lengthy process of then dumping the radioactive water into the ocean is projected to take several decades.

Previously, the government had considered a number of alternatives to simply releasing the radioactive water into the Pacific.

n a tragedy, 10 pilgrims were killed and 24 others were injured when a speeding private luxury bus carrying them to the famed Shirdi Saibaba Temple in Maharashtra's Ahmednagar, crashed into an oncoming truck near Patharde in Nashik district on Friday morning, police said.

The accident took place around 7 a.m., when the bus, with around 45 pilgrims from Ambernath town in Thane, was speeding to Shirdi via Sinnar-Shirdi state highway.

According to police, the bus crashed headlong into the truck coming from the opposite direction and then overturned, resulting in the huge disaster, said the police. President Droupadi Murmu and Prime Minister Narendra Modi



expressed pain and grief over the tragedy and conveyed their condolences to the bereaved families and the injured victims.CM Eknath Shinde also ordered a detailed and related aspects, said an official.

Among those who perished in

and 2 minors, all from Ambernath town, said the police.

1 year jail for congress MLA, 3 others in 2017 assault case

Court in Maharashtra's Nagpur district on Friday sentenced Congress MLA and former minister Sunil Kedar and three others to one year imprisonment for assaulting power company officials in 2017.

"Requested for preventive Action U/s 149 and 107 of CrPC, (Chapter proceeding against her as she s continuously committing breach peace in society by threatening on media) today have mailed complaint to Woman Commission and now about 12.30 I will meet Rupali Chakankar Chairman Woman Commission. With written complaint for taking further



action," the message further read.
On January 4, the BJP leader took to
Twitter and slashed Uorfi Javed for her
dressing sense and asked if the women's
commission would do anything to it or
not."Half-naked women walk openly on
the streets. Why is the Women's
Commission itself not taking notice of
this? The protest is not against Uorfi but
against the attitude of walking around
openly in public places. And yes...the
women's commission will do anything
or not?" Wagh tweeted in Marathi. In
another tweet in Marathi, she wrote,
"Actions are not needed.. Is it the culture
of our Maharashtra to walk naked in

public places? Does @Maha_MahilaAyog support Uorfi's display of body in Bhar Road in Mumbai which is very disgusting?" Chitra Wagh had shared an image of herself with the Mumbai police on January 1, along with

CBI says Videocon's V Dhoot confronted with Kochhars, he says not true

The lawyer of Videocon Group promoter Venugopal Dhoot on Friday argued before the Bombay High Court that the industrialist's arrest in the ICICI Bank loan fraud case was unwarranted as he was cooperating with the probe.

he Central Bureau of Investigation (CBI), on the other hand, claimed that he was trying to avoid it.
Dhoot, arrested by the CBI on
December 26, 2022, and presently in judicial custody, has moved the High Court seeking to quash the First Information Report, and has also sought interim bail

A division bench of Justices Revati Mohite Dere and PK Chavan, after hearing both Dhoot's lawyer Sandeep Laddha, and CBI's counsel Raja Thakare, reserved its order on interim relief.

Advocate Laddha argued that Dhoot had appeared before the CBI "31 times" since a 'preliminary enquiry' (PE) was registered in December 2017. "Dhoot was never arrested in the case.

"Dhoot was never arrested in the case Even when the charge sheet was filed, Dhoot had appeared before the concerned court which granted him bail noting that he had been co-operating with the probe," the lawyer said.

Dhoot had appeared before the CBI

twice even last month, he said.
On two other dates (December 23 and



25) he could not appear, as on December 23 he had been already summoned by the Enforcement Directorate, the lawyer said.

"The CBI is holding this non-appearance for two days as non-co-operation. On December 25, the CBI issued Dhoot a notice....he appeared on December 26 and was arrested," advocate Laddha

CBI counsel Raja Thakare said Dhoot was summoned in December 2022 to confront him with co-accused Chanda Kochhar, former MD and CEO of ICICI Bank; and her husband Deepak Kochhar, both of whom were arrested on December 23.

"There has been a systematic attempt by Dhoot and the Kochhars to avoid probe. It is a case of conspiracy. When they are outside (not arrested) they decide the precise answers to give. But the moment one person is arrested, the blame game starts, and they start pointing fingers at each other," Thakare said. He added that the CBI wanted to bring the three accused together for interrogation. "Despite being summoned, he (Dhoot) refused to appear. The CBI at the time had Kochhars' custody for a brief time and hence wanted to confront them with Dhoot," Thakare said.

When the HC asked if after Dhoot's arrest, the three were interrogated together, Thakare said they were questioned together on December 26 and 27.

But Dhoot's lawyer said this was not true. The industrialist was never made to sit with the Kochhars and questioned after his arrest, he claimed.

Woman cheated of Rs 22 lakh by face book friend

family, opposed bail to the actor, and told the court that Sheezan Khan's mother was also involved in the mat-

ter. He had submitted an application to the Mira-Bhayandar, Vasai-Virar police commissioner to make Sheezan Khan's mother a co-accused in the case, advocate Sharma further said.

After hearing both sides, the court rejected Sheezan Khan's bail plea. The detailed order is expected later.

Tunisha Sharma (21), who was acting in the TV show 'Ali Baba: Dastaan-E-Kabul' along with Sheezan Khan, was found dead in the washroom on the set of the Hindi serial near Vasai, located on the outskirts of Mumbai, on December 24, 2022. She was in a relationship with Sheezan Khan but they broke up later.

Stranded in Oman, helpless Maharashtra woman brought back to India

After Bombay HC rap, Rapido Bike Taxi suspends services till Jan 20

Following a strong rap from the Bombay High Court, the "illegally run" Rapido Bike Taxi services disabled its app within an hour and suspended all services in Maharashtra till January 20.

The move followed an order by a bench of Justice Gautam S. Patel and Justice Shivkumar G. Dige warning that if the company did not suspend services immediately, it would permanently bar it from getting a license and impose a heavy fine.

The irked court's order came in a petition filed by Rappen Transportation operates Rapido Bike Taxi in Mumbai and Pune - challenging a state government communication of December 29, 2022, refusing to issue it a bike taxi aggregator licence.

Advocate General Dr.
Birendra Saraf informed the court that the state government has appointed a committee to examine the issue, and formulate guidelines on various aspects, including safety, before licensing.

However, he said that
Rapido was operating illegally without a licence and said
first it should discontinue
the illegality before coming
to the court.

The December 29, 2022 intimation declined the licence to the company on grounds that there is no state policy or fare structure on this mode of bike transport.

The annoyed judges also disagreed with the company's contentions that it had complied with the conditions and guidelines under the Motor Vehicles Act.

When the state produced a list of aggregators whose licence applications were pending before the government, the judges said that the proposed policy would be equal for all aggregators to the extent that licences to ply such services would be given to all or to none.

Spanish woman becomes second foreign national to donate organs in India

Fernandez has become the first donor from beyond Asia and the second foreign national to donate organs in India. In 2019, a Nepalese national was the city's first international cadaver donor.

hen 67-year-old Teresa Maria Fernandez came to Mumbai, her only intention was to explore the city. But her visit gave a new lease on life to four Mumbaikars and a foreign national, who were donated her organs when she passed away after brain hemorrhage. Her daughter, a doctor of emergency medicine, who asked that her organs be donated. One of the recipients is also a doctor herself. Fernandez came to Mumbai on January 5 and was travelling on a bus with her friend when she suddenly collapsed. As the bus was near Jaslok hospital, she was taken there. Dr Sudheer Ambekar, neurosurgeon at Jaslok Hospital, said, "When she was brought in, she was deeply comatose and after investigation it was revealed that she had a massive brain hemor-



rhage. She had a history of high blood pressure so most likely that might have been the reason. Her daughter from Spain, who is also a doctor of emergency medicine, got in touch with us.

We discussed the situation with her and operated on Fernandez. Unfortunately, she didn't respond well and became brain dead. The day after the surgery, her family arrived. Her daughter

took the great decision of donating her organs."

According to the Zonal Transplant
Coordination Committee (ZTCC) the woman's
heart, kidneys, lungs, liver and bones were donated by the family. According to Sujata Ashtekar,
consultant, Regional and State Organ and Tissue
Transplant Organization, the kidneys, liver, and
lungs were donated to patients in Mumbai, while
the heart was donated to a Lebanese citizen in
Chennai. The bones and tendons were donated to
a tissue bank.

The liver donated by the Spanish national gave a new lease on life to a 54-year-old general practitioner from Mumbai. Dr Chetan Kalal, programme director, Hepatology and Transplant Medicine at Nanavati Max Hospital, who headed the transplant team, said the recipient developed liver cirrhosis in 2019, after a hysterectomy.

MESSI AND MBAPPE NOMINATED, **RONALDO MISSES OUT**

orld Cup finalists Lionel Messi (Argentina) and Kylian Mbappe (France) have been nominated for FIFA's Best awards while Christiano Ronaldo is a notable omission from the list.

The list of candidates for the 2022 award has been released by FIFA on Thursday night where Messi and Mbappe feature alongside Ballon d'Or winner Karim Benzema and Neymar in the Best FIFA Men's Player category.

Julian Alvarez also joined team-

mate Messi among the nominees in the 14-member list. Alvarez, playing his first World Cup, scored four goals while skipper Messi topped the scoring charts for his country with seven goals in Argentina's first World Cup triumph in 36 years. Real Madrid's Carlo Ancelotti, France's Didier Deschamps and Argentina's World Cup-winning manager Lionel Scaloni are nominated for best Men's Coach. Morocco's Walid Regragui also features on the shortlist after his side became the first African nation to reach a World Cup semifinal.



England's Leah Williamson, Beth Mead and Keira Walsh are nominated in the Women's Best Player category.Argentina goalkeeper **Emiliano Martinez and Champions** League winner Thibaut Courtois are among the five nominees for The Best Men's Goalkeeper.

Mbappe's late equaliser and Alessia Russo's goal in England's Euro 2022 semifinal win over

Sweden are among the 12-goal list of nominees for the FIFA Pusk's Award for best goal of the year.

Two expert panels - one for women's football and one for men's football - selected the candidates for the players', goalkeepers' and coaches' categories.

The three finalists in each of the seven categories will be announced by FIFA in early February 2023.

C Barcelona will play arch-rivals Real Madrid in the final of the Spanish Sup Madrid in the final of the Spanish Super Cup on Sunday after beating Real Betis on penalties.

The two sides ended 2-2 after 120 minutes before Marc-Andre ter Stegen saved from William Carvalho and Juanmi in the shootout to see Barca through, but just as Valencia made Real Madrid suffer on Wednesday night, Betis pushed Barca to the limit.

Barca began in control on Thursday with Betis struggling to get a touch of the ball, and it was no surprise when Pedri had the ball in the net in the 23rd minute after an excellent curling ball from Raphinha.

Pedri timed his run perfectly between the defenders, but VAR intervened and it was ruled out for a tight offside from Raphinha before his cross. The goal woke Betis up and they began to create better chances, with Sergio Canales' shot from outside the area deflected out for a corner. German Pezzella



got a powerful header on the corner but was denied by a low reflex save from Ter Stegen. Sergi Roberto was Barca's next saviour, just clearing ahead of Rodri as Luiz Henrique's low cross deflected across the goal.

Robert Lewandowski put Barca ahead in the 40th minute after Pedri had set Ousmane Dembele clear down the left. Dembele rode one challenge and squared to Lewandowski, and although his first shot was blocked, the ball fell for him to score from a narrow-angle.

Ter Stegen was in action again before the break, saving from Rodri and then getting down to frustrate Henrique, whose low effort

However, Bencic was the victor in their only previous outdoor hardcourt encounter -- also in Adelaide, when she won 6-4, 6-4 in the 2020 first round and went on to reach the final.

Malaysia Open: Prannoy loses to Kodai Naraoka, bows out in quarterfinals

ndia's No. 1 shuttler H.S. Prannoy on Friday bowed out of the Malaysia Open Super 1000 badminton tournament after suffering a quarterfinal loss at the hands of Kodai Naraoka of Japan.

Playing on court 2, World No. 8 Prannoy lost 16-21, 21-19, 10-21 to Naraoka here at the Axiata Arena. The unseeded Japanese will square off with No. 8 seed Kunlavut Vitidsarn of Thailand for a spot in the last four.

Naraoka started the proceedings on a high note and took an early advantage with five back-to-back points. The Indian badminton player got his way back into the game and levelled it at 7-7. The Japanese shuttler maintained a



slender lead throughout the game and in the end, comfortably pocketed the first game. The second game witnessed an intense contest between both the

players but it was the Indian who eventually emerged as the victor of the battle and took the match into a decider. Naraoka completely dominated the final game and hardly gave Prannoy a chance to claw his way back in and finally wrapped up the match in 84 minutes of play. Heading into the match, the Japanese shuttler was leading 2-0 in the head-to-head stats against Parnnoy, having won both their meetings last year - Singapore Open and then at the World Tour Finals.Later in the day, world championships bronze medallists men's pair Chirag Shetty and Satwiksairaj Rankireddy, ranked fifth in the world, will take on the Chinese pair of Liu Yu Chen and Ou Xuan Yi in the men's doubles quarterfinals.

Rashid Khan threatens to quit BBL after Australia pull out of Afghanistan ODI series

fghanistan's top spinner Rashid Khan is likely to withdraw from the Big Bash League, the franchise-based domestic T20 league after Cricket Australia decided to pull out of an ODI series with his country in March this year. Rashid Khan has threatened to quit playing in the BBL, highlighting Afghanistan's furious response, said he would be "strongly considering my future in that competition" after Australia refused to travel to the United Arab Emirates (UAE).



Australia decided to withdraw from the ODI series after Afghanistan's Taliban government banned women and girls' education and employment in Afghanistan. Cricket Australia stated the

decision to opt out of the tour was made in consultation with the Australian government and other stakeholders.

Afghanistan is the only ICC full-member nation without a women's team and will be the only full-member without a side at the inaugural Women's U19 T20 World Cup starting on Saturday.

The Afghanistan Cricket Board (ACB) announced that it will take up the matter with the International Cricket Council.In response, Rashid Khan expressed his disappointment over CA's decision.

"If playing vs Afghanistan is so uncomfortable for Australia, then I wouldn't want to make anyone uncomfortable with my presence in the BBL. Therefore, I will be strongly considering my future in that competi-


The actor was injured in the incident that occurred few days back and rushed to the hospital immediately; he has been advised complete bed rest for now.



Story: The film revolves around an animal loving vigilante Arjun Bakshi, who learns from his father to fight for those who don't have a voice the animals, especially dogs. He is a delivery boy and martial art trainer by profession. In pursuit of searching for his indie dog shonku, he finds out several dogs going missing and unearths the illegal animal trade industry at Kolkata port. Arjun does not shy away from breaking bones of those who trouble animals. Due to which, crime branch and police forces are in search of him. On investigating he chances upon a rare species of the Indian Striped Hyena (Lakadbaggha). Will Arjun be nabbed by the police? What tactics will he use to protect the animals? The answer to these questions lies in

Review: Lakadbaggha begins on a promising note with Arjun Bakshi showing his action chops towards those ridiculing stray dogs. It then shows his daily life routine, search for shonku, to police in search of him, falling in love with Akshara D'souza, and encountering a hyena



to then unearthing the illegal activity. Well, reading this one might think that the film has a lot to offer in the 128 minutes. But, as it progresses it turns out to be a tepid fare. Initially it does touch a nerve and your heart lurches as you see the poachers greedily and heartlessly attack these creatures.

The wafer-thin plot gives no scope to director to chalk out an interesting narrative. The audiences need entertainment along with enlightenment and that's where this film falters. The background story of vigilante hiding


his face and crime branch being behind him is not explained well. Instead, time is dedicated twice to point out the past of illegal activist(Paresh Pahuja).

The screenplay turns out to be stretched with various unnecessary elements and repetitive dialogues. The build-up overall appeared staged and unconvincing.

The cinematography of Junglee has nothing new to offer. The action sequences are astutely choreographed but they lack gravity. Lacking songs, the backgrounds is in sync with the theme.

When it comes to performances, Anshuman Jha fails to pack a punch. Milind Soman is sincere, in a special appearance. Ridhi dogra fails to making a striking Bollywood debut as her character is poorly written. Newbie Eksha Kerung too suffers a similar fate. While Paresh Pahuja played his part well as there was not much that his character could offer.

Overall, Anshuman Iha's action adventure has the right intention, but much is lost between intent and execution.
