

he Adani Enterprises Ltd -the flagship company of the Adani Group -- on Thursday said it is withdrawing the Red Herring Prospectus (RHP) filed with the Registrar of Companies (RoC) Gujarat. The move is a follow up to the company's decision on Wednesday not to proceed with its Rs 20,000 crore follow-on public offer and withdraw the RHP on account of the prevailing market conditions.

The company said owing to the extreme volatility in the company's stock price, other commercial and strategic considerations, and to protect the interest of the investors it is withdrawing the follow-on public offer. #### **OPPN PROTESTS ON ADANI ISSUE WASH AWAY PROCEEDINGS IN BOTH HOUSES**

New Delhi: Parliamentary proceedings on Thursday were washed out amid noisy protests by the Congress-led opposition, which sought a discussion over research group Hindenburg's report on Adani Group. Both Houses were adjourned till Friday

As political temperatures soared over the matter, leader of opposition in the Rajya Sabha Mallikarjun Kharge led a demand by the opposition parties, seeking a probe by a joint parliamentary committee (JPC) or by a team under the Chief Justice of India's supervision into the research group's report.

Both the Houses were adjourned within minutes of assembling at 11 a.m. amid noisy protests by the opposition members. The Lok Sabha and Rajya Sabha were adjourned till 2 p.m.

As soon as the Lok Sabha reconvened at 2 p.m., the opposition members stormed into the Well of the House, seeking a discussion on the Adani group issue.

As protests continued, speaker adjourned the House till Friday. Soon after, the Rajya Sabha, which too had earlier been adjourned till 2 p.m., was also adiourned for the day amid protests by the opposition members on Adani issue.

#### **CONGRESS QUESTIONS TIES OF CHANG CHUNG-LING WITH ADANI GROUP**

New Delhi: Attacking the government over the Hindenburg report on the Adani Group, the Congress on Thursday questioned the relation between Chinese businessman Chang Chung-ling and the Adani group.

Citing the report, Congress leader Pawan Khera at a press conference said, "As per Hindenburg Research, Chang Chung-ling runs (or used to run) a firm called Gudami International, which was identified as part of an investigation into government fraud in the Adani Group's alleged circular trading of gems and that Chang Chung-ling and Vinod Adani's Singapore residential address was

"The most sensational revelation that has gone unnoticed by the Indian media so far, is that of the relationship between the Adani Group and Chang Chung-ling, a Chinese businessman of questionable antecedents," he said.

The report says, "This is a significant matter, not only for the sake of the shareholders but also for the national security of India," he added. He said the Modi government has maintained a stoic silence on the Hindenburg Research report, as if nothing has happened. "We want to tell PM Modi that we have nothing to say if you cheat your best friend, but shall not keep quiet if you cheat the investors of India - 29 crore policy holders of LIC and 45 crore account holders of SBI," he added.

## **'Passed many orders** nobody taking action'

Supreme Court on plea against hate speech event in Mumba

he Supreme Court on Thursday orally observed that it has passed many orders in connection with hate speeches at events yet nobody was taking action, while agreeing to examine a plea against an alleged hate speech event scheduled on February 5 in Mumbai.

A lawyer mentioned the matter before a bench headed by Justice K.M. Joseph and sought urgent hearing. The bench, also comprising Justices Aniruddha Bose and Justice Hrishikesh Roy, said it will seek instructions from Chief Justice D.Y. Chandrachud and subject to his approval the matter would be posted for hearing on Friday.

The bench orally told the counsel, "You ask us to be embarrassed again and again by getting an order. We have passed so many orders yet nobody is taking action. The Supreme Court should not be asked to pass an order on an event-to-event basis.

The bench told the counsel, "We are with you on this, but understand that the Supreme Court cannot be triggered every time... a rally is notified."

The counsel insisted that the matter requires urgent hearing citing the alleged hate speech rally organised in Mumbai.

The bench stressed that it had already passed an order which is clear enough and further added that if rallies were to happen all across the country and every time there will be an application before the Supreme Court. It added, "How can that be feasi-

The lawyer contended a similar rally was organised a few days ago where an alleged call was made to boycott Muslim communities economically and socially. She added that nearly 10,000 people participated in the rally.

After hearing the counsel's submissions, the bench asked her to serve a copy of the application on the Maharashtra government counsel, and added, "we will list it tomorrow subject to orders of the CJI. Only this case, not the entire batch".

In October last year, the apex court had directed the Delhi, Uttar Pradesh and Uttarakhand governments to come down hard on hate speeches, promptly registering criminal cases against the culprits without waiting for a complaint to be filed.

## Share market crash almost led to the fall of Union govt: Mamata

est Bengal Chief Minister Mamata Banerjee on Thursday claimed that on the day of the Union Budget on Wednesday, the Union government virtually was on the verge of collapse because of the share market crash. "The government was on the verge of col-

lapse. Desperate calls were made to some parties to provide funds to that person whose share prices were going down fast," the Chief Minister claimed at a public rally in East Burdwan district on Thursday.

However, she did not name anybody in this connection.

"I know exactly who all were approached for providing funds. But I do not want to take any names since that would make their lives miserable. At least six individuals were called up. Some were asked to pay around Rs 30,000



crore, some Rs 20,000 crore and some Rs 10,000 crore to that individual whose companies' share prices fell. How will such a government, which does not have any planning, continue in the long run," Banerjee asked.

#### **OVER 340 PHONES RECOVERED IN 2.5 MONTHS: DG PRISONS**

New Delhi: The Delhi Prisons department has recovered over 340 mobile phones and chargers from different jails in the last two-and-ahalf months, officials said on Thursday.

The Director General of Prisons, Sanjay Baniwal, told the media that the jail authorities have recovered 348 mobile phones in the last twoand-a-half months, with 18 seizures made on Wednesday.

The DG added that the jail superintendents have started conducting raids based on inputs from their intel sources inside the prisons, in order to send across a strong message to the criminal world.

#### BYJU'S SLASHES AROUND 15% ROLES, MOSTLY IN ENGINEERING, AS PHASED LAYOFFS ON

dtech major BYJU's has laid off further 15 per cent of its employees from its engineering teams, as the company continues phased layoffs to remain growth-oriented in global economic meltdown.

According to sources, the company in a fresh round of layoffs has asked more than 1,000 workers (or 15 per cent) to go, mostly from its engineering teams.

When reached, the company immediately declined to comment.

BYJU's last year decided to lay off as many as 2,500 employees or 5 per cent of its workforce in order to achieve profitability by



March 2023. In India, more than 21,000 employees have been laid off by more than 70 startups today, including from unicorns like BYJU'S, Ola, MPL, Innovaccer, Unacademy, Vedantu, Cars24, OYO, Meesho, Udaan and many more.

The edtech sector has laid off the most employees, with 16 edtech startups laying off more than 8,000 employees to date.

#### **NO DECISION AS OF NOW** ON IMPLEMENTATION OF UNIFORM CIVIL CODE

New Delhi: There has been no decision "as of now" on the implementation of a uniform civil code in the country, the government informed



Rajya Sabha on Thursday.In a written reply, Law Minister Kiren Rijiju said the government had requested the 21st Law Commission to undertake an examination of various issues relating to uniform civil code and to make recommendations."The term of the 21st Law Commission ended on August 31, 2018. As per the information received from the Law Commission, the matter related to uniform civil code may be taken up by the 22nd Law Commission for its consideration. Therefore, no decision on implementation of uniform civil code has been taken as of now.'

#### Guj court orders to confiscate Rs 24L worth property of former MLA

Surat: Surat's district court recently issued an order to confiscate the property of former BJP MLA V.D. Zalavadiya worth Rs 24.75 lakh to pay compensation to a victim's family after a road accident death. The court issued the confiscation order for the second time

after Zalavadiya failed to comply with its order in October 2022. Gautam Lathiya, the complainant's advocate, said that a truck with registration number GJ-05-AU-5645 was parked illegally on the Puna-Simada canal road on February 22, 2016, when his client's son, Hiren Limbaniya, rammed into it from behind. Hiren later succumbed to his injuries. The petitioner said that the truck was parked on the road without parking lights or reflectors, because of which it was not noticed by his son.

He added that the truck driver Jemal Dodhiya, owner Zalavadiya and his son Sharad were responsible for Hiren's death and should compensate the deceased's family.

The court had ordered the former MLA to pay Rs 15.49 lakh as compensation, with 9 per cent interest amount of Rs 8.26 lakh and Rs 1 lakh for legal charges, totalling to Rs 24.75 lakh, to the complainant in 2021.

# OLD TAX REGIME AND NEW TAX REGIME; EXPLAINED

he Union Budget 2023-24, which was presented by Finance Minister Nirmala Sitharaman in Parliament on February 1, has brought significant changes to personal income tax. The income tax rebate limit has been increased to Rs 7 lakh.

In Budget 2020, taxpayers were given an option to either continue with the old tax regime, where tax exemptions could be claimed, or opt for the new regime with lower tax rate but no exemptions. In both the old and new tax regimes, however, the annual  $% \left( \frac{1}{2}\right) =\left( \frac{1}{2}\right) \left( \frac{1}{2}\right) \left($ income up to which one did not need to pay taxes was Rs 5 lakh. This has been changed in the Union Budget 2023-24. The Finance Minister, in her budget speech, proposed to increase the tax-free ceiling in the new tax regime to Rs 7 lakh from the existing Rs 5 lakh. This means that those who have chosen the new tax regime and have an income of up to Rs 7 lakh will not be required to pay any taxes.

Besides this, the tax slabs have also been reworked and the number of slabs have been brought down from six to five. Now, in the new regime, income between Rs 0-3 lakh will not be taxed. This is an increase of Rs 50,000 from the zero to Rs 2.5 lakh notax slab applicable earlier.

#### **INCOME WITH UP TO RS 7 LAKH** (OLD TAX REGIME)

If you have an income of up to Rs 7 lakh in the old tax regime then your total taxable income after all deductions will turn out to be Rs 3,70,000. The tax payable on it will be Rs 6,240, which includes 4% surcharge and 5% tax in the Rs 2.5 lakh to Rs 5 lakh tax slab. This payable amount becomes zero after deductions under Section 87A of the Income Tax Act are claimed. Here, you can avail the various exemptions and deductions such as house rent allowance (HRA)and interest on

#### **INCOME WITH UP TO RS 7 LAKH** (NEW TAX REGIME)

If your annual income is up to Rs 7 lakh then in the proposed new tax regime, you are not liable to pay any taxes on your income. However, you cannot claim any exemptions.

#### **INCOME OF RS 10 LAKH (OLD TAX REGIME)**

For those who have an annual income of Rs 10 lakh, the taxable income will be Rs 6 lakh after deductions of total Rs 4 lakh. In this case, the income tax payable could be Rs 33,800 after all exemptions and deductions.

#### **INCOME OF RS 10 LAKH (NEW TAX REGIME)**

In the new tax regime, a person with Rs 10 lakh annual income will have to pay Rs 54,600 as income tax. The total taxable income here is Rs 9,50,000, which is subject to tax at 5%, 10%, and 15%. No exemptions or deductions can be availed here.

### **INCOME OF RS 15 LAKH (OLD TAX REGIME)**

Taxpayers with Rs 15 lakh annual income will have to pay Rs 1,06,600 as income tax. This includes 5% tax in the Rs 2.5 - Rs 5 lakh slab and 20% tax in the Rs 5 -Rs 10 lakh slab. Here, the total taxable income is Rs 9,50,000.

#### INCOME OF RS 15 LAKH (NEW TAX REGIME)

In the new tax regime, those with income of Rs 15 lakh will have a taxable income of Rs 14,50,000. This will be taxed at 5%, 10%, 15%, and 20% in different tax slabs, which brings the total tax payable to Rs 1,45,000.

## RAJ MLAS' RESIGNATION: BJP SUBMITS BREACH OF PRIVILEGE NOTICE AGAINST 6 MINISTERS, MLAS

eputy leader of opposition in Rajasthan assembly, Rajendra Rathore on Thursday submitted a proposal of breach of privilege against MLA Sanyam Lodha to Principal Secretary, Rajasthan Legislative Assembly alleging that the resignations made by 81 MLAs were not voluntary but they were pressured to do the same.

Breach of privilege notice was also submitted by BJP MLA Vasudev Devnani against Ramlal Jat, Anita Bhadel against Mahendra Chowdhary, Jogeshwar Garg against Rafiq Khan, Ashok Lahoti against Shanti Dhariwal and Ramlal Sharma against Ramlal Jat, respectively. The notice was also submitted against Mahesh Joshi to the Principal Secretary, Rajasthan Legislative Assembly.

The notice was submitted two days after a war of words broke out in the Assembly between Speaker C.P. Joshi and deputy leader of



opposition Rajendra Rathore. Earlier, Rathore had filed a PIL in court against the resignations of 81 MLAs pending before the Speaker and the High Court eventually sought reply from the Speaker on

In reply, it was informed that 81 MLAs' resignation was not voluntary drawal were accepted.

The Congress and Independent MLAs resigned on September 25 in support of Chief Minister Ashok Gehlot after the high command called a parallel meeting at chief minister's residence to discuss a change of leadership.

Now the BJP has given a notice of breach of privilege to the Assembly

MLAs of the Congress government on the basis of pressurising them for their resignations.

Appearing before the Speaker on September 25, the six minister-legislators who handed over the resignations of the rest of the MLAs have been accused of breach of privilege.

In this notice, the BJP has made the basis of the answer given by the Assembly Secretary in the High Court, in which it is mentioned that MLAs did not resign on their own. The BJP argues that the six ministerial MLAs who appeared before the Speaker pressured the remaining 75 MLAs to resign, which is a direct violation of the privilege of an MLA.

# Facebook alert helps police foil youth's suicide bid in Ghaziabad

Facebook alert helped save a youth's life in Ghaziabad. The young man was about to commit suicide on an Instagram live, when Meta Headquarters the parent company of Facebook and Instagram based in California, reviewed the video and sent an alert to the Uttar Pradesh police, who reached his house by tracing his mobile's location in around 15 minutes.

The 23-year-old has been identified as Abhay Shukla, who was counselled for 6 hours before being sent back to his family.

The UP police had tied up with Meta in March last year to alert them immediately if a post related to suicide was



seen on Facebook or Instagram. On Tuesday night, Shukla came live on Instagram and started tying a noose.deo, the headquarters sent an email alert to the social media centre of the state's police department, along with Shukla's registered mobile number.

The social media centre transferred the alert to the Ghaziabad Police Commissionerate, when the phone's location was found to be in the city.

The message was then forwarded to Vijay Nagar police station.

Shukla is a resident of Kannauj and currently lives in Vijay Nagar area of the

He worked in Gurugram's Cashify company and left his job to start his own business in the same field.

As per the police, Shukla took the extreme step when he had to borrow Rs 90,000 from his mother, who had saved the amount for his sister's marriage, to compensate for the loss he suffered in his venture.

## Tripura: Left, Cong withdraw candidates fielded against each other

The CPI-M-led Left parties and the Congress, who earlier announced to contest jointly the February 16 elections to the 60-member Tripura assembly, on Thursday withdrew their candidates fielded against each other.

ommunist Party of India-Marxist (CPI-M) state secretary Jitendra Chowdhury said that candidates of Congress withdrew their nomination

The Left parties, dominated by the CPI-M, on January 25 announced the names of 47 candidates leaving 13 seats to their new ally, Congress

The Congress leaders were upset over the paltry allotment of seats by the Left parties.

On January 28, Congress announced 17 candidates. On the last day of filling of nominations on Monday, both the Left parties and the Congress fielded candidates against each other in 16 seats.



Talking to IANS, Chowdhury, also a CPI-M central committee member, said that no common declaration or common minimum programme would

be announced by the two parties. "Our common agenda is to protect the Constitution and to restore the law and order situation," the Left leader said.

State Congress president Birajit Sinha, who is contesting the elections from Kailasahar constituency, said that the Congress and the Left par ties are jointly fighting the elections to end the "jungle raj" of the BJP.Sinha, a former minister of the Congress-led alliance government (1988-1993), urged the party leaders and workers to forget all hesitations and doubts to jointly fight the elections to defeat the BJP in the forthcoming elections.

Another Congress leader said that it was not yet decided whether any joint rallies of the two parties

## SC declines plea to bar candidates from contesting from more than one seat

he Supreme Court on Thursday declined to scrap a rule, which allows candidates to contest from more than one constituency in a general election.

A bench headed by Chief Justice D.Y. Chandrachud said, "It's a policy matter...an issue of political democracy".

The bench, also comprising Justices P.S. Narasimha and J.B. Pardiwala stressed, "It's for Parliament to take a

The plea filed by advocate Ashwini Upadhyay sought to restrict a canfrom more than one conelection.During the hearing, the bench orally told senior advocate Gopal Sankaranarayan, representing the petitioner, that the leader of a national party would also want to show his pan-India image and show that I can stand from west, east, north, and south India.

The bench further added that there is nothing wrong with that and there are historical figures who had that kind of popularity, and told the counsel that if Parliament wants to amend it can, and the

The counsel argued

should be asked to deposit more if they are standing from two constituencies.The bench noted that candidates may contest from different seats due to a variety of reasons and whether this would further the course of democracy is up to Parliament.

The apex court concluded that permitting a candidate to contest from more than one seat is a matter of legislative policy since ultimately its Parliament's will on whether the political democracy is furthered by granting such choice.

#### PREGNANT WOMAN, HUSBAND **KILLED AS CAR GOES UP IN FLAMES IN KERALA**

Thiruvananthapuram: A pregnant woman and her hus suddenly burst into flames in Kannur district of Kerala on Thursday, police said.

The couple, along with four others, were on their way to a hospital when the incident took place near the Kannur Fire Station around 10.40 a.m.

While the couple on the front seats was burnt to death, four

others seated at the rear escaped, said the Police who rushed to the spot soon after being informed.

According to eyewitnesses, the two who were seated in the front were unable to open their doors, while a child and three others at the rear managed to escape.

The deceased were identified as 26-year-old Risha and her husband Preejith. They were on the way to the local hospital for her routine check up. "We are awaiting the arrival of the forensic experts who will be able to find out the exact reason for the fire. Nothing will be left to chance and the probe will cover all aspects," said a top Kannur Police official.

## Himachal withdraws cases for violating Covid-19 protocol



## Minister resigns over SC's verdict terming Sikkimese Nepalis as immigrants

senior minister in the Sikkim Krantikari Morcha (SKM) government on Thursday resigned as the public outrage kept growing after the Supreme Court, while hearing a case in January, said that Sikkimese Nepalis were persons of foreign origin.

Mani Kumar Sharma, who heads the Health and Information Technology departments, has addressed his resignation letter to Chief Minister Prem Singh Tamang.

In his resignation letter, Sharma said in view of the Supreme Court's verdict on January 13 this year, "The State government has not taken the sentiments of the Sikkimese people seriously and I feel that it is not necessary to remain in the State Cabinet further."

Hence, I submit this resignation with immediate effect, said Sharma who is an influential MLA from the Singtam-Khamdong constituency in East Sikkim.

A controversy has been going in Sikkim for the past few days with several apolitical organisations and political parties holding rallies and Press meets to condemn the



objectionable remarks against the Sikkimese

Nepali community.

While granting income tax exemption to old settlers of Sikkim as sought in 2013 petition by the Association of Old Settlers of Sikkim (AOSS), the Supreme Court on January 13 observed that the Sikkimese

Nepalis were persons of 'foreign origin'. Speaking to media, Sharma said the state government should have at the moment camped in Delhi and actively lobbying with the Union ministers besides preparing its replies to the court.

"There should be a multi-dimensional

approach by the government to permanently remove this repetitive slur on the Sikkimese. People would not have come out on the streets if the state government was transparent in this issue," said Sharma.

He maintained that the 'most important' step to do now is to go and 'lobby' in Delhi. I am also going to Delhi on this matter, he

Meanwhile, Chief Minister Prem Singh Tamang has been reiterating that the Sikkim government will file a review petition in the apex court to expunge those 'foreigner' and 'immigrant' tag on the Sikkimese Nepali community.

Tamang said he has personally spoken to Union Law minister Kiren Rijiju who assured him that the Centre will support the review petition of the Sikkim Government, and if required will file a review petition itself as well on similar lines. I thank him on behalf of the people of Sikkim, said the Chief

"I appeal to all to have patience, and faith in the judiciary. It is just a matter of time that this issue will be addressed for the good," said the Chief Minister in his recent assurances to the people of Sikkim.

#### If accused is dead, fine can be collected from successors: K'taka High Court

he Karnataka High Court in an important judgment stated that the fine can be collected from the property or from the successors who inherit from the accused even after his death. The bench headed by

Justice Shivashankar Amarannavar gave this order on Wednesday while looking into the petition by late Tottile Gowda from Hassan. He had submitted the peti-

tion when he was alive. The bench stated that the petitioner will not get an exemption from accountability of paying fine as per the court order even in case of his death.

No family member has submitted the petition after the death of the petitioner to continue the case. The counsel for late Tottile Gowda submitted that legal heirs do not want to continue the petition. The successor of the property should have to pay the fine amount, the bench said.

## AMRIT KAAL BUDGET: POISON FOR LIFE INSURANCE SECTOR

ቱ e proposals in the Amrit Kaal budget presented to the Parliament by Finance Minister Nirmala Sitharaman has turned out to be an 'halahala' (poison) for the life insurers. Barring the ICICI Prudential Life Insurance scrip which opened positive, the shares of other listed life insurers were in red for a second consecutive day. The shares of ICICI Prudential that closed at Rs 402.55 on Wednesday opened at Rs 396.95 and went up to Rs 410.61 and changed hands for Rs 407. In a regulatory filing, the company clarified that the share of business of non-unit linked policies with annual premium of above Rs 500,000 is approximately 6 per cent of the total annualised premium equivalent (APE) for 9M-FY2023. The shares of industry leader Life *Insurance Corporation of India (LIC)* opened at Rs 584.85 after previous close of Rs 598.80. The scrip was changing hands during the day for Rs 595 though it touched a high of Rs 606. By tweaking the 'New Tax Regime' (launched in the FY21 Budget), the government has attempted to make it attractive - it has brought down taxes under this 'exemption-free' regime, thus reducing the tax-saving value of tax-saving instruments (such as life insurance policies) under Sections 80C, 80D and others of the Income Tax Act. And by removing exemptions under Sec10 (10D) of the Income Tax Act, the Budget has also proposed taxing the maturity and surrender amount of non-ULIP policies (purchased after 1-Apr-2023), if the total premium paid by an individual under such polices is more than Rs 5 lakh in a year. While in the Indian mythology, the 'Halahala' poison was taken by Lord Shiva, at the country's bourses the investors are bearing the brunt.

# ISRAEL STRIKES GAZA IN RESPONSE TO ROCKETS FIRING

sraeli fighter jets on Thursday carried out a series of airstrikes on facilities belonging to militant groups in the Gaza Strip in response to rockets fired from the coastal

Israeli army drones and fighter jets were heard buzzing in the air, and several explosions were heard in the central Gaza Strip, witnesses told Xinhua news agency.

They added that more than 14 missiles were fired at a military post that belongs to Hamas and the Palestinian Islamic Jihad militant groups.

Palestinian medical sources said that no injuries were reported during the strikes that mainly targeted posts and facilities.

The airstrikes were in response to the earlier firing of two rockets at southern Israel, said an Israeli army spokesman.

Thursday, militants in the Hamasruled coastal enclave also fired at least eight rockets at southern Israeli communities close to the borders with the Gaza Strip, and anti-aircraft missiles were fired at Israeli fighter jets by Hamas militants.

On January 26, Israeli forces raided the Jenin refugee camp in the occupied northern West Bank and killed nine Palestinians and wounded 16

A day later, a gunman opened fire on people near a synagogue at a Jewish settlement in East Jerusalem, killing at least seven people.

Since early January, some 35 Palestinians have been killed in the ensuing violence.

More than 170 Palestinians were killed in the West Bank in 2022, and at least 29 have been killed in January this year, according to figures from the Palestinian Health Ministry.

According to the UN, 2022 was the deadliest year for Palestinians since 2006. The tensions have been further aggravated since Israel's most rightwing government, headed by Prime Minister Benjamin Netanyahu, took office in December 2022.

# NO CLASSIFIED DOCUMENTS FOUND IN BIDEN'S BEACH HOUSE: LAWYER

lawyer for US President Joe Biden has said that no classified documents were found in the latter's beach house in in Rehoboth, Delaware, during an FBI search of the property. Wednesday's search was the latest in a series carried out at various locations, after classified documents were found at the Penn Biden Center, an office space that Biden had used when he was Vice President, in Washington D.C. last November, which was not made public at the time, the BBC reported. More documents were discovered at another of Biden's homes in Wilmington, Delaware, in searches conducted in December 2022 and last month.

In a statement issued late Wednesday, Biden's lawyer, Bob Bauer, said the search that lasted from 8.30 a.m. to 12 noon was "planned" with the President's "full support".

"No documents with classified markings were found," he said, adding that some "materials and handwritten notes" that appear to date to Biden's time as Vice President between 2009 and 2017 were taken for "further review". The exact number of classified records recovered till date remains unclear, although at least a dozen were found



during the January searches alone.

Wednesday's search came a day after special counsel Robert Hur officially began his duties overseeing the probe into the documents, reports the BBC.

Former President Donald Trump and former Vice President Mike Pence have also been embroiled in controversy over the handling of classified documents.

In Pence's case, a "small number of documents bearing classified markings" were found at his home in Carmel, Indiana, according to a letter sent to the National Archives by his lawyer. The documents were recovered by the FBI from a safe at the property on 19 January, with two boxes more delivered to the Archives on January 23.

# N.Korea warns of 'toughest reaction' to US military drills with S.Korea

jets, to Seoul in order to deter
Pyongyang's evolving military threats,
reports Yonhap News Agency.

Pyongyang's Foreign Ministry claimed the US has been driving the security situation on the Korean Peninsula toward an "extreme red-line" and is pushing to spur further tensions through joint military drills of larger scale and scope with South Korea.

"This is a vivid expression of the US dangerous scenario which will result in turning the Korean Peninsula into a



huge war arsenal and a more critical war zone," the Ministry said in a statement carried by the North's official Korean Central News Agency (KCNA).

North Korea will "take the toughest reaction" to any military action by the US under the principle of "nuke for nuke and an all-out confrontation for an all-out confrontation", it added.

The North said it is ready to counter any military challenges from the US with the "most overwhelming nuclear force,"

while stressing it is not interested in any dialogue with Washington as long as the latter pursues a "hostile policy".

Earlier on Thursday, South Korea and the US staged combined air drills, involving B-1B strategic bombers, as well as F-22 and F-35B stealth fighters, from the US Air Force, in a show of Washington's "will and capabilities" to provide credible extended deterrence against North Korea's military threats.

North Korea launched around 70 ballistic missiles last year alone, the most in a single year, amid persistent speculation it may conduct a nuclear test in the near future

near nature.

The North's leader Kim Jong-un called for an "exponential" increase in its nuclear arsenal and the need to mass-produce tactical nuclear weapons at a

AMGM President Umesh Zirpe said that the scale-model project will see

around 25-30 more forts being created in this manner in the next five years.

"The models will travel to major cities like Mumbai, Pune, Nashik, Aurangabad, Nagpur, Kolhapur, etc. for the people and youth to understand their glorious legacy and the need to preserve and conserve them before it is too late," Zirpe told reporter.

Present were AMGM's Hrshikesh Yadav, Dr A Rahul Warange, Virendra Vanju, Bhushan Harshe, Rajesh Nene, and other dignitaries.

Zirpe said that during the project they learnt that of the 450-plus forts in the state, the state government has an official map record of only one - the Sinhagad Fort of Pune. "Our team of top architects painstak-

ingly mapped each and every corner of the two forts, absolutely free of cost, prepared designs, and then the scale-models were created. It's a tough task and we feel the government should take appropriate steps to conserve our heritage,' Zirpe said.AMGM's Suyash Mokashi said that in the coming time, the forts shall be selected on the basis of their historical, geographical and strategic importance to make the scale-models and display them in museums, for students, tourists, etc.Mokashi said it's a unique and mega-initiative since many of the forts are on hilltops, in coasts, around half a dozen in the Arabian Sea, river banks, some in forests, towns and cities, built by various rulers from various dynasties and even the foreigners who ruled in the past

## Man with world's largest camera collection dies in Mumbai

hotographer Dilish Parekh, holding two world records for owning the largest collection of antique cameras and also the biggest collection of photographic instruments, passed away in Mumbai late on Wednesday.

He was 69 and breathed his last at his south Mumbai residence. Parekh, who also was a freelance lensman, is survived by his wife Binita, sons Jay and Harsh and other relatives.

A freelance photographer in his early career, Parekh had made it to the Guinness World Records (2003) for his collection of 2,634 antique cameras and again shattered his own record with a GWR certificate acknowledging him as owning 4,425 cameras (2013).

He had started his hobby in 1977, after which he had painstakingly collected cameras of different shapes and sizes, from different manufacturers all over the world.

Parekh's awesome collection comprised Leicas, Rolliflexes, Zeiss, Linofs, Canons, Nikons, Kodaks, including the most valuable piece -- a 1934-made Leica 250, a rare one as around 1,000 were manufactured by the German company.



Another notable one was a German-made Bessa II, produced in 1962, the Tessina L, said to be the world's tiniest and lightest 35mm camera, weighing just 155 gms, a twin-lens reflex camera from 1959 produced by Concava, Switzerland.

Parekh was attracted to the photography instruments after his father bequeathed his collection of 600 cameras, and he launched his own collection from there, building it up to nearly 4,500, sourcing them from all over the planet, including Mumbai's infamous flea market, the Chor Bazar.

Other interesting items in his collection were a leather-bound Royal Mail Postage Stamp Camera of 1907, which could click 15 stamp size pictures at a time.


