he Supreme Court on Friday asked the Telangana Police not to continue its investigation into the alleged criminal conspiracy behind an attempt to poach BRS MLAs allegedly by the BJP.The development comes after the apex court, earlier this week, asked the CBI to not begin its probe in accordance with the Telangana High Court direction.

Senior advocate Dushyant Dave, representing the Telangana Police, contended before a bench of Justices Sanjiv Khanna and M.M. Sundresh that on the last date of hearing on March 13, the matter was mentioned for hearing as no formal notice was issued. The apex court said the Telangana Police can't continue with its probe, while issuing notice to the central agency, the BJP and others. On March 13, the Supreme Court

said the CBI should put on hold its investigation into alleged criminal conspiracy behind an attempt to poach BRS MLAs allegedly by the BJP, while hearing an appeal filed by the Telangana Police against the high court order in the matter.

The top court orally observed that the CBI should not proceed with the matter, while listing the matter for further hearing in July.

Dave had vehemently opposed transfer of probe to the CBI. The top court was informed that the case materials have not been handed over to the central agency so far. The bench said it is making it very clear that the CBI probe should not be continued while the matter is sub-judice

### **Delhi HC refuses to** entertain PIL seeking compulsory voting in Parliament, Assembly polls

New Delhi: The Delhi High Court on Friday refused to hear a PIL moved by BJP leader and practicing lawyer Ashwini Upadhyay seeking compulsory voting in Parliament and Assembly elections.

Upadhyay had moved the plea on Wednesday.

A division bench headed by Chief Justice Satish Chandra Sharma said that voting is a choice and judges are not lawmakers who can pass such directions.

The bench, also comprising Justice Subramonium Prasad, said that it cannot force a person in Chennai to come back to his home town in Srinagar and vote there.

To Upadhyay saying that he will not press his prayer for compulsory voting, the CJ remarked: "It can't be that when you are confronted with something, you will say you are not pressing it.

The bench further remarked that if the plea is not withdrawn, it will impose costs. The petitioner then proceeded to

withdraw his PIL

### Issue of simultaneous polls with Law Commission for further examination: Govt

he issue of simultaneous elections to Lok Sabha and State Legislative Assemblies is with the Law Commission for further examination to work out a practicable road map and framework.

It was informed by Minister of Law and Justice, Kiren Rijiju in a written reply in the Lok Sabha on Friday.

"The Department Related Parliamentary Standing Committee on Personnel, Public Grievances, Law and Justice had examined the issue of simultaneous elections to Lok Sabha and State Legislative Assemblies in consultation with various stake-holders including Election Commission of India. The Committee has given certain recommendations in this regard in its 79th Report. The matter now stands referred to the Law Commission for further examination to work out a practicable road map and framework for simultaneous elections to Lok Sabha and State Assemblies," said the reply.

The Minister informed that the simultaneous elections would result in huge saving to the public exchequer, avoidance of replication of effort on part of administrative and law and order machinery in holding repeated elections and bring considerable savings to political parties and candidates in their election campaigns

Further, asynchronous Lok Sabha and Legislative Assembly elections (including bye-election) result in prolonged enforcement of Model Code of Conduct with its concomitant adverse impact on developmental and welfare programmes, the Minister's reply said. However, major impedi-

ments or imperatives for synchronisation for Lok Sabha and Legislative Assembly elections include bringing amendments in not less than five articles of Constitution, namely, article 83 relating to duration of Houses of Parliament, article 85 relating to dissolution of the House of the People by the President, article 172 relating to duration of the State Legislatures, article 174 relating to dissolution of the State Legislatures and article 356 relating to the imposition of President's Rule in the states.

bout one-third of the people in the world suffer from sleep disorders which is mainly caused by a sedentary lifestyle, medical experts said.

King George's Medical University (KGMU) Vice Chancellor Lt Gen Bipin Puri said, "These can be prevented by a healthy diet, 15-20 minutes exercise, and leaving electronic gadgets two hours before going to sleep. Drugs are needed in extreme cases."

He said, "If you are not able to sleep for at least five hours at a stretch in a day or have disrupted sleep patterns for more than three weeks, it



could be insomnia or sleep apnea, which if ignored, could cause high blood pressure, fatigue, depression or anxiety and loss of concentration." He said that while an adult needs around 7 hours of

sound sleep daily, a new-born

must sleep for 18 hours and children up to 6 years for 12 hours.Prof Ved Prakash, head of respiratory critical care medicine, KGMU, who is in charge of the comprehensive sleep centre, said, "Extended shifts, prolonged exposure to

light, stress, anxiety, addiction to alcohol, caffeinated drinks and smoking, are the main reasons adversely affecting the body clock in adults."

He said that the modern lifestyle does not give enough time to the body to relax and recharge itself, which leads to decreased secretion of neurotransmitters-serotonin and dopamine - which play a vital role in sleep quality.

Faculty at the physiology department, KGMU, Prof Narsingh Verma said that a person facing sleep issues should take a balanced diet which is rich in green vegetables, fruits and sprouts as they have micronutrients and vitamins.

### Jitan Ram Manjhi claims Ravan was greater than Ram

ormer Bihar Chief Minister Jitan Ram Manjhi triggered a fresh row on Friday after he said that Ravan was a greater character than Ram.

Manjhi said: "When Ram was in trouble, some divine powers always helped him, which was not the case with Ravan. Hence, Ravan was a greater character than Ram."

Manjhi, however, also said that Ram and Ravan were imaginary characters in Ramcharitmanas and Ramayana,

but in whatever way the writers presented the characters on the basis of their imagination, Ravan had an edge over Ram.

When asked whether his statement could create a controversy, Manjhi said: "I am telling the truth. Rahul Shankritayan and others had said that Ram is an imaginary character. While most who said that were Brahmins, no one would question them. But some people will accuse me for saying the same."

"Ramcharitmanas is a very good book but it has many points which are wrong. B.R. Ambedkar and Ram Manohar Lohia had also said that the wrongful content should be removed,' Manjhi said.

"Ramayans was written by Valmiki, but no one worshiped him. On the other hand, Ramcharitmanas was written by Tulsi Das and hence every one worships him. People having Manuvadi ideology have made such a system," he said.







## 'CAN'T BULLDOZE GOVT AUTHORITY BY JUDICIAL ORDERS', SC ON LAND ALLOTMENT FOR LAWYERS' CHAMBERS

he Supreme Court on Friday observed that a signal must not go to the government that the court can bulldoze its authority by passing judicial orders, while hearing a plea moved by the Supreme Court Bar Association (SCBA) to convert a land measuring 1.33 acres allotted to the top court for the construction of lawyers' chambers.

A bench headed by Chief Justice of India D.Y. Chandrachud and comprising Justices S.K. Kaul and P.S. Narasimha, said it would take up the land allotment issue for lawyers' chambers with the government.

The bench queried senior advocate and SCBA president Vikas Singh, how could the court pass an order to take over the land for allotment of chambers? Lawyers are part of us, but can we use our own judicial powers to safeguard our own people?

The bench added it would appear that the apex court is exercising its own judicial powers to meet its own needs.

Singh said the apex court is surrounded by roads on all sides, there is



no way to grow except within the campus, and futuristic planning is required for the court campus and urged the court to issue notice on the plea, so that a discussion can start. It was pointed out that a building close to the court has received eviction orders, and they have got another land. The bench asked how it could take over all the buildings judicially, and added that the court did not doubt the requirement of the lawyers, but under Article 32, how can it take

over these buildings? "We must trust the court to take it up on the administrative side with the government. A signal must not go to the government that we can bulldoze their authority by passing judicial orders", said the bench.

Singh pressed for issuing notice in the matter and added that the Delhi High Court expansion land was taken over. The bench replied that it was done administratively. Expressing his reservation, Singh said the bar and

other stakeholders will not be a part of such administrative consultation. The bench further added that for the e-courts project, the government allotted Rs 7,000 crore because they said that we need it, and the government engages with the top court on the administrative side and the lawyers' chambers issue can be put to

Thanking the bench on behalf of the entire bar, Singh said that the entire bar is with the institution and "we will not do anything to undermine the majesty of the institution irrespective of whatever happens in this case".

Counsel for Bar Council of India contended that there is a need for space for the bar body and also Supreme Court Advocate on Record Association (SCAORA) sought to be a part of the proceedings and intervene in the issue. Attorney General R.

Venkataramani submitted that flexibility of the administrative side would certainly be helpful to resolve the matter. After hearing detailed submissions, the apex court reserved its

### Delhi Police visit twice, wait for hours at Rahul's house to serve notice: Sources details of these victims so



## *Police can't act biased in permitting*

### Kolkata Agencies single-judge bench of the Calcutta High

Court on Friday observed that the state police forces in West Bengal cannot act in a biased manner while giving permission for rallies by different political parties in the state.

The Calcutta High Court's single-judge bench of Justice Rajasekhar Mantha also ruled that from now onwards instead of seeking permission from the local police station, all political parties can seek permission either from the commissioners of respective police commissionerats or the respective district police

superintendents. "I hope the police to adopt an unbiased approach in permitting rallies without any discrimination in political parties," Justice Mantha ruled in a case filed at the Calcutta High Court complaining denial of police permission for joint rally by CPI(M) and All India Secular Front (AISF)



at Bhangar in South 24 Parganas district in West

Bengal. Justice Mantha observed that recently there had been several cases filed at the court with complaints against police for giving permission to conduct political rallies and programmes. "It seems there is a necessity to format some specific norms on this count," Justice Mantha observed.

He also outlined a specific

format regarding applications for permission for rallies to commissionerats and offices of district police superintendents, besides setting some norms for the police authorities on this count. According to Justice Mantha, the police authori-

ties concerned should separately register the different applications and at the same time upload the status of the application on their respective websites. He also said

that it is advisable to treat the application on a "first come first serve" basis, which means priority should be given to applicants applying before. "There should not be any kind of disparity on this count," Justice Mantha observed. He also said that the police should maintain and document proposed routes of rally and estimated turnout and ensure that the rally is conducted peacefully.

He impressed officials by dropping names of people in high places. "This was his third visit to the Valley.



During his present visit he had also gone to Gulmarg where he was purportedly looking for improvement in the hospitality industry, the source added.

A number of people have so far been questioned in this case. Reports also said that the same person is wanted in over a dozen other cases of fraud in Guiarat.

## ED FILES CHARGE SHEET IN CHINESE LOAN APP CASE

he Enforcement Directorate (ED) on Friday said that they have filed a charge sheet against seven entities and five individuals involved in the Chinese loan app case before the Special PMLA Court, Bengaluru. The court has taken cognizance of the charge sheet.

"The accused entities include three Fintech companies namely Mad Elephant Network Technology Private Limited, Baryonyx Technology Private Limited and Cloud Atlas Future Technology Private Limited which are controlled by the Chinese nationals, three NBFCs registered with RBI namely X10 Financial Services Private Limited, Track Fined Private Limited and Jamnadas Morarjee Finance Private Limited and one Payment gateway, Razorpay Software Private Limited," the ED

The ED had initiated investigation based on various FIRs registered by

CID, Bengaluru based on the complaints received from various customers who had availed loan and faced harassment from the recovery agent of these money lending companies. The ED investigation revealed that the Fintech companies have agreement with respective NBFCs for disbursement of loans through digital lending apps.

"During investigation, it was revealed that the money lending business is being illegally run by these Fintech companies actually and these NBFCs knowingly let these fintech companies to use their names for the sake of getting commission without being careful about the conduct of these fintech companies. The same is also violation of the Fair Practices Code of RBI," the charge sheet said.

Further investigation in the matter is on.

## FIRST H3N2 CASE CONFIRMED IN STATE, **PATIENT IN HOME ISOLATION**

Team Absolute Bhopal

he first case of H3N2 influenza is confirmed in Madhya Pradesh. According to state health department, the swab sample of a 26-year-old patient with symptoms of the infection has been sent to AIIMS Bhopal.

The patient is a resident of Bhopal and is in home isolation. Bhopal chief medical and health officer (CMHO) Dr Prabhakar Tiwari confirmed the case as positive for H3N2.

As per the reports, the patient is now among 14 new cases of H3N2 diagnosed during the week in the country, according to the ICMR laboratory network for ILI-SARI surveillance. Patient does not have any travel history. Currently there are no guidelines for home isolation or area wide testing for H3N2.

Seasonal influenza is an acute respiratory tract infection caused by 4 distinct types of viruses- Influenza A, B, C and D belonging to the Orthomyxoviridae family. Among these types, Influenza A is the most common pathogen for humans.

Globally, influenza cases are typically seen to increase during certain months of the year. India usually



witnesses two peaks of seasonal influenza one from January to March and another one in the postmonsoon season. According to Union Health Ministry, the cases arising from seasonal influenza are expected to decline from March end. In most cases, the disease is self-limiting with symptoms of cough and cold, body ache and fever etc. and usually resolves within a week

However, potentially high-risk groups such as infants, young children, pregnant women, elderly above the age of 65 years and people with comorbidities might experience more symptomatic illnesses, even requiring hospitalisation.

Disease transmission is mostly airborne from person to person. through large droplets generated by the act of coughing and sneezing.

### **JABALPUR TURNS ON ITS PRECAUTION MODE AFTER 1ST CASE IN MP**

Jabalpur: After the first case of H3N2 influenza was confirmed in Bhopal on Thursday, the state has started to stepup precautions. Recently, a woman in Jabalpur had similar symptoms, after which the health authorities took her sample and sent it to the ICMR for testing, said medical experts.

According to Jablapur Chief Medical and Health officer, Dr. Sanjay Mishra, it is essential to follow the protocols used during COVID-19 period to prevent influenza.

The doctors said that Influenza H3N2 is more dangerous than coronavirus because it causes difficulty in breathing and also chokes the throat.

Notably, there are only four centers in Madhya Pradesh for testing of influenza H3N2, out of which, Indian Council of Medical Research (ICMR) Jabalpur is the one. In view of an Influenza patient in Bhopal, the health department said that it is closely moni-

toring the situation.

## SC issues notice to state govt on bail plea of woman with PFI links arrested for filming Indore court proceedings

Police officials have alleged the woman has links with the banned group Popular Front of India (PFI).

A bench of justices Ajay Rastogi and Bela M Trivedi issued notice to the state government on Sonu Mansuri's plea. SC asks petitioners to approach MP High Court

At the outset, the bench expressed disinclination to entertain the matter and asked the lawyer appearing for the petitioners to approach the Madhya Pradesh High Court.

"This business of getting everything transferred to Delhi should stop. Why don't you go to the high court," the bench said.



Senior advocate Dushyant Dave, appearing for the petitioner, submitted that the accused was in custody for over two months and no lawyer is being

allowed to appear for her. Dave said the top court has a duty to intervene when the fundamental right of a citizen is violated.

The apex court then issued notice in the matter and posted the case for hearing on March 20. The incident occurred on January 28

Mansuri, who was arrested on January 28, had told the police that an advocate had asked her to make the video to be sent to the Islamic group PFI and she was given Rs 3 lakh for the work.During the hearing of a case related to Bajrang Dal leader Tanu Sharma, his advocates Amit Pandey and Sunil Vishwakarma noticed the woman shooting the video in court room no. 42 of Indore district court, police had said.

Mansuri, a resident of Indore, claimed before the police that senior advocate Noorjahan Khan had given her the task of making the video to be sent across to the PFI, the official had said.

The woman also told the police that she was given Rs 3 lakh for this work, the police official had said, adding the money has been recovered.

Prime Minister Narendra Modi is visiting Davanagere on March 25 and Congress leader Rahul Gandhi will address a mega public rally in Belagavi on March 20. The Vijaya Sankalp Yatra launched by the BJP on March 1 from four directions of the state is congregating at Davanagere on March 25. The programme is being organised in a 400 acre ground behind JMIT college and the party is hoping that minimum seven lakh people will attend the rally. The party senior leaders have been asked to gather a 10 lakh crowd for the programme. Following the repeated visits of PM Modi and Union Home Minister Amit Shah, the Congress is getting Rahul Gandhi to be in the state on March 20. He will attend 'Yuva Kranthi Convention' at Belagavi and leaders are striving to make it a historic rally. The Belagavi city of Karnataka has hosted the first AICC session and Rahul Gandhi is attending a public rally for the first time after the Bharat Jodo Yatra in Karnataka.

## **UKRAINE-RUSSIA MILITARY CONFLICT: CAN THERE BE A UNIVERSALLY ACCEPTABLE MEDIATION?**

he Ukraine-Russia military confrontation has stretched longer than expected largely because the plan of Russian President Vladimir Putin to establish a protective presence in

the eastern provinces of Ukraine for the Russian-speaking population there through a quick military operation went awry because of the determined move of US-NATO combine to pump in war material in the hands of Ukrainian President Volodymyr Zelensky on a big scale.Russia might not have been deterred by the thought of Western sanctions as it had become familiar with them ever since it had annexed Crimea in 2014 following an armed revolt led by Islamic fundamentalists there who apparently enjoyed the US support.

Presently, the US-led West is keeping up aid and military support to Ukraine in a 'proxy' mode, believing that for Russia the war was inflicting costs that might become overbearing, that the world opinion was gravitating in favour of peaceful negotiation between the two warring sides and that certainly an escalation into a nuclear dimension would be totally unacceptable for the international community.

It is not going unnoticed by observers that Zelensky was taking to an aggressive jargon all on the strength of US support though - setting demands like immediate withdrawal of Russian troops and talking of an ultimate Russian defeat. Coming from a leader in his precarious situation this was understandable. There is little doubt however, that the world favours an honourable peace pact between Russia and Ukraine.

India became the voice of sanity as Prime Minister Narendra Modi reached out to both Putin and Zelensky - he was the world's first leader to do that - and called for peace negotiations. His pithy reminder later that 'this is not a time for war' has swung international opinion in favour of a cessation of armed hostilities.

India maintained a non-partisan approach to the conflict and abstained from US-sponsored anti-Russia resolutions at the UN. What is noteworthy, however, is that India retained a bilateral friendship with the US and the UK, as well as the leading European powers like France and Germany.

A situation has arisen where any initiative for bringing a halt to the Ukraine-Russia military conflict that has prolonged without creat-

ing any definite advantage for either side would receive a global endorsement. Ukraine is bearing the losses and yet seeking a further upgradation of the US armament support while President Putin might be aware that Russia was running into an image problem as a 'big power' that could not score a decisive 'victory' over a smaller neighbour.

Putin can not be serious about injecting a 'nuclear dimension' in the name of using tactical missiles with that special capability. India's balanced approach has already

been hailed by the world. It can be surmised that both the US and Russia would welcome any role India could play in bringing about a ceasefire - the US and India would not like Russia to be pushed into the Chinese camp deepening the revival of the Cold War. Any meaningful success of such an intervention would be a feather in India's cap during the G20 Presidency.

India's NSA has been in touch with Russia and Ukraine at the highest levels and under his guidance, a track-2 team could quietly get into the act - an official engagement would be vulnerable to fault-finding in case the progress was not perfect. The team comprising a senior diplomat and a strategic expert chosen by NSCS, could possibly start consultations for peace and explore with the help of its counterparts from Russia and Ukraine, the possibility of evolving a framework of guidelines for negotiations.

The fundamental point is that the negotiating team must consider concerns and sensitivities of both sides. When the Cold War ended with the success of the anti-Soviet armed campaign in Afghanistan- a battle run on the war cry of Jehad- that resulted in the dismemberment of the USSR and literally the demise of International Communism, the cause of global peace for the future, would have been served better if the newly freed East European countries and the Central Asian Republics were encouraged to have peaceful relations with the residual state of Russia

NATO could be maintaining oversight on these regions but without getting into direct military involvement with the neighbours of Russia

Former US President Donald Trump struck a certain equation with Vladimir Putin despite the history of the 'Crimean war' but the relationship between the US and Russia soured as President Biden renewed emphasis on America's special bonds with NATO and apparently, looked upon Russia as an adversary at par with China.

The Democrats, it may be mentioned, had returned to power amidst widespread resentment over the alleged interference by Russia in the US Presidential election designed to favour Trump.

The neighbours of Russia left on their own should have concentrated on building themselves as democratic regimes willing to deal with that country on merit - with such help as the international community could possibly extend to them.

Annexation of the adjoining Crimea by Russia in 2014 - following the rise of the anti-Russia revolt led by Islamic militants there had predictably marked the beginning of a constant decline of West-Russia relations.

In the environment set by that event countries like Ukraine were nearly sucked into the NATO orbit for their self-defence. European Union saw Russia as a source of threat but Trump who welcomed the British on 'getting their country back' through Brexit, seemingly treated Russia as another European country and thought it could be handled according to what would be in the best American interests.

Negotiators working for peace in the present would have to start with an acknowledgement that both Russia and Ukraine had security concerns that needed to be kept in view and that the matter was largely about two adjoining countries with different philosophies of governance, respecting each other and striking an arrangement for living in peace as neighbours. It would help if Ukraine declared that it is a democratic country run by a political executive elected on the basis of 'one man one vote' without any distinction of race, region or gender.

Russian-speaking people of its eastern region would have an added confidence and feel they were on the same footing as the rest of the population.

It is also - as a good starter - desirable for Ukraine to explicitly indicate that left to itself it would not seek membership of NATO. A ceasefire has to mark the launch of tripartite negotiations between the teams of Ukraine, Russia and the mediators and logically also to a scaling down of the Western supply of arms and ammunition to Ukraine.

It would be necessary to let the two warring countries express their concerns and misgivings in the present and for the future. The more open they are about these the easier it would be for the negotiators to

work around them and establish a reasonable level of

acceptance and lasting assurance on both sides.The intervention of the US-led West on the side of Ukraine was justifiable up to a point but not the strategy of running a proxy war through that country in the hope of weak ening Russia - particularly when this was happening at the cost of a friendly Ukraine.

The real challenge for the negotiators would be to do the groundwork for facilitating a Peace Pact between Russia and Ukraine that will create certain checks and balances to the satisfaction of the international community, and see to it that an arrangement both sides could trust would be created - embracing Crimea's status too - and bring in the democratic world as a whole for possible assistance in completing that groundwork. The pact will have to envisage global funding for the reconstruction of Ukraine - with Russia also making a symbolic contribution in keeping with its status as the much bigger power, in the bilateral conflict.

A relevant issue would be to fix a reasonable sizing of Ukraine's Defence forces required to preserve the sovereignty of a democratic country and provide internal security in the areas where the Russian-speaking population lived. Conditions would have to be created for a gradual withdrawal of the Russian military from Ukraine in pursuance of the Peace Pact as also a matching lifting of 'sanctions' imposed by the US-led West on Russia. The Russia-Ukraine military conflict had been a prolonged one - adversary impacting the entire geopolitics and global economy - and untangling the complex issues that precipitated it in the first instance will have to be done patiently and with an understanding of what was bothering the two sides.

Shared economic growth is a guarantor of peace and the negotiations should give due attention to whatever could provide mutual benefit to the two countries in future. The Ukraine-Russia military conflict had in one sense, a localised dimension involving two neighbours and it cannot be allowed to land the entire world in a crisis

Peace negotiations have to be free of political tints, have to be guided by what was good for the world and had to be conducted upfront on the strength of the bona fides of the mediators

he death toll from tropical cyclone Freddy in Malawi has increased to 326, President Lazarus Chakwera announced.

In an address to the nation late Thursday, he also said that number of people injured and those still missing have risen to 201 and 796, respectively, Xinhua news agency reported.

"The number of people displaced has more than doubled to 183,159, as has the number of households displaced, which now stands at 40,702," he said

The country has set up 317 camps across the stormed region to mitigate the situation, according to Chakwera.

The Malawi leader has re-emphasized the need for more humanitarian support from local and international organisations and individuals. describing the devastation and desperation as "unbelievable and over-



whelming."Local business people have pledged to mobilize up to \$1.5 million towards supporting residents affected by the cyclone.

Meanwhile, health experts raised concerns that the cyclone-induced floods, strong winds and mudslides, could cause waterborne diseases such as cholera.

Charles Mwansambo, the Secretary for Health, has acknowledged those

#### working closely with health agencies to minimize the threat. "The ministry and other health agencies are working hand in hand to

tighten the efforts and make sure that the response is immediate, Mwansambo told Xinhua.

Malawi Red Cross Society director of programs and development, Prisca Chisala, said that many of the victims residing in evacuation camps are at high risk of contracting cholera due to lack of sanitation facilities

"It has become increasingly challenging to regulate the provision of clean water and food, posing a potential threat to the lives of many," she added.Civil society organizations in Chikwawa and Nsanje districts in Lower Shire Valley, have also sounded the alarm about the potential cholera outbreak in the camps, as many victims lack toilets and other water, sanitation, and hygiene facilities. The country has already recorded 54,120 cholera cases with 1,660 deaths since March 2022, according to the health authorities.

Freddy is the strongest tropical cyclone on record and could also be the long-lasting one, according to the World Meteorological Organization.

On Sunday, it struck Mozambique as a cyclone -- for the second time in a less than a month after battering the island nation of Madagascar in the Indian Ocean, causing severe destruction.

It has been difficult to determine the extent of the damage caused in Mozambique and the number of deaths as power supply and phone signals were cut off in some parts of the affected areas.

Freddy also broke records for the strength it has accumulated over the 8,000-km path it travelled across the Indian Ocean from north-western Australia.

the world's longest suspension bridge between the island of Sicily and the Italian mainland.

In a statement on Thursday, the ministry of infrastructure and transport said the bridge would be "the crown jewel of Italian engineering".The north-eastern most tip of Sicily is clearly visible from the western shore of Calabria, but deep water and fast currents between the two land masses mean building a bridge is a daunting challenge for engineers.

According to technical specifications, once completed the bridge will be 3,666 meters long, with a single span of 3,300 meters.

This means the central span will be over 50 percent longer than the 2,023-meter central span of the Canakkale Bridge in Turkey, currently the world's longest suspension bridge. The Turkish structure, which connects the European part of Turkey to the Asian part, was completed a year ago. The bridge took six



years to build, and reportedly cost at least \$2.7 billion.The timetable and budget for the Italian Messina Bridge project have not yet been announced, but according to previous estimates the project will take at least six years to complete, at a cost of around 8.5 billion euros (\$9 billion).

As far back as 251 BC, the Roman historian Pliny the Elder wrote about plans to construct a floating bridge to connect Sicily to the Italian mainland, and other projects were discussed in later centuries. The first modernday project was announced in 1981, and a blueprint for the project was produced in 2005.

## XI JINPING TO VISIT RUSSIA

### Moscow Agencies

hinese President Xi Jinping will make a state visit to Russia next Monday, the Kremlin and the Chinese Foreign Ministry have revealed, media reported.

The trip will last until Wednesday. Xi will meet with Russian President Vladimir Putin to discuss "aspects of further development of comprehensive partnership," according to a statement from the Kremlin

There will also be a discussion of the international agenda and cooperation between the two nations in world affairs, the Kremlin added. Russian and Chinese officials are expected to sign a number of bilateral agreements, RT reported.

Putin invited Xi to Russia during a phone call in late December, but the date of the trip was not previously announced. The two Presidents have been in frequent contact after Moscow launched its military operation in Ukraine in early 2022, both in person at international events and via video link

Last month, Beijing revealed an ini-



tiative for a settlement to the conflict in Ukraine. Moscow said it would consider the proposal, but reiterated that Kiev's refusal to acknowledge the new reality on the ground is a major obstacle to negotiations, RT reported.

The Ukrainian government has stated that its goal is military victory over Russia and the expulsion of Russian troops from all territories that Kiev claims to be under its sovereignty. It has also prohibited any negotiations with Moscow as long as Putin remains in office.

### **4 PALESTINIANS KILLED IN** ISRAELI RAID IN WEST BANK

Ramallah: Four Palestinians were shot dead by Israeli soldiers who stormed the northern West Bank city of Jenin, the Palestinian Health Ministry said in a statement.

Another 20 Palestinians were wounded, four of whom were in serious conditions, Xinhua news agency reported, citing the statement.

According to Palestinian sources and eyewitnesses, heavy clashes between Israeli soldiers and Palestinian militants broke out in Jenin's main street after an Israeli undercover unit stormed the city.

There has been no official statement from Israel on the shootings.

Israeli security forces have regularly conducted raids in Jenin in the past few months, amid an escalation of tension between Palestinians and Israelis in the occupied West Bank.

The Palestinian Health Ministry said that 84 Palestinians had been killed by Israeli soldiers since January. Meanwhile, official Israeli figures show that 14 Israelis were killed in attacks carried out by Palestinians.

## North Korea test-fired missile in 'warning to enemies' holding drills

#### **Seoul** Agencies

Torth Korea test-fired a Hwasong-17 intercontinental ballistic missile (ICBM) in a show of the "toughest response posture" of its strategic forces against "aggressive" massive combined drills by the US and South Korea, Pyongyang's state media reported on Friday.

The nation's leader Kim Jong-un "guided" the launch on Thursday together with his young daughter Ju-ae, as it served as an occasion to "give a stronger warning to the enemies intentionally escalating the tension" on the peninsula, according to the North's official Korean Central News Agency (KCNA).

It cited the "unstable security environment" in the region attributable to "provocative and aggressive large-scale war drills", referring to the South Korea-US Freedom Shield (FS) exercise underway in a program coupled with major field trainings, reports Yonhap News



## WOMAN ACCUSED OF OFFERING BRIBE TO AMRUTA **FADNAVIS SENT TO POLICE CUSTODY TILL MARCH 21**

Mumbai court on Friday remanded designer Anishka Jaisinghani in police custody till March 21 in a case registered against her for allegedly offering a bribe to Maharashtra Deputy Chief Minister Devendra Fadnavis's wife Amruta Fadnavis for intervening in a criminal case, and also threatening her.

Anishka was arrested on Thursday, while her father, also an accused in the case, was still at large. The Malabar Hill police station had registered a First Information Report (FIR) on February 20 on Amruta Fadnavis's complaint.

The accused was produced before Sessions Judge DD Almale.

The police, represented by Chief Public Prosecutor Jaysing Desai, sought her custody for seven days, saying this is not a simple matter. Unless the person is remanded in sufficient custody, it will be difficult to investigate the case, he said. The court then remanded

Anishka in police custody till March

21As per the FIR, Anishka was in touch with Amruta Fadnavis for the past 16 months, and also visited her residence.In her statement to the police, Amruta Fadnavis said she first met Anishka in November 2021. Anishka claimed that she was a designer of clothes, jewellery, and footwear, and requested the BJP leader's wife to wear them at public

events saying it would help her promote the products, a police official said.After gaining Amruta Fadnavis's trust, Anishka offered to provide her with information on some bookies through which, she claimed, they could make money. She then directly offered Amruta Fadnavis ? 1 crore to get her father off the hook in a police case, as per

the FIR. Amruta Fadnavis also told the police that she was upset by Anishka's behaviour and blocked her number, the official said.

The woman then allegedly sent Amruta Fadnavis video clips, voice notes, and many messages from an unknown number. She and her father indirectly threatened and conspired against Amruta Fadnavis,

said the official citing the FIR. The police registered the FIR against Anishka and her father under Indian Penal Code sections 120-B (conspiracy) and the Prevention of Corruption Act sections pertaining to using corrupt and illegal means to induce a public servant to take a bribe.

### "TRAP" SET TO CATCH **WOMAN: DEVENDRA FADNAVIS**

Mumbai: Devendra Fadnavis spoke about the 'trap' that the Maharashtra government and the state police had laid to catch a designer who allegedly tried to bribe and blackmail his wife, Amruta Fadnavis.

Devendra Fadnavis said that the FIR by his wife was deliberately not made public as cops want to trap the accused. The police planned to engage with the accused, who was allegedly under the impression that they did not know about the bribe and blackmail against Fadnavis.

"With help from the police, we continued to engage the said person and in one conversation names of police officers and leaders were revealed. We were told that the previous police commissioner had started the procedure to take cases back," Fadnavis said.

He claimed that now that the case has made headlines, the accused will be alert and may not get caught.

# 12-year handicap ends for Raj man after Asia's 1st bilateral total arm transplant

In what is stated to be the first of its kind surgery in Asia, a Rajasthani farmer successfully underwent a 'bilateral total arm transplant', spelling the end to his 12-years of handicapped life, at the Global Hospitals here, officials said on Friday.

The medical team led by the hospital's Dr. Nilesh G. Satbhai performed the 16-hour complex surgery on Prema Ram, 33, of Ajmer, and rekindled his hopes of an independent normal life.

Ram had lost his arms when he accidentally touched a live electric pole in his field and sustained multiple electric burns and was rushed to a local hospital.

However, the doctors in Ajmer and later in Jaipur advised a life-saving amputation of Ram's both hands, which he finally underwent almost up to the shoulder level that made his life a living torture.

Though the family tried to get artificial limbs and prostheses, they were not practical and Ram led an extremely disabled and dependent life since. Though he lost his arms, he did not lose hope and his family even enquired about arms transplant options in Europe which were very expensive and a similar operation was impossible in India then.

Even as he completed his education and a B.Ed course with the handicap in the past few years, finally, he learnt of the Global Hospitals Mumbai where successful hand transplants had been performed in the recent past and came



here in October 2022 to try his luck. Dr. Satbhai said that previously a bilateral total arm trans-

plant was done in Europe and Global Hospitals attempted the first such operation in Asia since such proximal level

surgeries are extremely challenging

The hospital had got a donor limb which matched Ram's hand colour and size and in a race against time the surgery was performed.

"For such procedures, timing and coordination are important so that limbs are attached to the body as early as possible to enable immediate resumption of blood circulation in the large number of muscles that are transferred, and doing the same surgery on both arms adds to the technical and logistical efforts," Dr. Satbhai explained.

Moreover, here the doctors had to prepare the two arms, attach them, connect the blood vessels, restore the blood supply perfectly so that the donor arms survive and start functioning. Finally, Ram was successfully operated on February 9 and discharged a month later with a pair of two new arms.

The hospital CEO Dr. Vivek Talaulikar said that artificial hands provide very limited functions to the amputees and a hand transplant is the sole option to regain useful hand function to lead a normal life.

IHH Healthcare India CEO Anurag Yadav said Mumbai has witnessed eight hand transplants till date of which seven were done at the Global Hospitals, and the hospital strives to raise awareness of organs and even limb donations to help other needy people.

Now, Ram will undergo physiotherapy on both his new arms for almost two years and achieve substantial hand functions in about 18 months, said Dr. Satbhai



### **TAYLOR SWIFT** REVEALED SHE WILL DROP 'FOUR UNRELEASED SONGS'

Singer Taylor Swift revealed she will drop four unreleased songs at midnight, on the eve of the first night of her Eras Tour. Three of the songs are part of Swift's massive re-recording undertaking, and one is a never officially released track that was written during the 'Lover' era, reports Variety.

The singer made the announcement on her Instagram story, writing: "In celebration of The Eras Tour I'm releasing four previously unreleased songs tonight at midnight."

The tracks include 'Eyes Open (Taylor's Version)', 'Safe & Sound (Ft. Joy Williams and John Paul White) (Taylor's Version)', 'If This Was a Movie (Taylor's Version)' and 'All of the Girls You Loved Before'.

'All of the Girls You Loved Before' is an unreleased track that was considered for Swift's 2019 'Lover' album.

The song was leaked in February this year, only for it to go viral on TikTok and be met with fans' requests for its official release. As it was recorded after she left Big Machine for Republic Records, a re-recording was not necessary, making it the only one of the four tracks that doesn't carry a 'Taylor's Version' tag.

The rollout of tracks includes two 'Hunger Games' soundtrack cuts fans might have worried would be orphaned in her re-records, since they never appeared on a Swift album.

Safe & Sound' had the Civil Wars officially co-billed when it was first released in 2011; since the two artists who made up that duo have long since broken up, it appears Williams and White re-recorded their parts separately and will be billed on the remake as respective solo artists.

That song and 'Eyes Open' were featured on 'The Hunger Games: Songs From District 12' and were released in December 2011 and March 2012, respectively.

'If We Were A Movie', meanwhile, precedes a yet-unannounced deluxe version of Swift's album 'Speak Now', which many fans speculate will be the next re-recorded album the singer releases.

## **KL RAHUL'S BRILLIANT KNOCK GUIDES INDIA TO VICTORY**

L Rahul struck a well-controlled unbeaten 75 while being in a crucial sixth wicket partnership of 108 runs with all-rounder Ravindra Jadeja as India defeated Australia by five wickets with 61 balls to spare in a low-scoring affair. With the win at the Wankhede Stadium, India took a 1-0 lead in the three-match series.

After the pace duo of Mohammed Shami and Mohammed Siraj claimed three wickets apiece to help India bundle out Australia for 188 after skipper Hardik Pandya had won the toss and elected to bowl first, Rahul and Jadeja came together to extricate India from a precarious 83/5 to take them to a memorable victory.

It was not the usual Wankhede wicket and offered movement off the seam to the bowlers. The bowlers held the upper hand barring the magnificent 65-ball 81 by Australia's makeshift opener Mitchell Marsh and the controlled knocks by Rahul and



Jadeja

India made a disastrous start as they lost their first three wickets with just 16 runs on the board. With the ball swinging and nipping around, the Indian batters found the going tough and the Australian bowlers made their life difficult by not giving them any chances.

Gill stayed at the wicket for 31 runs and scored 20 runs, failing to adapt to the conditions as Starc claimed 3-24 in his first spell.

Rahul and skipper Hardik came together to raise 44 runs off 55 deliveries for the fifth wicket. Rahul played the waiting game while Pandya (25 off 31 balls) went for his shots.

Rahul then figured in the most crucial partnership of the Indian innings -- a half-century partnership for the

sixth wicket with Jadeja as India, who were lagging in comparison to Australia at the end of 28 overs at 114/5 to the visitors' 169/5, fought back brilliantly.

Rahul completed his half-century in 71 deliveries, opening up later by hammering Adam Zampa for a four and a six in the 36th over. He had reprieves when a couple of outside edges did not carry and was also beaten on a few occasions but kept building his innings, hitting four boundaries in his fifty. He celebrated it by hitting two fours and a six but raised most of his runs through singles. Jadeja proved an able ally as they raised an unbeaten century partnership to help India escape to victory from a difficult situation.

Germany (2752) managed to get one win out of four in the Rourkela mini-tournament and slip down to third in the world rankings, just ahead of India (2689) who had a stellar home run of 3 wins and one shoot-out win to climb two spots into fourth.

India's charge up the rankings sees England (2536) lose ground as they slide down to sixth in the world rankings. Argentina (2269) and Spain (2251) played in the mini-tournament in Hobart alongside Australia with both teams maintaining their rankings in seventh and eighth place respectively. Spain's three wins in the first three matches had seen them briefly climb up to the seventh spot, but a final match loss to Argentina saw the teams switch back. In the FIH Women's World Rankings, the Netherlands (3199) remain at the top of the table, continuing to maintain their huge lead over Argentina (2640) in second place. India (2086), New Zealand (1879) and China (1777) close out the top-10 positions, with India last featuring in the Nations Cup where they finished as champions, securing a place in the FIH Hockey Pro League for the 2023/24 season

Should she go on to successfully defend the title, the 21-year-old will join Martina Navratilova as the only two women to win back-to-back championships at Indian Wells.

### **ALCARAZ RETURNS TO SEMIS, DEFENDING CHAMPION FRITZ BOWS OUT**

Indian Wells (USA) | Top-seeded Carlos Alcaraz of Spain surged past Canada's Felix Auger-Aliassime, 6-4, 6-4 to book his spot in the Indian Wells Masters semifinals for the second consecutive season.

Alcaraz continued to gain steam in his bid for a maiden Indian Wells title as he marched to his first victory in four tries against the 10th-ranked Canadian.

"Today, the goal was to stay there. I knew that I was going to have my chances. I had to try to take it. Probably I played one of my best matches this season, in 2023. I'm really happy and want to keep going," Alcaraz said. The Spaniard won 30 percent of his first-serve return
