SC issues notice on plea against release of 11 convicts on Bilkis Bano case, says

'IT IS HORRENDOUS'

The Supreme Court on Monday issued notice on a petition filed by 2002 Gujarat riots victim Bilkis Bano against the premature release of 11 persons convicted of her gang-rape and murder of her family members, calling the offence "horrendous". The bench directed the parties involved in the matter to complete the pleadings by the next date of hearing and also asked the state government to be ready with the relevant files connected with granting remission to the convicts on the next date of hearing.

bench of Justices K.M. Joseph and B.V. A Nagarathna observed that before hearing the plea, the court would like to know what is the gamut of issues, which would aid in knowing the framework within which the issues have to be considered.

Advocate Shobha Gupta, representing Bilkis Bano, submitted that the state (Maharashtra), where the trial was held should decide on the remission of the convicts, and not the state where offence was committed.

During the hearing in the matter, the bench orally observed that the offence was "horrendous". Advocate Vrinda Grover, representing one of the petitioners, contended that the trial judge



said no remission should be granted and also the CBI said that remission should not be given, yet they were released.

As the judges queried how many years each accused had spent in jail, counsel, representing one of the convicts, said over 15 years and 14 years is the requirement for consideration under Gujarat government remission policy. However, it was contested by a counsel, representing one of the petitioners.

A contention was made during the hearing in the matter that all the petitions against the release of 11 convicts were "emotional pleas". However, the bench said it is only on the law and has nothing to do with emotions. Noting that the crime against Bilkis Bano and her family was horrendous one, the bench made it clear that the matter will be decided on the basis of law. After hearing detailed submissions, the top court scheduled the matter for further hearing on April 18.

All 11 convicts were granted remission by the Gujarat government and released on August 15

UP GOVT'S PLEA AGAINST HC DIRECTION TO GIVE **JOB TO FAMILY MEMBER** OF HATHRAS VICTIM DISMISSED

New Delhi: The Supreme Court on Monday dismissed Uttar Pradesh government's plea against high court direction to consider giving a job to a family member of the victim in Hathras case and also the relocation of the family, saying "the state should not come up in such matters". The bench told Garima Prasad, additional advocate general (AAG) of Uttar Pradesh, "State should not come up in such matters... Prasad submitted that the state government is ready to relocate the family but they wanted a job either in Noida or Delhi."

Declining to entertain the state government's plea, the Chief Justice said, "these are facilities provided to the family. We should not interfere. State should not come up in these

Indian Embassy in Kathmandu claims **Amritpal Singh hiding in Nepal: Report**

Kathmandu has claimed that absconding pro-Khalistan radical Sikh preacher Amritpal Singh is currently hiding in Nepal and requested the Himalayan nation's government agencies to arrest him if he tries to flee. The Mission made the claim in a letter to the Department of Consular Services under the Ministry of Foreign Affairs on March 25."The esteemed Ministry is requested to inform the Department of Immigration not to permit Amritpal Singh to travel through Nepal for any third country and arrest him if he attempts to escape from Nepal using an Indian passport or any other fake passport under intimation to this mission," reads a copy of the letter obtained by The

Kathmandu Post. The letter and Singh's personal details have been circulated to all the concerned agencies from hotels to airlines, multiple sources told The Kathmandu Post.

Singh is said to be possessing multiple passports with different identities

The development comes amid a massive crackdown on Amritpal Singh and his associates in Punjab.

OVER BILKIS BANO RAPIST SHARING STAGE WITH MP

Hyderabad: Bharat Rashtra Samithi (BRS) leaders K. Kavitha and her brother K.T. Rama Rao have lashed out at BJP after one of the convicts in Bilkis Bano gang-rape case shared stage with a BJP MP and MLA in Gujarat. Kavitha, daughter of BRS president and Telangana Chief Minister K. Chandrasekhar Rao, took to Twitter to express her outrage.

"Bilkis Bano rapist openly shares stage with BJP's MPs and MLAs. What have we become as a community that perpetrators of heinous crimes against women are being celebrated and given a platform while the victims plead for justice. India is watching!," tweeted Kavitha.

"Welcome to Amritkaal," taunted KTR. "Balatkaar Justification Party and its brazen embrace of these rapists is a true reflection of their mindset," tweeted KTR.

Shailesh Bhatt, one of the 11 convicted in the Bilkis Bano gang-rape case and murder of her kin during Gujarat riots of 2002, shared the stage with a BJP MP and MLA in Gujarat at a government function in Dahod district on March 25.

The convict was seen sharing the stage with Dahod MP Jasvantsinh Bhabhor and Limkheda MLA Sailesh Bhabor.

Mumbai's main water pipelines burst, half the city to suffer water cuts

major water main pipeline was construction of a water culvert near the Mulund Octroi Checkpost in Mumbai on Monday afternoon, the BMC Disaster Control said.

The 2,345 mm Mumbai-2 mainline, which supplies water from the Pise-Panjrapur Treatment Plant Complex, was damaged during the ongoing work carried out by the Maharashtra State Road Transport Corporation (MSRDC) at Hariom Nagar.

Evewitnesses said that a massive water jet was seen shooting at least 20 metres upwards and lakhs of litres of the precious drinking water flowing from there into the gutters, flooding



some of the low-lying areas around. Moving swiftly, the BMC engineers have shut off the water on the affected main pipeline and initiated the repair works.Consequently, the BMC will impose a 15 percent water cut in almost half of the city, comprising most parts of south Mumbai and the eastern suburbs for 48 hours starting from 10 p.m.

Female cheetah from Namibia dies in MP's Kuno Park due to renal infection

female Cheetah 'Shasha' brought from Namibia to Madhya lesh's Kuno National Park died on Monday due to renal infection, said a senior forest officer. Sasha was among three cheetahs, which were not released into the wild earlier this March.

Cheetah conservation fund spokesperson Susan Yannetti confirmed the death and said, "Sasha died at around 8am on Monday. At this point, renal failure is suspected. This is what happens with cheetahs, that is why we say they are delicate creatures. They are prone to renal disease."

"The autopsy will reveal the real cause of death," she added. The Indian forest officials and MP forest officials are yet to



Earlier, MP Principal Chief conservator of forest (PCCF), (wildlife) IS Chauhan had said that Sasha was suffering from renal infection, but she was

"She was in quarantine BOMA and about to shift into a soft predator-free enclosure. She was being provided buffalo meat due to weakness," Chouhan

The veterinarians found the symptoms of dehydration and renal infection in Sasha.Cheetahs were translocated to India on September 17 at Kuno National Park under world's first intercontinental translocation project.

As of now, four cheetahs from Namibia were released into the wild while four were in enclosures. Now, three cheetahs remain in the bigger enclosure and only one of them will be released in the wild. The 12 cheetahs from South Africa are in quarantine and will be released in soft predator-free

DALAI LAMA NAMES **US-BORN MONGOLIAN BOY AS 3RD HIGHEST** LEADER IN BUDDHISM

Dharamsala: Tibetan spiritual leader the Dalai Lama has named an eightyear-old US-born Mongolian boy as the reincarnation of a spiritual leader.

He has been recognised as the reincarnation of the third most important leader in Tibetan Buddhism as the 10th Khalkha Jetsun Dhampa Rinpoche. The elderly spiritual leader was pictured with the boy during a ceremony recognising him as the 10th Khalkha Jetsun Dhampa Rinpoche. The ceremony took place earlier this month in Dharamsala, where the Dalai Lama (87) lives in exile.

"We have the reincarnation of Khalkha Jetsun Dhampa Rinpoche of Mongolia with us today," the Dalai Lama said during the ceremony which was attended by 5,000 monks and nuns 600 Mongolians and other members.

BJP functionary hacked to death in Puducherry

Bharatiya Janata Party (BJP) functionary, Senthil Kumar, has been hacked to death at Villianur in Puducherry by some unknown assailants following which the police have constituted four special teams to nab the killers, the police said on Monday.Senthil Kumar was close to BJP leader and Puducherry Home Minister, A. Namassivayam.

The police said that the incident took place at



around 9 p.m. on Sunday when the BJP functionary was waiting near a tea stall. Police said that a group of assailants who reached the spot on seven motorcycles hacked Senthil Kumar to death.According to eyewitnesses, the assailants also hurled two country

bombs at Senthil Kumar,

following which smoke engulfed the area and they hacked him to death. The gruesome murder occurred near a bakery adjacent to Kannaki Government High School.Tension prevailed in Villianur area with a large number of BJP supporters reaching the spot of crime. A heavy contingent of police is camping in the area. Senthil Kumar was also into real estate and many other businesses apart from looking after the BJP's party-related matters in Mangalam

India's heat action plans not suited to risks: Report CPR's report, 'How Is India Adapting to Heatwaves? An Assessment of Heat Action Plans With Insights for Transformative Climate Action', recommends that HAPs identify sources of financing -- either from new funds or by combining actions with existing national and state policies and set up rigorous inde-pendent evaluations as a basis for constant improve-

ment.

Closely following the Intergovernmental Panel on Climate Change (IPCC) report on the climate crisis that emphasised the need for the world to reduce emissions in the next two decades to prevent warming temperatures to reach 1.5 degrees Celsius, the CPR has analysed all 37 HAPs across 18 states, to evaluate how policy action is keeping up with the warming weather in India.

Tith India witnessing unprecedented heatwaves in 2022 and this February declared the hottest month since 1901 by the India Meteorological Department, the Centre for Policy Research (CPR) on Monday, in the first critical assessment, said most of the heat action plans (HAPs) in 18 states may not be suited to the risks faced by local populations.

Also, nearly all HAPs fail to identify and target vulnerable groups.

A study by World Weather Attribution last year analysed the climate imprint on the Indian heatwave and claimed that human-induced actions made the chances of extreme heat events 30 times higher in the region. The CPR's report says most HAPs are not built for local contexts. They across the country generally focus on dry extreme heat and ignore the threats posed by humid heat and warm nights.

Most HAPs adopt national heatwave thresholds that may not be suited to the risks faced by local populations. "Only 10 out of 37 HAPs seem to have locallyspecified temperature thresholds. Climate projections, which could help identify future planning needs, are not integrated into current HAPs," says the



Nearly all HAPs fail to identify and target vulnerable groups. Only two HAPs carry out and present vulnerability assessments (systematic studies to locate where the people most likely to be affected are in a city, district, or state). While most HAPs list broad categories of vulnerable groups (elderly, outdoor workers, pregnant women), the list of solutions they propose do not necessarily focus on these groups, says the

ower Minister Atishi on Monday alleged that a conspiracy is being hatched to stop the free electricity scheme that Delhi government is providing to the people of the national capital.

"The scheme which has been a huge success is being obstructed by some officials in connivance with Lt. Governor V.K. Saxena. To investigate the matter further and to find out the truth behind the conspiracy, a spe cial audit of the accounts of all the electricity companies of Delhi for the last 8 years will be conducted by the CAG auditor," she said.

Atishi also noted that the officials have removed experts appointed by the government on the boards of power companies in a hurry, and this has raised questions about the nexus between the officials of LG and the power companies

Addressing the media, she also questioned the removal of chartered accountants and power sector experts from the boards of power companies."Why is the file related to free electricity not being

shown to the elected government of Delhi? Are the LG and the officials conniving with the power companies and hatching some big conspiracy?" Atishi asked.

Atishi said that a special audit of power companies will expose the conspiracies to stop the free electricity being given to the people of Delhi by the Arvind Kejriwal government. It will be clear from the special audit that the money given to the power companies for free electricity has not been misused, she added.

'The file related to the scheme which came out from $\,$ the LG office 15 days ago, has

2 CAUGHT IN BIHAR'S GAYA FOR SMUGGLING LIQUOR IN AMBULANCE COFFIN

wo persons were arrested in Bihar's Gaya on Monday on the charge of smuggling liquor from Jharkhand, concealed in the coffin of an ambulance, Excise Department officials said.

The accused, identified as Lalit Kumar Mahto, a resident of Ranchi, and Pankaj Kumar Yadav, a resident of Chatra district in Jharkhand, had put a coffin in an ambulance to smuggle liquor. The excise sleuths have recovered 212 bottles of Indian Made Foreign Liquors of different brands inside the coffin.

The incident came to light on Monday morning when the accused came from Jharkhand via NH19. They were intercepted at Dobhi check post in Gava district.

"We were doing routine checking of vehicles coming from Jharkhand and West Bengal. We have spotted an ambulance coming from NH19. Our personnel stopped the ambulance. When we asked the driver Mahto, he said that a dead body was inside the coffin. When we asked them to open the coffin, they became uncomfortable. When we opened the



coffin, 212 liquor bottles of different brands were found in it," Gaya's Excise Inspector Dipak Kumar Singh said.

The accused were booked under relevant sections of liquor prohibition act.

Liquor has been banned in Bihar since April 2016. Still, smugglers are using different modus operandi to smuggle liquor from neighbouring states like West Bengal, Jharkhand, and Uttar Pradesh. A large number of smugglers also used the Nepal border route to smuggle liquor bottles.

On Sunday night, a man named Aloke Kumar was arrested after the girl's body was recovered from his residence. Later on the same night, the local people staged demonstrations in front of the Tiljala police station demanding handover of the accused to them, leading to clashes between the cops and the protesters.

The situation turned violent on Monday afternoon, as the local people staged fresh protests in the Tiljala, Tarikhana Crossing, Picnic Garden Road and Bondel Road areas. A group of agitators also started a rail blockade at the Bondel Gate railway cross-

As a large contingent of the police,



led by two deputy commissioners, made an attempt to remove the agitators, clashes broke out between the protesters and the cops. The agitated mob attacked the police with bricks,

stones and crude bombs. A police vehicle and a couple of motorcycles were torched by the agitators on the Bondel Road flyover. A number of police vehicles were damaged by the

protesters. The police had to resort to lathicharge and fire of tear gas shells to bring the situation under control. Till the time of filing this report, tension prevailed in the above-mentioned

According to police sources, Aloke Kumar has confessed to sacrificing the seven-year-old girl on the advice of a 'tantrik', who told him that the sacrifice of a minor girl will help him become a father. Both Aloke Kumar and the 'tantrik' hail from Bihar.

The accused told the police that his wife had suffered three miscarriages following which he contacted the tantrik who advised him to adopt the sacrifice route.

According to the girl's parents, she was sent to dump the garbage at the nearby garbage bin on Sunday morning and since then she went missing.

nion Road Transport and Highways Minister Nitin Gadkari, known for his casual, candid, and blunt remarks which sometimes evoke controversies, on Monday emphatically declared that he was not ready to "butter up" people for the sake of votes. "I stubbornly carry out many experiments, including biofuels and watershed conservation in the country. If people like these, it's ok, otherwise don't vote for me. I am not ready to apply more butter for the sake of popular politics," he said his address at the Dr Mohan Dharia Nation Building Award ceremony organised by a local NGO here.

Gadkari said there is a lot of scope for experimentation in areas such as water conservation, climate change and proper use of waste land, and work is being done diligently in those areas.

"I do it with love," he said. "In the future, we have to work vigorously in this field, because it can change not only the economy of India but also the face of rural areas," he said, adding that a lot of work has been done in this regard so far.

The Union Minister also said that he has initiated several such works across the country. "If people like it, people will vote for me, otherwise they will reject me. I am not ready to put any more butter for sheer vote bank politics," he said, adding that if he is not suitable for the people with such works, "they can replace me with someone else".

Gandhi was convicted under Indian Penal Code sections 499 and 500. The maximum punishment

under this section is two years. BJP MLA and former Gujarat Minister Purnesh Modi had filed

elhi Police have arrested five persons, including two juveniles, after busting a Mewat-based gang of sextortionist which indulged in blackmailing and extorting money from people, especially the elderly, by threatening to upload their objectionable pictures/videos online.

The accused have been identified as Rahul Khan (26), Arman (21) and Azad (41), all residents of Rajasthan, apart from two juveniles.

According to the police, a 67-year-old man had filed a complaint with the cyber police station in Shahdara district wherein he alleged that on March 18, he had received a WhatsApp video call from an unknown number in which a girl was performing some obscene act.

"After some time, the complainant started receiving extortion calls. Someone introduced himself as the SHO of the cyber police station and tried to extort money by saying that if the complainant does not transfer the money, he would circulate the complainant's nude video on social media," said Rohit Meena, Deputy



Commissioner of Police, Shahdara. Under pressure, the victim had transferred a total of Rs 13,70,000 to the

cheater's bank account, the DCP said. During investigation, the police collected all the relevant information; include the call detail records and WhatsApp chat details."All the bank details and phone numbers of the cheaters were analysed, following which raids were conducted at Bharatpur and Alwar in Rajasthan from where three adults and two juveniles were apprehended," the DCP said.

On interrogation, it was revealed that

the gang used to make WhatsApp video calls or Messenger calls to the victims and start playing obscene videos of girls using a second mobile phone and provoke the victims to do the same.

The accused then recorded the calls along with taking screen shots. To commit the crime, the accused purchased SIM cards and cellphones from West Bengal and managed the fraud bank accounts with the help of other co-accused persons.

"To threaten the victims, the accused introduced themselves as 'Vikram Rathore', SHO, cyber police station, and 'Sanjay' from YouTube. They mainly used to target elderly people as many of them were reluctant to lodge complaints in such

a matter," the DCP said. The police have also traced money trail of more than Rs 40 lakh from the frozen accounts the accused. More than 20 victims were also traced who had transferred

money into these accounts. "A total of 24 videos were found from the phones recovered from the accused. Rahul, the mastermind, used to pose as Sanjay from YouTube, while Azad used to introduce himself as SHO Vikram

Rathore," the officer said

Autopsy is however also done for greater understanding of disease and for research purposes with consent from family of the deceased (adult, child or newborn) when it is called Clinical Autopsy. Department of Forensic Medicine and Toxicology conducted clinical autopsy in cases of COVID deaths with consent from family members of the deceased and were able to bring out relevant facts related to the pandemic. Department of Forensic Medicine and Toxicology routinely handles



Facility to conduct autopsy at AIIMS Bhopal is unique in scientific and humanitarian ways. The department has recently installed three Downdraft Ventilated Autopsy Tables and one

Downdraft Ventilated Dissecting bench. Mortuary has ventilation system which ensures 12 to 18 air

cycles per hour. This makes the post mortem room a safe place to conduct autopsy on even infectious bodies. This is the only Forensic Medicine and Toxicology department known in the country to conduct an X-ray examination (using mobile Digital X-ray machine) before conducting an

which helps to establish diagnosis in some cases, provides evidence of either injuries or their complications and sometimes suggests most suitable autopsy procedure based on expected findings suggested at X-ray.

Histo-pathological examination of organs is also done. A Fellowship in Forensic Histopathology (the first and only known in the country) is also starting this year.

Postmortem Microbiology is also done in collaboration with Microbiology department of AIIMS Bhopal.

Analytical Toxicology lab of the department provides screening of drugs of abuse in urine samples. This lab is going to start Thin Layer Chromatography soon for qualitative detection of poisons.

WOMAN WITH 4 KIDS JUMPS INTO WELL IN BURHANPUR, THREE DEAD

Bhopal: In a shocking incident, a 30year-old woman along with her four minor children jumped into a well in Madhya Pradesh's Burhanpur.

But, the woman came out of the well along with one of her children, leaving the other three to die.

The police later recovered the bodies of three children, including that of an 18month-old son. The bodies were sent for post-mortem. Police said investigation in the matter was underway, a preliminary probe revealed that the woman took the extreme step following a quarrel with her husband. Police said the woman first threw her children -- one after the other -- into the well and later jumped into a deep well located near her house. However, she managed to catch the rope used to fetch water from the well and along with one of her daughters came out of the well. By the time the family members or locals could rescue the children, they were dead. The shocking incident occurred at a village located around 60 km from the district headquarters Burhanpur on Sunday.

Brainwashed in Brampton

s Khalistani activists in Canada have grabbed headlines after the Amritpal Singh incident in Punjab, many fear that the pro-Khalistani sentiment is rising in the country. "What did the promptness of NDP leader Jagmeet Singh, MP Sonia Sidhu, and others in tweeting about the Punjab situation after Amritpal Singh's incident and ban on Internet services, say? It was done at the behest of radical votebanks," says a Brampton Sikh entrepreneur, requesting anonymity. He says the majority is silent because of fear of reprisal. "Nobody opens their mouth against the Khalistanis who enjoy political patronage. Any leader who says anything against them is banned from entering gurdwaras and joining Vaisakhi parades," he says. When events such as the arrest of Amritpal Singh happen, Khalistan supporters bombard the offices of mayors, MPs, MPPs and ministers with messages, forcing them to issue hasty statements or tweet," says an Indo-Canadian restaurant owner in Toronto. The restaurant owner claims that Khalistanis are luring and using new students from Punjab to further their agenda. They brainwash these students while helping them with jobs, accommodation and food, he says. "The students are being roped in for Khalistani demonstrations. In return for helping these students, the radicals ask the parents of these students in Punjab to help pro-Khalistan activists in the state," says the Toronto restaurant owner. Ritesh Malik, national convener of the Canada-India Foundation which has been targeted by radicals as being pro-RSS, blames the political appeasement for the rise of anti-Indian sentiment in Canada. Brampton Punjabi journalist Balraj Deol also blames the Indian government for emboldening Khalistanis by deleting their names from the black lists.

But for India, tackling the Khalistan movement and its referendum seeking independence from India is a matter of serious concern and is a sensitive vulnerable point, which can be exploited by its arch-rival Pakistan.

"India had supported Bengalis to break Pakistan into pieces in the past. The issue of Kashmir is also somewhat of the same demand of holding a plebiscite for right to self-determination of the people of Kashmir - another contention between Pakistan and India."And this Khalistan movement is another demand of independence of a Khalistan state. So, Pakistan officially supports the Kashmir cause and their demand of independence from India. It would be difficult to say if Pakistan would not be desirous of

extending a similar support to the

Khalistan movement as well," said Javed Siddique, senior political analyst. Pakistan has in the past linked any question related to the support to Khalistan movement with the Kashmir dispute and has stated that India should hear the demands of the people of Kashmir and those demanding a separate state (Khalistan) and let them decide their future.

Pakistani media has been talking about Indian government's action against Khalistan leaders, protests in Australia, the UK and other countries.

While the Pakistan government or its military establishment has never openly expressed their support to the pro-Khalistan movement, it is believed that as the Khalistan issue is similar to the Kashmir dispute, and also because Khalistan leaders openly express their support to the Kashmir cause and take Pakistan's side, it is more likely of Pakistan to be supportive of the Khalistan movement and provide support to its leadership.



Political clout of Khalistanis in Canada far greater than their numbers

Though Khalistanis constitute a small fraction of the Sikh diaspora in Canada, they wield huge clout in most federal and provincial political parties -- the Liberal Party, the Conservative Party and the New Democratic Party.

Their deep influence on the Canadian political set-up allows them to indulge in radical activism.

Through their influence, pro-Khalistan leaders have managed to place their supporters, sons, daughters and relatives in these parties and get them elected as MPs and MLAs and even appointed as cabinet ministers. Because of their political clout. the Khalistanis have also managed to get their sympathizers placed in various Canadian government agencies and services."The modus operandi of the Khalistanis is simple: control gurdwaras. They have managed to capture major gurdwaras in Ontario and British Columbia provinces where most of the Sikhs in Canada live," says a Sikh realtor of Brampton, requesting anonymity.

All the political clout that the Khalistanis enjoy flows from their control of the gurdwaras because these religious places are the biggest gathering centres of the Sikh community, he says.

"The control of gurdwaras gives a huge clout to Khalistanis. All sorts of politicians run to them for votes and donations."

Adds veteran Punjabi journalist Balraj Deol, "Politicians tions. And Khalistanis deliver them votes and notes in abundance. That's how the Khalistanis have formed a deep nexus with politicians and mayors in Canada."

This nexus has allowed the Khalistanis to exploit the Canadian political system to further their agenda, he says. "Khalistanis have managed to get their sons and daughters placed in important positions in all political parties, get them elected as MPs and get ministerial berths. The fathers of two cabinet ministers have been known to be pro-Khalistan. The father of a Brampton-area MP was also a sympathizer of radicals," says a Brampton-based mortgage broker who wanted to be identified only by his surname Gill.

He says the lure of votes and notes (donations) has made politicians ignore the agenda of the radicals. "Politicians pander to Khalistanis because Sikhs are one of the fastest growing ethnic groups in the Toronto and Vancouver areas. Politicians need their votes. Through their control of gurdwaras, Khalistani radicals deliver them the votes. They volunteer in large numbers for all political parties."With major gurdwaras in the Toronto and Vancouver areas perpetually under their control and many Indo-Canadian MPs getting elected with their support, Khalistanis in Canada will continue with their anti-India activities in the foreseeable

Global researchers create digital database of over 1.1 bn natural history objects

ore than 1.1 billion natural history objects from 73 major natural history museums and herbaria from 28 countries are now collected into a huge global database.

The database created by global researchers and the museums' staff will help researchers and decision-makers find scientific solutions to global challenges of conservation of endangered wildlife, climate crisis, food insecurity, and preparedness for epidemics, the Hebrew University of Jerusalem (HU) which participated the project said in a statement on Sunday.

The inventory, described in a new article published in the journal Science, includes diverse collections of animal and plant remains of all kinds alongside archaeological and geological findings,

Xinhua news agency reported.

The project's organisers subdivided



the enormous aggregate collection by creating a unique shared vocabulary for collection types and their geographic

source areas.

The result was a grid of 19 collection types by 16 geographic regions, such that any collection object from any-

where in the world would fall into only one of the resulting 304 cells.

The researchers hope with the digital database to catalyse collaborative collection-based efforts to support future global sustainability, biodiversity and climate frameworks.

Major incident declared in Southern England after fluid leak

London: A major incident has been declared after around 200 barrels of reservoir fluid leaked into Poole Harbour, in Southern England's Dorset, local authorities have said

"It is estimated that nearly 200 barrels of reservoir fluid has been released into the water column in Poole Harbour," said Poole Harbour Commissioners (PHC) in a statement on Sunday.

Typically, there are five main types of reservoir fluids: black oil, volatile oil, condensate (retrograde gas), wet gas, and dry

The PHC said the leak had come from the Wytch Farm facility, operated by hydrocarbons' producer Perenco. Wytch Farm is one of the largest onshore oil fields in Europe, Xinhua news agency reported.

"PHC have activated their oil spill plan and are working with a number of organisations. A major incident has been declared, and a gold command unit has been established," it added.

Members of the public have been urged not to swim at Poole Harbour or the surrounding area until further notice.

17 killed in car accident in Mozambique

At least 17 people, including three children, were killed in a deadly road accident in central Mozambique, the state radio channel Radio Mozambique reported.

The official said that the injured have been transferred to the Beira Central hospital in the provincial capital Beira, after being treated at the Nhamatanda rural hospital, Xinhua

"According to preliminary reports, there is information that one of the tyres (of the minibus) burst and the vehicle crashed in the cargo truck carrying cement. The collision was vio-



lent," said Graca.

The President of Mozambique, Filipe Nyusi, lamented the death of the 17 people and said that road accidents continue to be a public tragedy with devastating social and economic consequences.

"In the preliminary assessment carried out on the spot, the cause of the accident was found to be excessive speed and mechanical problems caused by a tyre burst," said Nyusi who was speaking on Saturday evening during a session of the Central Committee of the ruling Frelimo party, in the city of Matola, southern province of Maputo.

Trump seemed little fazed by the possible indictment on the lower Manhattan Tax Evasion case following Attorney General Letitia James prosecution even as the city and rest of the US has gone on high alert expecting disturbance from supporters.

Trump is quite calm and has repeatedly insisted, especially Saturday night, that he was not upset by expected criminal charges that might arise from the Manhattan district attorney's investigation into his role in paying hush money to adult film star Stormy Daniels as he returned from a campaign rally in Waco, Texas.

Trump's responses to questions suggested possible potential damage to his image, media reports said, he came across as someone angry that his good vibrations with his "Make America Great Again" base in Texas could be interrupted by the reality of a possible indictment as soon as this week.

He claimed in a recorded inter-



view with reporters aboard his Trump Force One plane that he was unafraid about the investigation even as he attacked the case and attacked media reporting about the

"I'm not frustrated by it. It's a fake investigation. We did nothing wrong... I told you that," the former Pesident said before proceeding to lash out at the NBC News reporter on the plane who asked if he was frustrated.

"This is fake news, and NBC is one of the worst. Don't ask me any more questions."

Trump admitted he had actually no insight into the investigations. "I have no idea what's going to happen. They've already dropped the

case, from what I understand."

Trump went on to attack the investigation insisting the case is over even as he asserted it was fake though not supported by any concrete evidence.

"If anything ever happened with the case, it's a fake case. This is a fake case. They have absolutely nothing. They have it in reverse. They should indict Michael Cohen for all the lies that he told," he was quoted by the British newspaper Independent. as he referred to the attorney who allegedly made the hush money payment.

"They may not do that, but that's

what should be happening.
The case is about the sum of \$130,000 that Trump reportedly paid to Daniels through Cohen in the final days of the 2016 campaign.

Trump later allegedly reimbursed Cohen with \$35,000 checks using his personal funds, put down in account books as legal expenses. Cohen later pleaded guilty in 2018 to federal crimes.

However, it's still vague what charges the district attorney Alvin Bragg might seek against Trump, though some members of his legal team believe the most likely scenario involves a base charge of falsifying business records coupled with potential tax fraud because Trump would not have paid taxes on the payments.

SHIV SENA (UBT) TO SKIP OPPN MEET **OVER RAHUL'S SAVARKAR REMARK**

ollowing the uproar over Rahul Gandhi's remark referring to Hindutva ideologue V.D. Savarkar, the Shiv Sena (UBT) led by Uddhav Thackeray has decided to skip the Opposition meet convened by the leader of opposition in the Rajya Sabha and Congress President, Mallikarjun Kharge.

"My name is not Savarkar, I won't apologise," Rahul Gandhi had said after he was disqualified from the Lok Sabha following his conviction by a Surat court in a 2019 criminal defamation case.

Sources in the Shiv Sena (UBT) indicated that the party is upset over the remark, which has come to haunt the Maha Vikas Aghadi coalition.

The development came a day after Thackeray publicly appealed to Rahul Gandhi to refrain from insult-



While declaring his full support to Rahul Gandhi in his fight against the BJP, Thackeray, however, reiterated his plea and urged the Congress leader "to refrain from targeting Veer Savarkar who's our idol".

"I am publicly appealing to Rahul Gandhi... You are doing a great job, fighting for the country. But, Savarkar is our icon... We shall not tolerate any insult to him," Thackeray had said while addressing a rally in the Muslim-dominated Malegaon town

Endorsing, Raut said that Veer Savarkar is "a matter of our faith", and such utterances are intolerable, adding that he will call on Gandhi in a day or two in New Delhi to discuss and amicably resolve the matter.

Earlier, the Sena (UBT) had raised strong objections to Gandhi's comments vis-A-vis Savarkar during the Bharat Jodo Yatra in November during its Maharashtra leg.

However, the Congress ruled out the possibility of their snapping ties in the Maha Vikas Aghadi (MVA), with Chief Spokesperson Atul Londhe and MP Rajani A. Patil saying their stand on the Savarkar issue is clear for all.

Similarly, Patole declared that the Congress' stance on the Savakar matter is well known to all and vowed that the party will not make any ideological compromises.

Savarkar is an important figure for the Sena, which is why earlier Thackeray's faction members went wearing black to a meeting called by their Maharashtra ally Congress to show their disagreement.

This evening, Shinde, in a rare move that aligned with his rival Thackeray's stand, also launched a fresh attack on Gandhi over this comment on Savarkar. "The citizens of Maharashtra are upset with what Rahul Gandhi said. We will organise Savarkar Gaurav yatra throughout the state to inform about the sacrifice of Savarkar... Rahul Gandhi should go and stay at the Andamans jail for one day if he can," Shinde told reporters.

'Savarkar isn't a God only of Maharashtra, but of the entire country," the Chief Minister said. He also took a swipe at Thackeray for diluting the Sena's core principles by joining hands with the Congress and the Nationalist Congress Party (NCP).

"People who keep on speaking about Hindutva didn't say anything on Rahul Gandhi during the Maharashtra assembly session. They wore black ribbons, stood with Congress leaders and opposed the disqualification of Rahul Gandhi. The entire state watched this." Shinde said

Mumbai hardware shop gutted in fire, 2 killed in sleep

t least two youths were Akilled in their sleep when a massive fire raged through an electrical and hardware shop at the dead of the night in Andheri, the BMC Disaster Control said here on Monday.

The blaze was reported around 2.15 a.m. from Rajshree Electric & Hardware stores near the Saki Naka Metro station, and five fire engines and water tankers were rushed to the spot, with police supervising the opera-

The flames remained confined within the 200-sq ft congested shop's electrical fittings and wiring, but the shop also had two lofts with more goods stored there.

Locals claimed that there could be at least two to three persons, reportedly workers, still trapped inside, but the

Fire Brigade have recovered two bodies. They are identified as Rakesh Gupta, 22, and Ganesh Devashi, 23, said the BMC Disaster Control.

The officials said that due to the intensity of the blaze the two lofts were fully gutted and crashed down to the lower level, blocking the entry for the rescue teams.

Accordingly, the Fire Brigade deployed a bulldozer to break down the front por-

tions of the shop and gained access to douse the flames and also retrieved the bodies of the two youths who perished in the tragedy.

The cause of the fire -which was finally extinguished after nearly nine hours, is not clear and it's also unknown whether the double-lofts built inside the shop, which hampered the firefighting efforts, were autho-

Jodhpur man who threatened Salman Khan sent to police custody till April 3



Rajasthani youth, who was A arrested in a joint operation by Mumbai and Jodhpur Police, was produced before a Magistrate Court which sent him to seven-day police custody, an official said here on Monday.

The accused, identified as one Dhakadram Ramlal Siyag, 21, was nabbed on Sunday for allegedly sending an email threatening to kill Bollywood mega-star Salman Khan last week.

Cracking into the probe, the Bandra Police Station registered an FIR on March 18 and with tech-intel traced the email originating to Rajasthan.

They shared the information with the Jodhpur Police, who tracked down Siyag and after zeroing in on his location, they went in a combined operation to nab him on



The Bandra Police team said that the arrested Siyag is a historysheeter and wanted by the Rajasthan and Punjab Police in different cases and has some cases lodged against him in that state.

These include a case filed in the

Rajasthan and threatening the killed singer Siddhu Moosewala's father in an email threat, registered by the Mansa Police Station in Punjab.

It may be recalled that a week ago, the Bandra Police lodged the FIR against mafiosi Lawrence Bishnoi, his associates Goldie Brar and Rohit for the threat email sent to the actor's aide, Prashant Gunjalkar.

It had referred to the mafia don Lawrence Bishnoi's interview in which he made a chilling claim, that "his life's aim was to kill Salman Khan".

The email in Hindi, came from one Rohit Garg, who also wanted to talk with the actor and the police booked him also following a complaint lodged by Gunjalkar.

The communication also advised that if Salman had not seen the Bishnoi interview, then he should watch it, and if he wanted to close the matter, he must speak with Garg and Brar, face to face, and he (Garg) would arrange it.

Nawazuddin Siddiqui files defamation suit seeking Rs 100 cr damages from his ex-wife and brother

ollywood actor Nawazuddin Siddiqui has filed a defamation suit in the Bombay High Court seeking Rs 100 crore damages from his former wife Aaliya alias Zainab Siddiqui and his brother Shamasuddin Siddiqui accusing them of making defamatory and false statements against him.

The suit is likely to be heard on March 30 by a single bench of Justice Riyaz Chagla.

The actor, embroiled in a matrimonial dispute with his former wife, requested the High Court to permanently restrain Aaliya and his brother from making any statements or remarks that would defame him. He also sought a written apology from his former wife and brother.

As per the suit, Nawazuddin had appointed Shamasuddin as his manager in 2008 and "blindly"



assigned all financial work to him.

However, Shamasuddin started cheating and defrauding Nawazuddin and purchased properties using the actor's money, the suit alleged

It added that when the actor learnt about the fraud and raised queries, Shamasuddin instigated Aaliya to file a false case against Nawazuddin.

The actor claimed Aaliva and Shamsuddin have misappropriated Rs 21 crore from him.

When Nawazuddin demanded that properties be returned to him, Shamasuddin and Aaliya joined hands and started blackmailing the actor by uploading "cheap videos and comments on social media", the suit said.
