MANIPUR VIRAL VIDEOS: SC TAKES SUO MOTO COGNIZANCE

Tew Delhi: The Supreme Court today condemned what it called the "deeply disturbing" video of two women paraded naked in Manipur and said the visuals showed "gross constitutional failure". The Chief Justice of India, DY Chandrachud, asked the government to take action and also keep the court apprised about the steps being taken to ensure the safety of women in the region.

If the government didn't act, the Supreme Court would, warned the Chief Justice, adding that the court would take up the case

"We are very deeply disturbed about the videos distributed yesterday. We are expressing our deep concern. It is time that the government steps and takes action. This is unacceptable," DY Chandrachud said.In the video that has triggered massive condemnation and demands for action, two women were paraded naked by a mob, molested, and dragged to a field, where they were allegedly gang-raped.

According to the Indigenous Tribal Leaders' Forum (ITLF), the two women were also gang-raped in a paddy field after being paraded naked while being groped by



a mob. The gravity of the situation caught the attention of the Supreme Court, which has now also taken suo moto cognizance of the viral videos.

"If the government does not act, we will. We are of the view that the court must be apprised of the steps taken by the government so that perpetrators are booked for such violence. What is portrayed in the media and visuals which appeared sill ws gross constitutional violation."

Four accused held, CM says will seek capital punishment

Imphal: Four accused have been arrested in connection with the shocking case of two women being paraded naked on camera by a mob in Manipur's Kangpokpi district on May 4, state police said on Thursday."Four main accused arrested in the Viral Video Case: 03 (three) more main accused of the heinous crime of abduction and gangrape under Nongpok Sekmai PS, Thoubal District have been arrested today. So total 04 (four) persons have been arrested till now.

"The State Police is making all out efforts to arrest the other culprits at the earliest. Raids are continuing," the Manipur Police tweeted. Chief Minister N. Biren Singh, who had earlier said two more accused had been arrested, announced that maximum punishment would be accorded to the perpetrators.

Sonia asked PM Modi for debate in House on **Manipur issue**

New Delhi: Even as Prime Minister Narendra Modi was seen reaching out to Congress Parliamentary Party (CPP) chairperson Sonia Gandhi in Parliament on Thursday, the Congress leader urged him to have a detailed discussion on Manipur issue in the House. Sonia Gandhi made the demand during her brief conversation with the prime minister in the Lok Sabha on the first day of the Monsoon session. Just before the House met for the day, PM Modi took a round to greet various leaders. It is customary for leaders to greet each other on the first day of the Parliament session. As the Prime Minister reached the bench of opposition leaders, he had a brief conversation with the former Congress president. The arliament's Monsoon Session began on Thursday and will continue till August 11.

Tribals demand punishment for perpetrators, separate administration

Imphal: Braving heavy downpour, thousands of tribals in Manipur's Churachandpur district on Thursday raised their demand for a separate administration and stringent punishment for the perpetrators involved in the horrific incident in Kangpokpi district where two women were paraded naked and allegedly gang-raped. The spirited rally, also attended by elders, demanded a separate administration (equivalent to separate state) for the tribals "as they are not safe living with the Meitei community". Raising slogans for a separate administration, the rally commenced from the Lamka Public Ground. Despite heavy rains, the determination of the protesters remained firm as they marched towards the Peace Ground after covering a large part of the hill town. The protesters also demanded Manipur Chief Minister N. Biren Singh's resignation, and immediate intervention by the Central government

Manipur Chief Minister to stay

New Delhi: Manipur Chief Minister N Biren will stay, sources said. Many on social media, including the Congress, have demanded the Chief Minister's removal, alleging massive failure in governance.

There is "no discussion on changing the Chief Minister, rather the priority is to ensure that law and order remains in control," said sources in the government amid reports to the contrary. "The situation in Manipur is under control. The Home Minister spoke to Kuki groups this morning. Assured them of speedy action... The Centre is in constant touch with the state," sources said

Tine people were killed and over 15 injured after a speeding luxury car ploughed into a crowd on the ISKCON bridge in

Ahmedabad on Thursday, police said. The accident occurred around 1 a.m. on the bridge located on the Sarkhej-Gandhinagar highway when the Jaguar, reported to be running at over 100 kmph, ploughed into a crowd gathered there after an accident between two vehicles, a police

The overspeeding vehicle coming from Rajpath Club hit the unsuspecting crowd. The force of the impact was so tremendous that it sent people flying through the air, some landing approximately 25 to Chaos prevailed on the bridge as rescue teams

injured victims were rushed to the Civil Hospital. Among the deceased are a police constable and a Home Guard personnel, who were on duty at the



time of the accident. Kripa Patel, a Medical Officer at Sola Civil Hospital, said that efforts are currently underway to provide medical treatment and support to the remaining injured individuals in the hospital. The student has been identified as Tathya

Pragnesh Patel who is the son of a wealthy builder and is in the second year of his college.

Patel was driving with his friends when he lost control of his overspeeding SUV GJ 01 WK 93, leading to the collision. He has been admitted to CIMS, a prominent hospital in Ahmedabad.

His father, Pragnesh Patel has a criminal history, including involvement in a rape case in Rajkot in 2020.Patel resides in a lavish bungalow named 'Hare Shanti' situated opposite Gokul Farm House in the Gota area in Ahmedabad. Their house is located approximately 700 meters from the SG highway and eight kilometers from the accident

Denying any wrongdoing by his son, Pragnesh Patel said, "Tathya and his friends had left home around 11 p.m. to have coffee. The car is registered under my partner's name and there were two female friends and two male friends accompanying Tathya in the car.

"Pan masala, drugs or liquor -- my son has never done anything in his life.'

Defamation case: Supreme Court to hear Rahul Gandhi's plea today

Delhi court grants bail to Brij Bhushan in sexual harassment case

Delhi court on Thursday granted bail to Bharatiya Janata Party MP and former Wrestling Federation of India (WFI) chief, Brij Bhushan Sharan Singh, in connection with the sexual harassment case of female

Additional Chief Metropolitan Magistrate (ACMM) Harjeet Singh Jaspal of Rouse Avenue Court passed the order after having reserved it earlier in the day. The court has also granted bail plea to

co-accused Vinod Tomar. The accused persons have been directed by the court to not leave the country without its prior intimation and said that they will not, directly or indirectly, indulge in threat or inducement

to the complainants or witnesses. "Please ensure that all the conditions are meticulously followed," ACMM Additional Public Prosecutor (APP)

Atul Srivastava earlier reiterated that Singh may influence witnesses, hence conditions be imposed while granting bail. In the order, the court recorded: " ... APP submits that he is neither opposing nor supporting the bail application. His submission is only that court should deal with bail application as per law,

rules, guidelines and judgements of Supreme Court."Even the Advocate Harsh Bora for complainant said: "If your honour is inclined to grant bail, strict conditions may be imposed."

Representing the accused, Advocate Rajiv Mohan submitted that they will abide by all conditions.

Less than 6 months after 'cake-cutting' parole, Ram Rahim out again



ess than six months after he had held a big bash while on a 40-day parole, rape convict Gurmeet Ram Rahim Singh walked out of a jail in Haryana today after being granted parole for 30 days

This is the Dera Sacha Sauda chief's fifth parole in less than two years and his seventh overall. He was sentenced to 20 years in prison in 2017 for raping two women followers.

Following a controversy over the 40-day parole being given to Ram Rahim in January, Haryana Chief Minister Manohar Lal Khattar had said that getting parole after following all procedures was the Dera Sacha

MUMBAI COVID SCAM: LIFELINE HOSPITAL MANAGEMENT SERVICES ACCUSED OF FAKING ATTENDANCE SHEETS

he Enforcement Directorate (ED) on Thursday arrested two persons in connection with the Mumbai Jumbo Covid centres scam.

The arrested persons have been identified as Sujit Patker of Lifeline Hospital Management Services, a company that received contract to run two Jumbo Covid Centres in Mumbai, and Kishore Bisure, a civic

It has been alleged that although Patker got the contract to run Jumbo Covid Centres, medical staff were not deployed at the hospitals, and government funds were siphoned off.

The duo was produced before a special PMLA court, which sent them to ED custody till July 27.

The ED had initiated a PMLA investigation on November 21, 2022, based on an FIR registered by the Azad Maidan police station, Mumbai. Later, the Economic Offences Wing (EOW) over the probe and filed a charge sheet on April 27, 2023.

During the course of ED's investigation, it was revealed that during the pandemic in March 2020, the municipal bodies took measures and established Jumbo Covid Centres to overcome the scarcity of beds for Covid patients in all the available hospitals in the jurisdiction of Mumbai.

For the purpose of making treatment available to all citizens, these



centres were established with a large number of beds (oxygenated, nonoxygenated, and ICU). It was learnt that Lifeline Hospital Management Services received Rs 31,84,71,634 from the Brihanmumbai Municipal Corporation (BMC) for the supply of medical personnel to the Covid centers.The investigation revealed huge discrepancies in the attendance sheets and documents submitted to BMC by the staff of Lifeline Hospital

Management Services (LHMS). "For the functioning of these Jumbo Covid Centres, contracts were awarded by the BMC to various firms, including LHMS, which was a new company established in 2020, without any experience of providing medical

In this regard, letters were issued to the doctors, nurses, and staff reportedly engaged in the Jumbo Covid Centers of LHMS; most of these letters were returned undelivered to the nostal authorities. Some of the doctors and staff in their replies even submitted that they have never

appeared for an interview and submitted their personal records to LHMS. But on the instructions of Patker and other partners in the firm, the concerned staff of LHMS submitted their attendance in bills to the BMC authorities showing them as regular employees.

"This arrangement was made by a partner of LHMS with Kishore Bisure, to project that the doctor-to-patient ratio was being maintained as per the specifications mentioned in the Expression of Interest (EOI) issued to

"Patker fabricated the bills, despite huge under-deployment of medical staff to the extent of 50-60 per cent, and the same were submitted to the BMC authorities. Patker used to handle liaison with BMC officials and played a key role in the process of allotment of the contract of manpower supply to the Jumbo Covid Centres at Dahisar and Worli to LHMS. He also managed Kishore Bisure and other BMC staff for clearing invoices with fake attendance sheets," the ED alleged.The agency said that Bisure received valuable items, cash, and a laptop from LHMS.

"LHMS was acting in connivance with BMC officials. An offence of this magnitude is not possible without the explicit complicity of senior functionaries of the BMC," read the

he Madhya Pradesh government has appointed retired High Court judge Rajendra Kumar Verma to probe the alleged irregularities in Patwaris recruitment exams, Chief Minister Shivraj Singh Chouhan said on Thursday.

The government said the probe on alleged irregularities would be completed by August 31, and further action would be initiated on the basis of its recommendations. "Retired Judge of Hon'ble High Court Rajendra Kumar Verma has been appointed to examine Group-2, Sub-Group-4, and Patwari Recruitment Examination conducted through Staff Selection Board. In the investigation, complaints related to the above examination and other



relevant points arising during the investigation will also be investigated. Based on the findings of the investigation, appropriate recommendations will be submitted to the state government by August 31, 2023," a post of the CM's official Twitter handle read.

The development came a week after Chouhan had announced a hold to the appointment of selected can-

24-year-old youth died after being electrocuted while using a treadmill at a gym in Delhi's Rohini area, a police official said on

The victim was identified as Saksham, a resident of Sector-19, Rohini. Saksham, a B.Tech graduate used to work in a multi-national company in Gurugram.

Saksham is survived by his father, mother, and a younger sister.

On Tuesday, police received information regarding the death of a youth from the BSA Hospital.

"Upon reaching the hospital, the police team was informed that the victim was brought in an unconscious state from the gym situated in Sector 15, Rohini," said Deputy Commissioner of Police (Rohini), Guriqbal Singh Sidhu.

During investigation, the police reviewed the CCTV footage, which depicted Saksham performing his workout routine. "During the exercise, he sat on one of the treadmills, and it appears that he received an



electric shock while in that position, leading to his fall," said the DCP. In response to the incident, the forensic science laboratory (FSL) team was called to the scene. After examining the treadmill on which the unfortunate incident occurred, the

FSL team concluded that the metal parts of the machine carried an electric current.

The police have registered a case under IPC sections 287 (negligent conduct with respect to machinery) and 304A (causing death by negligence) at the KN Katju Marg police

Recounting the incident, complainant Keshav, who was present at the gym, told police that the incident occurred during his workout on Tuesday. "Saksham, another gymgoer, was also exercising at the time. At approximately 7:15 a.m., after some physical exertion, Saksham took a break and sat between two treadmills to rest. Unfortunately, during this time, he accidentally fell backward," said Keshav in his complaint.

When Keshav attempted to help Saksham, he too received an electric shock. Reacting swiftly, Keshav turned off the power switch to prevent further harm. Other people at the gym rushed to aid Saksham by rubbing his hands and feet and administering CPR, but regrettably, their efforts yielded no response. Consequently, Saksham was immediately taken to a hospital for medical attention, while Keshav returned home. According to the FIR, the gym in question was being managed by one Anubhav Duggal.

TN sanitary worker cleans sewage with bare hands, officials issued show cause notices

12 KILLED IN RAIGAD HILLSLIDE, **MORE TRAPPED**

welve villagers and a rescue team member were killed when a portion of a 550-metres hillock crashed on a large part of the Irshalwadi tribal village near Khalapur in Maharashtra's Raigad district, officials said here on Thursday

The incident happened late on Wednesday. Around 10 persons were rescued from the slush and stone while another 80 people are still feared trapped with a massive rescue operation on a war-footing mounted to rescue them.

Chief Minister Eknath Shinde rushed to the tragedy spot -- around 100 kms from Mumbai -- and monitored the situation, while Deputy CM Ajit Pawar was stationed at the State Disaster Management Centre.

According to state government officials, the disaster occurred around 11.45 p.m. on July 19 when the region was lashed by torrential rain.

A portion of the tall hillock, over 550 metres high, under which the tribal village nestled, suddenly crashed on Irshalwadi, crushing an estimated 30-40 hutments and trapping the residents in them.

According to Pawar, the Irshalwadi village population was 228 of which more than 100 people have been affected by last night's tragedy.

On learning of the disaster, Raigad district administration and police, SDRF, NDRF teams rushed to the spot and launched a massive rescue oper-



ation as rains continued.

The hilly terrain with huge boulders and stones scattered hampered the rescue teams who could work only with hammers to save the people as the clock ticked away.

This morning Shinde reviewed the situation and in view of the difficulties encountered in the hazardous terrain as cranes and heavy machinery cannot be taken there for the rescue operation. He said two helicopters would be deployed for the rescue mission. Pawar said that while choppers are ready for the mission, they would not be able to land in the region due to the stormy weather conditions. Several ministers, police and civilian officials from different departments and the Navi Mumbai Municipal Corporation and Panvel Municipal Corporation have also

FIREMAN DIES EN ROUTE TO RESCUE MISSION

Raigad: An officer of the Navi Mumbai Fire Brigade, rushing to help the rescue mission in Raigad, collapsed and died of a heart attack en route to Irshalwadi where a hillslide occurred, officials said here on Thursday

Early this morning, Assistant Station Officer Shivram Dhumne, 52, of the Belapur Fire Brigade was deployed on the team to join the massive search and rescue operations for the victims of the hillslide.

While climbing up the steep path at the tragedy site, Dhumne suddenly collapsed, suffered a massive heart attack and breathed his last there, said Chief Fire Officer Shirish Aradwad.

Dhumne's colleagues and officers of the Navi Mumbai Fire Brigade and the civic corporation have grieved over the tragic on-duty passing and his body was brought from Raigad and handed over to his family for the last rites.

Infant slips out of man's arms, washed away in flooded Thane drain

n a heart-wrenching tragedy, a fourmonth-old infant reportedly slipped from a man's arm and plunged into a flooded drain near Thakurli town of the district, here on Wednesday afternoon.

The shocking incident occurred when an Ambernath-bound suburban local train had stopped between Thakurli and Kalvan stations as the railway tracks were flooded owing to torrential rains in the district since last

After waiting for over an hour, many of the commuters in the train jumped off the train and started walking to their respective desti-

One of the coaches of the train was over a raging drain dotted with trees and thick bushes on both sides, and there were some utility pipelines beside the railway tracks.

Thane social worker Binu Varghese, citing local eyewitnesses, said that most commuters managed to safely cross over the drain to the other side. A young woman and her brotherin-law, along with her infant child, also took courage to walk over the narrow pipes on the

Suddenly, the child, which was in the man's arms, slipped off and dropped straight into the swirling dark waters of the swollen drain below, even as the horrified mother started screaming.

As the rain continued and the drain was flowing fast, there was little they could do except wait for help, even as videos of the woman and her relative pointing towards the drain went viral.

After word passed to the Thakurli and Kalyan stations, teams of the Railway Protection Force, Government Railway Police and SDRF rushed to the spot to carry out a search operation. The rescuers with ropes and other gear scoured the vicinity, including the bushes but the infant remained untraced till

darkness fell and the rainfall continued.

"I am in constant touch with the rescue teams but so far there is no sign of the infant. The mother is inconsolable and in a state of shock... The authorities are trying to ascertain the details of the family and are expected to give an update later," said Varghese.

A SDRF official said that the 'child' is missing and all efforts are on to trace the infant.

The entire coastal belt of Maharashtra comprising Mumbai, Thane, Palghar, Raigad, Ratnagiri and Sindhudurg districts has experienced very heavy rains in the past 24 hours, with many districts put on red or orange alert till Saturday.

The state government closed offices early today and allowed the staffers to leave for their homes in view of the incessant rains. The Chief Minister Eknath Shinde has

termed the incident as unfortunate. This evening, the Chief Minister also took a review of the rainfall and flood situation affecting large parts of the state, the transport and communication and all rescue agencies are kept ready for deployment in any emer-



ED SEIZES ILLEGAL 'SAI RESORT' IN PROBE AGAINST EX-MAHARASHTRA MINIST

he Enforcement Directorate (ED) stated on Wednesday that it has taken possession of 'Sai Resort NX', constructed on land located in

Murud, Dapoli, Ratnagiri, falling under Coastal Regulation Zone (No Development Zone) in connection with a money laundering probe against Anil Dattatray Parab, former Maharashtra minister.

"The action has been initiated after the Adjudicating Authority for PMLA confirmed the provisional attachment of assets worth Rs 10.20 crore," said an official.

The ED initiated the investigation based on a complaint filed by the Ministry of Environment, Forest, and Climate Change against Parab, Sai Resort, Sea Conch Resort, and others before the Judicial Magistrate, Dapoli, for violation of Section 19 and Section 15 read with Section 7 of the Environment (Protection) Act.

At a later stage, an FIR was also registered at the Dapoli Police Station under various sections of the IPC.During the investigation, the Dapoli Police found various other crimes related to offences under various sections of the IPC and the Prevention of Corruption Act, which were also included in the FIR.

"The ED Investigation has revealed that Parab

and his close associate, Sadanand Kadam, hatched a conspiracy and obtained illegal permission from the revenue department authorities, state of Maharashtra, through forgery & misdeclaration for the construction of twin bungalow (Ground + 1 Floor) on a piece of agricultural land falling under the "No Development Zone" and subsequently constructed an illegal resort, namely "Sai Resort NX," having Ground + 2 Floors in blatant disregard of CRZ-III rules and regulations," said the official.

The official stated that the permission for the construction of the twin bungalow was obtained in the name of the earlier owner without his knowledge, and even the revenue department authorities, knowing well that any construction is prohibited over the said piece of agricultural land, granted permission because of undue pressure and influence. Thereafter, the gram panchayat was deceived, misled, cheated, and pressurised to transfer the land along with the building in the name of Anil Parab to legitimize the illegal construction of "Sai Resort NX.

Anil Parab, with the intent to utilize his unaccounted money and conceal his identity as the real owner, paid expenses for construction in cash before the registration of land in his name so that in the future, if any violation comes to light, the onus could be shifted to the erstwhile owner

When various complaints regarding the illegal construction of Sai Resort NX came under media scrutiny, a benami transaction was executed wherein Anil Parab sold the said land on paper to Sadanand Kadam to conceal the illegalities and irregularities vis-a-vis the construction of the resort within CRZ-III, i.e., the No Development Zone.

During the course of the investigation, the ED attached assets worth Rs 10.20 crore in the form of land located at Gut No.446, Murud, Dapoli, Ratnagiri, valued at Rs 2,73,91,000, and Sai Resort NX, constructed on the said land, valued at Rs 7,46,47,000.The Adjudicating Authority for PMLA confirmed the provisional attachment of these

The ED has arrested two persons, Sadanand Kadam, and Jayram Deshpande, the then SDO, Dapoli. It filed a Prosecution Complaint on May 6. Further investigation into the matter is ongoing.

MULTIPLE SOCIAL MEDIA PLATFORMS DON'T AFFECT MENTAL WELL-BEING

re use of many different social media platforms is not a significant risk factor for the well-being of the users, according to a study. Social media has become an integral part of everyday life. However, numerous studies have produced conflicting results on how the use of these applications affects the mental health of their users. "Previous studies have only looked at single variables such as depression or general health. Or the type of social media use was not clearly defined," said Sophie Lohmann, from the Max Planck Institute for Demographic Research (MPIDR) in Rostock, Germany. The new study, published in the journal PLOS Digital Health, showed that people who use multiple social media channels are no happier or unhappier than others. "There is very little correlation between the use of multiple social media platforms and the outcome variables, such as relationship satisfaction, financial satisfaction, general satisfaction, trust in the state, and so on. When we apply our method, all negative effects disappear completely," Lohmann said. The assumption that the use of multiple channels leads to overload is not confirmed. Further, the researchers said the topics are diverse and, above all, very complex. It is therefore important to define exactly what is meant by 'social media use' and not to lose sight of the complexity of the platforms. "Twitter is not the same as Facebook, which is not the same as TikTok. The way people use the different channels is very different. This must not be neglected in research," Lohmann said. "In the future, more attention needs to be paid to operationalisation in social media research. It needs to be clearly defined what social media use means and what kind of use has which effect."

UNRAVELLING THE UCC

n December 9, 2022, BJP MP Kirodi Lal Meena introduced a private member bill on India's Uniform Civil Code (UCC) in the Rajya Sabha that fuelled a fresh debate on an issue, which saw no resolution even in pre-independence India and continues to haunt the political climate of the country even today.

The sensitive nature of the issue besides giving political mileage to the BJP, affects various political parties, with respect to their stand on the issue.

Plus, it also puts various religious communities coming under the purview of the UCC to give up their respective Personal Laws, particularly the Muslims, which are the

largest religious minority in the country. Let's dissect the political motives first and then the response of the affected communi-

First, the audacious move of tabling the Private Member Bill in the Rajya Sabha came just one day after the BJP secured victory in the December 2022 Gujarat Assembly polls.

It reinforced the BJP's political manifesto of enforcing Hindutva, which may also serve as the lynchpin of its political strategy for the upcoming general elections in 2024, by polarising the public.

Further, the second move to seek public opinion on the proposed UCC, in absence of any draft of the proposed Bill, was a very astute move by the BJP.

As it came within a week of the opposition parties' meeting in Patna in June to formulate a united front and strategy to counter the BJP in the upcoming 2024 elections. As expected the move sowed division within the opposition's ranks. Further, it saw an immediate half-baked response from the so-called leaders of the religious minorities -- particularly the Muslims.

Muslim religious and community leaders without batting an eyelid immediately started opposing the UCC, and didn't stopped to dwell on what grounds they were protesting and we saw a plethora of sentimentally rich and logically poor responses coming forth from them. The only common stand they took was that they oppose any interference in the Muslim Personal Law.

But I'm sure, neither the leaders nor their supporters know which Muslim Personal Law they are talking about. The one codified by any Muslim rulers like the Mughals, the Khiljis or the Tughlaqs or the ones before

them? The answer is NO. In fact, the British colonialists codified the prevailing Muslim Personal Law, without any consultations from any Islamic jurist or scholar.

Before 1937, Muslims of all denominations, all over India, followed the uncodified local Hindu customs, practices and usages in addition to their personal law as per the Sharia. So the British just concurred on codify ing the prevalent practices relevant to the marriage, divorce etc., but changed the ones relating to succession and division of property, in the case of Muslims.

It would be interesting to know at whose behest the colonial rulers codified the Muslim Law of Succession and Inheritance. It was none other than MA Jinnah, the leader of the Muslim League.

The Shariat Act of 1937 was imposed on Indian Muslims as a win-win political deal between the British, keen to divide Hindus and Muslims, and the Muslim League, keen to lure the Muslims away the Congress. In a manner this also suited Jinnah's political strategy on how to secure a separate country for the Muslims, but it had an added personal angle also to it.

MA Jinnah's daughter Dina married Nevile Wadia -- a Parsi, against his wishes, though he himself had married a Parsi lady, Rattanbai Petit. To disown Dina and leave no inheritance for her, Jinnah made use of the recently introduced Shariat Act 1937 and nominated his sister Fatima as his successor. The Act, a joint strategy of the British and the League, contained provisions to sabotage the Islamic Sharia, by secretly smuggling the Hindu customs and usages into the 1937 Act to save the property rights of the Muslim leaders, Jinnah and the zamindars from harm by the Islamic Sharia. Did the Shariat Act of 1937 -- now acclaimed as the holy law of Islam -- contain Hindu law provisions to secure the property rights of the League leaders? Yes, it does.

Historian, KK Abdul Rahiman in The History of the Evolution of Muslim Personal Law in (1986) says the British gave strength to customs and usage that had long been adhered to particularly in matters of succession by sections of Indian Muslims.

Further, we have to realise that the UCC would not only affect Muslims but also Hindus, Sikhs, Christians, Jains, Jews, Parsis and other minorities and scheduled tribes in the country. And at the moment it is just a political gimmick of the government to polarise the electorate and also sow seeds of discord amongst the unified opposition. Muslim leaders need to bring other communities leaders at the same platform and also inform their Hindu brethren that the UCC will abolish the HUF provisions for filing Income Tax, thus it would increase the tax liability of Hindus also.

The UCC Bill has been introduced as a political reform by the BJP, guided by principles of Hindutva, as a response to replace the existing complicated set of personal laws. These personal laws are so complicated that even the Britishers didn't dare to interfere with them. Further, the Constituent Assembly, besieged by two schools of thought, one supporting the UCC argued that it provided for the emergence of a secular and progressive nation, while the opponents felt it to be conflicting with the ideas of inclusiveness and pluralism, deemed it fit to circumvent the issue and leave it at the moment and thus chose to include it under the Directive Principles of the constitution, under Article 44 of the Constitution, and leaving it

for the future generations to sort it out.

A realistic and practical understanding of how personal laws operate will indicate that the state's organs and the Indian society are yet not ready, even after 73 years for the substantial revamp that such legislation would bring. Instead of gunning for political gains we should try to reflect the rich Indian diversity of traditions and their importance in common Indians' daily life.

Lastly, the manner in which the Muslim leadership responded to the government's move, shows its complete immaturity and the set manner of its traditional, out of touch with reality reactive response, completely bereft of any political nuances and strategy, which was also evident during the Babri Masjid movement, Triple Talaq issue etc.

Though it is high time but still there is time for the Muslim leaders to formulate a Unified Strategy and response to the UCC, in consultation with leaders of other religious minorities and political parties, so that this time they don't get defeated by the government in its anti-Muslim campaign, though the chances of any such endeavour seem very

15 INDO-CANADIANS ARRESTED IN AUTO THEFT RING, STOLEN GOODS WORTH \$9 MN RECOVERED

anadian police have arrested 15 Indian-origin men and laid 73 charges against them in an alleged organised auto theft ring, while recovering stolen goods worth more than 9 million dollars.

Dubbed Project Big Rig, a joint task force was formed in March this year to investigate a series of tractor trailer and cargo thefts in Peel and across the Greater Toronto Area, the Peels Regional Police said in a statement on Wednesday.

The investigation led to the recovery of 28 containers of stolen cargo valued at \$6.99 million. An additional 28 stolen tractors and trailers valued at \$2.25 million were recovered, taking the total value of recovery to \$9.24 million.Addressing a news conference on Wednesday, Peel Regional Police Deputy Chief Nick Milinovich said that estimated \$1.8 billion worth



of goods travel through the Peel region every day, making it the largest cargo hub in Canada.

"Often we are seeing that the proceeds of cargo theft and auto theft are used to fuel and fund organised crime... This often involves drugs and guns that are then directed towards our communities. The recovered

cargo and vehicles through this investigation have removed millions of dollars out of the hands of organised

Peel police commercial and auto crime unit said the suspects stole products by cutting through the

crime," Milinovich said. Detective Mark Haywood from the fences of logistic facilities as well as

Trump loses retrial bid in defamation case

Trump has lost a retrial bid in a case in which a jury found him liable for sexually abusing and defaming columnist E Jean Carroll.

E. Jean Carroll, 79, had accused Trump of raping her in a Manhattan department store dressing room in the mid-1990s, and then branding the incident a hoax in an October 2022 post on his Truth Social platform. The jury found Trump guilty of battering the columnist, but stopped short of finding the former President guilty of rape.

Trump has been ordered to pay \$5 million in damages.

The former President's attorneys had argued in their bid for a new trial that "the Court should order a new trial on damages or grant remittitur because contrary to Plaintiff's claim of rape, the Jury found that she was not raped but was sexually abused by defendant during the 1995/1996 Bergdorf Goodman

In a 59-page decision on Lewis Kaplan ruled the jury did not reach "a seriously erroneous result", in calculating the amount of damages, as argued by Trump's lawyers, and dismissed his request for a new trial.

Judge Kaplan, who presided over the original trial, wrote that the trial evidence demonstrated Trump "raped" Carroll in the plain sense of the word.

The finding that Ms Carroll failed to prove that she was 'raped' within the meaning of the New York Penal Law does not mean that she failed to prove that Mr Trump 'raped' her as many people commonly understand the word 'rape'," the BBC quoted Judge Kaplan as

"Indeed, as the evidence at trial recounted below makes clear, the jury found that Mr Trump in fact did exactly that."

Roberta Kaplan, the lawyer representing Carroll, celebrated the ruling.

Mogadishu: The Somali National Army (SNA)'s elite forces have killed 30 al-Shabab militants during a



fierce gun battle in the Middle Shabelle region of central Somalia, officials confirmed.

Abdirahman Yusuf Al-Adala, the Deputy Minister for Information, on Wednesday told Somali national news agency that the latest military offensive against the militants was carried out as they plotted to stage attacks, Xinhua news

"Our special forces, Danab and Gor-gor units, conducted a successful operation against al-Shabab militants this morning, the forces also recovered weapons and other military equipment and destroyed terrorist bases during the operation," Al-Adala said.

He added that the elite forces are still pursuing the al-Shabab militants, but did not clarify whether there were casualties on the side of the

The al-Shabab militants have not commented on the latest military onslaught, as the Somali Army in conjunction with regional and international troops intensify efforts to neutralise the al-Oaeda-linked armed group.

SC CONCERNED OVER RISING CHEETAH DEATHS, SAYS IT DOES NOT PRESENT GOOD PICTURE

The Supreme Court on Thursday said that deaths of 40% of translocated cheetahs from Namibia and South Africa in less than a year painted a worrying picture of the state of affairs, as it suggested the Union government to consider if they can be shifted to some other sanctuaries.

The court also sought to know why all the cheetahs were only sent to the Kuno National Park in Madhya Pradesh. A bench of Justices B R Gavai, J B Paridwala and Prashant Kumar Mishra pointed out that two more deaths have happened last week and asked the government not to make it a

"Why is this becoming a prestige issue? Please take some positive steps. Also, why were they all put in one place instead of being spread? 40% deaths occurring in less than a year does not paint a good picture," the bench told Additional Solicitor Solicitor General AishwaryaBhati,

appearing for the Centre. The court suggested that some of the cheetahs could be shifted to Rajasthan, particularly at Jawai National Park, which is very famous for leonards. As many as 20 cheets were translocated to India from Namibia and South Africa in September 2022 and February 2023 in two batches. Eight cheetahs, including three cubs, have died at Kuno National Park since March this year, due to various reasons. Bhati assured the court of taking all requisite steps in this regard. She said when similar projects were implemented in Rajasthan, deaths of tigers occurred within enclosures. She also submitted at authorities at the highest level have taken cognisance of these deaths. "After all, this is a prestigious project for the country," she said.

Bhati also submitted that the deaths are not alarming, as up to 50% of deaths were anticipated within the first year of the project. "We want to know. Prima facie it appears our conditions do not suit them. They reportedly suffered from respiratory problems. One was detected with kidney ailment," the bench told Bhati.



choice but to take this step in light of its financial circumstances."

"The last few years have been incredibly difficult for Bron, and things have only gotten more complicated over these past months. Covid and the many other issues affecting the media industry the last few years, most recently the strikes, have made

Bron's ability to continue its existing busi-

ness impossible," he added.

According to Variety, in recent months, Bron's co-financing deals with Metro-Goldwyn-Mayer and Warner Bros. sunsetted. He further mentioned in the statement, "Thank you to our many friends who have been there to support us. Thank you to the BRON team and to our incredible creative, production, and business partners. Thank you to the many production financing partners and our corporate backers for

supporting us for all these many years."

NEW ZEALAND REGISTER 1-0 WIN OVER NORWAY

Tew Zealand celebrated a historic victory on Thursday at a nearly full Eden Park, edging Norway 1-0 in the opening match of the 2023 FIFA Women's World Cup,

This triumph put an end to its previous poor campaign performance. In its five World Cup outings, New Zealand failed to reap any victory in

the past 15 games. The winning goal was scored by Hannah Wilkinson in front of 42,137 spectators, while Ria Percival failed to add the second as her penalty was thwarted later by the woodwork, a

Xinhua report said. Co-hosted by Australia and New Zealand, the ninth edition of the Women's World Cup is slated to run from July 20 to August 20. This is the first time the tournament is hosted by more than one country and includes 32 teams.

A shooting in Auckland on



Thursday morning left three people, including the gunman, dead and six others injured, casting a pall over the Women's World Cup's outlook.

"FIFA extends its deepest condolences to the families and friends of the victims following the incident," said the organisation, which also observed a moment of silence before the match's kickoff.

New Zealand, with a historically poorer record against Norway who boasted three victories from equal official matches, fielded Alexandra Riley in her fifth World Cup appearance. Ada Hegerberg, the women's Ballon d'Or winner, spearheaded Norway's frontline.

The first half was rather lacklustre, devoid of any goals. New Zealand, however, emerged strong after the break with a well-coordinated play. Jacqui Hand initiated the move from their own territory, sprinted down the right, and rolled the ball across for Wilkinson to tap in from close range, marking her third World Cup goal.

Norway nearly equalised in the 81st minute, but Tuva Hansen's attempt met the crossbar.

A penalty was awarded to New Zealand in the 90th minute after a VAR review, but Percival missed the chance, hitting the bar.

The away team made a final push in the closing minutes, but it proved fruitless against the steadfast defense of New Zealand players.

Sakshi Malik criticises WFI ad-hoc panel's decision to exempt Vinesh, Bajrang from Asian Games selection trials

The 30-year-old Sakshi, who was a prominent figure along with Vinesh and Bajrang during the wrestlers' protest against the Wrestling Federation of India (WFI) chief Brij Bhushan Sharan Singh, revealed that she along with others demanded an extension in the trial date so that they can train.

"We had demanded time from the Ad Hoc committee as we were unable to train.



Accordingly, they sent a letter giving us time and said that the trials will be conducted around August 10.

Notably, a number of junior wrestlers, including the current U20 World Champion Antim Panghal, have raised concerns about the perceived "unfair" exemption of Vinesh and Bajrang from the selection trials.
