Denied ticket, BJP MLA floats new party to contest in 40 Assembly seats in MP

fter failing to get a ticket for himself from his own Bharatiya Janata Party (BJP) or the Congress, four-time MLA from Maihar seat Narayan Tripathi has decided to contest next month's Madhya Pradesh Assembly elections on his own party.

He has floated the Vindhya Janta Party (VJP) to contest the elections.

Tripathi, who has won the Maihar seat twice on BJP ticket and once each on Congress and Samajwadi Party tickets and has been demanding a separate Vindhya region, which comprises as many as 30 Assembly seats in Madhya Pradesh, released the first list of 25 VJP candidates in Bhopal on Friday.

Out of these 25 seats, at least 19 are part of the Vindhya region, which is also Tripathi's home

Out of these 25, 18 seats were won by the ruling BJP in the 2018 Assembly polls.

The 25 VJP candidates, include local leaders of both the ruling BJP and the opposition Congress, who failed to get tickets from their respective parties to contest the November 17 polls.

Tripathi himself is contesting polls from his old seat in the newly-created Maihar district for the



sixth time. Only once (in 2008) has Tripathi lost from Maihar seat, which has a predominantly decisive Brahmin population. He had won the seat for the first time as a SP candidate in 2003, but lost in 2008 to the BJP. He wrested the seat from the BJP on Congress ticket in 2013, but quit the Congress two and half years later, to win the 2016 by-election as a BJP candidate.

He retained the seat on a BJP ticket in 2018 polls also, but quit the party after denial of ticket recently. His efforts to get Congress ticket too turned futile, leaving him with no other option, but to contest himself.

Among the other 24 candidates named in the newly created party's first list, at least two candidates were associated with the BJP, including Hari Om Gupta, a distant relative for ex-MP minister and senior BJP leader Umashankar Gupta, from Satna seat and Phoolmati Devi from Jaisingh Nagar-ST seat of Shahdol district. Phoolmati is the BJP-supported Shahdol district panchayat Vice-Chairperson, who quit the BJP recently.

Also, in Deotalab seat of newly-created Mauganj district, the VJP has decided to field Kunj Bihari Tiwari, the husband of Congressbacked Nai Garhi Janpad Panchayat chairperson. The seat is already witnessing a high-profile battle between the third time BJP MLA and current Speaker Girish Gautam pitted against his nephew Padmesh Gautam of the Congress.

"We will field at least 40 candidates, all for the cause of a separate Vindhya Pradesh. No matter whether we win or lose, or who loses or wins due to our presence in the contest, all we know is that these candidates will be the voice for a separate Vindhya Pradesh," Tripathi told the press.

RBI fixes price for premature redemption of Sovereign **Gold Bonds**

he RBI on Friday announced a price of Rs 6,079 per unit for the premature redemption of sovereign gold bonds issued

by the government. The price is based on the simple average of closing gold price of 999 purity of previous three business days from the date of redemption as published by the India **Bullion and Jewellers** Association Ltd (IBJA).

"Accordingly, the redemption price for premature $redemption \ \bar{du}e \ on \ October$ 30, 2023 shall be Rs 6,079 (Rupees Six thousand seventy-nine only) per unit of SGB based on the simple average of closing gold price for three business days i.e., October

25-27, 2023," the RBI said. Under the Sovereign Gold Bond Scheme, premature redemption of Gold Bond may be permitted after the



fifth year from the date of issue of such Gold Bond on the date on which interest is payable. These bonds were issued October 30, 2017.

Accordingly, the next due date of premature redemption of the above tranche is October 30, 2023, the RBI

ven as Manipur continues to deal with the devastating ethnic crisis six months after it began, there has been an outbreak of African Swine Fever (ASF) that has killed hundreds of pigs, dealing a major blow to farmers in seven districts in the northeastern state.

The Manipur Veterinary and Animal Husbandry (VAH) department has stepped up measures to combat the ASF as the contagious disease has been reported from pig farms in at least seven districts --Imphal West, Imphal East, Ukhrul, Bishnupur, Thoubal, Kakching and Kamjong.

The VAH department officials on Friday said that the latest outbreak of ASF has been confirmed at five piggery farms located at Lilong Chajing Mamang Leikei, Konthouiam Maning Leikai, Loitang Khur Luker and Sairemkhul in Imphal West district. A notification issued by the Deputy Commissioner (Imphal West) on Thursday said that particular farms have been declared as epicentres and areas



within one km radius of those farms as infected zones. Further, areas within a 10 km radius from those farms have been declared as surveillance zones, and all of them constitute controlled areas. The notification strictly prohibited movement of pigs (dead or alive) in the controlled areas along ovement and sale of nork and feed within the infected zone and materials that could have come in contact with the infected or suspected to be infected animals.""Culling of all pigs of the infected zone shall be done by the officials of Veterinary and

Animal husbandry Department, Manipur," it said, adding all equipment/tools as well as vehicles used in the farms that have pigs, either infected or suspected to be infected, shall be restricted from movement without protocols. VAH Director Ibotombi Singh said that since the ASF has been confirmed in the laboratory reports, department officials and doctors are working round-the-clock to combat further spread of the epidemic."We have sent out four to seven teams of our department's doctors and staff in every district of the state to fight the spread of ASF. Besides taking up culling of pigs at the infected zone, they also intensified surveillance activities at the surveillance zones," he added. Awareness programmes have also been taken up at other ASF-free districts, Singh said, adding that a state-level awareness programme on it would be held soon. The highly-contagious ASF often creates havoc in various ern states including Mizoram every year, where during 2021 and 2022, over 33,400 pigs were killed, affecting over 10,000 families besides causing a

Ukrainian attack on Russian nuclear facility thwarted

Ukrainian attack involving multiple drones has been thwarted in the Russian city of Kurchatov, home to the Kursk nuclear power plant, according to civilian and military officials.

Unconfirmed reports claimed that one of the aircraft damaged a nuclear waste storage building at the site, RT reported.

The spree of incidents happened on Thursday evening in the Kursk Region, which borders Ukraine. The Russian Defence Ministry reported intercepting a fixedwing drone over the Russian territory on two occasions,



about two hours apart, while the power plant's press service said it was attacked by three enemy drones.

Kurchatov is located some 60 km from the Ukrainian border. The statement by the civilian authorities reported no damage or casualties on the ground, saying that all four units of the facility were operating normally.

Three of them are currently online, while one is undergoing a shutdown procedure ahead of being decommis-

sioned, it said. The oldest reactor, which first went operational in 1976, has not been generating power since late 2021, RT reported.

The news outlet SHOT claimed that the incident was more serious than according to official statements, reporting that the third drone "fell next to a nuclear waste storage and blew up". The report said the blast caused minor damage to the infrastructure, but didn't hurt anyone.

Moscow has accused Kiev of launching multiple attempts to sabotage its crucial energy infrastructure, including nuclear power plants, amid ongoing Russian-Ukrainian hostilities, RT reported.

Maha mass-poisoning: Accused's ex-flame procured rare poison from Mumbai, nabbed

n a fresh twist to the sensational mass-poisoning of a five-member family from Mahagaon, the Gadchiroli police have learned that a former alleged boyfriend of one of the two accused women helped her procure a rare poison from Mumbai which she used to killer her relatives. officials said on Friday.

The man, identified as Avinash Tajne, aged around 30, made the payment to a firm from where the lethal material - the name of which has not been disclosed - was

obtained. He was arrested from Buldhana late on Thursday, and remanded to police custody for four days

till Monday, said an official. The Gadchiroli police cracked the sensational case of the mystery deaths of five persons of a single family by arresting two close women relatives who executed the gory cold-blooded crimes for vendetta and a property dispute - as IANS had reported on Oct. 18.The deceased family members were: Shankar P. Kumbhare (died September 26), his wife Vijaya S. Kumbhare, (death September

27), their son Roshan S.

Kumbhare (passed away on October 15), the couple's two daughters - Komal Dahagaonkar (died October 8) and Varsha Urade (death October 14). Two others another son from New Delhi and family driver Rakesh Madavi luckily survived the poisonous ordeal, and lived to tell the tale to the investigating teams. Shaken by the multiple deaths in barely a fortnight, Gadchiroli Superintendent of Police Neelotpal sent up special investigation squads to probe the matter and cracked the case within 48 hours, nabbing the accused women duo

Liking an obscene post not Boost for Telangana Congress as eight BRS, BJP leaders switch loyalties an offence: Allahabad HC

n a significant verdict, the Allahabad High Court has held that liking an "obscene" post on social media does not constitute an offence but the act of sharing or reposting such content will lead to legal consequences.

The court, in its ruling on Wednesday, explained that sharing such a post falls under the category of "transmission" as per Section 67 of the Information Technology (IT) Act, and will be subject to penalties.

Justice Arun Kumar Singh Deshwal made these remarks as he dismissed the ongoing criminal proceedings against Mohd Imran Kazi from Agra, who had been charged under Section



67 of the IT Act and other sections of the Indian Penal Code for liking a post related to unlawful assembly.

"I do not find any material which could connect the applicant with any objectionable post, as there is no offensive post available in the Facebook and WhatsApp accounts of the applicant. Therefore, no case is made

out against the applicant." Justice Deshwal clarified that while the IT Act considers transmitting obscene material as an offense, in this

particular case, "the applicant has liked the post of one Farhan Usman for unlawful assembly, but liking a post will not amount to publishing or transmitting the post, therefore, merely liking a post will not attract section 67 IT Act". The court also highlighted that Section 67 of the IT Act pertains to obscene material and not to provocative material.

Kazmi, faced a criminal case for liking "provocative" messages on social media, which resulted in the assembly of about 600-700 individuals from the Muslim community for a procession conducted without permission. The Chief Judicial Magistrate (CJM) in Agra took note of the charge sheet and issued a nonbailable warrant against him on June 30

n a major boost to the Congress in Telangana ahead of next month's Assembly elections, eight leaders from ruling BRS and BJP joined the party on Friday.

General Secretary K.C. Venugopal, incharge for Telangana, Manikrao Thakre, state unit President A. Revanth Reddy and CLP leader Mallu Bhatti Vikramarka were present.

Other leaders who joined the Congress are former MLA Enugu Ravinder Reddy, former MLC Nethi Vidyasagar, former MLC Santosh Kumar, former MLC Akula Lalitha, former MLC Kapilawai Dilip Kumar and Neelam Madhu.



It's a home coming for Raj Gopal Reddy, who had quit the Congress to join the BJP last year. He had also resigned from the Assembly to force a bypoll but failed to get re-elected on BJP ticket.A former MP, Raj Gopal Reddy is the brother of Congress MP

Komatireddy Venkat Reddy. His return will further strengthen the Congress in undivided Nalgonda district.Narasimhulu was a TDP MLA from the Tungathurthi constituency but parted ways with the party in 2018. He had joined the BJP but quit

the party in 2021 to switch loyalties to the TRS (now the BRS). Narasimhulu, $\frac{1}{2}$ who was unhappy with BRS P:resident and Chief Minister KCR for denying him ticket, had called on Karnataka Deputy Chief Minister D.K. Shivakumar in Bengaluru on September 29.

At least a couple of those who joined the Congress on Friday are likely to get the tickets to contest the November 30 election. The latest joining have further boosted the morale of the party, which is confident of wresting power from BRS. Following the victory of Congress in Karnataka elections, several leaders from the BRS have defected to the Congress. They included former minister Jupally Krishna Rao and former MP Ponguleti Srinivas Reddy. Both have been fielded.

The Congress has already announced candidates for 55 out of 119 Assembly seats and announced

Attending an event, 'Pradhan Mantri Matru Vandana Yojana', Shinde also distributed an amount of Rs 321.57 lakhs online to 8.14 lakh mothers under the scheme in the presence of Union Ministers Smriti Irani, Munjapara Mahendrabhai, state ministers Aditi Tatkare, Mangal Prabhat Lodhan and others.

Shinde said that the women who are the 'mother power', work to build the society and a new generation and the state government is prepared to solve their problems.

He pointed out that through Prime Minister Narendra Modi's efforts, the women have got reservations in parliament and assemblies, lakhs of toilets were built in households under the Swachch Bharat Abhiyan, the names of women have appeared under homes through the Pradhan



Mantri Awas Yojana, and others.

"For the first time in history, PM Modi launched a nutrition tracker to check whether mothers and children are getting proper nutrition services. Irani said that the Centre will pay the insurance premium for Anganwadi workers, the government will give Rs 12,800 to each for purchase of mobiles phones, and provide help for the skill development of the helpers. She added that soon the Centre will notify starting 1,000 nurseries for children of women going for employment in urban areas, and other schemes for the safety and security of the women. 

BJP leader's SUV rams couple in Bihar's Purnea, wife dead

speeding SUV of a BJP leader mowed down a husband-wife couple's in Bihar's Purnea district, leading to the woman's death, police said on Friday.

Pankaj Kumar Pandit and his wife Kalpana Devi were returning home when a speeding SUV rammed their bike at 11.15 pm on Thursday near Harda Basti under Mangra police station.and also dragged them around 500 metres before the occupants stopped the vehicle and fled from the spot.

Kalpana died on the spot while Pandit was referred to PMCH Patna in critical condition.

"My elder brother and his wife were returning home on a bike and were just 500 metres away from the village when a speeding vehicle rammed them. The SUV belongs to BJP leader Rajesh Yadav. He was travelling with his entire family when the accident took place. The driver of the vehicle dragged them for five hundred metres



before they left the vehicle and fled from the spot. The impact of the accident was such that all airbags of the SUV opened up," said Munna Pandit, brother of victim.

The police said that the SUV having registration number BR 11AR 0001 was coming from Gedabari in Katihar and its speed was more than 100 kmph when the accident occurred. Following the accident, local police seized the vehicle.

Contacted, Rajesh Yadav claimed that he was not in the SUV at the time of accident and only the driver and a body guard were inside.

Chandigarh | Agencies ver 200 farmers, government officials and industry members on Friday participated in a farmer outreach event in the Rania block in Haryana to strengthen the efforts to end stubble burning in the area.

The event was organised by the CII, which is supporting field initiatives in 430 villages in Punjab and Haryana promoting alternatives to stubble burning through awareness sessions, machinery support and technical

The event was supported by Apraava Energy which is partnering with CII in its crop residue management initiative in Haryana.CII and Apraava have been working on crop residue management in the Sirsa district since 2019 and have adopted 26 villages covering 33,770 acres of land and 6,795 farmers. Overall, in Haryana CII has adopted 77 villages in partnership with corporate, including Apraava Energy, SBI Card, ONGC and Birlasoft, where six custom hiring centers with 240 machines have been set up which are managed by farmer's cooperatives formed by CII.

In 2022, incidents of stubble burning were reduced significantly in the 26 intervened villages in Sirsa due to the project interventions as hundreds of farmers joined the project to create a zero-stubble burning movement.

While the focus of interventions till last year was on in-situ measures, in the current

season, village-level ex-situ interventions for the management of straw are also being promoted by CII in Sirsa.

A key highlight of the event was the inauguration of a biogas unit and a straw-based compost unit by Ranjeet Singh, Minister for Power, and Sunita Duggal, Member of Parliament, Sirsa. Three other biogas units in Sirsa and Fatehabad are already operational and can use 1.6 MT of biomass of straw and

.4 MT of cow dung for a three-month cycle and turn it into cooking gas sufficient for a small family. The straw-based compost unit has a capacity of turning 16 MT of paddy straw into 32 MT of compost per month which will be ready to use by farmers in 30-35 days after a two-stage solid-state digestion. Speaking at the event, Ranjeet Singh said. "Due to stubble burning, we have lost a lot of flora and fauna from the villages and

we are harming nature and nature is reverting it in the form of earthquakes and floods.

People are moving out of Delhi due to the poor air quality and its impact on children and older generation and a new trend of farmhouses has started."

He urged farmers to adopt environmentally sustainable alternatives to stubble burning to stop the damage.

Highlighting the negative impact of stubble burning, Sunita Duggal said a soil health laboratory has been started in the district and all farmers should test their samples to get benefits from it.

Farmers shared their experiences at the event as part of a peer-to-peer learning effort to encourage other farmers to join the movement of zero-stubble burning.

To help curb the effects of stubble burning, Birlasoft, part of the \$2.4 billion diversified CK Birla Group, has set up an initiative called Project Shodhan in 2017 with the aim of achieving zero crop residue burning in villages of Punjab, Haryana, Uttar Pradesh, and Rajasthan. The Confederation of Indian Industry (CII) Foundation and Birlasoft had signed an MoU towards the third phase of Shodhan, focused on introducing alternate solutions to manage crop residue and create

A notable impact from the project is that stubble burning was checked in 90 per cent farm area and there was a 5-7 per cent increase in yield as of 2020-21.

NO U-TURN

JP national vice-president D. K. Aruna on Thursday denied that she is planning to return to the Congress party. She made it clear that there is no question of switching loyalties to the Congress party. The former minister alleged that the Congress is playing mind games. Aruna said the BJP leadership recognised her by appointing her the national vice-president of the party. She considers working under Prime Minister Narendra Modi's leadership a good fortune. The BJP leader was reacting to reports that she too was also planning a return to Congress after former MLA and BJP national executive member Komatireddy Raj Gopal Reddy quit the party. Some key leaders from Bharat Rashtra Samithi (BRS) and BJP defected to the Congress party during the last couple of months. Aruna had quit Congress to join the BJP on the eve of 2019 Lok Sabha elections. The party fielded her from Mahabubnagar but she lost to Manne Srinivas Reddy of TRS (now BRS). In 2020, she was appointed as the national vice-president of the BJP. She had served as a minister in undivided Andhra Pradesh in the cabinets of Y. S. Rajasekhara Reddy and K. Rosaiah. Meanwhile, another BJP leader and former MP G. Vivek Venkatswamy has also denied that he is planning to quit BJP and join Congress. He said he would remain in BJP and will contest next year's Lok Sabha polls. Viveka has switched loyalties multiple times. He quit TRS in 2019 after the party denied him ticket for Lok Sabha elections. He was with Congress before joining TRS in 2013. He returned to Congress in 2014 and contested the elections from Peddapalli Lok Sabha seat. However, he suffered a crushing defeat. In 2016, he returned to TRS but again quit the party in 2019 to join the BJP.

Oct 22, 1947: The day when Pakistan betrayed and backstabbed Kashmiris

s the world is agitated over the Israel-Hamas-Palestine issue, Kashmiris rememharrids-raiestine 1850ac, Australian ber October 22, 1947, as the darkest day in the history of Jammu & Kashmir when Pakistan perpetrated its vile design and got thousands killed to gobble up the independent land, and changed the history in the region.

October 22 is observed as a Black Day in J&K. When Britishers divided India and allowed the making of Pakistan in 1947, J&K declared itself an independent country. On August 12, 1947, the Maharaja sought a standstill agreement with both India and Pakistan. While India did not sign, Pakistan accepted the offer and on August 15, 1947 sent a communication to Janak Singh, the then Prime Minister of J&K, confirming the

But Pakistan had different designs. It wanted J&K by all means and planned and executed an invasion not by its army but by tribesmen. And the raid began early October 22, 1947. Thousands of tribesmen were supplied with arms and ammunition, and transported by the Pakistan Army. The army regulars also joined the raiders in civil clothes.

The invasion was code named 'Operation Gulmarg' under the command of Pakistan's Major General Akbar Khan and the mission was to seize the land.

The tribesmen first took over the bridges spanning Neelum river linking Muzaffarabad and Abbottabad and captured the first major town, Muzaffarabad. The invaders killed Hindus, Sikhs, looted and burnt their houses. A large number of women and girls were raped and kidnapped. The raiders then moved further towards Uri, Baramulla and reached there on October 26. The mayhem of killings, rapes and plunder was repeated at every stop along the route.

Besides Muzaffarabad, Baramulla was another major town that bore the brunt of the ruthless tribals. Hindus and Sikhs were massacred. Women were raped and kidnapped. The tribals did not even spare the hospital which was run by Christian missionaries. They killed everyone there, even the Muslim patients. The loot and plunder continued for three days. When the fall of Srinagar looked imminent, Maharaja Hari Singh sought India's help and signed the Instrument of Accession on October 26.

It was then that Indian troops landed in Srinagar and a battle began to save Kashmir. By November 8, the Indian Army had taken control of Srinagar, on November 9 of Baramulla, and by



November 13 Uri was secured. However, with the Pakistani Army formally entering the battle in support of the tribesmen, the war continued for over a year until a ceasefire was declared on the night of December 31, 1948.

Kashmir was saved but Pakistan took away its slices. Pakistan Occupied Kashmir (PoK) is a part of the original Kashmir, the borders of which touch Pakistan's Punjab, Northwest, Wakhan corridor of Afghanistan, and Xinjiang region of China. A part of Pakistan-occupied Kashmir's Shaksgam Valley was illegally handed over to China by Pakistan in 1963 when both countries signed a boundary agreement to settle their border differences. The frontiers of the princely state of J&K comprised a total area of 2,22,236 sq kms. Upon the signing of the Instrument of Accession on October 26, 1947, the territory belonged to India. Of the territory, 78,114 sq kms are under the illegal occupation of Pakistan while 38,000 sq kms is under the illegal occupation of China; and further, 5,180 sq kms in the Shaksgam Valley, illegally ceded by Pakistan to China under their border agreement of March 2, 1963.

After the failed Operation Gulmarg of 1947, Pakistan attacked India in 1965, 1971 and even in 1999, every time biting the dust. Convinced that it cannot win a war with India, Pakistan had launched cross-border terrorism since 1988 in Kashmir by playing the religion card. In the name of Jihad, terror was unleashed in the valley. Thousands have perished and minorities

dling false narratives about Kashmir, including its culpability in the 1947 tribal invasion. October 22, 1947 is no less than a day of holo-

For all these decades Pakistan has been ped-

caust for the people of J&K, including those under Pakistan and Chinese siege.

The horrors that the world is witnessing in Israel-Gaza have been long endured by the people of Kashmir at the hands of

Along with unleashing terror in

CANADA SAYS IT EXPECTS TO PROCESS ONLY HALF OF INDIAN VISA APPLICATIONS BY DEC 2023

anada has said that out of the 38,000 visas for Indians, it will only be able to process 20,000 by reduction of staff on the ground.

At a meeting of the Standing Committee on Citizenship and Immigration this week, Immigration Minister Marc Miller said there are now only five members to do the on-the-ground visa work in India, the CIC News reported.

The Immigration, Refugees and Citizenship Canada (IRCC) which processes the visa applications, had its staff reduced from 27 to just five members this month after India, seeking diplomatic parity, asked Canada to withdraw its 41 diplomats.

The IRCC now expects there will be approximately 17,500 Indian applications in backlog at the beginning of 2024. However, signalling hope, senior officials with the country's top Immigration Department said that the government is working to return to normal processing for Indian applications by early 2024. This can be achieved as the immigration staff

pulled from India reestablishes itself and gets back to work in Canada and the Philippines, IRCC said.

According to CIC, IRCC is trying to mitigate the impact by adjusting the work load for Visa Application Centres (VACs) that already process the majority of the applications from India. IRCC said in a statement released last week that a large majority of applications from India are already processed outside the country, with 89 per cent of India's applications processed

'The five Canada-based IRCC staff who remain in presence such as urgent processing, visa printing, risk assessment, and overseeing key partners," the IRCC

The department aims to process 80 per cent of all applications within service standards, which vary depending on the type of application. An application is in backlog when it has not been processed within service standards.

IRCC has also temporarily suspended all in-person services at consulates in India, although applications from India will still be accepted and processed.

India, meanwhile, partially resumed visa services in Canada from October 26 onwards after they were shut down amid deteriorating diplomatic ties. The services will resume for entry, business, medical, and conference visas, the Indian High Commission said in a statement. "Further decisions, as appropriate, would be intimated based on continuing evaluation of the situation," the statement added.

Israeli military again conducts 'targeted raids' inside Gaza Strip

or a second straight ight, Israeli troops coninside the Gaza Strip before withdrawing from the Hamascontrolled enclave, the military said in a statement on Friday.

A video published by the Israel Defense Forces (IDF) showed tanks and armoured vehicles moving on a road near agricultural land as well as strikes on buildings and open areas, reports CNN.

The raid, which included aircraft and artillery strikes in the Shaja'iyah neighborhood, targeted Hamas infrastructure including "anti-tank missile launch sites, military command and control centers, as well as Hamas terrorists", the IDF said. "The troops exited the area at the end of the activity," the statement said.

On Thursday, the IDF had



said that it carried out a "targeted raid" in the northern Gaza Strip as "part of preparations for the next stages of combat", in which the Jewish nation is planning a ground offensive in Gaza, reports Xinhua news agency.

During the raid, soldiers located and struck "numerous" militants, infrastructure and anti-tank missile launch posts and "operated to prepare the battlefield", it added.

Israel has vowed to wipe out

Hamas, the militant group that controls Gaza, in response to its October 7 deadly terror attacks and kidnap rampage in which 1,400 people, mostly civilians, were killed and more than 220 taken hostage.

In a televised address on Wednesday, Israeli Prime Minister Benjamin Netanyahu confirmed that Israeli is "preparing for a ground incursion," into Gaza following nearly three weeks of airstrikes on the coastal strip.



n the third day of his rigorous indefinite hunger strike, Maratha leader Manoj Jarange-Patil questioned whether Chief Minister Eknath Shinde raised the issue of Maratha reservations with Prime Minister Narendra Modi or not, here on Friday.

Appearing weary and fatigued, Jarange-Patil said the community was hopeful that Shinde, along with the Deputy Chief Ministers would raise the issue with the PM in New Delhi on Wednesday and in Ahmednagar

"Did the CM discuss it with the PM or not? If yes, then despite having the information the PM deliberately did not speak about it yesterday in Ahmednagar (Maharashtra). The CM and DyCM are hatching a conspiracy against the Maratha youth on this issue," said Jarange-Patil.

He said that the Marathas have high regards for the PM, "but it appears that now the PM and CM have no need for the poor and backward people of society". Jarange-Patil reiterated that they have given over 10,000 documents for declaring the Marathas as Kunbi caste and giving them quotas accordingly, but that is not yet done by the state government, "which points to a plot to deny the reservations". Earlier, he had said on several occasions that this time "either my funeral procession will he taken out or a Maratha victory march" on the quotas issue which ha been simmering for the past 10 years now. The Maratha leader launched his hunger strike from October 25 to press for the Maratha reservations in jobs and education after giving a 40-day ultimatum to the state government to declare the quotas. This time, Jarange-Patil is observing a rigorous hunger-strike, not taking medication, water and even refusing medical check-ups to monitor his vitals, even the state government officials, ministers and other leaders have pleaded with him to call off the agita-



Ex-union and state minister Babanrao Dhakne dies at 86

ormer union and state **→** minister Babanrao Dhakne died after a brief illness at a private hospital here, his associates said on Friday.

Dhakne was 86 and is survived by his younger son and daughter-in-law who are both independent political leaders.

He was the Minister of State for Energy in the government of former Prime Minister Chandra Shekhar, and had also handled several key ministries in Maharashtra besides serving as Leader of Opposition and Deputy Speaker of Assembly

According to an associate, Dhakne was suffering from pneumonia and other illnesses for which he was admitted to a local hospital three weeks ago. However, during treatment, his condition suddenly deteriorated and he breathed his last late Thursday night after suffering a heart attack. The leader's mortal remains shall be kept for public 'darshan' on Friday and the funeral rites shall be performed on Saturday afternoon at Pagori-Pimpalgaon

village in Ahmednagar. As a young student, Dhakne had carried out his first political agitation in



1951 and had met the then Prime Minister Jawaharlal Nehru after which he plunged fulltime into politics. Over the years, he was associated with several parties like Congress, Janata Party, Janata Dal, Nationalist Congress Party and enjoyed close rapport with former PMs like Indira Gandhi, V. P. Singh and other bigwigs in the Centre and state politics.

He actively took up the causes of the Goa Liberation

Movement, peasants, workers, labourers, sugarcane farmers, unemployed youth and carried out several campaigns, sit-ins and demonstrations for them all his life.

Maha man with rare blood group undergoes successful heart surgery at Lilavati Hospital

Quaid Najmi | Mumbai

n what is being described as a medical breakthrough, the Lilavati Hospital, Mumbai performed a successful complex heart surgery to remove a benign Myxoma tumour in a 50-year-old patient with a rare blood group, officials said here

The patient's blood group was identified as Gerbich Phenotype', the first such in India, and owing to this his own blood was collected for the surgery, eliminating the need for an external blood transfusion, said the medical team of Dr. Pavan Kumar and Ruhi Mehra.

The patient, Rajesh Agarwal from Yavatmal, Maharashtra, complained of chest pain and a mass was discovered in his heart, which was later confirmed as a Myxoma tumour within the right atrium of his heart. Apart from this he was suffering from severe triple vessel coronary artery diseases, necessitating a Coronary Artery Bypass Grafting

The team of Dr. Kumar, Dr. Mehra, Dr. Abhay Bhave, Dr. Nitin Chavan and others used state-ofthe-art techniques and innovative approaches to ensure safe removal of the tumour while minimising potential complications associated with the patient's unique blood group.

"Myxomas are extremely rare tumors that can develop in the heart and disrupt normal cardiac function. However, this case presented an additional challenge due to the patient's Gerbich Phenotype blood group, which is found in less than 0.01 per cent of the Indian population," explained Dr.

The patient underwent blood group testing prior to the operation to arrange for blood transfusion during the surgery and was found to have AB+ Blood Group, which is quite common. "However, his blood was not matching with any of the nearly 50 donor blood units tested (including O-Negative), and further extensive immuno-hematological analysis revealed that the patient possessed an



additional rare blood group antibody, posing an unexpected challenge," said Dr. Kumar.

The blood of even the patient's mother, three siblings and two sons was tested but none were found compatible, worrying the medical team as Agarwal was slated to undergo a complicated heart surgery that could require blood transfusion during the operation.

Accordingly, Dr. Mehra said to be absolutely sure, a blood sample was sent to the International Blood Group Reference Laboratory, Bristol, United Kingdom. "The IBGRL, UK, confirmed that the patient's cells had the rare Gerbich Phenotype due to which he had formed a clinically significant anti-Ge2 allo-antibody, and only eight such phenotype donors are registered in the international rare blood group donor registry. This made it likely that

Agarwal's case was the first-of-its-kind in the country," said Dr. Mehra. Prior to the surgery, Agarwal's blood was collected three times over three week before the surgery was performed on October 18 and the operation went off successfully. Lilavati Hospital COO Lt. Gen. (Dr.) V.

Ravishankar said in this case, the multi-disciplinary approach adopted by the hospital proved that such rare cases can also be handled with utmost care to obtain the desired favourable results.

On his part, Agarwal - who is recovering well post-surgery - said he was shocked to discover the series of health problems he was afflicted and then the discovery of the rarest of rare blood group, but expressed his gratitude to the Lilavati Hospital medical team for the successful surgery that has given him a new lease of life.

Jonathan Majors assault case: Judge denies motion to dismiss case, trial set for Nov 29

Los Angeles | Agencies ollywood actor onathan Majors will face a trial on domestic abuse charges after a New York judge denied the motion to

dismiss the case. The trial date is set to begin on November 29. Majors appeared in a lower Manhattan courtroom via Zoom because he is out of state, reports Variety. During the hearing, his defence attorneys filed a motion to request that "contested evidence" remain under seal and barred from public view due to the "high profile" nature of the case and alle gations against Majors.

Defence attorney Seth Zuckerman told Judge Michael Gaffey that he believes "the disclosure of sensitive informa-

tion will limit Mr Majors' right to a fair trial." As per Variety, the judge did not yet rule on the motion and told reporters in the room they could submit papers to oppose it by November 6.

Following the decision, a spokesperson for the Manhattan District Attorney's office

Dhoni reveals 2019 WC semifinal loss as turning point in retirement decision

ormer Indian cricket captain Mahendra Singh Dhoni has shared insights into his decision to retire from international cricket, saying that he had made up his mind after India's defeat to New Zealand in the 2019 World Cup semifinal, that it would be his last game in India

In the 13 months that followed India's semifinal exit from the 2019 World Cup, Dhoni conspicuously stayed away from the cricketing arena, eventually confirming his retirement on August 15, 2020.

Speaking at an event in Bengaluru, Dhoni revealed that he decided after the semifinal that it was the last game

difficult to control your emotions when you have lost a close game. And inside, I had made my entire planning. To me, that was the last day I played cricket for India. I took retirement a year later but the fact is that, that day I had retired. We cricketers are given certain machines and all of that."So every time I went to the trainer I gave it back to him. He said 'No you keep it. And in my mind, I am like 'how do I tell him I won't be needing or using it anymore'. I didn't want to announce it at that point in time."Dhoni further said: "You are high on emotions. The only thing you've done in the last 12-15 years is play cricket. And then there is no more chance of you representing the

but only few get that opportunity. And sportspersons, they have that. Irrespective of which sport you play, you are representing your country. Be it the Commonwealth Games, Olympics... So, once I quit cricket, there was no way I would be representing my country. I could no longer bring any glory. All those things are going on in mind.'

Despite retiring from international cricket, the former skipper remains an active player for IPL franchise Chennai Super Kings and led the side to its 5th title in 2023 during which he was marred by a knee injury which limited him to cameo appearances with the bat. But, he had promised his fans that he would return in IPL



2024. After CSK won their fifth IPL crown, Dhoni subsequently underwent surgery on his knee.
