



The Indian Council of Medical Research and National Institute of Nutrition (ICMR-NIN) on Wednesday released a set of 17 dietary guidelines to prevent nutrient deficiencies, as well as address the rising risk of non-communicable diseases (NCDs) such as obesity, diabetes, and cardiovascular diseases in India.

he top research bodies said that the new guidelines, which include evidence-based food and lifestyle-related recommendations "underwent rigorous academic and scientific review".


They "are designed as easily understandable and practicable approaches for ensuring diet diversity to meet the requirements of essential nutrients and prevent NCDs among people of all age groups across India"

It also calls for avoiding protein supplements for building body mass, restricting salt intake, moderating intake of oil and fats, adopting a healthy lifestyle to prevent obesity, maintaining proper exercise, minimising ultra-processed foods, and reading information on food labels to make informed and healthy food choices.

Rajiv noted that the guidelines have been made "very relevant to the changing food scenario in India with the addition of practicable messages and sugges-

tions on handling food safety, choosing minimally processed foods, the importance of food labels and physical activity'

The Hyderabad-based ICMR-NIN revises dietary guidelines for Indians from time-to-time based on emerging scientific evidence and the changing food landscape. The most recent nutrient requirements for Indians were released by ICMR-NIN in 2020.

"The dietary habits of Indians have undergone significant changes over the past few decades, leading to an increase in the prevalence of non-communicable diseases while some of the problems of undernutrition continue to persist." Rajiv Bahl, Director General, ICMR



'CONCERN GENUINE', SAYS DELHI REGIONAL LABOUR COMMISSIONER TO TATA SONS CHAIRMAN

elhi Regional Labour Commissioner Ashok Perumalla has written an email to Tata Sons Chairman N. Chandrasekaran stating that the concerns raised by the union and cabin crew members of Air India Express are genuine and a high-level committee should inquire about the grievances of the employees.

Around 300 crew members of Air India Express, which is owned by Tata, have called in sick, claiming that despite promises of job security, salary preservation, and recognition of seniority and expertise, there has been a noticeable deviation from these assurances. Over 100 international and national flights have been impacted since Tuesday

The email sent by Perumalla on May 3, which was also marked to Air India Express CEO Aloke Singh and Air India CEO Campbell Wilson, stated that the concerns of the Union are genuine and the management of the



airline has not sent any responsible decision-makers to any of the conciliation proceedings. "Mismanagement and blatant violations of labour laws were apparent. The HR department tried to mislead the conciliation offi-

cer with the wrong information and an idiotic interpretation of legal provisions," read the email by Perumalla. Perumalla further in the mail suggested to send a high-level committee to inquire into the grievances of the

Gold worth Rs 4.3 cr seized at India-Bangladesh border in last 24 hrs

Teteran Congress leader and two-time Haryana Chief Minister Bhupinder Hooda on Wednesday said the BJP has accepted its defeat in the state's Sonipat Lok Sabha seat with his party announcing Satpal Brahmachari as its candidate.

"It seems the BJP is now just completing the formalities of contesting elections because all communities have united and decided to enable Brahmachari's win," Hooda said while addressing election meetings in Gohana, Kharkhoda, and Murthal in the constituency.

Brahmachari, belonging to the Brahmin community, returned to state politics after spending two decades in politics in Uttarakhand.

Hooda, in his address, claimed that the BJP does not have a single public-friendly promise in its manifesto, and the public has, anyway, lost confidence in its election announcements and that is why BJP leaders always talk about Congress'



manifesto instead of their own manifesto. "BJP leaders are continuously spreading lies about the Congress

manifesto, while the Congress has promised 30 lakh jobs in the Central government, the guarantee of the

Brahmachari said the Congress victory in the Lok Sabha polls and later in the Assembly elections is certain.

"The Congress has announced to provide two lakh jobs in Haryana. Besides, promises like Rs 6,000 pension to the elderly, OPS (old pension scheme) benefit to employees, a cooking gas cylinder for Rs 500 to every housewife and 300 units of free electricity are being made by the Congress, while the BJP neither has any plans nor any report card of its past performance," he said.

Both the Congress and the BJP are heading to a straight contest on this seat. The BJP has pitted Rai Assembly legislator Mohan Lal Badoli against Brahmachari. Both belong to the same community.

he South Bengal Frontier of the Border Security Force (BSF) has seized nearly 5.9 kg of gold worth more than Rs 4 crore that was being smuggled into India along its border with neighbouring Bangladesh in the North 24 Parganas district of West Bengal between Tuesday and Wednesday.

This massive seizure is significant as Parliamentary elections are underway and four Lok Sabha constituencies in the state went to the polls on Tuesday.

The first seizure took place around 3:45 p.m. on Tuesday when personnel of the 145 Battalion BSF, deployed at ICP Petrapole, acted on specific information provided by the Intelligence Cell and searched an Indian truck returning after delivering goods to Bangladesh.

A search of the cabin of the truck (WB25E-8484) led to the seizure of 30 gold biscuits in which truck driver Ujjwal Mandal was apprehended.

During questioning, Mandal claimed that he had received the gold from one Monu Sk at



Benapole and handed it over to an unknown person at the Bongaon hospital, in return for which Mandal was due to receive Rs 10,500.

On Wednesday morning, the BSF personnel at ICP Petrapole received another alert and started frisking people crossing over from Bangladesh. Women constables detected some metal substance hidden in the body of a woman following which a thorough search revealed two gold biscuits.

The woman, identified as Dilruba Akhtar of Shariatpur in Dhaka claimed that she was travelling to Kolkata for treatment.

Elected members of municipalities can't be removed at whims 13-year-old girl, boyfriend held for murder of landlord in Lucknow and fancies of civil servants or their political masters: SC

he Supreme Court has said that elected members of municipalities cannot be removed at the whims and fancies of the civil servants or their political masters only because some of such elected members are found to be inconvenient within the system.

Observing that a municipality is an institution of "grass-root level democracy", a bench presided over by Justice

Surya Kant stressed that the elected representatives of a municipality deserve due respect and autonomy in their dayto-day functioning.

The Bench, also comprising Justice PS Narasimha, made the above observations as it quashed the decision of the Urban Development Minister in Maharashtra disqualifying the elected councillors/office-bearers of the municipalities, holding the action to be "unfair, unjust and founded upon irrelevant considerations." Against one of the appellants, there were allegations of violation of provisions of the Maharashtra Municipal Councils, Nagar Panchayats and Industrial Townships Act, 1965 and



alleged illegal construction of the house in excess of the permission granted.

In an enquiry held by the Collector, the allegations were determined to be correct and he was served with a showcause notice.

While the show-cause proceedings were pending, the Minister-In-Charge, in an order passed in December 2015 suo moto, disqualified the appellant Makarand @ Nandu from the post of Vice-President of the Osmanabad Municipal Council and he was also debarred from contesting election for six years.Similarly, the President of the Naldurga Municipal Council was removed and debarred from contesting election for six years on the complaint

that a particular company was given a tender for garbage collection and disposal, overlooking the lowest bid.

Earlier in 2016, the Bombay High Court (Aurangabad bench) had declined to interfere with the disqualification orders passed by the state government.

In its judgment, the apex court said that the impugned action does not satisfy the doctrine of proportionality, and the removal of the appellants with a ban to contest the election for six years is highly excessive and disproportionate to the nature of the so-called misconduct attributed

"The manner in which the proceedings, while pending before the Collector at the stage of show-cause notice, were suo moto transferred to the State Government and the Minister-In-Charge coming forward to hastily pass an order of removal, are sufficient for us to infer that the action was unfair, unjust and founded upon irrelevant considerations," it said. Also, it is noted that the tender for garbage collection and disposal was accepted after due negotiation, ensuring no financial loss was caused to the Municipality.

AstraZeneca recalled **Covid-19 vaccine**

n a significant move, pharma giant AstraZeneca has recalled its Covid-19 vaccine, made in collaboration with Oxford University, worldwide, months after admitting in the UK court about its potential rare blood clot side effect. The company voluntarily withdrew its "marketing authorisation" of its Covid vaccine, sold as Covishield in India and Vaxzevria in Europe. It can now no longer be used in the European Union, the Telegraph reported. While the company made the application to withdraw the vaccine on March 5, it came into effect on Tuesday. Credited for saving more than six million lives, AstraZeneca "accepted, in a legal document submitted to the High Court in February, that its Covid vaccine 'can, in very rare cases, cause TTS'," the report said. Thrombotic Thrombocytopenic Syndrome (TTS) is a rare side effect that can cause people to have blood clots and a low blood platelet *count. linked to at least 81 deaths in the* UK as well as hundreds of serious injuries. The British-Swedish multinational pharmaceutical is also being sued by more than 50 alleged victims and grieving relatives in a High Court case in the UK. However, AstraZeneca noted that the vaccine is being withdrawn for "commercial reasons" and is "not linked to the court case", and that "the timing was pure coincidence". The company noted that it will collaborate with global regulatory authorities "to initiate marketing authorisation withdrawals for Vaxzevria, where no future commercial demand for the vaccine is expected".

Pak's misstep in stirring controversy with India's election speeches

s Lok Sabha elections in India progress, it is not surprising to see Pakistan nose around. Like a quarrelsome neighbour, Athe country is whining about the election speeches being made in India by various political leaders. Pakistan is going to various forums crying over the political speeches being made in India. particularly by the ruling BJP leaders. A section of its leaders is attacking Prime Minister Narendra Modi, showering praises on Congress leader Rahul Gandhi, and talking about the CAA, Ram Temple in Ayodhya, etc. These leaders seem to be more excited about the election in the neighbourhood than worry about their own democratic institutions and processes which were exposed during the electoral exercise in February. Unable to maintain the sanctity of its own democratic institutions, Pakistan is trying to raise and project political speeches and debates in India as policy statements on various platforms. Recently, Pakistan raised concerns regarding a particular election speech at the UN. During a UNGA session on 'Culture of Peace', Pak envoy to the UN, Munir Akram, cited a US media report. The report referenced Prime Minister Narendra Modi's election speech, wherein he stated that the 'new India' is capable of entering enemy territory and striking. India slammed Pakistan at the UN meeting, saying that it is Pakistan that harbours the "most dubious track record" in all aspects. Pakistan not only is manipulating the election speeches of various Indian leaders on international forums, but some of its



leaders are openly coming out in support of the Congress and opposing PM Modi. Chaudhary Fawad Hussain, Pakistan's former Information Minister and a close aide of Imran Khan, wants Rahul Gandhi to be the winner. Recently, he posted on his X handle a video showing Rahul Gandhi attacking PM Modi with the comment "Rahul on fire." Hussian also said: "Pakistanis should support Rahul Gandhi because Modi's policies do not suit Pakistan.' Taking a dig at the Pakistani leader's support for Rahul Gandhi, PM Modi was quick to lash out, and said in an election rally: "Congress was dying here and Pakistan was crying," and the "partnership between the two has been completely exposed." The former Pakistan Minister is not the only Pakistani leader to openly express a preference for Rahul Gandhi, there are others, including experts and media outlets, who are eagerly pitching for Congress. The voices emanating from Pakistan have intensified the attacks and

counter-attacks in the electoral battle between BIP and Congress BJP's IT cell head Amit Malviya posted: "From a manifesto that has imprints of the Muslim League to a ringing endorsement from across the border, Congress's dalliance with Pakistan can't get more obvious." The Congress may be finding itself on a sticky wicket on the issue of support from a section of Pakistani leaders. The party, however, has neither distanced itself nor said elections are internal matters and Pakistan need not interfere. It is not the first time that Congress has been accused of dalliance with Pakistan. In 2015, a former minister in the Congress government, Mani Shankar Aiyar, during a panel discussion with a Pakistani anchor said that PM Modi has to be removed. "The first and the foremost thing is to remove Modi. Only then can the talks move forward. We have to wait for four more years... Bring us back to power and remove them ... " Again, very recently Aiyar took potshots at the Modi government during an event in Lahore. He said: "We have the courage to conduct surgical strikes against you, but we don't have the courage to sit across the table and talk." The neighbour with a long history of anti-India state policy, will never want a strong and stable government in India. So, when Pakistani leaders root for Rahul Gandhi, PM Modi's statements come out as a clarion call for people to see through the designs. As India moves on to the next phase of elections and the battle becomes intense, the neighbour's curiosity is only going to grow. Pakistan's democracy is a failure and they should focus inward, but then, the owner's pride is always the neighbour's envy.

Mayawati killed two birds with one stone by axing political heir Akash Anand

istakes - minute or monumental - are unacceptable and unpardonable in the Bahujan Samaj Party (BSP), particu-Larly if they have the potential to harm party chief Mayawati's political interests. In the past, innumerable BSP leaders have been shown the door by Mayawati for making mistakes. Party supremo Mayawati's decision to axe nephew, Akash Anand from all posts in the BSP on Tuesday night is designed to send a clear message to her voters that when it comes to punishment, she will not differentiate between party workers and family members. Akash Anand's removal is all the more significant because the former Uttar Pradesh Chief Minister had designated him as her political successor. However, whatever criticism Mayawati faced from rivals for promoting nepotism in the BSP by bringing in Akash Anand, has been washed away by her decision to punish him for his 'immaturity'. Akash Anand's 'immaturity' was evident when at an election rally in Sitapur on April 28 the 29-year-old went hammer and tongs at the BJP, which has often propped up his aunt Mayawati.\ In his enthusiasm, he crossed all limits of political propriety. "This BJP government is a bulldozer government and a government of traitors. The party that leaves its youth hungry and enslaves its elderly is a terrorist government. Taliban runs such a government in Afghanistan," he had said at the rally. Akash Anand was promptly booked for violating the Model Code of Conduct and



for allegedly using objectionable language at the Sitapur poll rally. The case was registered under Sections IPC 171C (undue influence at elections), 153B (imputation, assertions prejudicial to national integration) and 188 (disobedience to order duly promulgated by public servant) and Section 125 of the Representation of the People Act. The impact of his speech was also felt among the BSP cadres and voters, particularly non-Jatav Dalits who are aligned with the BJP now. They were upset at Akash Anand's speech and this was conveyed to his aunt through some coordinators. Mayawati moved swiftly to control the damage done by her protege and cancelled Akash Anand's rallies and asked him to avoid public appearances. When public anger did not subside, Mayawati

finally removed her political heir from all posts. With the removal of Akash Anand, Mayawati has killed the proverbial two birds with one stone - she has crushed all charges of nepotism and also pacified Dalits, who did not appreciate his diatribe against the BJP. "Parties like the Congress, SP and RJD that thrive on nepotism can no longer accuse the BSP of following in their footsteps. The BSP supremo is not dependent on her family and does not promote nepotism, unlike the Gandhis and Yadavs. Behenji (Mayawati) has proved it," said a BSP functionary. By sacrificing her nephew, Mayawati ensured that she did not burn her bridges with the ruling BJP. After all, she had formed the government with the BJP's support in Uttar Pradesh thrice (1995, 1997 and 2002). Mayawati cannot risk her chances of another alliance with the BJP in the future, whether at the Centre or in Uttar Pradesh. BIP leader Rakesh Tripathi said, "Because of Akash Anand's irresponsible remarks and his statements against the BJP, there was anger among the people (against the BSP), and that is why Mayawati relieved her nephew of his responsibilities as the party's National Co-ordinator.

Ukraine reports overnight Russian air attacks on energy system

ussia has once again attacked Ukraine's energy system from the air, Ukrainian officials said on Wednesday. Ukrainian Energy Minister German Galushchenko took to his Facebook account and said that power generation and distribution facilities in six regions were attacked overnight on Tuesday. He named the regions of Poltava, Kirovohrad, Zaporizhzhya, Lviv, Ivano-Frankivsk, and Vinnytsia

He further said that the technicians are working to repair the damage, and the exact extent is still being determined.

"The enemy wants to take away our ability to generate and transmit electricity in sufficient quantities," the Minister wrote.

He called on the people to save electricity as a "contribution to victory"

hina's Chang'e-6 lunar probe has successfully entered its circumlunar orbit, the China National Space Administration (CNSA) said on Wednesday. According to the CNSA, at 10:12 a.m. (local time) on Wednesday, Chang'e-6 successfully performed a nearmoon braking procedure before entering the circumlunar orbit, Xinhua news agency reported.

The near-moon braking procedure is a key orbital control for Chang'e-6 during its flight. The braking makes its relative speed lower than the lunar

escape velocity so that it can be captured by the Moon's gravity and fly around the Moon.

Supported by the Queqiao-2 relay satellite, Chang'e-6 will later adjust the altitude and inclination of the orbit around the Moon and choose a proper time to carry out the separation of the orbiter-returner combination and the lander-ascender combination.

Later, the lander-ascender combination will conduct a soft landing on the South Pole-Aitken Basin to carry out the sampling and return mission on the far side of the Moon as planned, the report said.

TikTok sues US govt to block potential ban

wikTok, an online video entertainment platform, and its Chinese parent company ByteDance have filed a legal challenge against the US government over a law forcing ByteDance to sell off the ultra-popular app or face a nationwide ban in the country.

US President Joe Biden signed a TikTok ban bill into law last month after it was passed by both houses of US Congress.

"Congress has taken the unprecedented step of expressly singling out and banning TikTok: a vibrant online forum for protected speech and expression used by 170 million Americans to create, share, and view videos over the Internet," said TikTok in the petition filed on Tuesday in the Court of




Appeals for the District of Columbia Circuit, adding that "For the first time in history, Congress has enacted a law that subjects a single, named speech platform to a permanent, nationwide ban, and bars

every American from participating in a unique online community with more than 1 billion people worldwide.

TikTok pointed out in the petition that the law -- the Protecting Americans From Foreign Adversary Controlled Applications Act -- is "unconstitutional", Xinhua news agency reported.

"Banning TikTok is so obviously unconstitutional, in fact, that even the Act's sponsors recognized that reality, and therefore have tried mightily to depict the law not as a ban at all, but merely a regulation of TikTok's ownership," said TikTok.

The law only gives ByteDance 270 days to sell TikTok to a non-Chinese buyer, with the possibility of a 90-day extension if the US President determines it necessary.

Elected members of municipalities can't be removed at whims and fancies of civil servants or their political masters: SC

Team Absolute New Delhi

he Supreme Court has said that elected members of municipalities cannot be removed at the whims and fancies of the civil servants or their political masters only because some of such elected members are found to be inconvenient within the system.

Observing that a municipality is an institution of "grass-root level democracy", a bench presided over by Justice Surya Kant stressed that the elected representatives of a municipality deserve due respect and autonomy in their day-to-day functioning.

The Bench, also comprising Justice PS Narasimha, made the above observations as it quashed the decision of the Urban Development Minister in Maharashtra disqualifying the elected councillors/office-bearers of the municipalities, holding the action to be "unfair, unjust and founded upon irrelevant considerations.

Against one of the appellants, there were allegations of violation of provisions of the Maharashtra Municipal Councils, Nagar Panchayats and



Industrial Townships Act, 1965 and alleged illegal construction of the house in excess of the permission granted.

In an enquiry held by the Collector, the allegations were determined to be correct and he was served with a show-cause notice.

While the show-cause proceedings were pending, the Minister-In-Charge, in an order passed in December 2015 suo moto, disqualified the appellant Makarand @ Nandu from the post of Vice-



President of the Osmanabad Municipal Council and he was also debarred from contesting election for six years.

Similarly, the President of the Naldurga Municipal Council was removed and debarred from contesting election for six years on the complaint that a particular company was given a tender for garbage collection and disposal, overlooking the lowest bid.

Earlier in 2016, the Bombay High Court (Aurangabad bench) had

declined to interfere with the disqualification orders passed by the state government.

In its judgment, the apex court said that the impugned action does not satisfy the doctrine of proportionality, and the removal of the appellants with a ban to contest the election for six years is highly excessive and disproportionate to the nature of the socalled misconduct attributed.

"The manner in which the proceedings, while pending before the Collector at the stage of show-cause notice, were suo moto transferred to the State Government and the Minister-In-Charge coming forward to hastily pass an order of removal, are sufficient for us to infer that the action was unfair, unjust and founded upon irrelevant considerations," it said. Also, it is noted that the tender for garbage collection and disposal was accepted after due negotiation, ensuring no financial loss was caused to the Municipality. It may be recalled that the

Supreme Court, in both cases, had permitted the appellants to continue to hold their respective offices during the pendency of proceedings

Phase-3 LS polls: Maharashtra's 11 constituencies record around 61 pc voter turnout

aharashtra's 11 constituencies, which went to the poll on LVL Tuesday in the third phase of the Lok Sabha elections, recorded around 61 per cent voter turnout, according to the provisional figures released by the Election Commission of India. In the 2019 elections, these constituencies witnessed 63 per cent voting.

Maharashtra's Chief Electoral Officer's office said that the voting percentage will increase as the information from the 11 constituencies is still being gathered.

In the third phase, 258 candidates have been in the fray. With 38 contestants, Baramati has the highest number of candidates in the fray while Ratnagiri-Sindhudurg with 9 has the lowest.

There were 1.07 crore male and 1.02 crore female and 929 transgender voters in these constituencies. The ongoing heat wave and summer vacations also adversely impacted the turnout. Of the 11 constituencies, the much debated



Baramati constituency where it was a high-intensity political battle between Sharad Pawar and Ajit Pawar reported the lowest turnout of 50.80 per cent. Of the other 10 constituencies, Kolhapur reported the highest turnout at 68.03 per cent, Hatkanangale (65.10 per cent), Satara (63.05 per cent), Madha (62.17 per cent), Dharashiv (Osmanabad) (60.41 per cent), Ratnagiri-Sindhudurg (59.23 per cent), Raigad (58.01 per cent) and Solapur (57.61 per cent). In Kolhapur, the Congress has fielded Chhatrapati Shahu Maharaj against Shiv Sena nominee Sanjay Mandlik while in Hatkanangale the Shiv Sena has renominated Dhairyasheel Mane against Shiv



and also had hit the most fours in this IPL. SRH were 87 for 0 in five overs. That was four times what LSG were at this point.

In all T20 cricket, only seven times have 100 or more been scored in the powerplay, SRH have the top two scores, both in this year of IPL. It seemed slow by comparison, but Abhishek Sharma reached his fifty in 19 balls with a straight six off Ayush Badoni as SRH reached 120 for 0 in 6.3 overs. As many as 14 sixes and 16 fours were hit in the chase which meant every second ball reached the boundary. Earlier, Bhuvneshwar Kumar led the way with figures of 4-0-12-2, conceding only in denominations of one, completely shutting down the LSG top order, which scored just 66 in the first 11.2 overs. The unbeaten 99-run stand between Ayush Badoni and Nicholas Pooran guided LSG to a respectable total.

SURYAKUMAR YADAV REVEALS THE SECRET BEHIND THE 'SUPLA' SHOT



umbai Indians batter Suryakumar Yadav broke down the arsenal of batting shots he has deployed throughout his career when he scored an unbeaten 102 off 51 deliveries which propelled the struggling Mumbai Indians side to secure a seven-wicket victory against Sunrisers Hyderabad at Wankhede Stadium.

From the iconic 'offside scoop' to his popular 'Supla' shot, the 33-year-old showed a glimpse of a multi-dimensional shot-playing ability against SRH. Yadav shared the story behind the origins of the shots in his repertoire. Yadav's 'Supla' shot has become familiar with each and every inning that he has played, something he now revealed that he picked up playing tennis ball cricket in Mumbai.

"I suppose the name of the shot comes from the local tennis ball cricket that is played in Mumbai. And from there, when I started playing that shot because people have played a lot of it in tennis ball cricket, they started connecting with this shot and gave it a name. When the shot is played and is referred to as a 'Supla' shot, it feels good to hear," Suryakumar Yadav said To JioCinema.

Yadav got into the details of how he perfected the shot while playing rubber ball cricket with his school friends while demonstrating how the shot is executed.



"The story behind the shot is beautiful. I used to play cricket on hard cement tracks with my school friends. We used to play with rubber balls in the rainy season and make the ball wet before bowling it hard. They used to bowl from my knee to my head, so if you want to score runs while not getting hit by the ball, that's where the shot comes from. Whenever people ask me if I have practiced this or not, I have used this shot so many times in rubber ball cricket that it's now in my muscle memory."

Hitting the 'Supla' shot is tricky, but Yadav has figured out when and how to use the shot when the situation demands it. "I actually try to take the ball on the body when I play the 'Supla' shot. Whenever I stand and hit, I try to be in the line of the ball. If you miss the line of the ball, it's very difficult to play that shot... I try to take the ball in line with the body and time it... There's no premeditation in this... Even if it's the first ball, if I want to use it, I'll do it because I go with the intent to bat, enjoy, and entertain as much as I can, as much as I have practiced. Even if it's the first ball, if it's in the arc, it will go. So, the fielder at the back is actually irrelevant for me. I don't see if he is there or not. If I want to play a shot, I have to play it."

Not every batting inning is flawless, but Suryakumar Yadav knows how to create magical moments, regardless. That is precisely what he did in 2020 while facing Jofra Archer, executing an incredible 'offside scoop' shot after taking a knock to the head.

"On the previous delivery, it hit me on my head and my head was spinning! After that, I thought I had to hit a different shot. I haven't used this shot again since."

If there is one thing we know about Florentino Perez is that he gets what he wants, as the president of Real Madrid continued his pursuit of the 2022 World Cup top scorer.

With Mbappe only having a year remaining on his contract, Real Madrid made reportedly made an offer of 160 million Euros in 2021 which was rejected by PSG in hopes of Mbappe staying with the club. Disaster seemed imminent for the Parisian club as it was reported that Mbappe had signed a pre-contract agreement with Madrid allowing the Frenchmen to join the club in 2022.

The Los Blancos were once again left with nothing but dust in their hands as Mbappe went on to sign a new contract with PSG that kept him in the fashion capital of the world till the end of the 2023/24 season, making him one of the highest paid players in the world.




