he unprecedented heat wave across north India has cost the lives of dozens including that of six Home Guards who were on election duty in Mirzapur, Uttar Pradesh. There have been reports of multiple deaths in Rajasthan as well, though the official figure is five.

RB Kamal, the Principal of Mirzapur Medical College said six of 23 Home Guards admitted to the hospital have died. All of them were admitted with other complaints -including high blood pressure, heart problems and other diseases. Currently, the condition of two jawans is critical."Twenty-three people have been sent to us so far among whom one is from Fire Service and one from civil police. There were 20 jawans from the Home Guard. Six

2 POLL PERSONNEL DIE, HEATSTROKE SUSPECTED

Sonbhadra: Two people on election duty died and nine taken ill of suspected heat stroke as they were being dispatched to their assignment locations in Uttar Pradesh's Sonbhadra district, a senior official said on Friday.

The nine poll personnel are undergoing treatment at the district hospital where their condition is said to be serious, said District Magistrate Chandra Vijay Singh.

While the exact cause of death is yet to be ascertained, the district magistrate said the symptoms appeared to be that of heat stroke.

Asked about the symptoms, he said they were brought in with high grade fever, high blood pressure, high blood sugar. "They have a high chance of brain stroke, which could be fatal," he

Over the last week, as temperature across north India shot onto unprecedented levels, unconfirmed reports of multiple deaths of homeless people have been flowing in. Unidentified bodies have been piling up in

morgues and in many cases, postmortems reports are awaited to confirm the cause of death.

The situation got so alarming that yesterday, the Rajasthan High Court took suo motu cognizance of deaths and urged the Centre to declare the ongoing heat wave as a national emergency.

The court also directed the state government to pay compensation to the victims' families and issued several guidelines to the government to provide relief to the people.

Among other things, the court directed the state government to sprinkle water on roads, mark out shaded areas and distribute water, ORS and cooling drinks like mango panna.Labourers, cart and rickshaw pullers should be allowed to rest between noon and 3 pm, the court said. Heat alerts should also be sent through bulk messages, print and electronic media to caution the people.

Patna: Amid an intense heatwave in Bihar, more than 80 persons have lost their lives in different districts of the state in the last three days.

- The officials said that in the majority of the cases, postmortem reports of the deceased have not come as of yet. The maximum impact is being seen in Aurangabad where 19 have lost their lives. On Thursday, the maximum temperature of Aurangabad reached 48.2 degrees Celsius.
- Around 200 people have also fallen sick due to heatstroke in Aurangabad. Medical Officer of Sadar Hospital Abhishek Kumar said that about 200 patients who came to the hospital were all treated.
- An official of the Health Department said that more than 300 people have been admitted to various hospitals in several districts of Bihar and are undergoing treatments.
- The department has advised people to avoid stepping out of their houses unnecessarily.

An official of the Disaster Management Department said eight people died due to heatwave in Arwal, Buxar, Rohtas and Begusarai districts. In Arrah city of Bhojpur district, nine people including five polling personnel died due to the

heatwave. Besides, the heatwave also took the life of a state committee member of CPI-ML In Rohtas, eight people died due to heatwave. In Jehanabad, eight persons died including a soldier who was on election duty in the district. He died during treatment.

In the Kaimur district, six people including a teacher died due to heatstroke. The teacher had left home for election duty while returning home, his health deteriorated and while being taken to the hospital, he succumbed. In Gaya, three persons died due to heatstroke in the last two days. They were identified as Manoj Ram (50),

Raghunandan Yadav (80), and Satendra Singh (68). Three people died due to heat stroke in Buxar and three in Chapra on Friday.

Two persons died in Sheikhpura and two in Munger on Friday. Deaths were also reported in Gopalganj, Jamui, Lakhisarai, and East Champaran districts.

Air India flight chaos: Passengers faint amid 20-hour delay

Sex videos case: Court gives Prajwal Revanna's custody to SIT till June

rrested JD(S) MP and prime accused in the sex videos case, Prajwal Revanna, was produced before the 42nd Additional Chief Metropolitan Magistrate (ACMM) on Friday.

After arguments and counterarguments, the court gave his custody to the SIT till June 6.Videos allegedly showing former Prime Minister HD Deve Gowda's grandson Prajwal Revanna sexually abusing women surfaced during the Lok Sabha elections and created a furore in Karnataka. Special Public Prosecutor (SPP) Ashok Nayak submitted to the court that Prajwal Revanna should be handed over to the custody of the SIT for 15 days.

Nayak said that following

the circulation of the videos on social media, the victims are facing a crisis, with their husbands viewing them with suspicion.

Arun, the counsel for Prajwal Revanna, submitted that the rape charge was not made in the initial complaint. "There is no video record

of the complainant. It is a four-year-old case. According



the victim's statement in court under CrPC Section 161. There was no mention of a rape charge between April

28 and May 2. The courtroom was teeming with counsels

Centre introduces separate mobile numbering series for service, transactional voice calls

he Centre on Thursday introduced a new numbering series, 160xxxxxx, for making service or transactional calls, to help citizens easily identify legitimate calls and curb unsolicited voice calls from telemarketers using 10-digit mobile numbers.

Currently, 140xxxxxx series has been allocated to telemarketers for making promotional/service/transactional voice calls.

The Department of Telecommunications (DoT) said in a statement that since the 140xx series is being used extensively for promotional calls, "consumers normally do not respond to such calls and many important service/transactional



calls are missed"."This has resulted in wide use of regular 10-digit numbers by genuine entities for making service/transactional calls. This also gave opportunity to fraudsters to deceive consumers using 10-digit

numbers," the DoT added. To address this, the DoT has allocated a new numbering series, 160xxxxxx which will exclusively be used for service/transactional voice calls by the Principle Entities

This clear differentiation between service/transactional calls versus other types of calls will make it easier for citizens to manage their communication."For example, the service/transactional calls originating from Financial Entities like by RBI, SEBI, PFRDA, IRDA, etc shall start from 1601," said DoT.

The Department said that telecom Service Providers (TSP) will need to ensure "adequate verification of every entity before assigning a number from 160 series and the entity shall undertake to use it only for service/transactional calls".

For any suspected fraud communications, citizens can report it on the Chakshu facility at Sanchar Saathi (www.sancharsaathi.gov.in).

RBI shifts 100 tonnes of gold from vaults in UK to India

he Reserve Bank of India (RBI) has shifted around 100 tonnes of its gold kept in bank vaults in the UK to its own vaults in India in a move aimed at saving storage costs, according to media reports

This is the first time since 1991 that India has undertaken such a large-scale overseas transfer of gold reserves.

Economist Sanjeev Sanyal, a member of the PM's Economic Advisory Council, said, "While no one was watching, RBI has shifted 100 tonnes of its gold reserves back to India from the UK." "Most countries keep their

gold in the vaults of the Bank of England or some such location (and pay a fee for the privilege). India will now hold most of its gold in its own vaults. We have come a long way since we had to ship out gold overnight in 1991 in the midst of a crisis," he added.In 1991, when the country was in the grip of a severe foreign crisis with no money to pay for essential imports, the Chandra Shekhar government pledged gold to raise funds. The RBI then pledged 46.91 tonnes of gold with the Bank of England and the Bank of Japan, to secure \$400 million. More than half of the RBI's

gold reserves are held overseas in secure custody with

the Bank of England and the Bank of International Settlements, while approximately a third is stored in the RBI's vaults in Nagpur and Mumbai. The central bank held 822.10 tonnes of gold as part of its foreign exchange reserves as of March 31, 2024, an increase from the 794.63 tonnes held at the same time last year, according to the annual data released by the RBI.RBI has, like other central banks, been buying gold as a safe-haven asset. The strategy of holding gold is primarily aimed at hedging against inflation and reducing foreign currency risks, especially in times of uncertainty triggered by geopolitical tensions.

NEARLY 2 LAKH PEOPLE HIT, RAJ BHAVAN OFFICES, **MEDICAL COLLEGES INUNDATED IN MANIPUR FLOODS**

round two lakh people have been affected in 348 villages and urban localities in eight districts of Manipur, where the flash floods continued to impact normal life for the fifth day on Friday but respite is in store as water levels are now receding, officials said.

Officials said that besides important installations including medical colleges and government offices, Chief Minister N. Biren Singh's private residence, and various hotels were inundated in knee- to waistdeep water. Water also surged into the Raj Bhavan complex, leaving the Governor's Office and Secretariat, staff quarters, and the security personnel's barracks under flood water, with only the vintage building, which is the official residence of the Governor, unaffected.

However, with the intensity of the rain weakening, the flood waters in the city, its outskirts, and other places, as well as in major rivers, are receding.

State Water Resource Minister Awangbow Newmai said that inces-



sant rainfall since Monday in the aftermath of Cyclone Remal, most of the state, spanning the hills and valley districts of Imphal East, Imphal West, Kangpokpi, Bishnupur, Noney, Churachandpur, Senapati, and Kakching, had been affected.

Three persons have died in different flood-related incidents so far while one person is missing and ten injured.Besides the National Disaster Response Force, the State Disaster Response Force, Army, Assam Rifles

and other central forces are engaged in relief and rescue works.

The minister said that 56 relief camps have been opened and over 20,000 people took shelter there. He also said 434 hectares of crop areas were affected and landslides occurred in several hill district areas.

The repair of the embankments, and tackling breaches and overflow of key rivers flowing in Imphal Valley is going on, he added. The Chief Minister held a review

meeting with ministers and top officials on the flood situation. He also inspected the rescue operation going on in Imphal city.

He said that a large number of people and livestock have been affected due to a breach of the river banks in many areas. "Inspected the situation on the ground at Ima Market and nearby areas along with my cabinet colleagues and MLAs. All possible measures are being taken up to con-

trol the flooding in these areas. Chaired a meeting with Ministers, MLAs, Chief Secretary, security officials and all department officials to review the flood situation in the state, while assessing the ongoing measures to provide necessary aid and assistance to the affected families," the Chief Minister said in a post on X. He said that out of the 18 spots

where the breach occurred in the embankments of rivers, 17 were sealed and the flooding in the surrounding areas has been successfully brought under control.

All the major rivers, including Imphal, Nambul, and Kongba, which were flowing above the danger level till late Thursday night, are now receding.

Swati Maliwal case: Delhi court sends Kejriwal aide Bibhav Kumar to 14-day judicial custody


Bibhav Kumar was arrested on May 18 in connection with the assault on Maliwal. an Aam Aadmi Party Rajya Sabha member and former Chairperson of the Delhi Commission for Women, on May 13.

The Delhi Police had moved an application seeking Bibhav Kumar be sent to judicial custody. While his counsel opposed the plea, the prosecution said that Kumar might interfere with the current investigation.

In a related development, the Delhi High Court on Friday reserved its order on the maintainability of Kumar's plea challenging his arrest in the case. On Monday, the Tis Hazari Court had dismissed Kumar's bail plea.

ndia's democratic exercise, unparalleled in its expanse, vibrancy, and outreach, is set to end its course on Saturday with polling for the remaining 57 Lok Sabha seats in eight states/UTs, extending from the plains of Punjab to the ghats of Varanasi and its eastern UP hinterland, and the hills of Himachal to the teeming urban sprawl of Kolkata and its environs.

The 57 seats, including 13 reserved for SCs and three for STs, are in Uttar Pradesh and Punjab (13 each), West Bengal (9), Bihar (8), Odisha (6), Himachal Pradesh (4), Jharkhand (3), and Chandigarh (1). Polling will also be held for the remaining 42 seats in Odisha in the simultaneous Assembly elections there.

Also in a key sideshow, bypolls to six Assembly constituencies in Himachal Pradesh are scheduled on



Saturday - and their results will determine the fate of the Sukhwinder Singh Sukhu government.

The bypolls were necessitated after six Congress MLAs cross-voted in the Rajya Sabha elections and subsequently resigned from their seats to ioin the BIP. There are a total of 908 candidates in the fray, with the maximum in Punjab (328) and the least in the adjoining UT of Chandigarh (19). Prime Minister Narendra Modi (Varanasi) heads the list of prominent

candidates in this phase. The electorate for the final round of the Lok Sabha elections comprises over 10.06 crore voters - 5.24 crore males, 4.82 crore females, and 3,574 of the third gender, the Election Commission said, adding that around

Anti-Dowry Section 498A being misused in matrimonial disputes with ulterior motives, Kerala High Court

more infant succumbs to injuries

he Kerala High Court on Friday asked courts to look into cases of matrimonial disputes with care as several women misuse Section 498 of IPC to put the close relatives of their husbands in distress by leveling allegations of cruelty.

Justice A. Badharudeen pointed out that in matrimonial disputes, many women misuse Section 498 A against their husbands and their relatives to defame them in society.

Justice Badharudeen said, "It is noticed that in matrimonial disputes, certain wives initiate criminal proceedings on the strength of vague and omnibus allegations against the parents, sisters, brothers and other relatives of the husband with ulterior motive to put them under the veil of prosecution involving non-bailable offences and to face the ordeal of criminal prosecution and trial by the parents, sisters, brothers and other relatives of the husband, to malign and defame their image in the society.""In such cases, the court must analyse materials available when quashment is sought whether the



allegations specifically state anything dealt under Section 498A so as to prosecute the accused for the said offences, by subjecting themselves for trial," said the High Court. The Court made these observa

tions while quashing criminal proceedings initiated by a woman against her 61-year-old mother-inlaw on the allegations of committing cruelty and demanding dowry. The High Court held that there

were only sweeping and general allegations against the mother-in-law without mentioning any specific instance of cruelty, and hence it quashed criminal proceedings against her.

ne more infant -- around 2 months old who was rescued after a fire broke out at Baby Care New Born Hospital here in the Vivek Vihar area, succumbed to injuries during treatment on Friday, an official said, adding that the death toll from the tragedy has now risen to seven.

"She succumbed to injuries on Friday morning. Further probe in connection with the fire incident is going on," a senior police officer said without divulging more details on the case

The fire incident happened on May 25. "In the hospital, there were 12 newborn babies admitted and one was already dead before the fire incident. All the 12 newborn babies were rescued from the hospital with the help of other people and shifted to East Delhi Advance NICU Hospital, for treatment. Six died during the treatment," said the official.As per police sources, Baby Care New Born Child Hospital flouted the guidelines of the Ministry of Home Affairs (MHA) regarding the storage of oxygen cylinders.

According to an MHA circular dated April 23, 2021, on guidelines for the safe storage, transportation, and handling of liquid oxygen for medical use, oxygen must be kept at least 20 feet away from flammables and com-



bustibles

Additionally, "No Smoking" and "No Open Flames" signs must be posted. Delhi Police has arrested the hospital owner and the doctor on duty at the hospital in connection with the incident. The owner was identified as Naveen Kichi, a resident of Bhairon Enclave, Paschim Vihar while the doctor was identified as Aaksh (26), a resident of district Charkhi

Delhi govt petitions SC seeking additional water supply from neighbouring states

Team Absolute New Delhi mid the rising water crisis in the national capital, the Delhi government has petitioned the Supreme Court seeking additional water supply from the states of Haryana, Uttar Pradesh and Himachal Pradesh

The plea demanded that the states neighbouring Delhi be directed to release extra water for a month to address the extraordinary and excessive water demand of the city triggered due to a surge in summer temperature.

Meanwhile, Delhi Water Minister Atishi has sought urgent intervention from the Centre on the issue of water shortage and apprised the Union Jal Shakti Minister that Harvana must immediately release Delhi's rightful share of water into the Yamuna

River to bring the waters to the normal level.

"Delhi is heavily dependent on water from the Yamuna River to meet its day-to-day demand for water. However, in the last few days, there has been a drastic dip in the water levels at the Wazirabad Barrage as Haryana is not releasing the required amount of water in the Yamuna River. This has

resulted in a massive crisis of water in the national capital, said Atishi in her letter to Union Minister Gajendra Shekhawat.

She added that the temperature in Delhi has touched almost 50 degrees and this has further intensified the demand for water putting additional burden on the already strained demandsupply chain of potable drinking water in Delhi.

JP Nadda slams Cong over Exit Poll boycott 'It shows party's antipathy towards world's largest democratic process'

JP President J.P. Nadda on Friday slammed the Congress' decision to boycott Exit Poll debates slated for Saturday, saying that this indicates an unequivocal confirmation that it has

conceded defeat ahead of the announcement of Lok Sabha election results on June 4.

With the seventh and final phase of polling concluding on Saturday, the Exit Polls conducted by several poll survey agencies and pollsters will be out by the evening, giving a 'fair' indication of what to expect on the counting day.

However, the Congress on Friday announced to give the Exit Poll debates a miss while dubbing the entire exercise as a "slugfest for TRPs".

Objecting to Congress' decision, the BJP chief said, "It is not surprising since the Congress usually opts out when it doesn't expect the results to go in its favour, but has no compunction showing up if it thinks it has even an outside chance. Their hypocrisy is not lost on



anyone. Let no one in Phase 7 waste their votes on them.

He also said that by boycotting the Exit Poll exercise, Congress has sought to question the rigorous exercise carried out by several professional agencies that work day and night to compile the figures."It doesn't behove India's grand old party to behave like a child, whose toy has been taken away. One expects a certain level of maturity from the largest political party in the Opposition," J.P. Nadda said in a post on X.

He also said that what is more discon

certing is Congress' antipathy towards the largest democratic process in the world, which saw the participation of over 960 million aspirations.

While Indians were electing their leader, who would lead them in the new world order, improve their lives, bring opportunities and prosperity, Congress was working assiduously to undermine the very institutional process on which rests our robust democracy's foundations. "Instead of focusing on winning the elections, Congress repeatedly approached the Supreme Court, making outrageous demands, to mutilate our well-established electoral process," he said.The BJP chief also slammed the grand old party over its whining on electoral losses and pinning the blame on 'EVM tampering' for electoral defeats.

"The Congress has no complaints about either the EVMs or the electoral process when it wins. Himachal and Telangana are recent examples. But it whines endlessly when it expects a rout," Nadda said.

Police will take action sensitively under POCSO Act. No anticipatory bail will be given Team Absolute Bhopal If you or someone you know has witnesses. gation and trial. The police must con-

he POCSO Act is a provision to protect children from crimes of sexual abuse. This law not only deals with sexual abuse of girls but also if any obscene molestation takes place with minor boys, then it will also be considered in the category of crime. Under this Act, apart from the traditional definition of rape, those acts have also been termed as rape due to which the child is molested with wrong intentions. If a person is convicted under the POCSO Act, then there is a provision to give him severe punishment considering him a criminal. Before the amendment in the POCSO Act, there was a provision for anticipatory bail. But after the amendment, the accused is not even given anticipatory bail.

Process of filing a complaint under the POCSO Act

If you or someone you know has been a victim of sexual abuse, then you

can file a complaint under the POCSO Act. The first step is to contact the police and report the incident. You can either visit the police station in person or call the police helpline number to register a complaint. You will need to provide details such as the date, time and place of the incident as well as the identity of the perpetrator if possible. The police will arrange for a medical examination of the victim to collect evidence of the abuse. If the police find that the complaint falls under the purview of the POCSO Act, they will file a First Information Report and begin an investigation. The case will be tried in a designated court under the POCSO Act. The victim and witnesses will have to give testmony in court. It is important to note that the POCSO Act also makes provisions for the protection of the identity of the victim and

witnesses. Police Responsibilities under POCSO

The police play a vital role in enforcing this law and ensuring justice for victims of such crimes. Under the POCSO Act, when a complaint of sexual offence against a child is received, the police will immediately register the complaint. The police is responsible for recording the statement of the victim or any witness in a manner that is sensitive to the age, gender and mental condition of the child. The police will ensure that the victim undergoes a medical examination within 24 hours of the complaint to collect evidence of the crime. The police have the power to arrest the accused person without a warrant if there is a reasonable suspicion of their involvement in the crime. The police must ensure the safety of the victim, including providing protection and assistance during the investi-

gation and trial. The police must conduct a thorough investigation of the crime, collect all evidence related to the crime and present it in the court. The police must ensure that the trial of the accused is conducted in a timely and expeditious manner as per the provisions of the POCSO Act. The police have an important responsibility under the POCSO Act to ensure the safety of children and bring the perpetrators of sexual crimes against children to justice.

Punishment and bail in POCSO Act, no anticipatory bail

The crime under POCSO Act is considered a very serious crime. In which there is a provision to provide the harshest punishment to the guilty person whoever is found guilty of committing this crime. This act provides for punishment ranging from minimum 3 years to life imprisonment depending on the severity of the crime.

Hooliganism of Dhirendra Shastri's younger brother Shaligram, entered the house and beat up women

All eyes on UP's final phase elections

he stakes are high for the seventh and final phase of Lok Sabha polls in Uttar Pradesh and the eyes of the *entire nation will be fixed on this phase* as Prime Minister Narendra Modi seeks a third term from Varanasi. There is no guessing who will emerge as the winner from this high-profile constituency. The campaign in the constituency has been marked by the presence of over a dozen union ministers, NDA alliance leaders and the well-wishers of the Prime Minister, including Union Home Minister Amit Shah and Union Minister for Women and Child Development Smriti Irani. Another constituency in the state which is grabbing eyeballs is Gorakhpur, the hometown of UP Chief Minister Yogi Adityanath. Though the BJP candidate in Gorakhpur is actor-politician Ravi Kishan, it is the prestige of Yogi Adityanath which is at stake. The Chief Minister himself has actively campaigned in the constituency. In the seventh phase, polling will be held in 13 Lok Sabha constituencies including Maharajganj, Gorakhpur, Kushinagar, Deoria, Bansgaon (SC), Ghosi, Salempur, Ballia, Ghazipur, Chandauli, Varanasi, Mirzapur and Robertsganj (SC). A total of 144 candidates are in the fray in the seventh phase, according to Chief Election Officer Navdeep Rinwa. The two BJP allies who will be on test in the final phase are the Suheldev Bharatiya Samaja Party (SBSP) and Apna Dal (S). The BJP faces a challenge from the INDIA bloc to retain the seats it won in 2019. The BJP had bagged nine of these 13 seats while its ally Apna Dal (S) won two seats. The BSP bagged two seats. The seventh phase has 2,50,56,877 voters including 1,33,10,897 men, 1,17,44,922 women and 1058 third gender voters.

HOW BSP'S VOTE BANK GOT DEMOLISHED BY **BUREAUCRATS ONCE CLOSE TO MAYAWATI**

Dolitical parties are made or marred by the decisions taken by their leaders but the Bahujan Samaj Party (BSP), in by their leaders but the Dahujan Gundan of the Vitar Pradesh, is an exception. This is one party that thrived on its loyal band of bureaucrats and also lost its vote bank as the bureaucrats began moving away from the BSP. BSP President Mayawati, as chief minister, was always lucky

to have a loyal and dedicated band of bureaucrats to help her steer through the turbulent waters of Uttar Pradesh politics. The bureaucrats, mainly Dalits, showed unflinching loyalty

towards her and were a major reason for her success as a chief minister.

When she first took oath as chief minister, she was a complete novice when it came to administration and running the government.

It was then Rai Singh, an IAS officer known to be close to Kanshi Ram, who took charge and even guided her through the swearing in ceremony.

However, within weeks, Mayawati allegedly became suspicious of his style of functioning and showed Rai Singh the door.

He was replaced with PL Punia who guided the chief minister through all administrative and political decisions.

Over time, PL Punia earned the sobriquet of 'mini chief minister' and since Mayawati did not meet her party cadres, it was left to him to deal with them and address their problems.

Mayawati, as chief minister, never opened her doors for anyone - whether it was bureaucrats, party leaders or the

media. It was PL Punia who sorted out issues with other officers, listened to grievances of party leaders and workers and even wooed the media that was initially very hostile towards Mayawati.

Seeing PL Punia, other bureaucrats posted in Mayawati's Secretariat also began adopting a similar style of functioning.

This suited the BSP President because she did not wish to be bothered with 'smaller problems'. The people too, were satisfied because the bureaucrats solved their problem.

However, gradually, the loyalty of BSP cadres veered towards bureaucrats who addressed their problems and it is here that the problem began in the BSP.

PL Punia left Mayawati after the Taj Corridor controversy and later joined the Congress.

Brijlal, former Special DG in Uttar Pradesh, was another Mayawati favourite who left her.

An upright IPS officer, he was known to tackle the law-andorder situation with an iron hand. However, he was apparently eased out of her coterie and has now joined the BJP. Brijlal is now Rajya Sabha MP and also the Dalit face of the

BIP in UP. Dalits who came to him to sort out their issues when he was

in the BSP, now meet him when he is in the BIP.

"He still helps us and that is what matters to us. BSP has nothing left for us. We will go with those who still interact with us," says Ramraj Prasad of Siddhartha Nagar.

According to a retired IAS officer, once known to be in Mayawati's good books, "She is now completely under the influence of non-Dalit leaders and this has been her undoing. She refuses to entertain Dalit leaders and this is evident from the exodus of senior leaders from the party. It is a matter of

time before the BSP completely disintegrates.' Almost all these bureaucrats - now retired - are moving

away from the BSP and have no qualms in criticising her style of function and deviated from Kanshi Ram's ideology.

Retired IAS officer Kunwar Fateh Bahadur, who served as Principal Secretary to the Chief Minister in the Mayawati regime and was one of the most powerful officers in her regime, had questioned her decision to send leaders to the Lok Sabha and Rajya Sabha from the Brahmin community.

He has now joined Samajwadi Party and sources close to the former IAS officer said that he was 'pained' to see Kanshi Ram's party move away from his ideology

As these bureaucrats moved away from the BSP, party cadres also moved out with them.

"Since these people come to us, it is our moral duty to help them and we do so," said another former IAS officer.

Tribhuvan Ram, a former Chief Engineer in the PWD, had taken voluntary retirement in 2011 to join the BSP. He was elected to the Vidhan Sabha twice but later joined the BJP.

Former bureaucrats like Ram Bahadur and Shri Krishna who were known to be trusted babus in the Mayawati regimes, have now moved away from the BSP President.

Padam Singh, Mayawati's Personal Security Officer, was known to be the man she trusted most. He was known as her shadow and she trusted him more than any of her party leaders and officers


However, he fell out of favour for reasons not known and is now in the BJP.

Jatavs, supposedly the core BSP voters, are also in a quandary about the BSP's future.

A generation of Jatavs, the caste BSP chief Mayawati herself comes from, had once been part of the Bahujan movement and are sworn loyalists of the party.

A weakened BSP, however, has resulted in most Jatav voters feeling let down.

Jatavs in many areas believe that the selection of wrong candidates in elections and Mayawati's "muted" campaign may



The voices of dissent among the community in Uttar Pradesh are no longer few and far between.

Mayawati's absenteeism from "active" politics is also haunting Jatavs.

'Woh kabhi aayein, hum logon se milen. Ek rally se kya hota hai? (She should come at times and meet us. One rally doesn't achieve anything)," said Umakant, a Jatav in Kajitola locality of Kannauj.

In Jahta, a Dalit-dominated village in Malihabad, on the outskirts of Lucknow, discontent among the BSP cadre is obvious.

"What candidates Behenji has fielded this time baffles me. I cannot recall most of these names, though I am a party worker myself. Jo party ka kaam kare, ticket usko dena chahiye (They should give tickets to people who work for the party)," said a local party functionary.

Malihabad is the Assembly segment under the Mohanlalganj LS seat.

In fact, Azad Samaj Party's Chandrashekhar Azad resonates more with the voters in Jatav-dominated villages in the constituency than Mayawati's nephew, Akash Anand, who has been removed from all party posts.

Mayawati's "disconnect" with the Jatav population is quite pronounced in many regions.

"We know she is a very big leader and cannot come to meet us on any ordinary day, but election is the time for it," said Babulal, a resident of Gopramau Village.

Since 2016, the BSP has seen a mass exodus of top brass who were either from the foundational stream of the party or formed a strong second line in the hierarchy.

Many of them either quit or Mayawati expelled them. As a result, the party presently lacks any other Dalit face than Mayawati whose campaign many Jatavs find "confusing" as compared to other parties in the fray.

Five killed in Russian missile attacks on **Ukraine's Kharkiv**

t least five people were killed and more than 24 injured in Russian missile attacks in the north-eastern Ukrainian City of Kharkiv, Governor Oleh Syniehubov said on Telegram on Friday. Most of the victims lived in a five-storey apartment block. The attacks also damaged a fire engine and an ambulance, he said.

At least 20 residential buildings were damaged as a result of the attack. The Russian military fired five missiles at the city, he said. The capital, Kyiv, was attacked with at least one cruise missile, the authorities said, adding that a car repair shop, a car wash and half a dozen vehicles were damaged by falling rocket debris. A transformer station was damaged, the energy company DTEK said, but the power supply has already been restored. There were no casualties. Ukraine has been fending off a full-scale Russian invasion for over two years. Due to Russian attacks on the Ukrainian power supply, there are repeated power cuts.

Berlin Agencies he German government

has authorised Ukraine to use German-supplied weapons against military targets in Russia, German government spokesman Steffen Hebestreit announced on Friday in Berlin.

Ukraine has pressed supporters in recent weeks for permission to use weapons supplied by the West to strike Russian forces on Russian territory. Several other countries, including the US, have recently made similar moves to give Ukraine more leeway

in its use of Western-supplied weapons

Many Western countries put conditions on military aid packages that limited Ukraine to use those weapons only in Ukrainian territory. Those conditions were intended to avoid escalation with Russia and prevent Ukraine's allies from being drawn directly into the conflict. But Ukraine has contended recently that Russian forces are exploiting those limitations to mass troops near the border and stage attacks against Ukrainian territory.

Seoul Agencies he unification ministry

of South Korea on - Friday warned that "unendurably" painful measures would be taken against North Korea if it continues to stage "irrational" provocative acts, such as this week's sending of balloons carrying trash to South. Earlier this week, North Korea flew hundreds of large balloons carrying trash and manure into South Korea and staged GPS jamming attacks in waters near South Korea's northwestern border islands for a third straight day until Friday. The country also fired a salvo of short-range ballistic mis-

siles on Thursday, reports Yonhap news agency.

The ministry in charge of inter-Korean affairs voiced "strong" regret over North Korea's "senseless and irrational" provocative acts. "The government is taking

the North's latest provocations very seriously. We will not tolerate such moves," the ministry spokesperson, Koo Byoung-sam said. "If North Korea does not stop its provocative acts, the government will take all measures that North Korea cannot endure. We sternly warn that all responsibility for what will take place afterward will rest on North Korea," it noted.

he UK has declared that the country is now free from highly pathogenic avian influenza, or bird flu.

The Department for Environment, Food and Rural Affairs said the declaration has been reviewed and published by the World Organization for Animal Health. This follows Northern

Ireland's declaration of freedom from bird flu on March 31.

The UK had faced its largest outbreak of bird flu with more than 360 cases

The UK health authorities advise that the available evidence suggests viruses currently circulating in birds in the UK do not spread easily to people and food standards bodies advise that avian influenza pose a very low food safety risk for UK consumers. There is no impact on the consumption of properly cooked poultry products, including eggs.

Lakhs of commuters in Mumbai hit as CR starts 63-hour mega-blocks for infra-upgrades

63-hour long 'special mega block' for infrastructure upgradation, implemented by the Accentral Railway on certain sections of its suburban network, threw Mumbai into a megachaos with delays in local trains, commuters flaring up in the heat, coupled with road snarls and crawling traffic, here on Friday.

The CR has launched its 'mega-block' on the Chhatrapati Shivaji Maharaj Terminus (CSMT)-Kalyan section on from 00.30 hrs of May 31 (Friday) and it will continue till 3.30 in the afternoon of June 2 (Sunday), said an official spokesperson.

The CR teams took up the upgrade works to widen Platform No. 5/6 at Thane station by dismantling the existing railway tracks, the overhead electrical wires, equipment, etc.

Expected to be completed by Sunday afternoon, the wider platform by around 3.05 metres, will enable seamless movement for commuters at this major station.

The other block is for the extension of the railway platform No. 10/11 to accommodate 24 coach trains at CSMT.

CR General Manager R. K. Yadav has appealed to the people to refrain from travelling unless absolutely necessary in view of the delays and



curtailment in services.

The two simultaneous blocks of varying durations have hit suburban and long-distance train services with 42 outstation trains cancelled, and around 160 other trains are short-originating,

ices operated at long intervals of 20-30 minutes. and the cascading effects felt on the Western Railway and the CR's Harbour Line.

The railway stations in the Thane-Raigad sections were jam-packed with harried, perspiring commuters making a beeline to catch a local and reach their workplaces on time, though the authorities had deployed extra buses to clear the commuter rush.

Expecting commuting problems - a lesson learnt from past mega-blocks - many Mumbaikars opted to commute in their twowheelers or cars, but they made slow and painful progress as the arterial roads, main thoroughfares and highways got clogged with vehicles.

A woman IT professional from Mulund, Mini P. Menon, who commutes a short distance to Ghatkopar in 15 minutes daily said she took a BEST bus but it took her over an hour to reach her workplace in the massive road traffic.

A Thane-based shipping consultant S. Bhaskaran said he spent over two hours by road to reach his office in Bandra Kurla Complex and he was resigned to a similar delay on his return journey home this evening.

Rattled by the surging crowds and the intense heat, many people decided to 'work from home' and those working five days availed a casual leave for a long weekend.

Woman scammed out of Rs 28 lakh in fake Gold deal

avi Mumbai police have arrested two men for dacoity after a woman lost nearly Rs 28 lakh in a scam involving the promise of gold at a cheap rate, an official reported on Friday.

The 36-year-old woman from Nerul filed a complaint stating that one of the arrested men contacted her, offering to sell her half a kilo of gold for Rs 27.81 lakh, below the market price. On May 18, the man took her to Sanpada station in a car for the deal. Once there, a group of people threatened the woman and snatched her bag containing the money. The man and an accomplice who was in the car fled the scene, she alleged, the report stated. According to the report, following various leads, police arrested Rakesh Shivaji Shingte (39), who had contacted the woman, and Roopesh Subash Sapkale (42), both residents of Thane. Efforts are ongoing to apprehend the others involved, the official added.

The accused are the father and grandfather of the accused minor boy - currently in a juvenile correctional home -- whose speeding Porsche car killed two Madhya Pradesh techies, both aged 24, early on May 19, triggering an outrage.

While Vishal S. Agarwal, 50, was arrested late on Monday (May 27), Surendrakumar B. Agarwal had been arrested earlier under fresh charges, and both were remanded to police custody till May 31. Simultaneously, the minor



accused's mother, Shivani V. Agarwal has now come under the police radar in connection with the probe into the swapping of the boy's original blood report which was swapped, ostensibly to get him off the hook in the serious

crime. In a related development, a couple of friends of the 17-year-old boy who were in the Porsche, have told the Pune Police that he was heavily drunk and driving at the time of the crash

that killed IT professionals Ashwini Koshtha and Aneesh Awadhiya that morning.

Earlier, another eyewitness to the car crash had recounted how he barely missed getting a deadly hit by the Porsche which, barely seconds later rammed into the motorcycle ahead on which the techies were travelling, killing them. Subsequently, the resident of Kalyani Nagar noticed a heavily sozzled boy along with another person emerging from the vehicle and getting thrashed by an angry mob that had gathered there.

The eyewitness further claimed before mediapersons that the boy pleaded and even offered 'as much money as you want' to spare them the thrashing before they were handed over to the Yerawada Police Station, and it triggered a national furore the next day (May 20).

Mumbai court on Friday remanded a structural engineer in police custody till June 5. The structural engineer was arrested in connection with the May 13 hoarding collapse that killed 17 persons in Ghatkopar. Structural engineer Manoj Sanghu was produced in the magistrate court after he was arrested by the Crime Branch on Thursday

Sanghu, who was appointed by the Brihanmumbai Municipal Corporation

(BMC), had given a stability certificate to the hoarding. which crashed onto a petrol pump after gusty winds and unseasonal rains hit the city on May 13.

Ego Media Private Limited had erected the hoarding on a plot which belonged to the Government Railway Police (GRP).

Sanghu is the second person to be arrested in the case. Police had earlier arrested Ego Media Private Limited director Bhavesh Bhinde, who is currently in judicial custody. Bhinde and others were charged under

Indian Penal Code sections 304-2 (when there is knowledge that death may be caused by one's act), 338 (endangering life or personal safety of other) and 34 (common intention). The police have now added IPC section 120B (criminal conspiracy) to the FIR.As many as 17 people, including a former GM of Mumbai airport ATC

lamping down on the menace of illegal power connections, Adani Electricity Mumbai Limited detected 26.21 million units of power thefts worth an estimated Rs 46.04 crore in the city last year, an official spokesperson said on Friday.

In the financial year 2023-2024, the company lodged 974 FIRs for power thefts, compared to the 778 FIRs registered in the previous fiscal (2022-2023). Power theft is a non-bailable offence that attracts a stringent fine/jail term of three years for the offenders.

During multiple raids carried out last year, the company seized 60.5 tonnes of illegal wires and the actions resulted in bringing down the Aggregate Technical and Commercial (AT&C) losses by 0.46 per cent - from 5.93 per cent (2022-2023) to a commendable 5.47 per cent (2023-2024), the official said.

This has placed Adani Electricity with the lowest AT&Closses among all Discoms nationwide, given its extensive power network and diverse con-



sumer base, the official added.

Among the major power thieves caught last year was Jaini Traders in Kurar village, Malad East, for illegally using a three-phase direct supply that led to theft worth Rs 1.33 crore. The case was probed by the Kandivali police station in June 2023.

In July 2023, the company's vigilance teams caught Crohast Plastic Moulding Mfg. Ltd in Andheri for using an illegal power connection

On Wednesday, in a meeting held at the collector's office, Kanoongo presided the need for urgent action and highlighted the necessity of collaborative efforts for sustainable rehabilitation of children and their families

Kanoongo highlighted the efforts initiated since 2016 for the same cause. He emphasized on Municipal Corporations' and Municipalities' responsibilities to take proactive steps, to enhance finacial capacity and facilitating school enrollment for these street children in the

rehabilitation.

Kanoongo proposed the establishment of "Cooperative Shelters" as an effective solution. He has told officials to study the successful Rehabilitation Project in Bhopal for inspiration and replication.

NCPCR, back in June 2022, has launched a 'CiSS application' under Bal Swaraj Portal, to help in the rehabilitation process of Children in Street Situations (CiSS). The CiSS portal is launched for online tracking and digital real-time monitoring mechanism of children in need of care and protection. The CiSS application is used for receiving data of children in street situations from all the states and union territories. tracking their rescue and rehabilitation process. It follows a detailed six stages framework for the rehabilitation of children.

The portal also provides a platform for professionals and organizations to provide any help that they can to children in need.


The Standard Operating Procedure for Care and Protection of Children in Street Situations 2.0 categorizes any child under 'Children in Street Situation', if the child is living on the streets alone, living on the streets during the day, or living on the streets with the family.

The root cause of the children in streets is found to be migration of families from rural to urban areas in search of a better standard of living.

As per the release by the District Administration, Kanoongo urged officials from Women and Child Development Department to visit and study such projects, study their methods, and replicate them in the Thane district Street Children Rehabilitation Project to ensure positive results.



Dev, who had missed out on the Paris Olympic berth in the 1st Qualifier in Italy after going down to 2021 world championships silver medallist Omari Jones of USA at the same stage, was determined not to lose out this time around as he took control of Round 1 with a combination of a right-hand jab and a lefthanded hook.Cebotari did put up a fight in Rounds 2 and 3 but the experience of Dev shone bright as he mixed caution with aggression and landed a few hooks and uppercuts to earn a unanimous verdict.India have already secured three quotas for the Paris Games with Nikhat Zareen (women's 50kg), Preeti (54kg), and Tokyo Olympics bronze medallist Lovlina Borgohain (75kg) confirming



medals at the 2022 Asian Games. However, it was the end of the road for former World Youth Champion Ankushita Boro in the 60kg quarterfinals as she was unlucky to go down 3-2 against Sweden's Agnes Alexiusson. Boro was slow off the blocks and that allowed her Swedish opponent

to take control. But the Indian fought back in Round 2 and looked on course to reverse the deficit as she earned a 4-1 verdict for the round. She continued to attack the Swede in the final round but Alexiusson landed a few punches of her own at the right time to convince three of the

five judges to rule in her favour. Four Indian boxers will be in action in the evening session on Friday with all of them -- Arundhati Choudhary (66kg), Amit Panghal (51kg), Sachin Siwach (57kg), and Sanjeet (92kg) just two wins away from a Paris Olympic spot.

"As part of its commitment to the future development of World Boxing, the BFI aims to play a leading role in establishing an Asian Confederation and



drive the recruitment of other National Federations in the region," the BFI said in a release.

"It also intends to actively participate in the work of World Boxing Committees and all Commissions as well as bidding to host World Boxing competitions and supporting World Boxing's efforts to secure commercial partnerships and generate new income streams," it added.

World Boxing president, Boris van der Vorst, said "India is a very important country in inter-

national boxing and we look forward to welcoming the BFI into the growing World Boxing family. This is a very exciting development which will significantly increase our presence in Asia and I look forward to working closely with the BFI in delivering our common goals.

"In both its public comments and during our recent meeting, the IOC has delivered a clear message to all National Federations that if they want boxers from their country to have the opportunity to compete at future Olympic Games then they must now join World Boxing. This is the only path that will see our sport remain in the Olympic Games after Paris 2024 and National Federations must act now and follow the example of the BFI if they want boxing to have any chance of still being part of the programme at Los Angeles 2028," he added.

BFI president Ajay Singh said their goals and values align with World Boxing and they wish to expand the sport in the continent.

"It is absolutely vital to the sustainability of boxing that it retains its Olympics status, so we are delighted to join World Boxing and look forward to working closely with the Executive Board and our fellow members to shape the future development of the sport and deliver a brighter future for boxers across the world," he said.

"The BFI shares the same values and goals as World Boxing and are keen to play a leading role in its development. We also wish to be at the forefront of the formation and hosting of a new Asian confederation to ensure boxing continues to expand and grow its membership on the continent," the BFI president added.


