# **GOVERNMENT VS OPPOSITION ON** SPEAKER, FIRST CONTEST IN DECADES

The election - scheduled for 11 am today will see the BJP's Om Birla, a three-time MP from Kota in Rajasthan, up against the Congress' Kodikunnil Suresh, an eight-term parliamentarian from Kerala's Mavelikara. Suresh is the longest-serving parliamentarian in the 18th Lok Sabha.

he BJP's ruling coalition and the Congress' INDIA opposition bloc will go head-to-head Wednesday in a battle for the Lok Sabha Speaker's post - arguably one of the most important in a parliamentary democracy and to be held for the first time in decades - after the two failed to agree a divi-

The Speaker and his/her deputy - the post fuelling disagreements between the two political giants - are usually elected by consensus, lack of which in this instance underlines the fractious BJP-Congress ties.

Birla is likely to win given the BJP-led alliance's majority; the Lok Sabha Speaker is elected by a simple majority of MPs voting and the ruling coalition can call on 293 votes to the INDIA bloc's 232.

After filing his papers Suresh told the press, "This is the party's decision... not mine. There is a convention... that Deputy Speaker will be from the opposition. But they (the BJP) are not ready to do this. We were waiting till 11.50 am... but there was no response. So we filed the nomination."

Union Minister Piyush Goyal, however, countered that claim, saying there is no precedent to suggest the Deputy Speaker's post must go to a member of an



### **BJP TRIED FOR CONSENSUS**

New Delhi: Defence Minister Rajnath Singh and Parliamentary Affairs Minister Kiren Rijiju met INDIA bloc leaders, including the Congress' Mallikarjun Kharge, and were told consensus relied on the opposition getting the Deputy Speaker's post. The deputy's chair is traditionally reserved for an opposition MP to ensure a balanced House.

The post was not filled in the second Modi government (2019-2024), but in the first (2014-2019), it was awarded to an ally of the ruling BJP - the AIADMK's M Thambidurai held the position.

The meeting did not go as the BJP may have hoped. The opposition said it stood ready to support Birla's candidature but only providing it was given the deputy's post. As per sources the BJP was not forthcoming on this demand; the party reportedly wanted immediate consensus for Birla and said a decision on his deputy would be taken later. The opposition, however, refused to play

#### TMC NOT HAPPY

New Delhi: Sources said the Trinamool - on paper a part of INDIA - was not consulted in the "unilateral" nomination of Suresh and that the party would decide how to react by this evening.

"We were not contacted about this... there was no discussion. Unfortunately, this is a unilateral decision," party MP Abhishek Banerjee said. Banerjee was later seen with Congress MP Rahul Gandhi inside Parliament; the two were engaged in a private dis-

#### RAHUL GANDHI TO BE THE LEADER OF OPPOSITION IN LOK SABHA

New Delhi: The Congress on Tuesday evening announced that senior party leader Rahul Gandhi will be the Leader of the Opposition in the 18th Lok Sabha. "Congress MP Rahul Gandhi has been appointed as the LoP in the Lok Sabha," said party General

Secretary (Organisation), K.C. Venugopal. The decision was taken at a meeting of the floor leaders of the INDIA bloc, sources said.

In a post on X, Venugopal said, "CPP Chairperson Sonia Gandhi ji has written to the Pro-Tem Speaker informing him that Rahul Gandhi ji is appointed as the Leader of Opposition in the Lok Sabha. We are confident that as LOP, Rahul ji will be a bold voice for the common people of India and ensure that the NDA government is held firmly accountable at all

On June 8, the Congress Working Committee (CWC) passed a unanimous resolution to appoint Rahul Gandhi as the Leader of Opposition in the Lok Sabha. "The CWC has unanimously requested Rahul Gandhi to take the position of Leader of Opposition in the Lok Sabha. He is the best person to lead this campaign inside the Parliament," Venugopal had said after the meeting, adding that the former party chief would take a decision very soon.

# 'Trial court didn't apply its mind': Delhi HC stays CM Kejriwal's bail

elhi High Court on Tuesday, in its final verdict on the Enforcement Directorate's plea, stayed a trial court order granting bail to Chief Minister Arvind Kejriwal.

Justice Sudhir Jain said that the documents and arguments were not appreciated by the trial court.

On June 20, a Delhi court granted bail to the Chief Minister in connection with a money laundering case related to the now-scrapped excise policy.

Following this, the ED moved the high court which stayed the order till its pronouncement of the final order

Now, Justice Jain in his final order said that the trial court vacation bench did not apply its mind to the material and it ought to give equal opportunity to the ED to argue bail application.

He said that other arguments will be considered by the roster bench.

The ED had sought a 48-hour deferral in signing the bail bond following the pronouncement of the order. However,

ASG Raju had further said that his prayer for a stay on the bail order wasn't even considered. "I am demanding that the order be stayed and the matter be heard as soon as possible. We were denied the full opportunity to argue the case. I am making allegations with full seriousness," he stated.

Senior advocate Abhishek Manu Singhvi, representing CM Kejriwal, had opposed the stay request, citing legal precedents. "There are 10 Supreme Court judgments that cancellation of bail is radically different from grant of bail," he had

After hearing arguments from both sides, the high court directed that the bail order should not be enforced until the matter is heard in full. "The bail order will not be given effect. We have not passed the final order. You may argue as much as you can," the bench had stated, effectively halting CM Kejriwal's release.

#### WORLD'S OLDEST, **41,000 YEARS OLD OSTRICH NEST, FOUND** IN ANDHRA PRADESH

New Delhi: Researchers have found the world's oldest Ostrich nest, dating back to 41,000 years, in Andhra Pradesh. The nest was discov ered while archaeologists from a Vadodara University and experts from Germany, Australia and the US were investigating a fossil-rich site in Andhra Praderdsh's Prakasam. The nest, a massive structure containing 911 ostrich eggs, offers unparalleled insights into the behavior and habitat of these ancient megafaunal birds, the researchers said.

Typically measuring between 9 to 10 feet in width, such nests were capable of holding anywhere from 30 to 40 eggs at a time. "This finding represents a crucial moment in comprehending the extinction of megafaunal species in India," said Devara Anil Kumar, Assistant Professor at MSU's Department of Archaeology and Ancient History in Vadodara.

### Stairs of Mumbai's Banganga Tank linked to Lord Ram damaged during desilting works; probe ordered

everal stone steps around the historic Banganga Tank at Malabar Hill were damaged while undertaking desilting works for the monsoon season, sparking outrage, here on Tuesday.

The Banganga Tank, estimated to be over eight centuries old, finds mention in the ancient texts of Ramayana and Skanda Purana. It has rich religious and cultural significance

associated with Lord Ram. Following an uproar, the BrihanMumbai Municipal Corporation (BMC) has initiated repairs to the old site.

### Alcohol and drug use claimed more than 3 mn lives in 2019: WHO

The WHO's Global Status Report on Alcohol and Health and Treatment of Substance Use Disorders, based on 2019 data, showed that 2.6 million deaths per year were attributable to alcohol consumption, accounting for 4.7 per cent of all deaths in that year, and 0.6 million deaths to drug use.

- Of these, 2 million of alcohol and 0.4 million of drug-attributable deaths were among
- ▶ The report also showed that low-income countries account for the highest death rates due to alcohol consumption, while high-income countries had the lowest rates.
- Young people aged 20-39 years accounted for the highest proportion (13 per cent) of alcohol-attributable deaths in 2019, said the report.

lcohol consumption and psychoactive drug use claimed more than three million lives in 2019, according to a new report from



the World Health Organisation (WHO) on Tuesday.

"Substance use severely harms individual health, increasing the risk of chronic diseases, and mental health conditions, and tragically resulting in millions of preventable deaths every year. It places a heavy burden on families and communities, increasing exposure to accidents, injuries, and violence," WHO Director General, Dr Tedros Adhanom Ghebreyesus said.

'To build a healthier, more equitable society, we must urgently commit to bold actions that reduce the negative health and social consequences of alcohol consumption and make treatment for substance use disorders accessible and affordable," he added.

Importantly, an estimated 1.6 million deaths related to alcohol consumption were from non-communicable diseases, including 474,000 deaths from cardiovascular diseases and 401,000 from cancer. Some 724,000 deaths were due to injuries, such as those from traffic crashes, self-harm, and interpersonal violence. Another 284,000 deaths were linked to communicable diseases, like HIV/AIDS, and tuberculosis. It called for "an urgent need to accelerate actions globally towards achieving Sustainable Development Goal (SDG) target 3.5 by 2030 by reducing alcohol and drug consumption and improving access to quality treatment for substance use disorders".

# ATISHI'S HEALTH DETERIORATES DURING HUNGER STRIKE, ADMITTED TO LNJP HOSPITAL

mid the ongoing water crisis in the national capital, Delhi Water Minister Atishi, who is on an indefinite hunger strike, was admitted to Lok Nayak Jai Prakash Hospital early this morning due after her health condition deteriorated.

According to the doctors, Atishi's blood sugar levels dropped dangerously low, reaching 43 at midnight and further plummeting to 36 by 3 a.m. Medical professionals immediately recommended hospitalisation. There was also a significant drop in her blood pressure and weight, marking her condition as increasingly perilous. Additionally, rising urine ketone levels indicated a severe threat to her health.

The Aam Aadmi Party leader is on an indefinite hunger strike demanding Haryana release Delhi's share of water. On the fourth day of her fast on Monday, doctors from LNJP checked her health. Observing her deteriorating condition, they recommended hospital admission.



Atishi decided not to break her fast. "Ensuring water for the people of Delhi is more important than my life. My fast will continue until the people of Delhi receive their rightful

share of water," she said.

## Passenger booked to travel on Air India's UK flight from Kochi taken into custody for bomb threat

n a bizarre incident, the Cochin International
Airport police on Tuesday took into custody a man who was booked to travel on an Air India flight from Kochi to London, after he was identified as the sender of a bomb threat to the airline.

Now, the 29-year-old Malappuram resident Suhaib is in the custody of the police and is being interrogated.

Police became alert as Suhaib, due to catch the London flight on Tuesday, was behaving suspiciously at the airport.

The cops questioned him and later it was discovered that it was he who had sent a threatening mail to the airline on Monday night from his official email.

He arrived at the Cochin International Airport along with his family and the family members are also being questioned now.



According to airport officials, the threatening email was sent to the Air India call centre at Mumbai late on Monday night.

At the time of the receipt of the threat, the Air India flight had departed from Delhi for Cochin Airport.

When the flight landed at Kochi, it was quickly moved to the isolated parking area of the airport and after a thorough check, it was found to be a hoax threat.

On questioning Suhaib it was revealed that he was nursing a grudge against the airline as his daughter fell sick after consuming food on an Air India flight a while ago.Later, the flight after all mandatory checks departed for Lordon

# 52 Drug Samples, Including That Of Paracetamol, Fail Quality Test

ndia's apex drugs regulatory body has found the samples of around 50 drugs, including that of widely-used paracetamol, pantoprazole and some antibiotics for treating bacterial infections, as not of standard quality. Of these sub-standard drugs, 22 are manufactured in Himachal Pradesh, according to the alert issued by the Central Drugs Standard Control Organisation (CDSCO) for the month of May.Besides Himachal Pradesh, the samples were collected from Jaipur, Hyderabad, Waghodia and Vadodara in Gujarat, Andhra Pradesh and Indore, among other places.

A total of 52 samples have failed the quality test conducted by the CDSCO, according to the drug alert issued on June 20. Sources said state drug regulators have reportedly sent notices to the pharmaceutical companies concerned and the failed



samples would be recalled from the market.The list of the sub-standard drugs contains Clonazepam tablets that are used to treat seizures and anxiety disorders, pain reliever Diclofenac, anti-hypertension drug Telmisartan, Ambroxol, which is used in the treatment of respiratory diseases, Fluconazole, an antifungal, and some multivitamin and calcium

tablets.

ment and thus contribute to the growth of the state in a very honest and sincere way" Bhutia said in a statement. "As Lord Buddha said, 'one's intentions must be good'. I can only say with utmost honesty and

humility that my intention in politics was to do good, for the people of both state and country," he added.

"I wish to thank everyone who supported me through thick and thin. I am also sincerely sorry if I hurt anyone unknowingly or knowingly. As we say in football, please take it in the spirit of the game."

The ex-star Indian footballer also congratulated Chief Minister Prem Singh Tamang for his SKM's resounding victory in the elections and hoped that the ruling party would fulfil their promises and the government would work towards the betterment of the state.Bhutia moreover mentioned that he will now devote more time to introspect, work towards other goals, and discover a new purpose.

# Udhayanidhi Stalin granted bail by Bengaluru court in Sanatana Dharma remark case

ther proceedings in the case.

As the case is also being looked into by the Supreme Court, the Special Court adjourned

the matter to August 8.

The complainant claimed that the remarks made by Udhayanidhi Stalin defamed him, his religion and people belonging to Hindu



The court had taken cognisance of offences under IPC Sections 153 (wantonly giving provocation, with intent to cause riot) 298 (uttering words etc with deliberate intent to wound religious feelings) and 500 (defamation). Speaking at a conference in September 2023, Udhayanidhi Stalin said that Sanatana Dharma was against social justice and equality and should be 'eradicated'.

The statement stirred a controversy at the national level.

# Ex-BJP leader Suryakanta Patil makes 'ghar-wapasi' to Sharad Pawar's NCP

from Hingoli in 2024 but was denied a nomination as the seat went to the ruling ally Shiv Sena's quota this time. The Shiv Sena had fielded

Baburao K Kohalikar, but he lost by over 1.08 lakh votes to the rival Shiv Sena (UBT) candidate, Nagesh B Patil-Ashtekar. Political sources are optimistic that Patil's entry to NCP(SP) could offset the departure of the former Congress strongman from Nanded, Ashok Chavan to the BJP, plus give an edge to the Maha Vikas Aghadi alliance ahead of the Maharashtra Assembly elections in October.

#### Speaker's election ends up showing 'schism' in INDIA bloc!

direct contest for the Speaker's post between the candidates of the rul-**∠ ⊥** ing alliance and the Opposition bloc has not been witnessed in the last 75 years since the time of Independence because the Speaker's chair is a bi-partisan Constitutional post who not only has the responsibility to run the House as per the rules and established norms, but is also the protector of the rights and duties of all members of the House, irrespective of their political affiliations. There has so far been a general unanimity that the beginning of a new term of the Lok Sabha shouldn't be on a sour note, with an open proclamation of distrust against the person nominated by the ruling dispensation as the candidate for the *Speaker's post. The Parliament this time* may see far more disruptions and noisy scenes in both the Houses than in the past. The BJP, after rounds of consultations with its NDA allies, has decided to go for continuity by reposing faith in Om Birla whom it nominated for the Speaker's post for a second consecutive term. The Congress may have broken the convention by going for a contest, but it's not going to be easy. But the problem for the Congress becomes far bigger. While it was trying to portray a united Opposition or post-election INDI Alliance unity, it ended up exposing the schism in that grouping. Mamata Banerjee's Trinamool Congress raised a red flag over Congress' unilateral decision. The Congress argues that it was compelled to take this decision because the BJP was not giving any assurance to them that the Deputy Speaker's post would be given to the Opposition. Union Commerce and Industry Minister Piyush Goel countered this by saying that there was no such convention (of offering the Deputy Speajer's post to the Opposition).

# RSS, Emergency, And The Importance Of Civil Society

In the annals of Indian democracy, few events cast as long a shadow as the 21 months of Emergency from 1975 to 1977. It was the darkest hour in the history of Indian politics, effected by Prime Minister Indira Gandhi in response to political opposition and unrest. Fundamental rights were suspended, press freedom was curtailed, and thousands of dissidents were imprisoned without trial. Yet, one organisation stood out for its ability to resist the government's policies - the Rashtriya Swayamsevak Sangh (RSS). Despite being banned, it played an important role in opposing the Emergency.

First, a primer on the period. By 1975, Indira Gandhi's government was facing hurdles on multiple fronts. Staring at the prospect of being forced out of office, Gandhi on June 25 made the fateful decision to have President Fakhruddin Ali Ahmed declare a state of emergency under Article 352 of the Constitution. Civil liberties were suspended, press censorship was imposed, and opposition leaders were swiftly arrested in midnight raids. Many from the Sangh leadership, including sarsanghchalak Balasaheb Deoras, were arrested. This is what Deoras said before his arrest, "In this extraordinary situation, the volunteers are not obligated to lose their balance. Continue the Sangh work as per the orders of Sarkaryavah Madhavrao Mule and build the ability of the public to perform their national duty while doing public relations, public awareness, and public education as

Prisons were flooded with RSS cadres nationwide. P.G. Sahasrabuddhe and Manik Chandra Vajpayee in The People Versus Emergency: A Saga of Struggle, claim that the number of RSS sevaks detained under the Maintenance of Internal Security Act (MISA) was 23,015, which included 77 female activists. "The number of Sangh activists arrested for offering satyagraha during the Emergency was 44,965, while only 9,655 people of other parties offered satyagraha," the

In a letter to Gandhi, Deoras said, "I listened attentively in jail to the radio broadcast of your address to the nation from the Red Fort on 15th August 1975. On 4th July 1975, the Central government issued a special ordi nance to ban the Rashtriya Swayamsevak Sangh (RSS). From press reports about the



ban, it appears that it has been imposed on the ground that the activities of its swayamsevaks and senior workers are prejudicial to the country's security and public law and order". In the same letter, Deoras said about the RSS, "The ban order does not give a specific reason for the ban. The RSS has never done anything that would endanger the country's internal security and public law and order. The objective of the Sangh is to organise the whole Hindu Society and make it homogeneous and self-respecting. ...it is necessary to make it clear that the Sangh had never indulged in violence. Neither has it ever taught violence. The Sangh does not believe in such things".

A few jailed Sangh leaders such as Nanaji Deshmukh and K.S. Sudarshan also communicated with the outside world through letters. Deshmukh wrote to film artists, urging them to join the movement for restoring democracy. "You have a special position in society. You are a model for the youth...The question is, will you confine yourself to mere entertainment in these difficult times?... The call of the hour is that you replace the despair of today with hope born of thought. I request you to participate in people's struggle.

Given its long experience in operating as a decentralised network of local shakhas, the Sangh could quickly adapt to the Emergency days. Its organisational structure proved to be remarkably resilient to top-down suppression. A key factor that bolstered the Sang was its vast network of pracharaks (full-time workers) spread across the country. These individuals became the backbone of underground resistance efforts. On December 12, 1976, The Economist wrote, "The underground campaign against Mrs Gandhi claims to be the world's only non-left wing revolutionary force, disavowing both bloodshed and class struggle. Indeed, it might even be called right-wing since it is dominated by the Hindu communalist party, Jan Sangh, and its 'cultural' (some say paramilitary) affiliate, the RSS. But its current platform has only one non-ideological plank: to bring democracy back to India...the other underground parties, which started as partners in the underground, have effectively

abandoned the field to Jan Sangh and RSS.' One of the Sangh's most significant contributions during this period was its efforts towards running the underground press. With mainstream media outlets heavily censored or co-opted by the government, clandestine newsletters and pamphlets became a crucial source of uncensored information. Sangh volunteers were vital in writing, printing, and distributing this material, often

at significant personal risk. Various monthly or fortnightly magazines were published

nationwide to portray the plight of the people. Printed on cyclostyle machines and distributed hand-to-hand, they provided a steady stream of news and commentary critical of the Emergency. The RSS cadres naturally took elaborate precautions to avoid detection, frequently changing printing locations and using a network of trusted couriers for distribution

The Sangh also supported other media. When veteran journalist Ramnath Goenka's Indian Express newspaper faced intense censorship, Sangh volunteers helped distribute unauthorised editions printed in secret. This collaboration between professional journalists and grassroots activists effectively circumvented government control.

But the organisation's resistance was not limited to narrative building. As the Emergency dragged on, the organisation shifted its focus to direct action to challenge government authority. It acted as a link between various opposition groups by facilitating communication between them. When Jayaprakash Narayan called for a 'Total Revolution' against the Emergency, Sangh volunteers proved instrumental in mobilising support for the movement. Using coded language and pre-arranged signals, the pracharaks maintained lines of communication and coordination. The Sangh also benefited from its deep roots in local communities across India. Many other citizens, even those not formally affiliated with the organisation, were willing to support it. All in all, the grassroots support network proved invaluable in evading surveillance.

Undoubtedly, the Sangh's resilience during the Emergency is a testament to the power of civil society organisations in the face of authoritarian regimes. As India grapples with the security-vs-liberty debate and questions about democratic governance, lessons from the Emergency stand relevant. Whether one agrees with the Sangh's ideology or not, its role during this period deserves recognition. The events of 1975-77 are a stark reminder of the fragility of democratic institutions and why civil society is crucial for defending them.

### Russia hopes South Korea 'calmly' accepts treaty with North Korea

Seoul Agencies Minister on Tuesday L Lexpressed hope that South Korea would "calmly" accept Moscow's new partnership treaty with North Korea, a news report said, amid condemnation over deepening military cooperation between the two coun-

Russian Deputy Foreign Minister Andrey Rudenko said the treaty, signed by the North's leader Kim Jong-un and Russian President Vladimir Putin after their talks in Pyongyang last week, is not directed at either South Korea or third countries,

reports Yonhap news agency. The treaty calls for, among other things, the provision of military and other assistance from one side to the other "with all means" at its disposal and "without delay" if either of the two gets invaded

or put in a state of war. Last week, South Korea said it could consider a possible supply of lethal weapons



to Ukraine in response to Moscow's commitment to military cooperation with North Korea.

South Korea also joined the United States and Japan in issuing a joint statement condemning, "in the strongest possible terms," the expanding military cooperation between Russia and North Korea.

-sraeli Prime Minister Benjamin Netanyahu has announced that Israel is "committed" to the deal proposal outlined by US President Joe Biden for a ceasefire in Gaza in return for the release of hostages

"We are committed to the Israeli proposal that President Biden endorsed," Netanyahu said on Monday during a special plenum session of the Knesset (parliament) summoned by the opposition, noting "Our position has not changed".

Biden first presented the deal proposal to end the ongoing conflict in late May. Netanyahu's remarks marked the first time the Israeli side has confirmed that Israel has approved and supports the proposal, Xinhua news agency reported.

Netanyahu told the Knesset that Israel will not end the conflict "until we bring back all the hostages, all 120 of them -both the living and the fallen" and until Hamas is "eliminated and the residents in southern and northern can safely return to their homes. Israel has been carrying out a massive offensive in the Gaza Strip in retaliation for a Hamas rampage on October 7, 2023, during which about 1,200 people were killed and about 250 were taken hostage.

### Biden designates Kenya as a major non-NATO ally of US

Washington | Agencies S President Joe Biden has designated Kenya as a major non-NATO By the authority vested in me as President by the Constitution and the laws of

the United States of America, including section 517 of the Foreign Assistance Act of 1961, as amended (22 U.S.C. 2321k)..., I hereby designate Kenya as a Major Non-NATO Ally of the United States for the purposes of the Act and the Arms Export Control Act...," stated a memorandum published by the White House on Monday.

The MNNA status is a designation under US law that provides foreign partners with certain benefits in the areas of defence trade and security cooperation.

According to the US Department of State, the MNNA designation is a "powerful symbol of the close relationship the United States shares with those countries and demonstrates our deep respect for the friendship for



the countries to which it is extended". While the MNNA status

provides military and economic privileges, it does not entail any security commitments to the designated country.

ussia's western Siberia is experiencing an unprecedented heatwave, with temperatures in several regions shattering records over the past 50 years or so, local weather authorities said on Tuesday.

A number of regions, specifically the Novosibirsk and Kemerovo Oblasts, along with the Altai Territory and the Republic of Altai, have experienced temperatures that surpassed records set in the 1970s and 1980s, said Natalia Kichanova, head of the weather forecasting service of the West Siberian Department for Hydrometeorology and Environmental Monitoring.

Kichanova noted that the heatwave is expected to persist across western Siberia until the end of



June, after which temperatures are predicted to decrease to a range of 17-25 degrees Celsius, accompanied by rainfall, reports Xinhua news agency.

The abnormally high temperatures are attributed to warm air masses moving into the macroregion from Central Asia, while "heat ridges" in the mid-troposphere contributed to the additional warming, she said.

### Bombay HC says JJB remand illegal, orders release of minor boy

erming the remand orders passed by the Juvenile Justice Board Pune as 'illegal', the Bombay High Court on Tuesday ordered the release of a 17-year-old minor boy accused in the alleged drunken driving case of his Porsche car which killed two persons on May 19. Allowing a petition filed by the boy's paternal aunt, Pooja G. Jain, a division bench comprising Justice Bharati Dangre and Justice Manjusha Deshpande directed the release of the minor boy, and to be given into the care and custody of the petitioner.

The boy has been lodged in a juvenile correctional home in Pune for over a month and soon afterwards, his 'buwa', Pooja Jain had filed the petition in Bombay High Court seeking his release.

Declaring the JJB's remand orders (of May 22, June 5 and June 12) as 'illegal and without jurisdiction', the high court, however, directed that the counselling sessions by a psychologist shall continue even after the boy



Official sources indicated to reporter that the minor boy is likely to be released 'either today or tomorrow', and depending on the government's stand, a decision would be taken on the high court order. During the hearings, the high court queried how and under what authority the JJB could remand the boy to a juvenile observation home after he had already been released on bail on May 19, (hours after the Porsche accident), and observed that the remand order

and its subsequent extensions had completely nullified the bail effects.

Arguing for bail for the minor boy, Jain's lawyer, advocate Abad Ponda, said that once a juvenile has been granted bail he cannot be remanded to an observation home, and emphasised that the bail was operative till date, since the boy had not been rearrested on any additional charges nor was the bail given to him cancelled by a higher court.

Accordingly, the boy remained

under 'illegal detention', and Ponda pointed out that instead of challenging the bail order, the authorities had filed an application mentioning concerns like public outrage and the minor's alleged addiction.

Ponda further contended that the boy could not be sent to the correctional facility while on bail under the Juvenile Justice Act, Section 39(2) and the order of remand without cancelling bail is not allowed even under other stringent laws like TADA or MCOCA. Opposing the plea, Public Prosecutor Hiten Venegaonkar said that the boy was released in the custody of his grandfather and not on his own bail bond, but since the grandfather and even the parents were in custody, the minor had to be sent to the observation home under the supervision of a probation officer.

Submitting that the JJB had just changed the person under whose care the minor was put, Venegaonkar said that the state does not want to cancel the boy's bail but sent him to the juvenile home for his own safety and wellbeing, given various other

### DHFL-Yes Bank case: SC asks Bombay HC to dispose of Pune builder Bhosale's bail plea

he Supreme Court on Tuesday asked the Chief Justice of the Bombay High Court to assign a bench for the disposal of a bail plea filed by Pune-based builder Avinash Bhosale in a money laundering case linked to the Yes Bank-DHFL fraud case.

A vacation bench, headed by Justice Manoj Misra, took note of the submission that the matter was repeatedly being adjourned before the high court due to paucity of time or non-availability of the counsel representing the other side despite being listed 5-6 times first on the board. "In these circumstances, we dispose of this petition (seeking release on bail on grounds of delay) by requesting the Chief Justice of the Bombay High Court to assign a bench for disposal of the bail application if a request is made by the petitioner through a proper application in that regard," ordered the Bench, also comprising Justice S.V.N. Bhatti. The apex court said



that it was not inclined to pass any direction for "expeditious" disposal of the bail plea and that the petitioner should approach the assigned bench of the Bombay High Court with such a request.

The Bombay High Court, in an order passed on May 17, directed Bhosale to be released on bail in the corruption case registered by the CBI. The Pune-based realtor was arrested by the CBI in May 2022 and subsequently by the Enforcement Directorate (ED) in connection with the Yes Bank-DHFL scam.

Bhosale, the founder of

the ABIL Group, has been accused of allegedly routing ill-gotten money through his Maharashtra-based real estate companies. In 2018, Bhosale had received around Rs 68.82 crore from DHFL. It was said that it was consultancy charges received by him. The ED probe revealed that Bhosale didn't provide any consultancy service to DHFL and the money received by him was nothing but alleged proceeds of crime. The ED had attached the assets worth Rs 164 crore of Bhosale under the Prevention of Money Laundering Act (PMLA),

The NCP bagged only one of the four seats it contested, whereas the NCP led by Sharad Pawar won eight of the ten seats it contested.

The Mahayuti alliance -- Bharatiya Janata Party (BJP), Shiv Sena and the NCP -- collectively bagged 17 seats in Maharashtra with BJP securing nine seats and the Shiv Sena seven.

Meanwhile, the leaders of the NCP led by Ajit Pawar, were reportedly upset over being offered the post of Minister of State (MoS) in the Modi 3.0 cabinet.

NCP leader Praful Patel had been offered the post of MoS, however, he turned it down saying that accepting the position of Minister of State with independent charge in the Union Cabinet would be considered a demotion for him, as he was earlier a Cabinet Minister in the Union Government.



He emphasised Warner's immense impact, saying, "You'll struggle to find a guy that's had as big an impact on all three forms in Australian cricket than David Warner has."

Warner in his last ICC tournament scored 178 runs including two-half centuries. Warner scored 56 against Oman and 53 not out against Bangladesh in the T20 World Cup 2024. However, despite his efforts, Australia fell short of reaching the semi-



finals after back-to-back losses to Afghanistan and India. As the team prepares for a future without Warner, Australia acknowledged the woid his absence will create Josh Hazlewood, reflecting on Warner's departure, noted, "We'll definitely miss him around the group, out in the field and off field. (An) amazing all-format career. It's sort of been a slow burn with Test cricket and ODI cricket and now T20. So, life without him, we've sort of gotten used to it a little bit .. it's always different when you lose a player that's been

Group Stage. This was also potentially the last time we see the 2018 Ballon d'Or winner represent his country at a major tournament with the World Cup nearly two years away. Football isn't always kind and the football gods don't always necessarily smile on us but we should be proud of the way that we represented our country," added the Real Madrid
